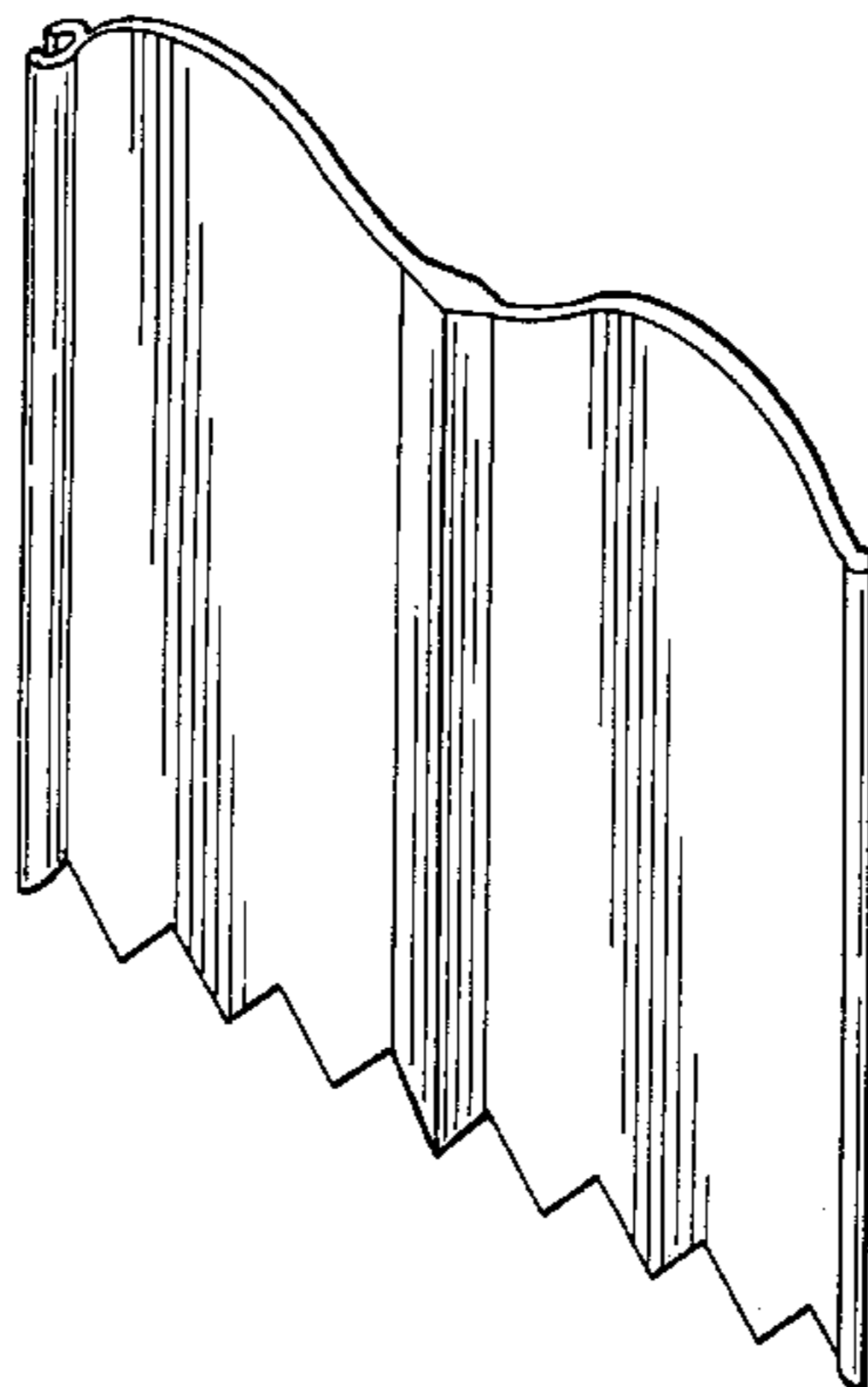

[57] **CLAIM**

The ornamental design for lawn edging with saw tooth profile, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of lawn edging with saw tooth profile showing our new design;
FIG. 2 is a front view thereof, the back view being a mirror image and symmetrical thereto;
FIG. 3 is a top view thereof; thereto;
FIG. 4 is a bottom view thereof;
FIG. 5 is a right side view thereof; and,
FIG. 6 is a left side view thereof.

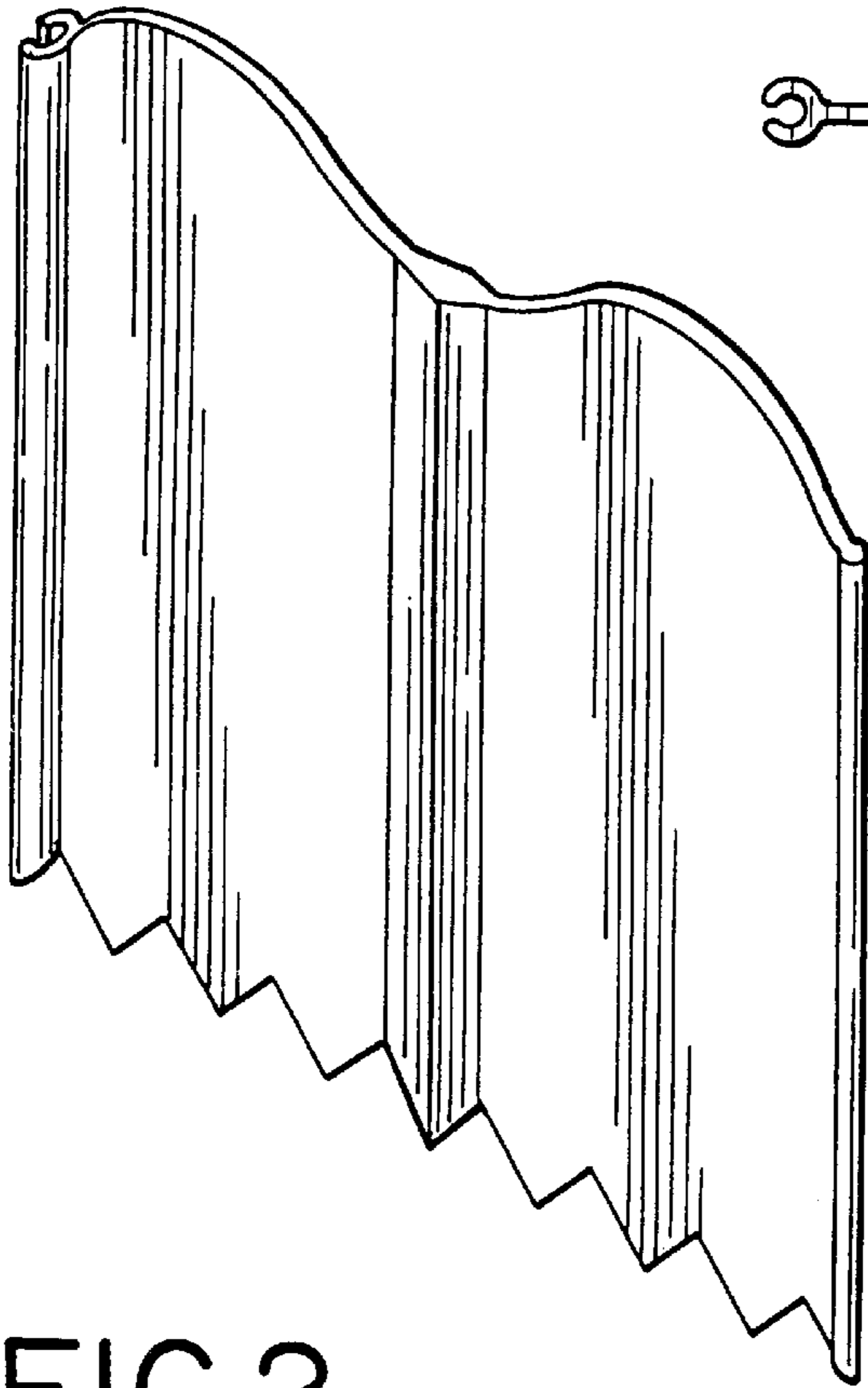

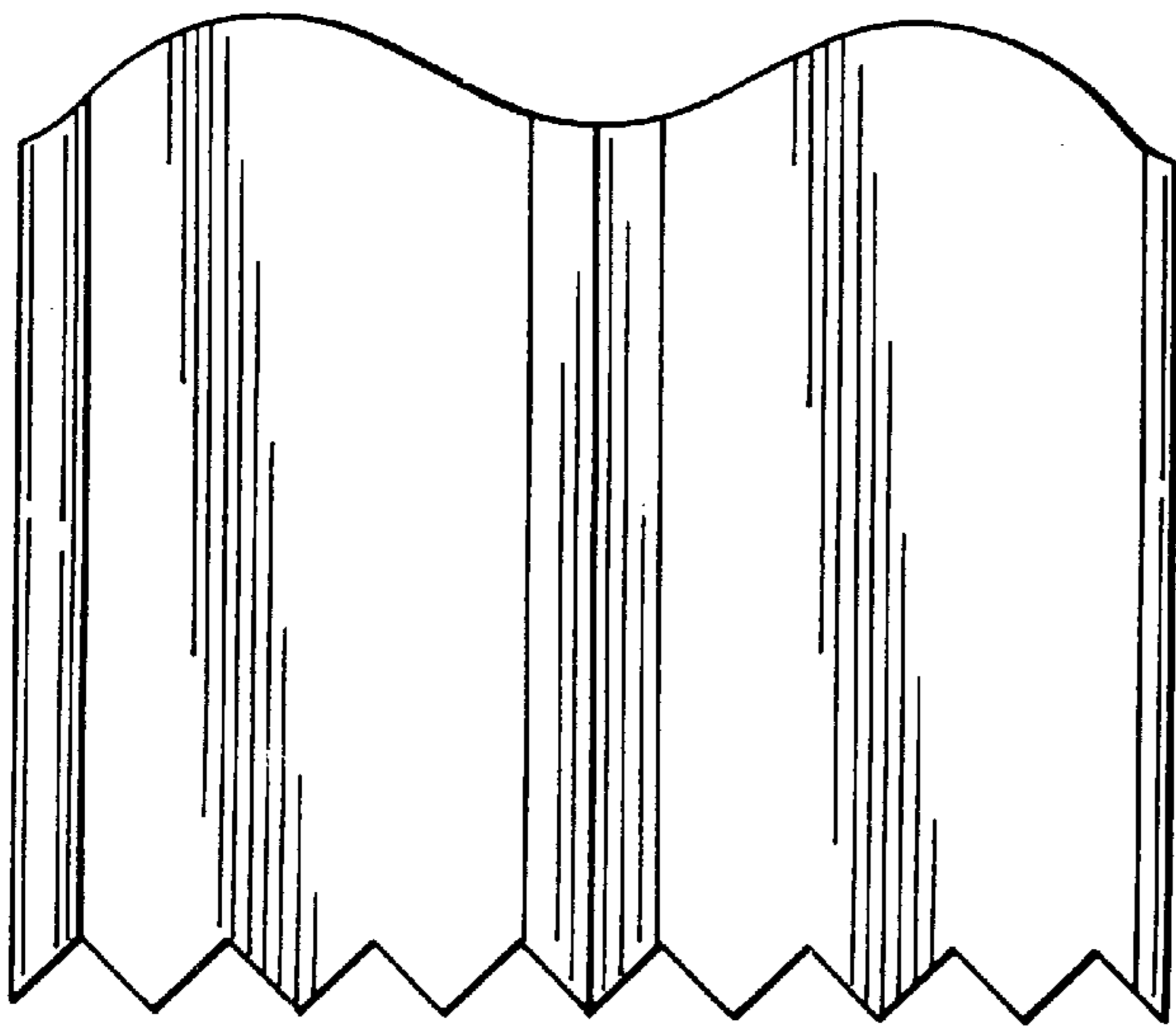
