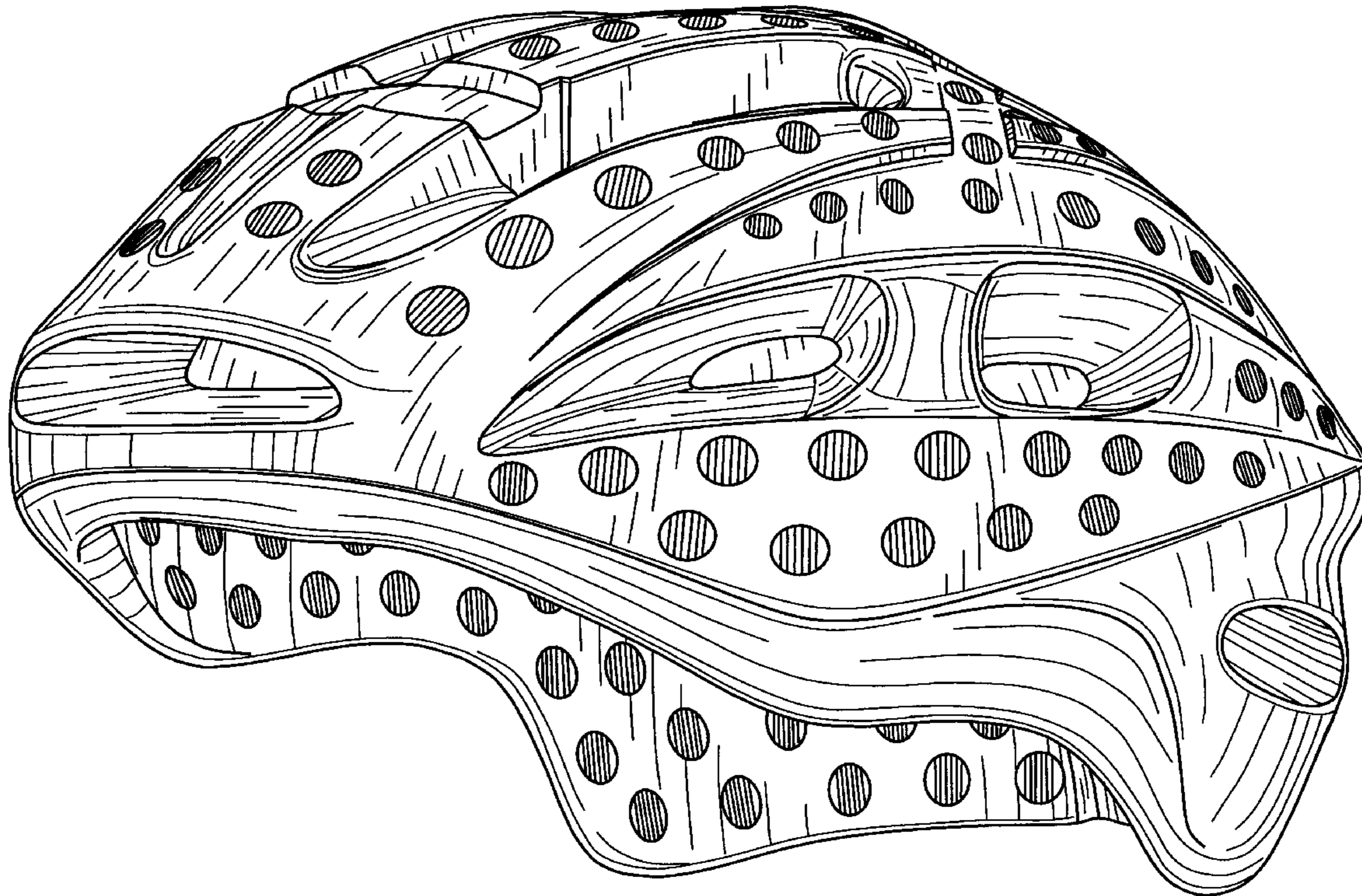

**DESCRIPTION**

FIG. 1 is a perspective view as seen from the front and left of a bicycle helmet showing my new design;  
FIG. 2 is a perspective view as seen from the rear and right thereof;  
FIG. 3 is a left side elevational view thereof, the right side is a mirror image;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a front elevational view thereof;  
FIG. 6 is a rear elevational view thereof; and,

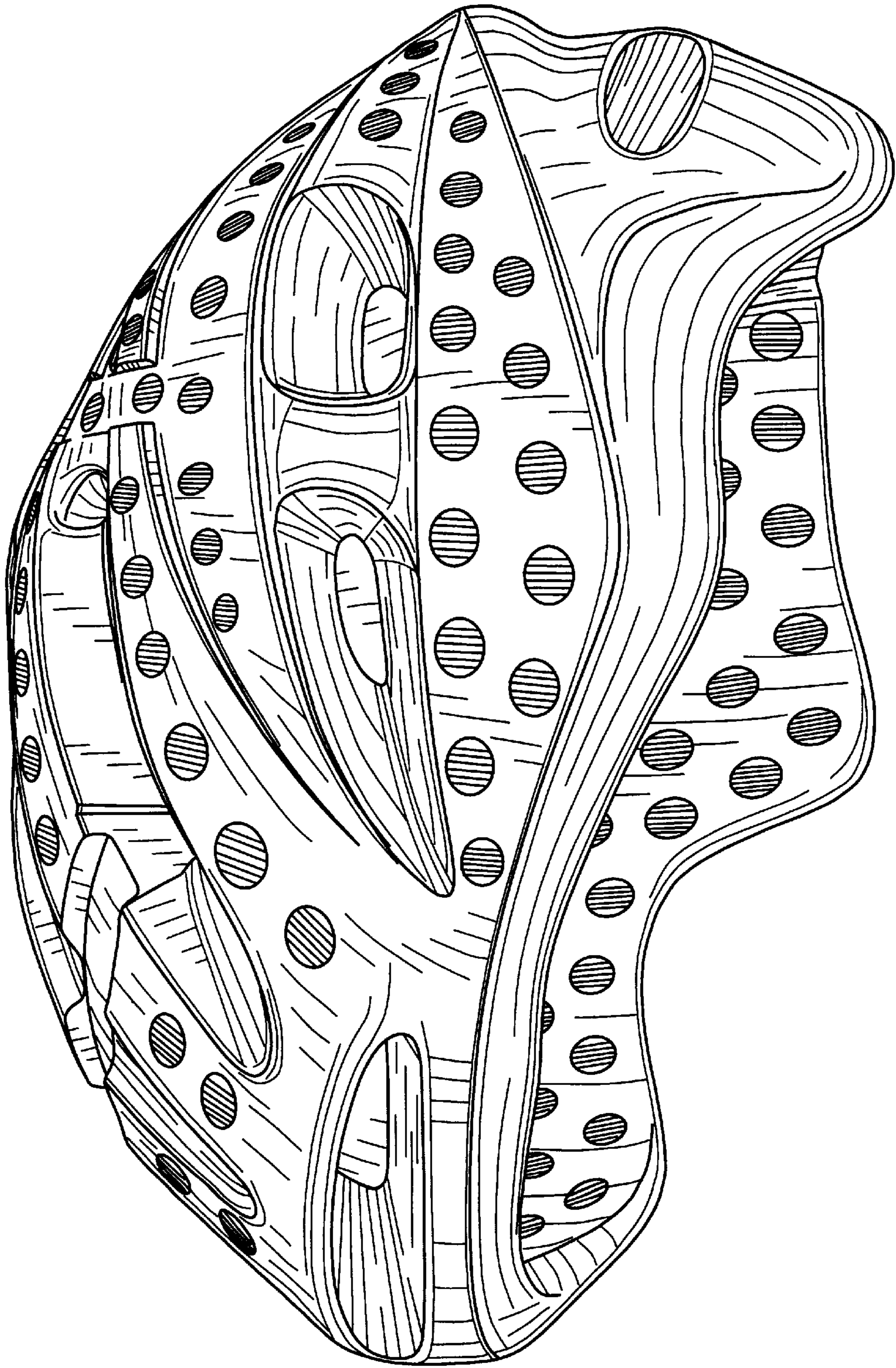

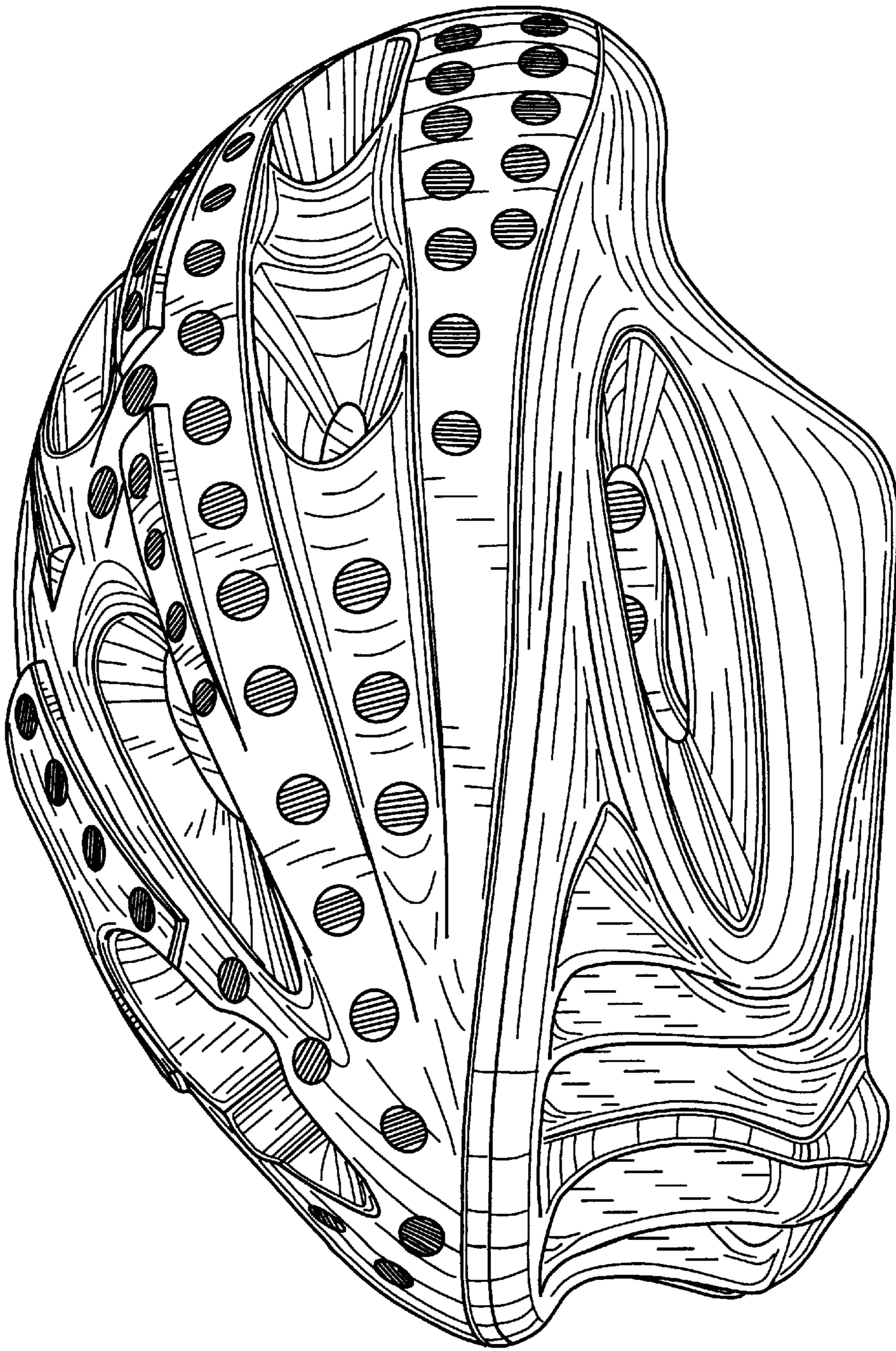

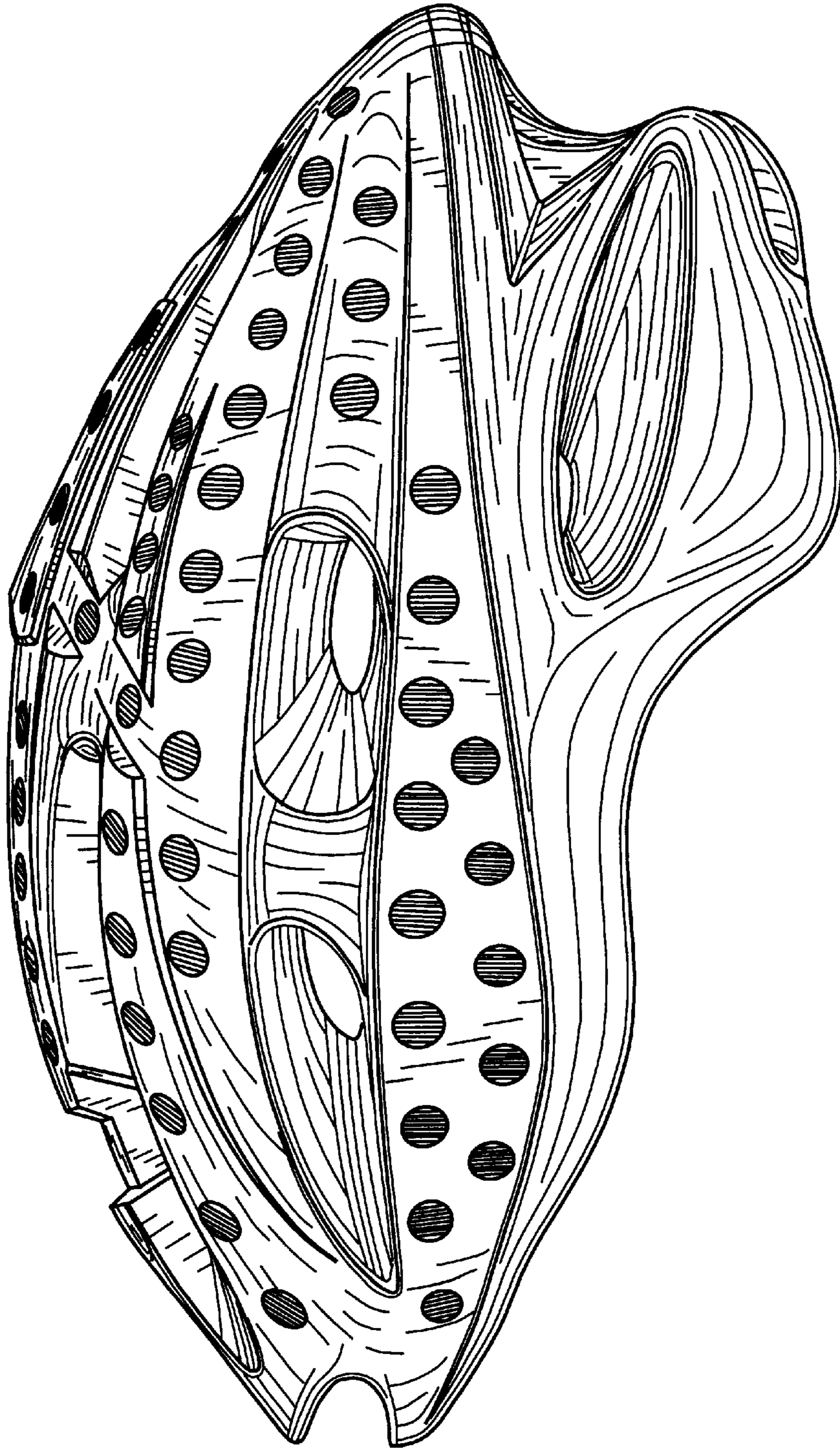

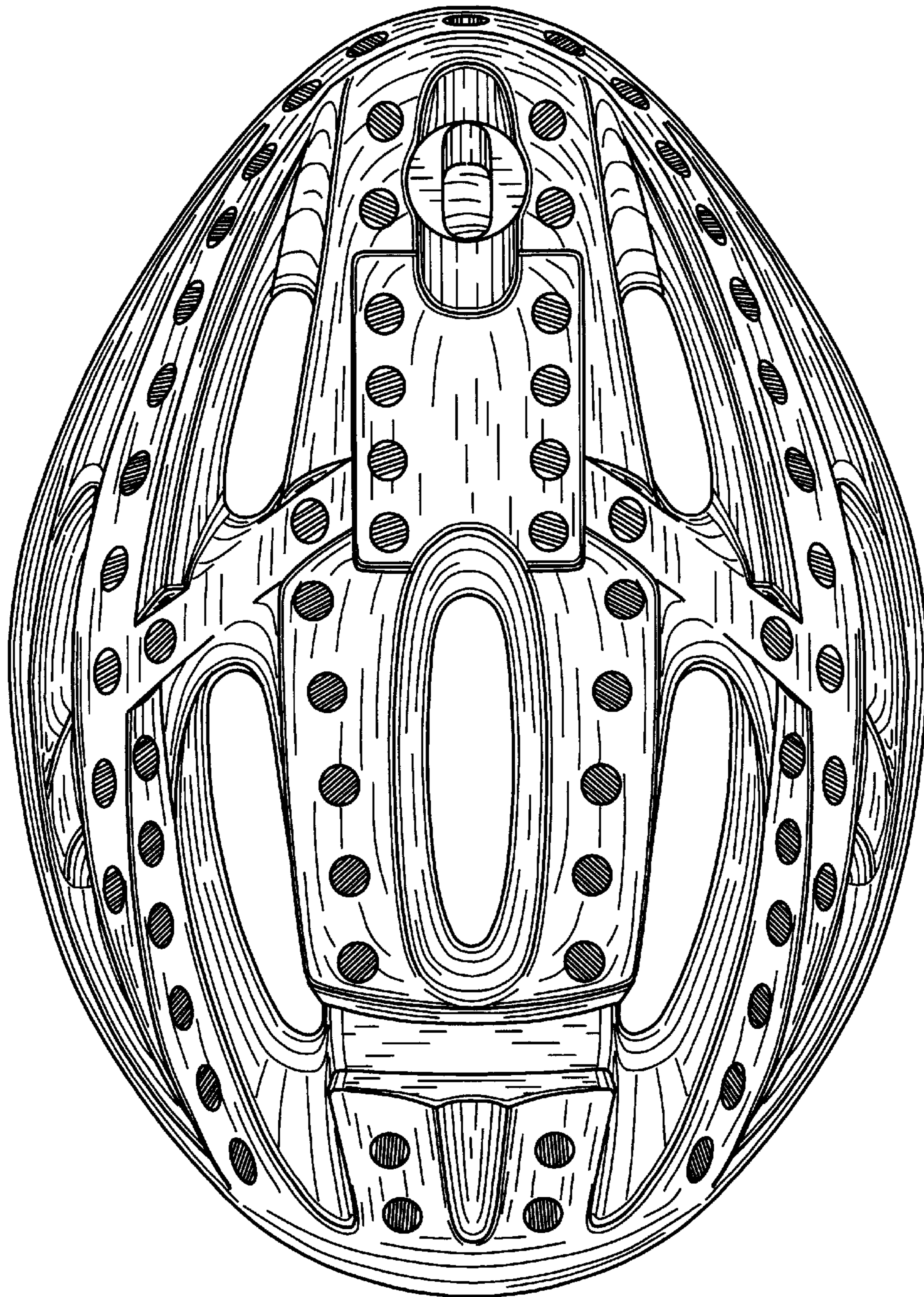

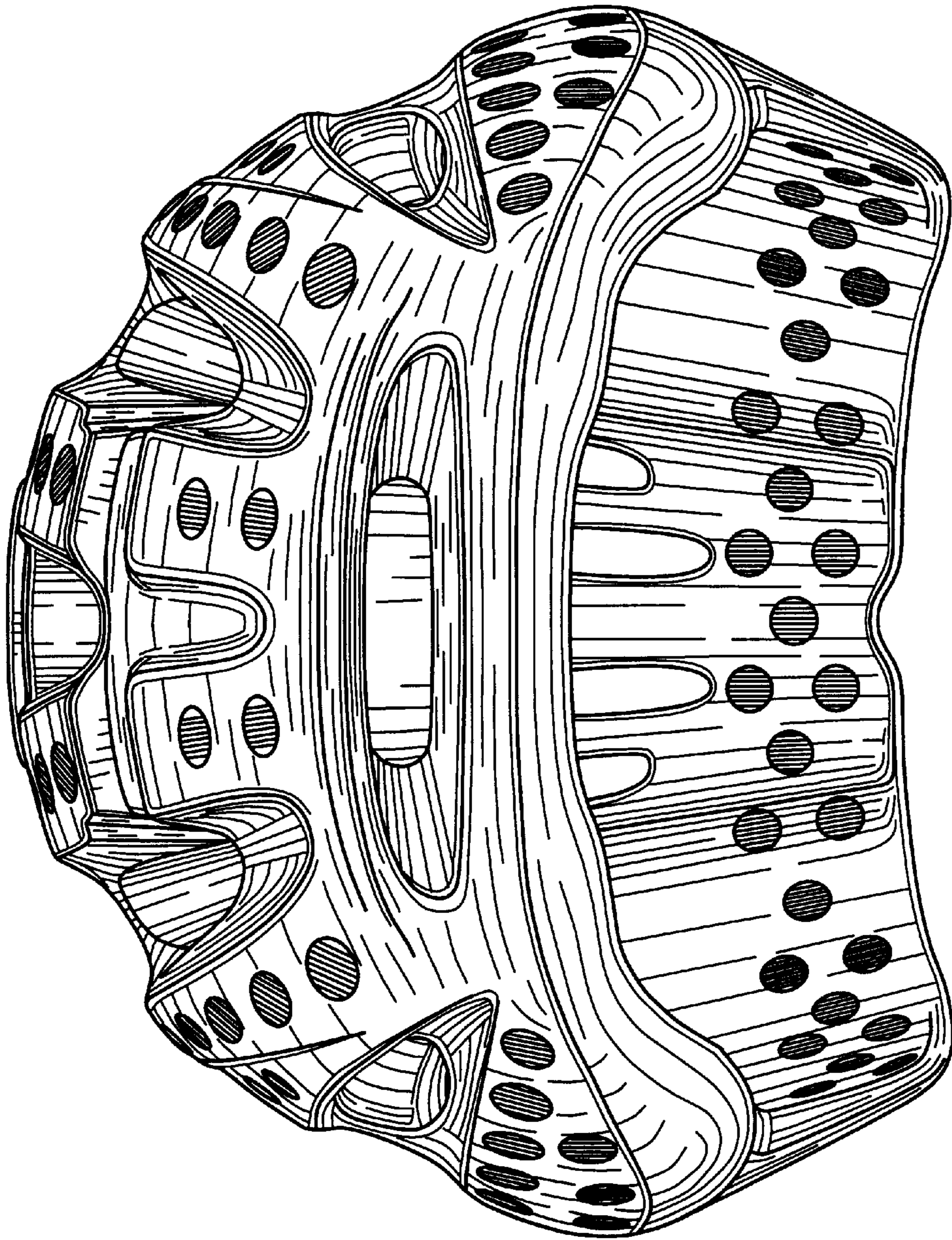

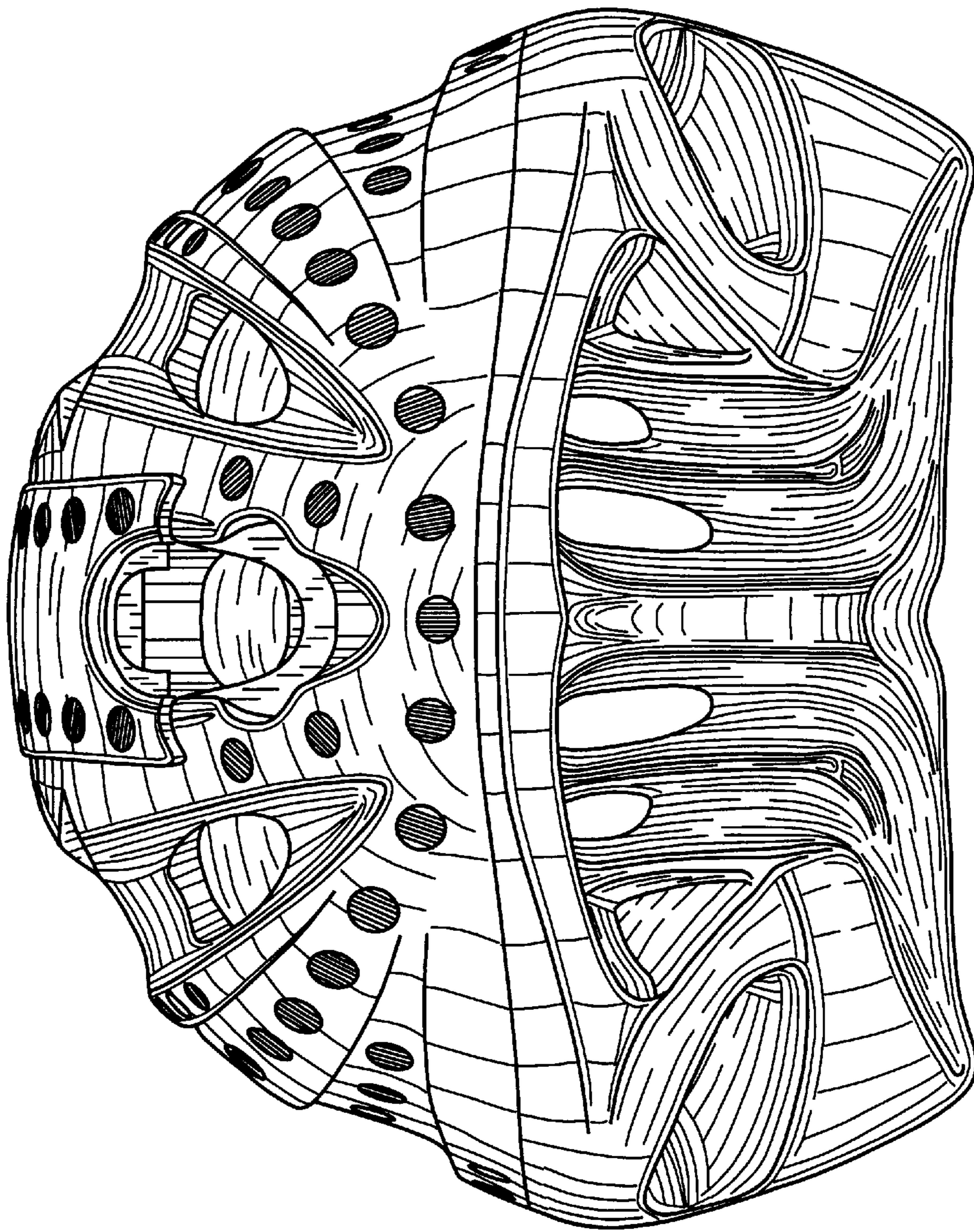

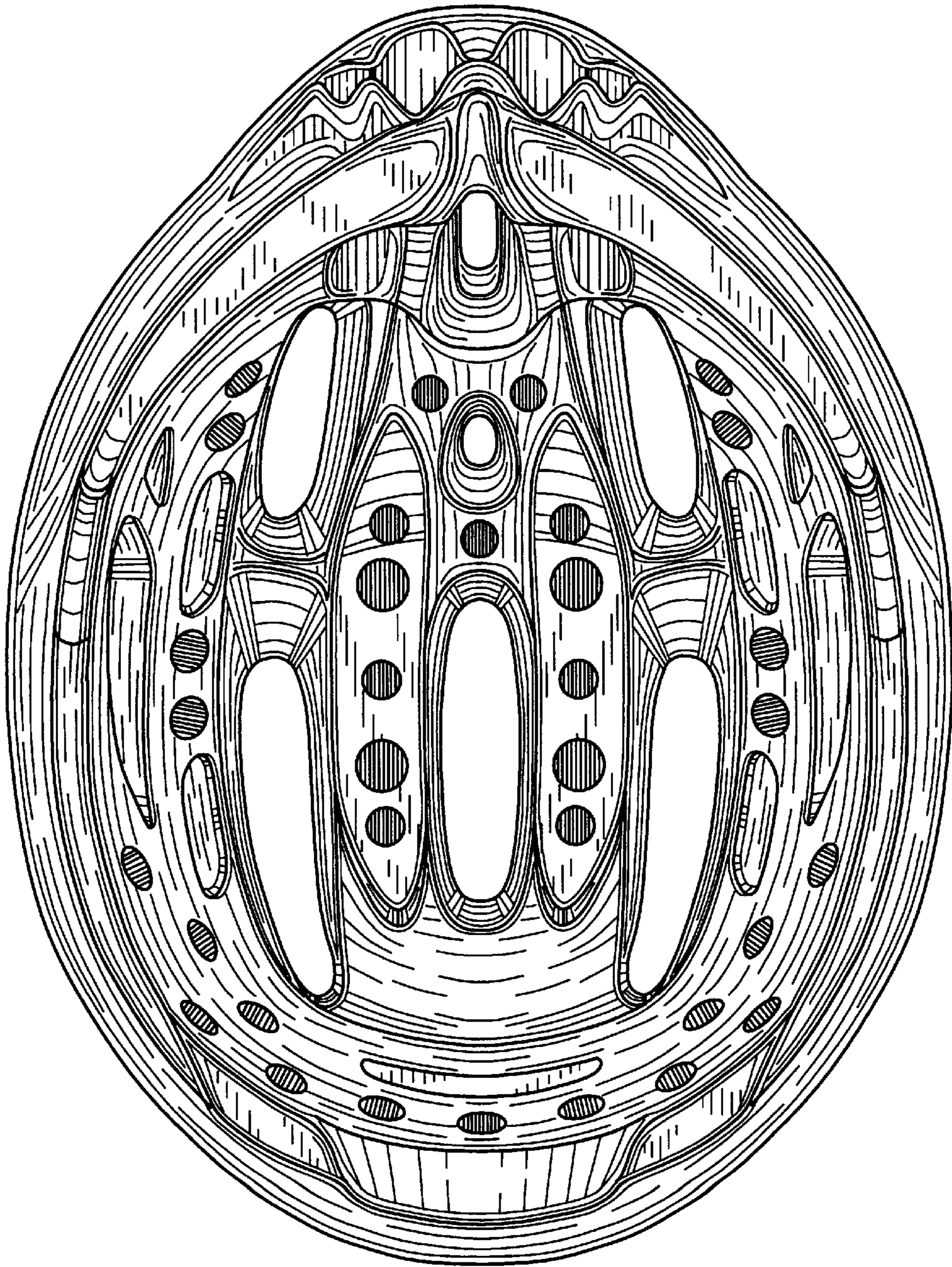
