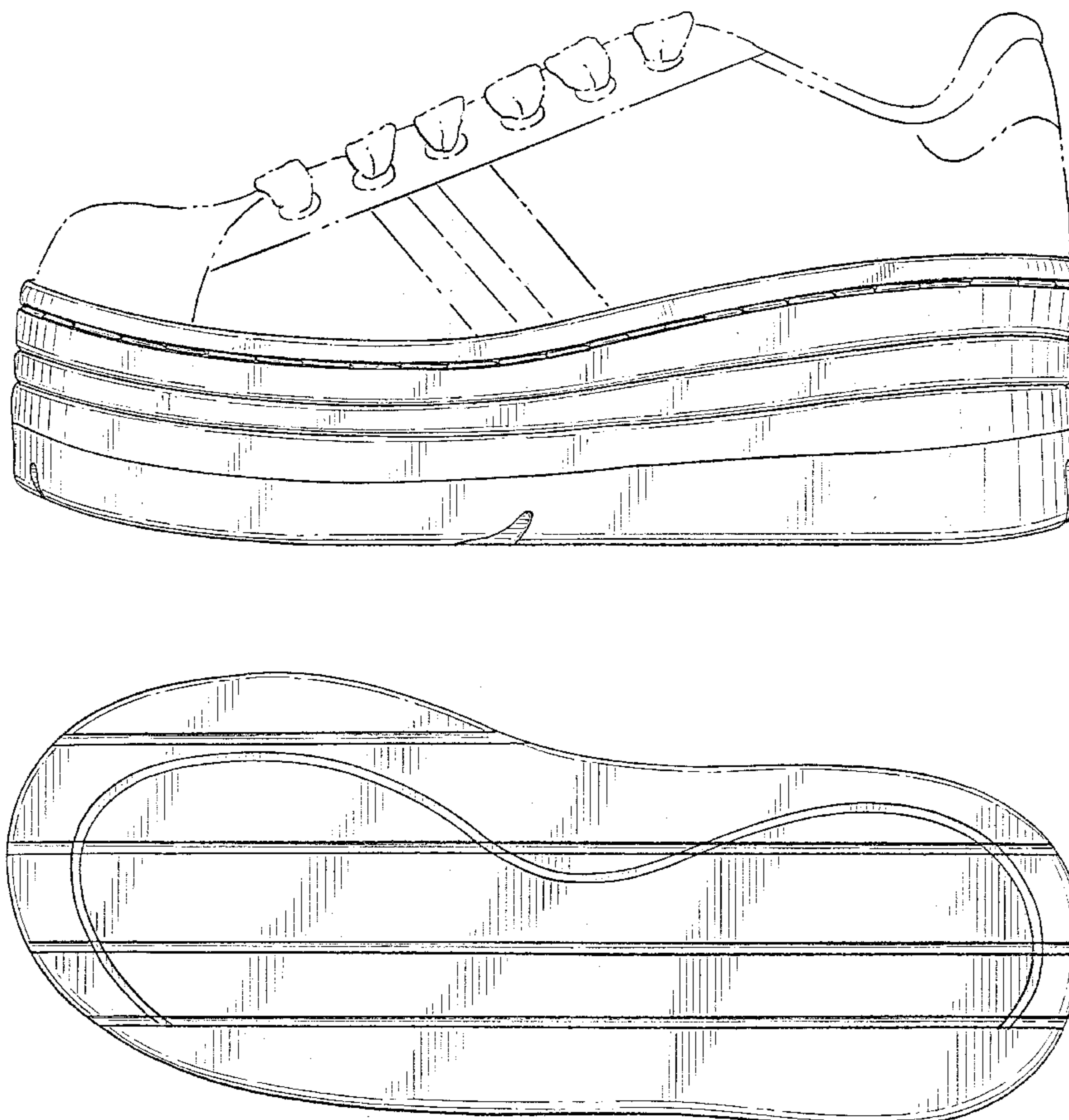
[57] **CLAIM**

The ornamental design for a combined shoe bottom and periphery, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the front, right and bottom of a shoe bottom and periphery showing my new design. FIG. 2 is a right side elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a front elevational view thereof; and FIG. 6 is a rear elevational view thereof; The broken line showing the shoe upper in the figures is for illustrative purposes only and forms no part of the claimed design.

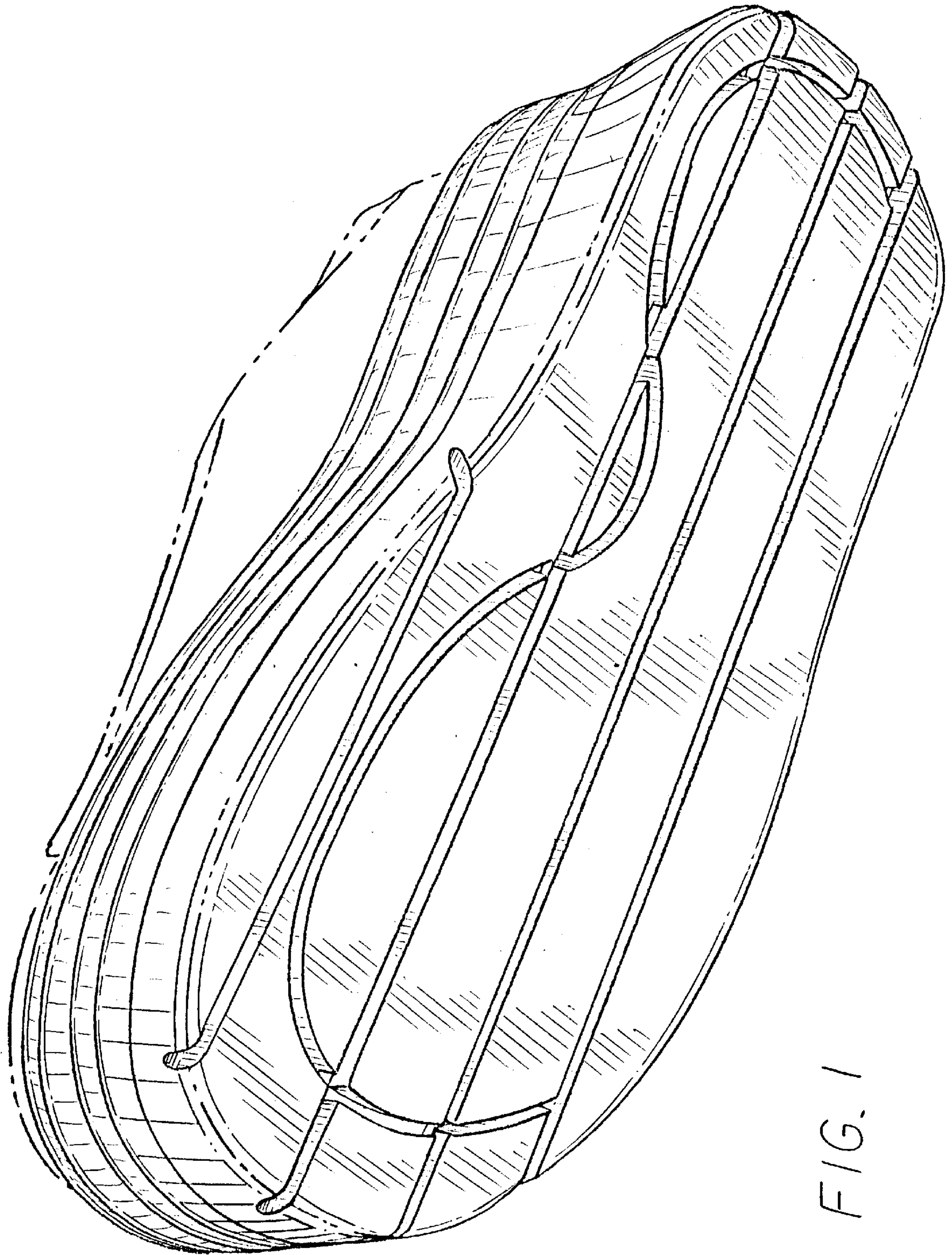

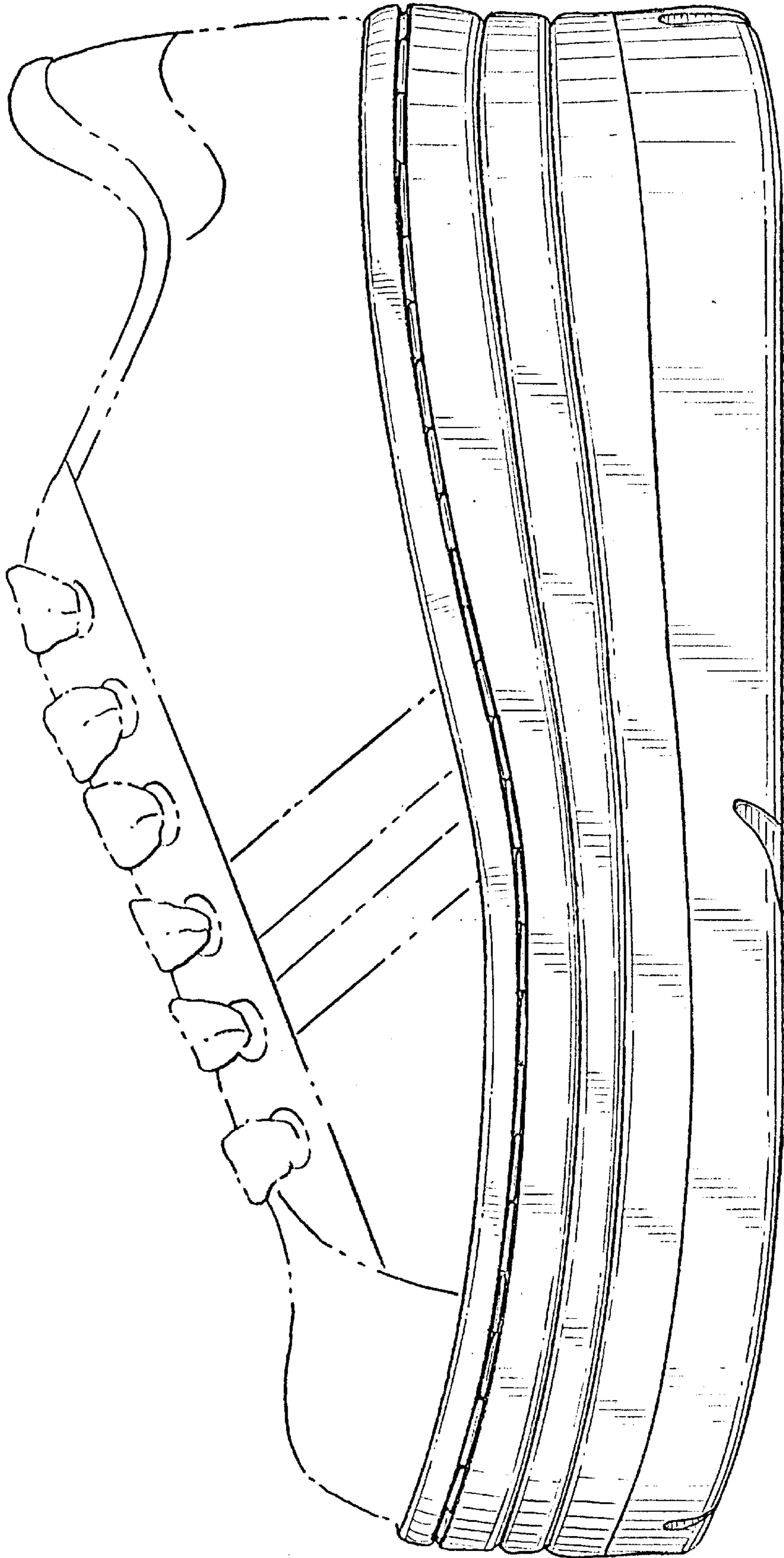

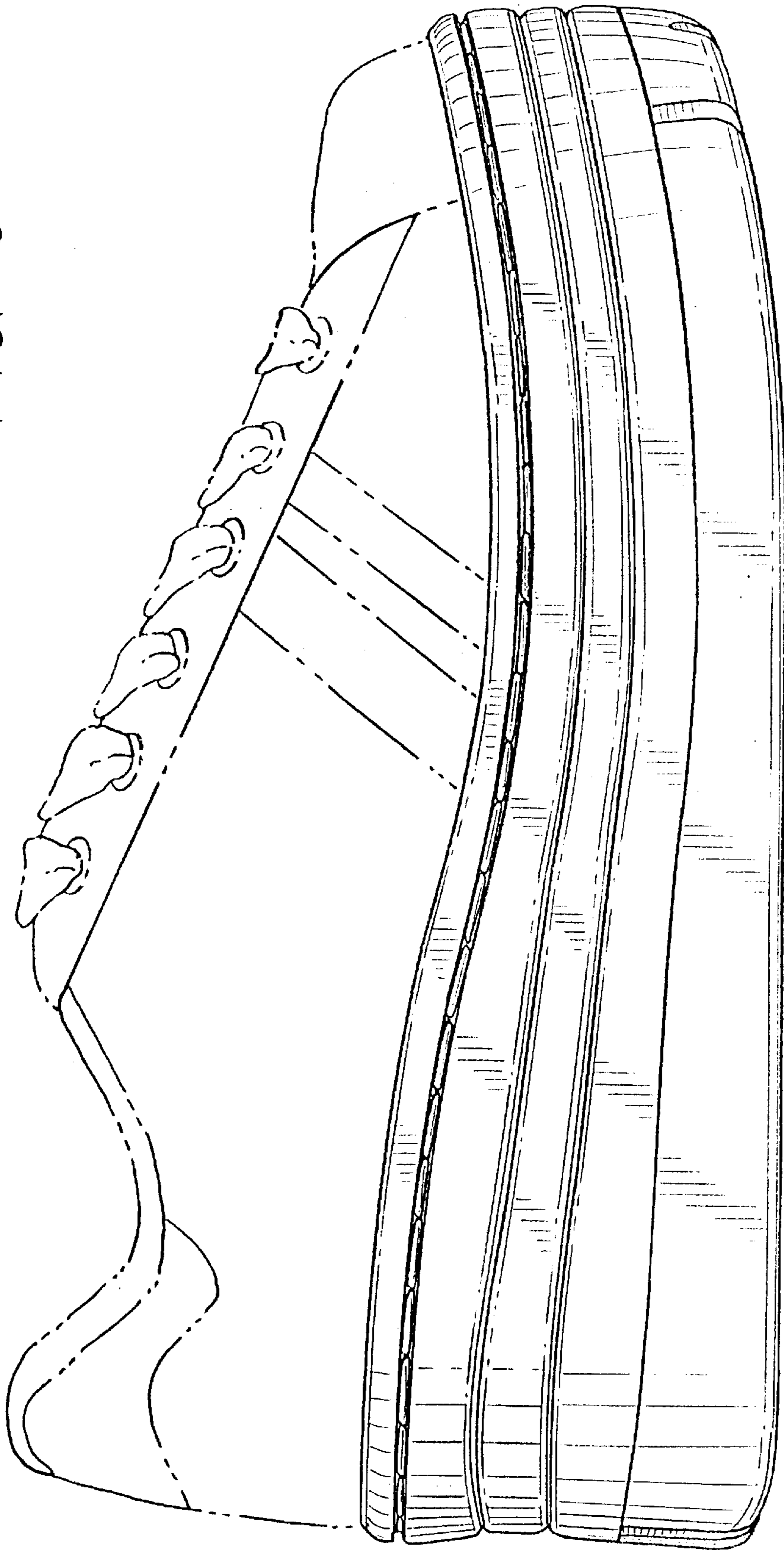

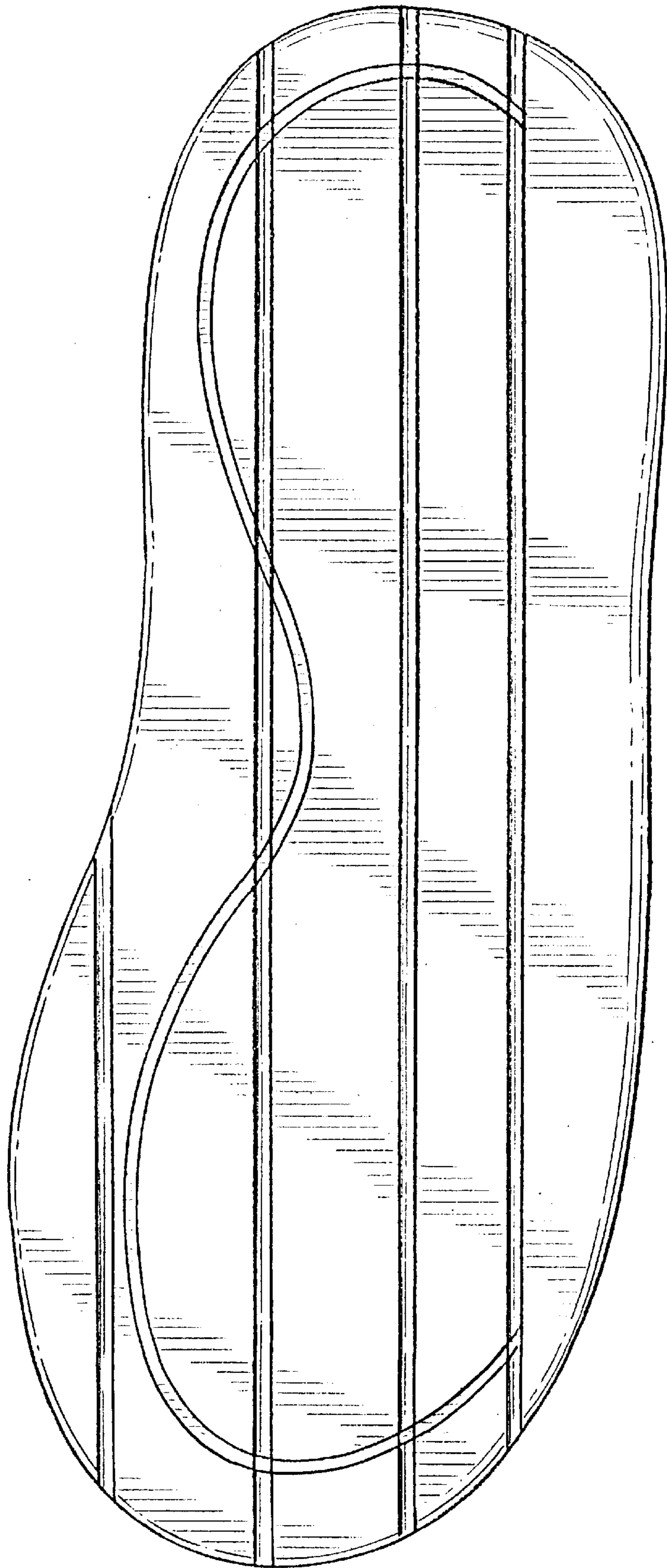

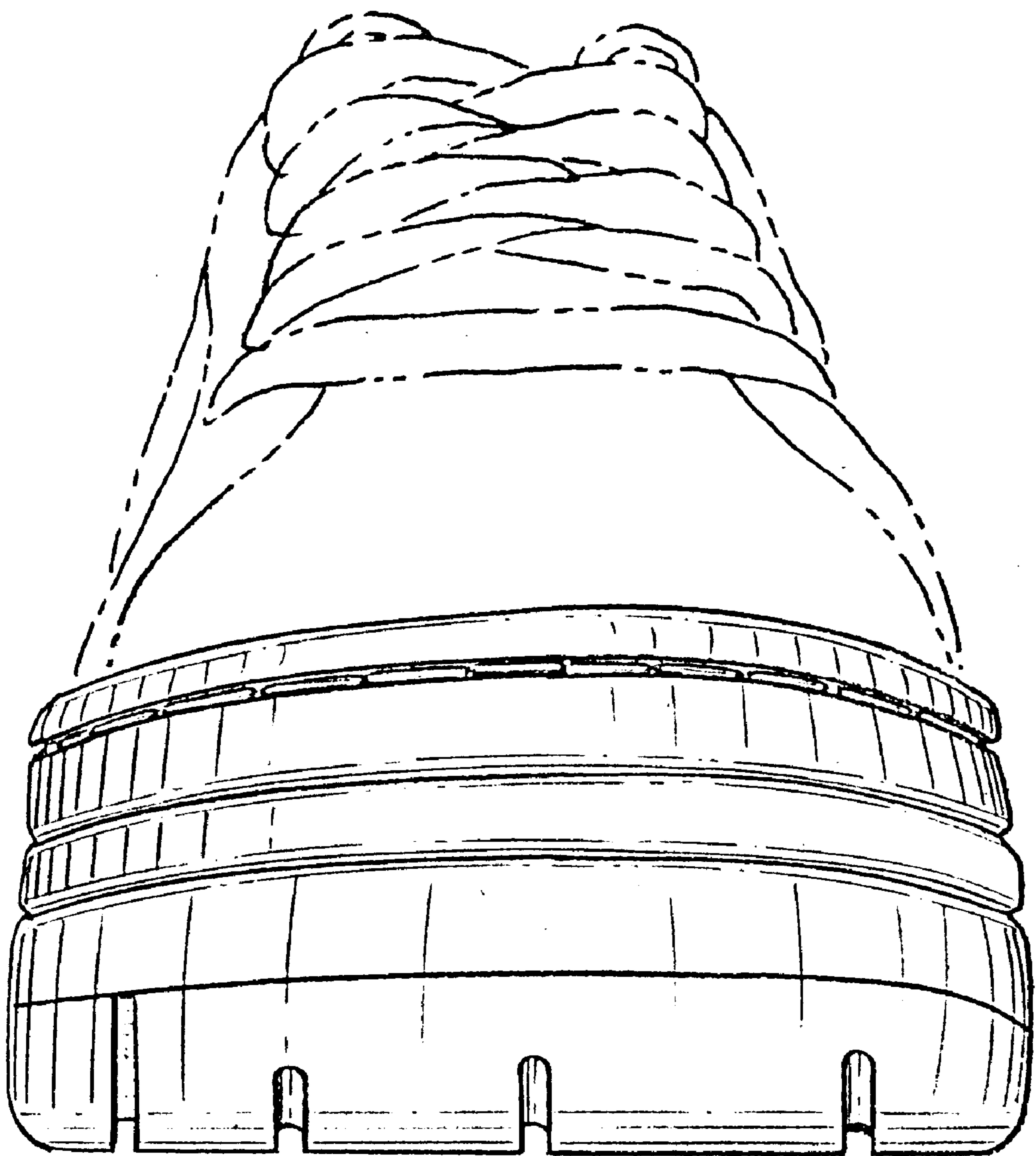
