## DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of a menu housing showing our new design.

FIG. 14 is a rear elevational view of the third embodiment thereof;

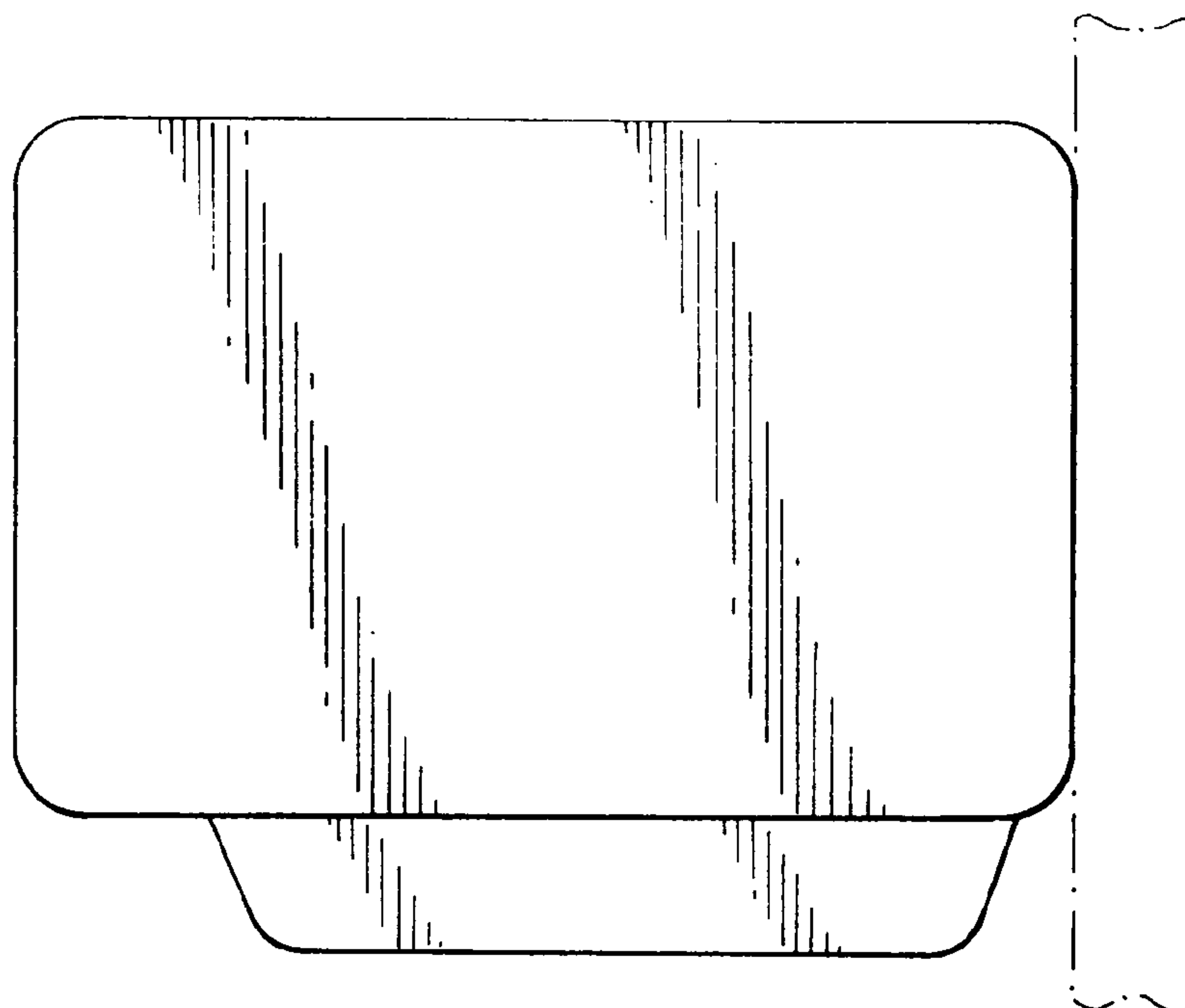
FIG. 15 is a top plan view of the third embodiment thereof;

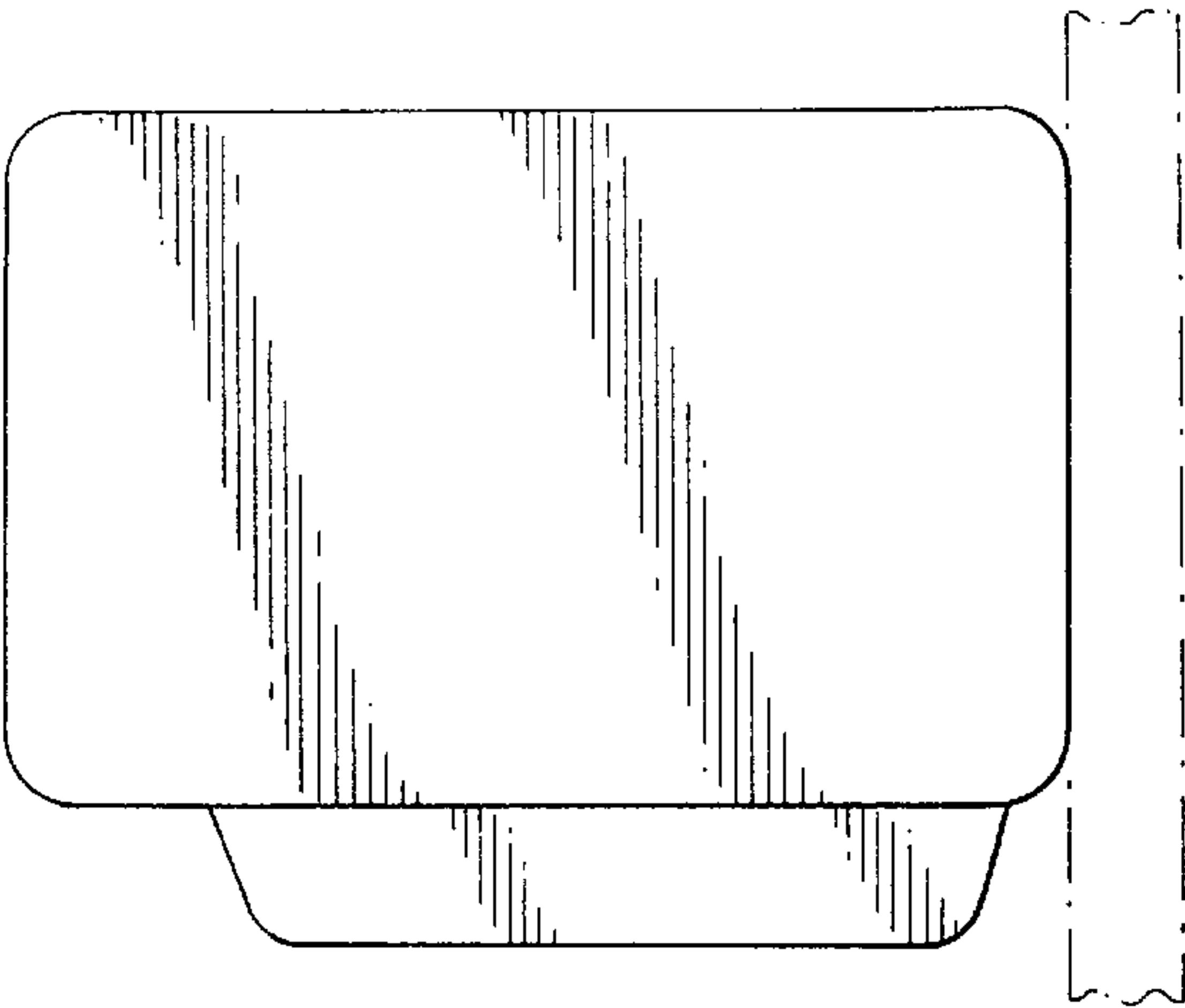

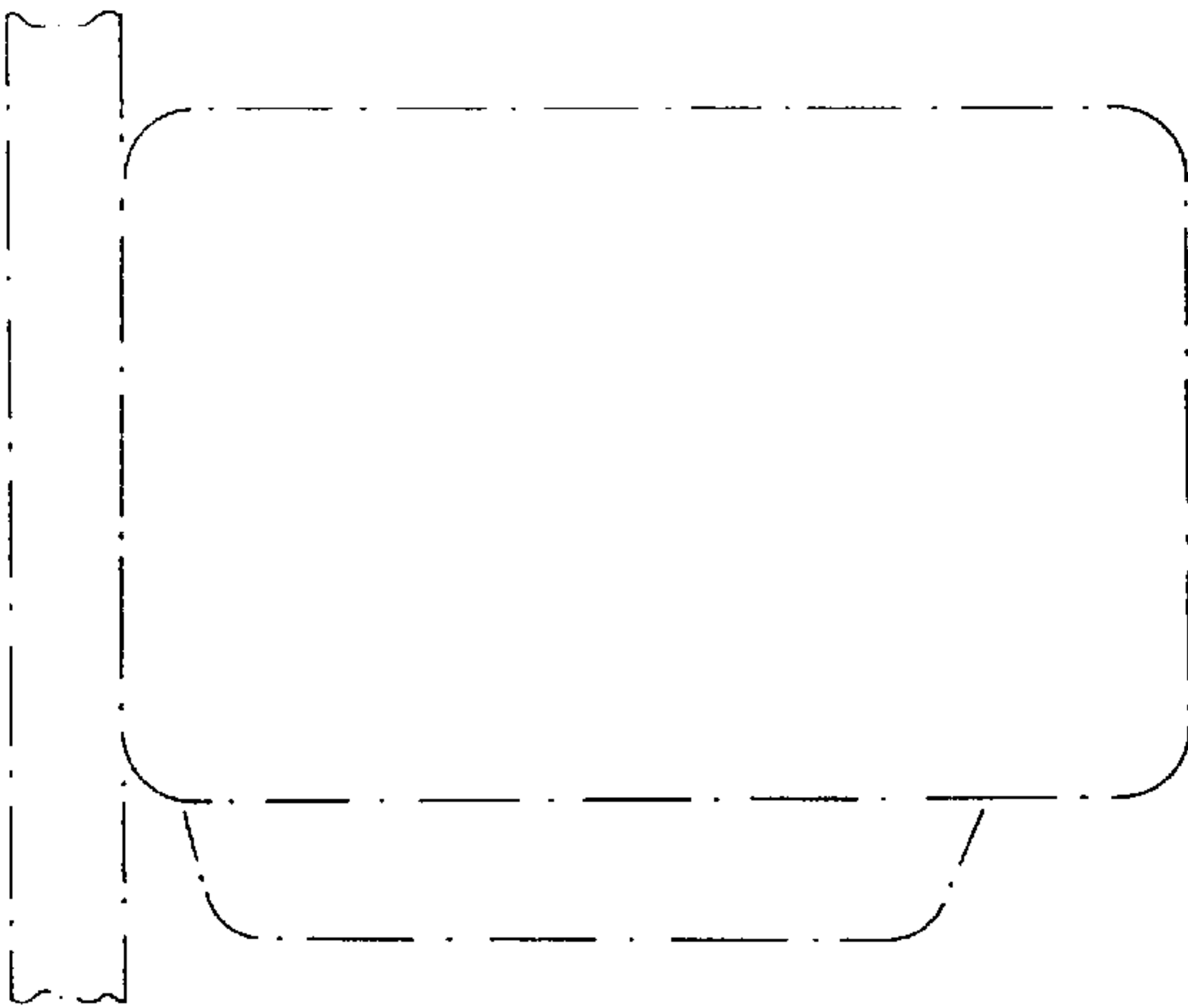

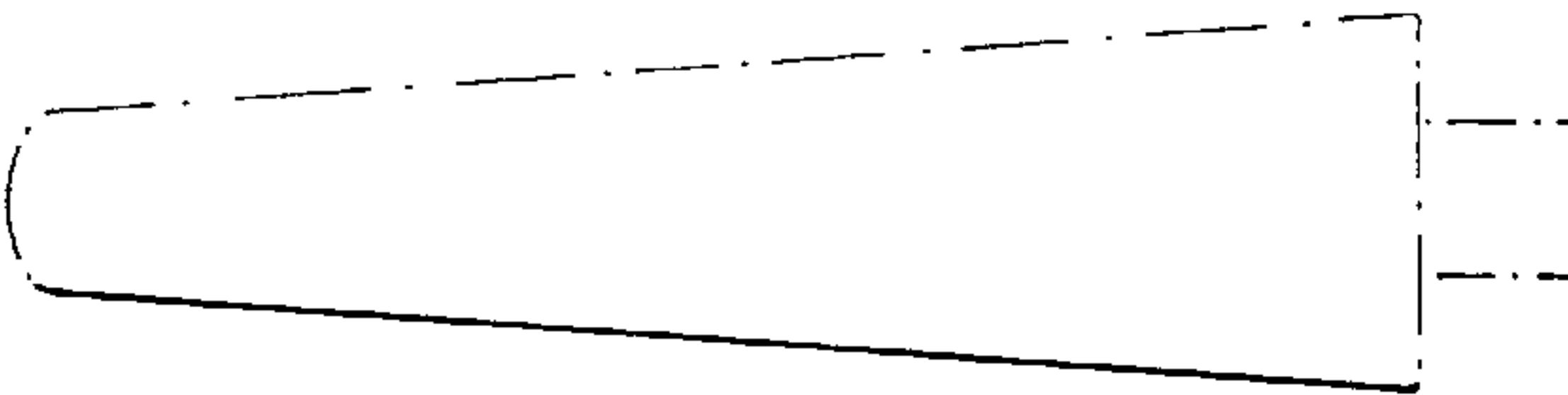

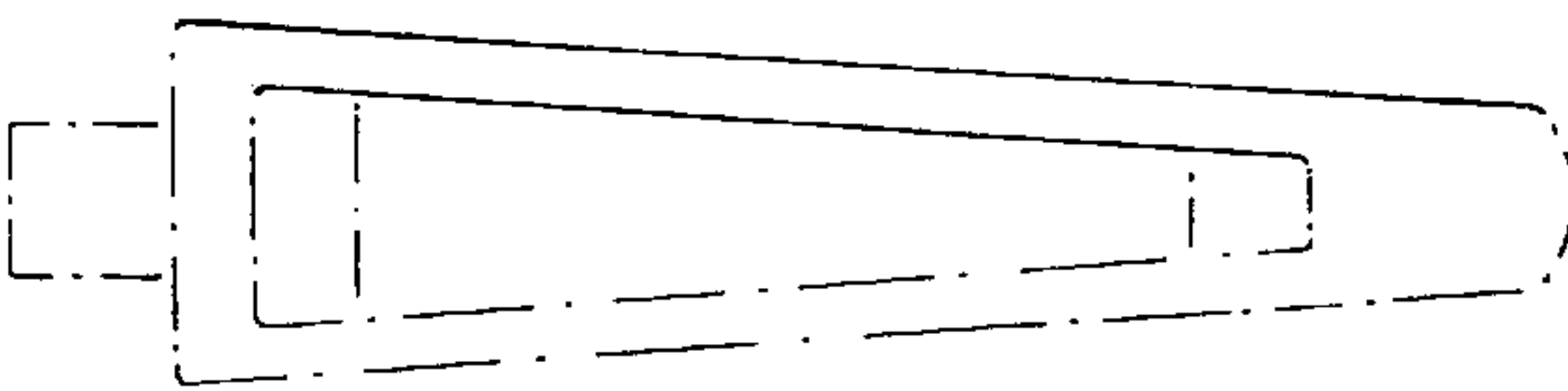

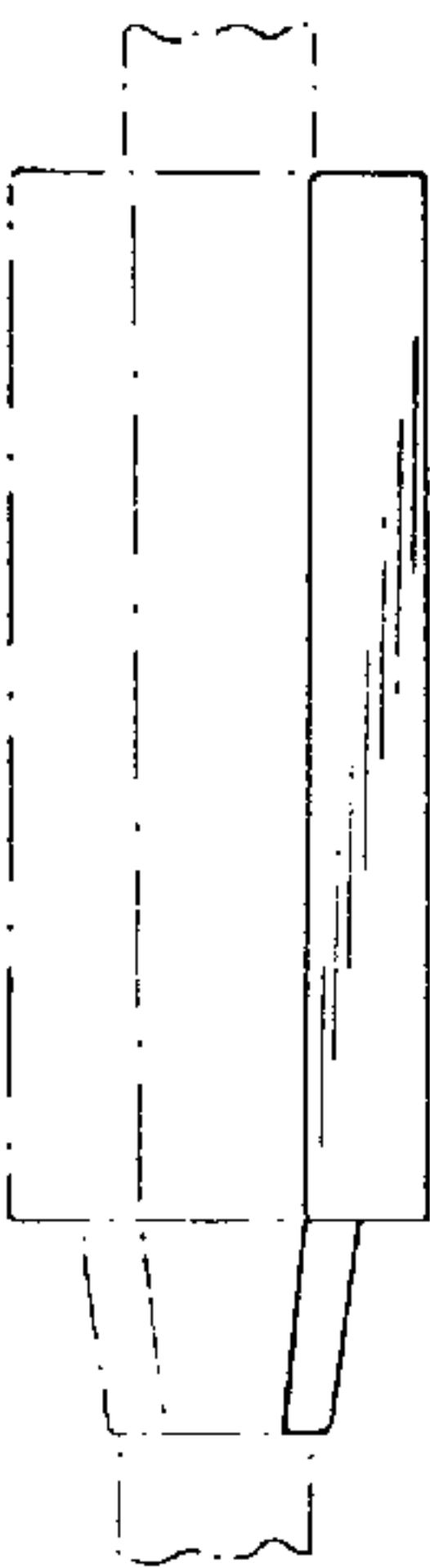

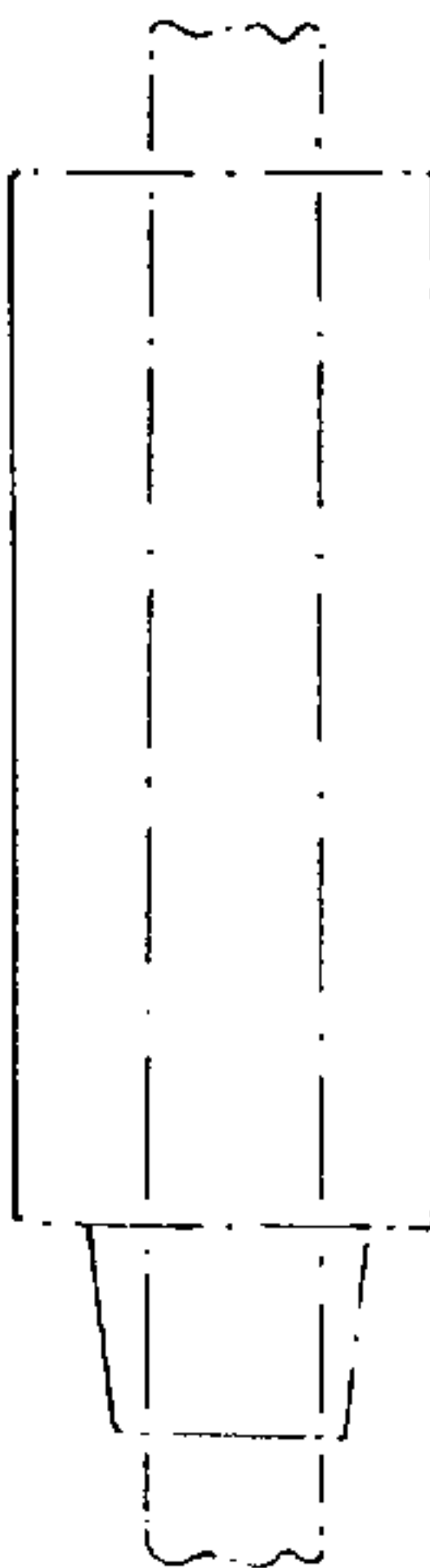

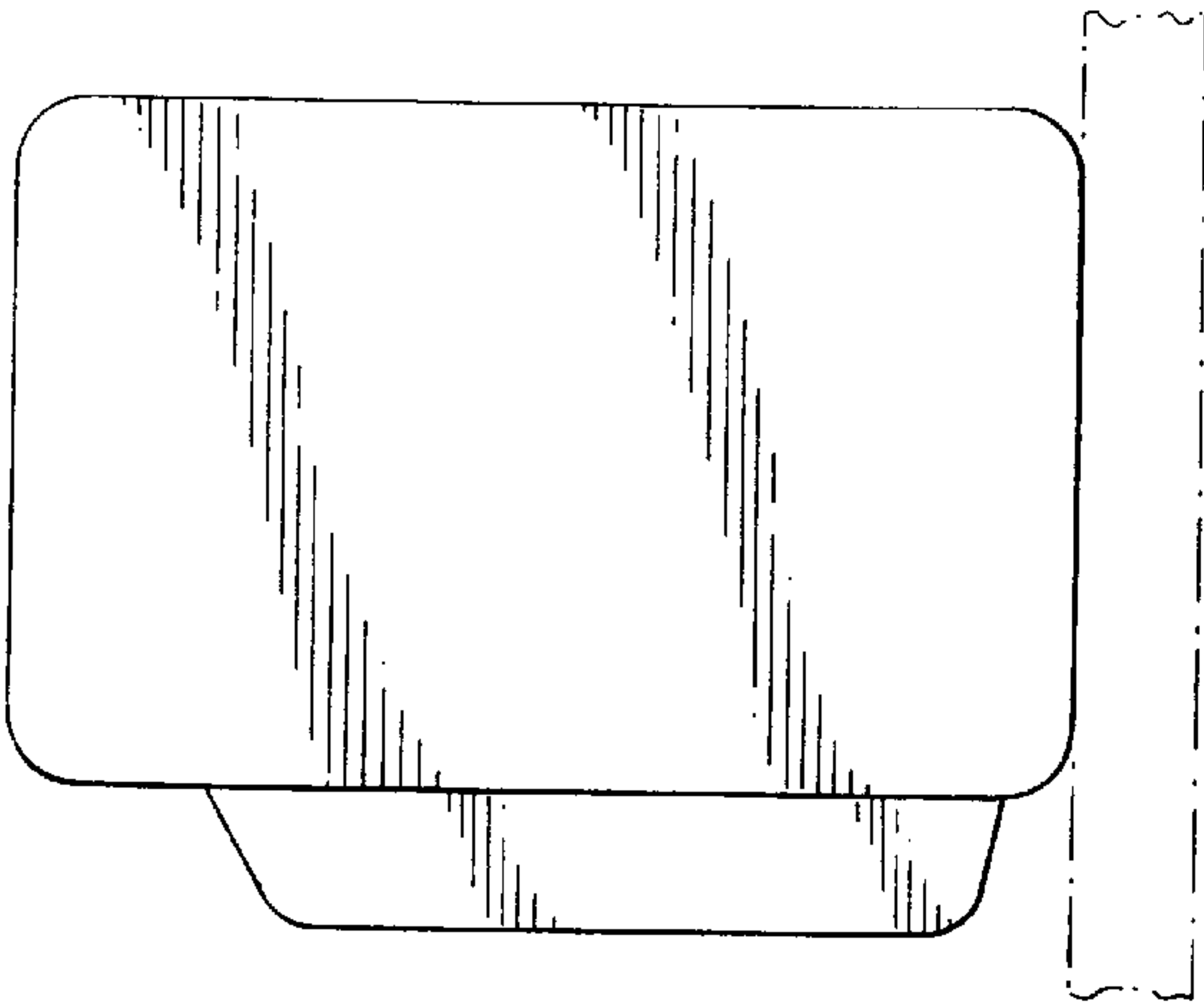

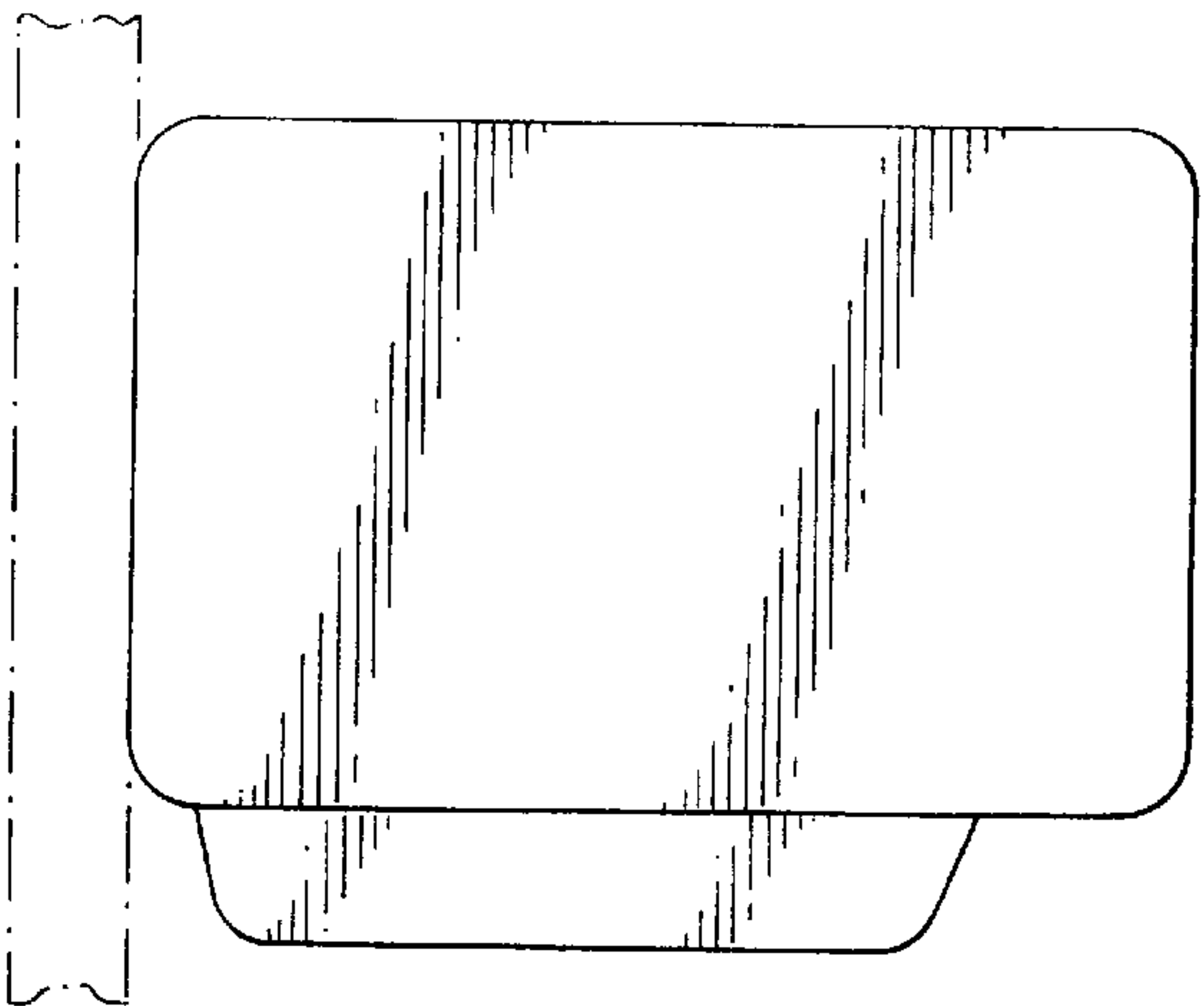

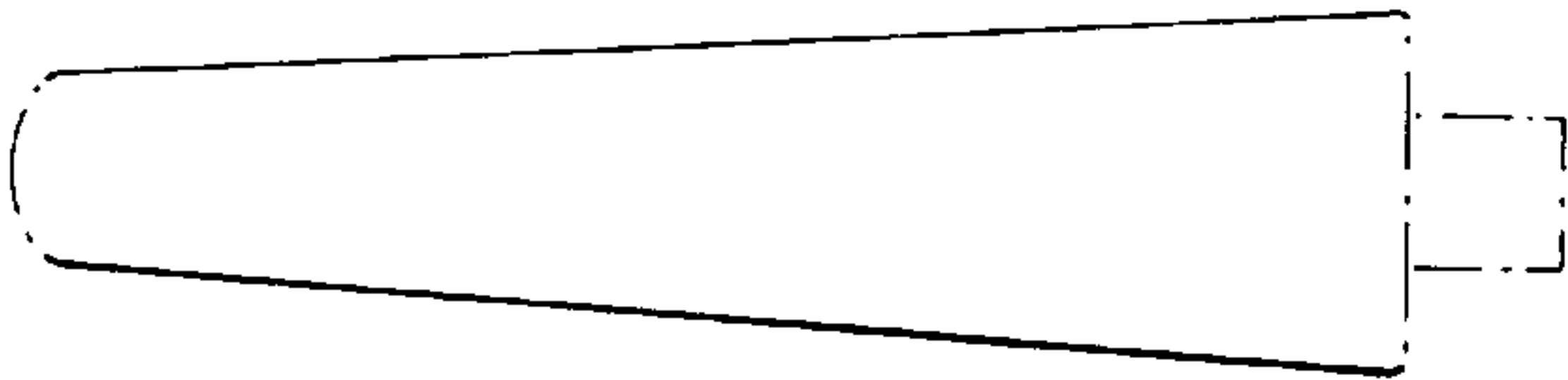

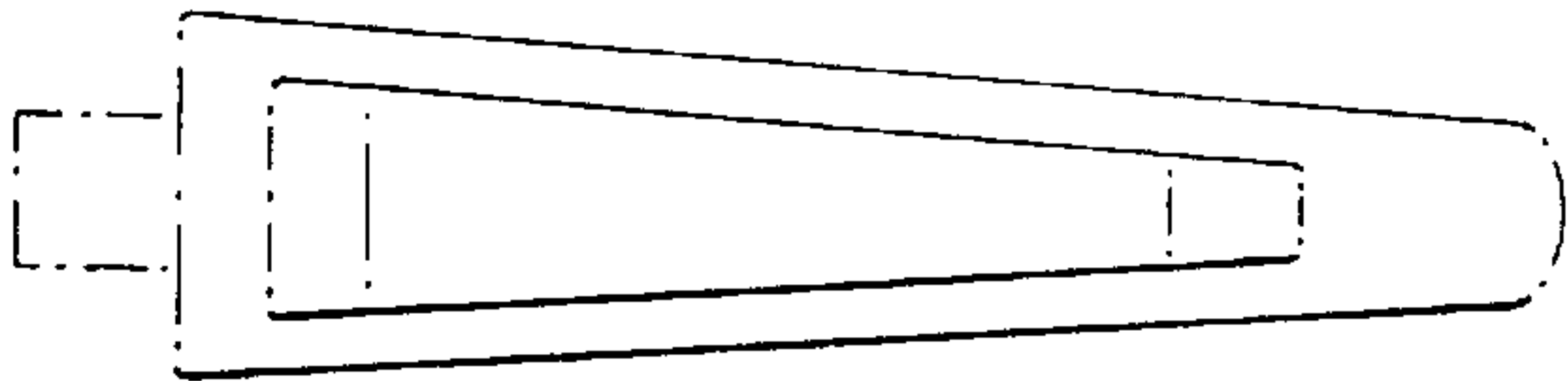

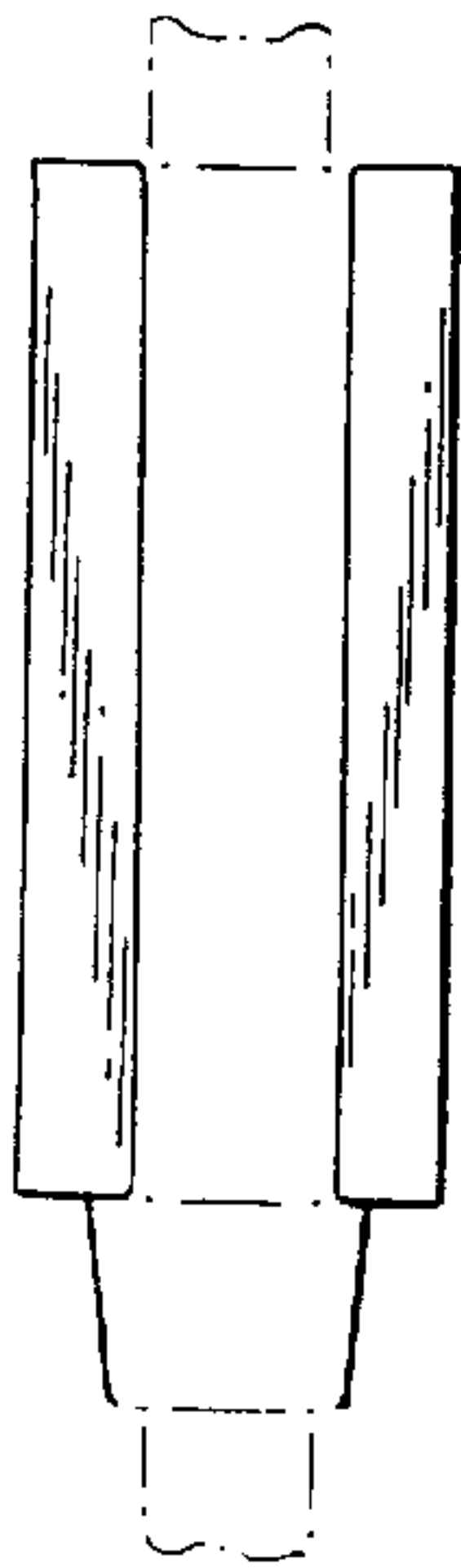

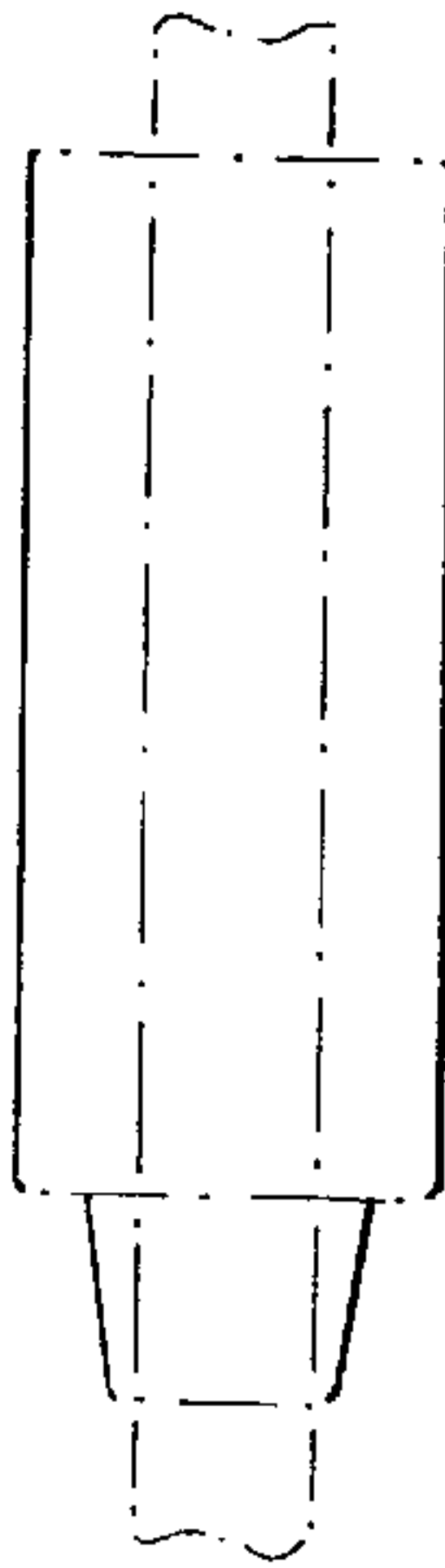

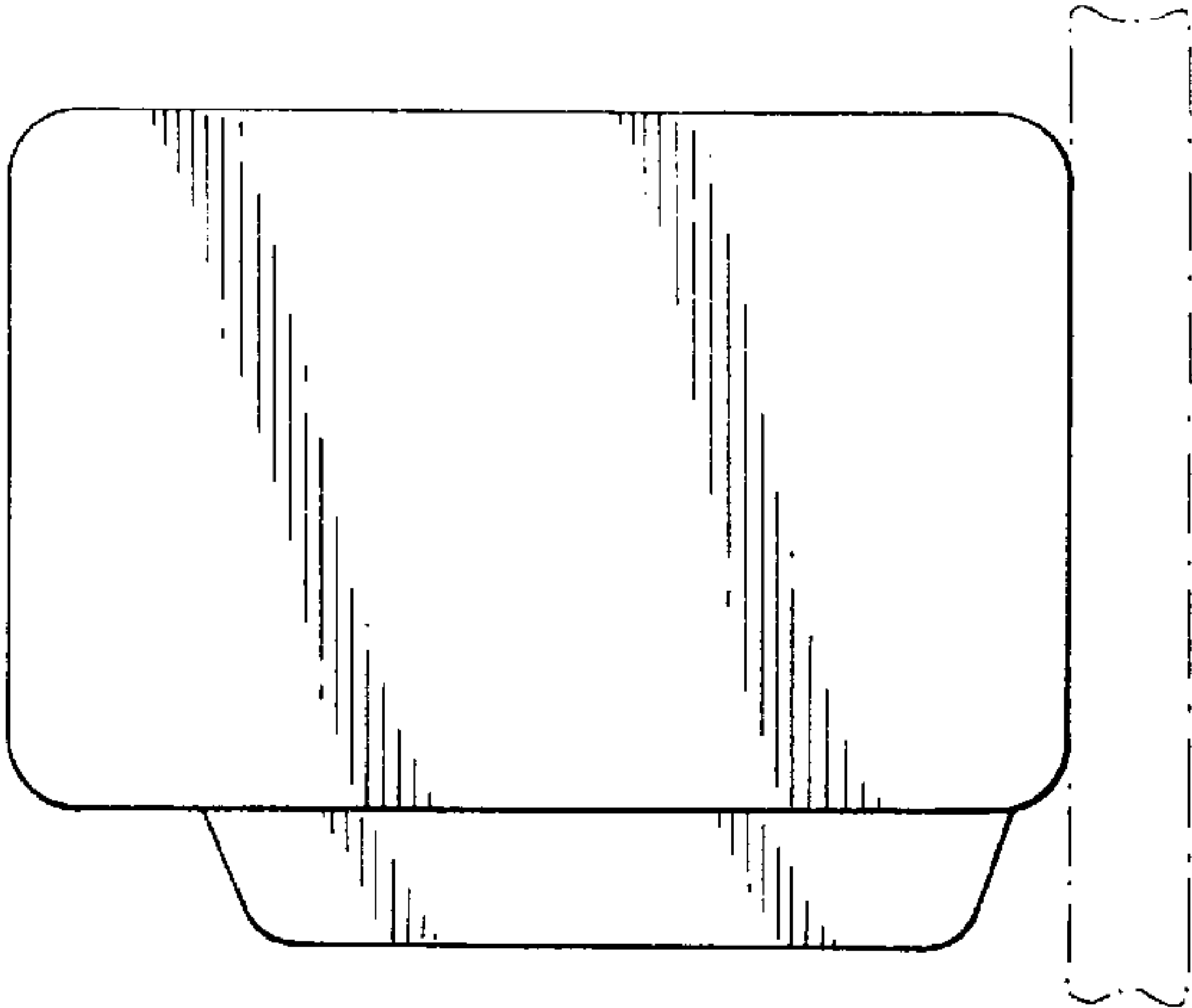

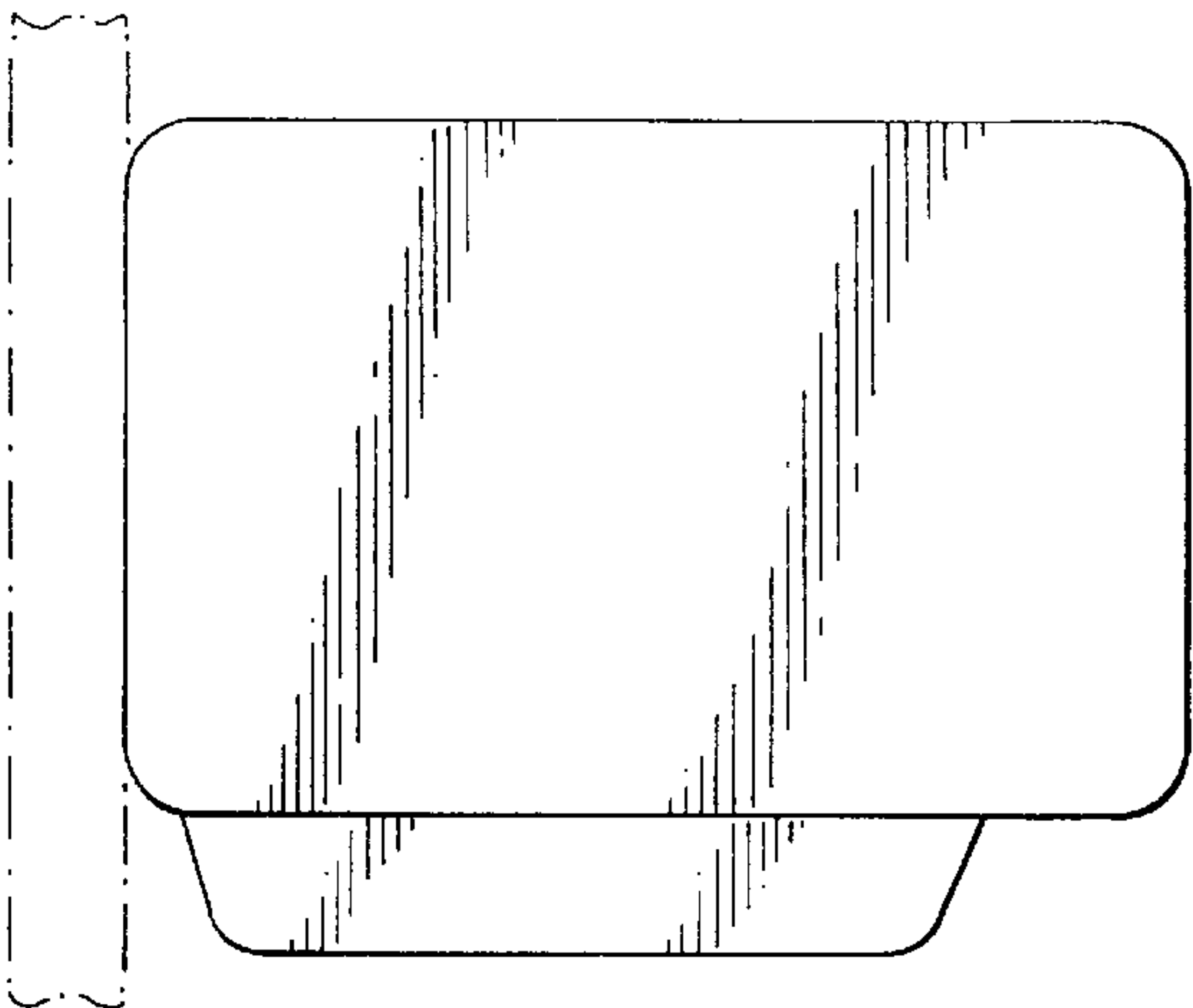

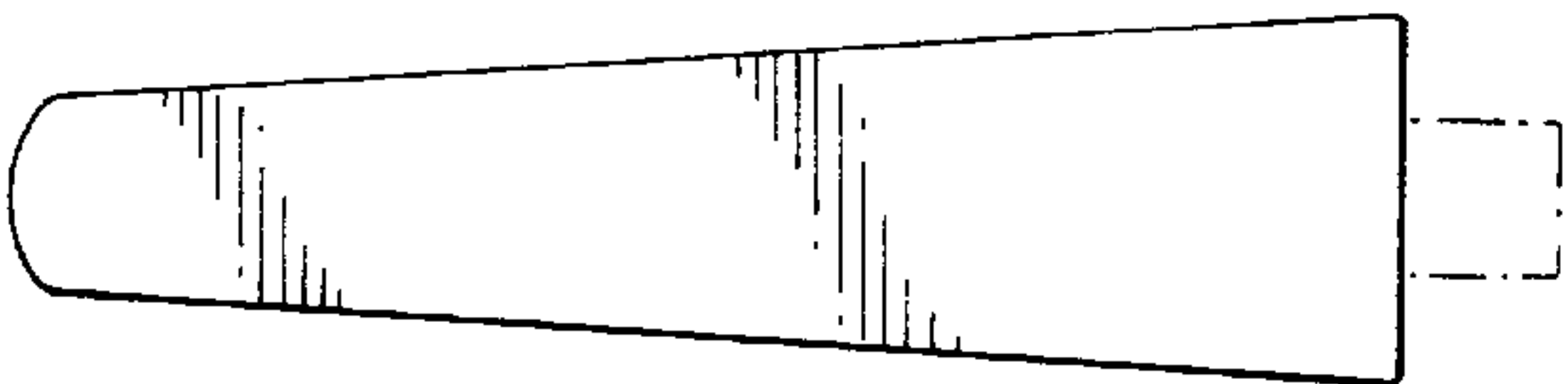

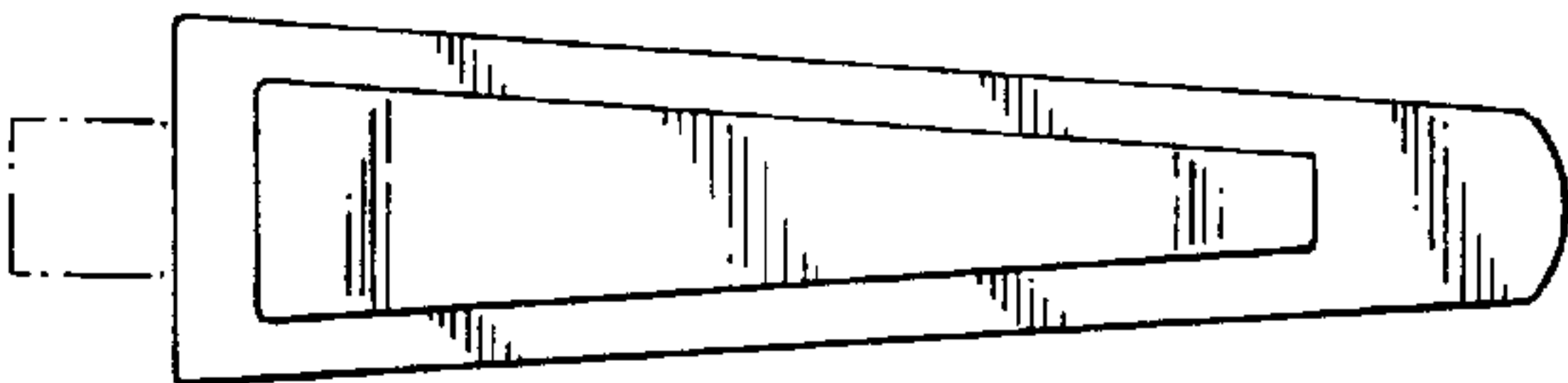

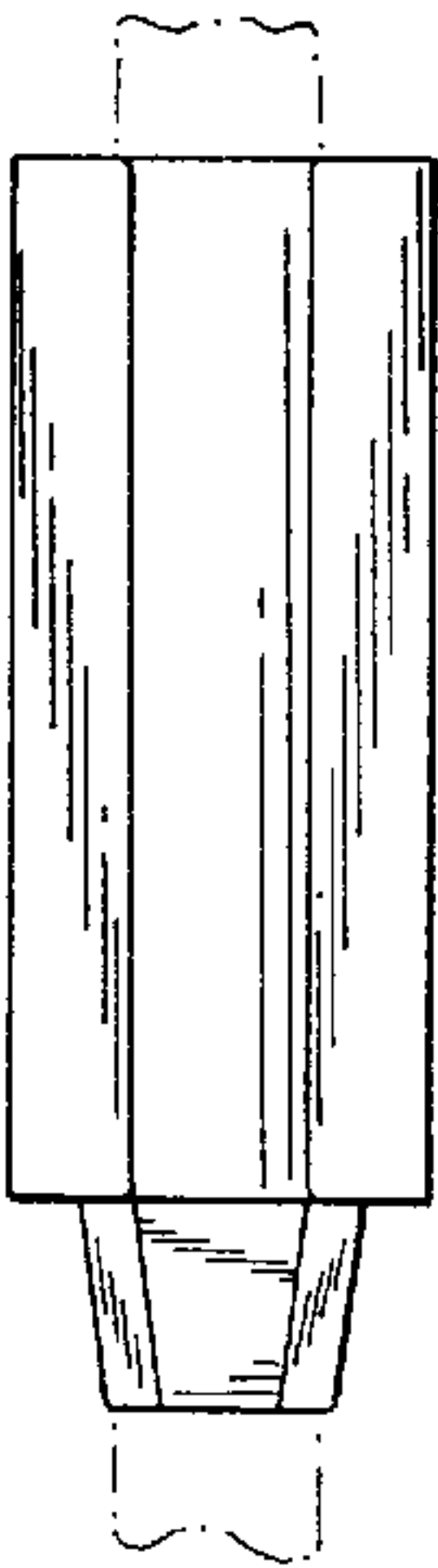

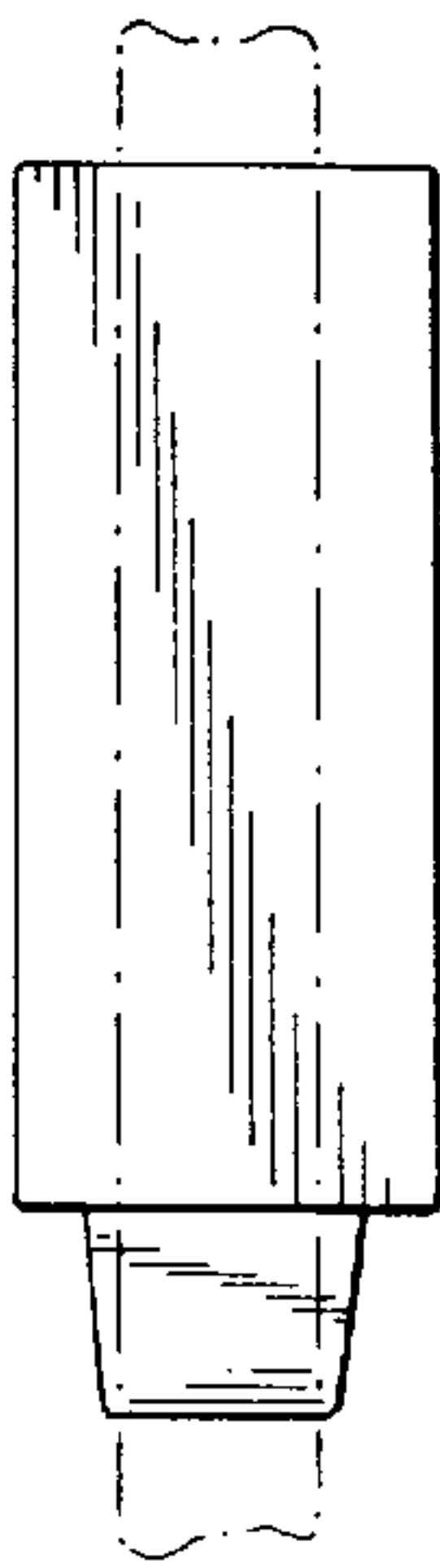
