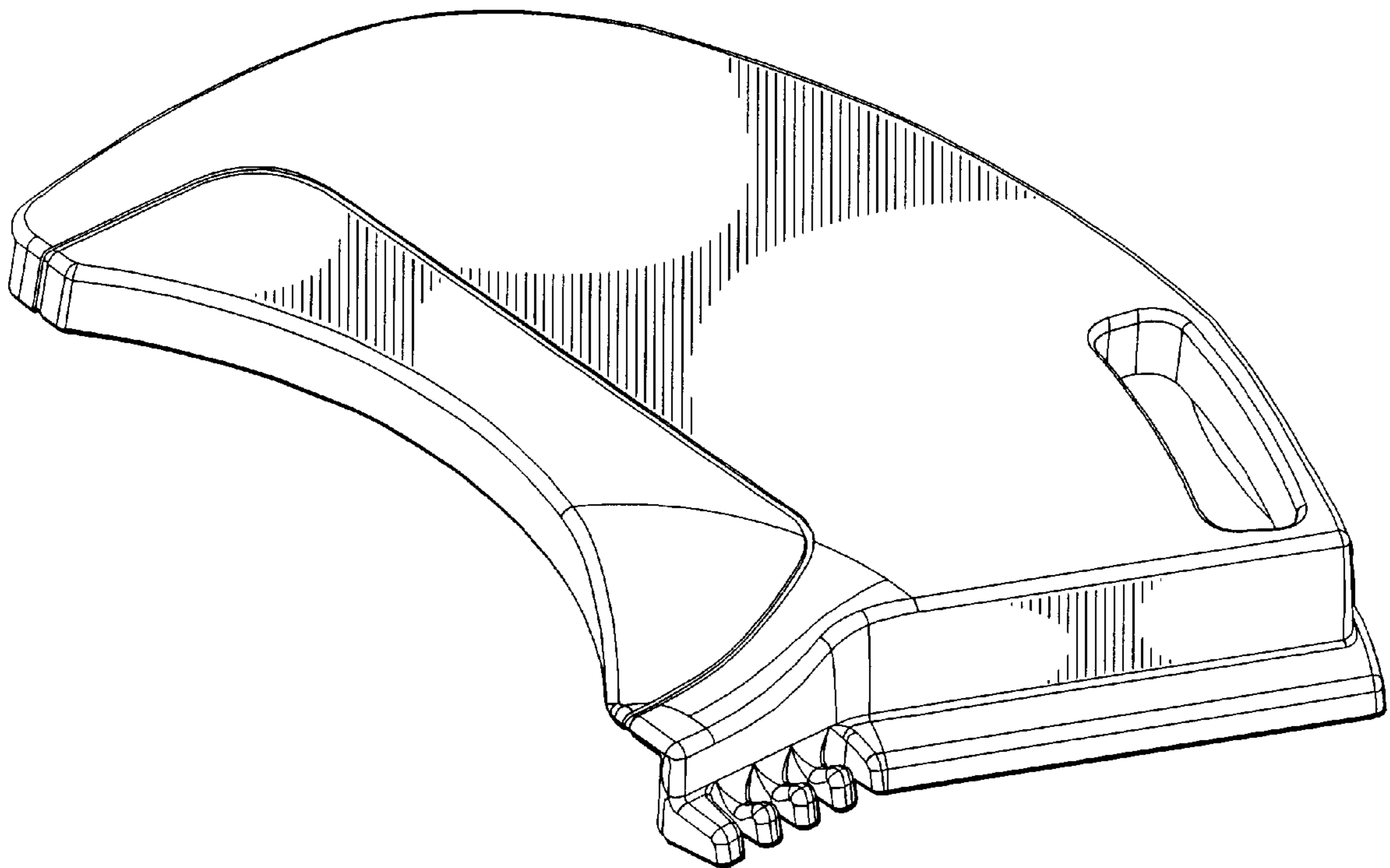

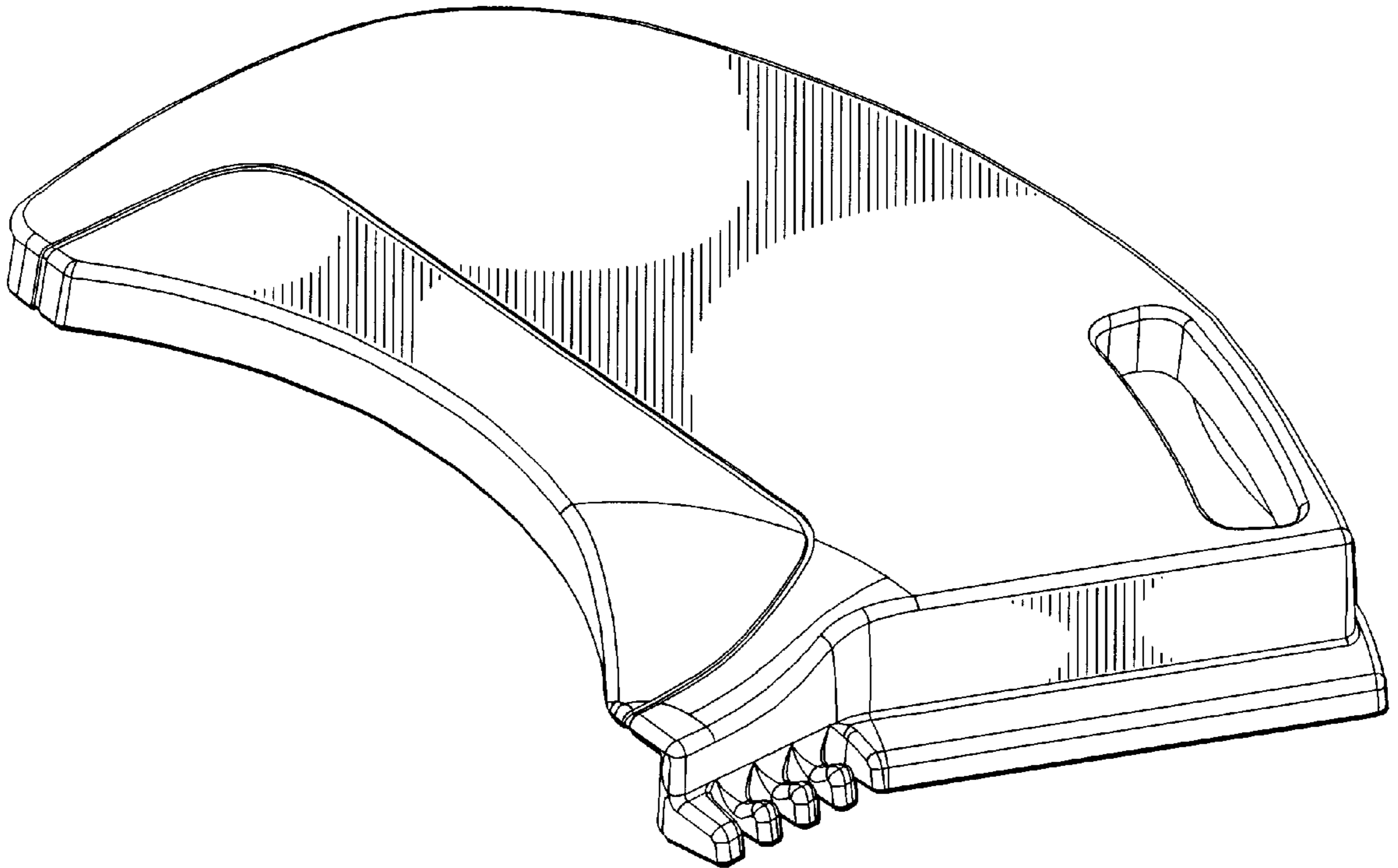
The ornamental design for a shelf for barbecue grill stand, as shown and described.

**DESCRIPTION**

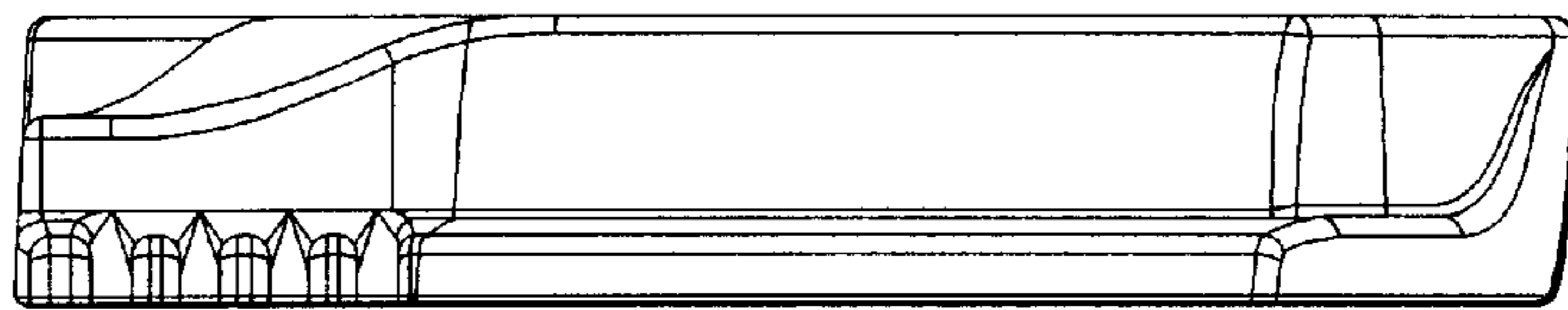
FIG. 1 is a perspective view of a shelf for barbecue grill stand showing our new design;

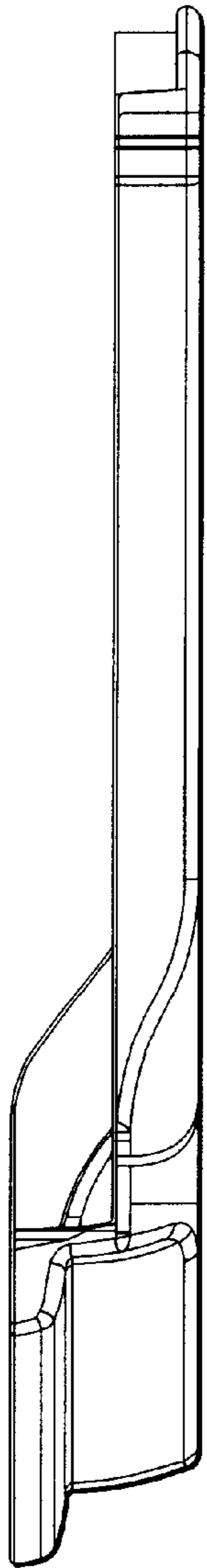




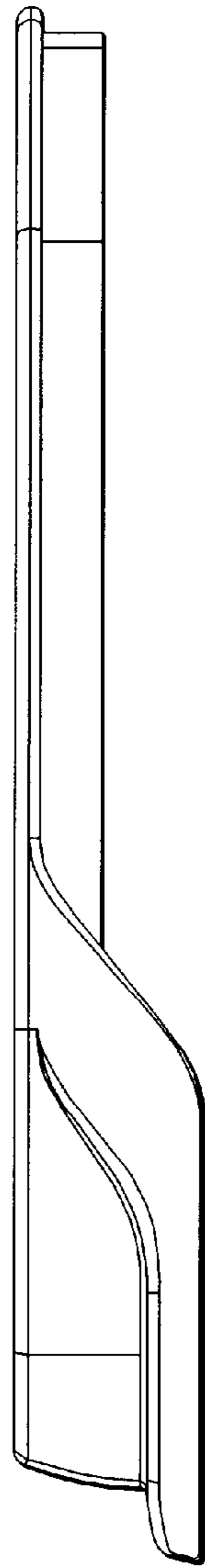

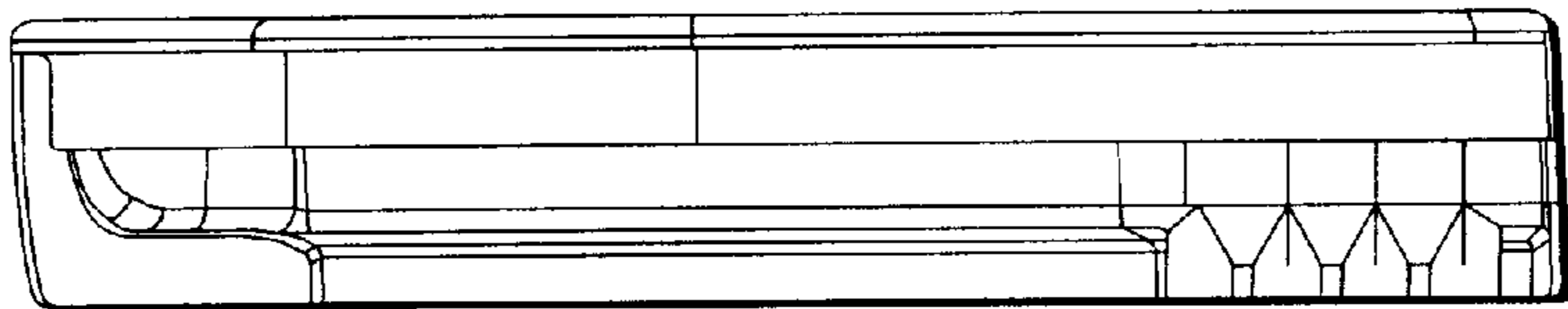

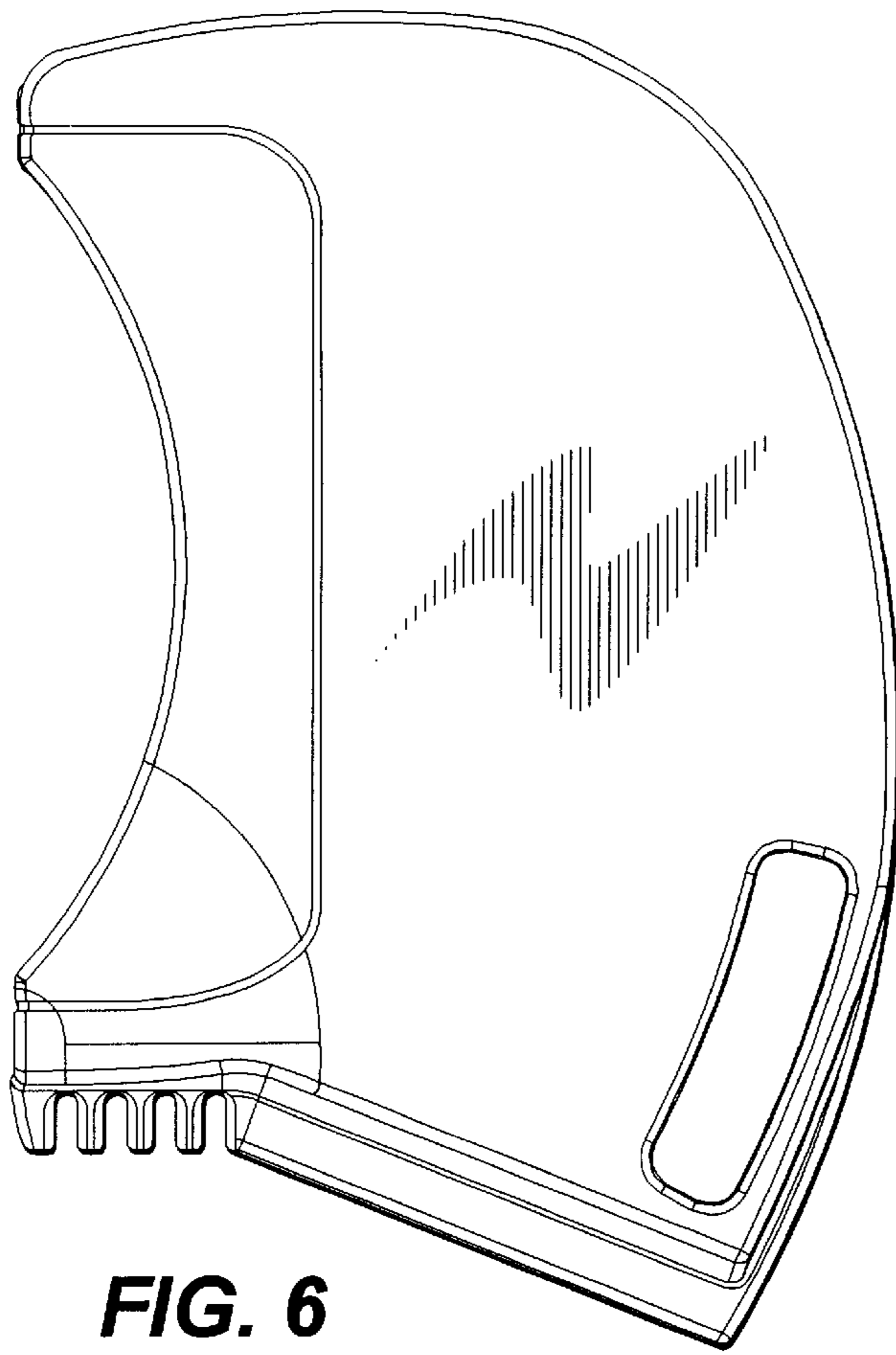

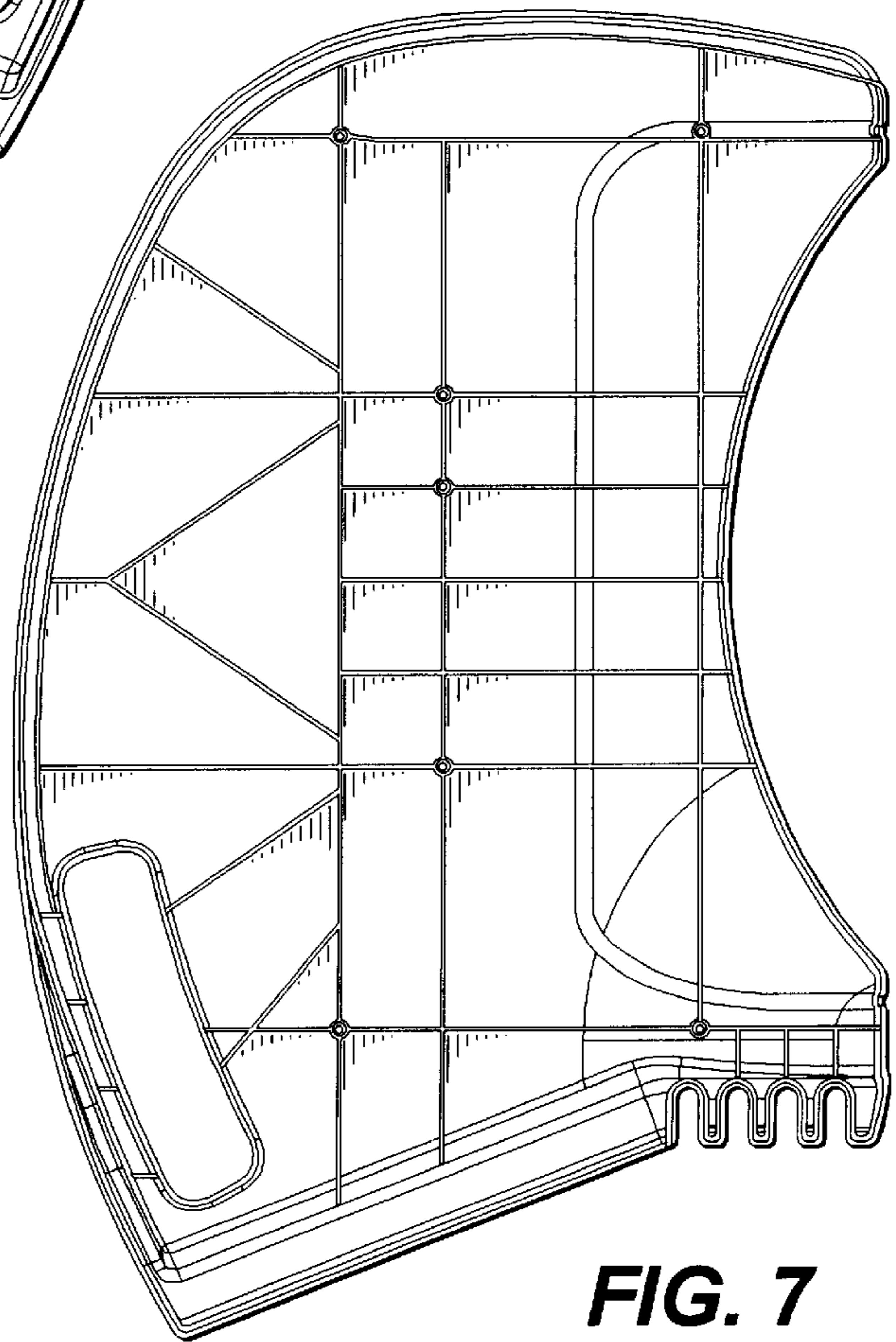
