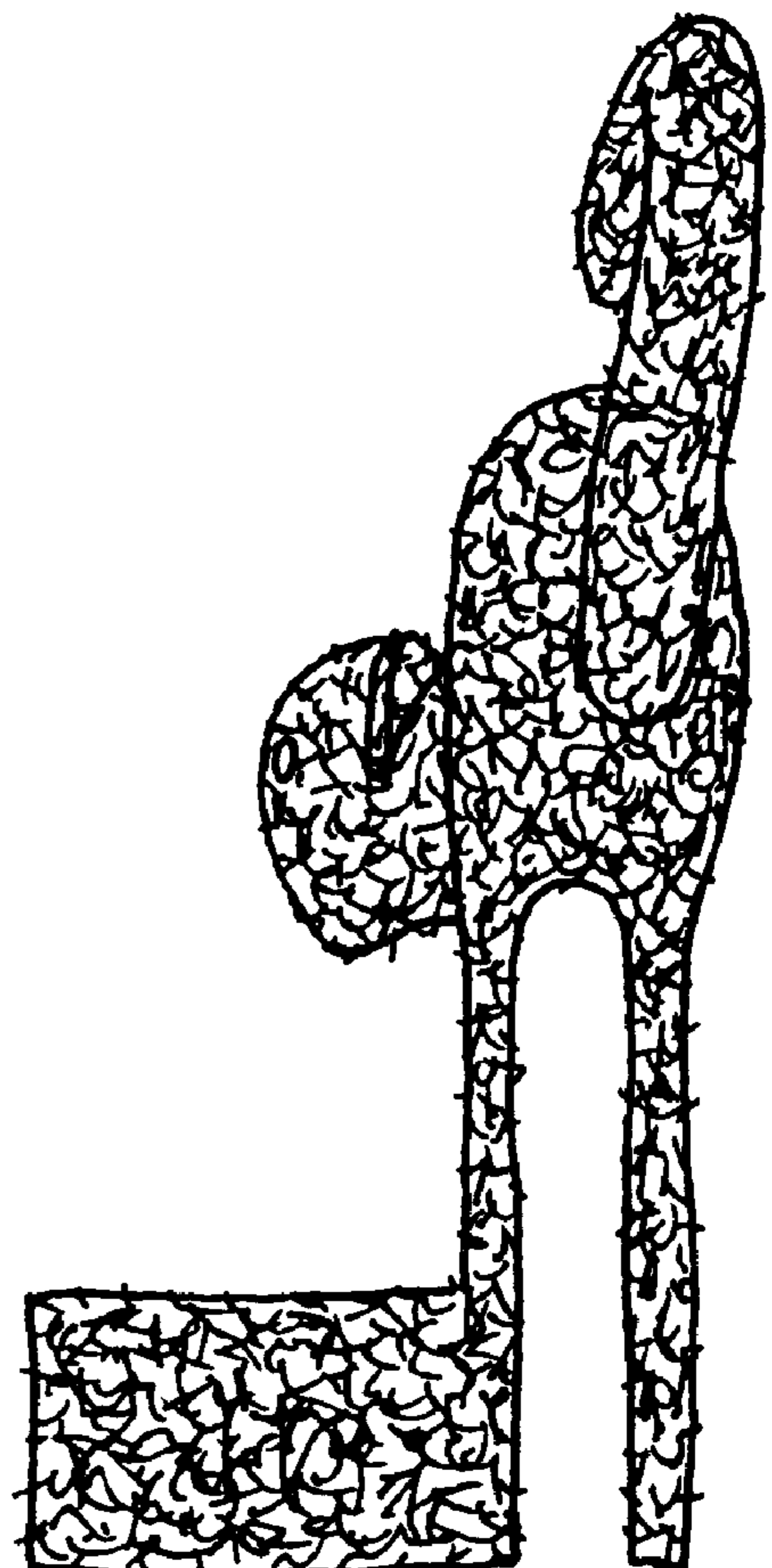
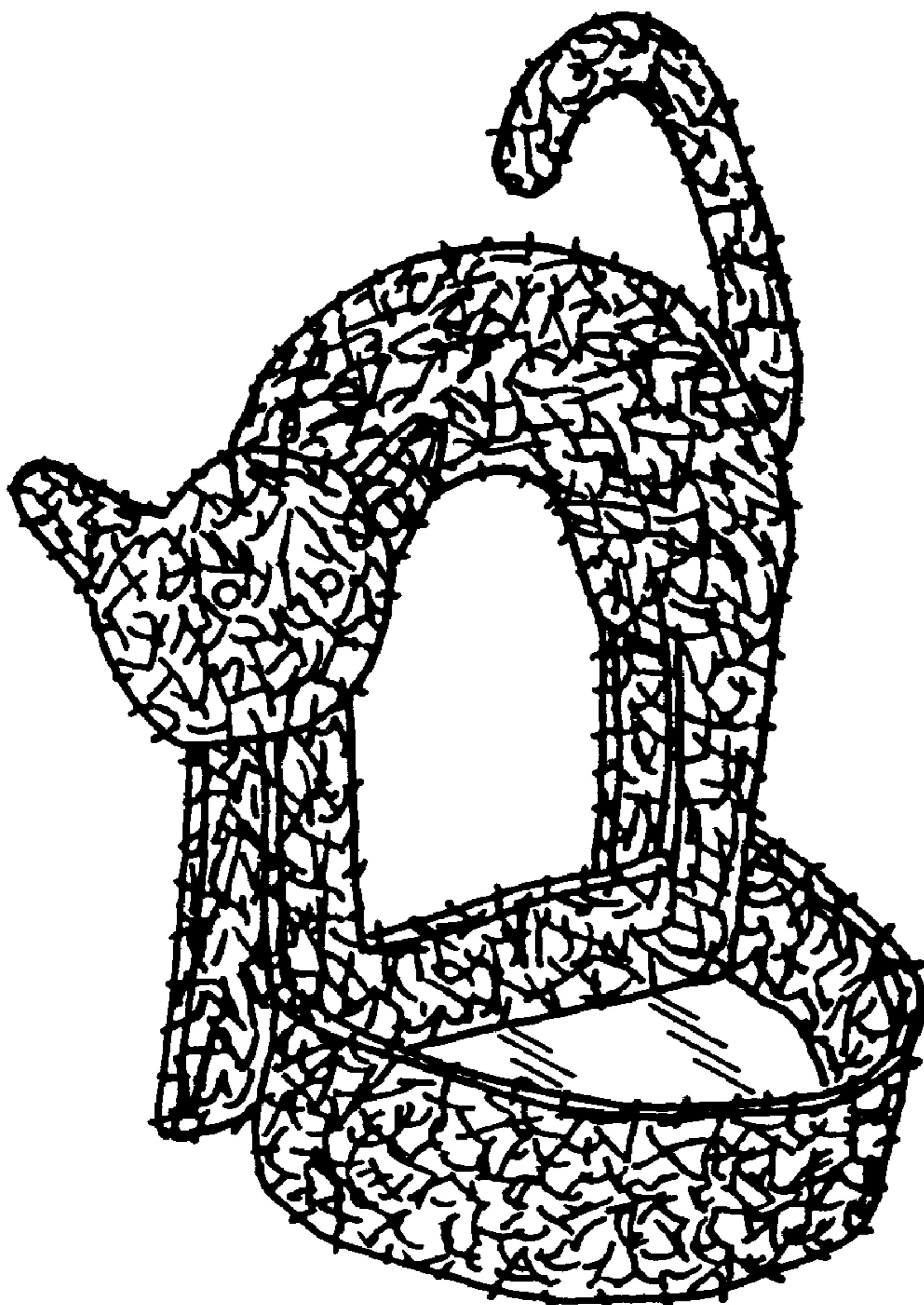
[57] **CLAIM**

The ornamental design for a tray with cat, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view taken from the top, front and right side of a tray with cat, showing my new design; FIG. 2 is another perspective view taken from the top, front and left side thereof; FIG. 3 is a rear elevation thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a left side view thereof; FIG. 7 is a right side view thereof; and, FIG. 8 is a front elevation view thereof.

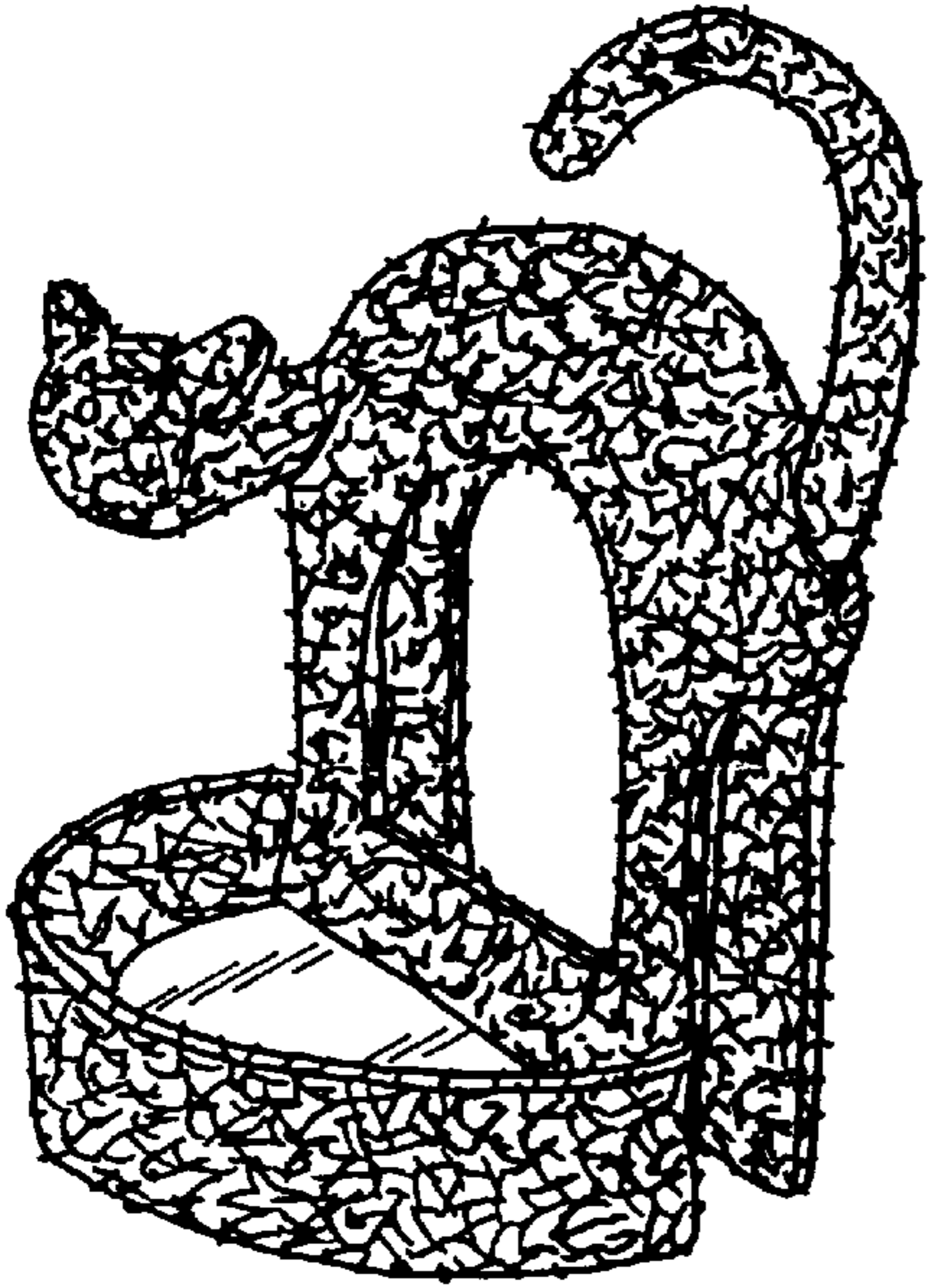

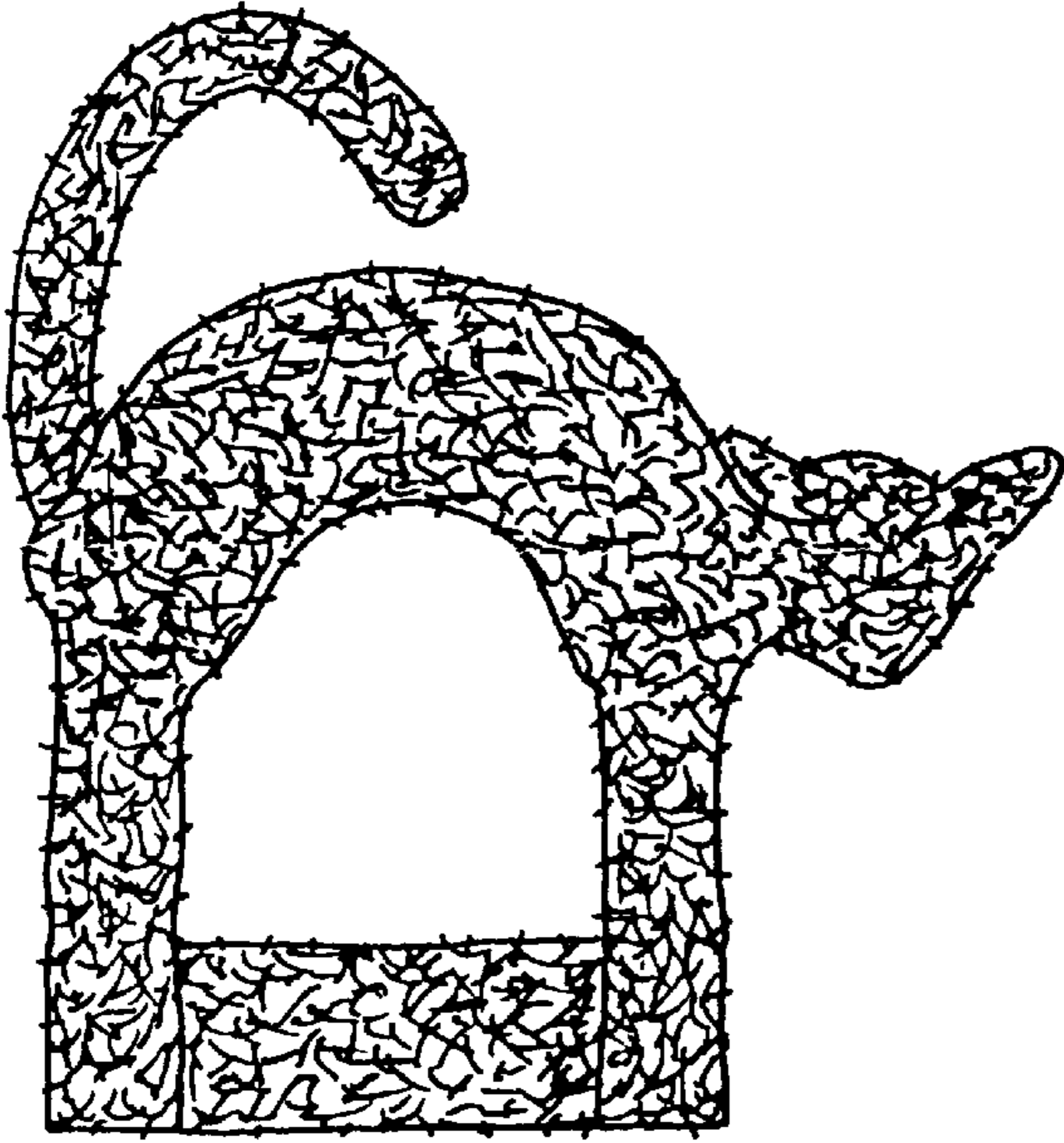

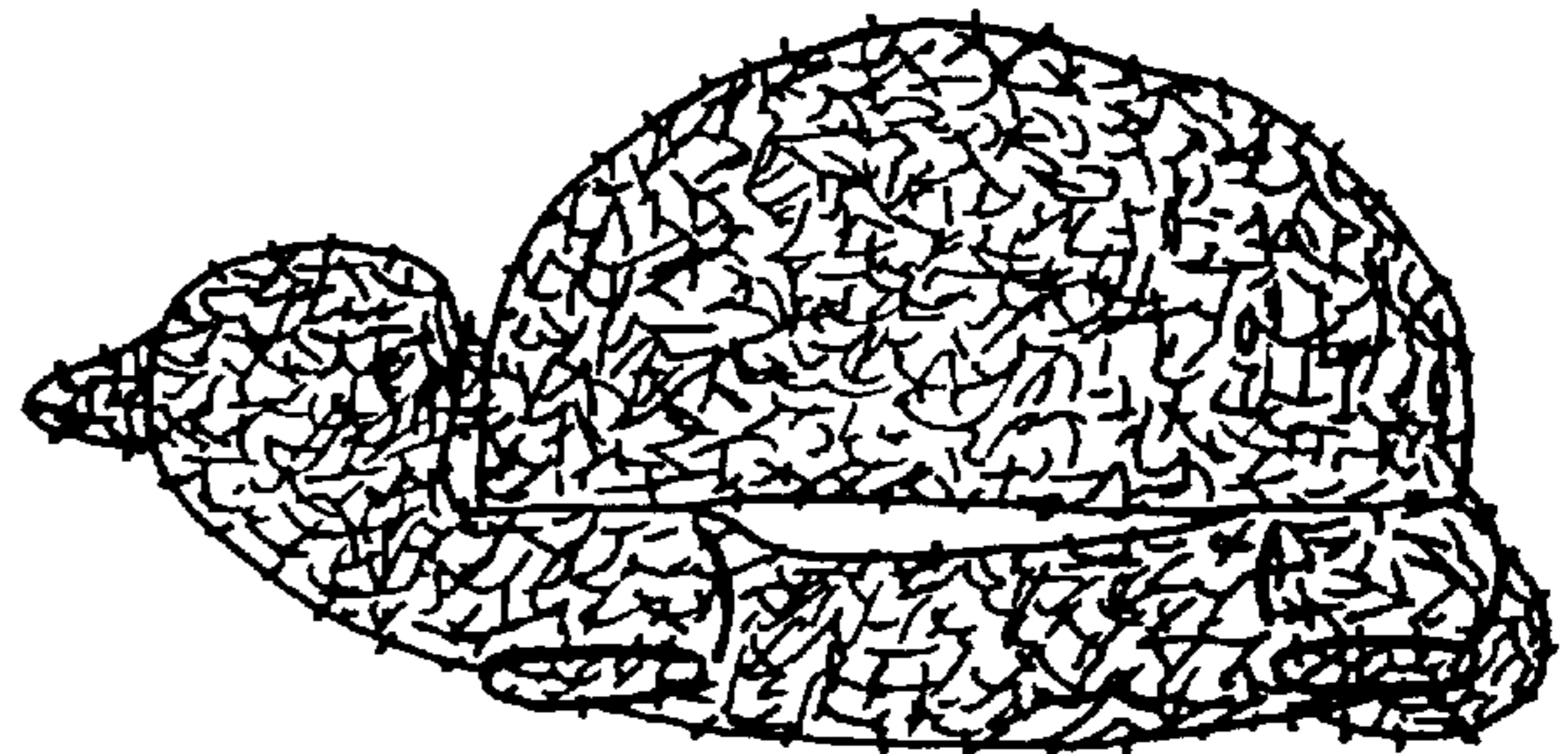

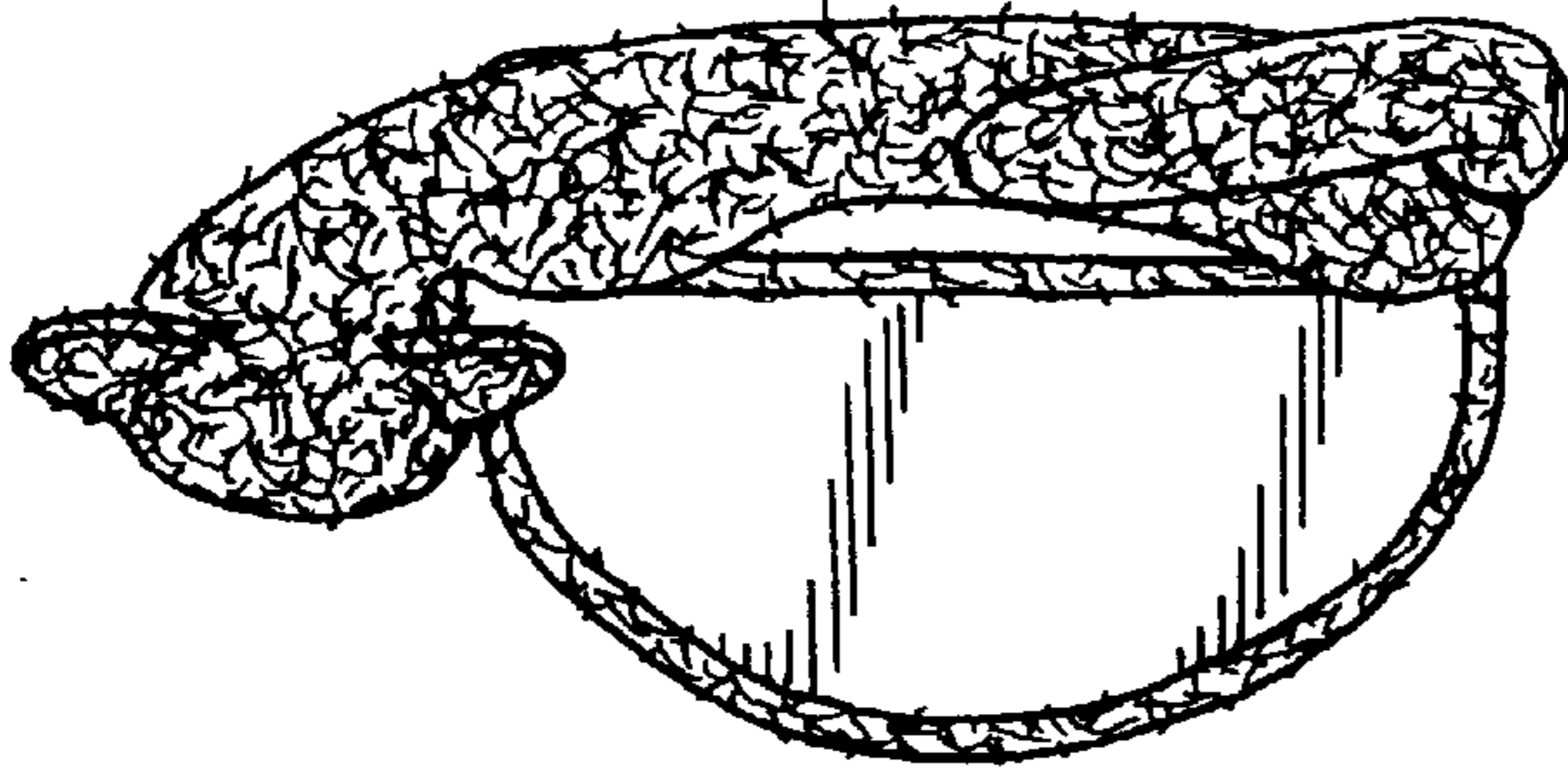

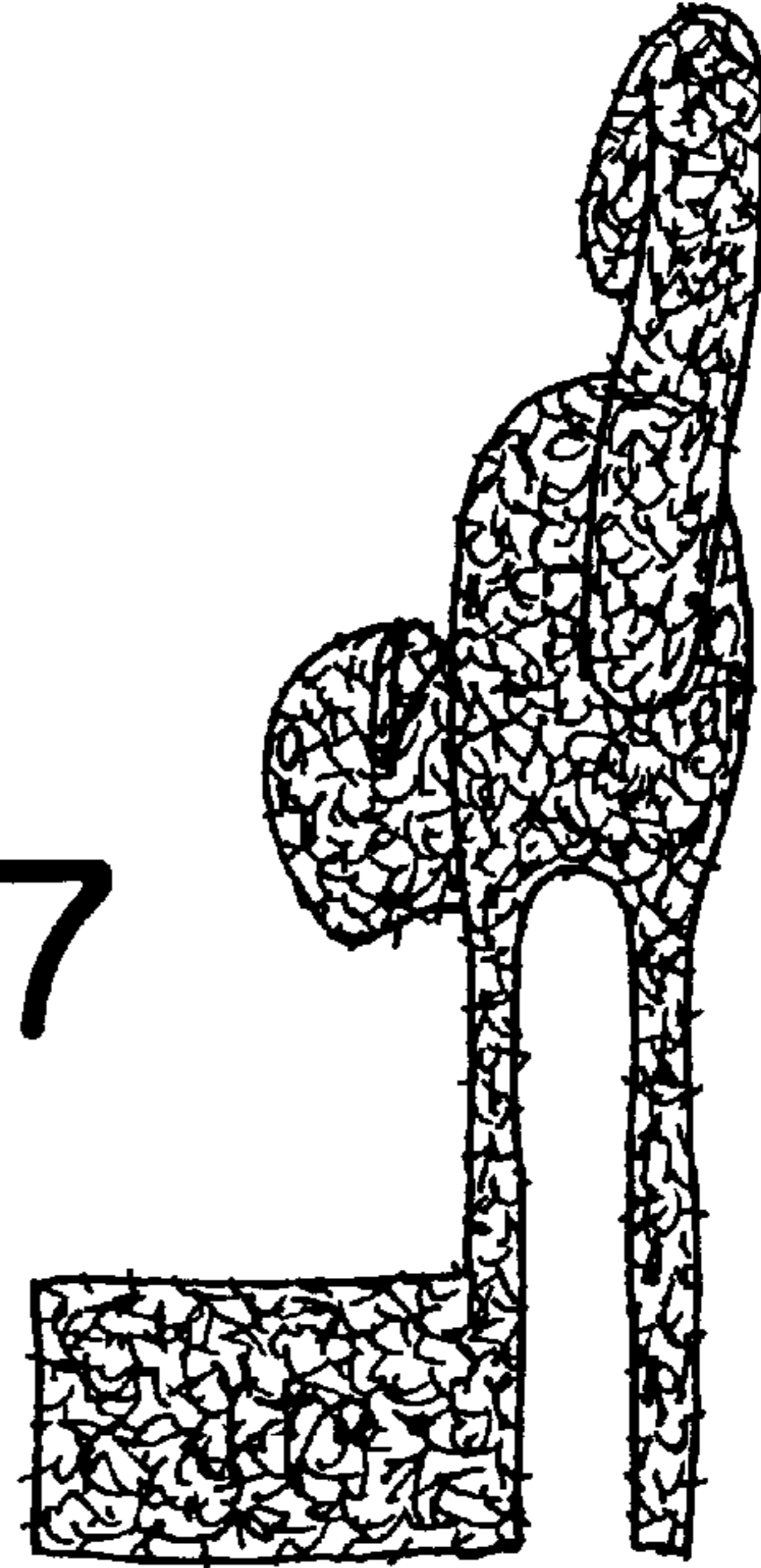

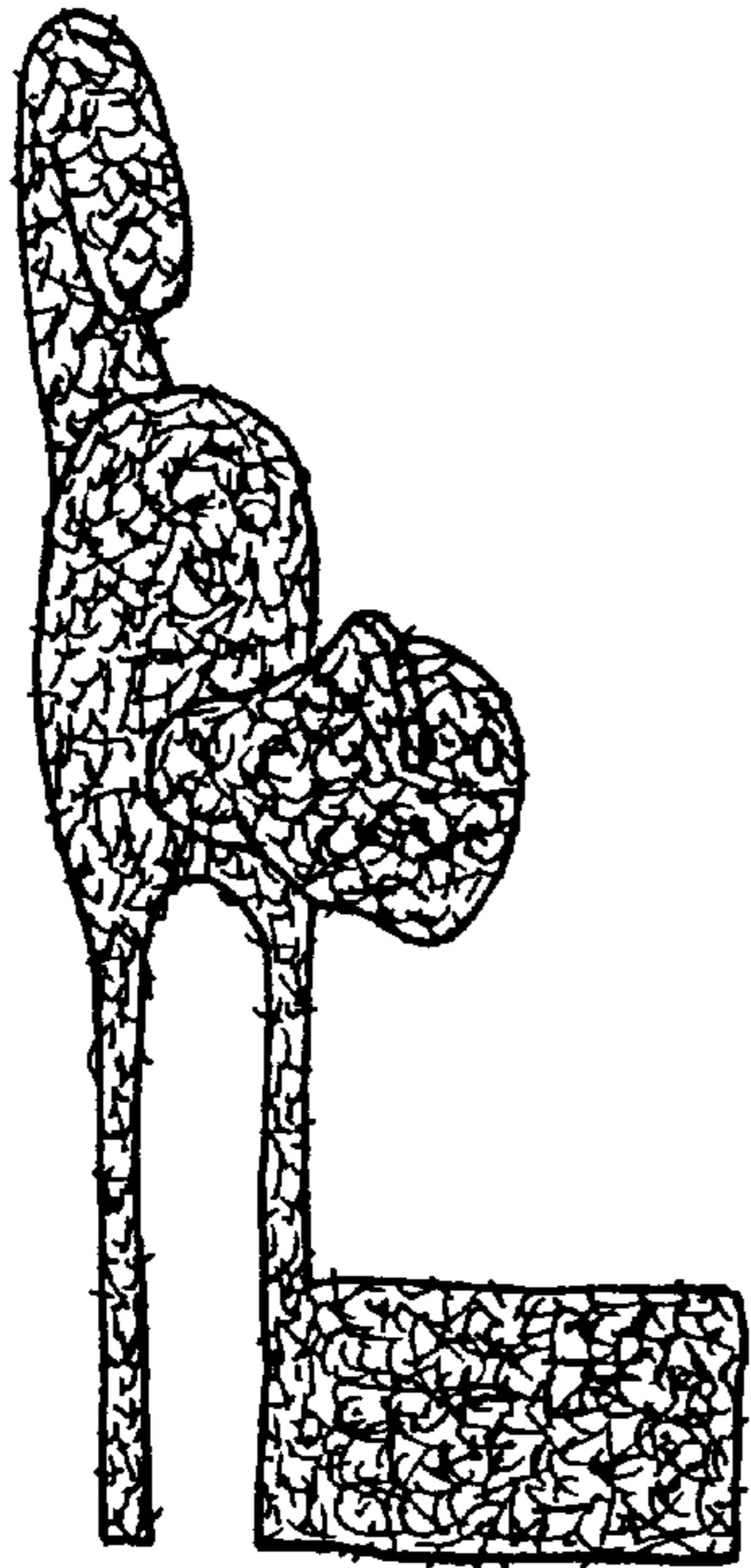

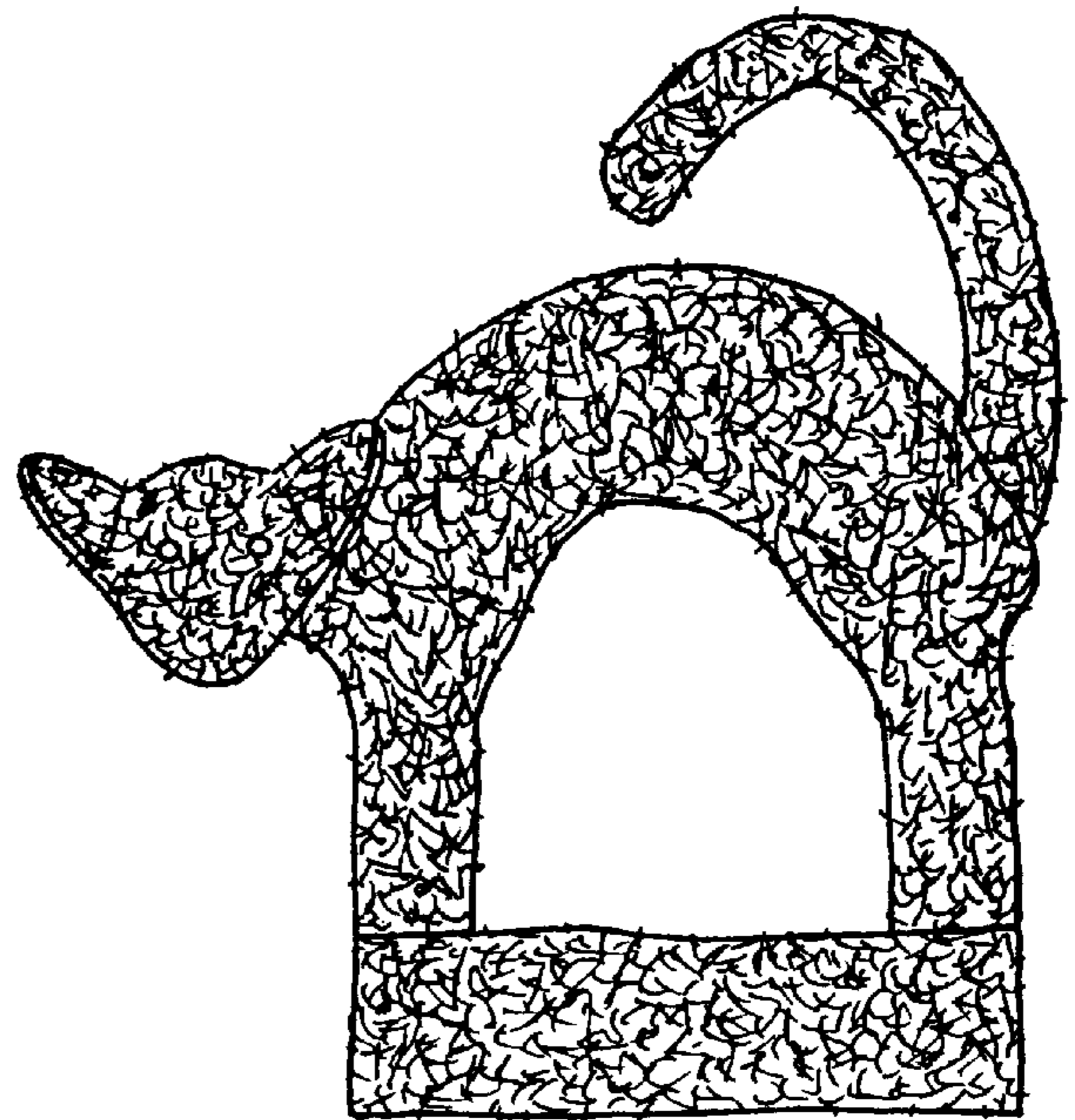
