FIG. 1 is a top perspective view of the handle face pair for a pocket knife of the present invention, The broken lines showing the knife body and the projecting key ring, divot fixer, toothpick, cap filter and notch are for illustration purposes only and form no part of the claimed invention;

FIG. 2 is a left side elevational view thereof, The broken lines showing the knife body, the projecting key ring and notch are for illustration purposes only and form no part of the claimed invention;

FIG. 3 is a top plan view thereof, The broken lines showing the knife body and the projecting key ring are for illustration purposes only and form no part of the claimed invention;

FIG. 4 is a bottom plan view thereof, The broken lines showing the knife body and the projecting key ring are for illustration purposes only and form no part of the claimed invention;


FIG. 5 is a right side elevational view thereof, The broken lines showing the knife body and the projecting key ring are for illustration purposes only and form no part of the claimed invention;











































