[57] CLAIM

The ornamental design for a chimney top, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of a chimney top showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a front elevation view thereof;
 FIGS. 4 and 5 are views similar to FIGS. 1 and 3, respectively, showing another embodiment of my new design, with the top plan view thereof being identical to FIG. 2;
 FIGS. 6 and 7 are views similar to FIGS. 4 and 5, showing another embodiment of my new design, with the top view thereof being identical to FIG. 2;
 FIGS. 8 and 9 are views similar to FIGS. 6 and 7, showing another embodiment of my new design;
 FIG. 10 is a top plan view of the chimney top of FIGS. 8 and 9;
 FIGS. 11 and 12 are views similar to FIGS. 8 and 9, showing another embodiment of my new design;
 FIG. 13 is a top plan view of the embodiment illustrated in FIGS. 11 and 12;
 FIGS. 14 and 15 are front and side elevation views, respectively, showing another embodiment of my new design;
 FIG. 16 is a top plan view of the chimney top of FIGS. 14 and 15;
 FIG. 17 is a partial side elevation view of the design of FIGS. 14 and 15 taken along line 17—17 in FIG. 15;
 FIG. 18 is a partial side elevation view of the design of FIGS. 14 and 15 taken along line 18—18 in FIG. 15; and,
 FIG. 19 is a side elevation view of FIG. 18 with the chimney top damper in a raised position.

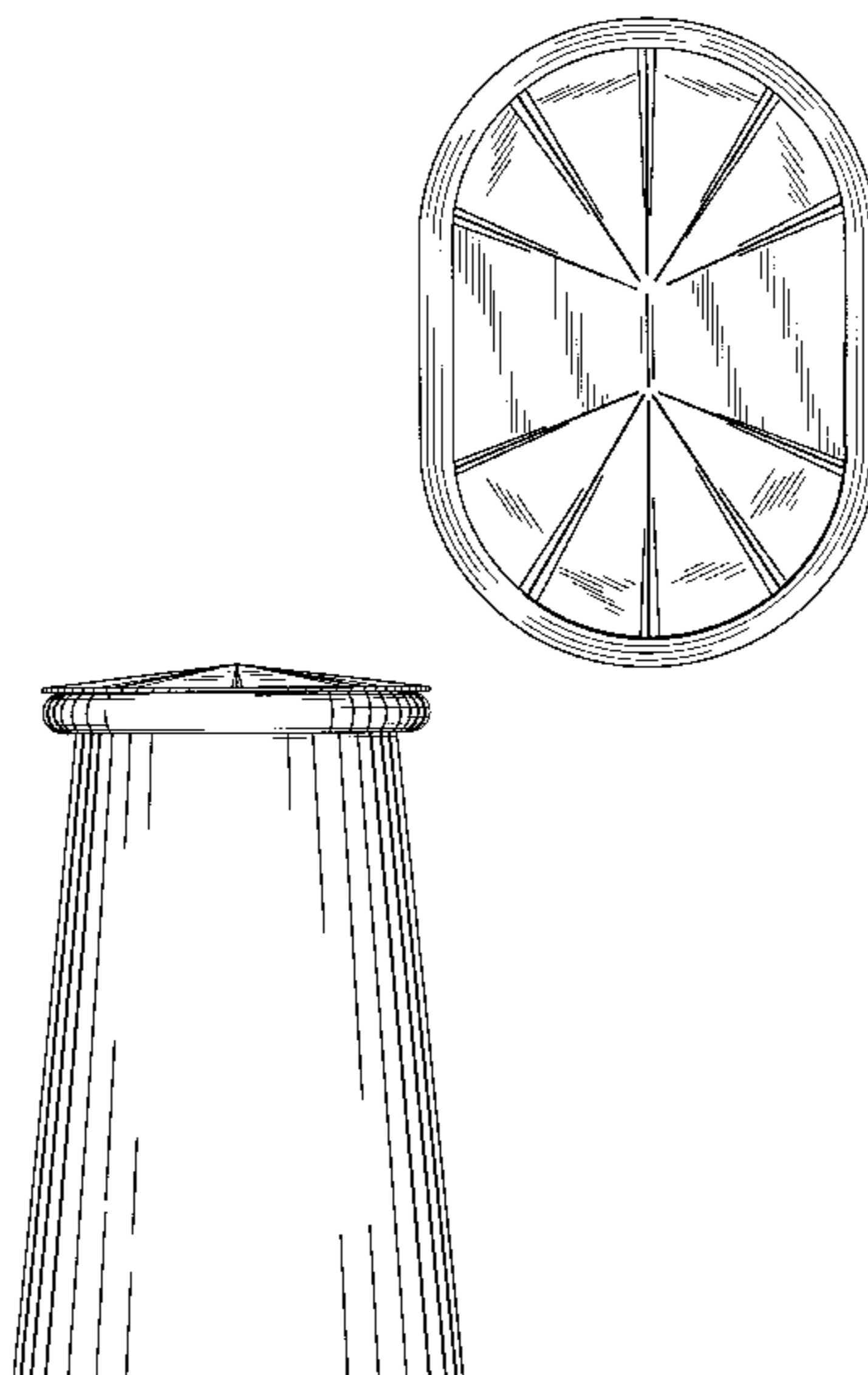

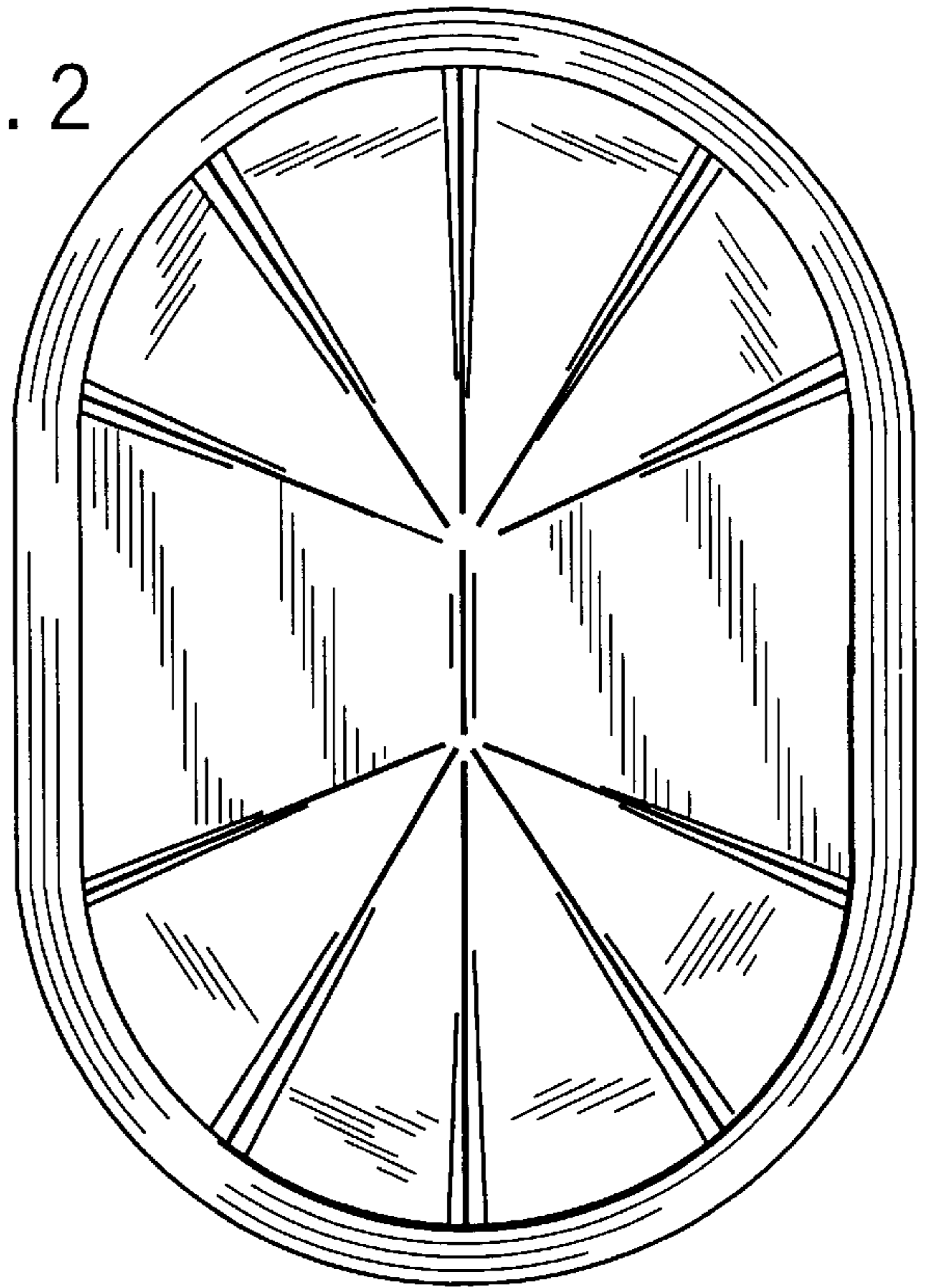
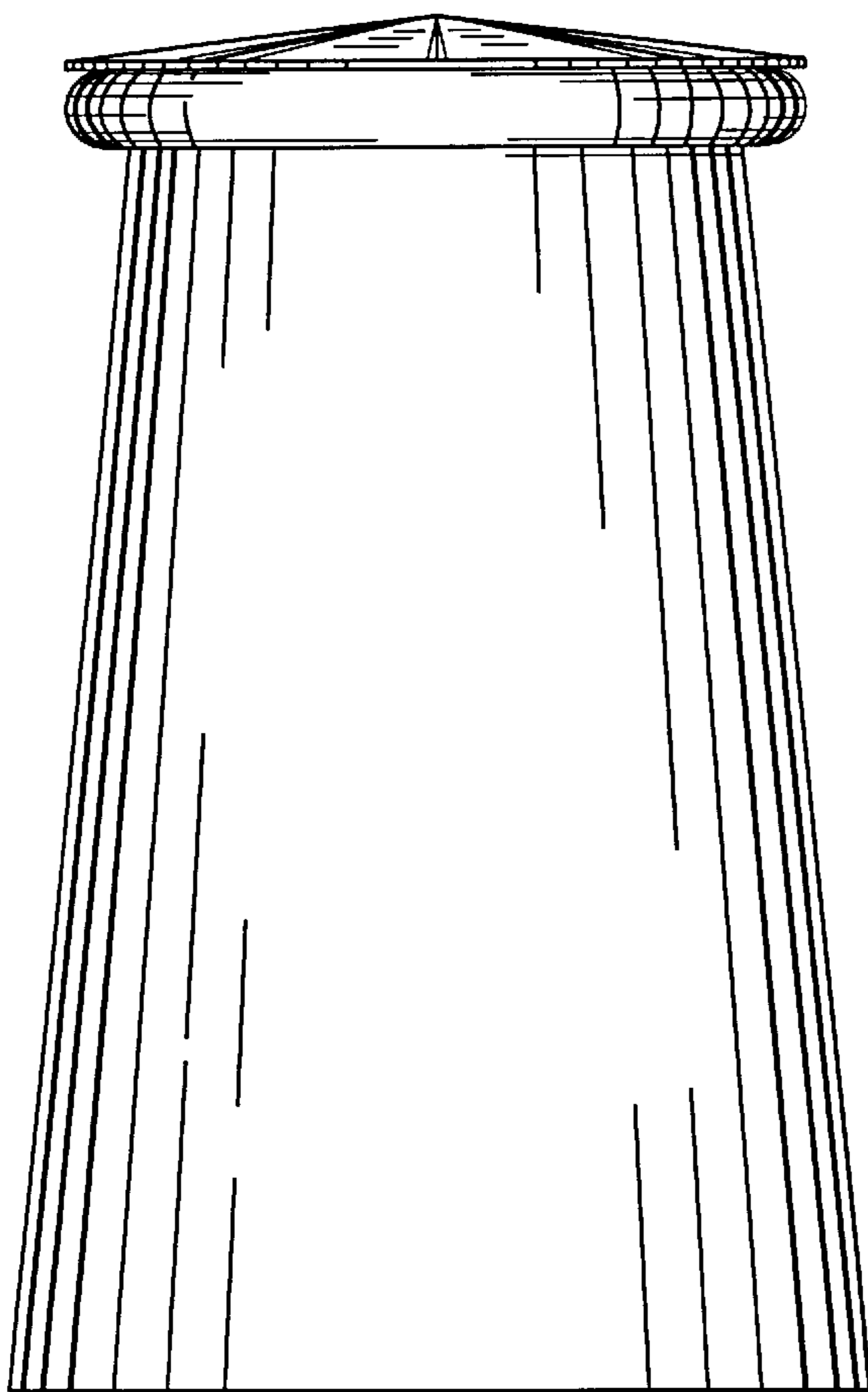

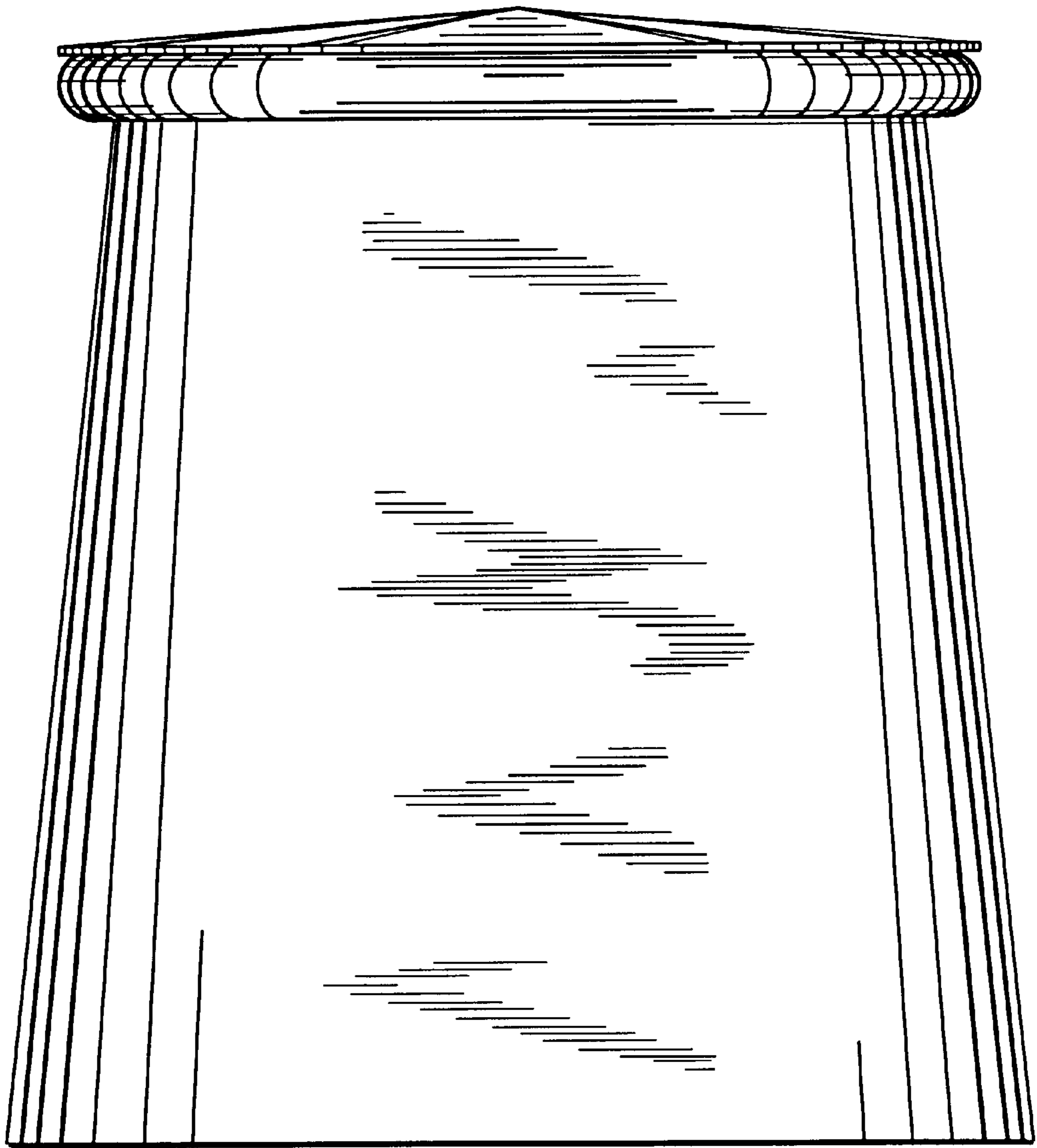

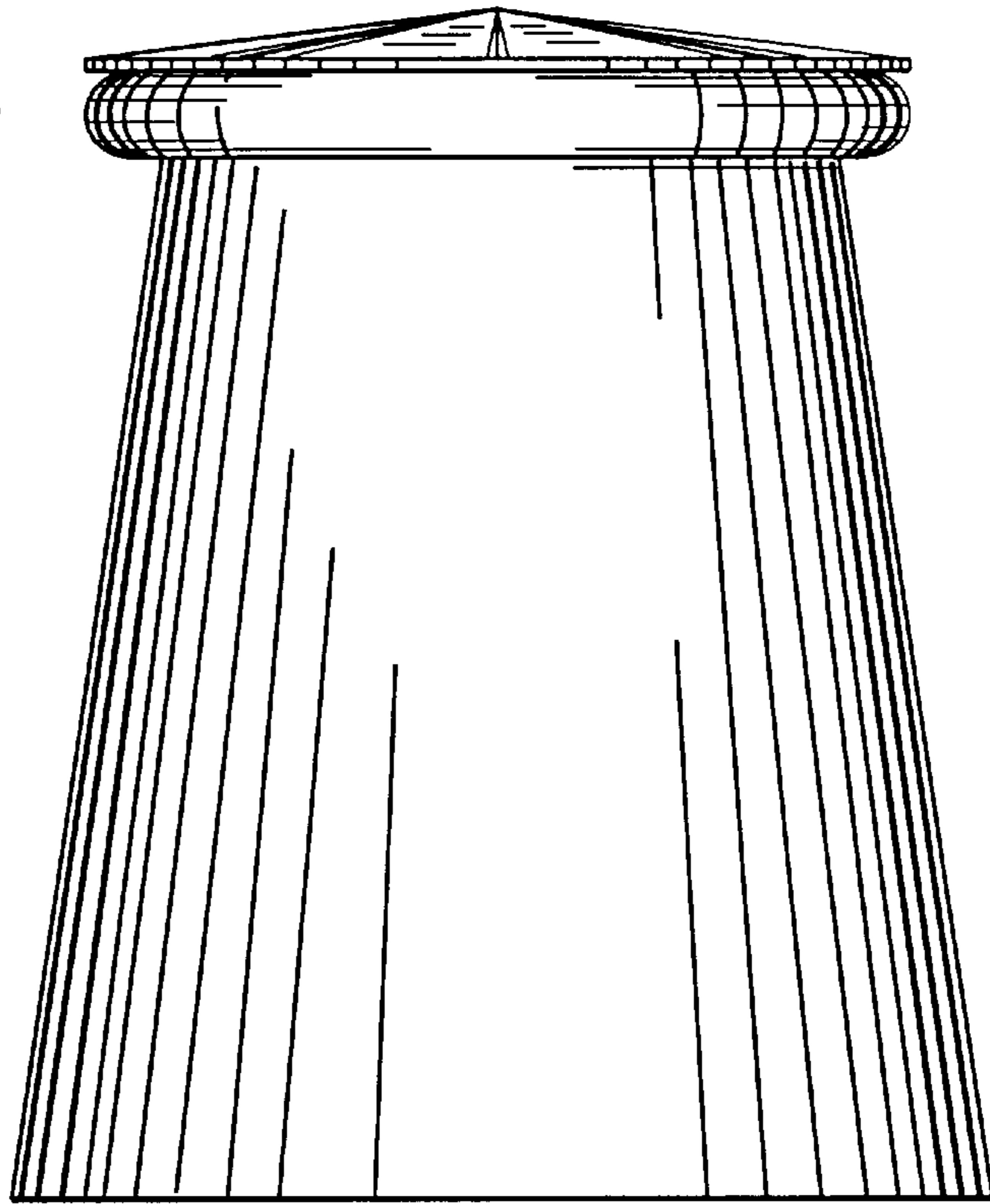

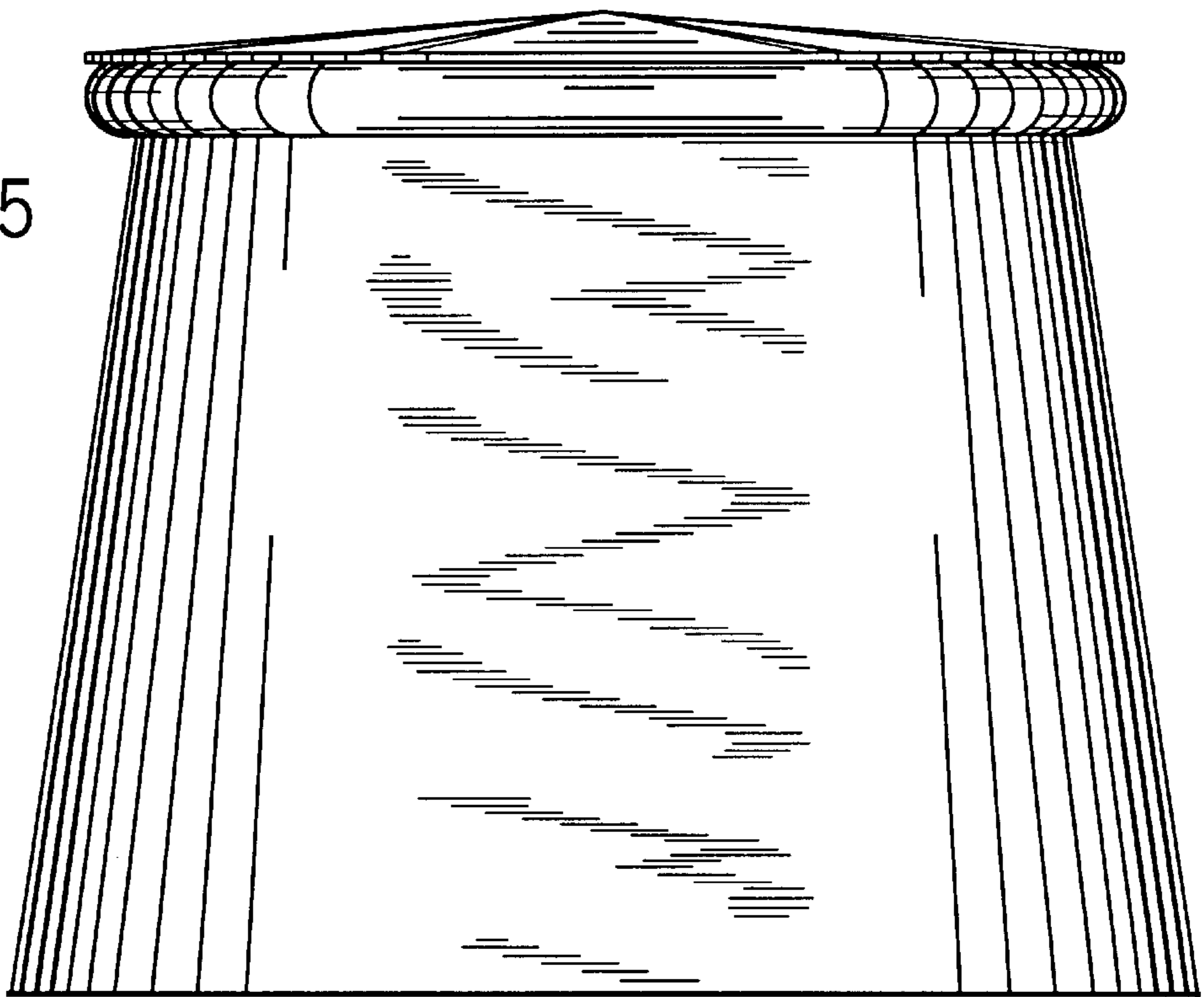

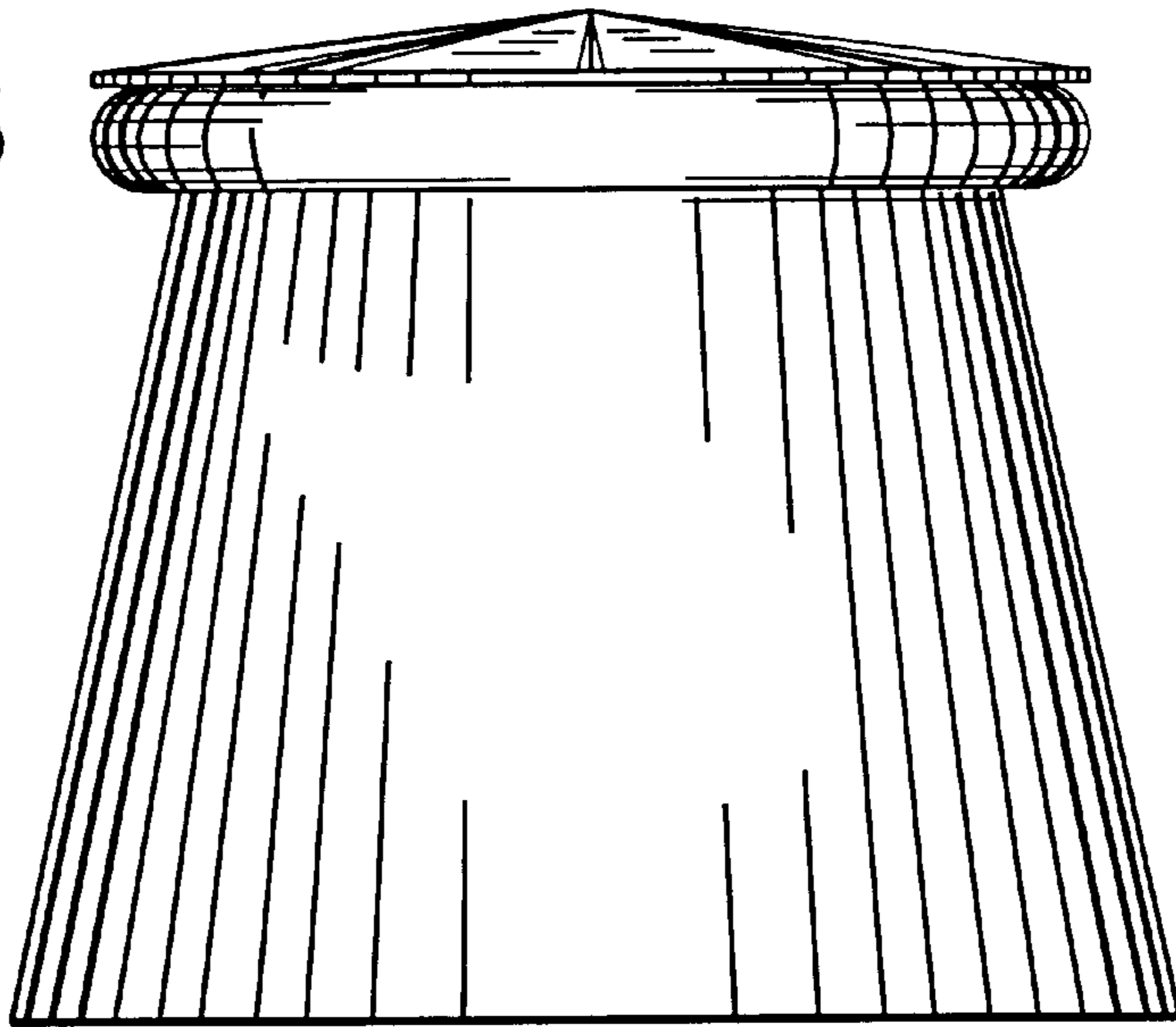

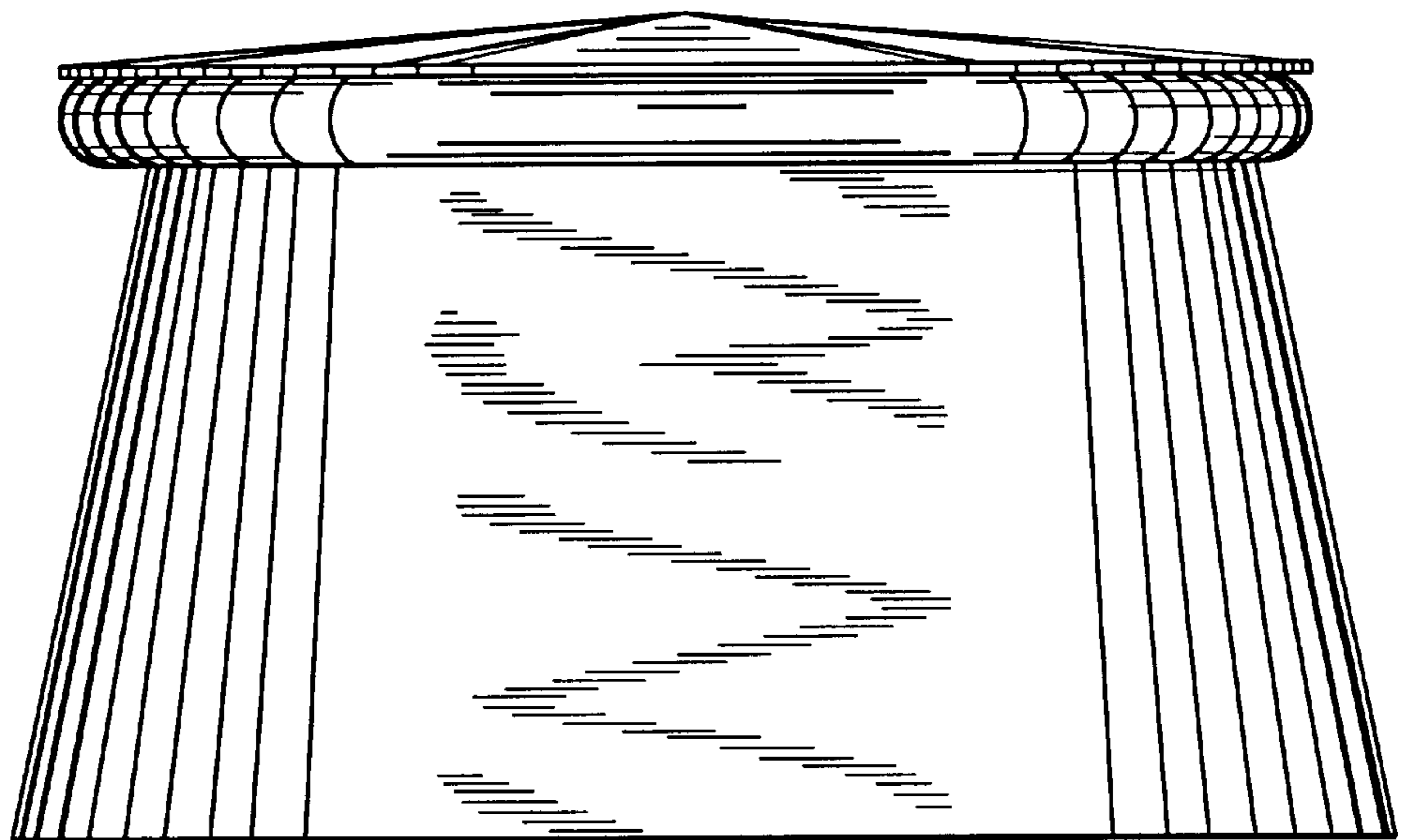

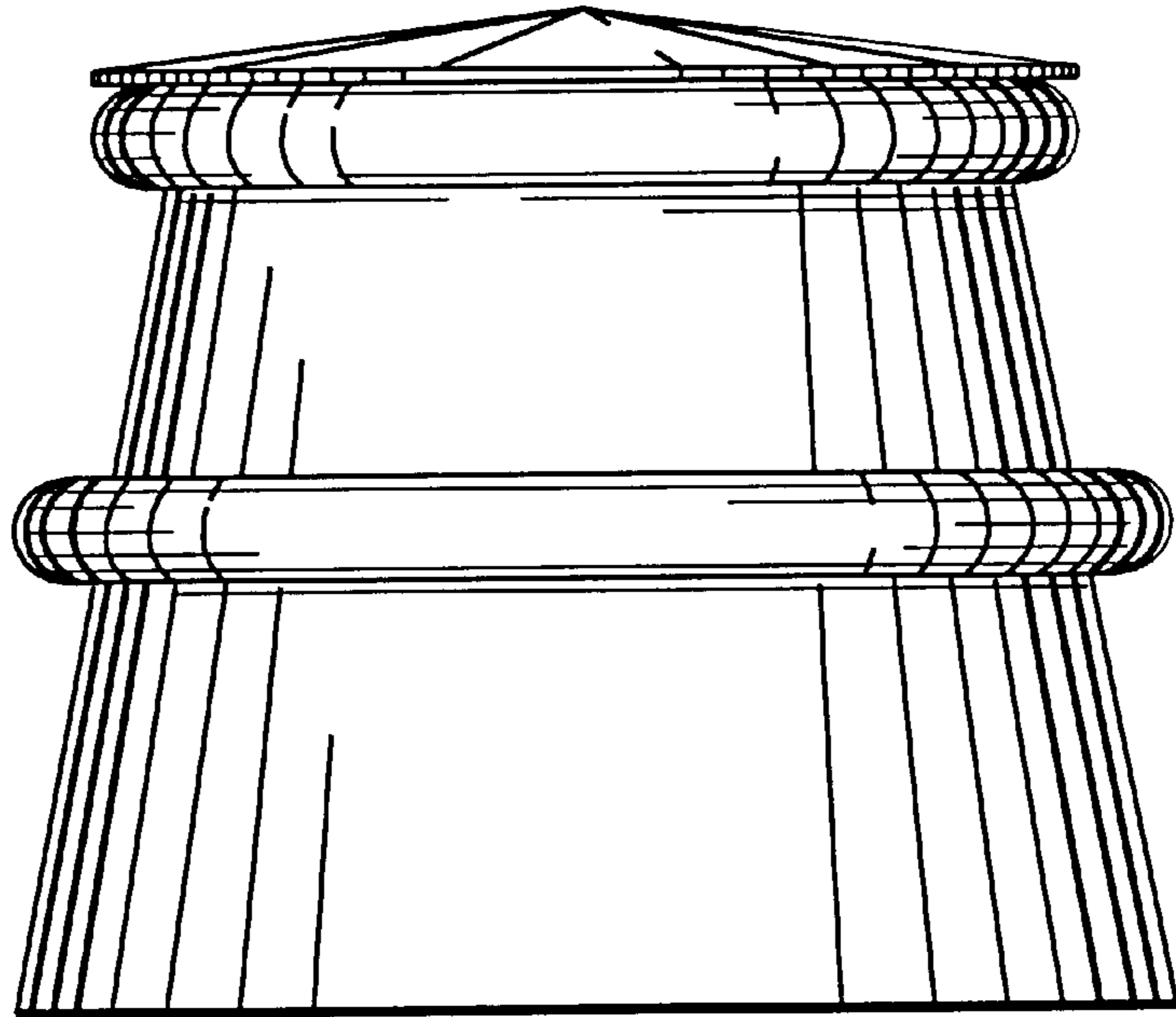

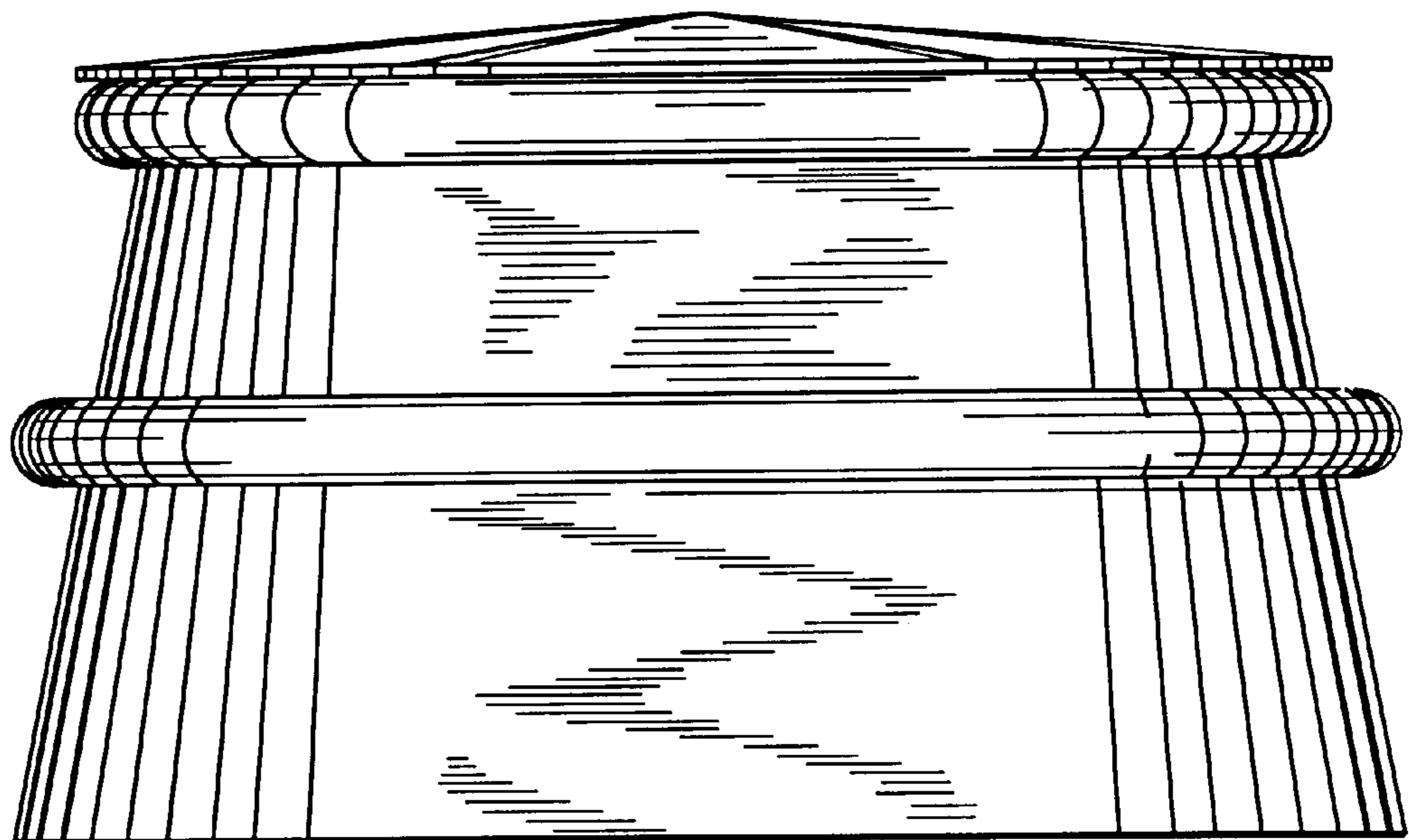

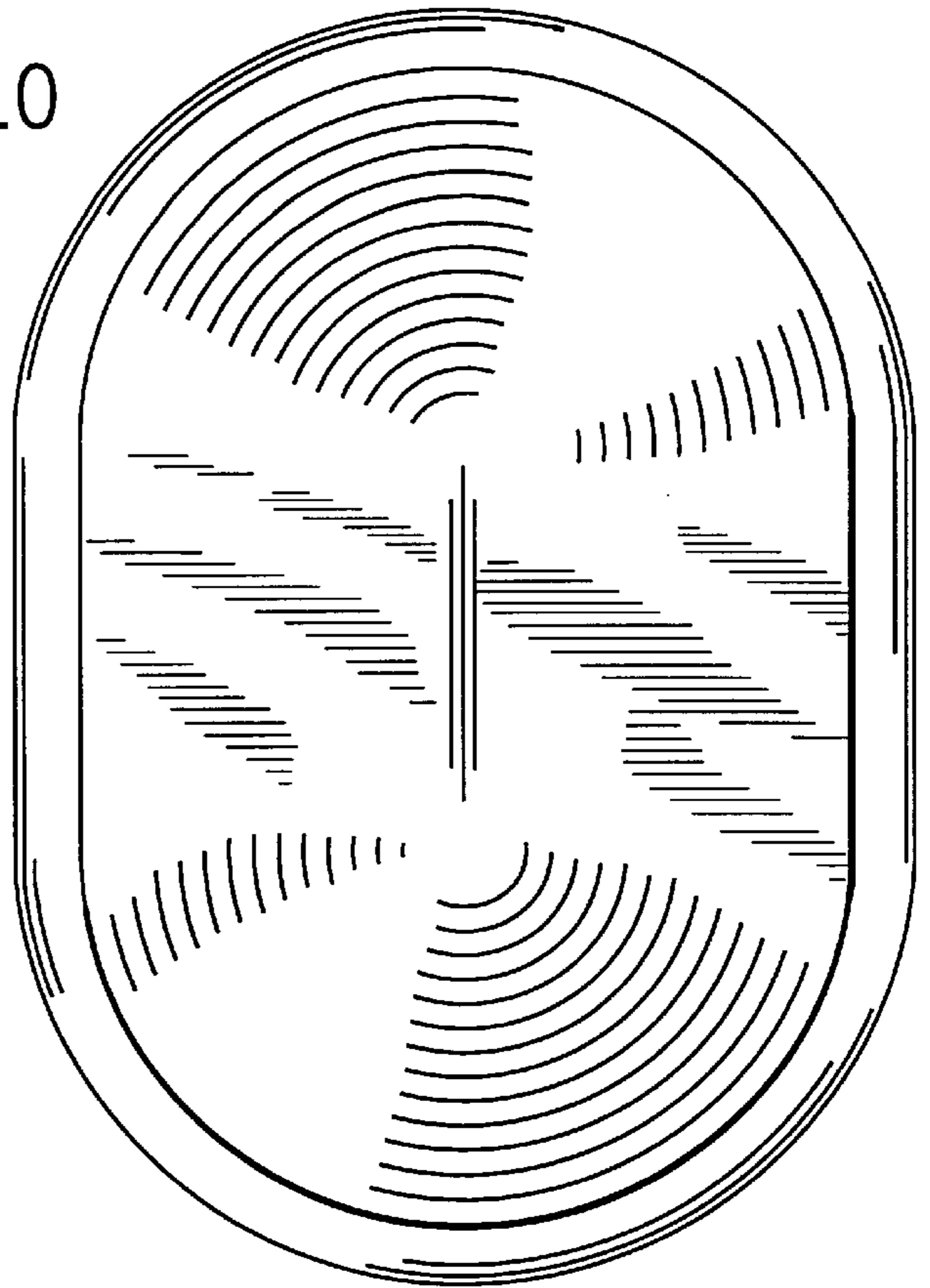
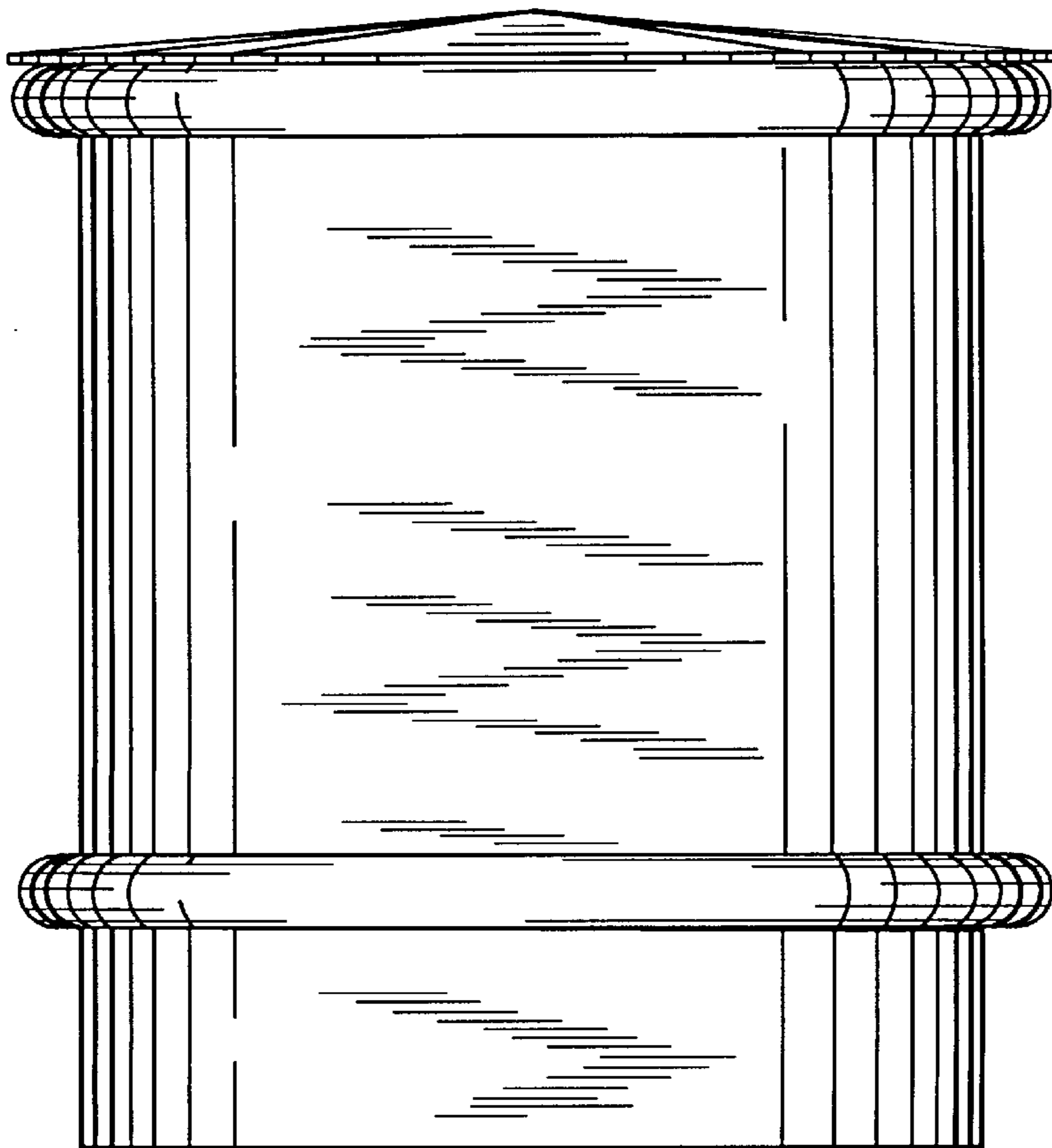

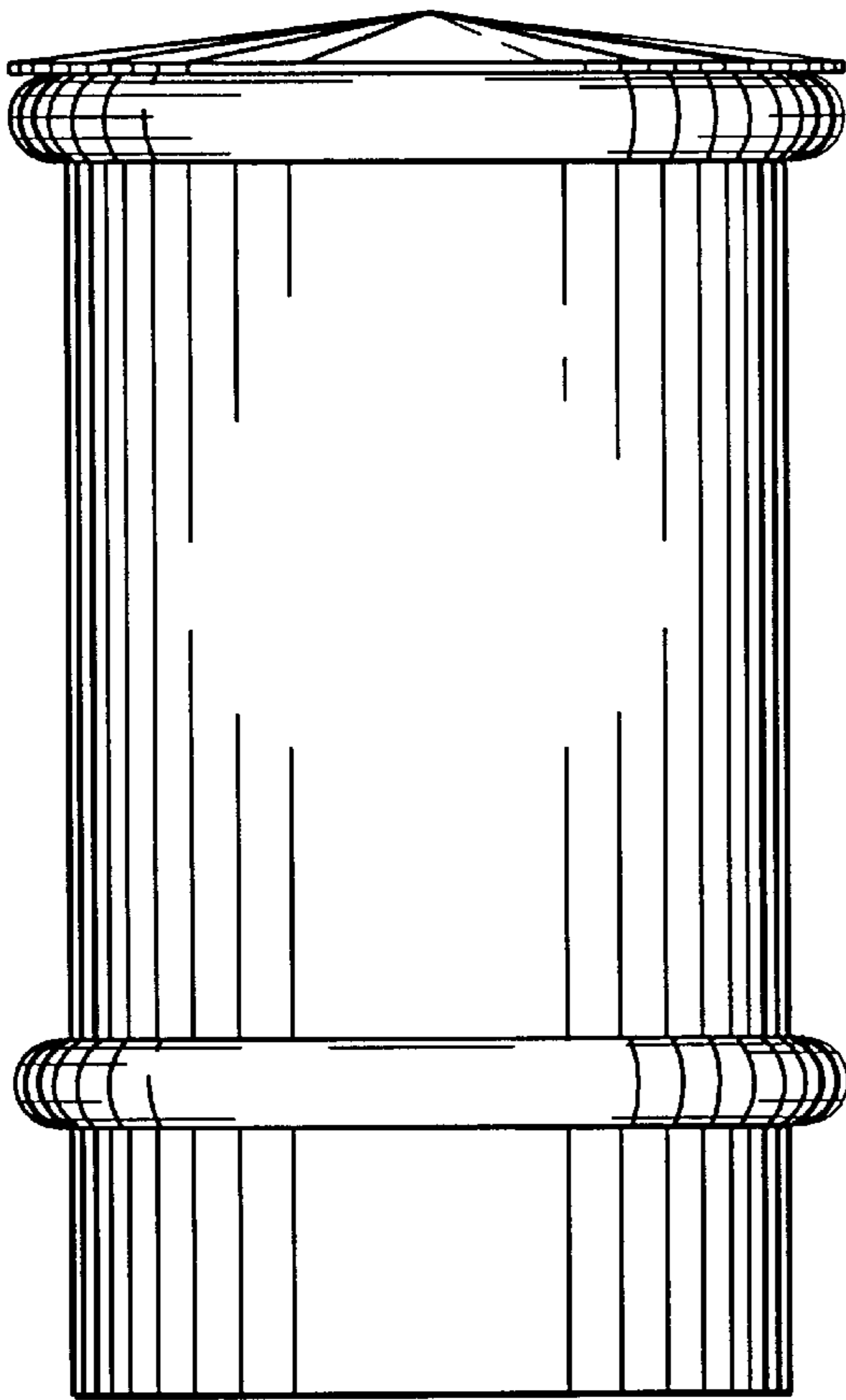

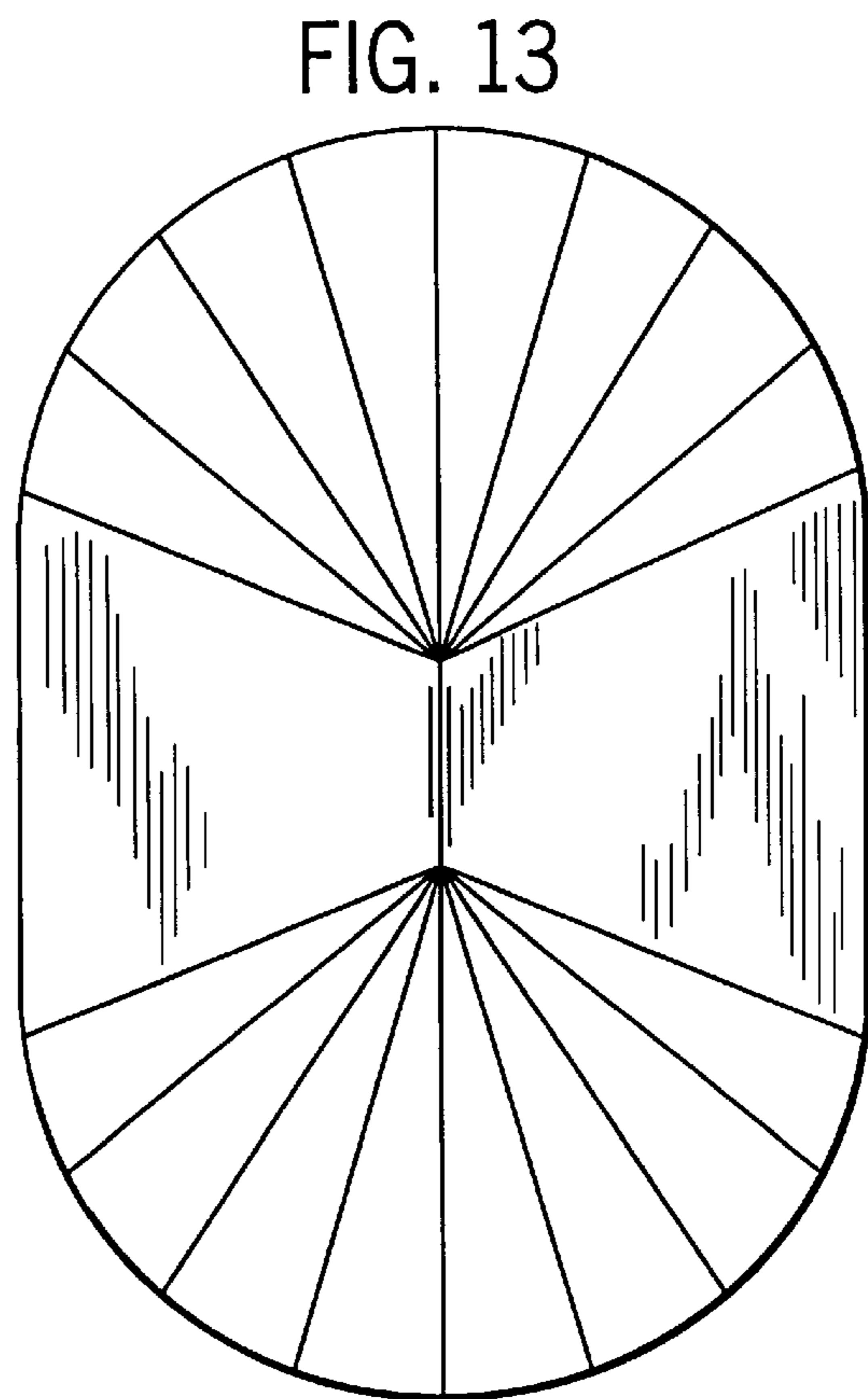

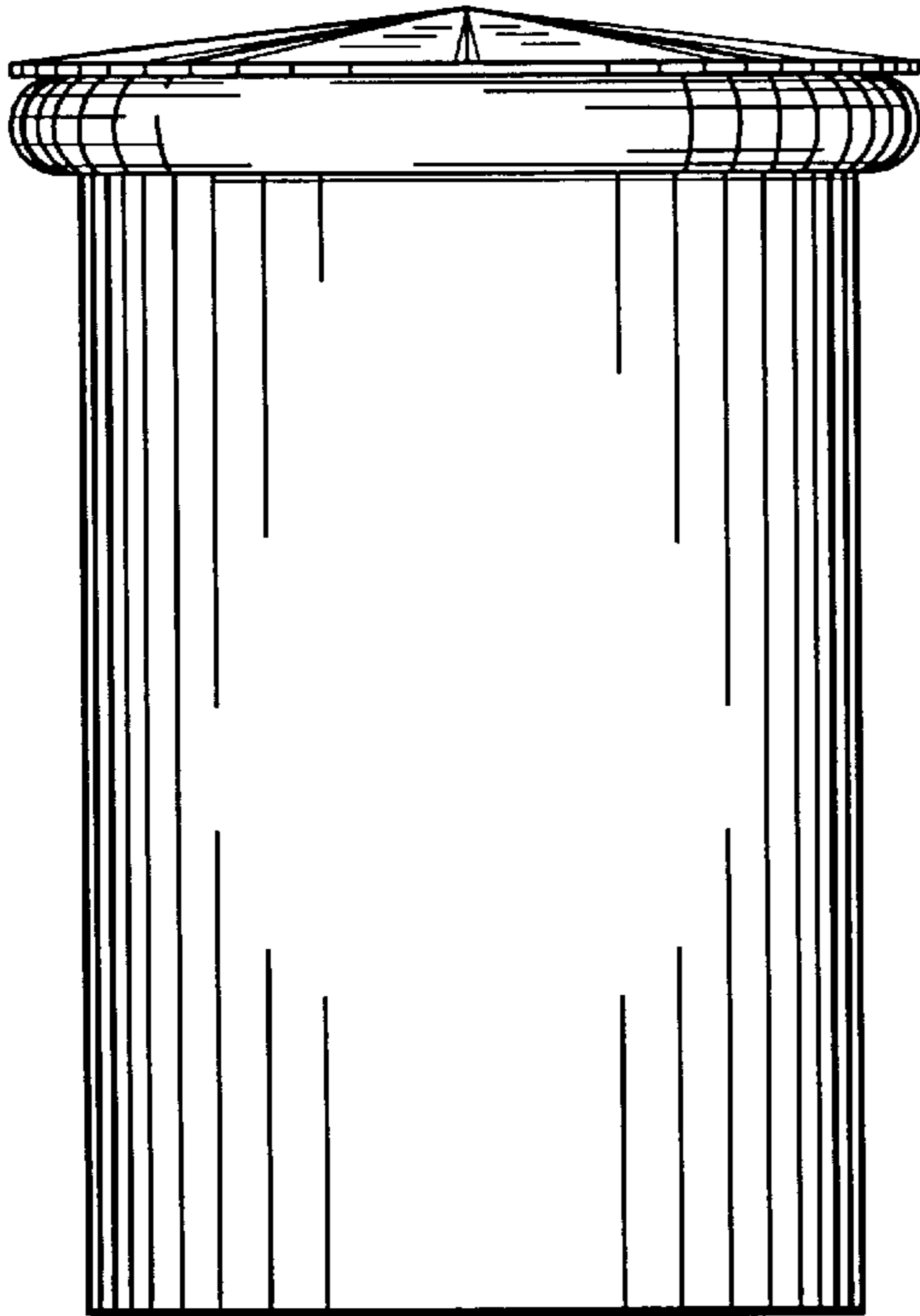

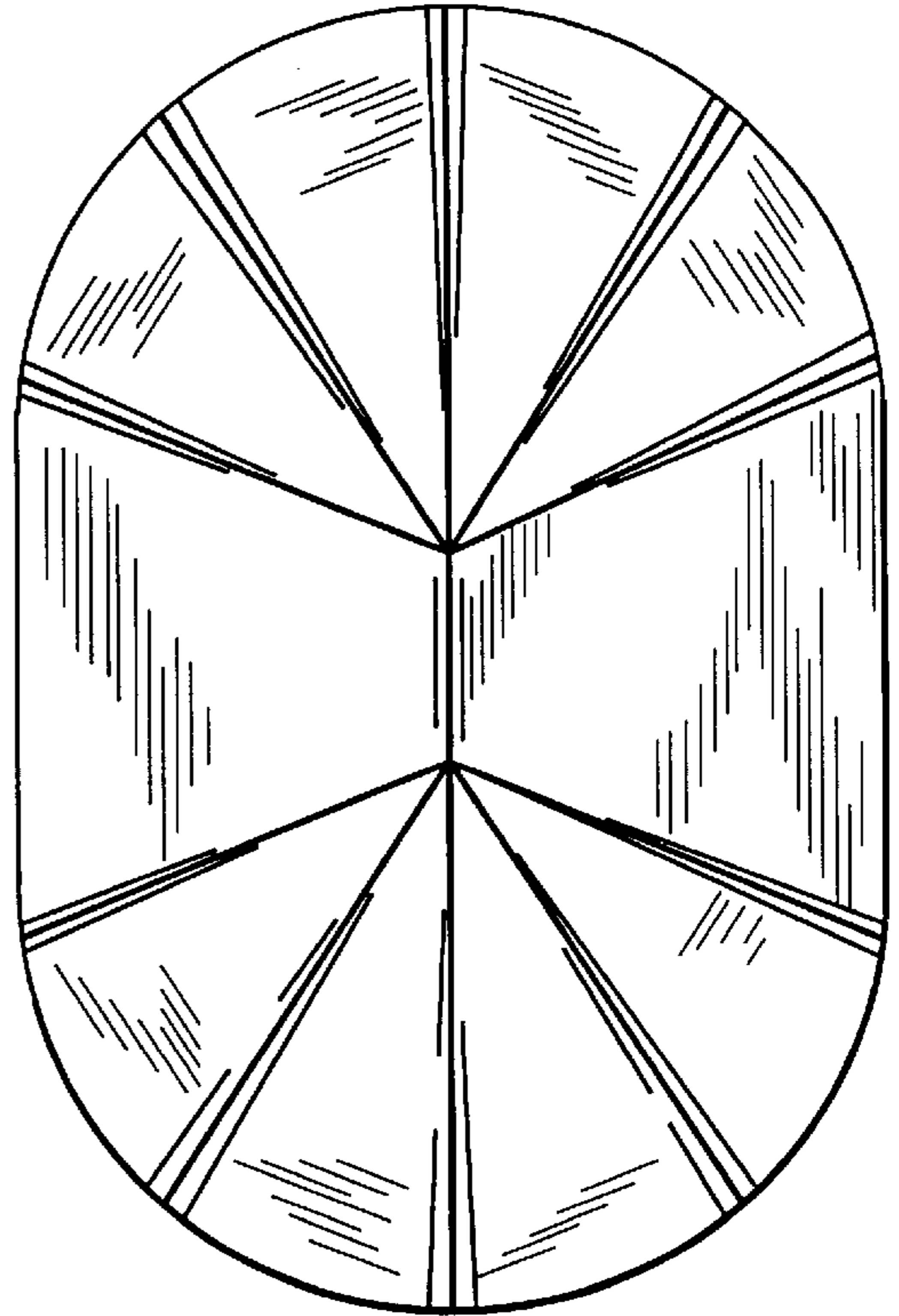

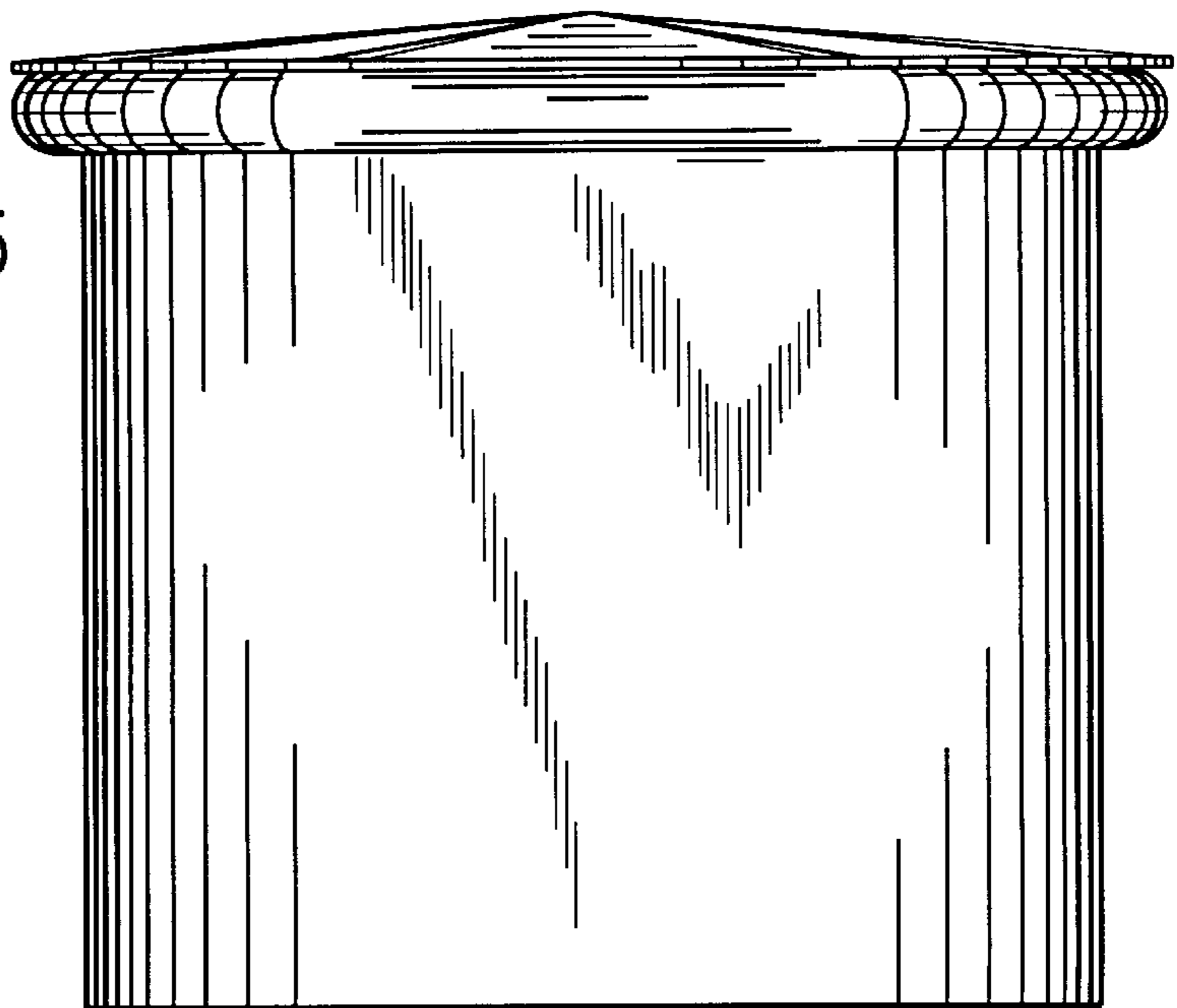

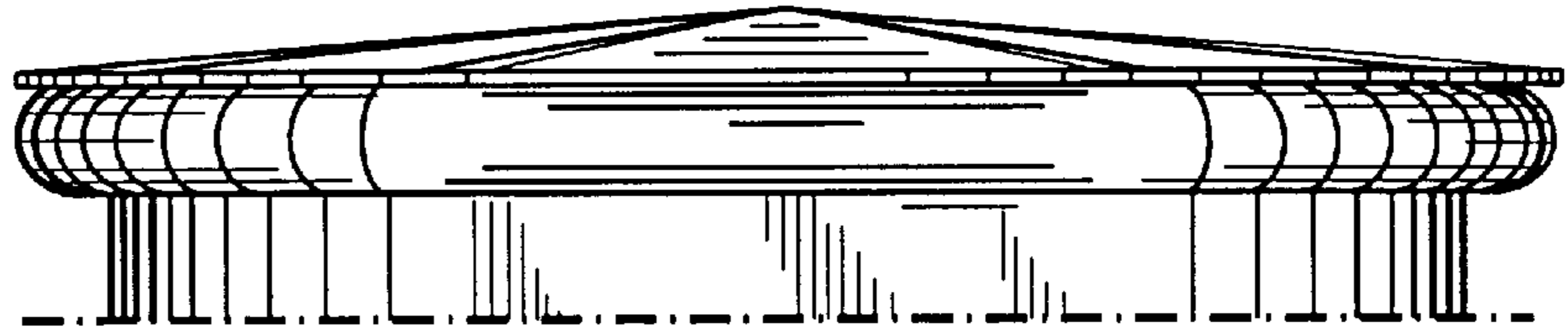

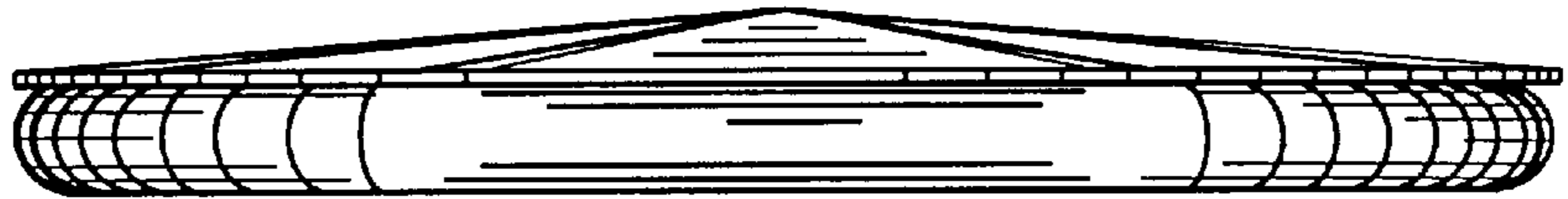
