DESCRIPTION

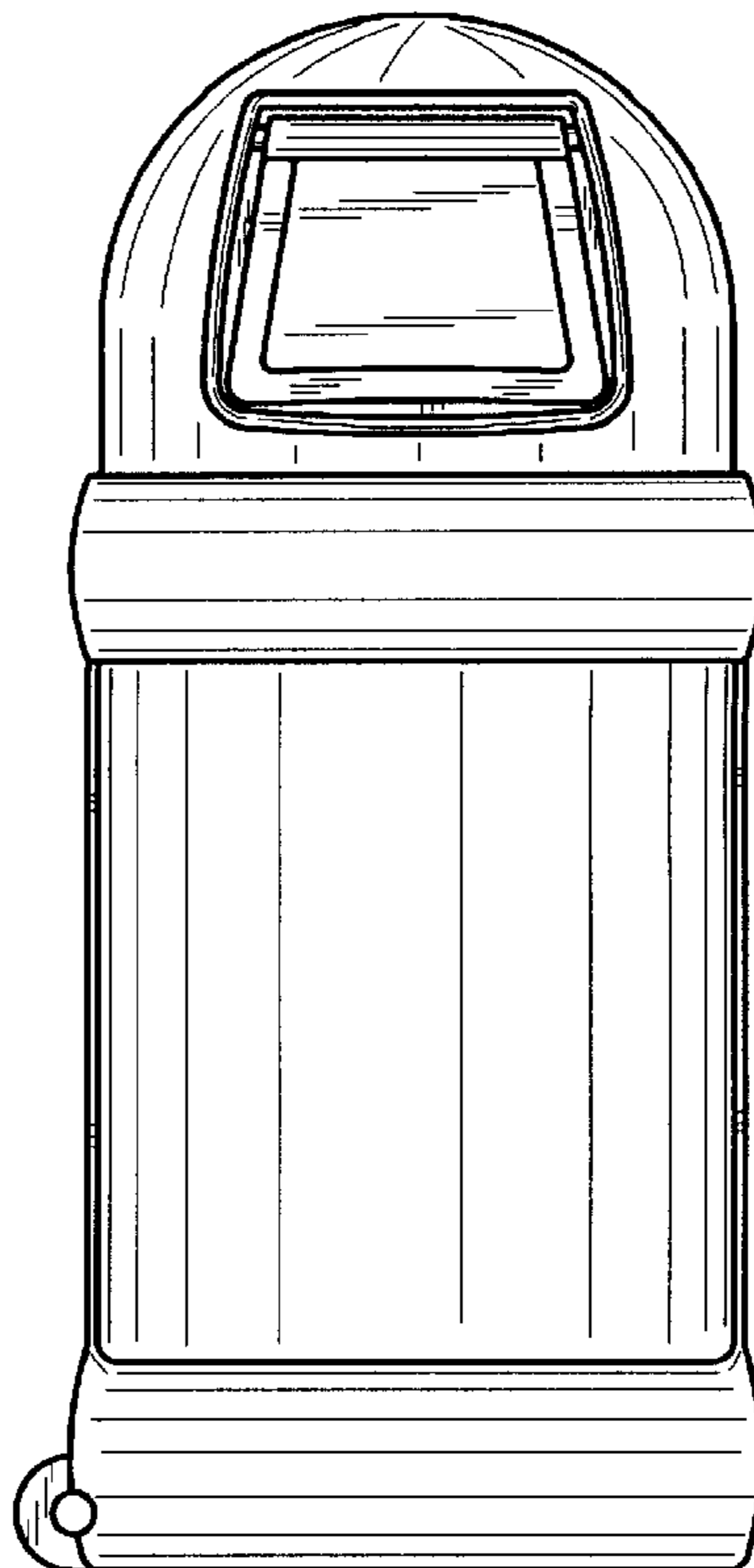
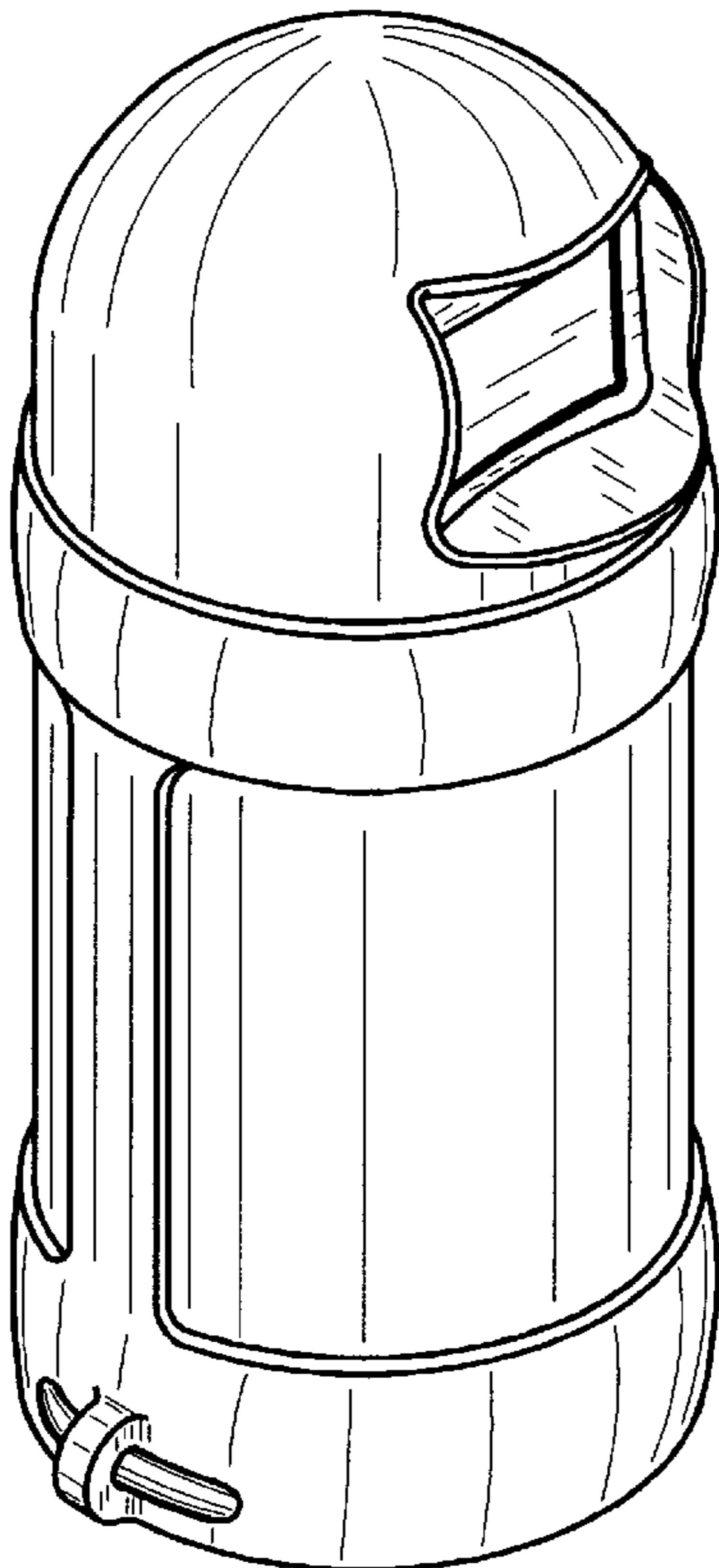
FIG. 1 is a perspective view of a waste container showing my new design;

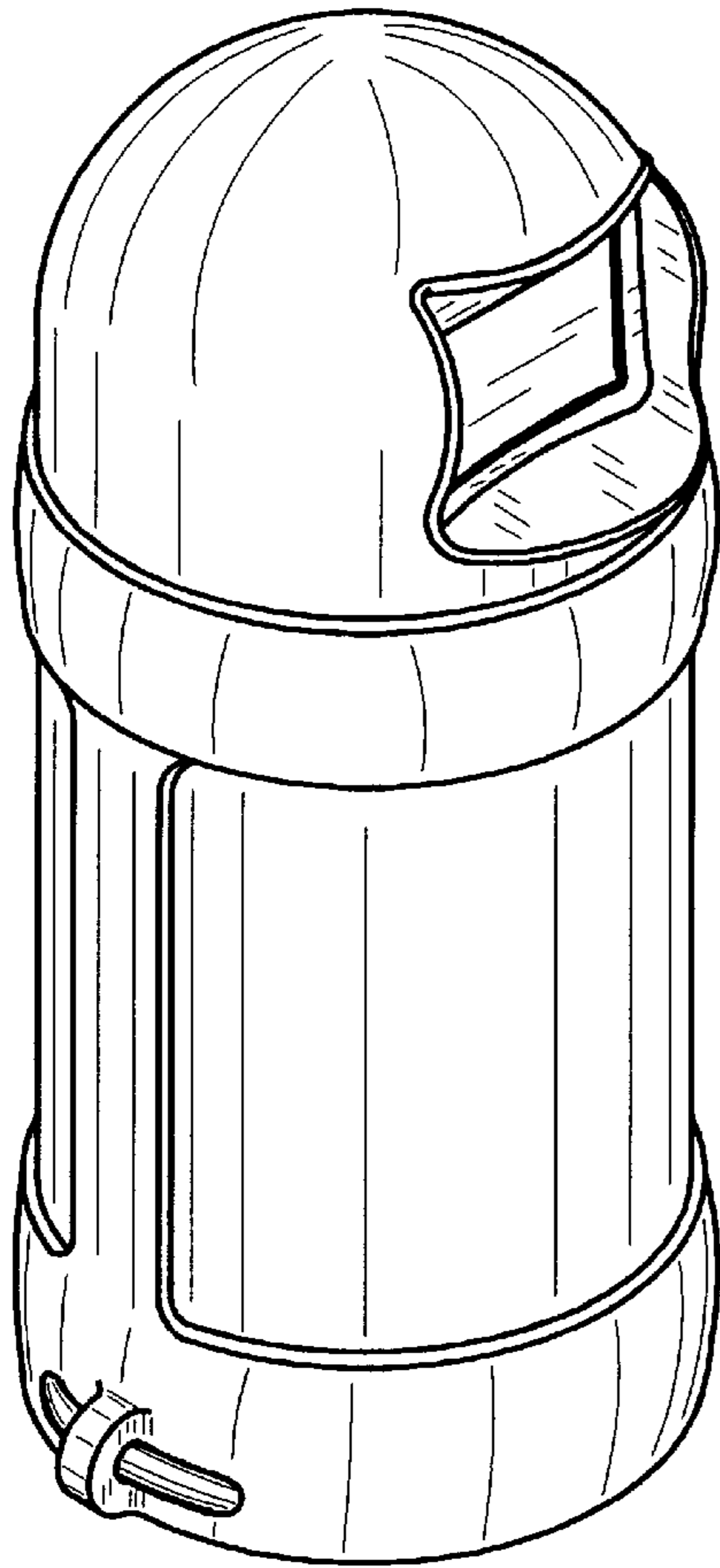

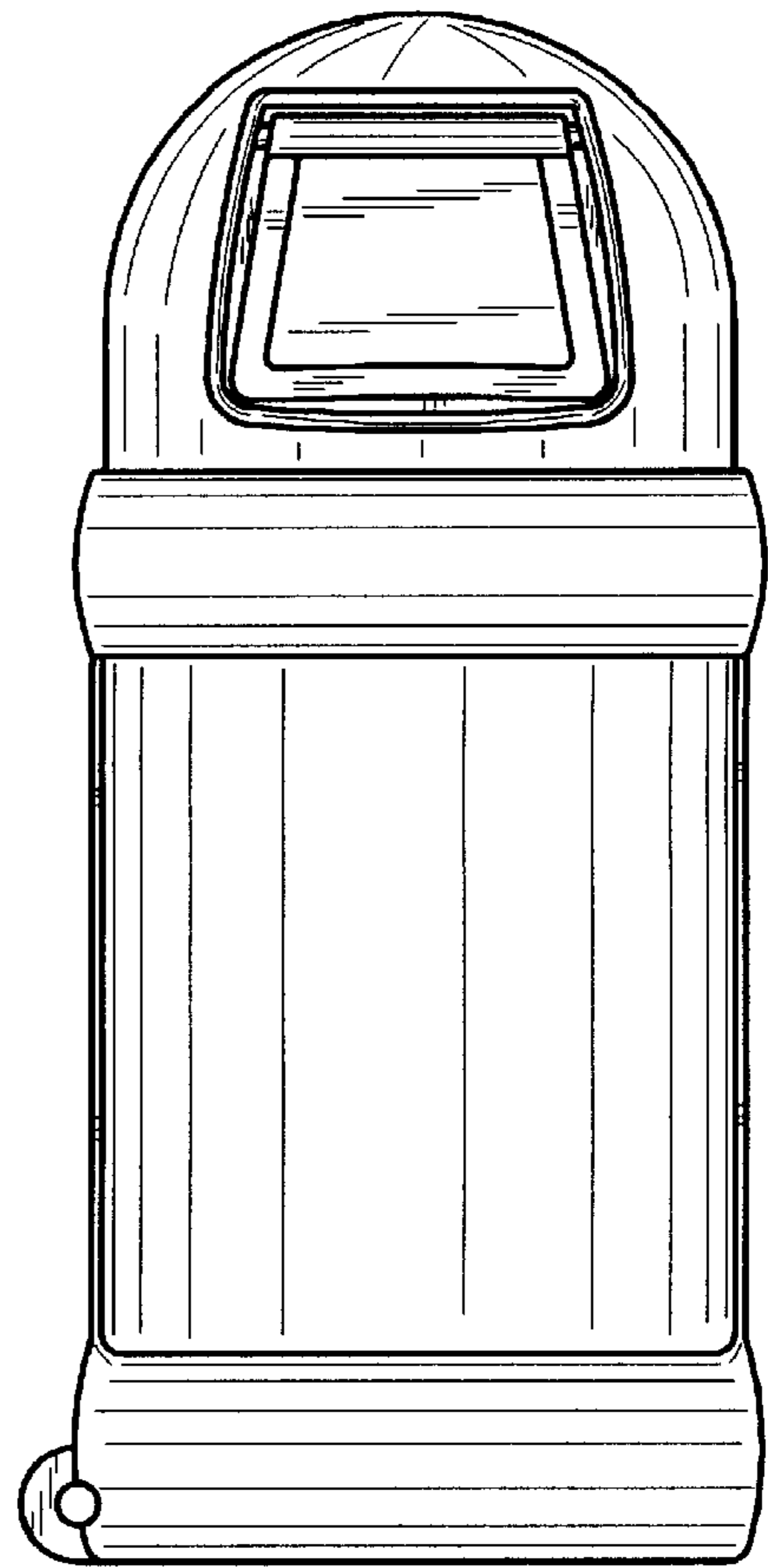

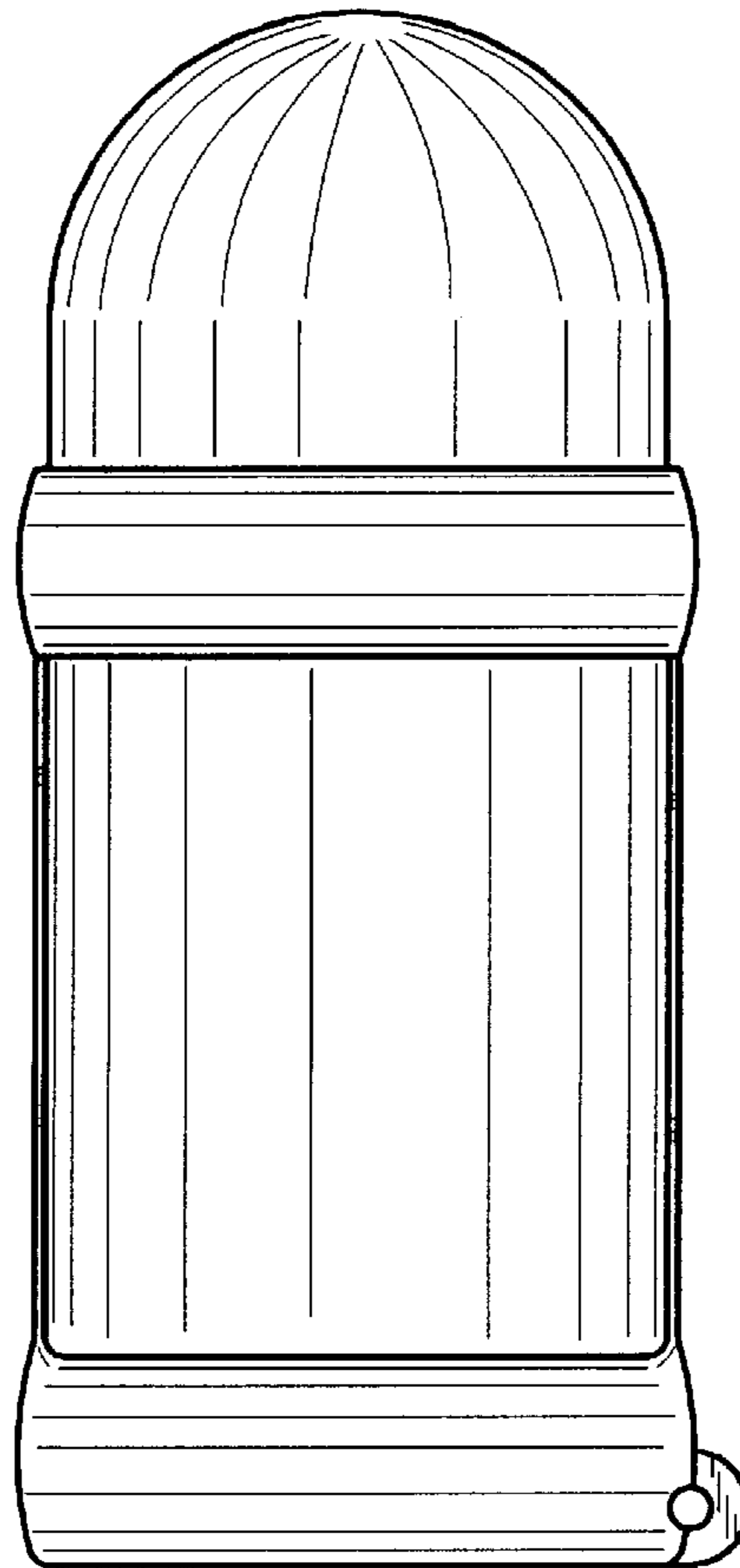

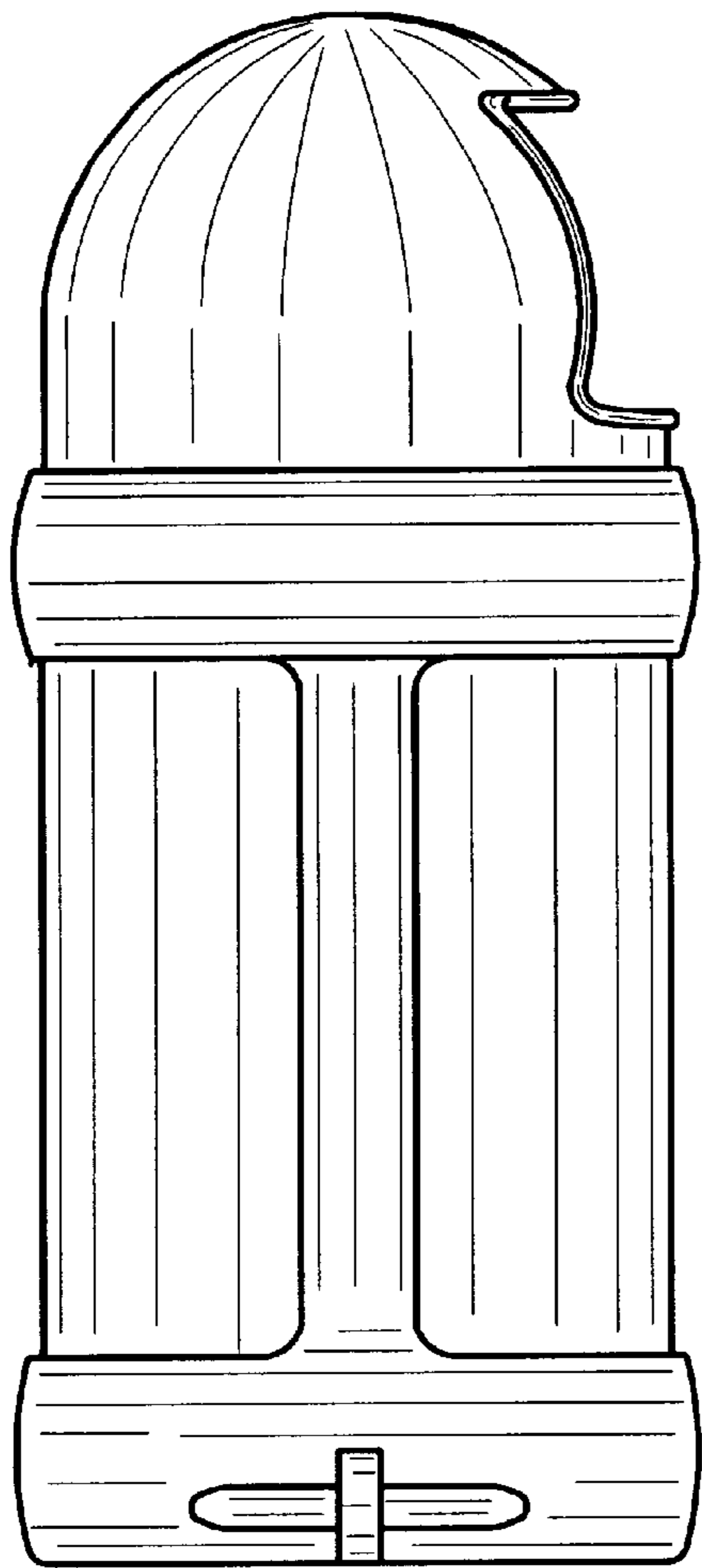

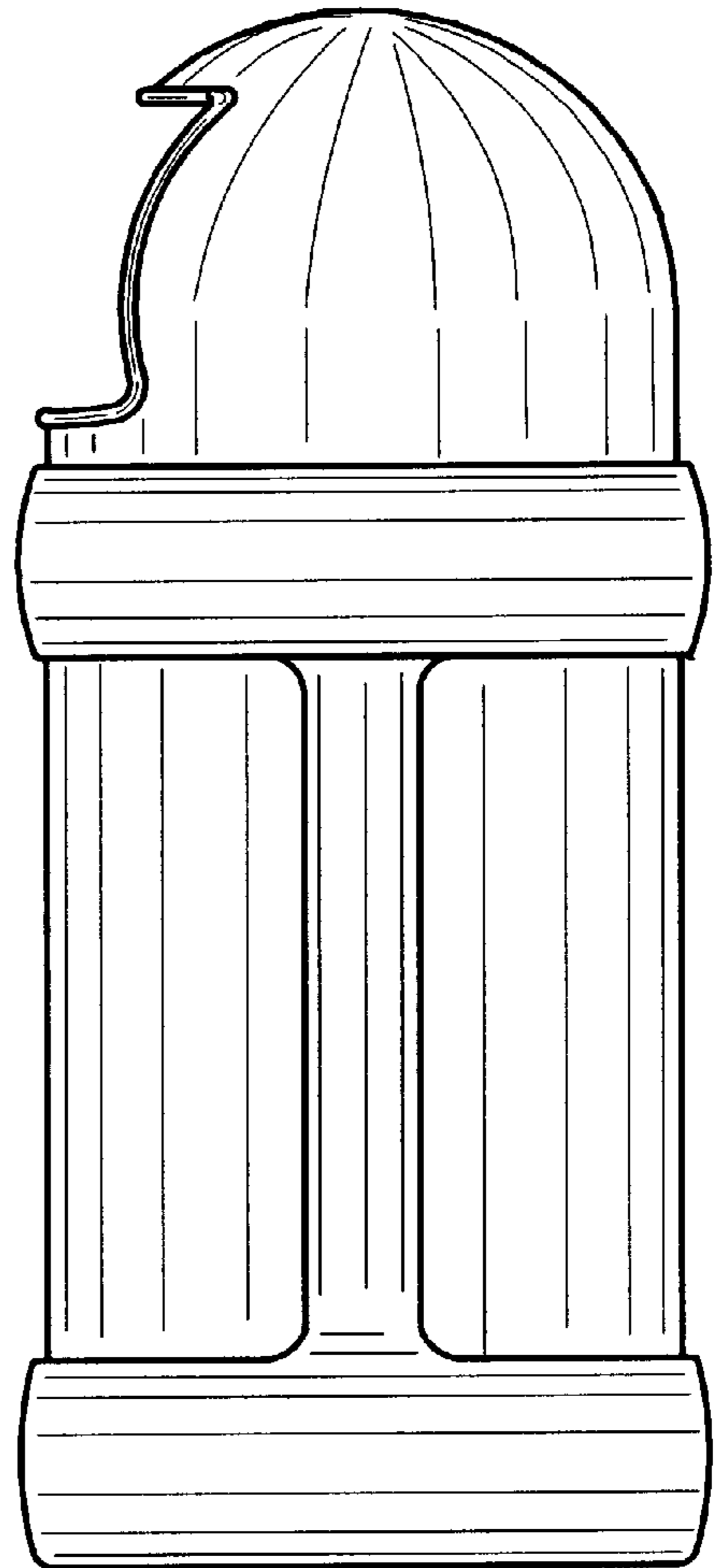

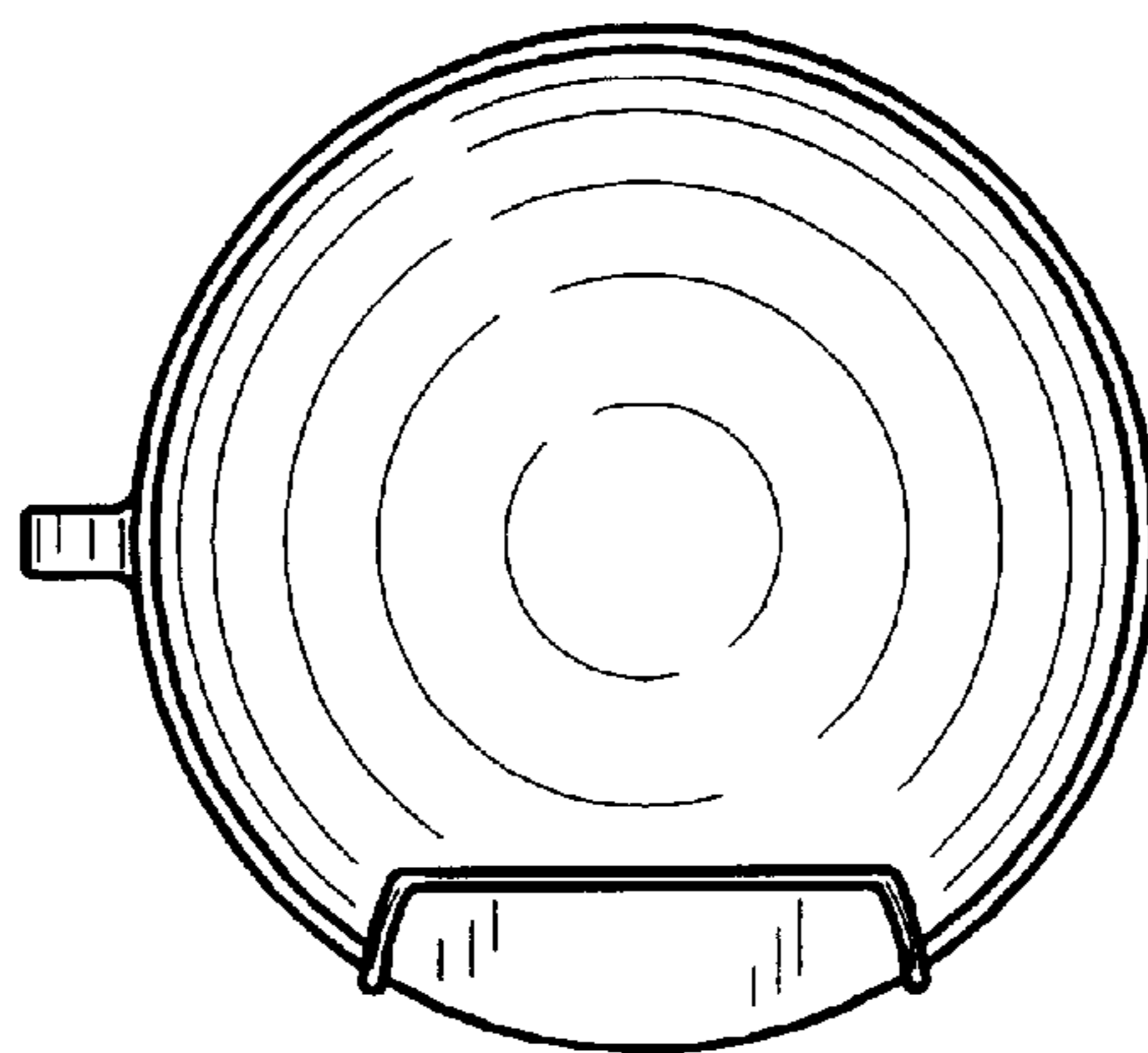
