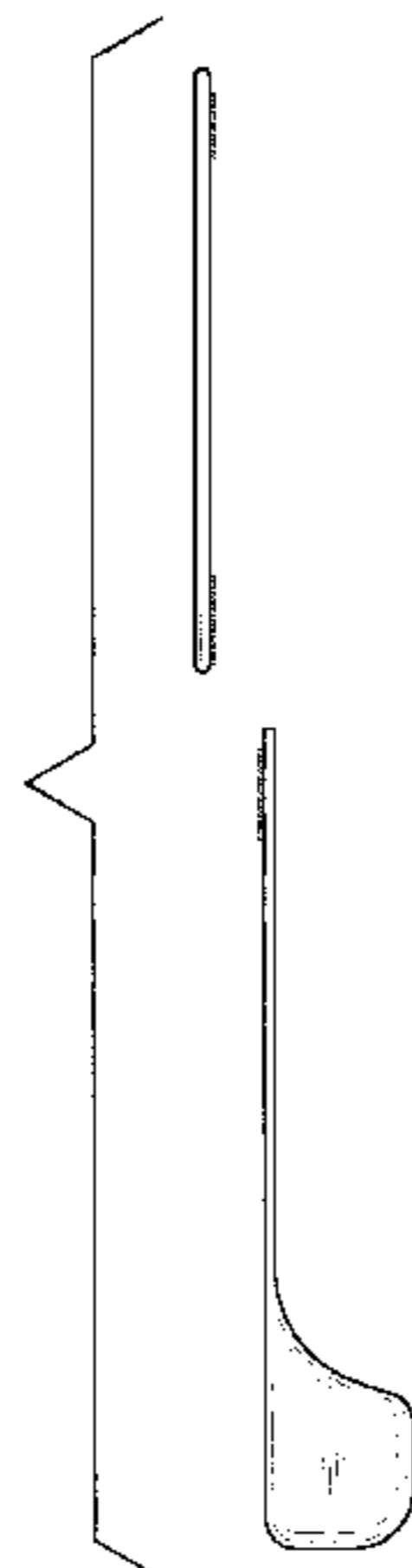
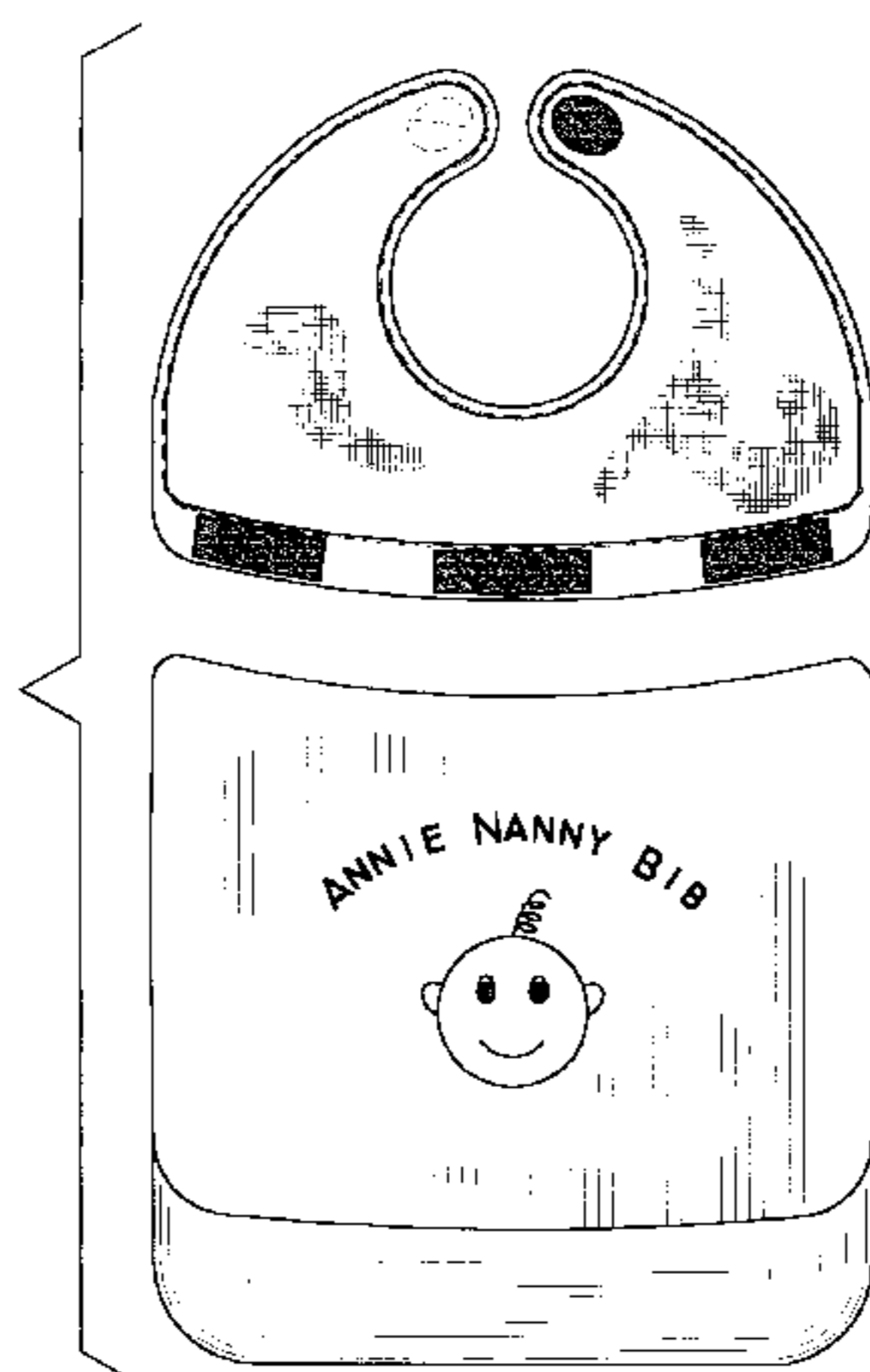
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of an infant bib showing my new design;

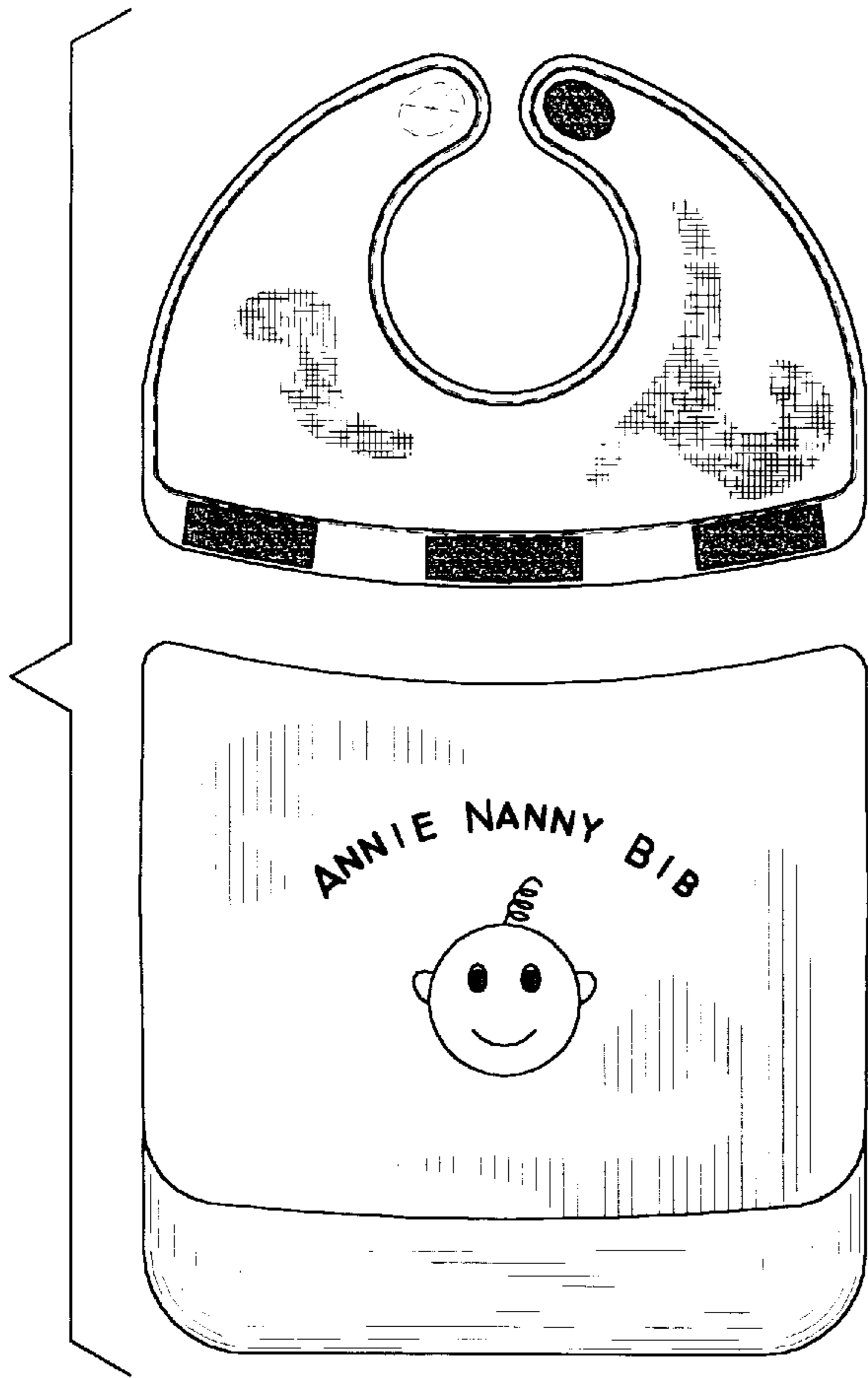

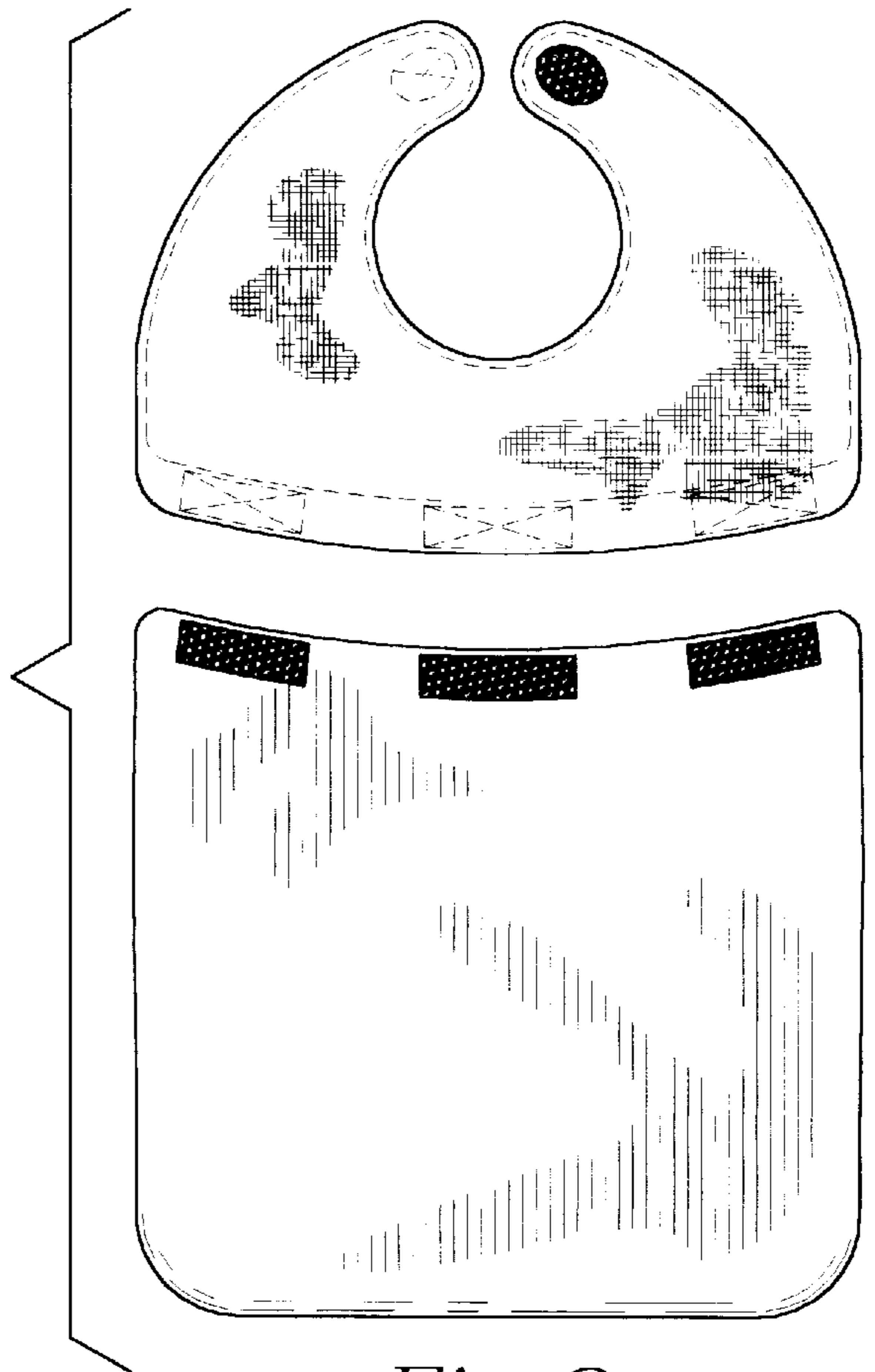

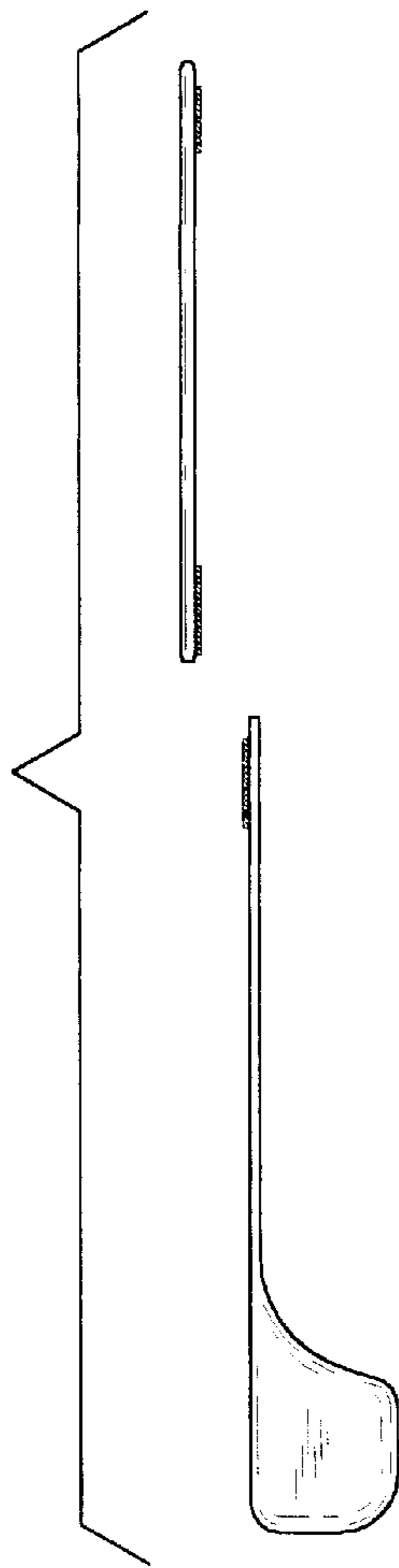

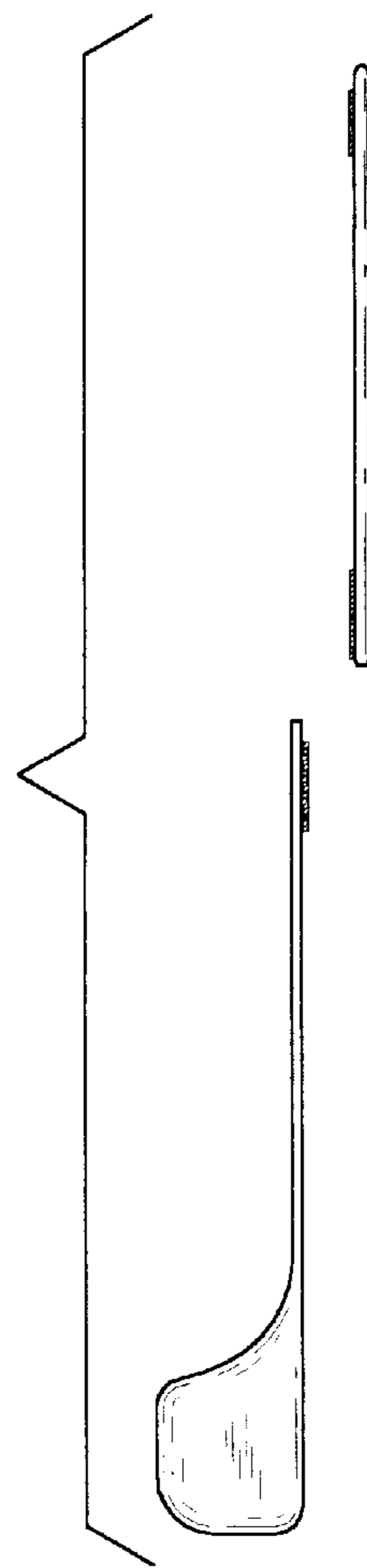

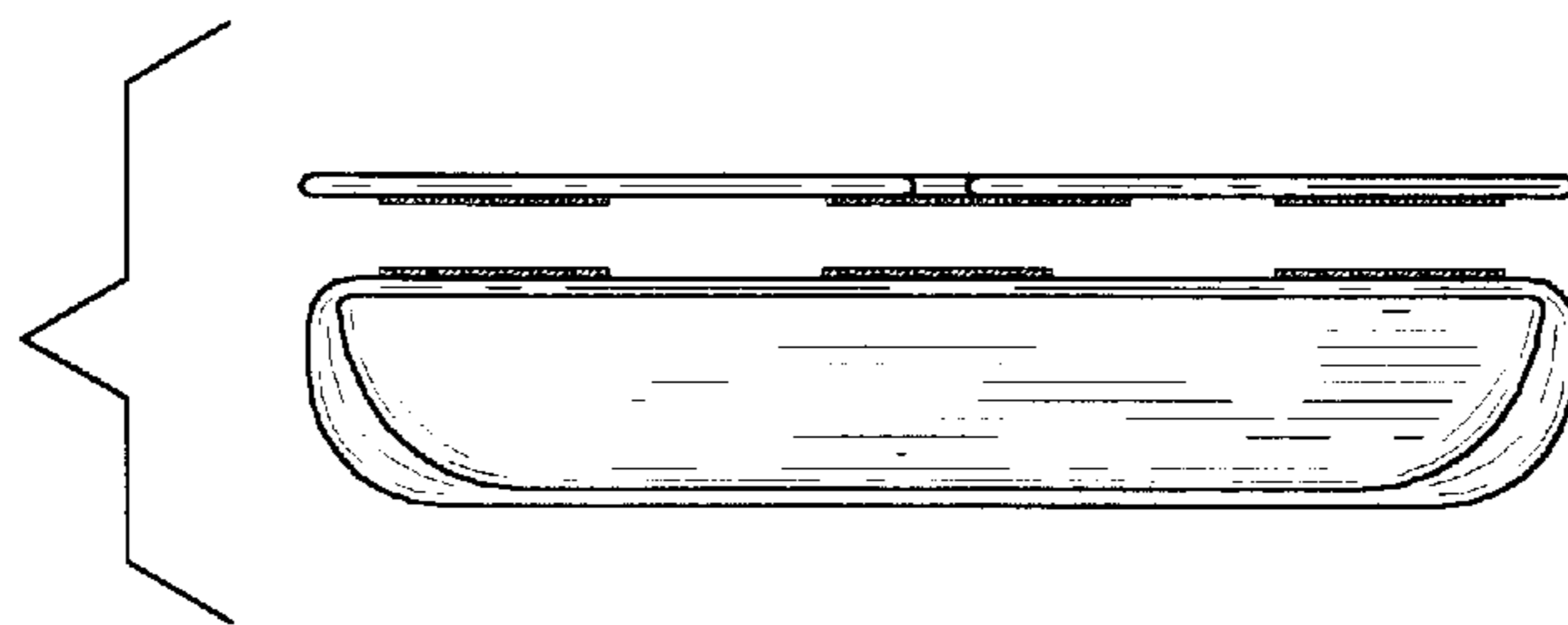

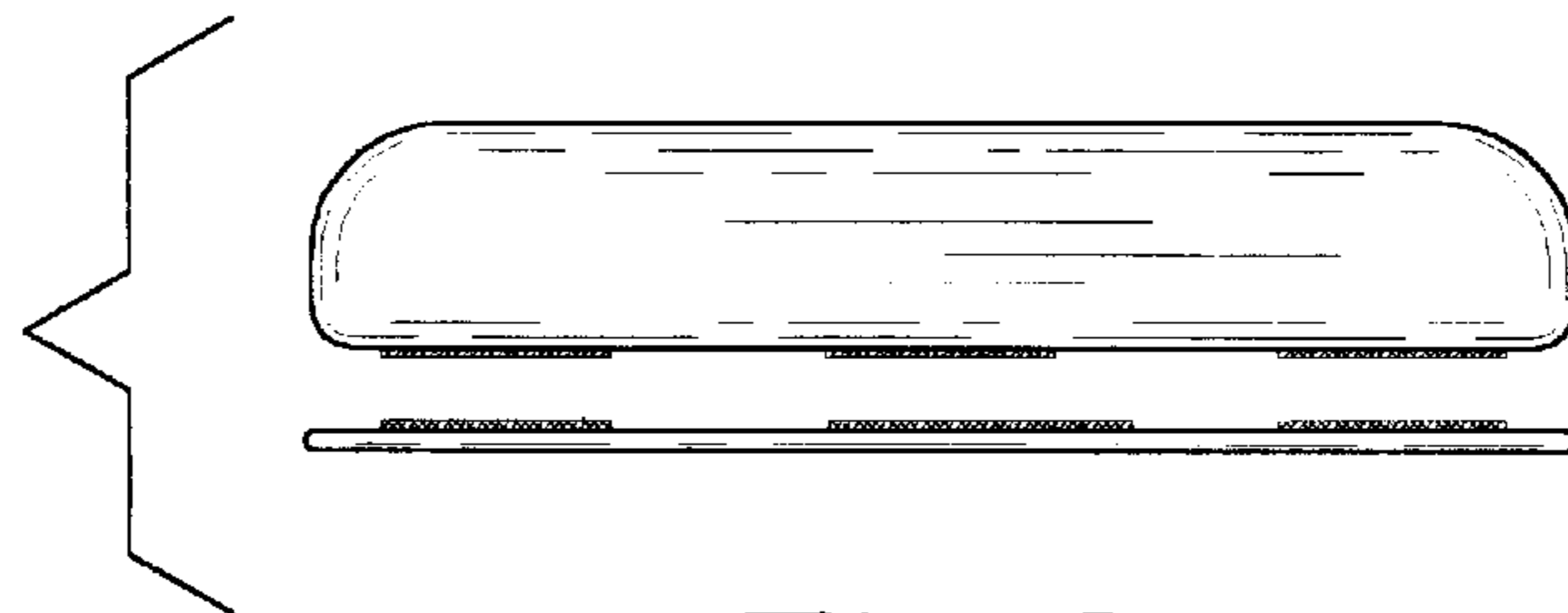
