[57] **CLAIM**

The ornamental design for a cap, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a cap showing a first embodiment of my new design, with a flap covering an

opening in the rear—the broken line showing the outline of a head of a person is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a rear perspective view of the first embodiment, illustrating the flap swung away from the opening;

FIG. 3 is a front perspective view of the first embodiment—the broken line showing a circular patch or logo (in the figures illustrating the front of the new design) is for illustrative purposes only and forms no part of the claimed design;

FIG. 4 is a bottom perspective view of the first embodiment;

FIG. 5 is a rear elevational view of the first embodiment;

FIG. 6 is a left side elevational view of the first embodiment;

FIG. 7 is a right side elevation view of the first embodiment;

FIG. 8 is a top plan view of the first embodiment;

FIG. 9 is a bottom plan view of the first embodiment;

FIG. 10 is a rear perspective view of a second embodiment of a cap showing my new design, the broken line showing of the human form is for illustrative purposes only and forms no part of the claimed design;

FIG. 11 is a bottom perspective view of a second embodiment, the broken line showing of the circular patch or logo is for illustrative purposes only and forms no part of the claimed design;

FIG. 12 is a rear elevational view of the second embodiment;

FIG. 13 is a left side elevational view of the second embodiment;

FIG. 14 is a right side elevational view of the second embodiment;

FIG. 15 is a top plan view of the second embodiment; and,

FIG. 16 is a bottom plan view of the second embodiment.

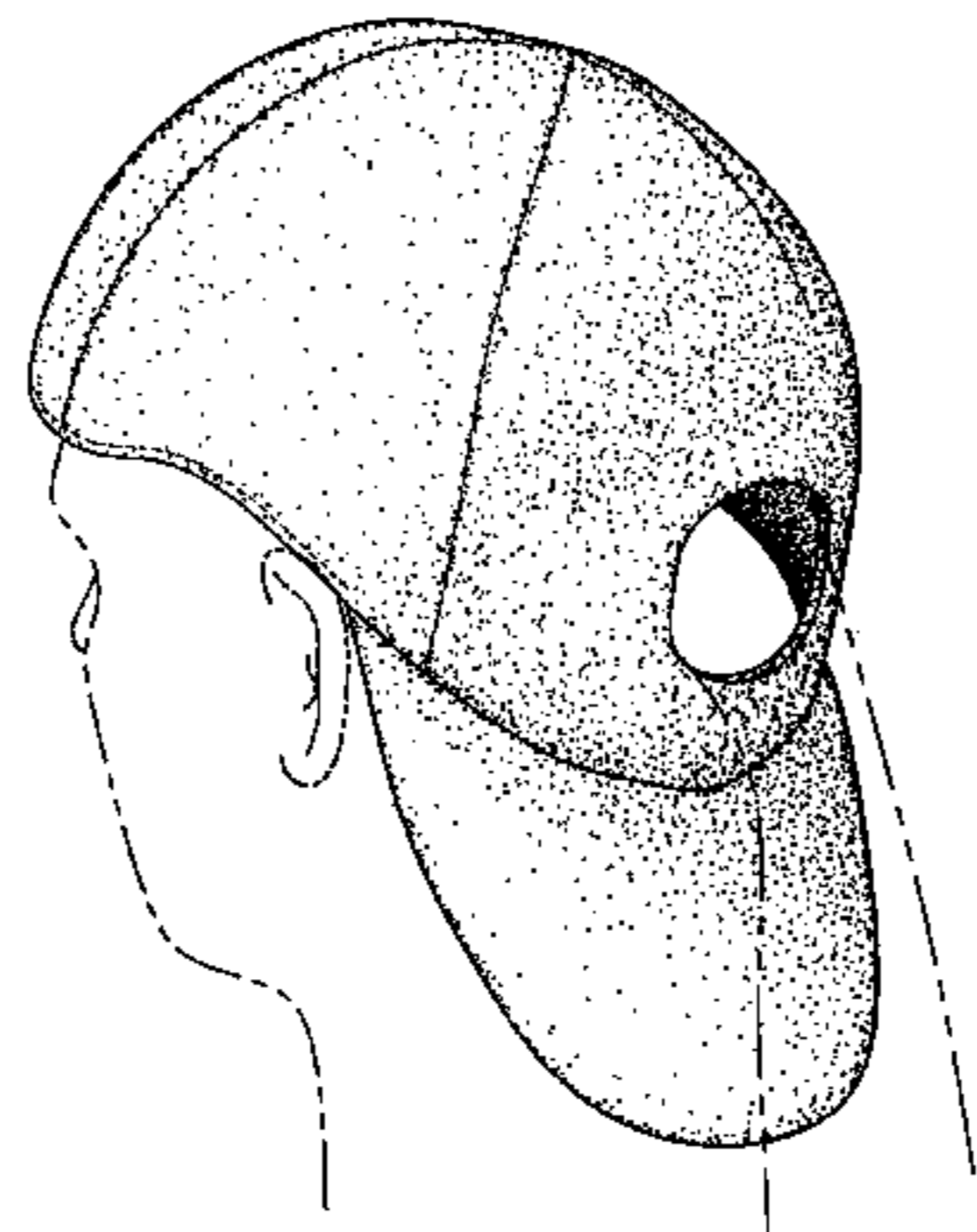
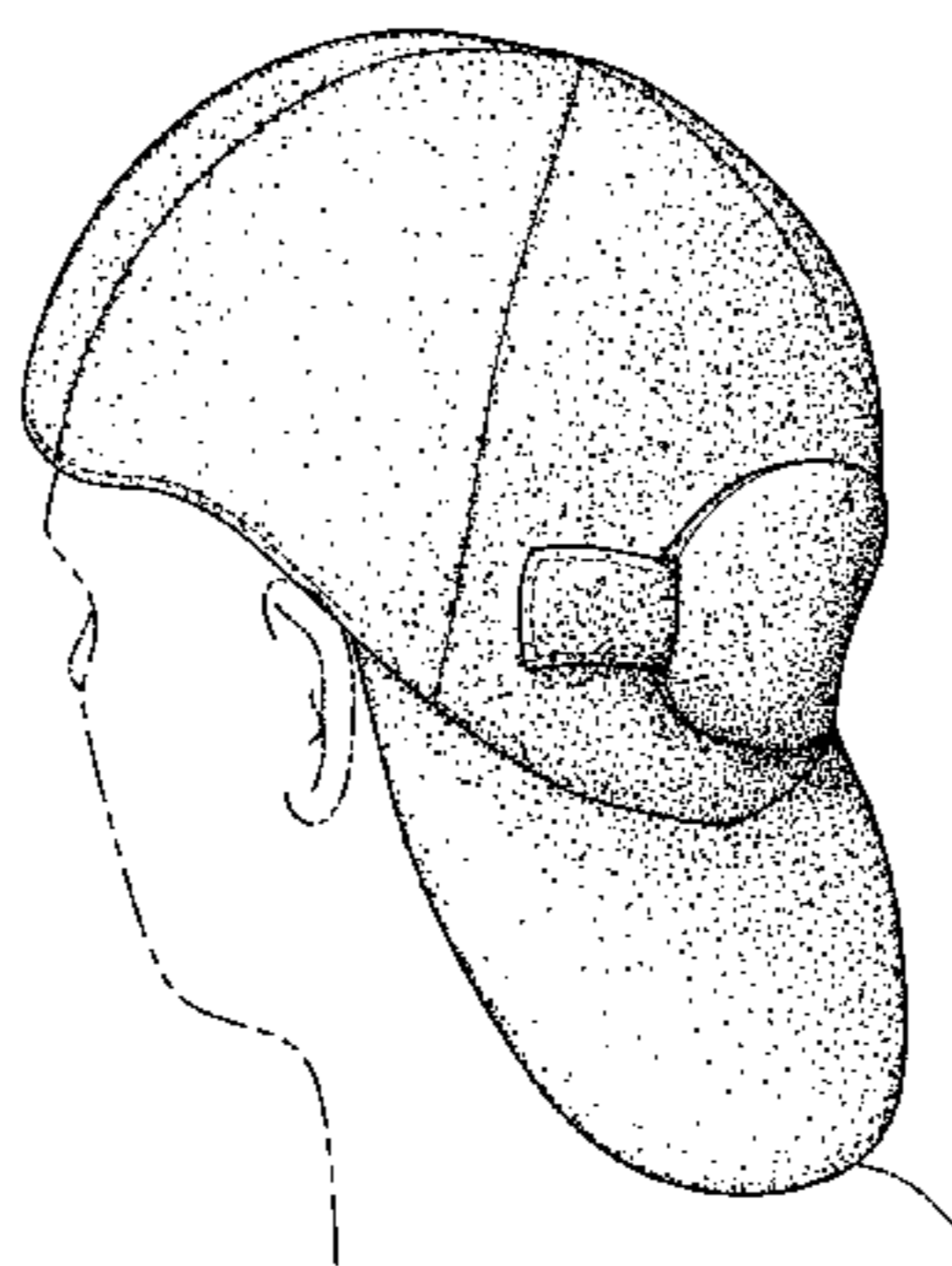

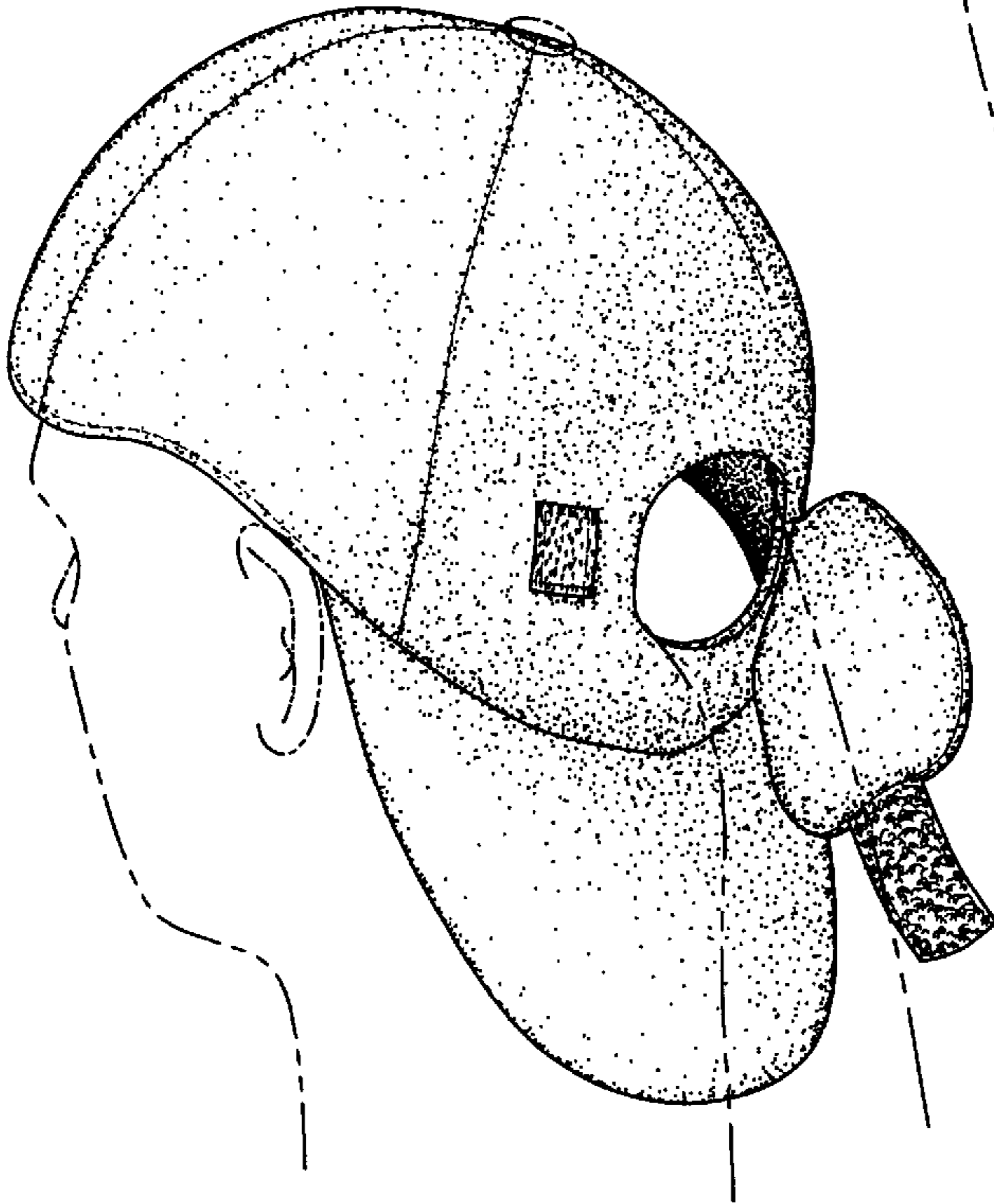
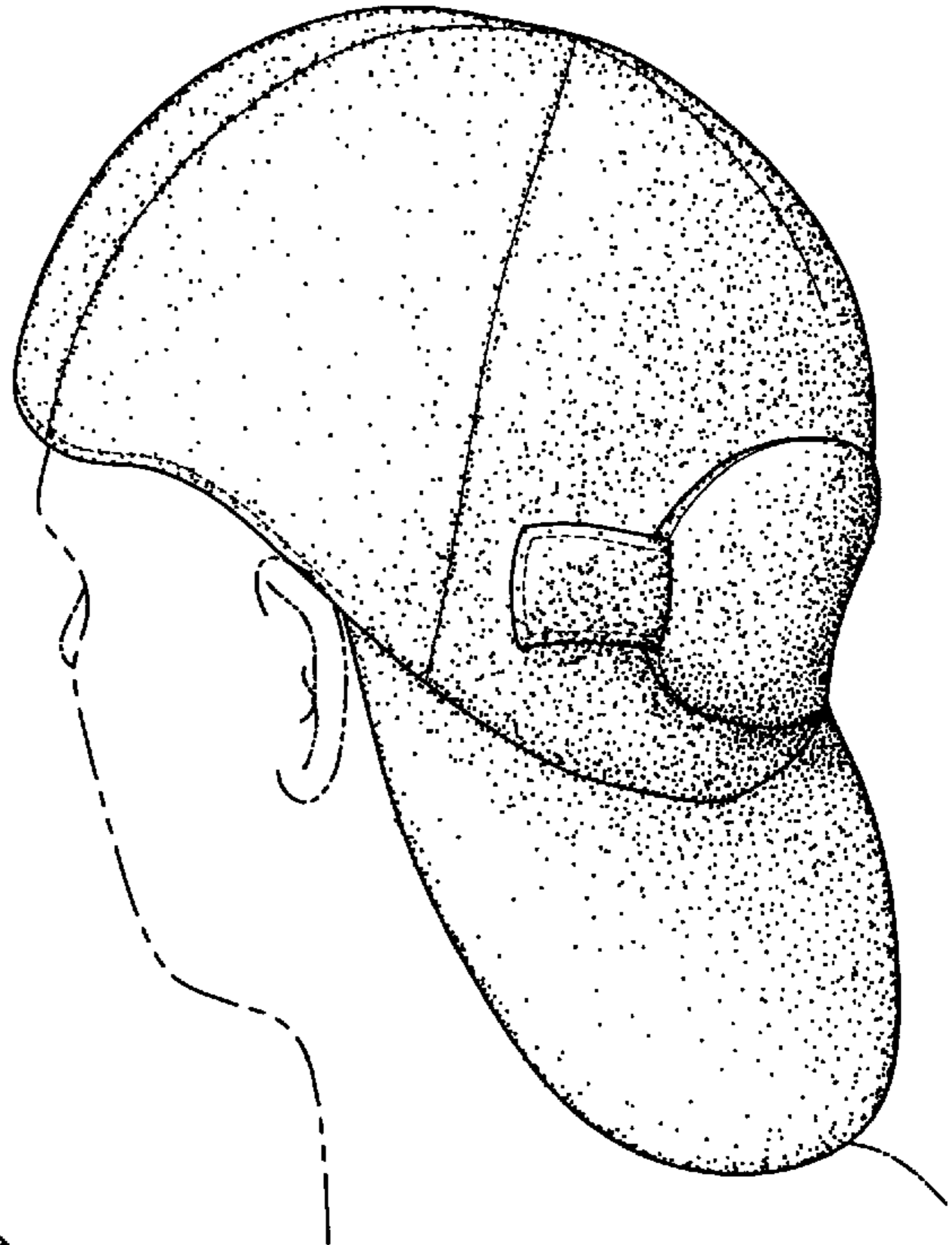

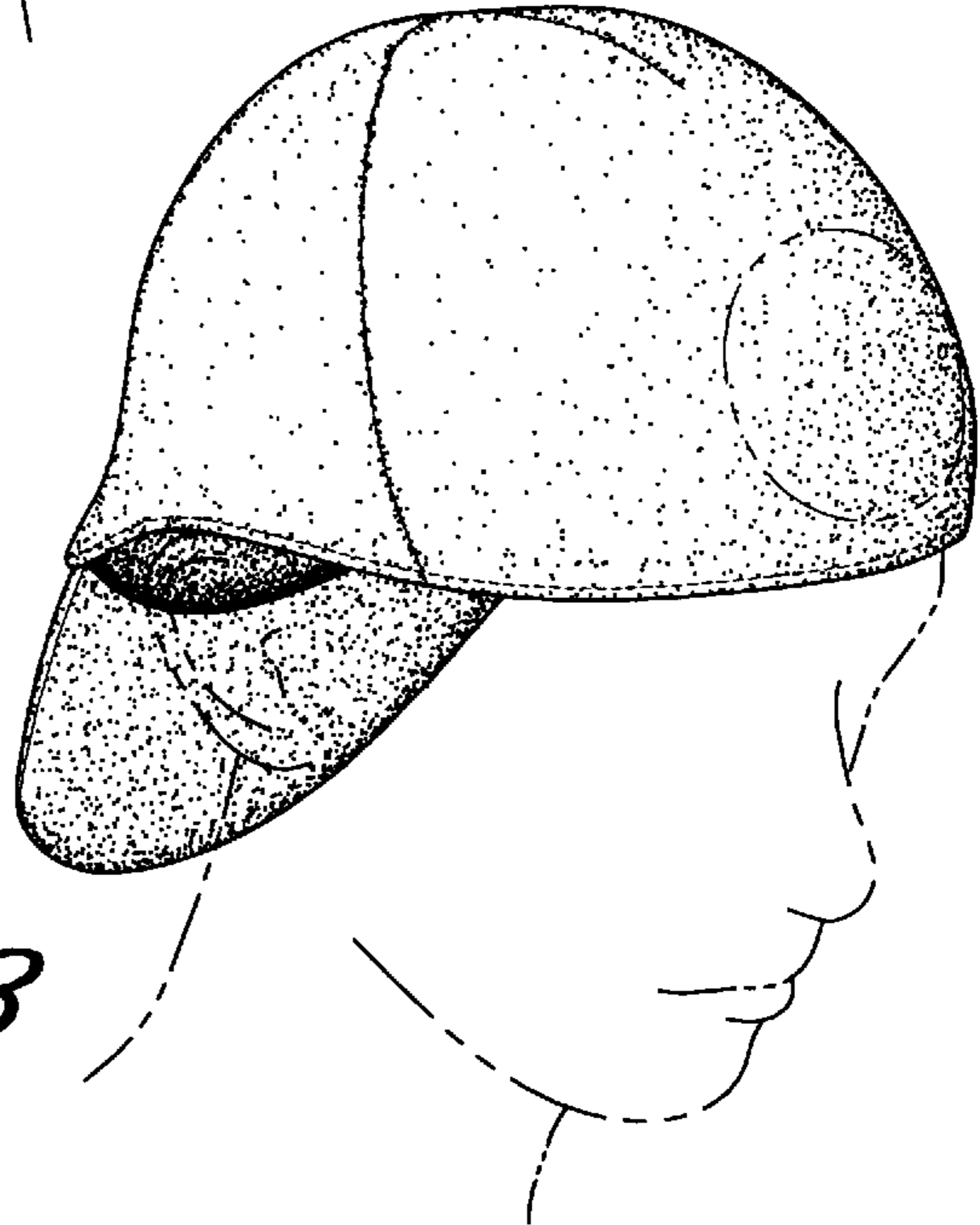

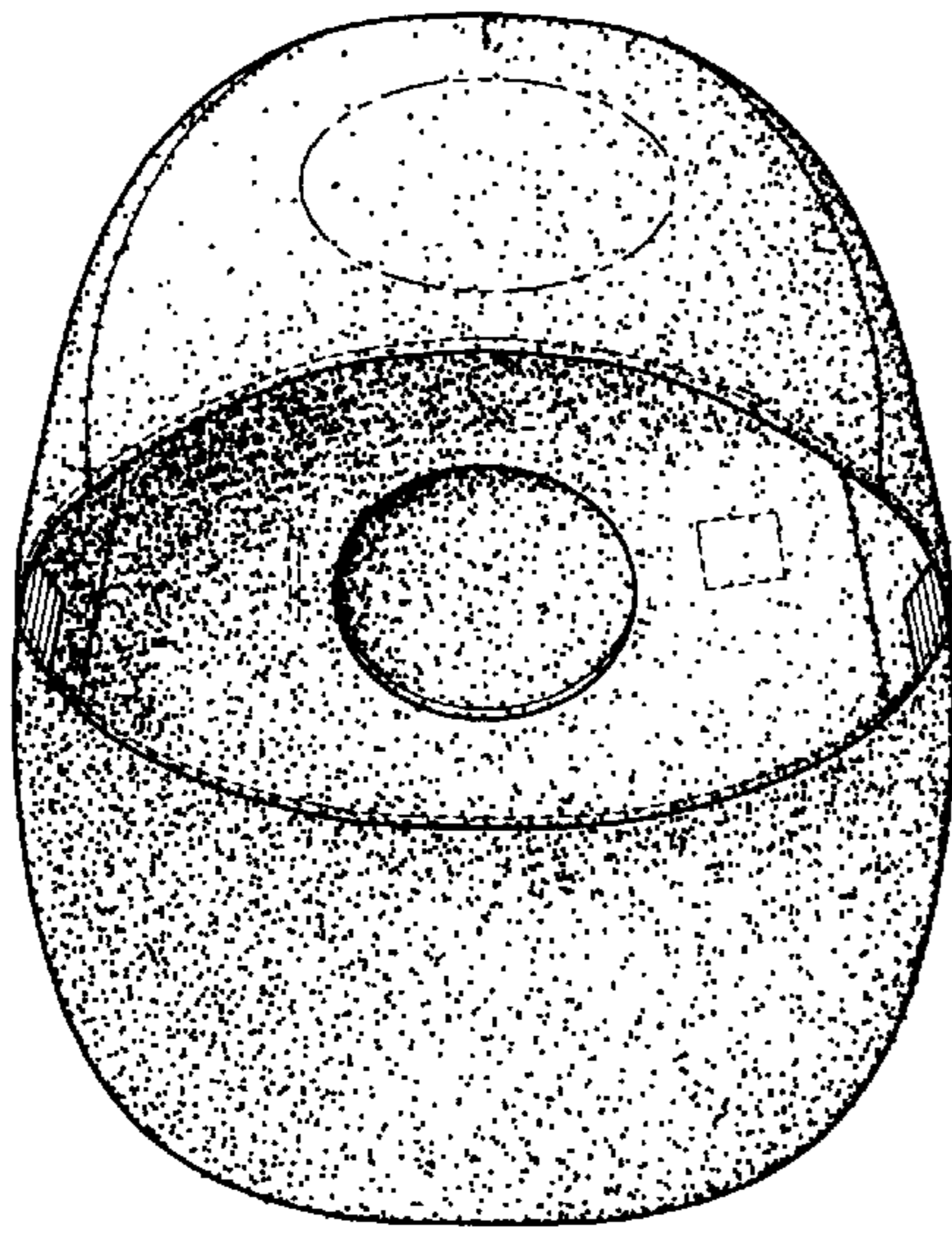

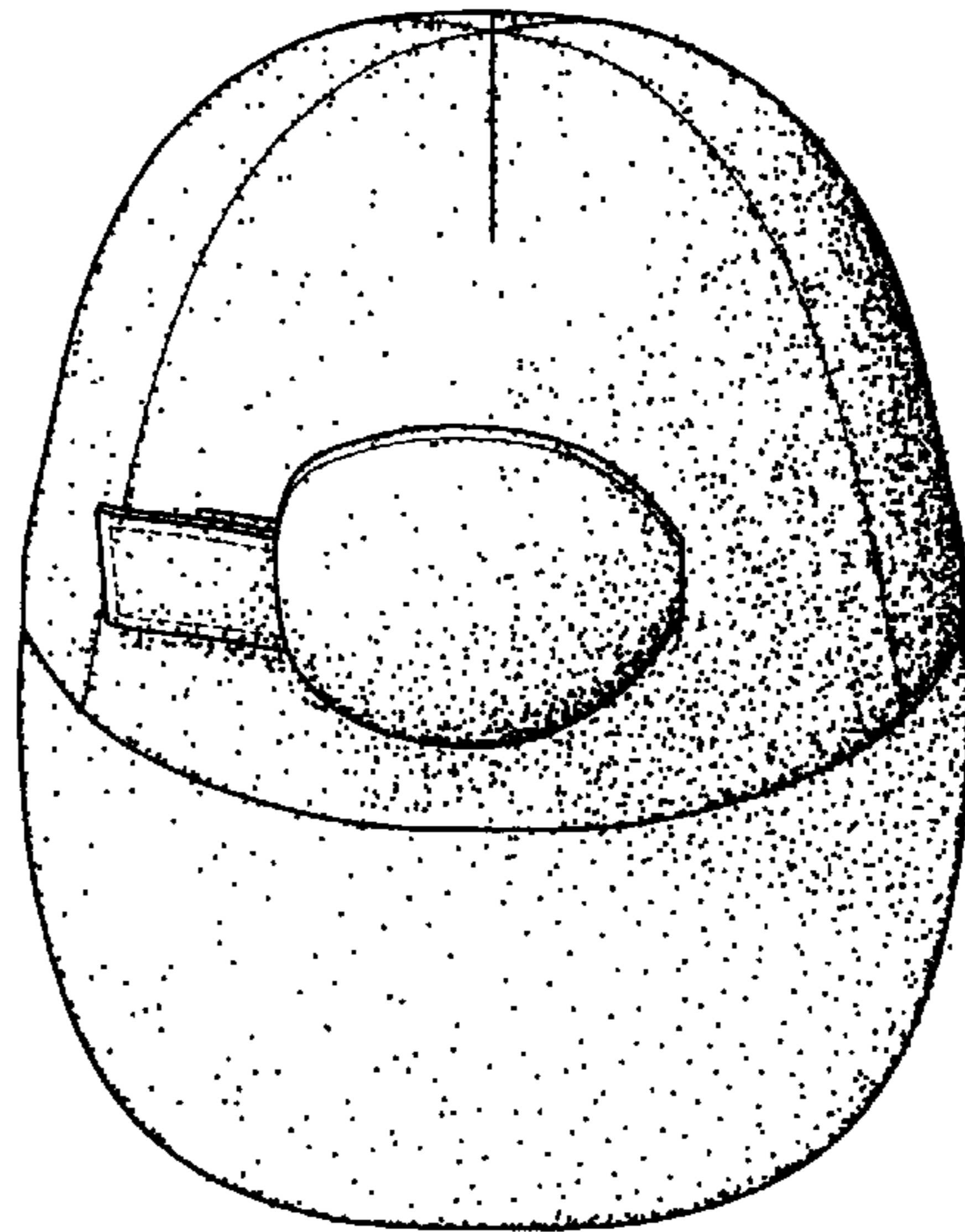

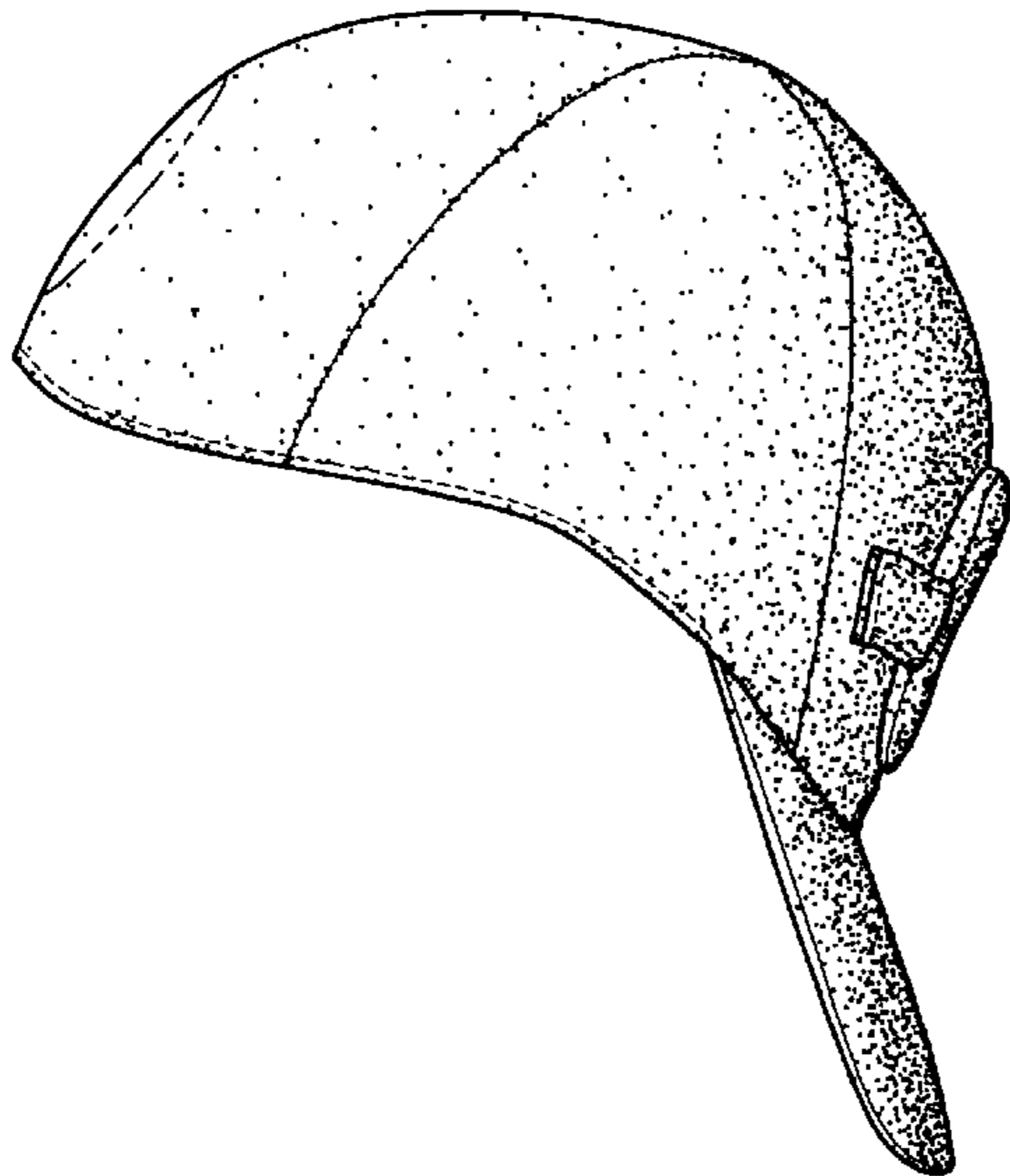

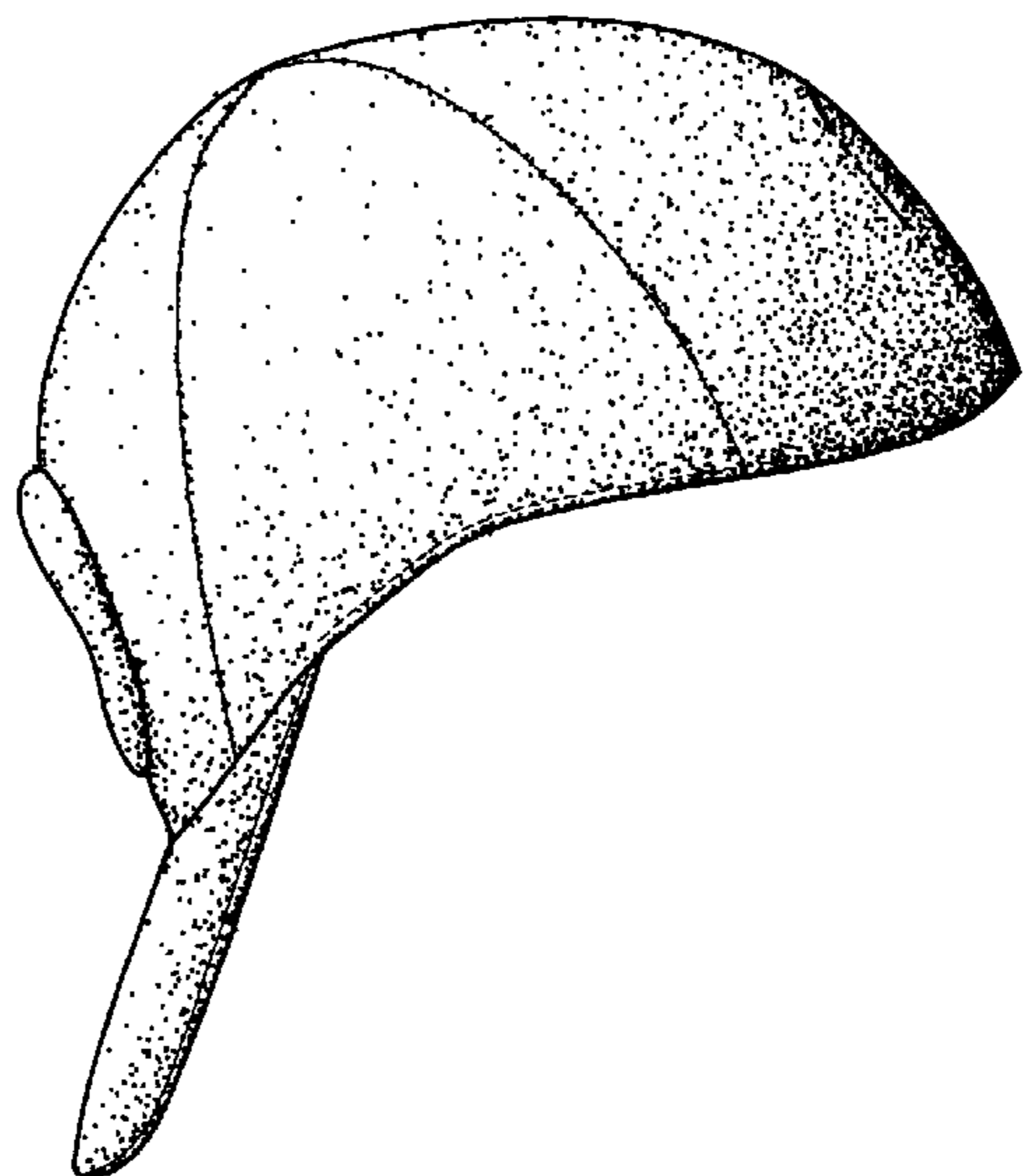

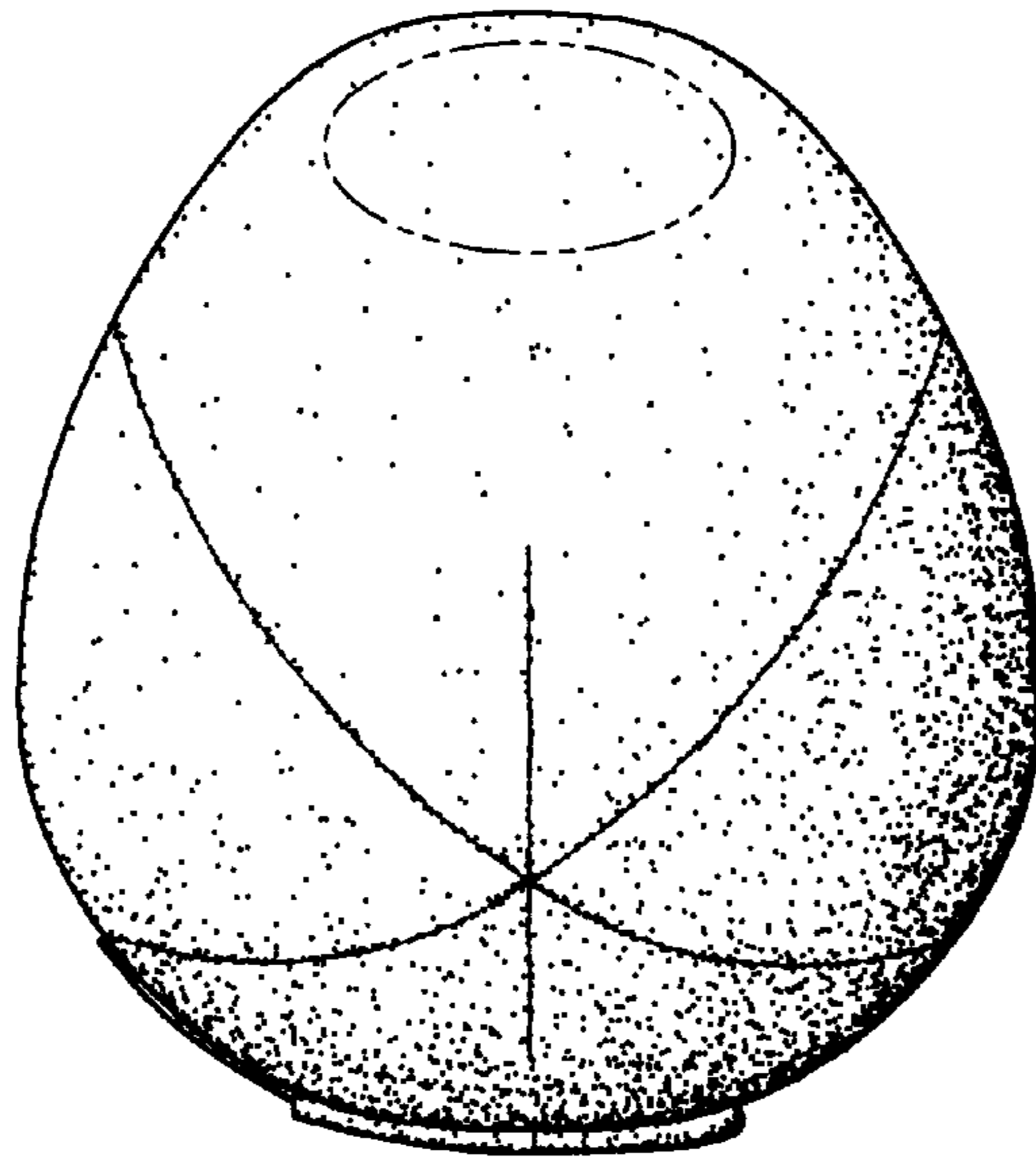

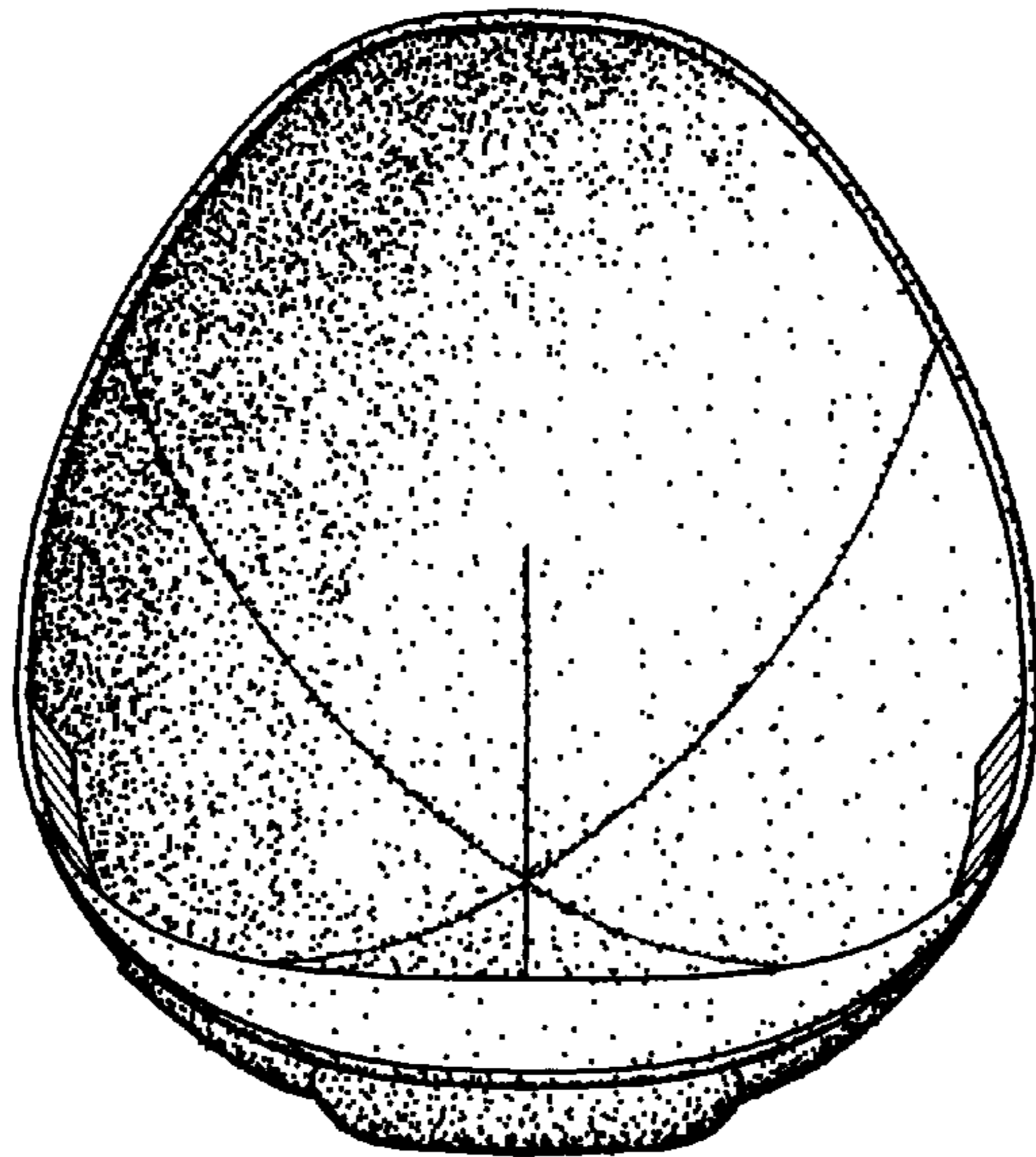

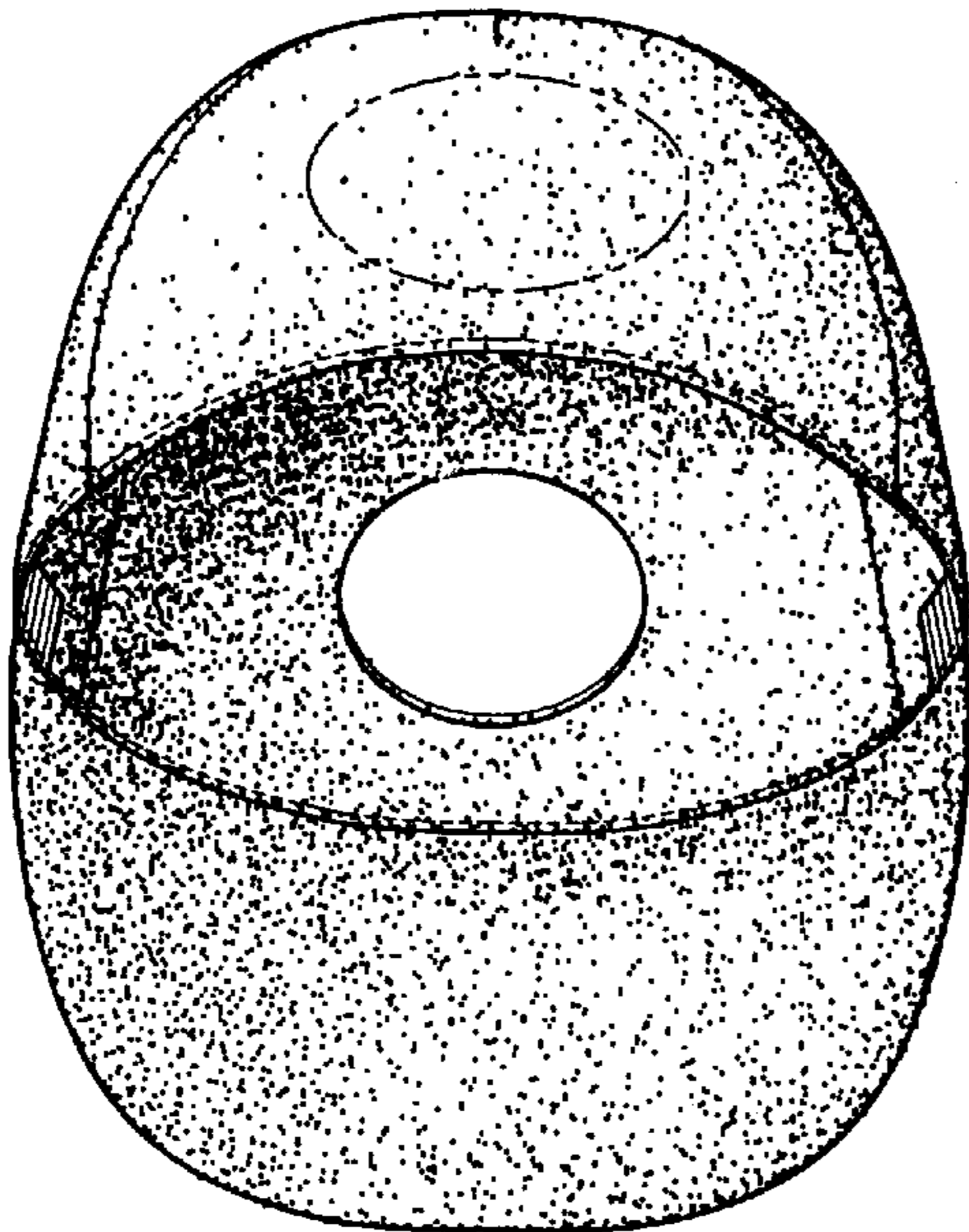
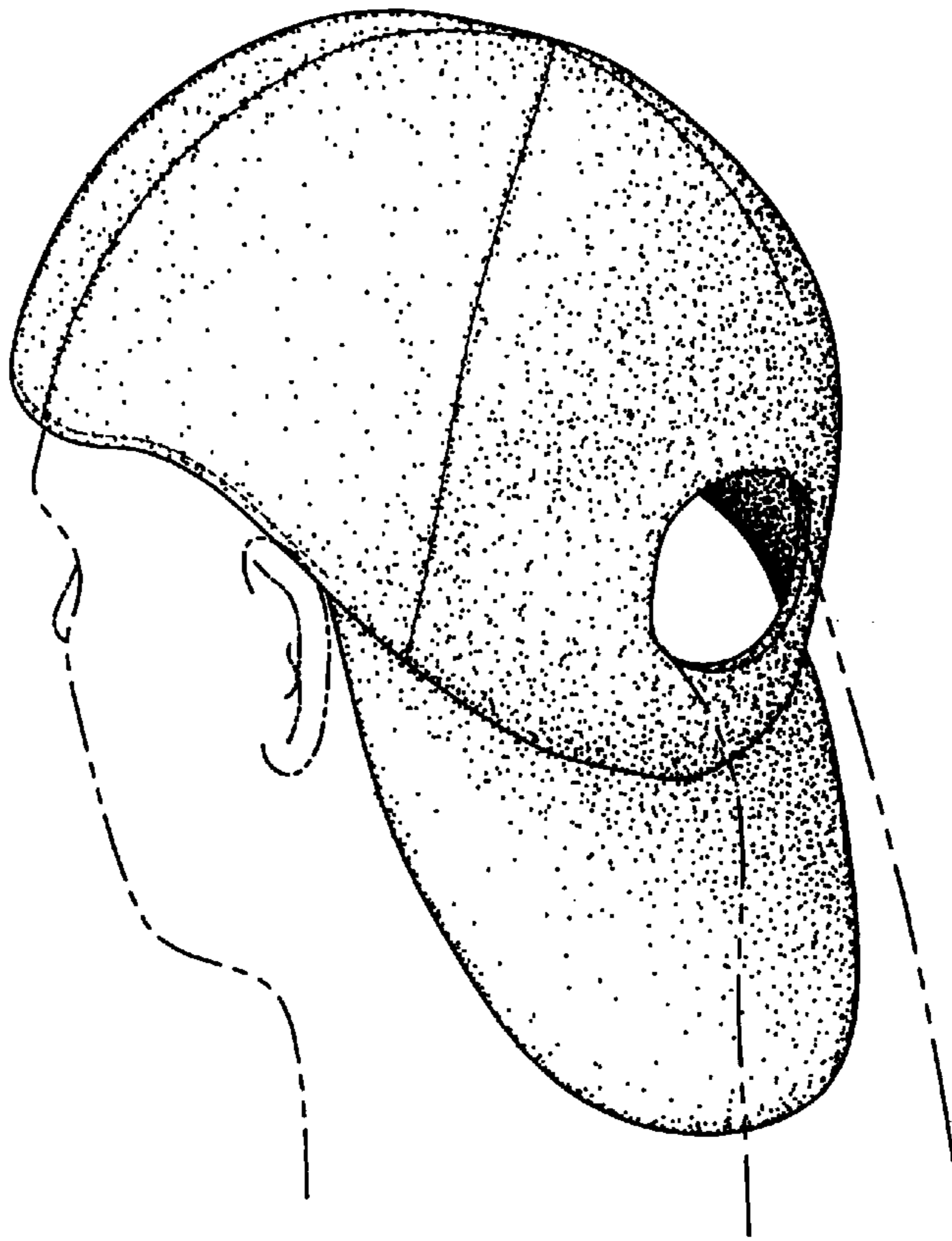

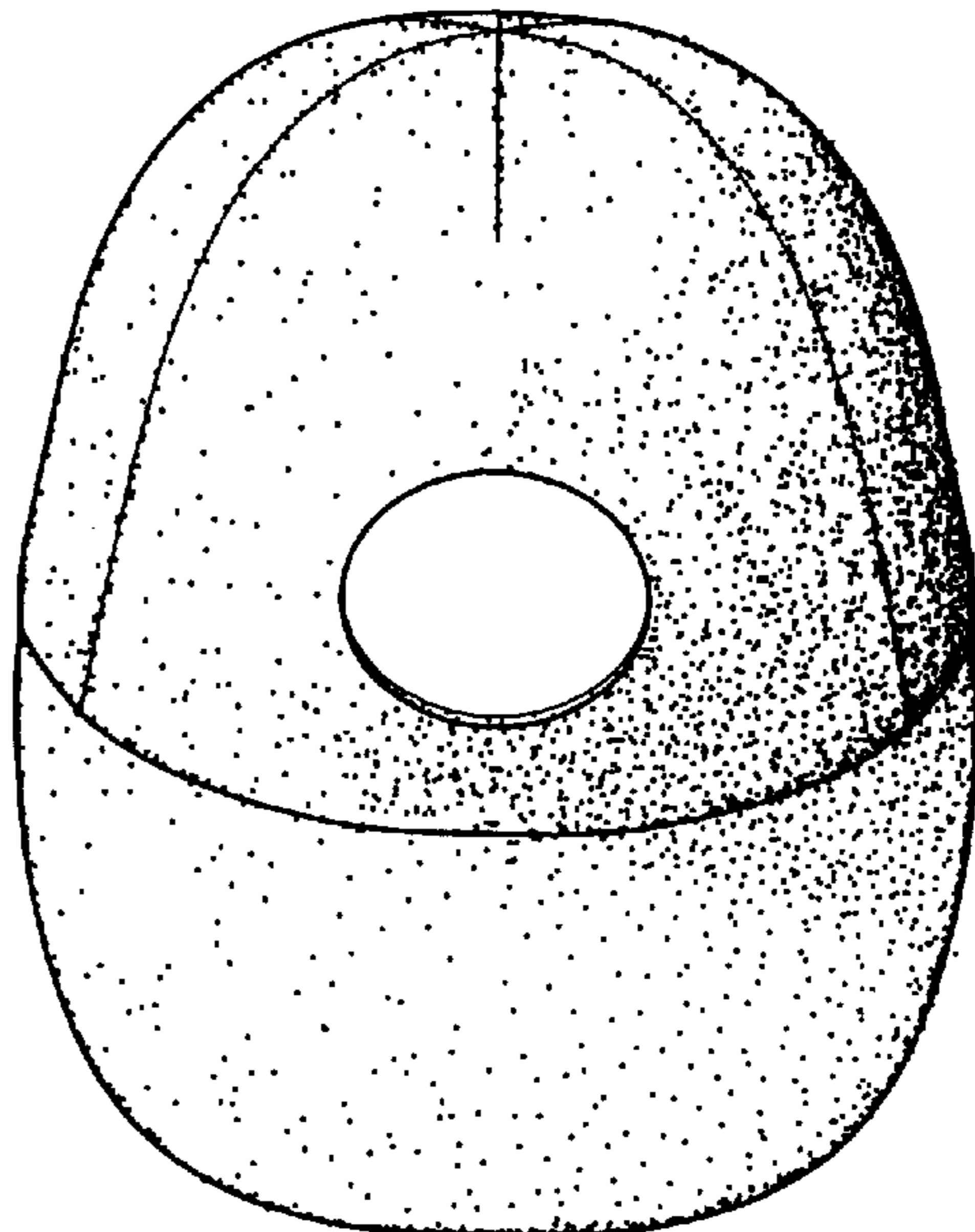

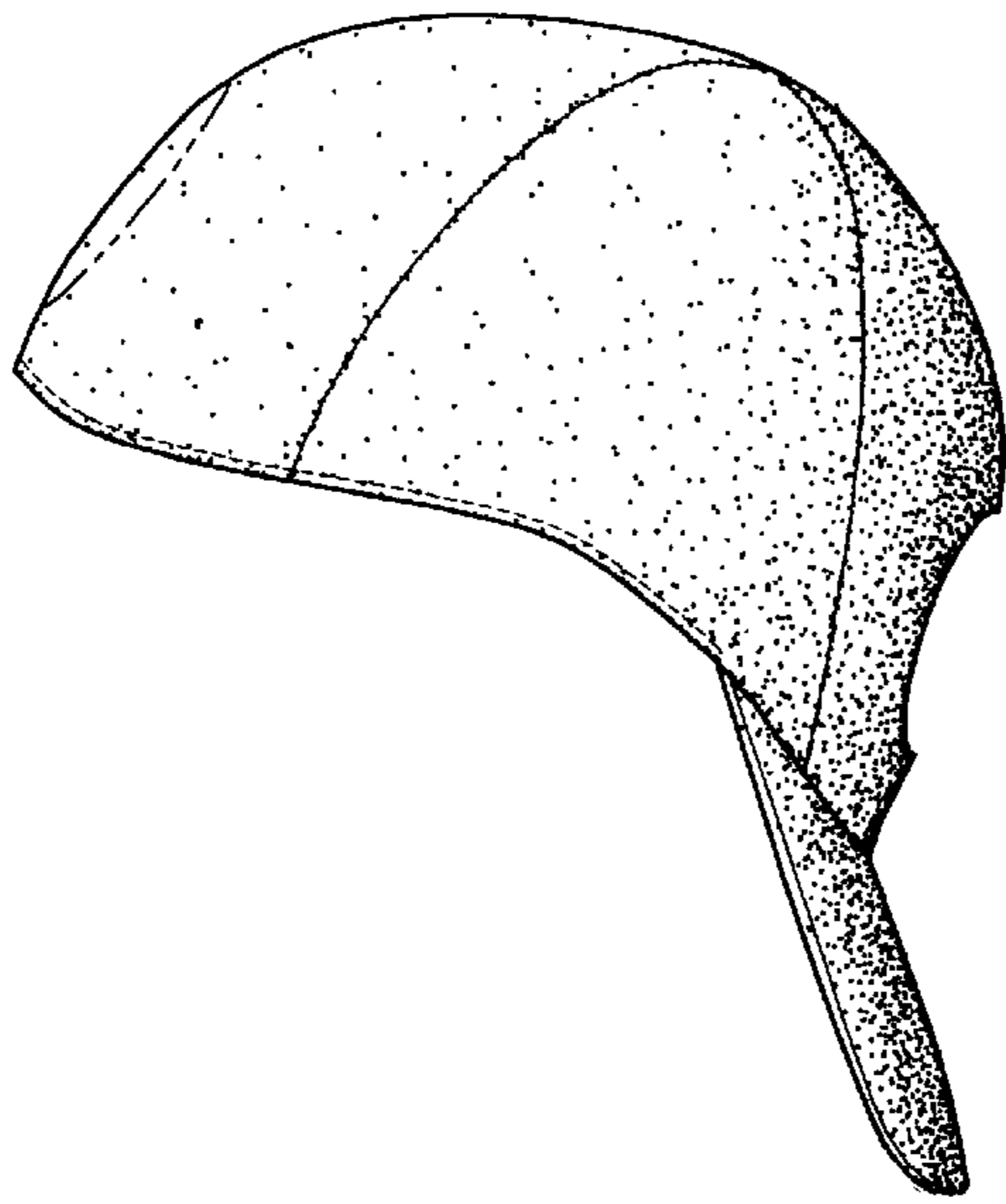

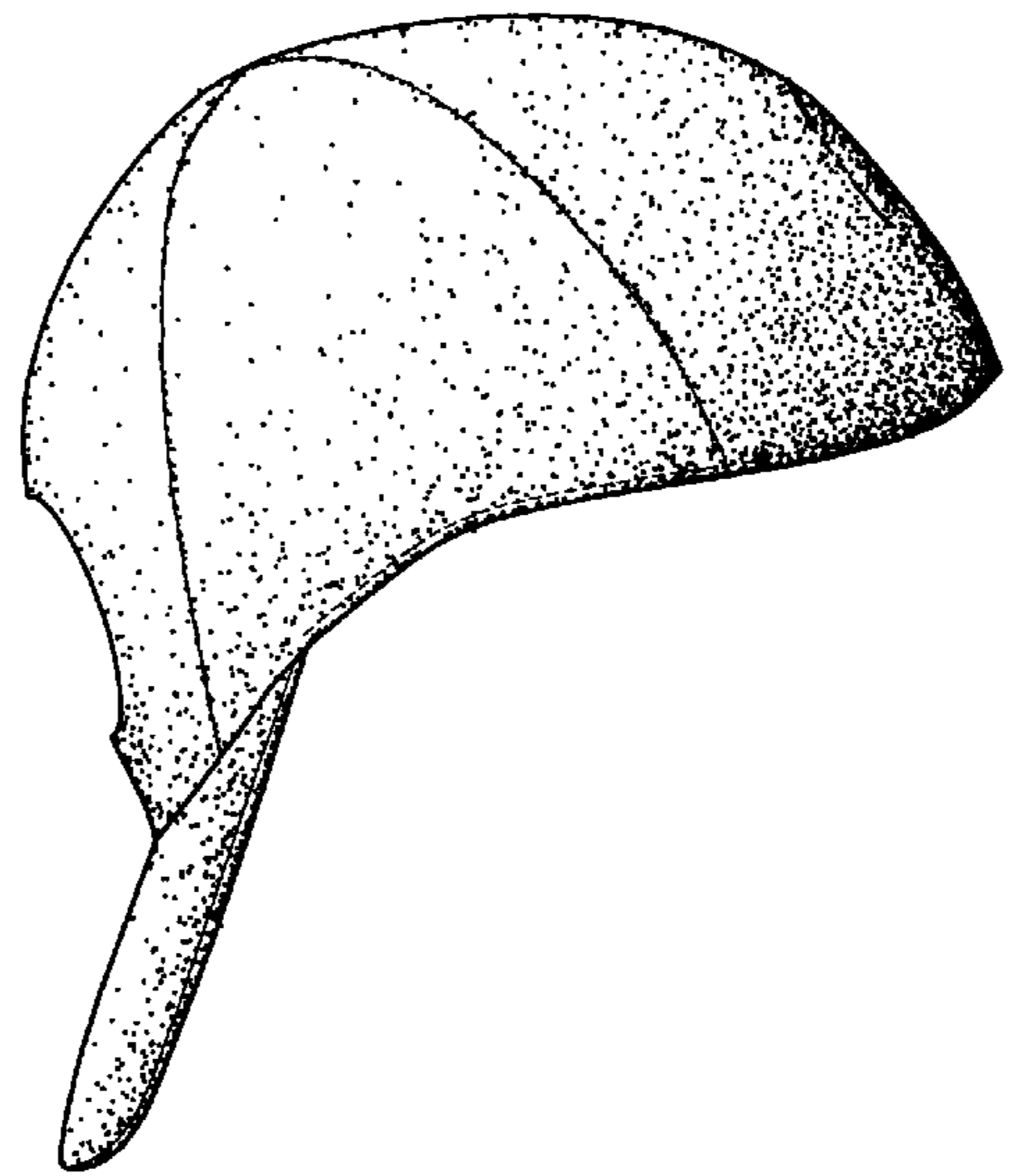

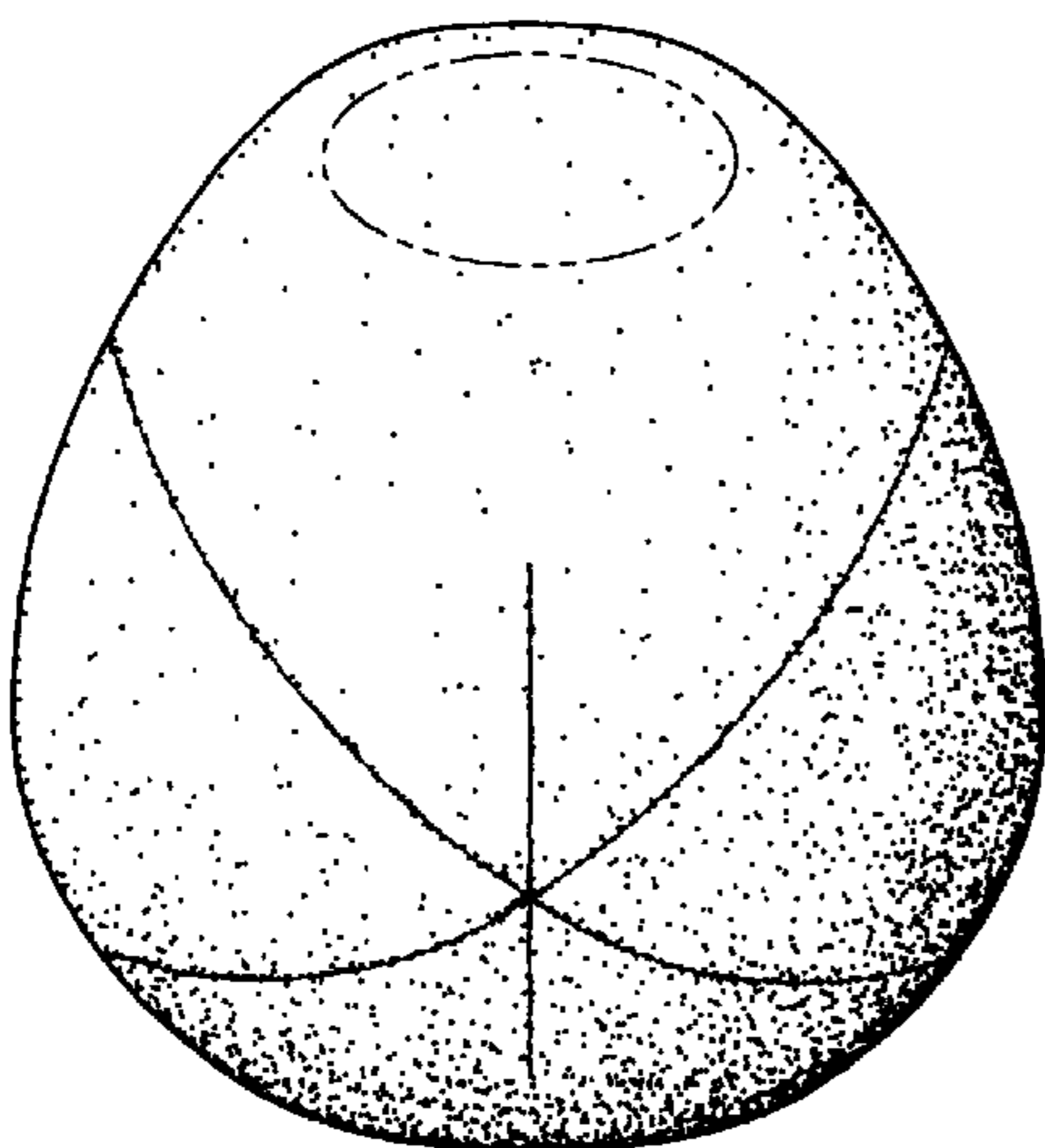

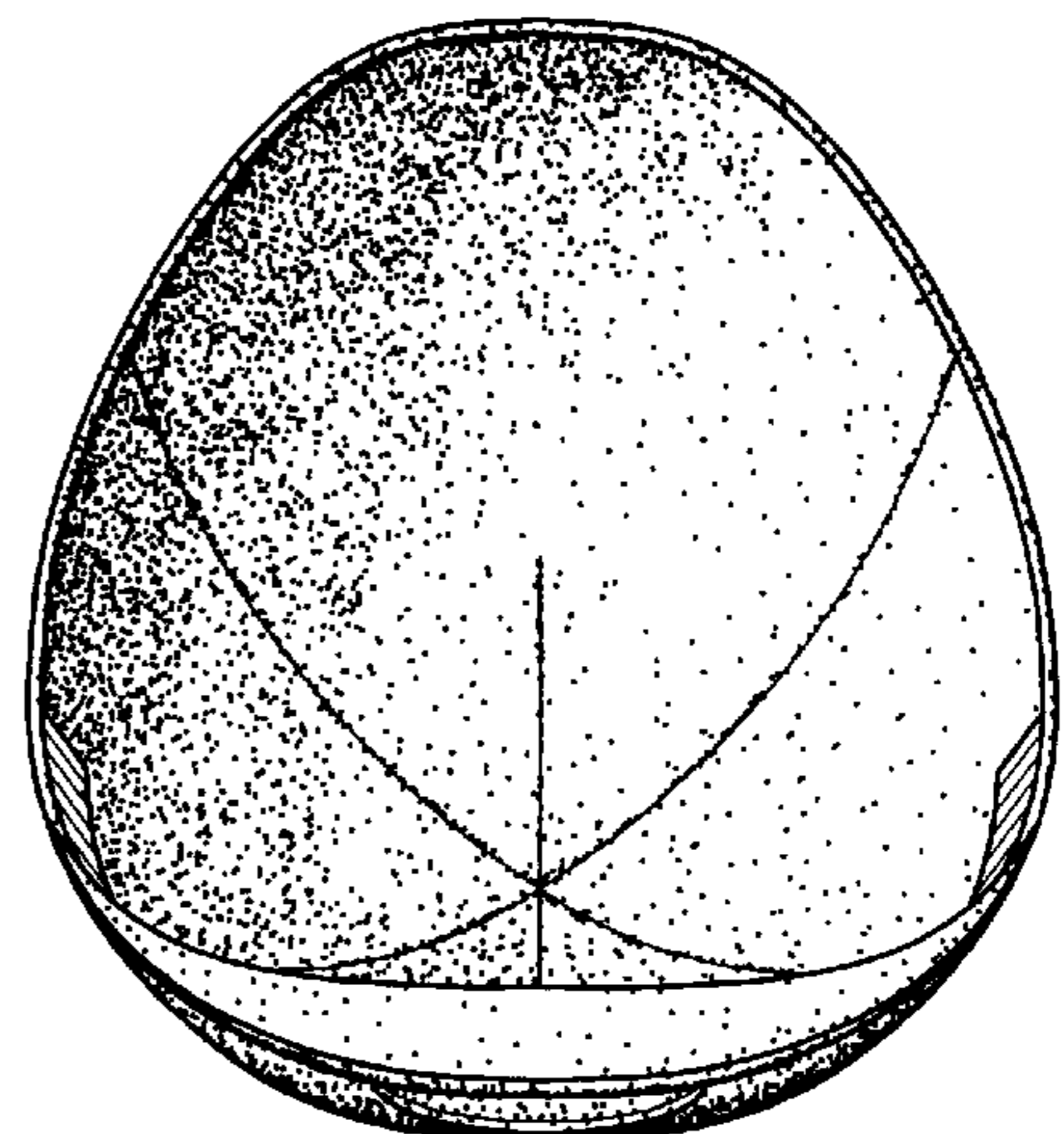
