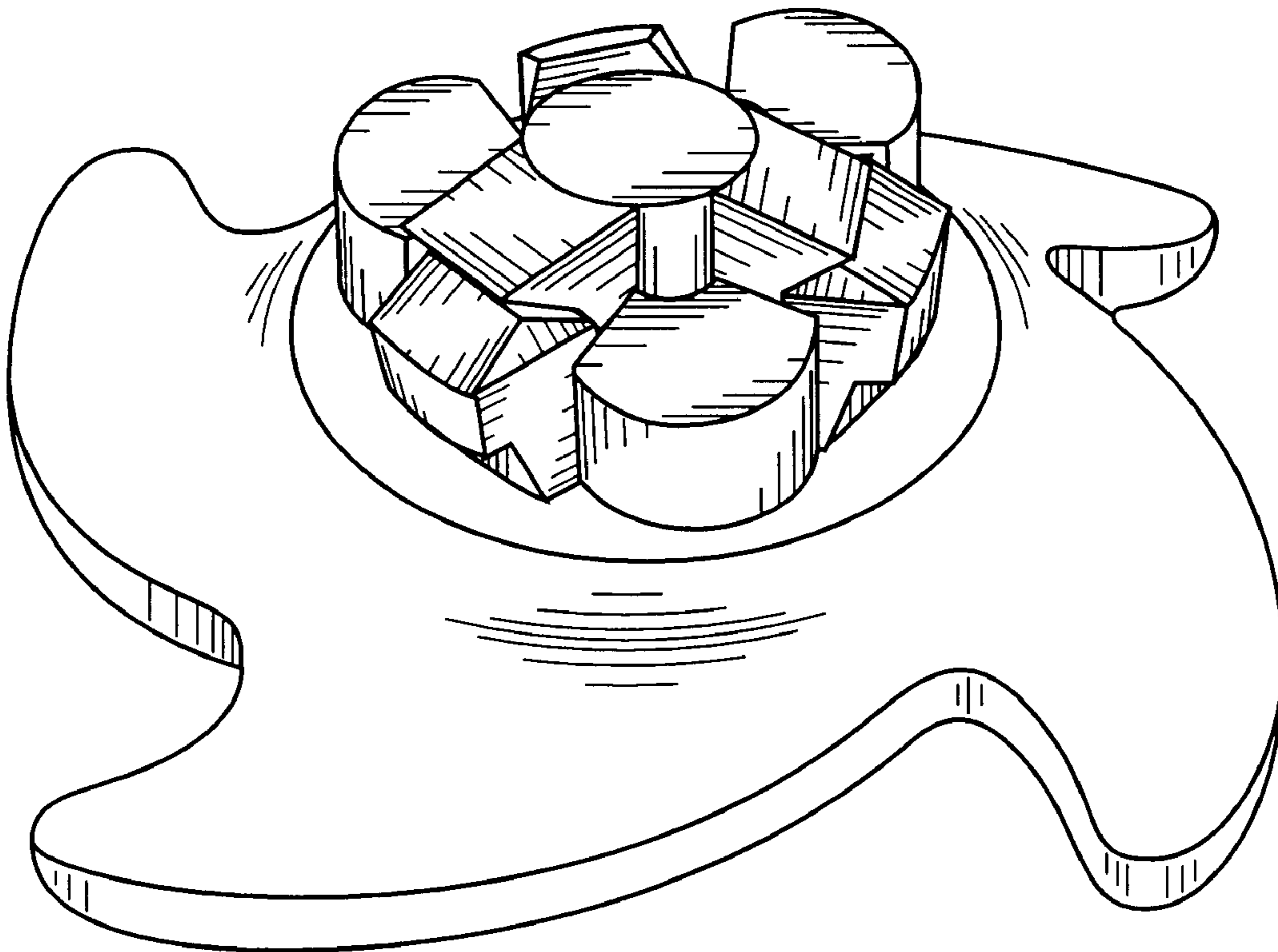
[57] CLAIM

The ornamental design for an athletic shoe vertical insertion independent locking spike, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an athletic shoe vertical insertion independent locking spike showing the new design;

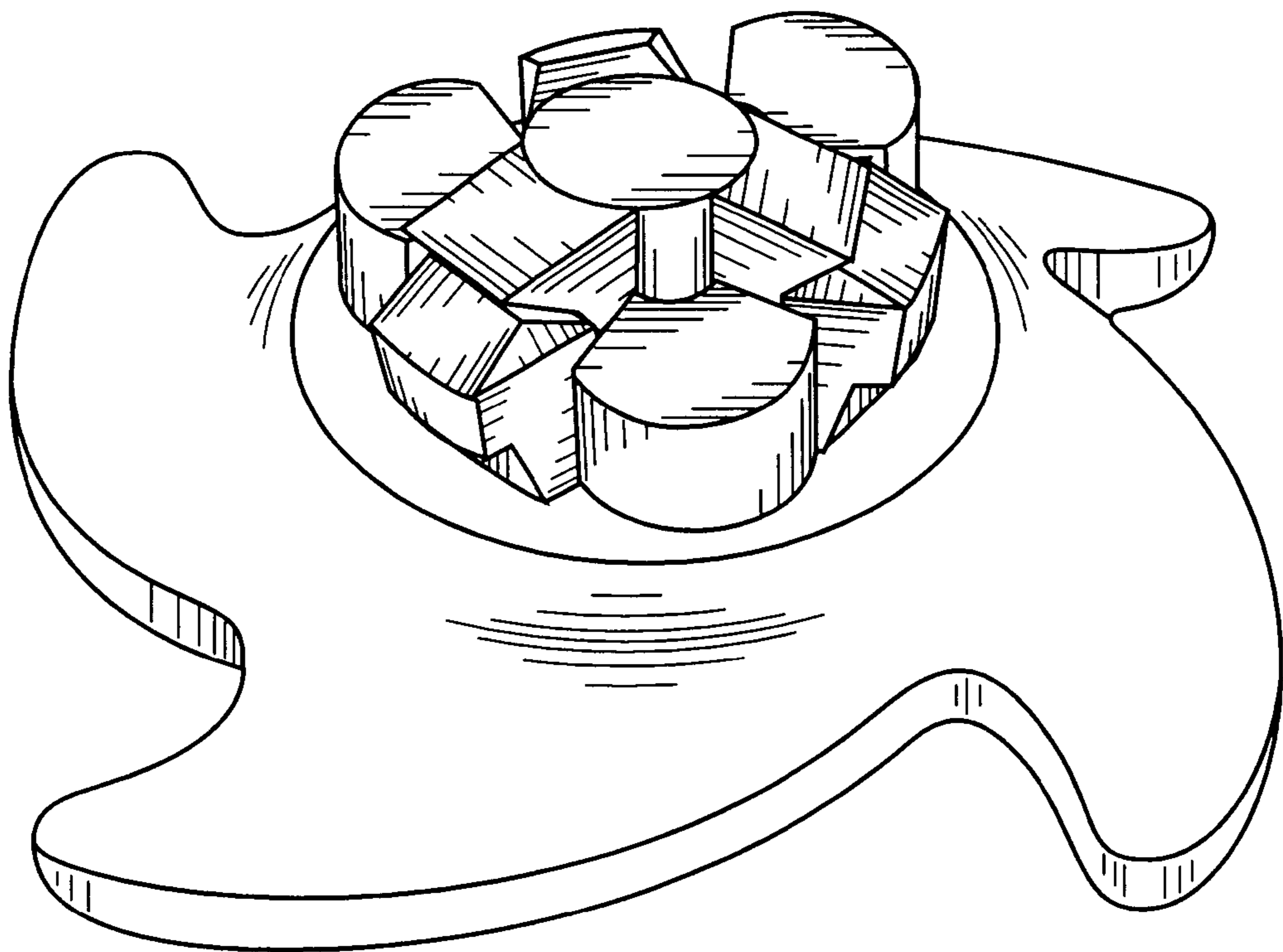

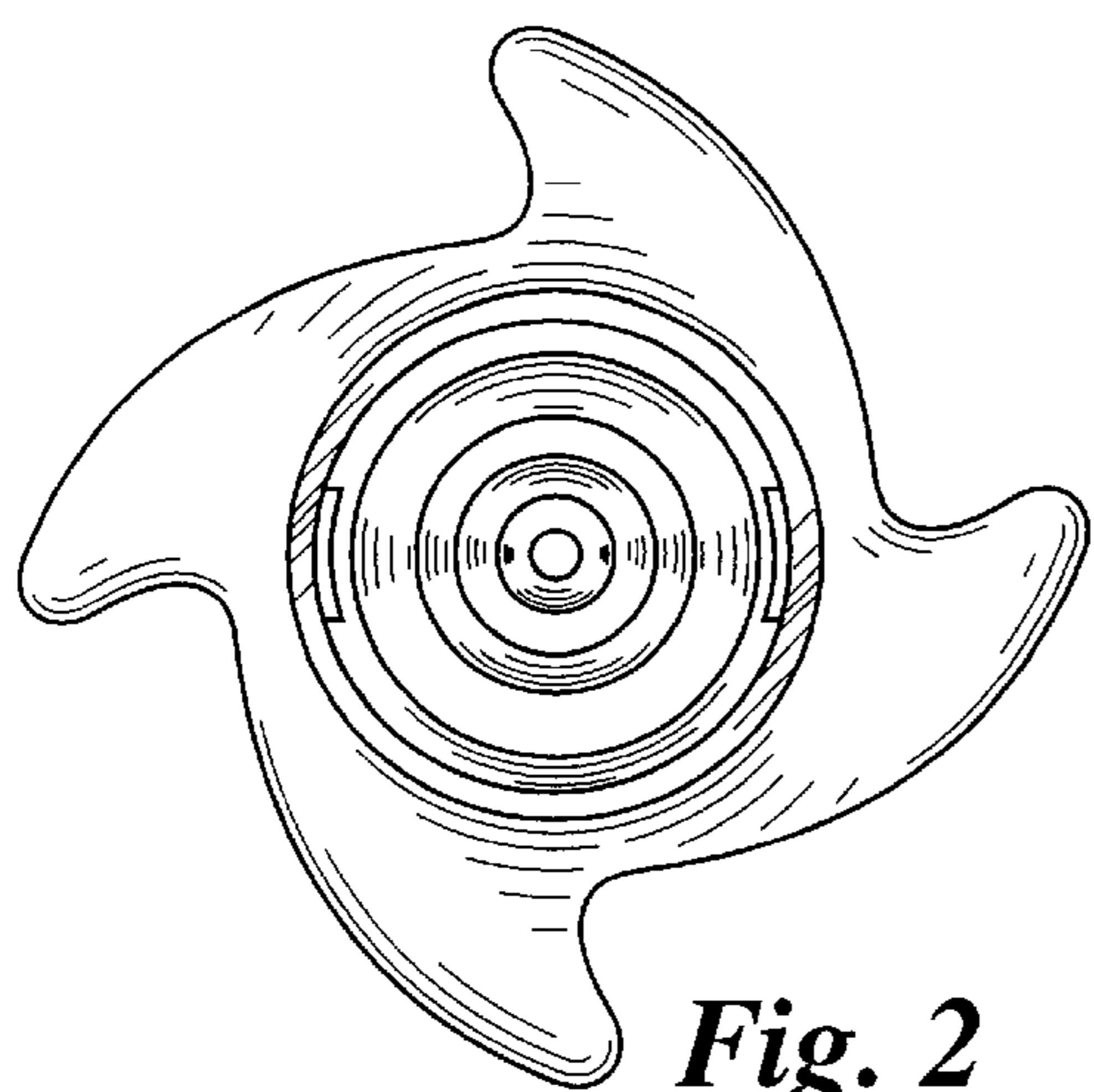

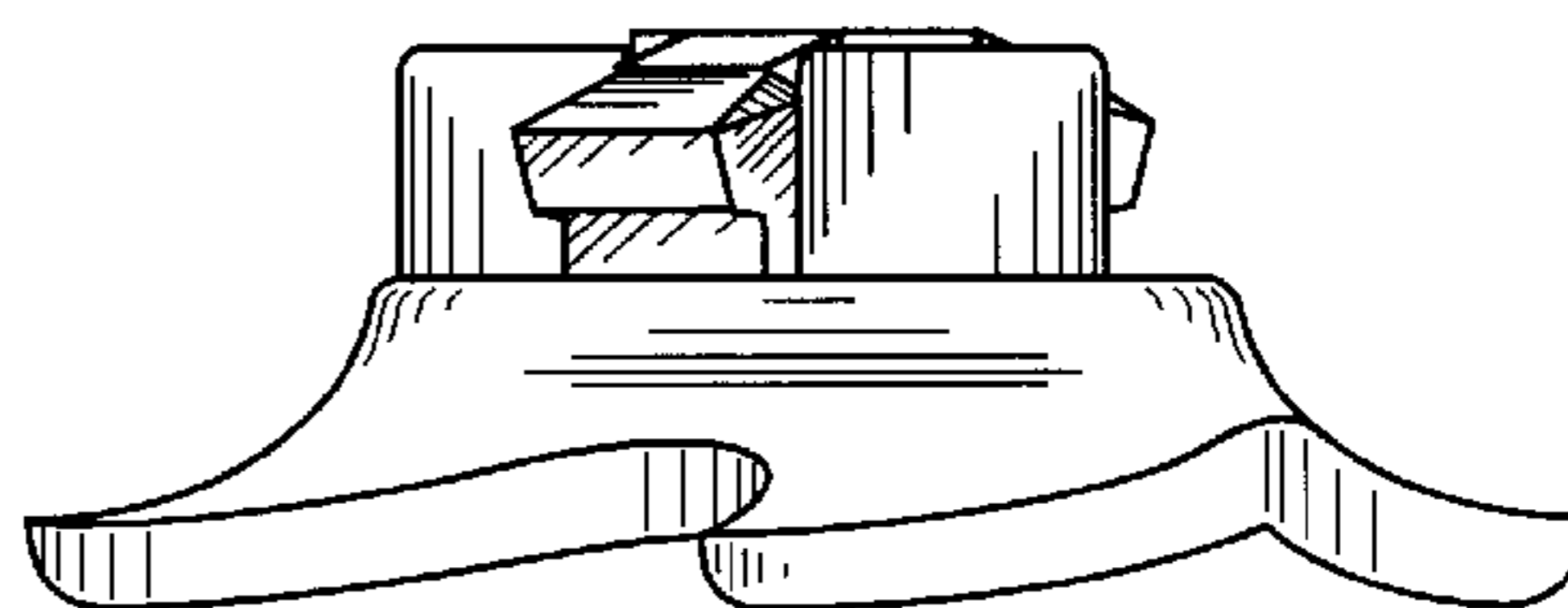

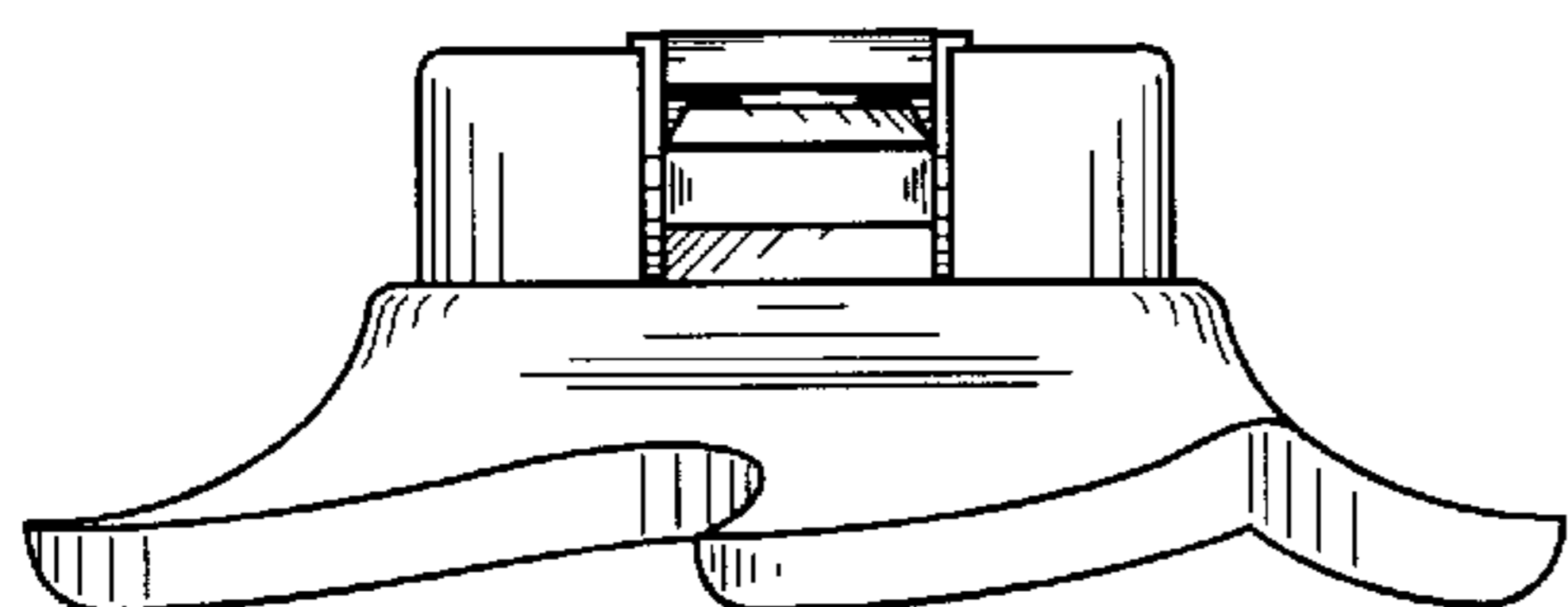

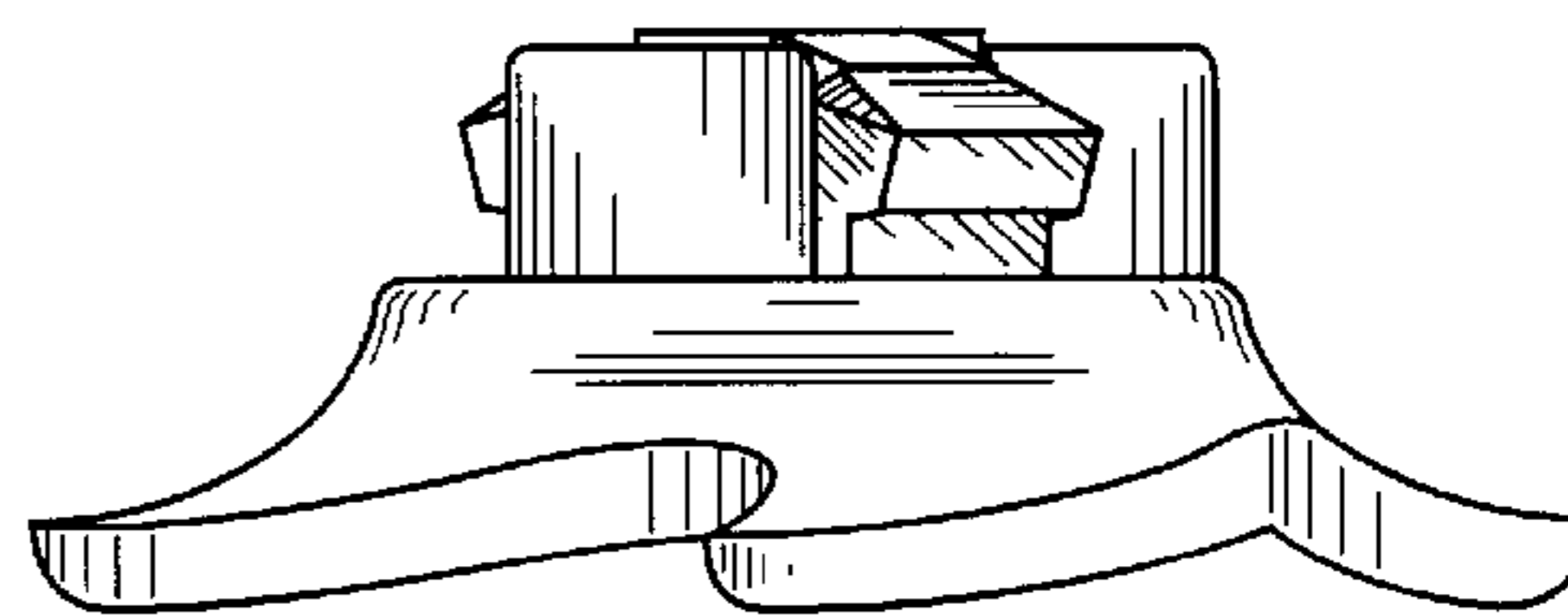

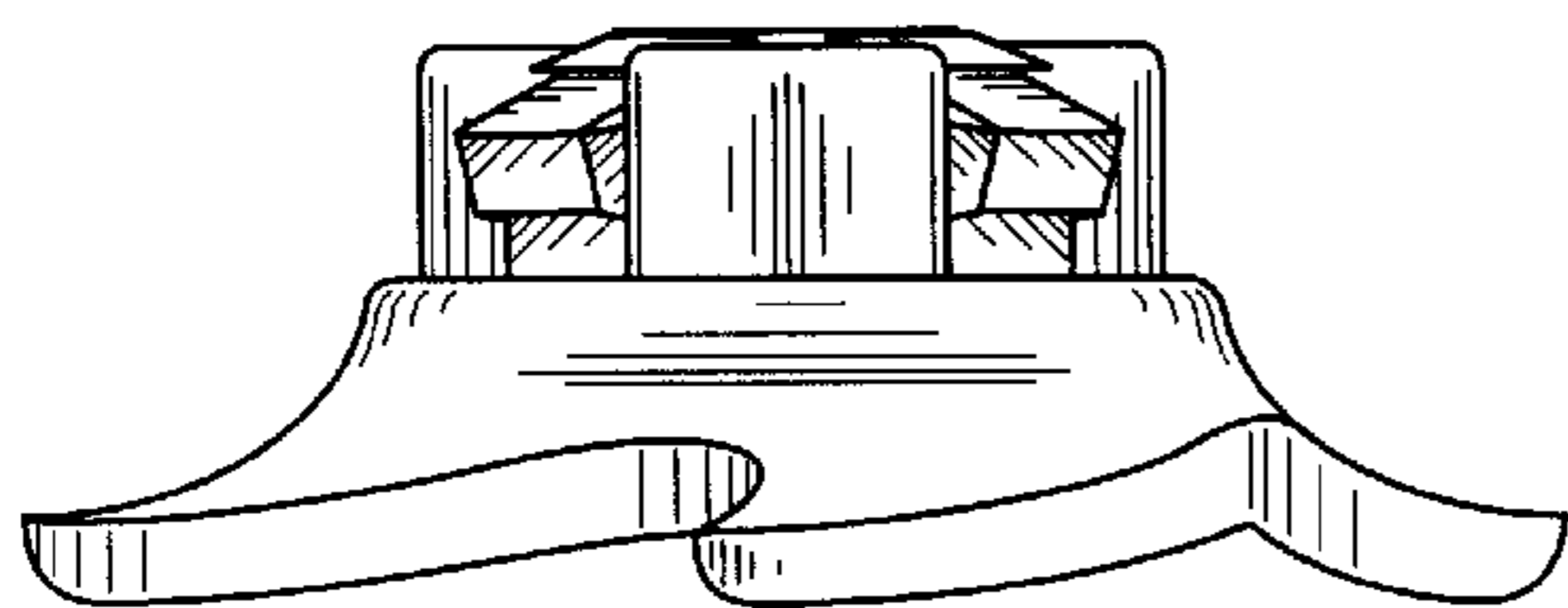

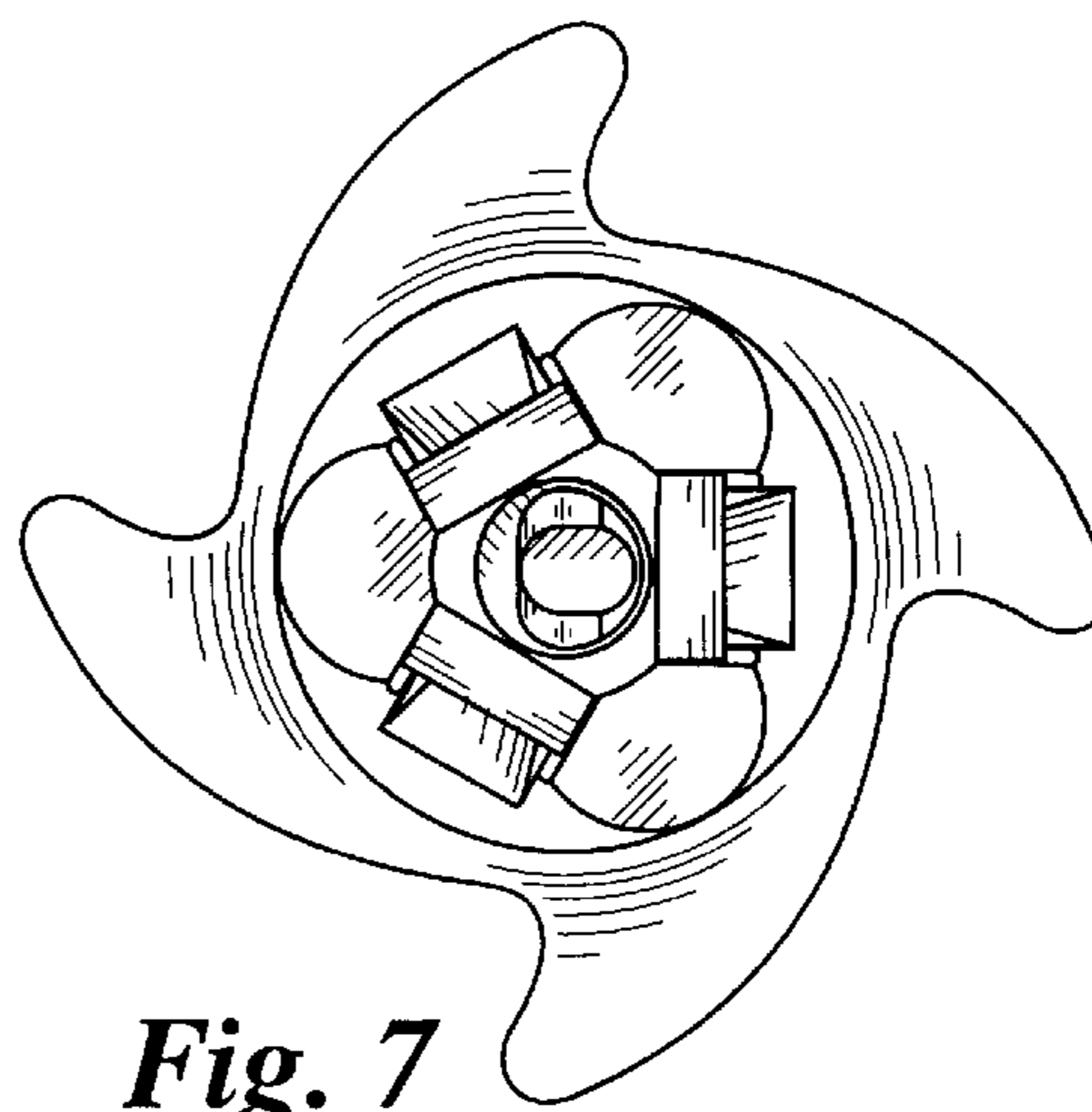
