The ornamental design for a wooden basket, as shown and described.

### DESCRIPTION

FIG. 1 is a front elevation view of the wooden basket showing our new design;  
FIG. 2 is a rear elevation view thereof;  
FIG. 3 is a right side elevation view thereof;  
FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a top view thereof;  
FIG. 6 is a bottom view thereof; and,

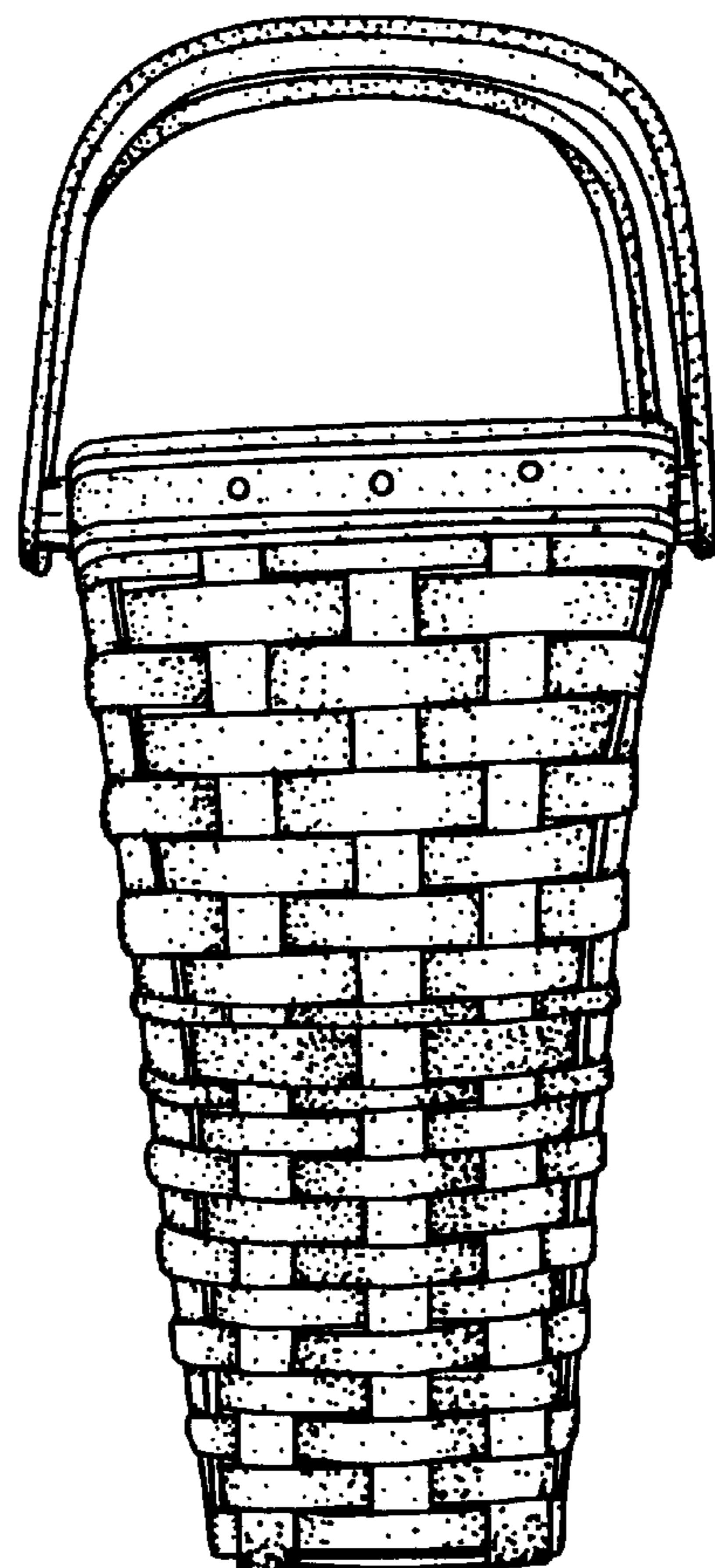
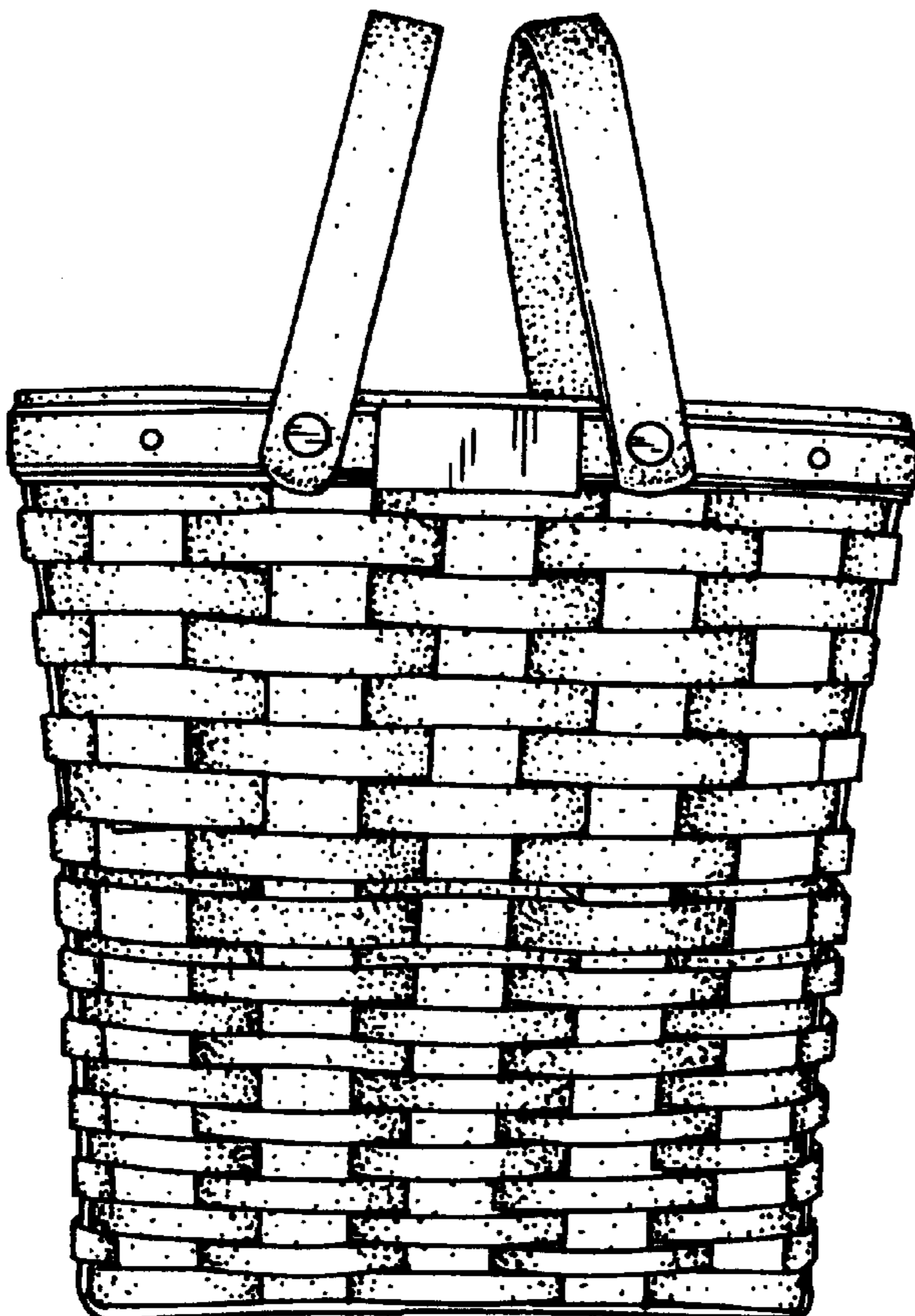

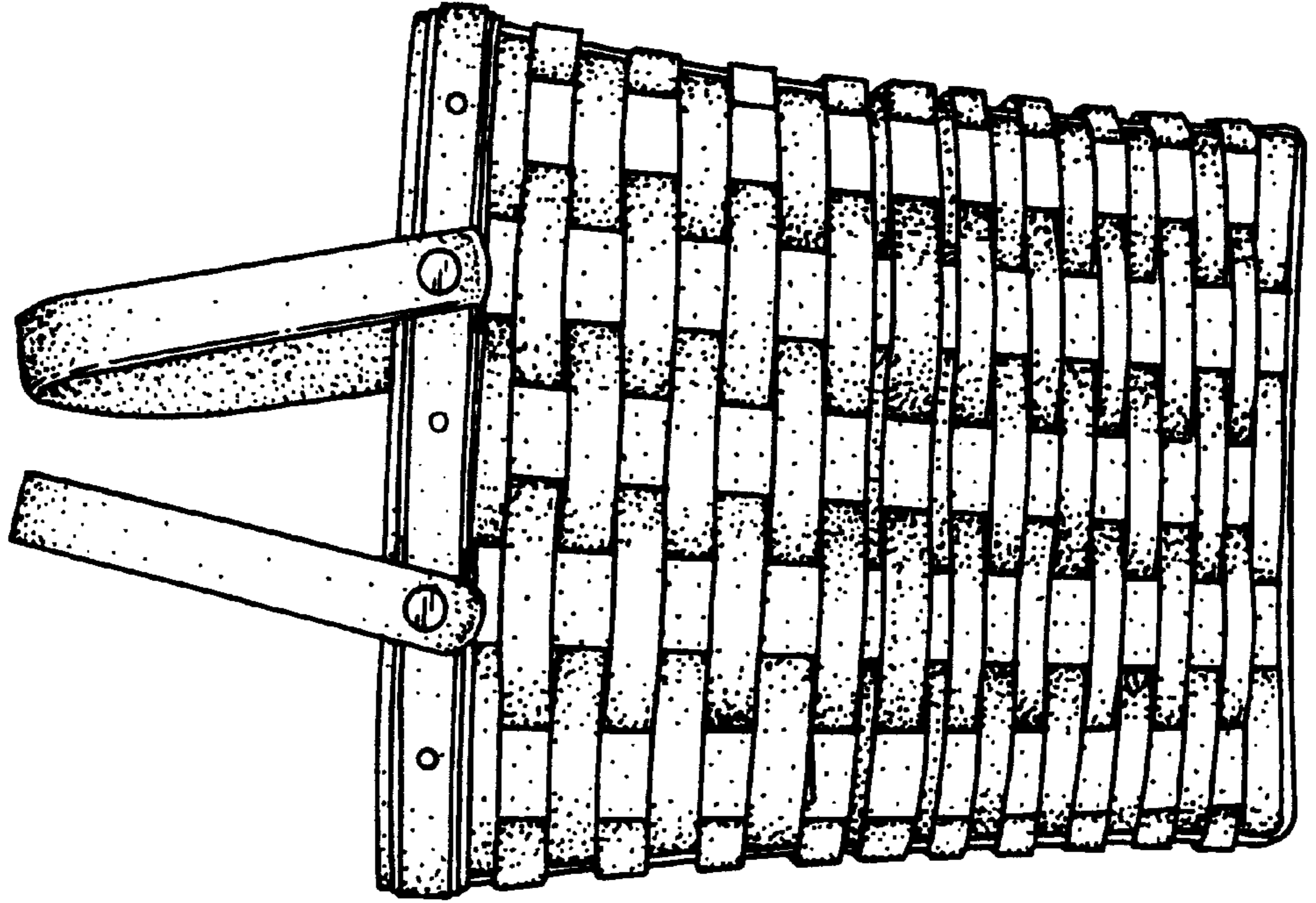

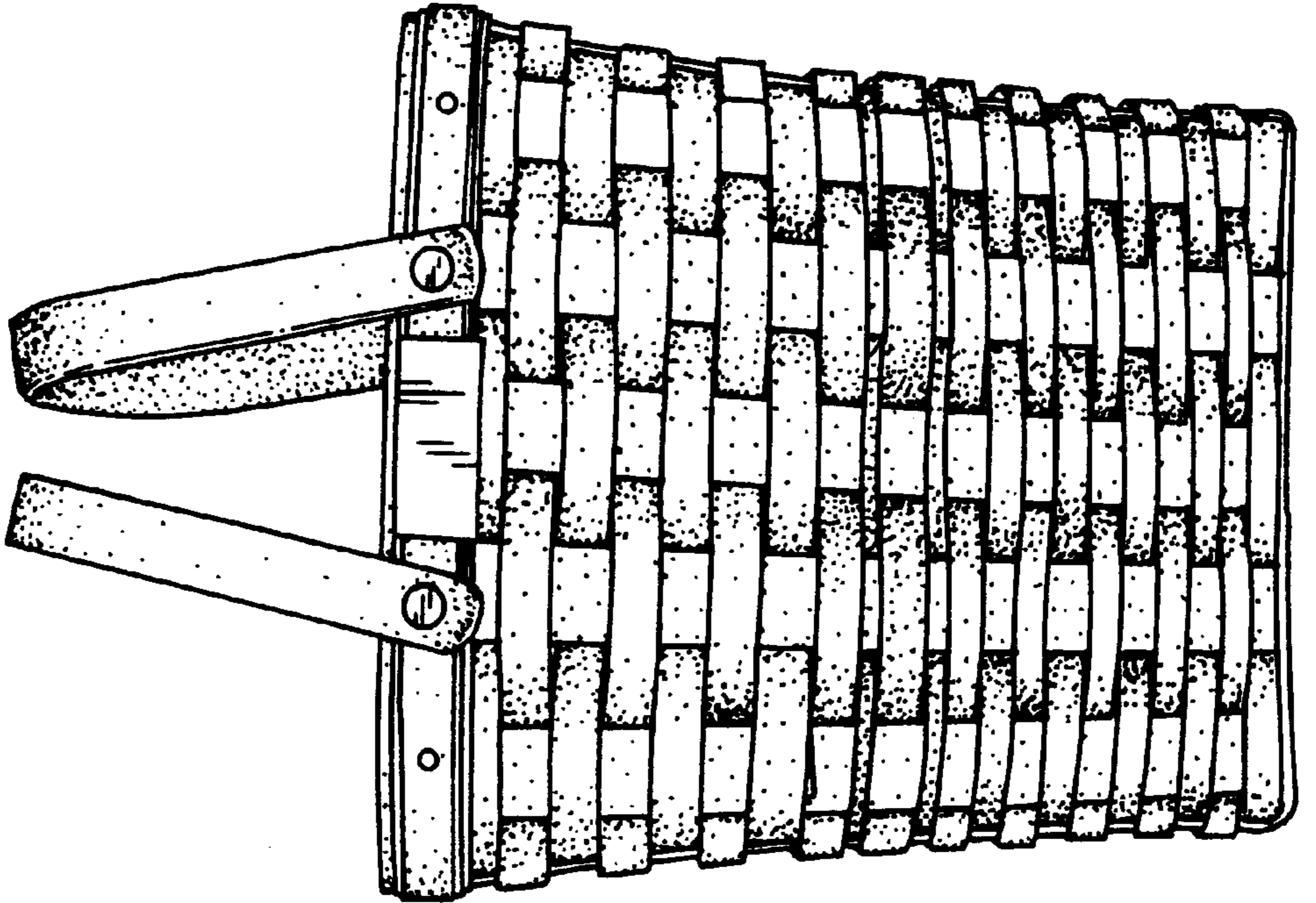

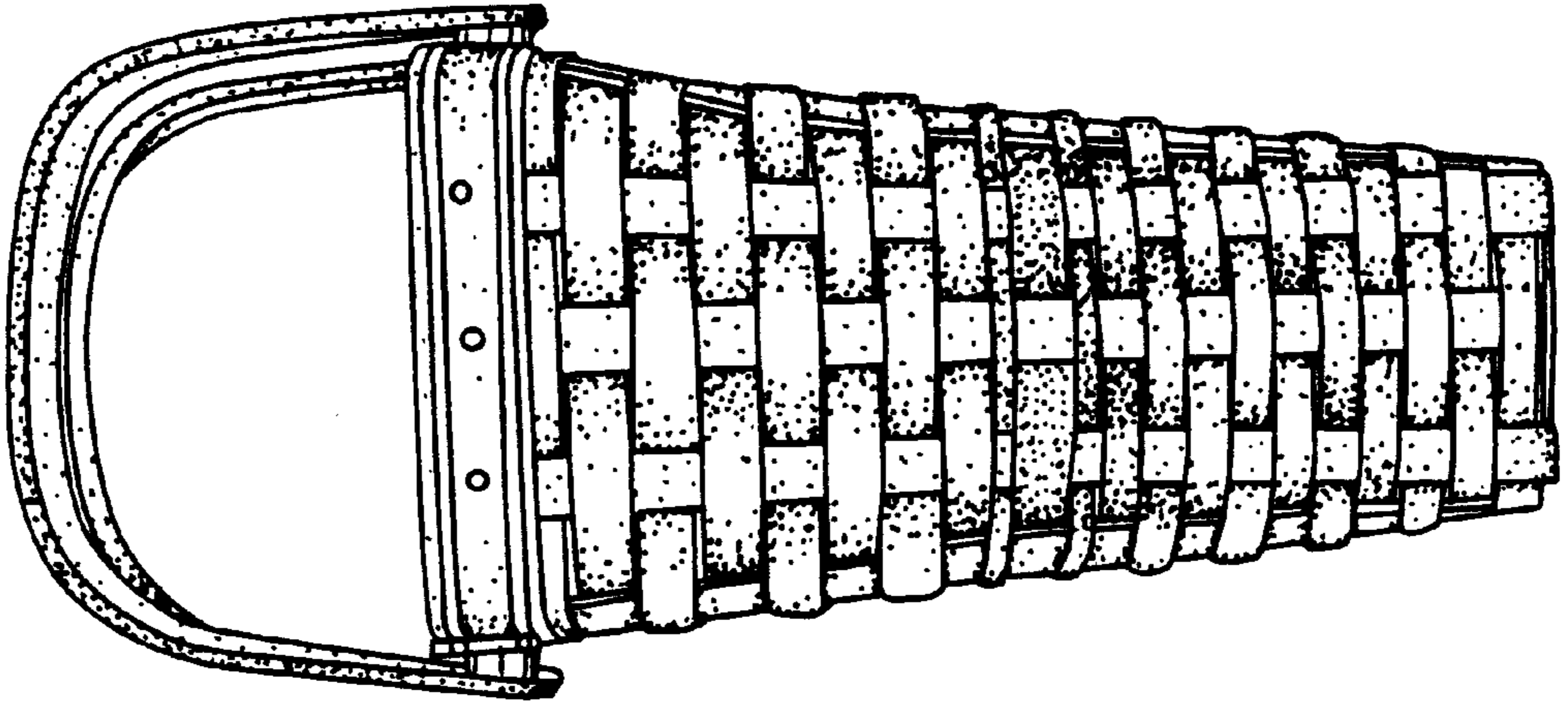

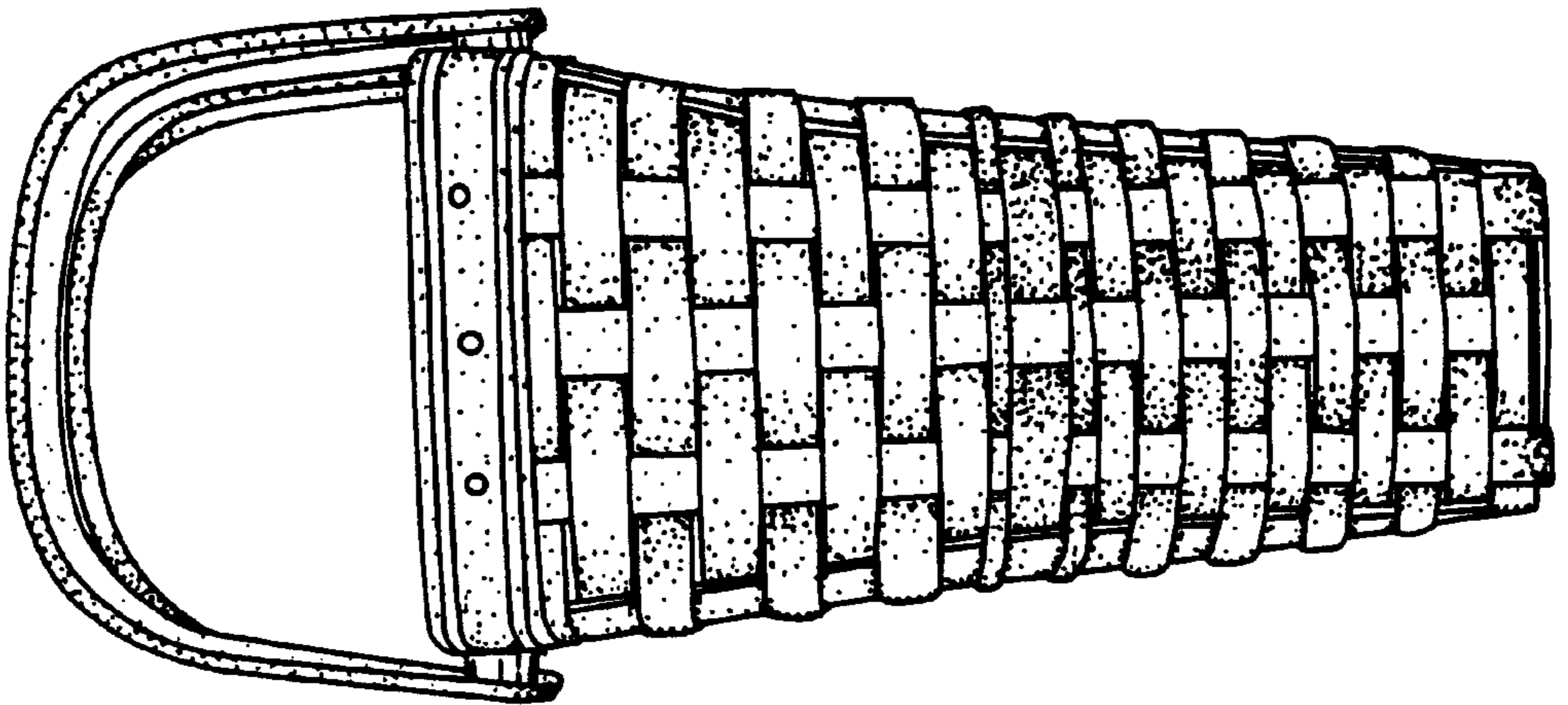

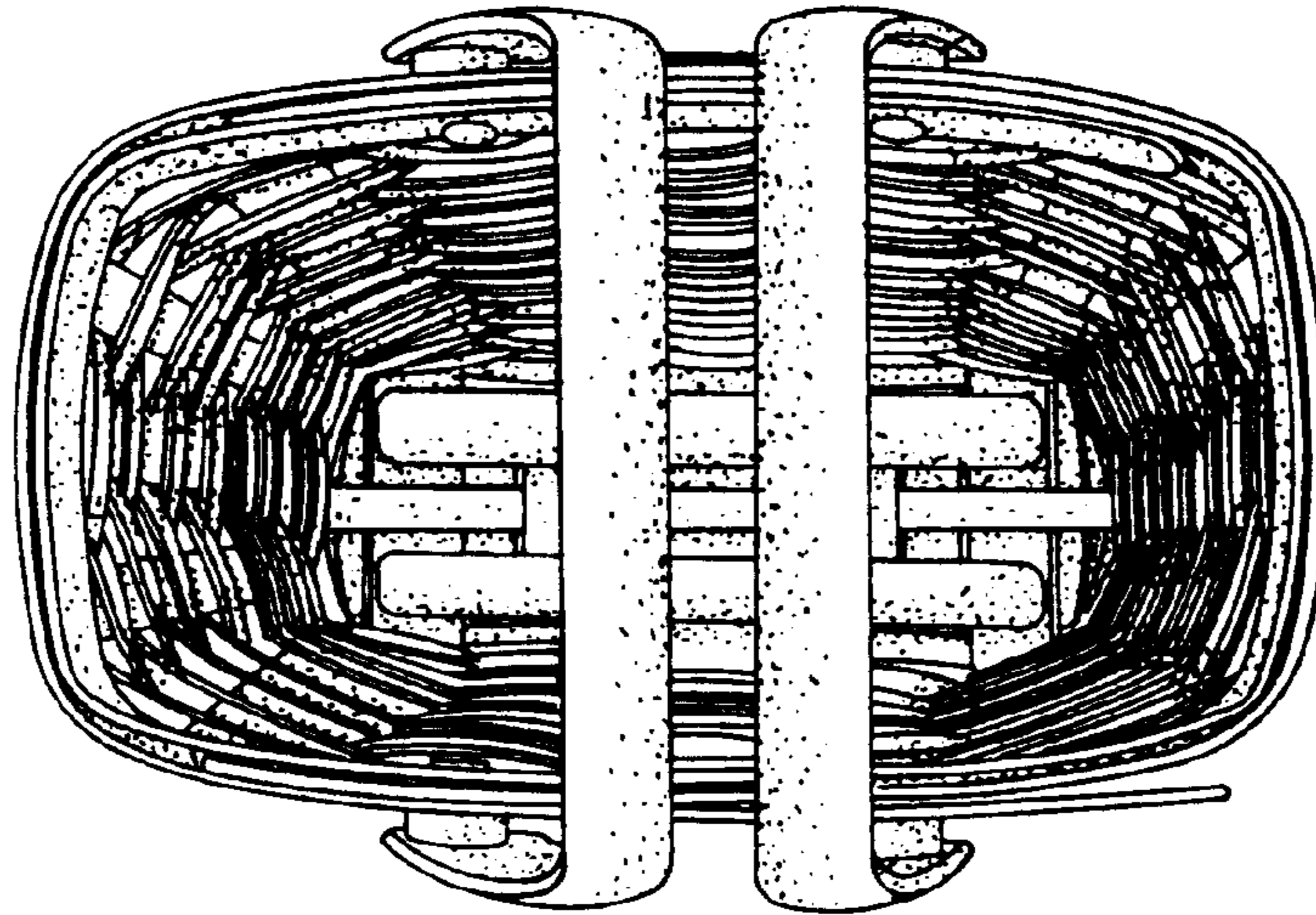
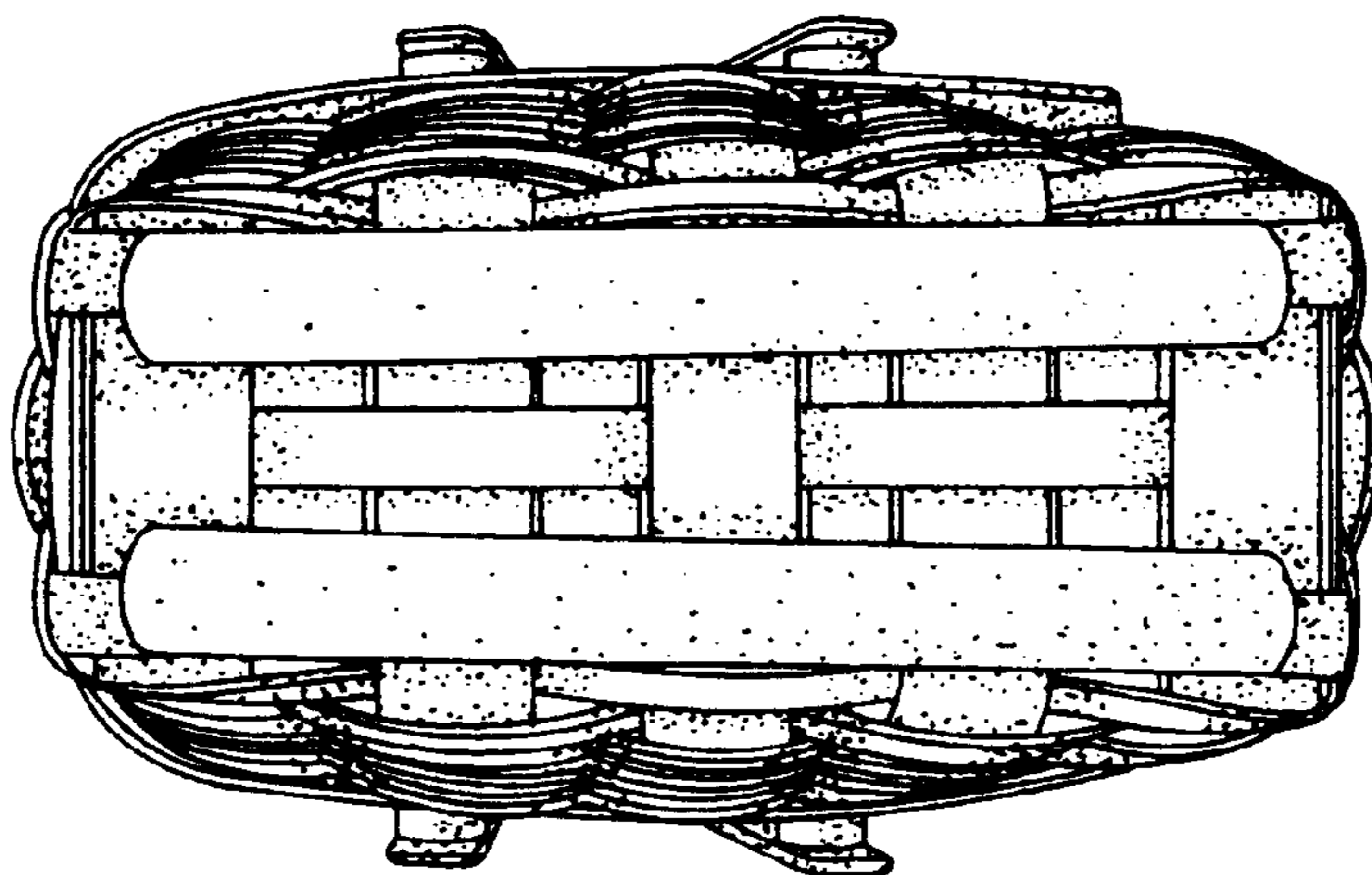

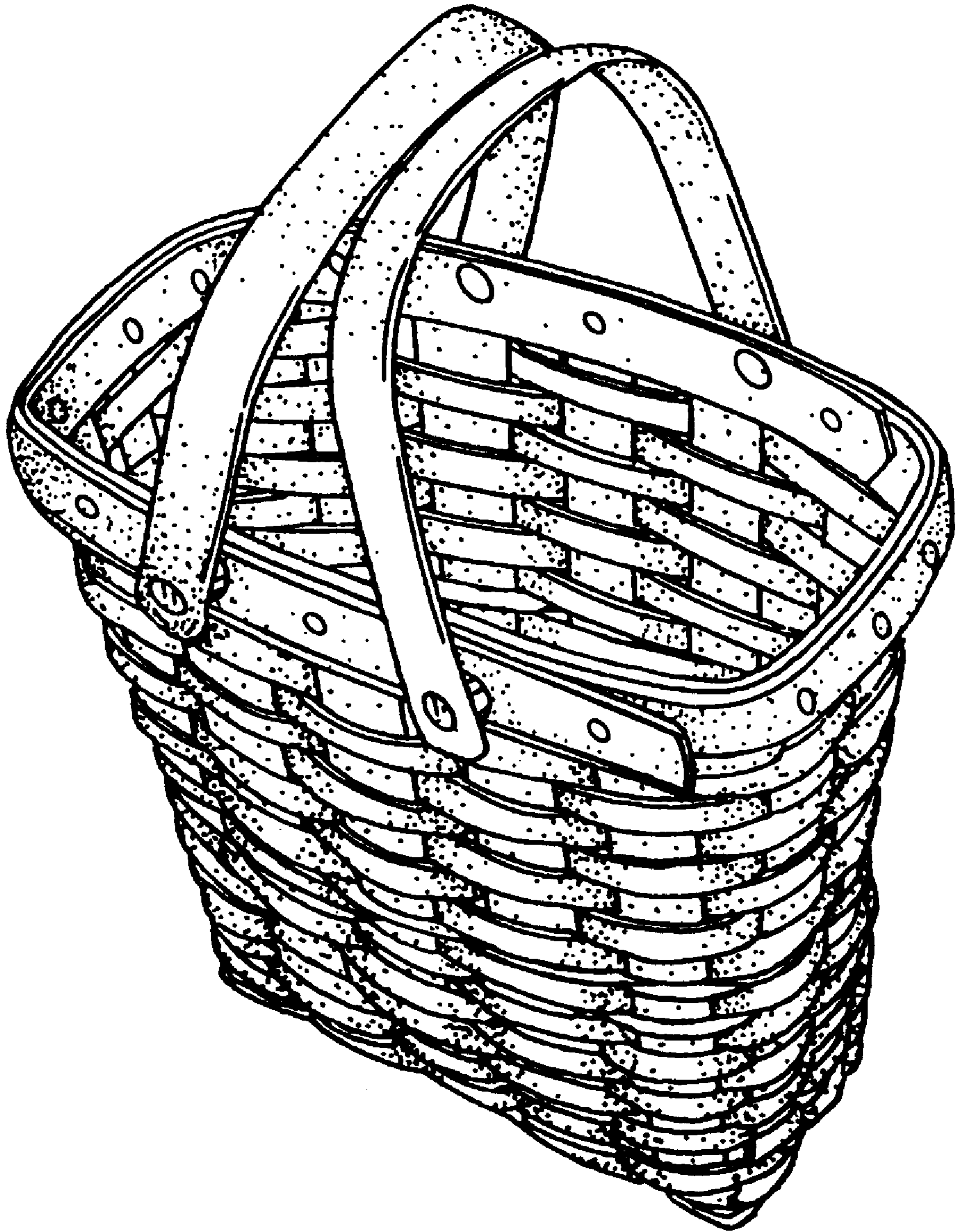
