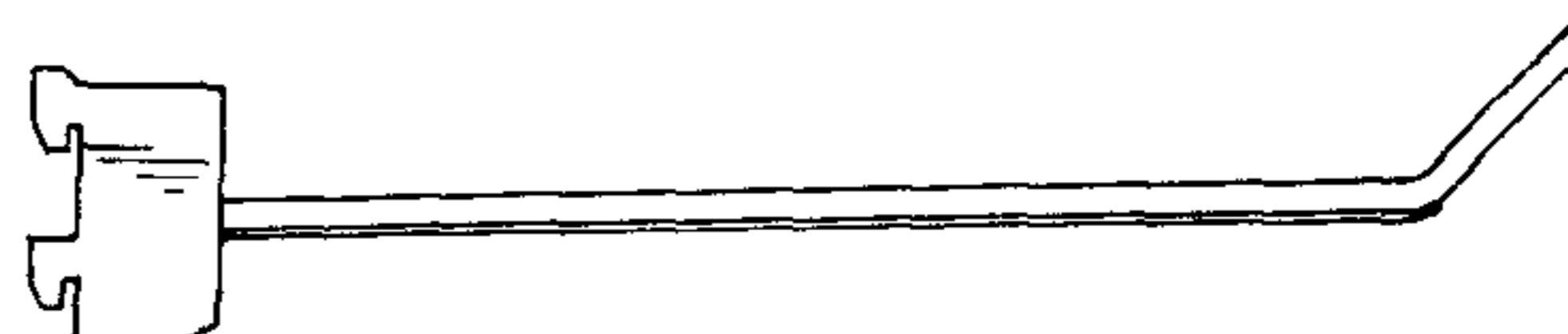
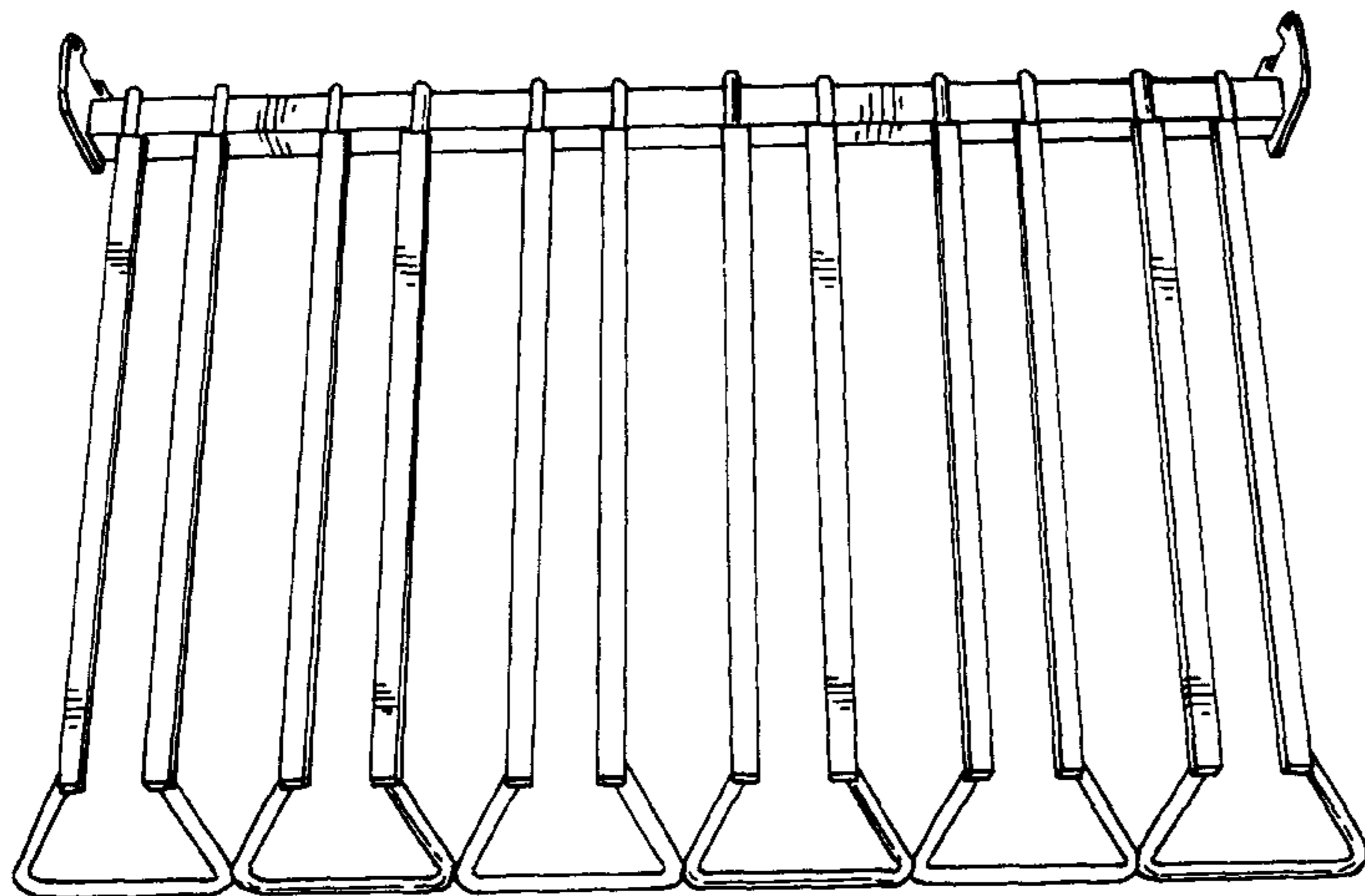
[57] **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective bottom view of a shelf for a  
mechandising rack showing my new design;

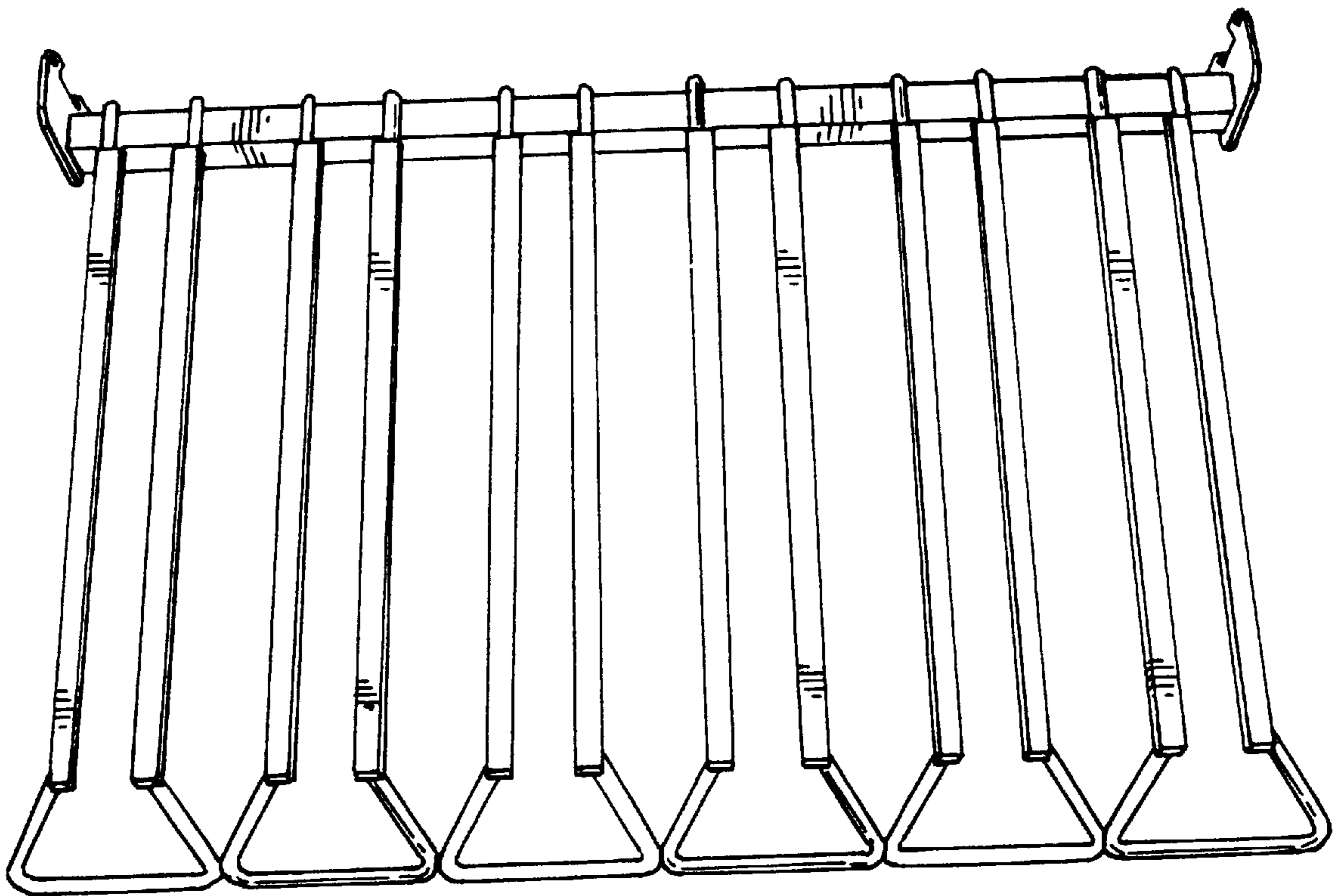

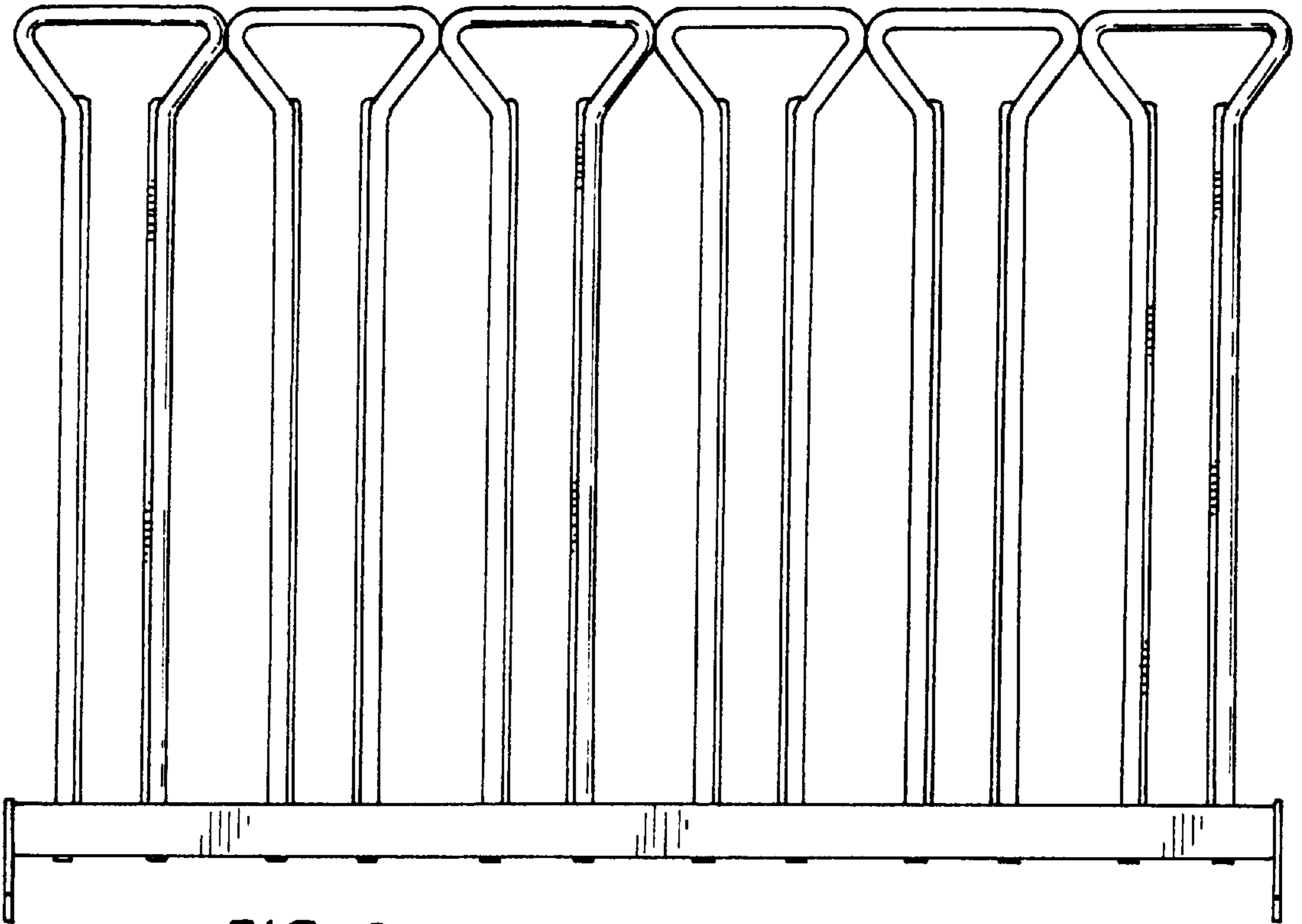
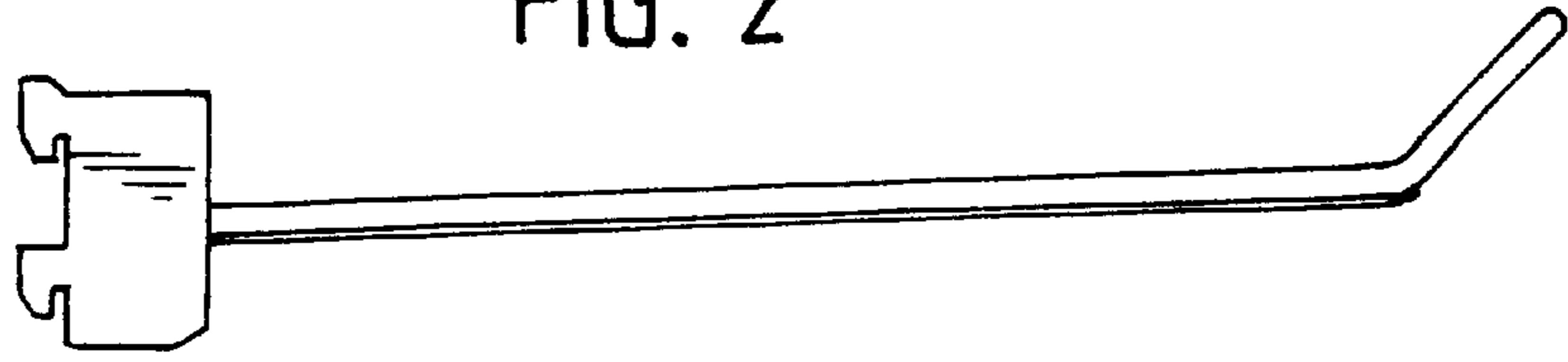

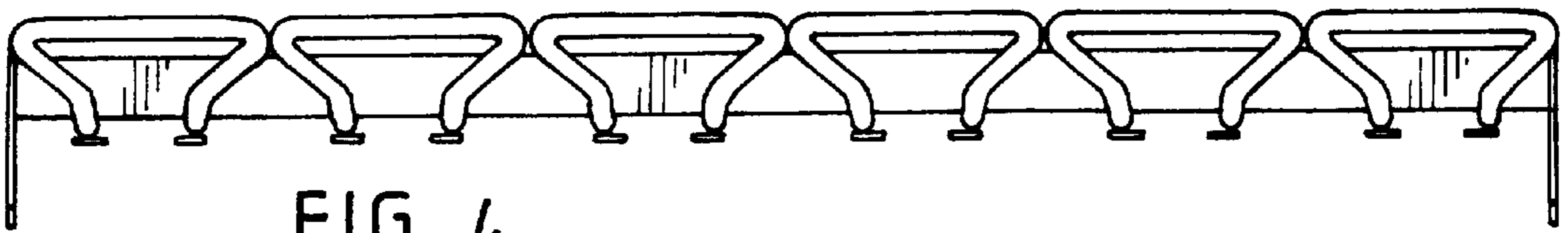

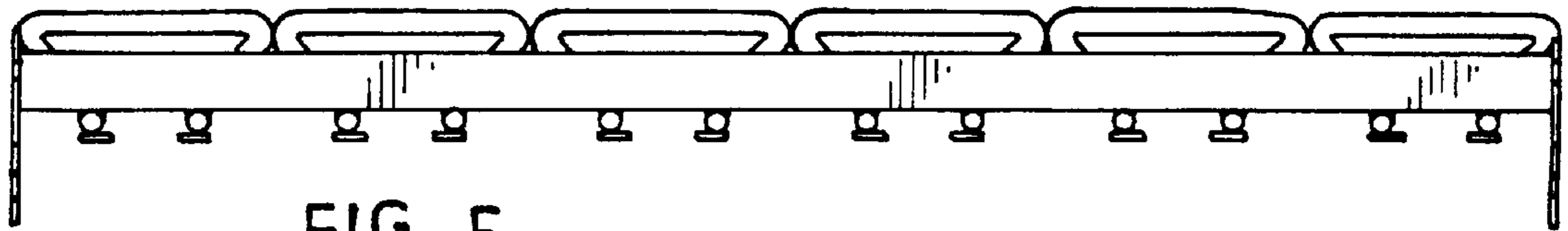
