[57] **CLAIM**

The ornamental design for a brush holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a toothbrush holder embodying our invention.  
FIG. 2 is a right-end elevational view.  
FIG. 3 is a left-end elevational view.  
FIG. 4 is a side-elevational view looking from the left-side of FIG. 2, the side opposite being the mirror image of FIG. 4.  
FIG. 5 is a top-plan view; and,  
FIG. 6 is a bottom-plan view.
