The ornamental design for a cover for cooking vessel, as shown and described.

DESCRIPTION

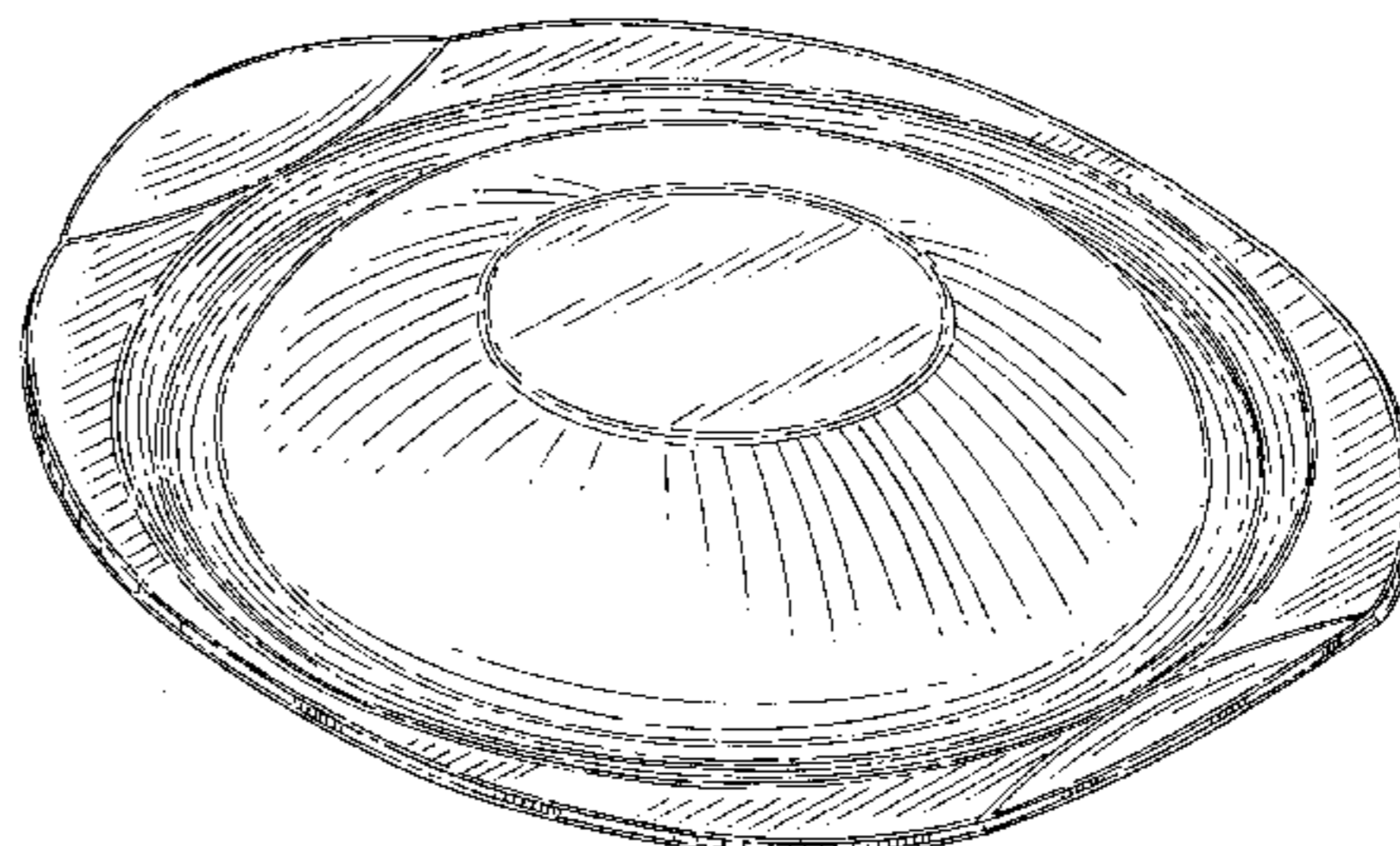
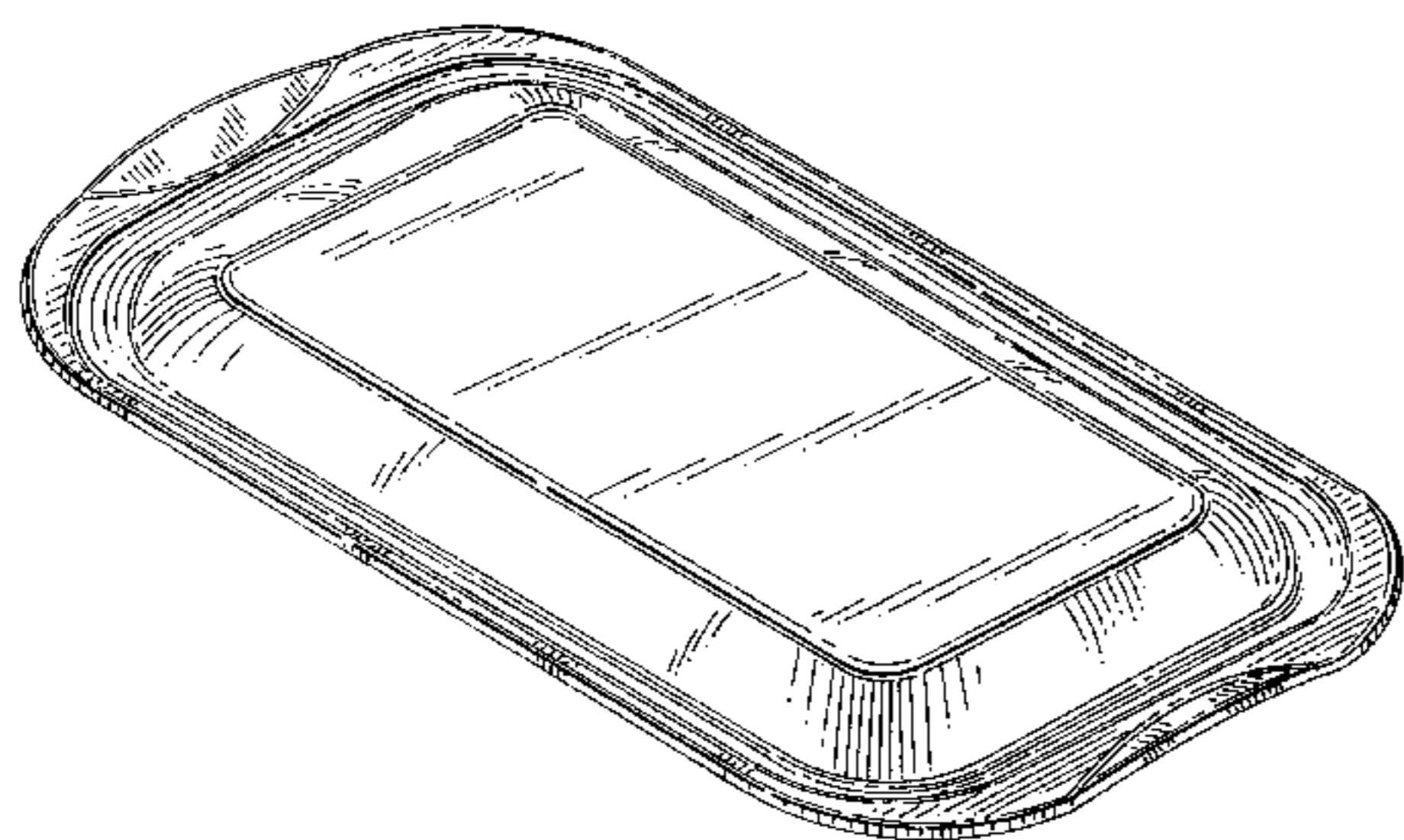
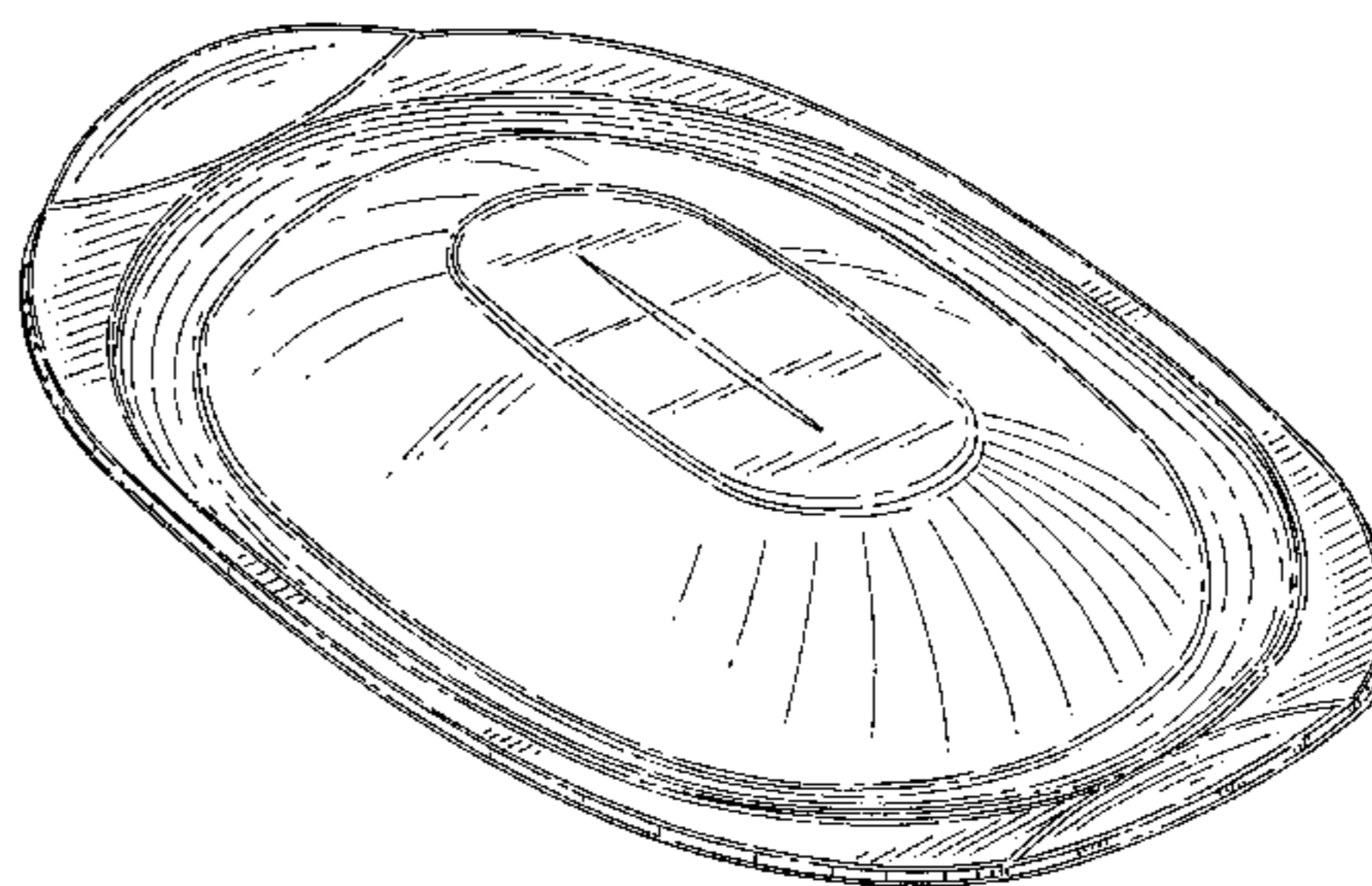
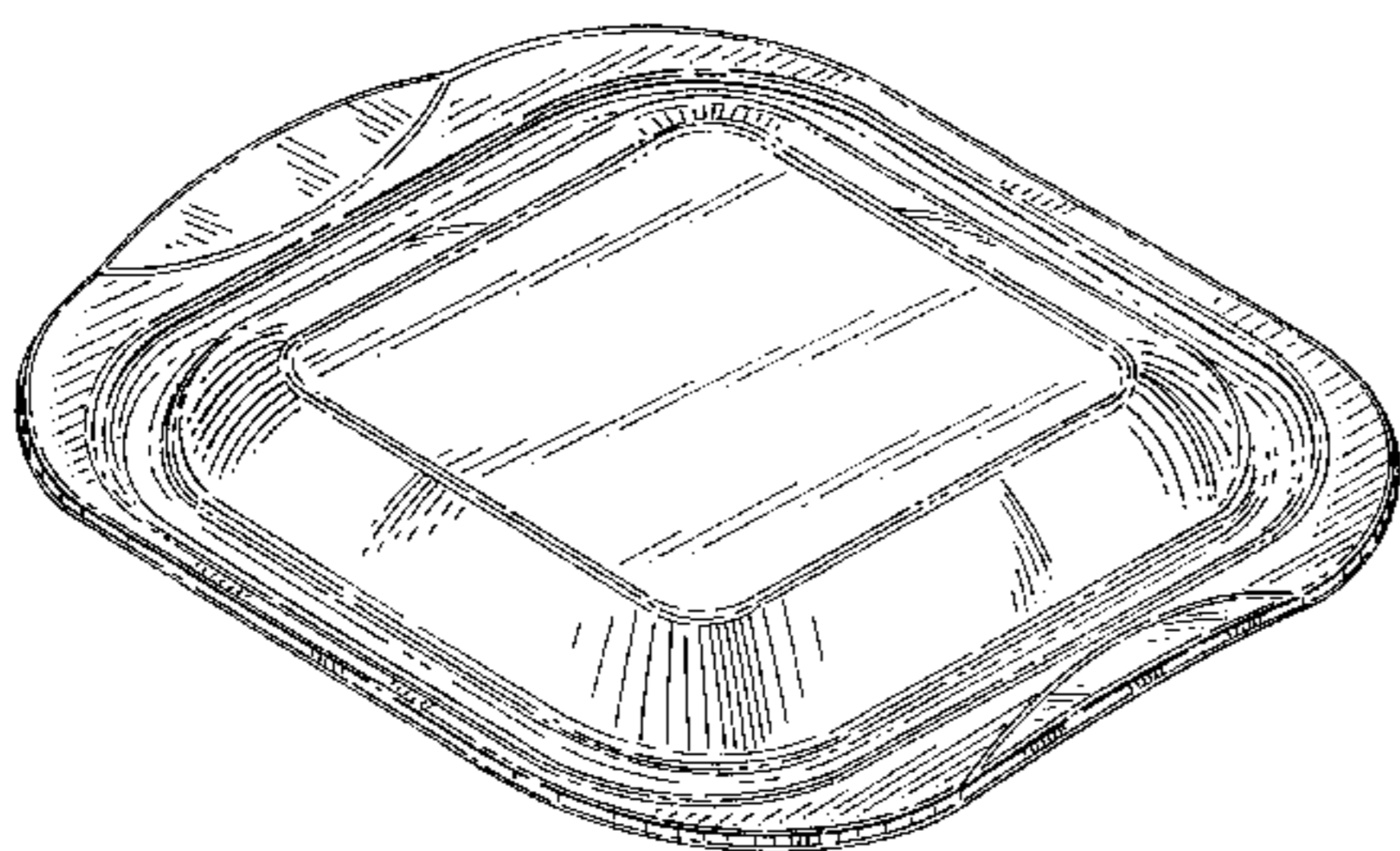

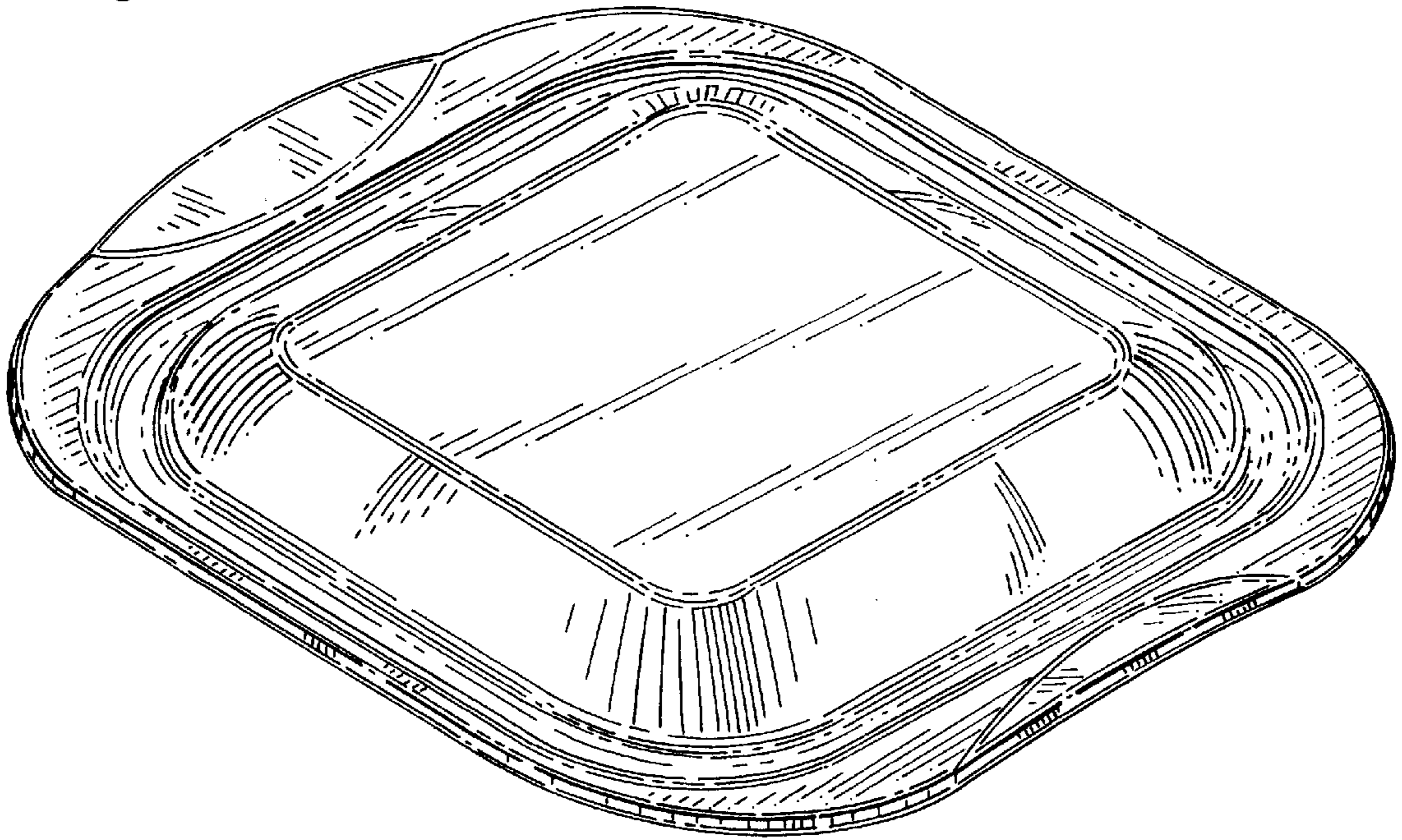

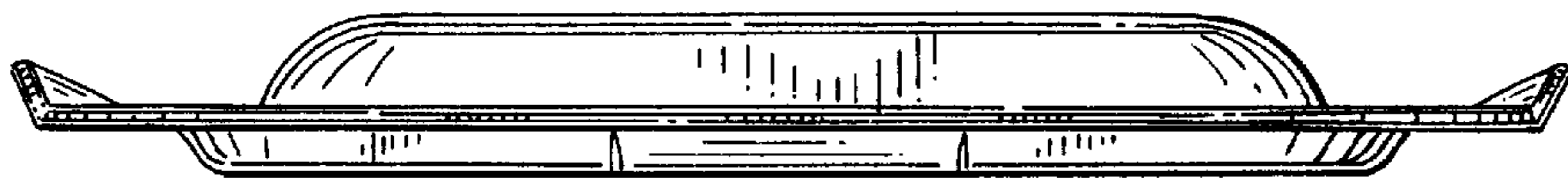

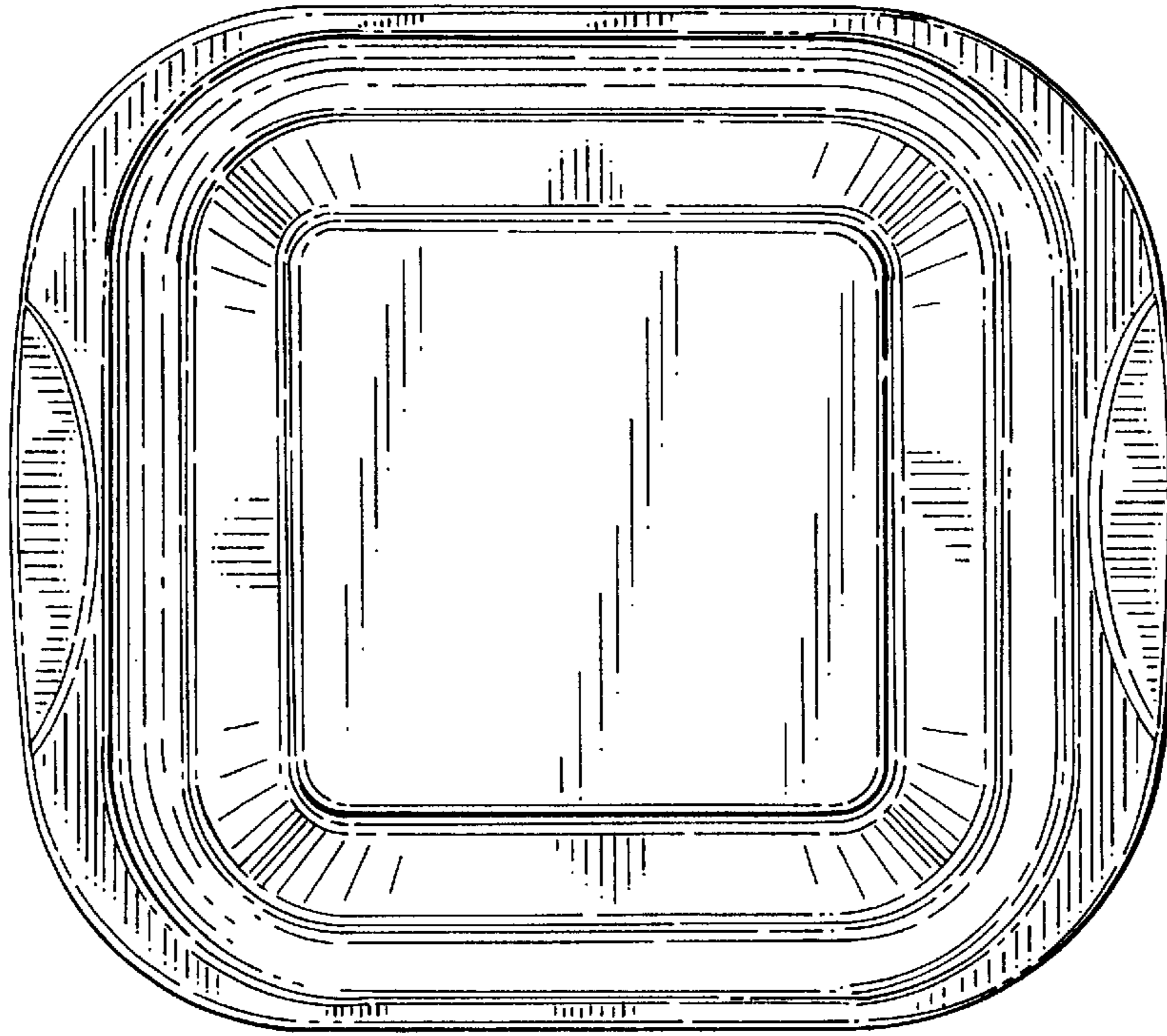
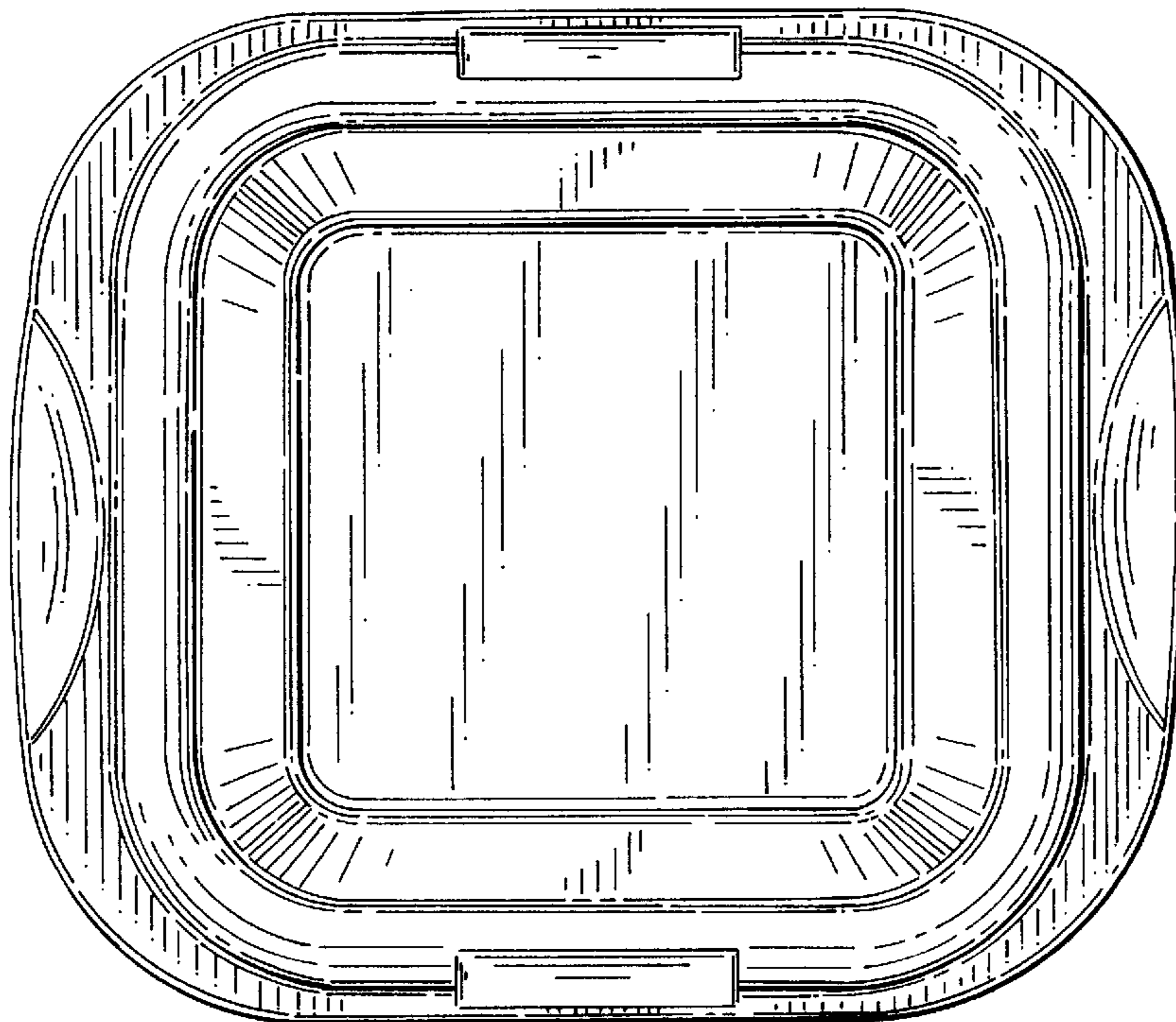

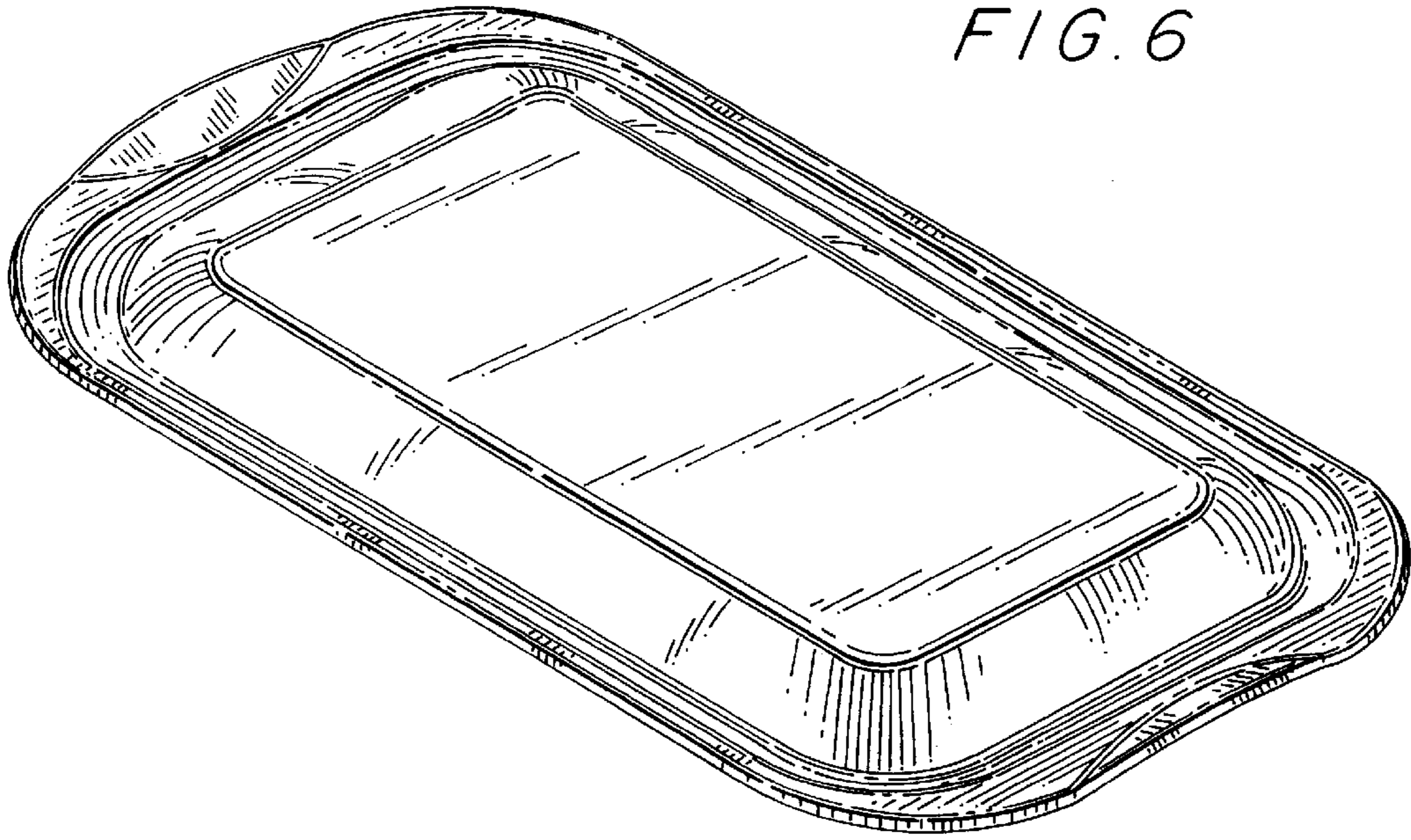

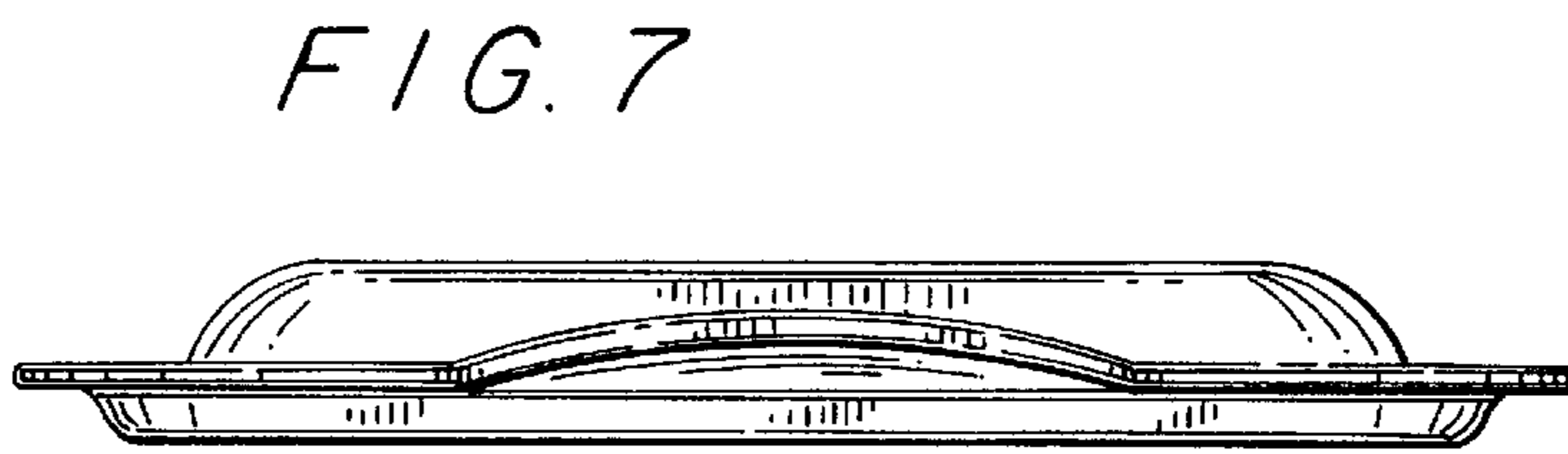

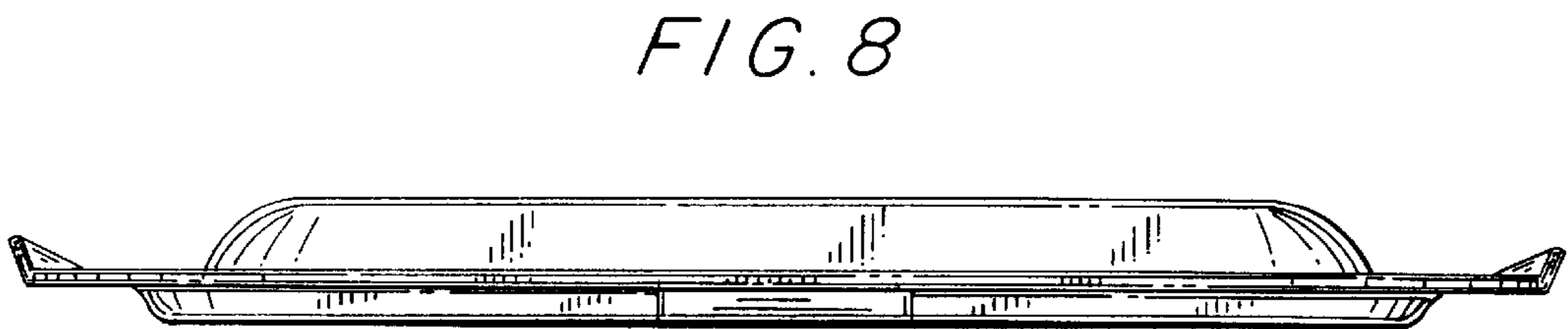

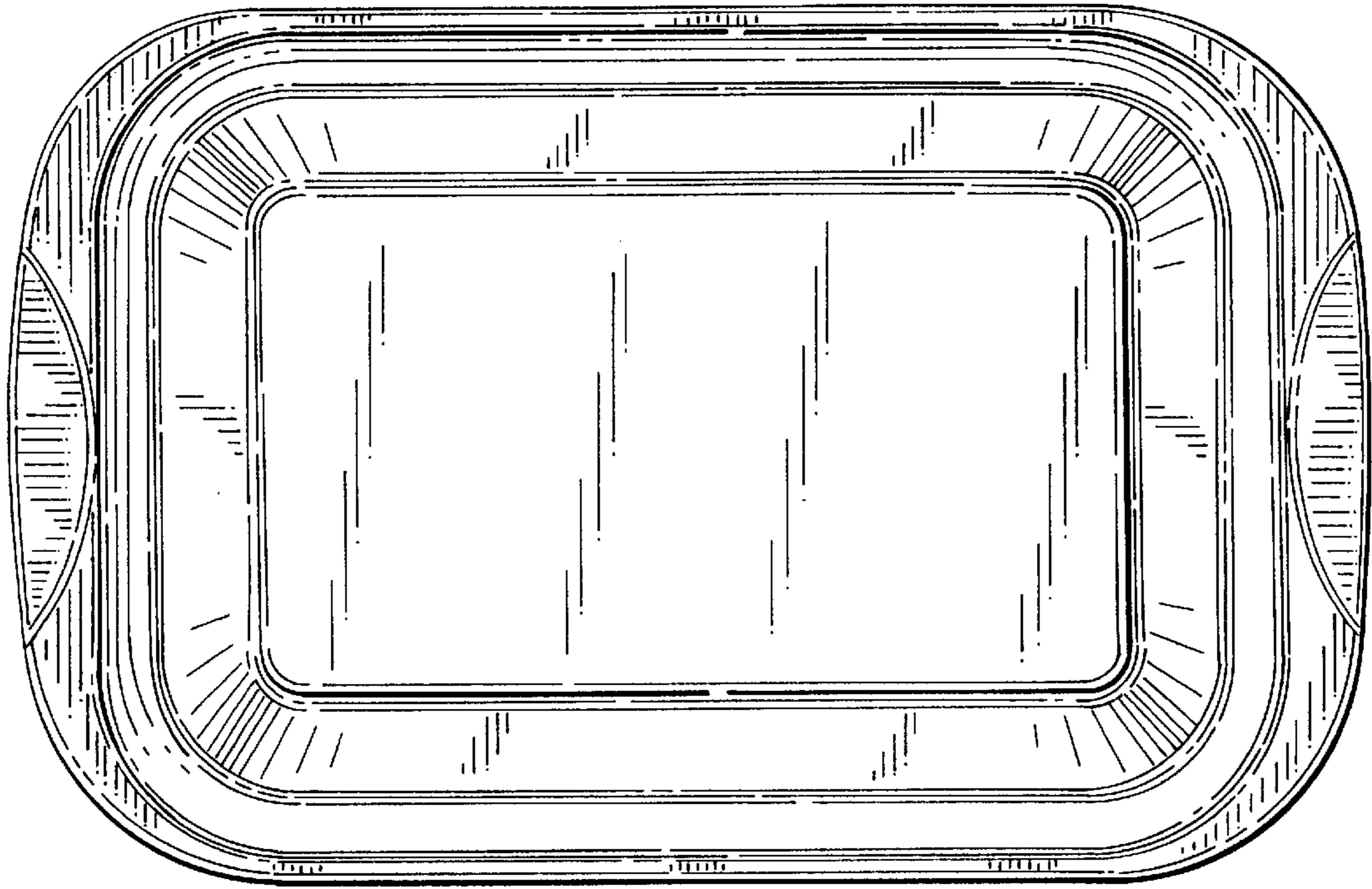

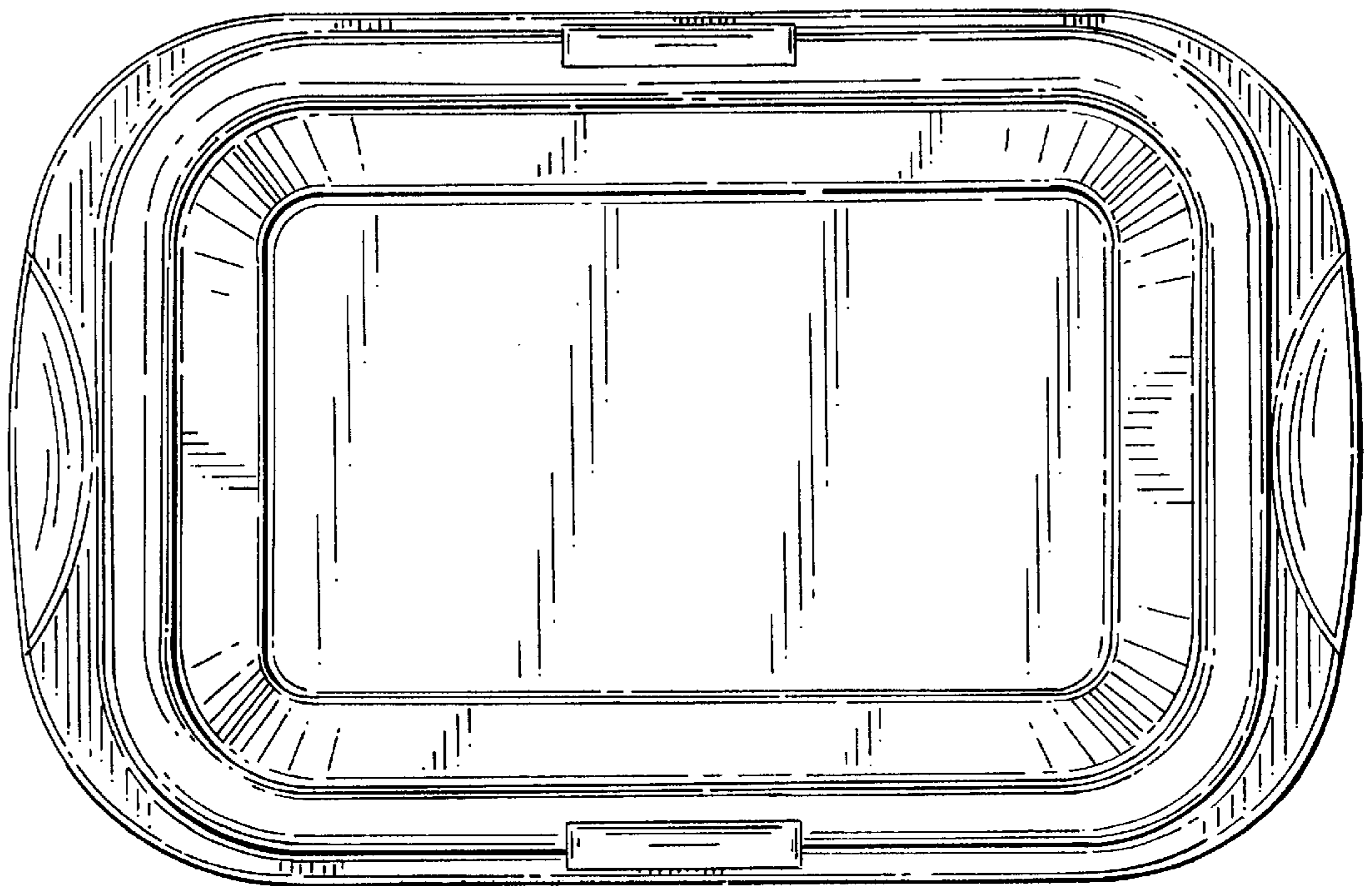

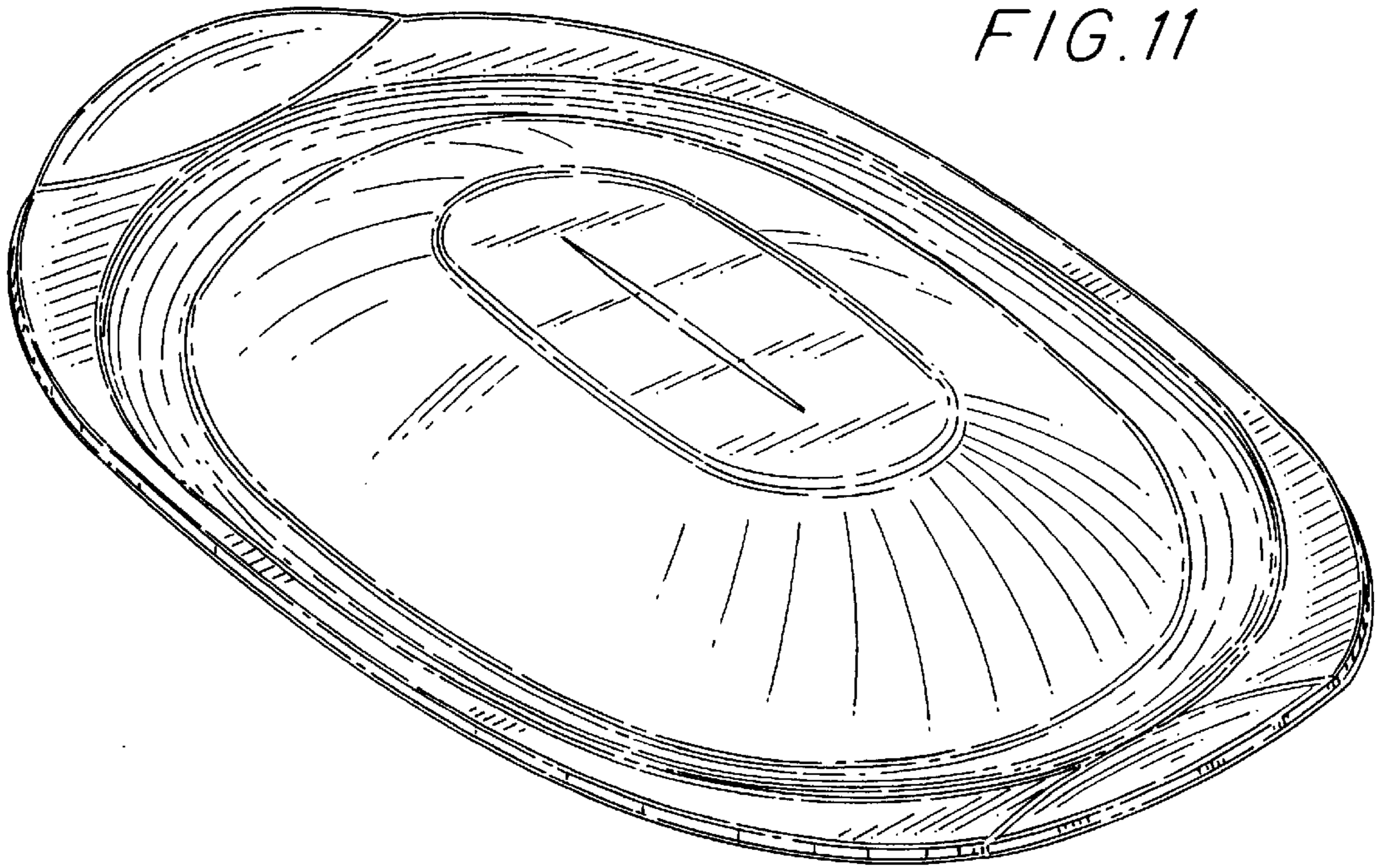

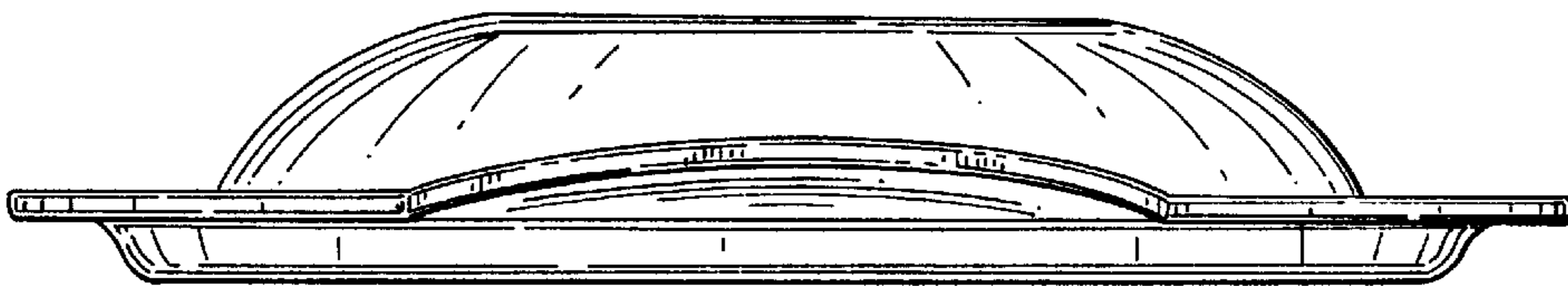

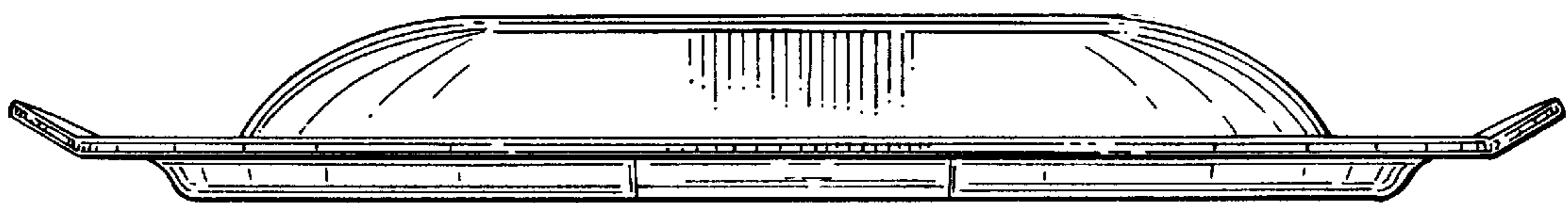

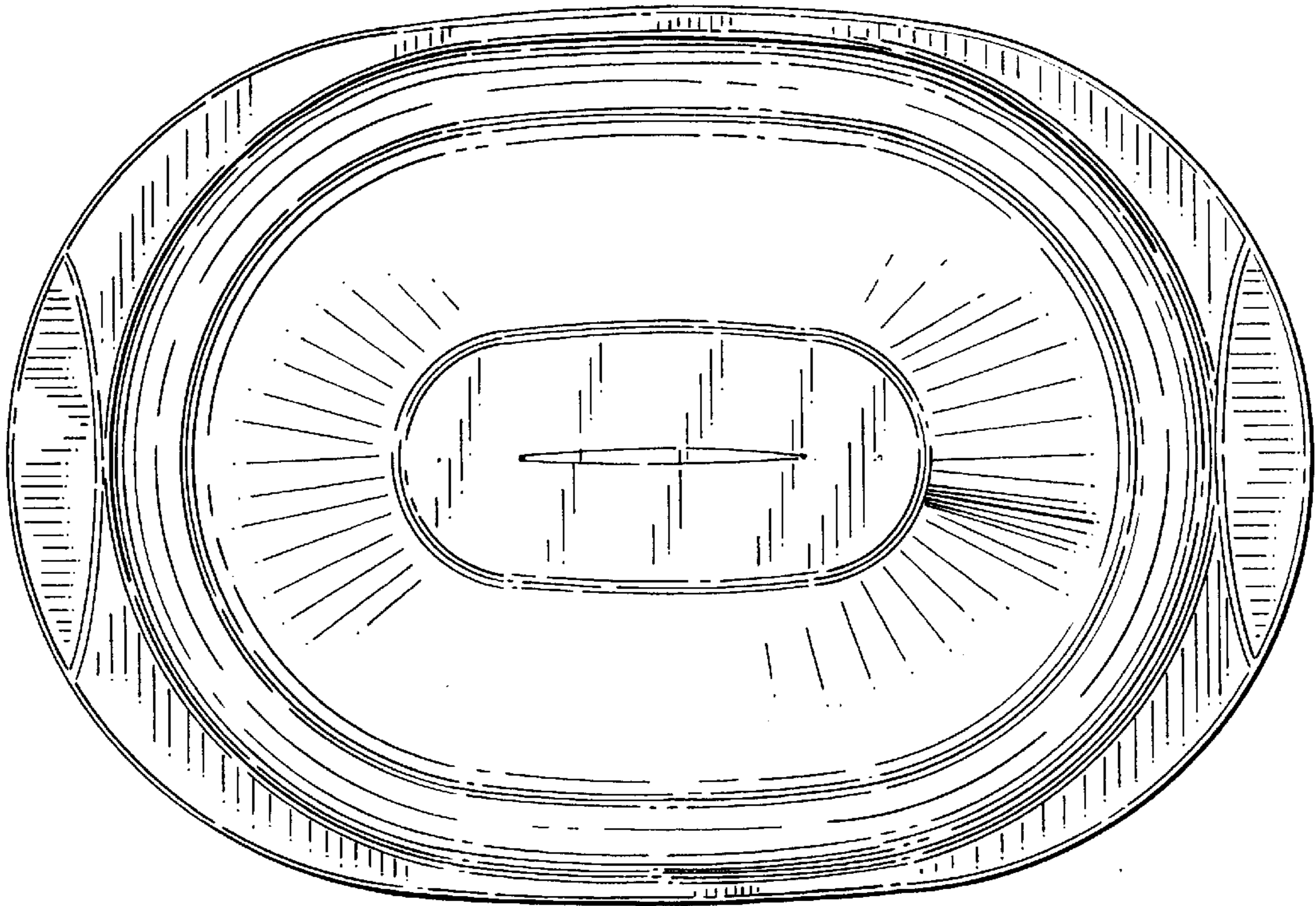

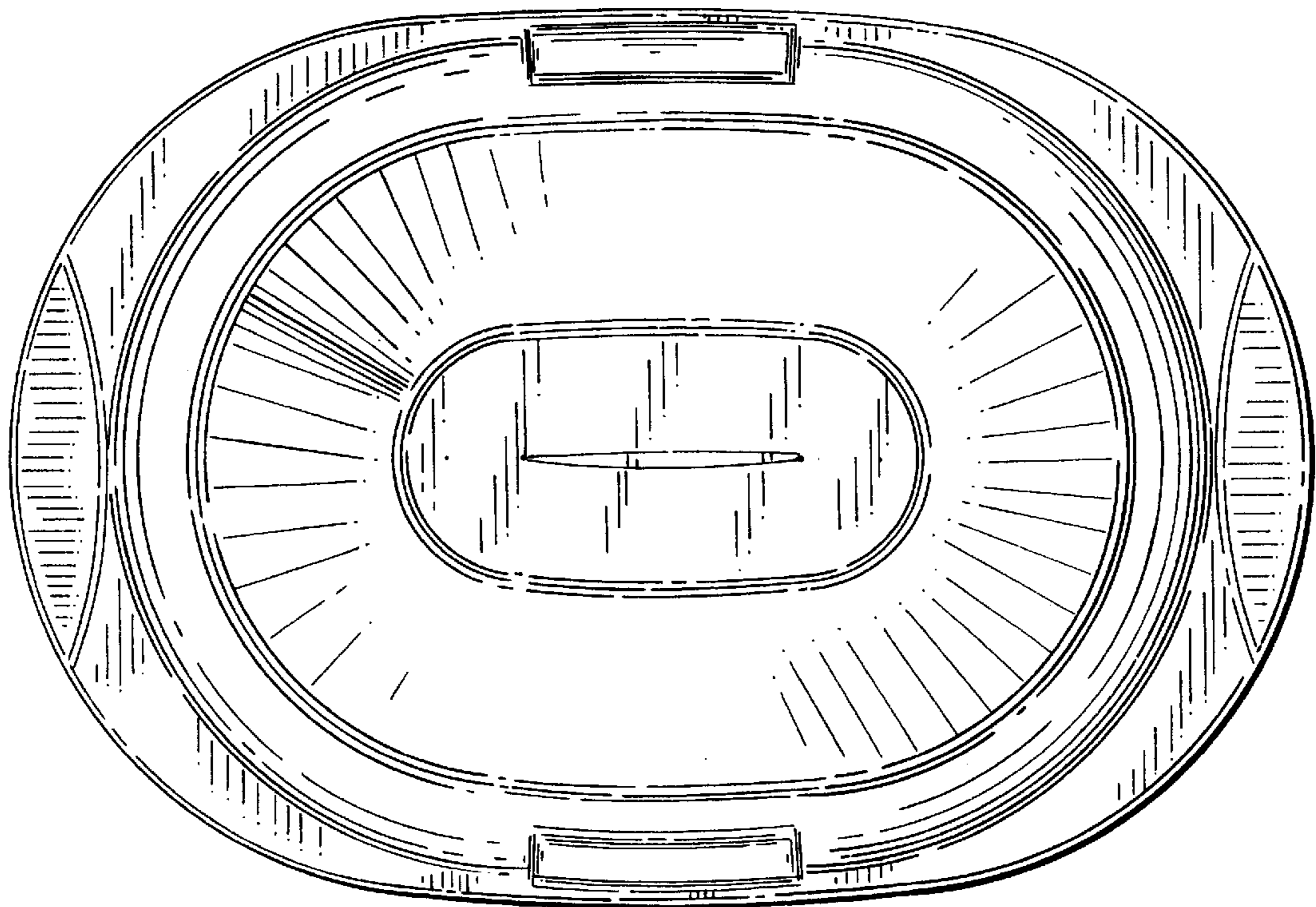

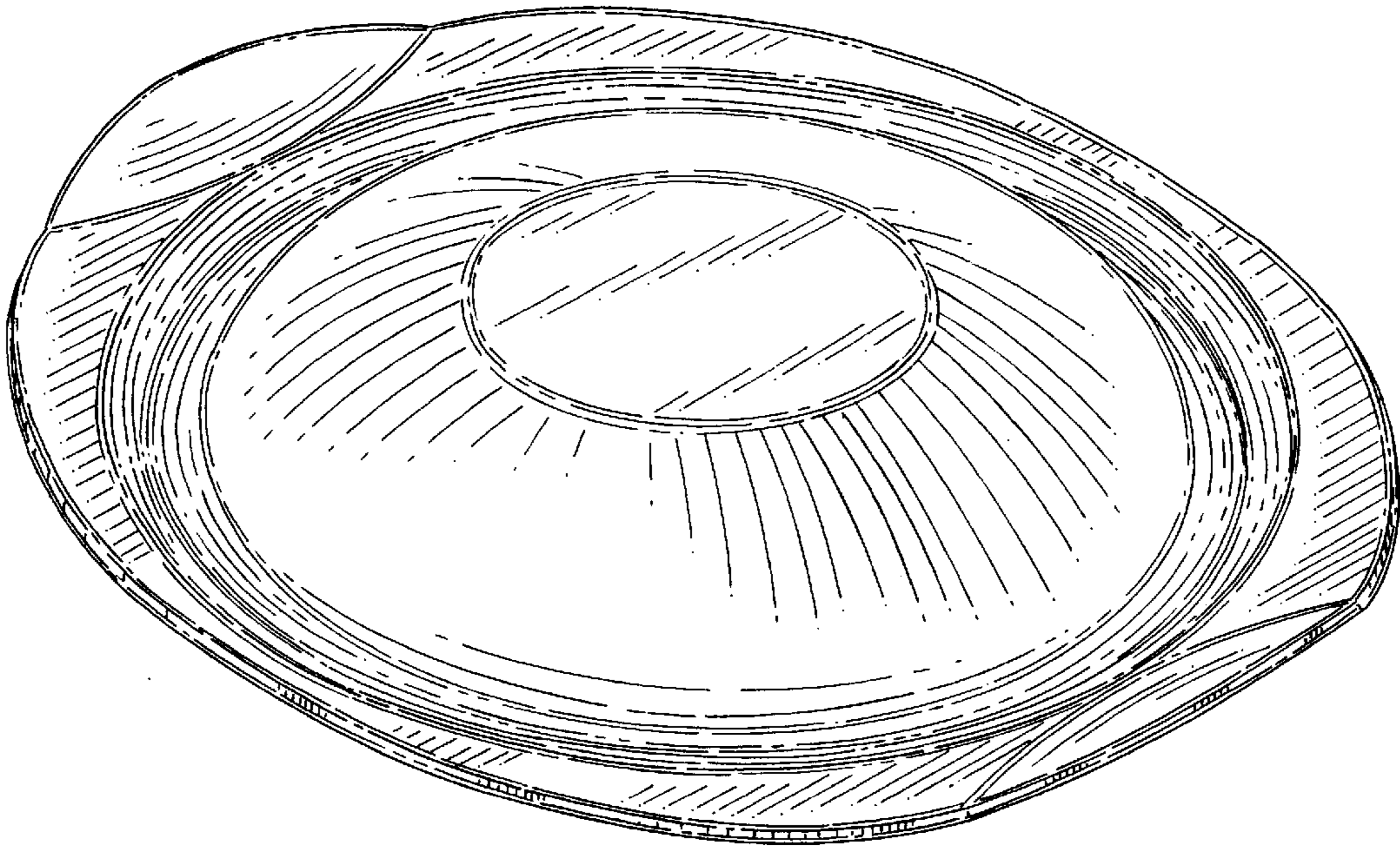

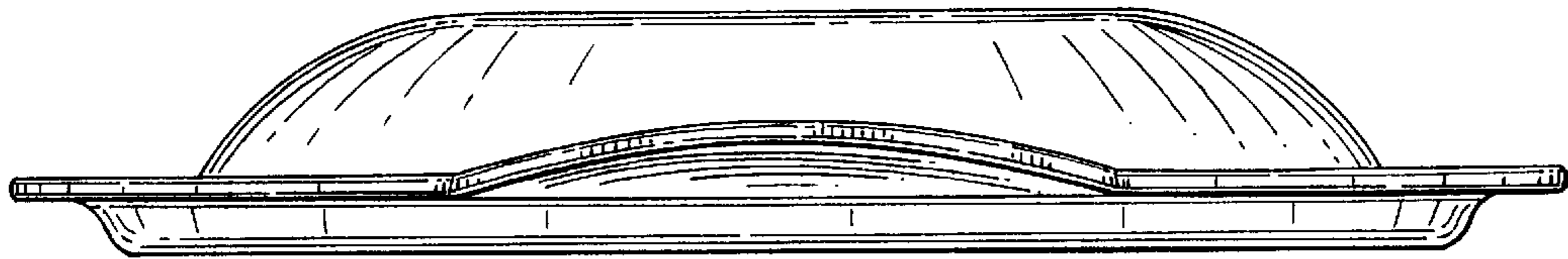

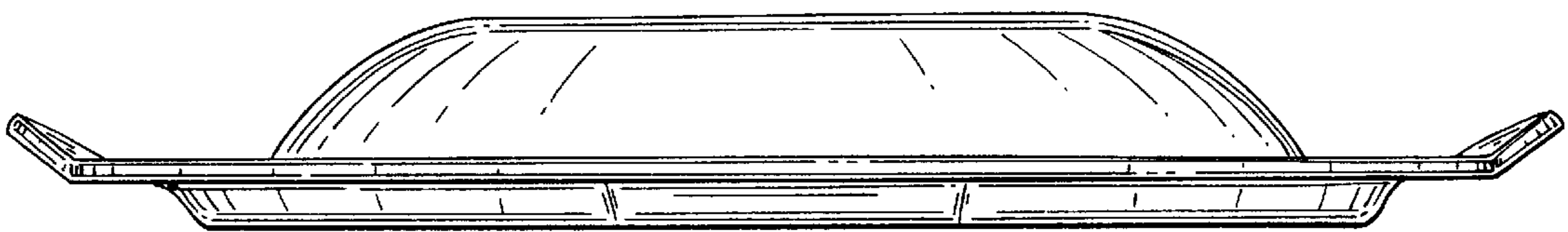

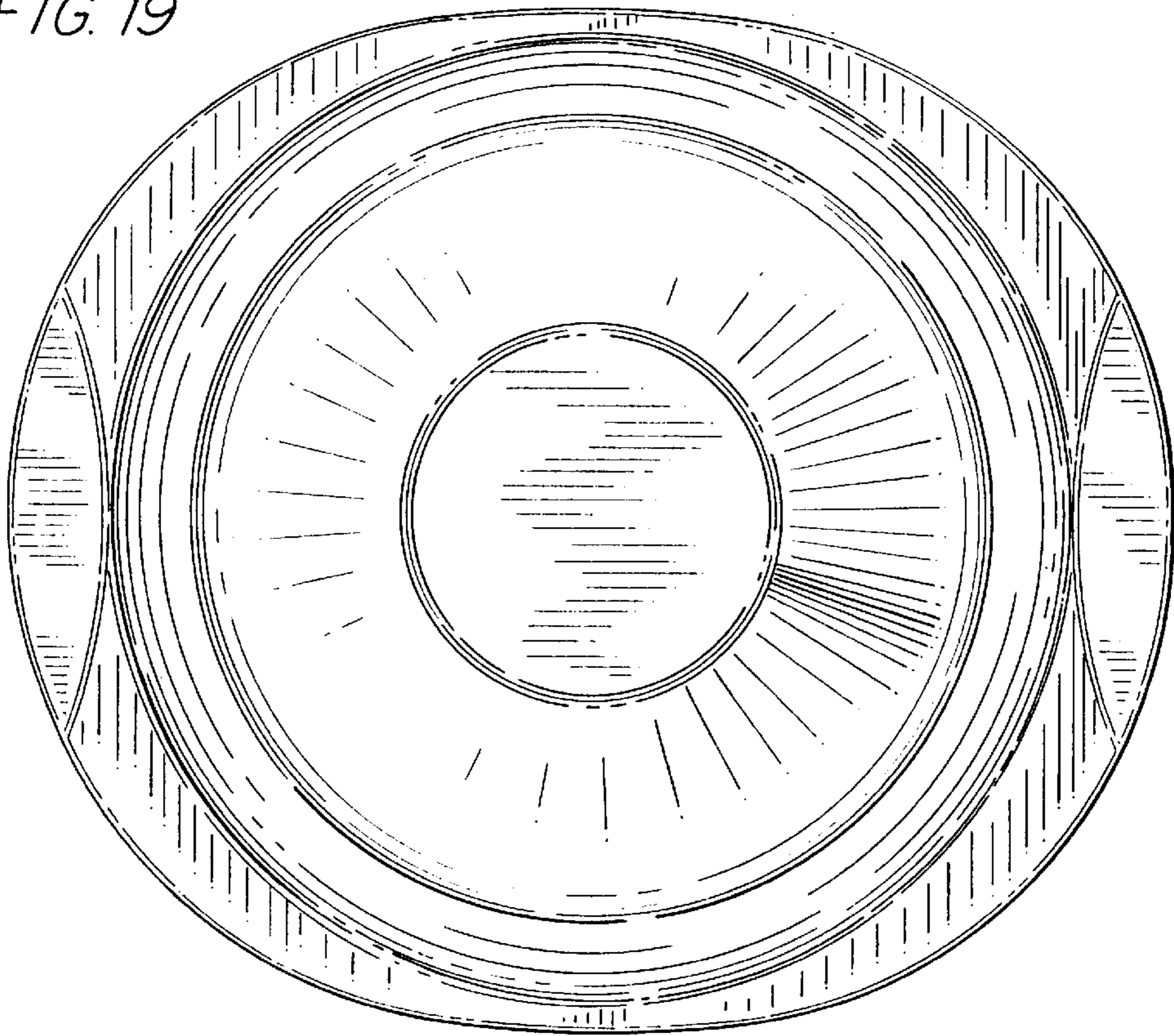
