**DESCRIPTION**

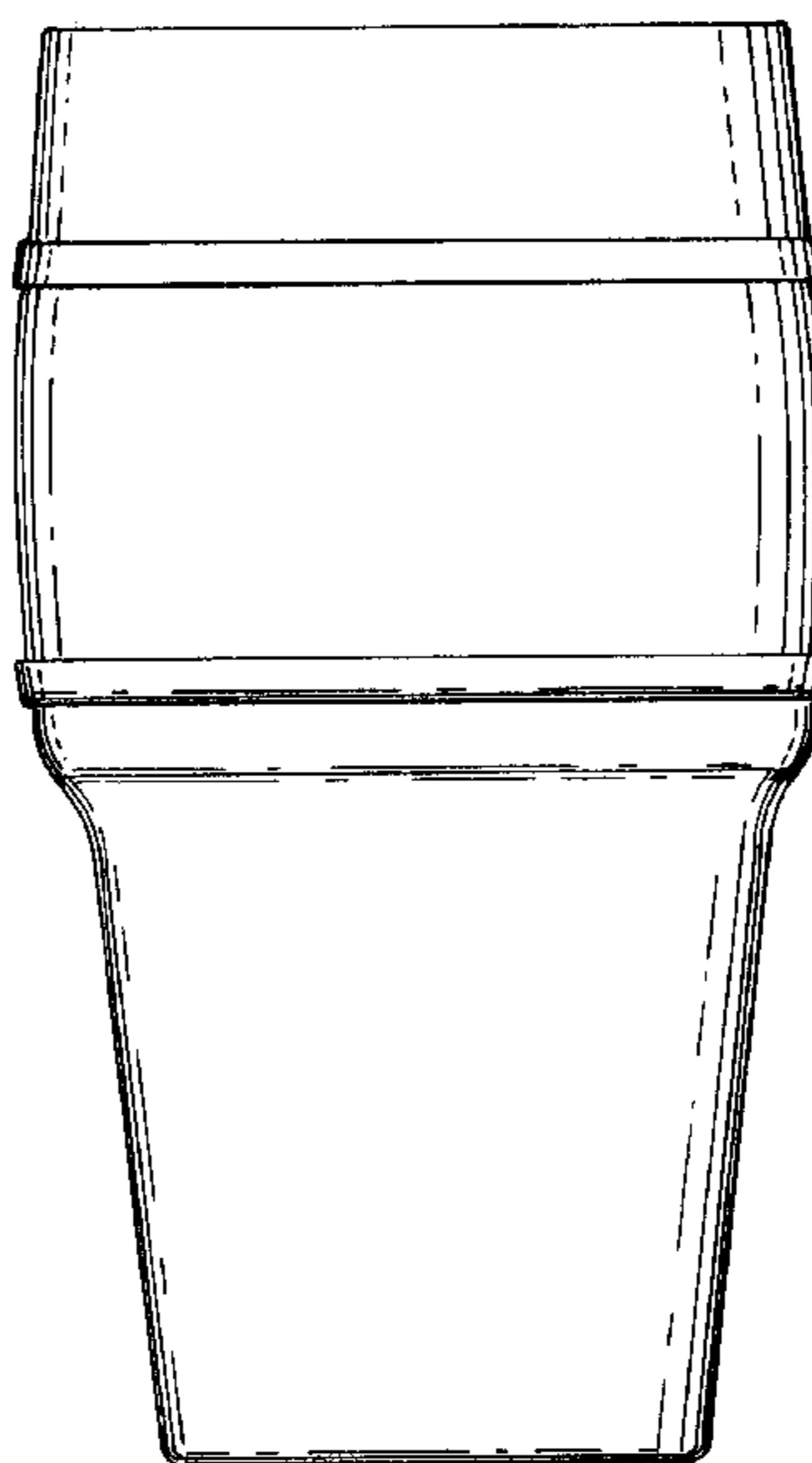
FIG. 1 is a top side isometric view of a signature banded tumbler showing my new design; the broken line showing of a lid in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

FIG. 2 is a right side elevational view of the banded tumbler shown in FIG. 1.

FIG. 4 is a bottom plan view of the banded tumbler.

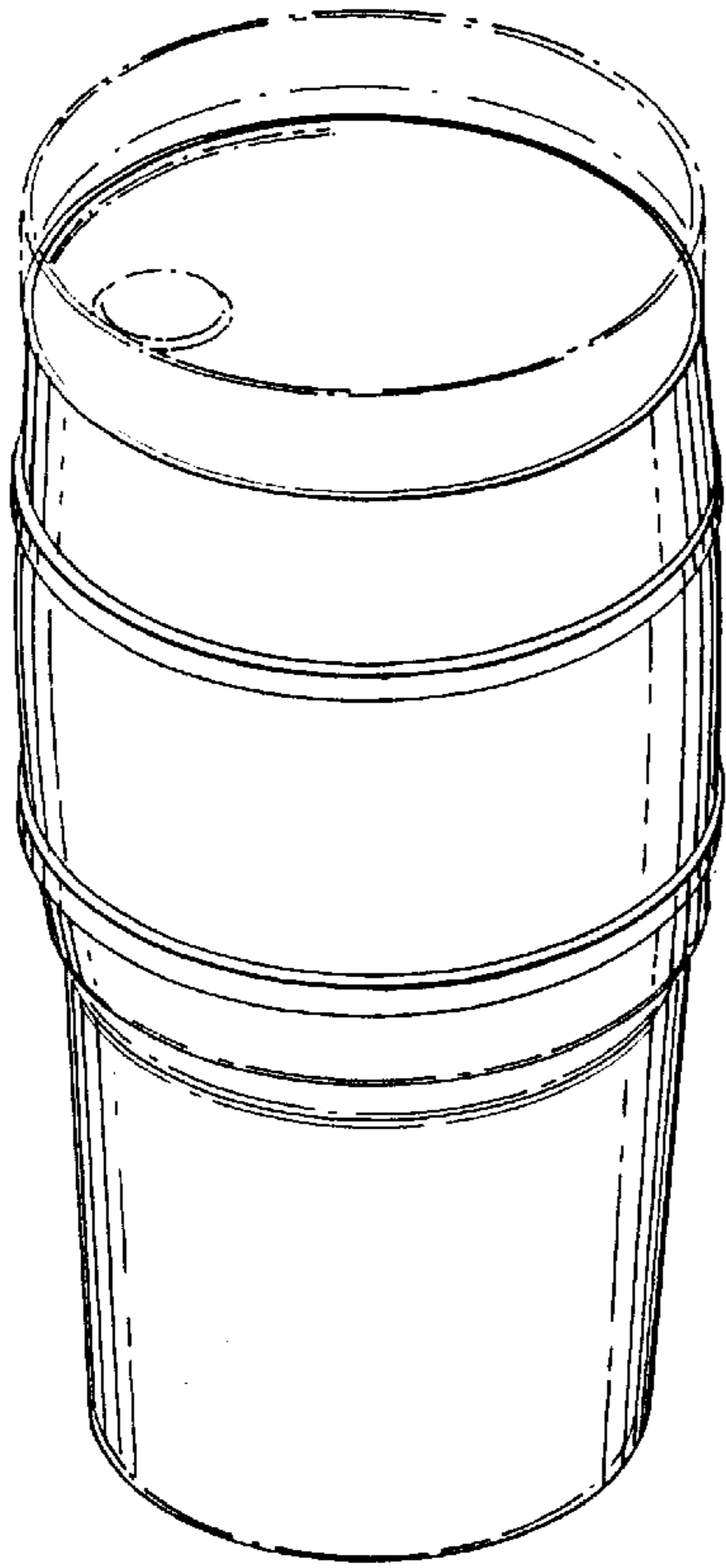

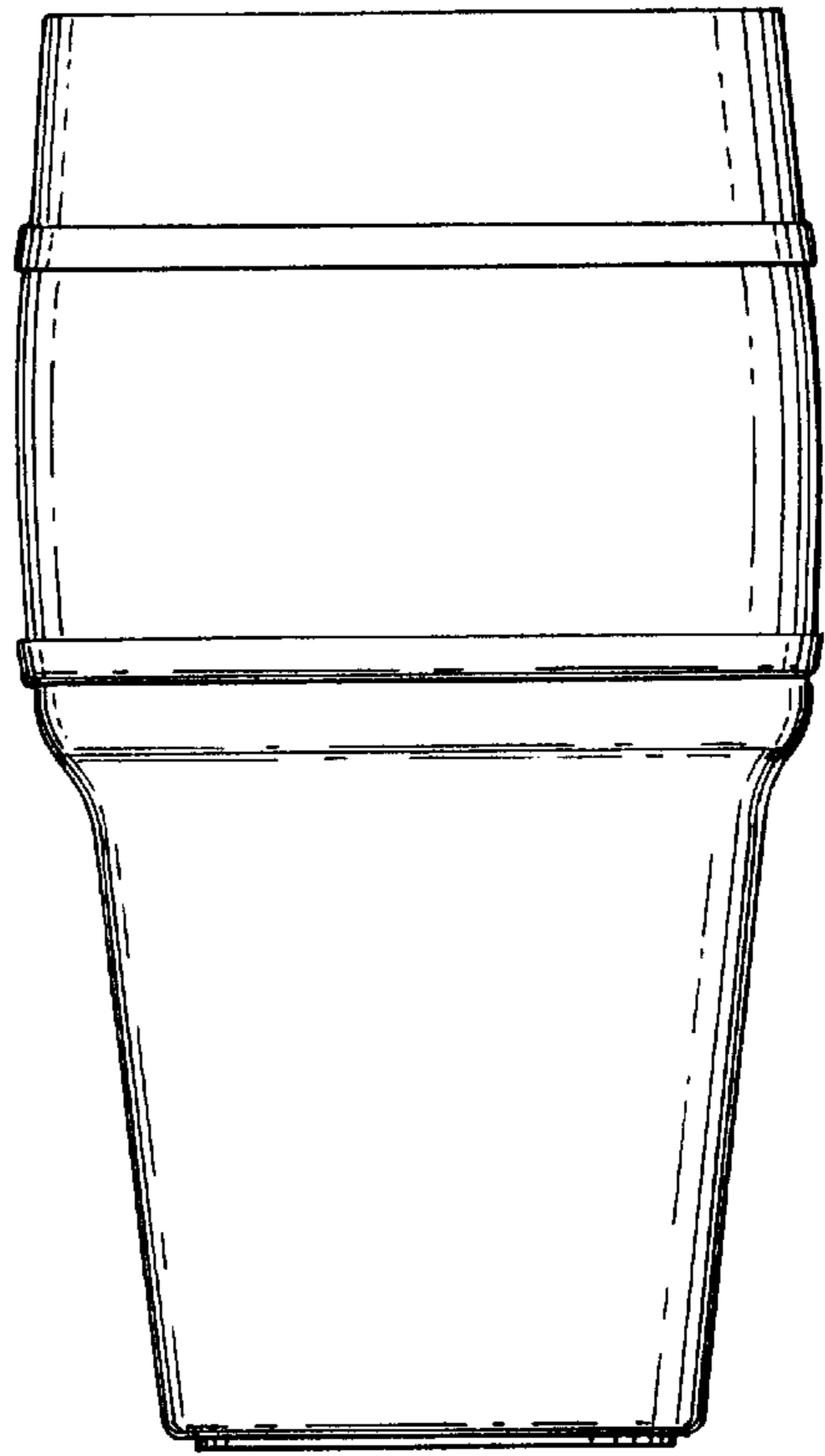

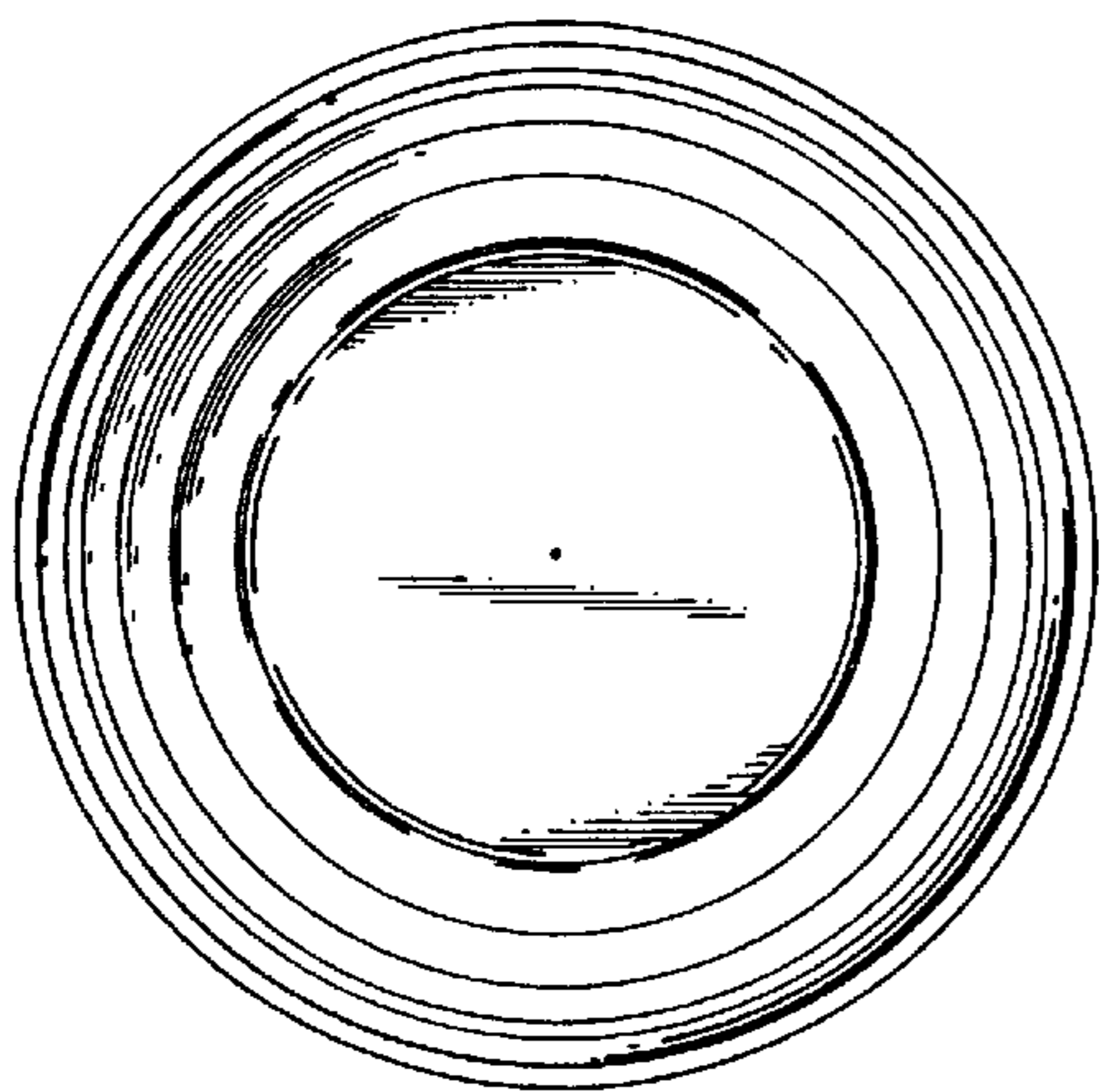
