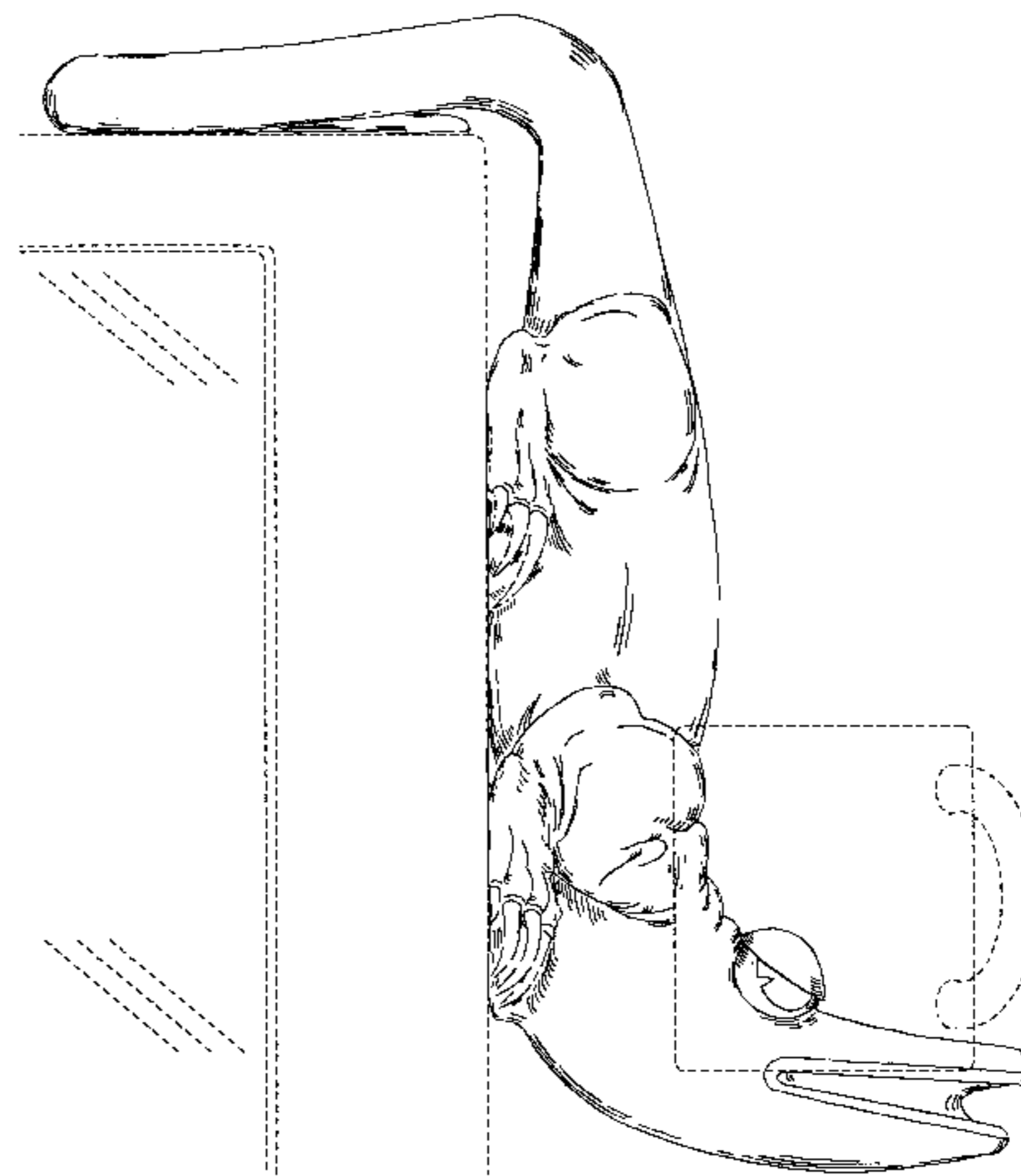
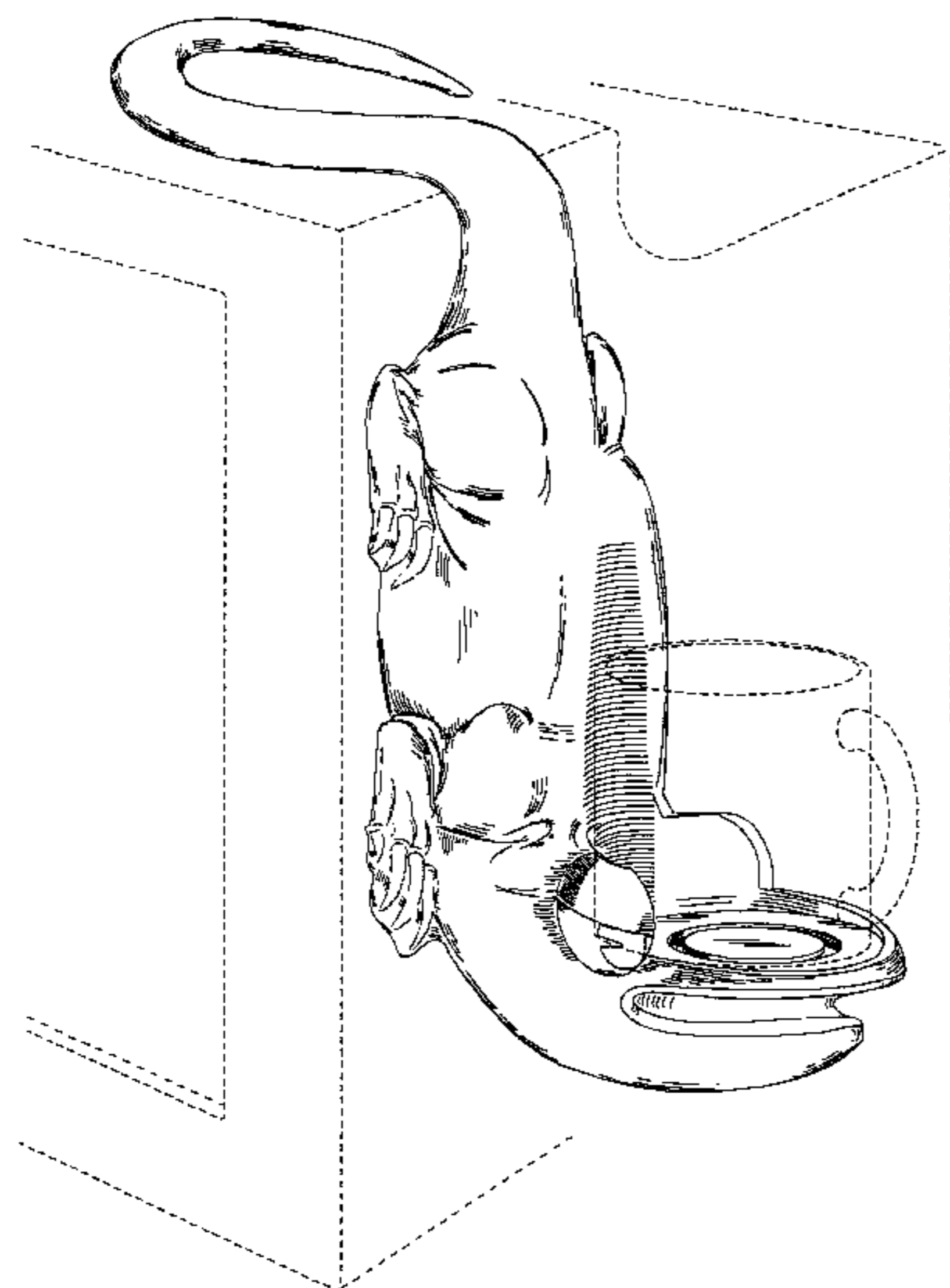

FIG. 1 is a front, right side perspective view of our holder for a beverage container according to a first embodiment; FIG. 2 is a right side elevation view of the holder for a beverage container according to the first embodiment, the left side being a mirror image of the right side; FIG. 3 is a front elevation view of the holder for a beverage container according to the first embodiment; FIG. 4 is a back elevation view of the holder for a beverage container according to the first embodiment; FIG. 5 is a bottom plan view of the holder for a beverage container according to the first embodiment; FIG. 6 is a top plan view of the holder for a beverage container according to the first embodiment; FIG. 7 is a front, right side perspective view of our holder for a beverage container according to a second embodiment; FIG. 8 is a right side elevation view of the holder for a beverage container according to the second embodiment, the left side being a mirror image of the right side; FIG. 9 is a front elevation view of the holder for a beverage container according to the second embodiment; FIG. 10 is a back elevation view of the holder for a beverage container according to the second embodiment; FIG. 11 is a bottom plan view of the holder for a beverage container according to the second embodiment; and, FIG. 12 is a top plan view of the holder for a beverage container according to the second embodiment.

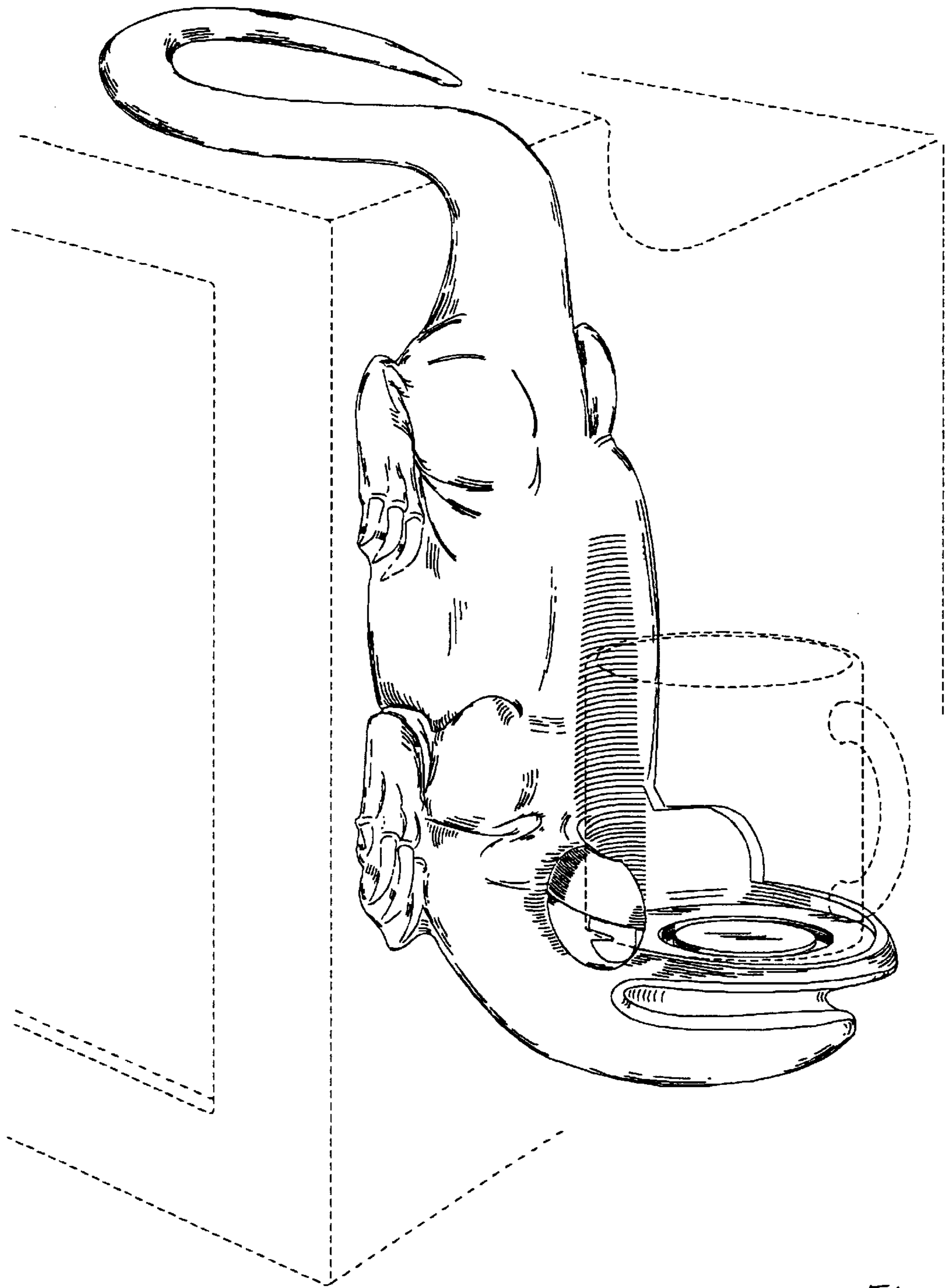

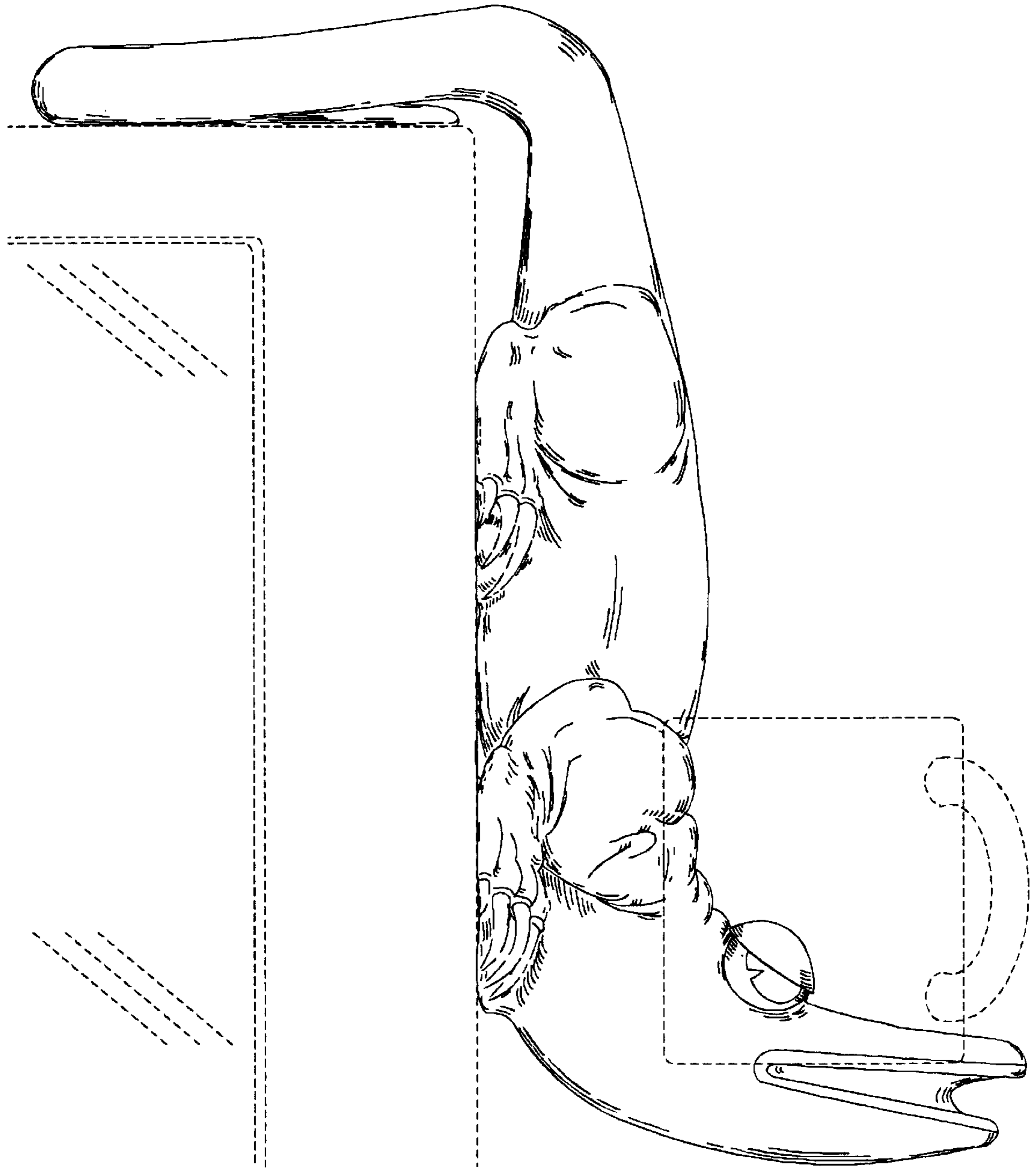

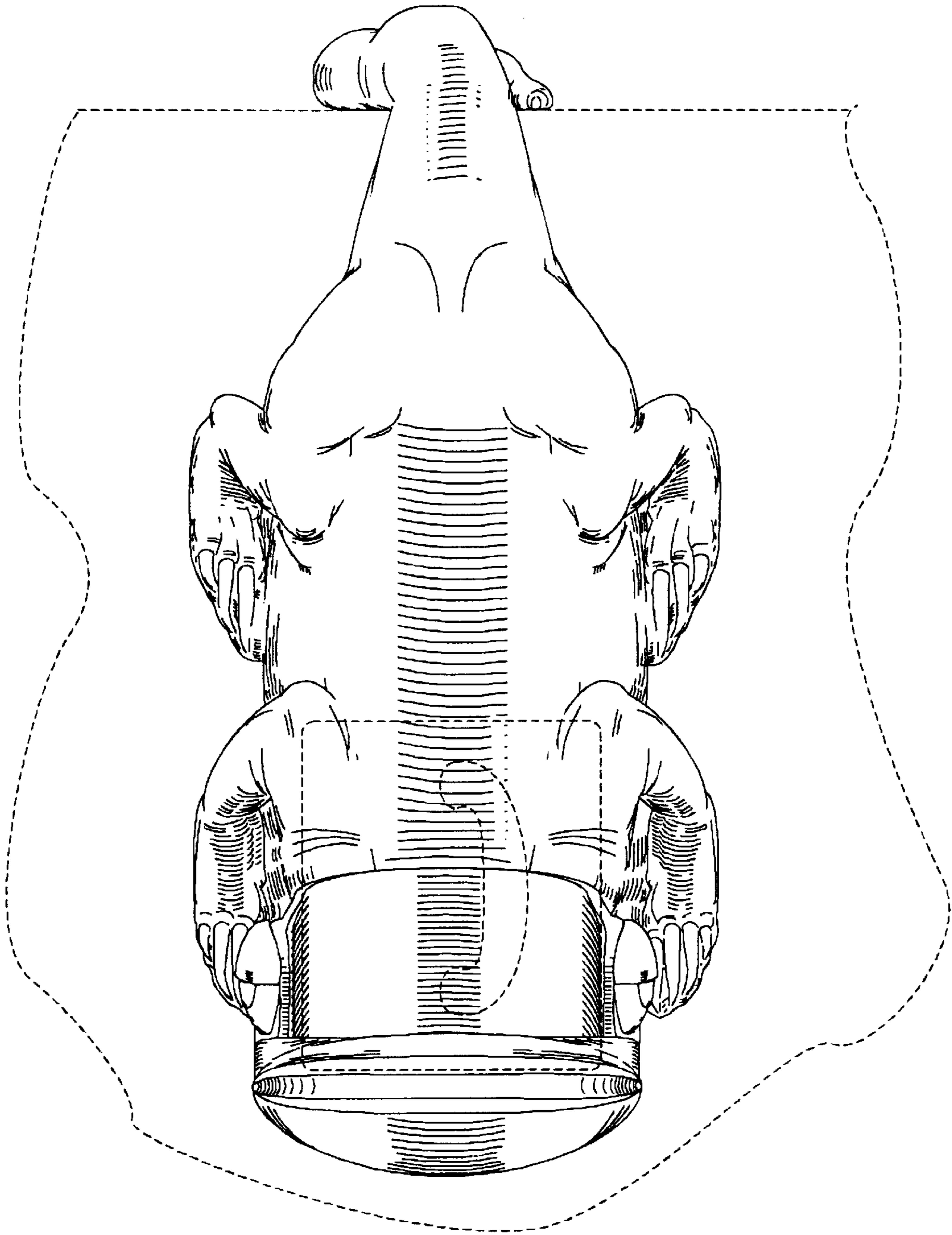

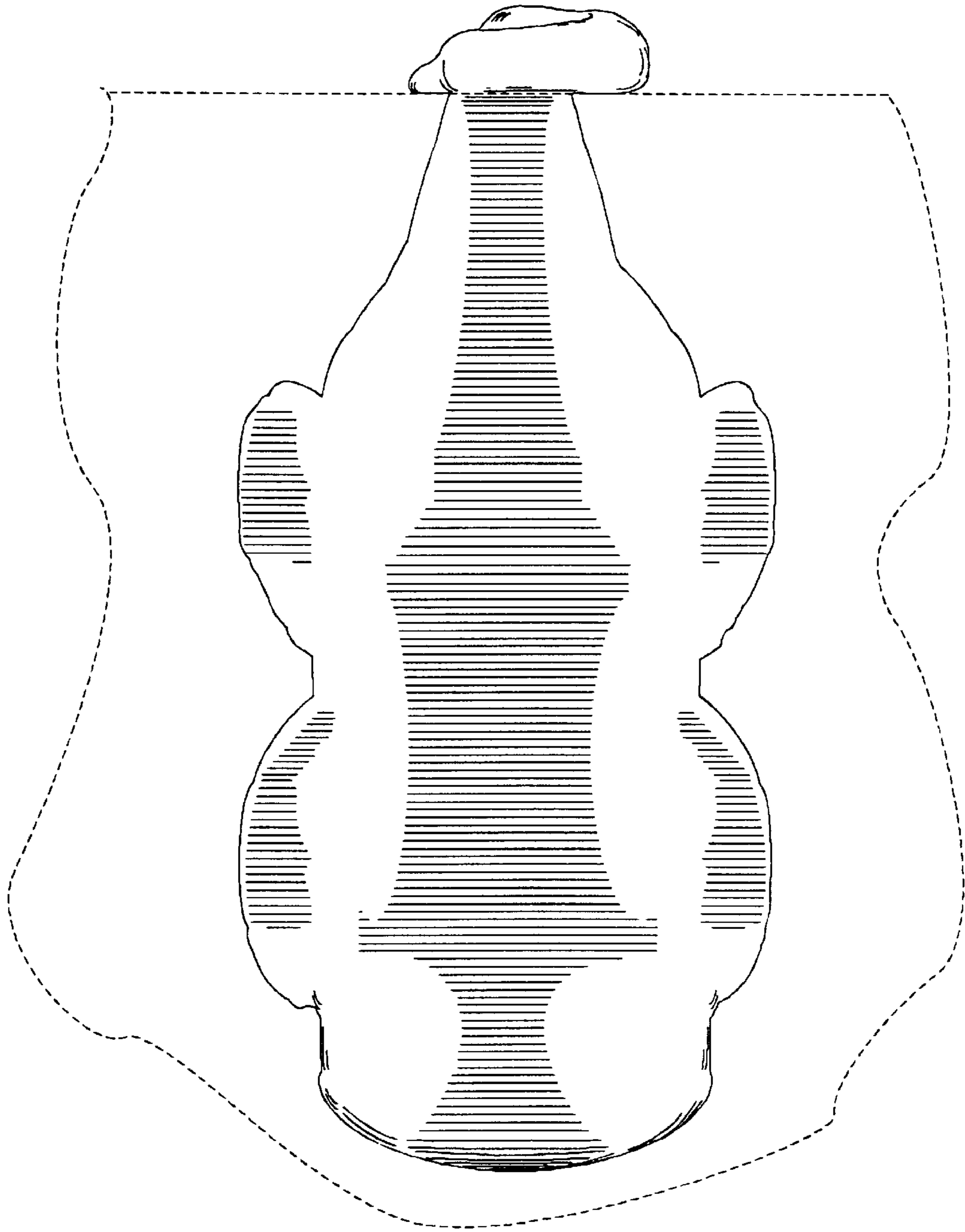

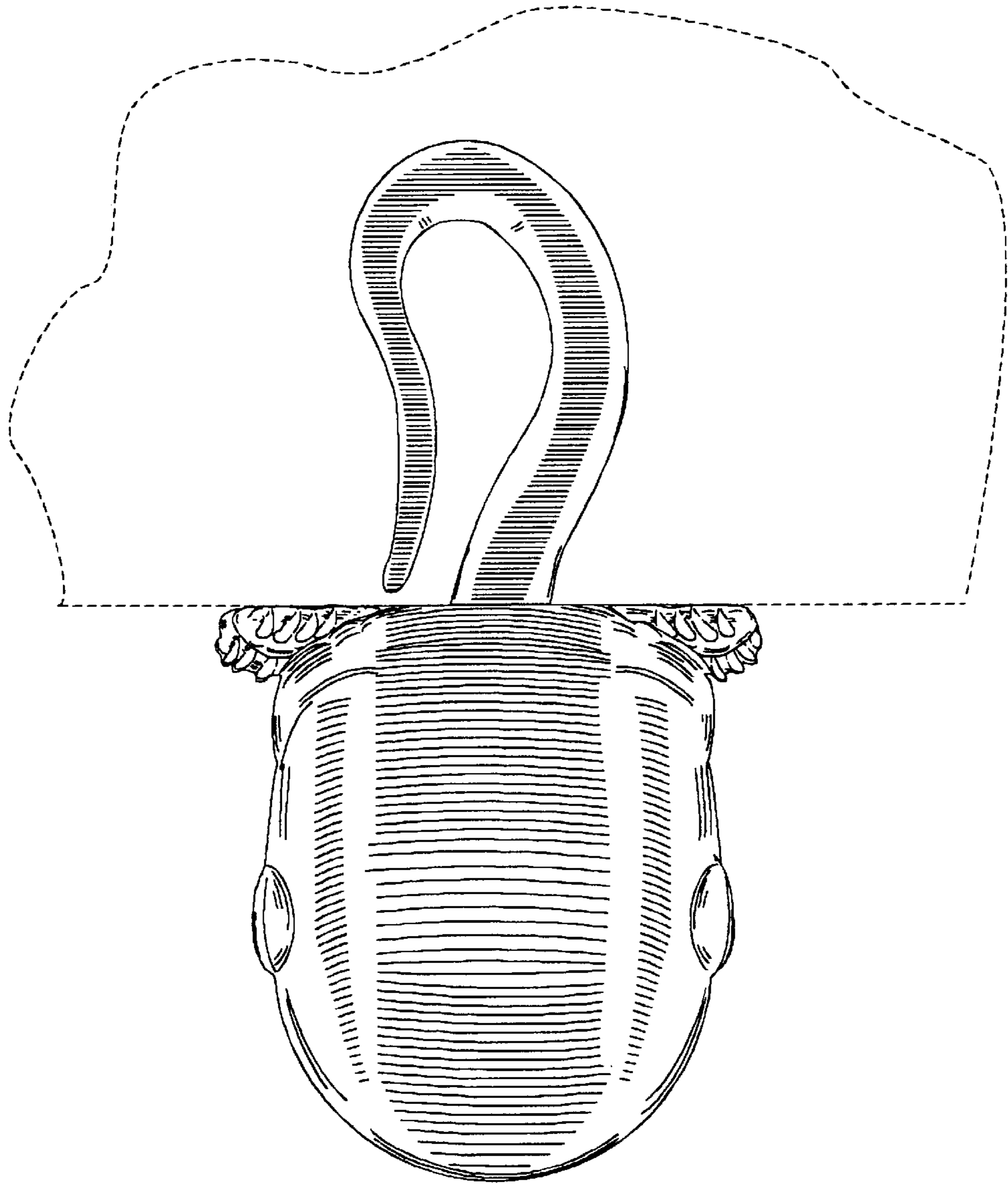

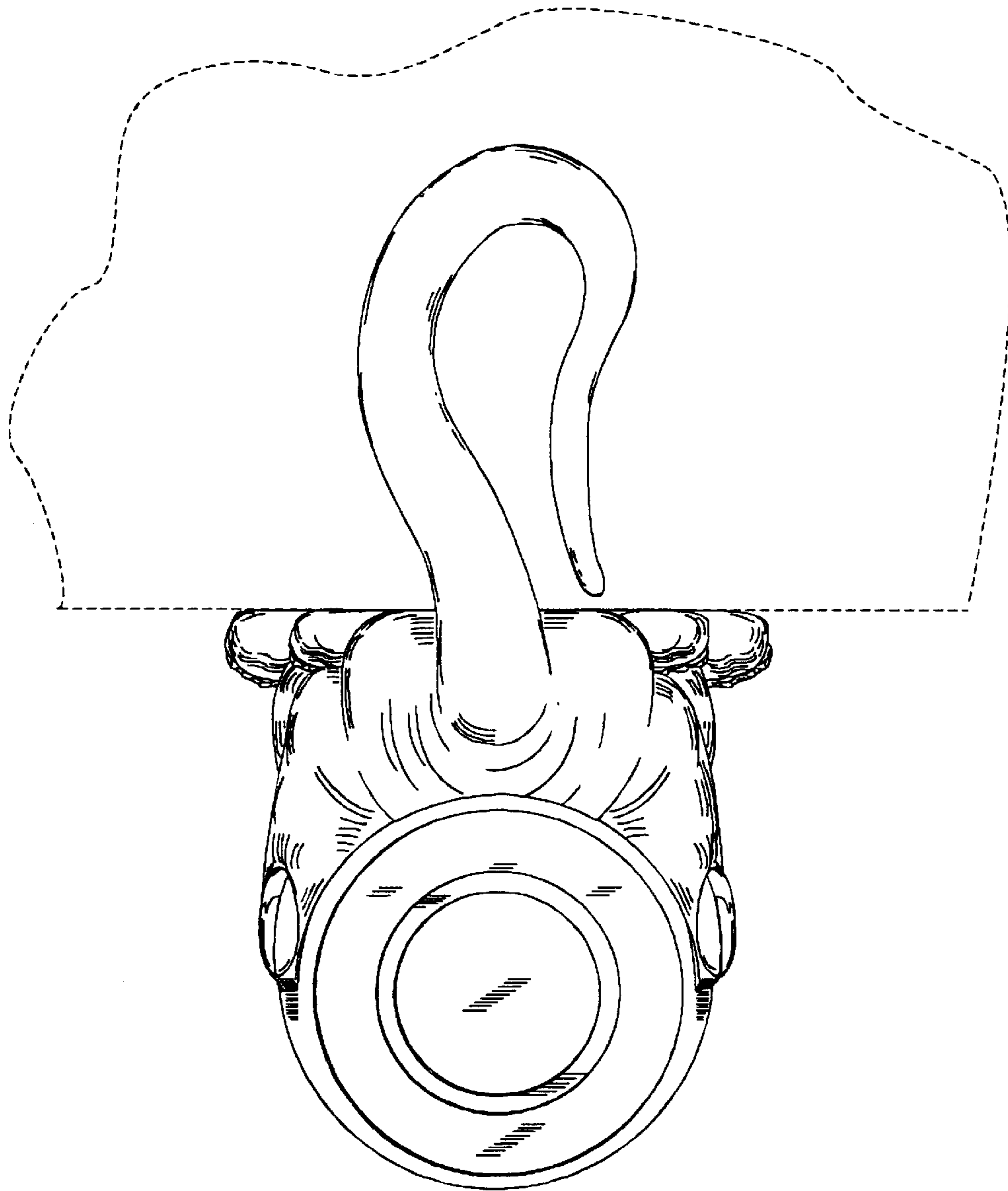

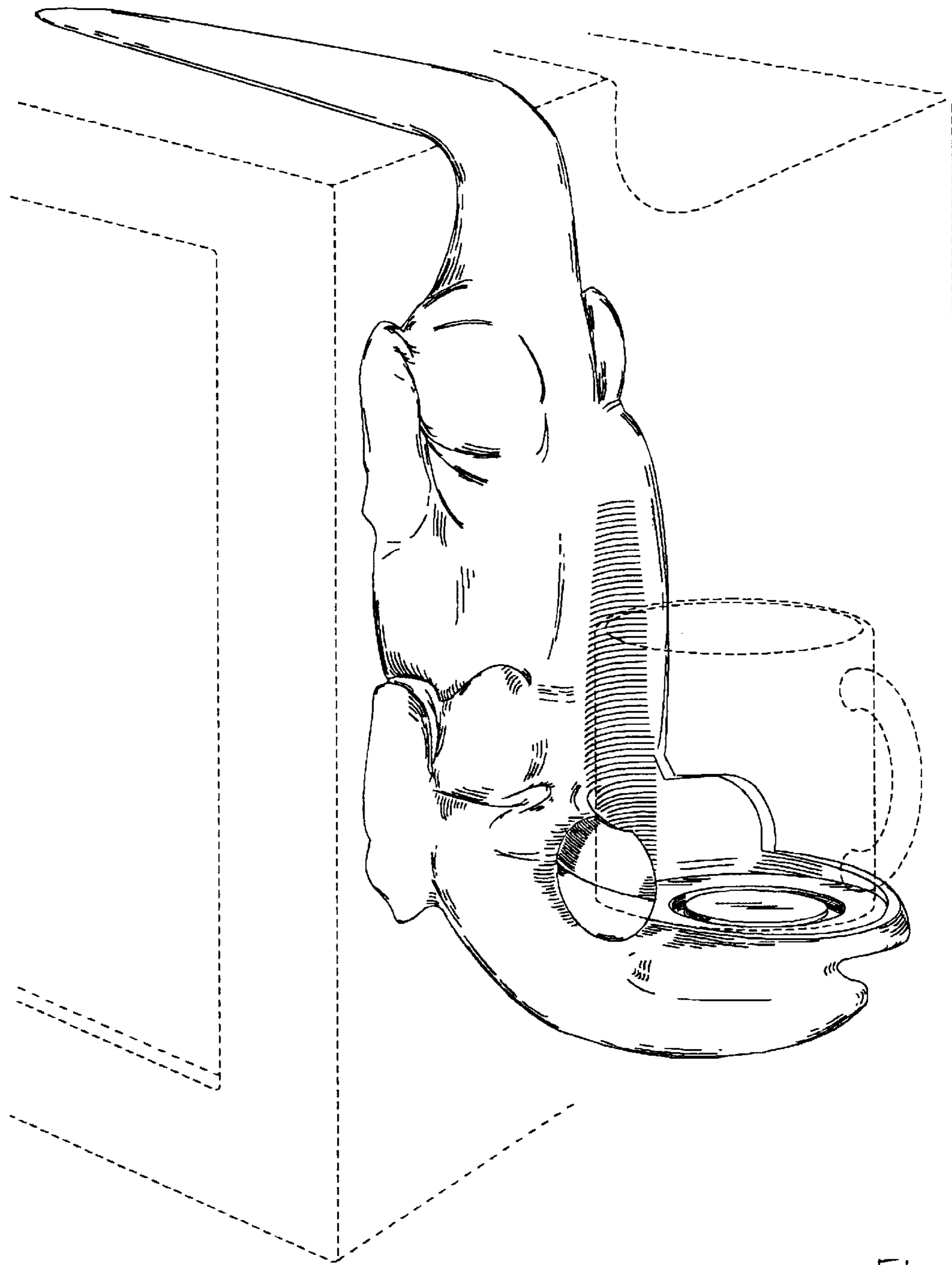

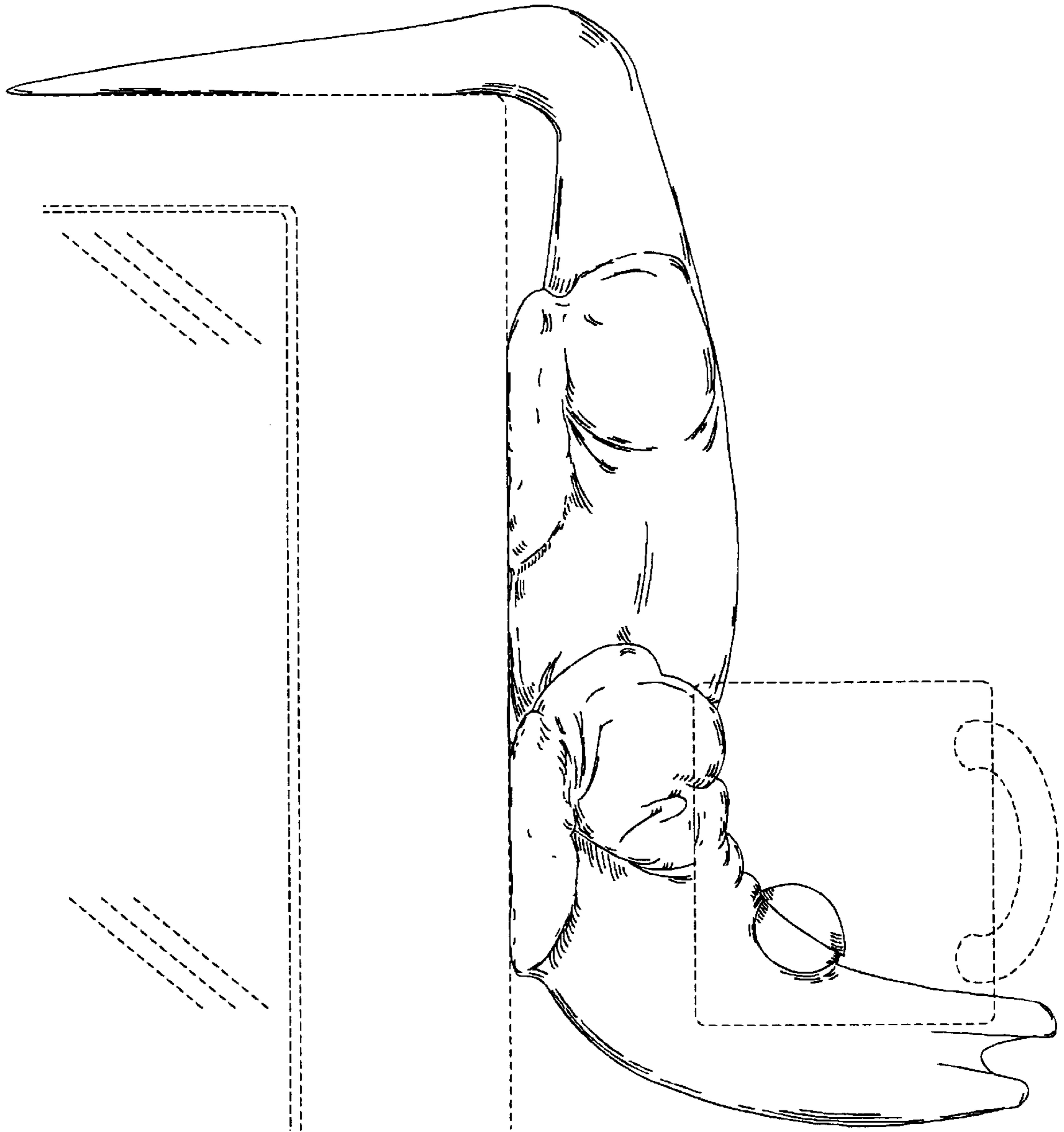

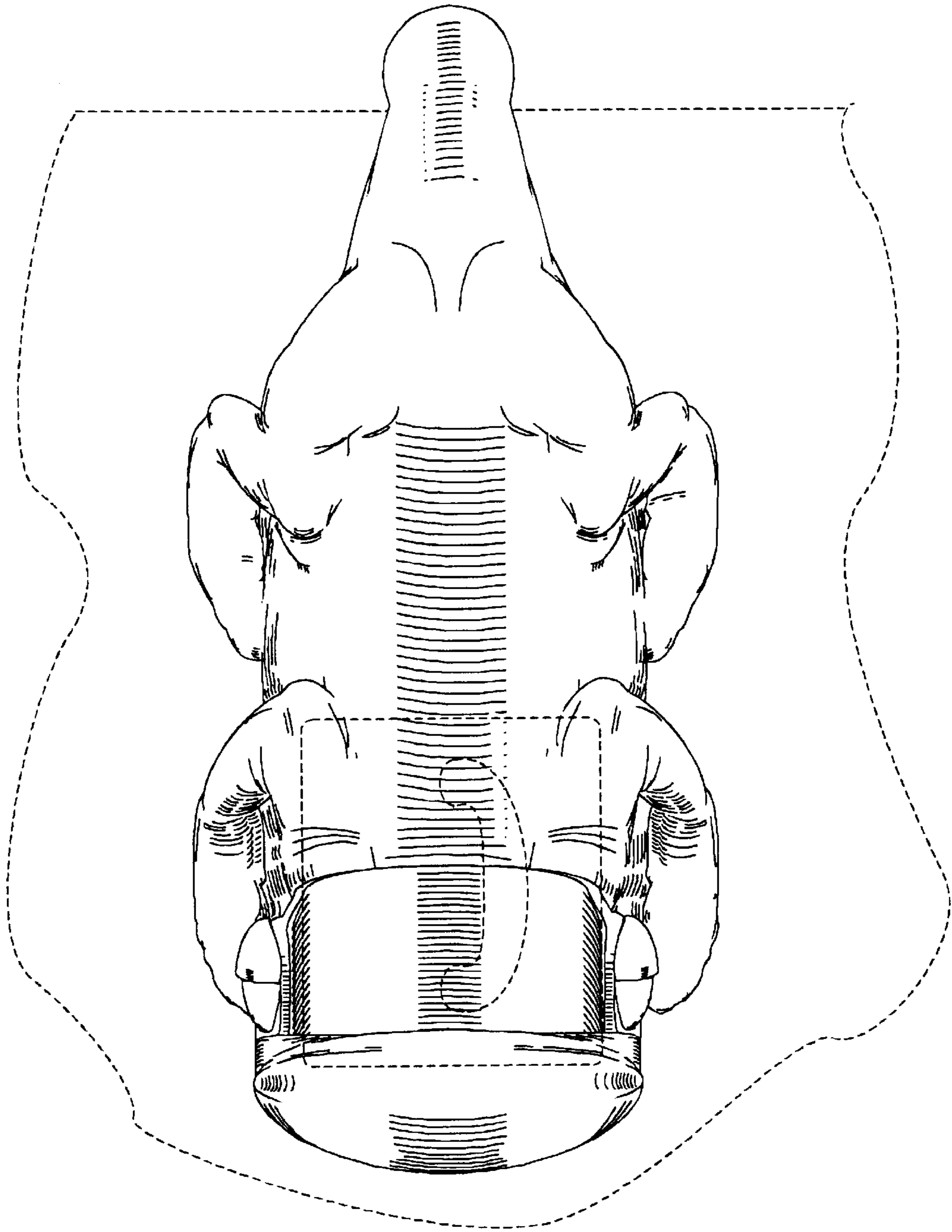

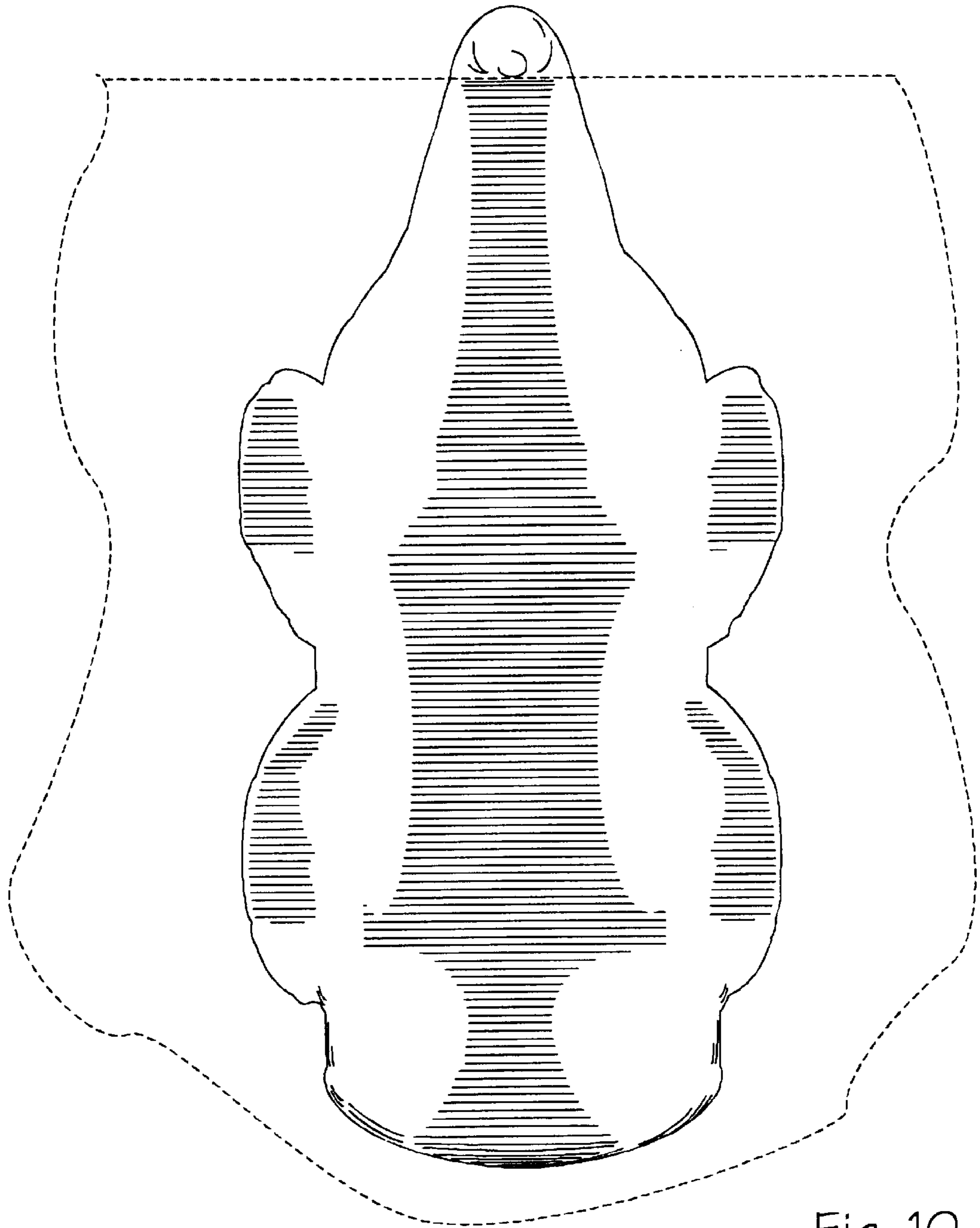

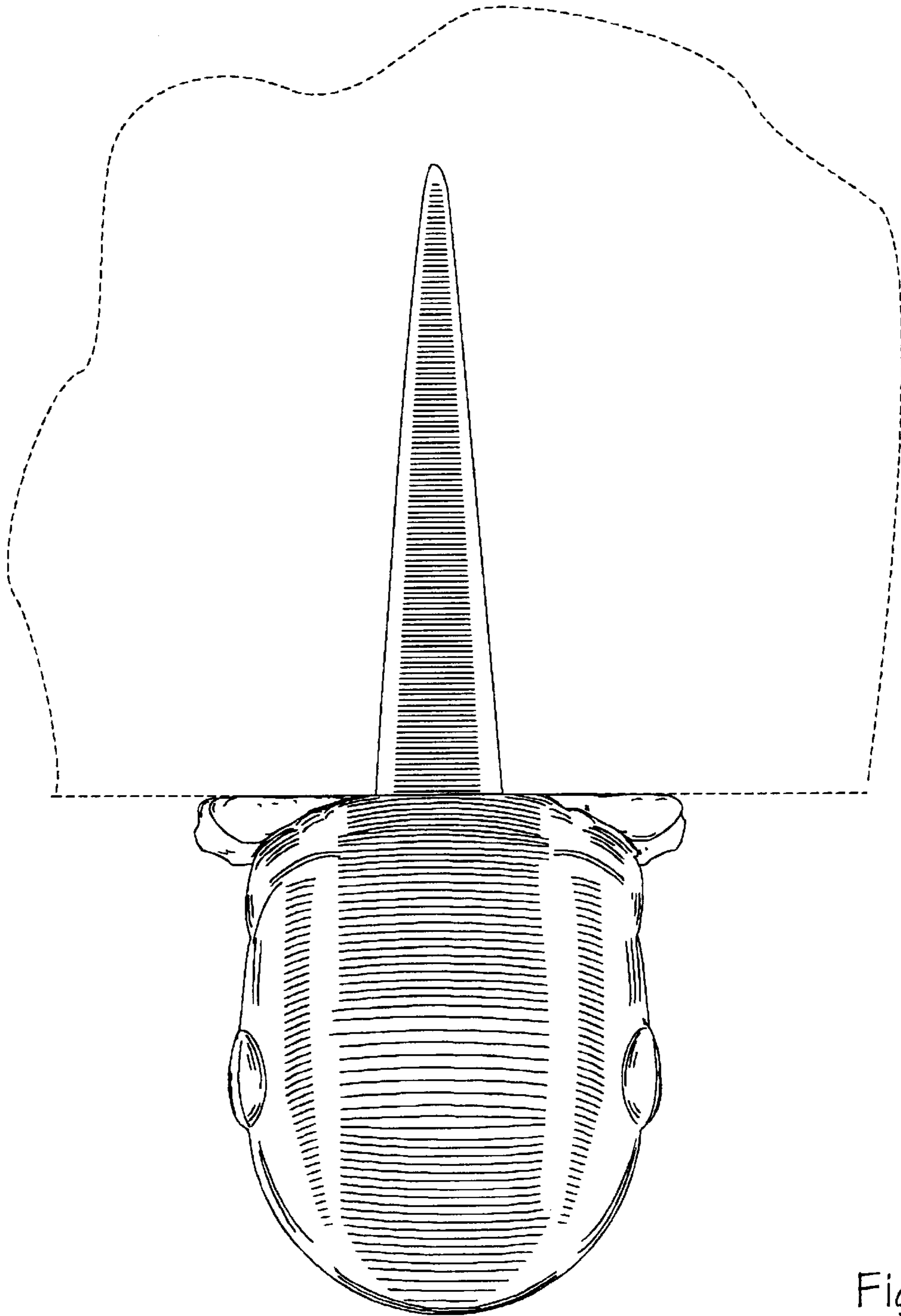

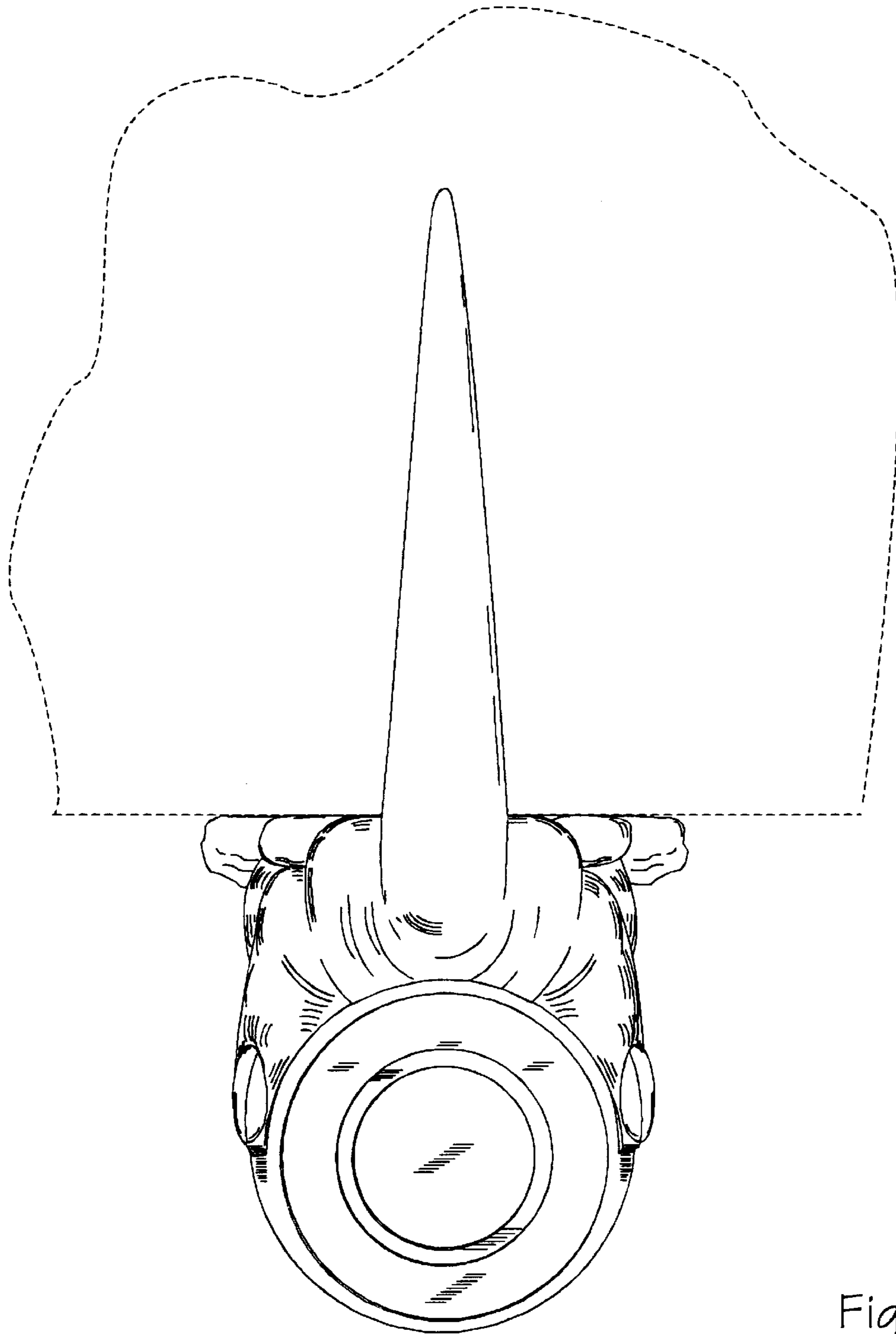
