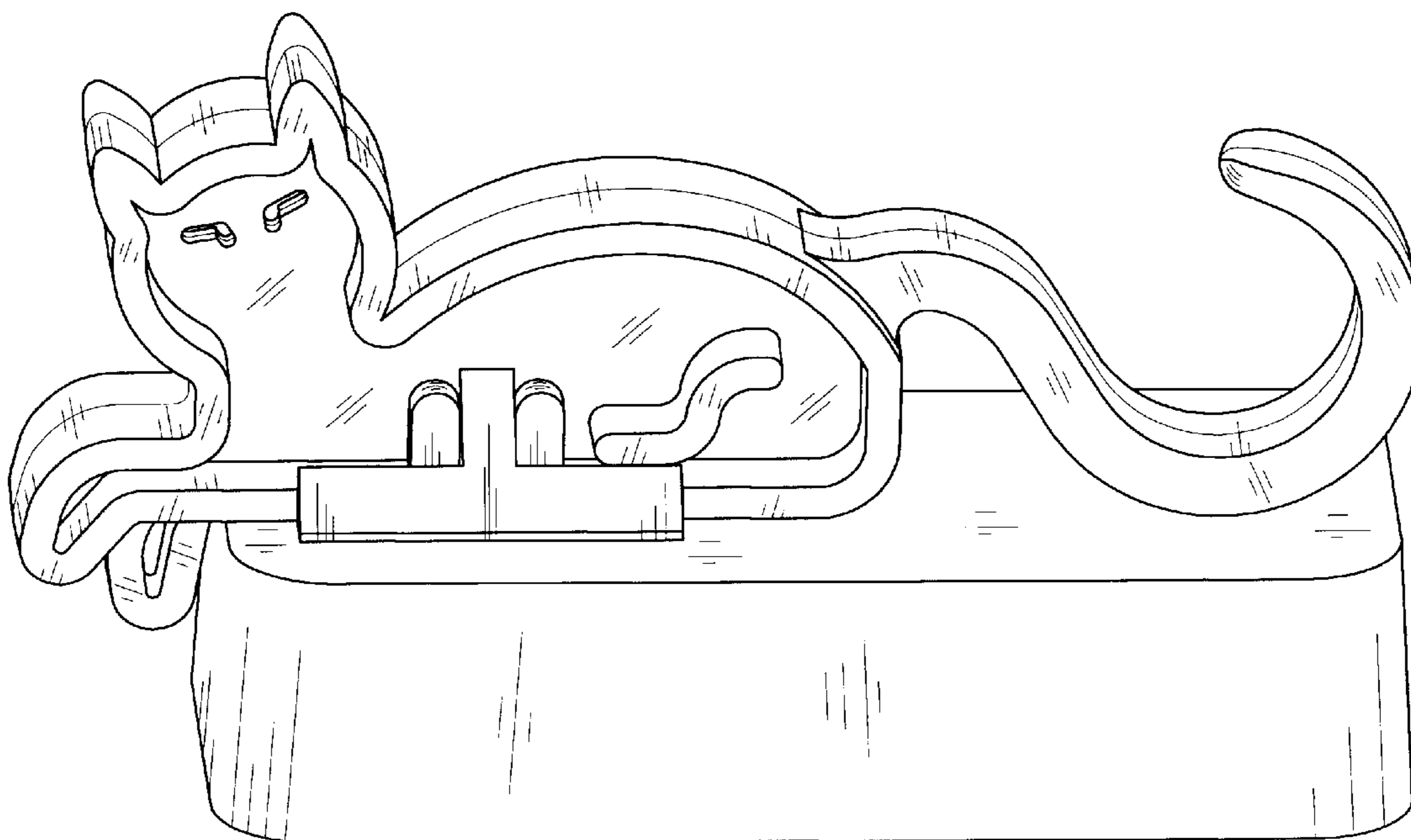
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a front view thereof;
FIG. 2 is a left side view, the right side being a mirror image thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a bottom view thereof, the broken lines being shown for illustrative purposes only and forming no part of the claimed design;
FIG. 5 is a top view thereof; and,

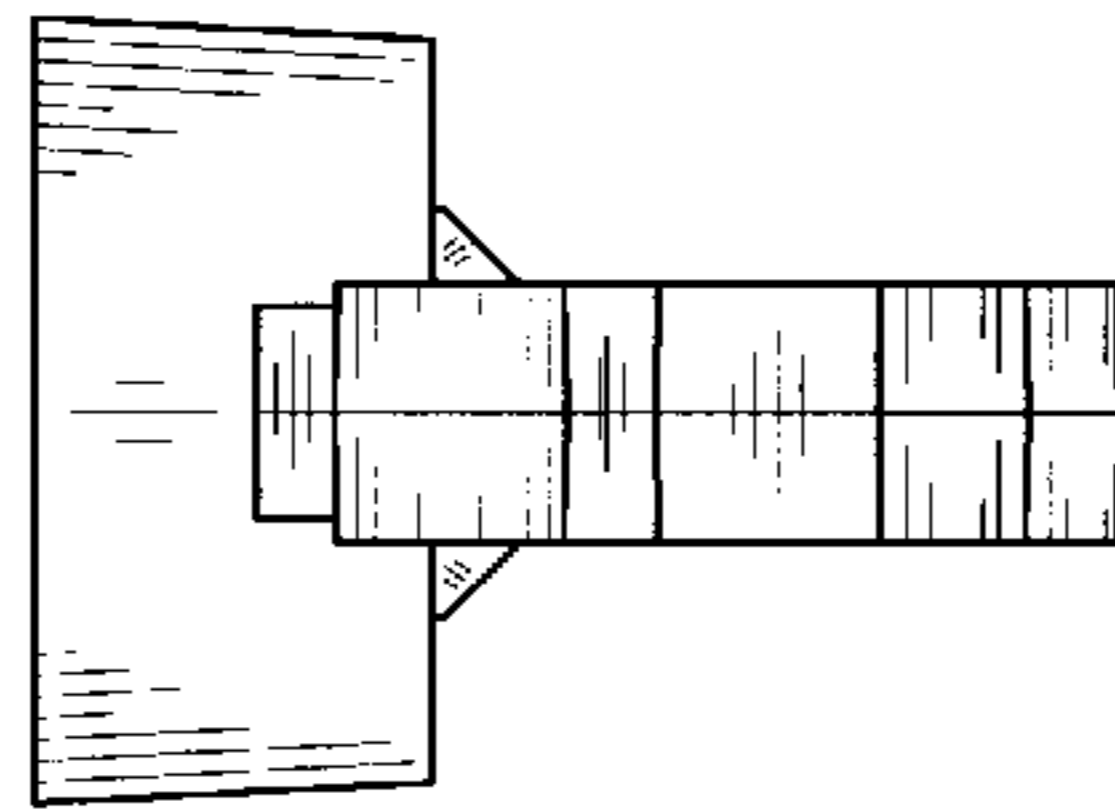

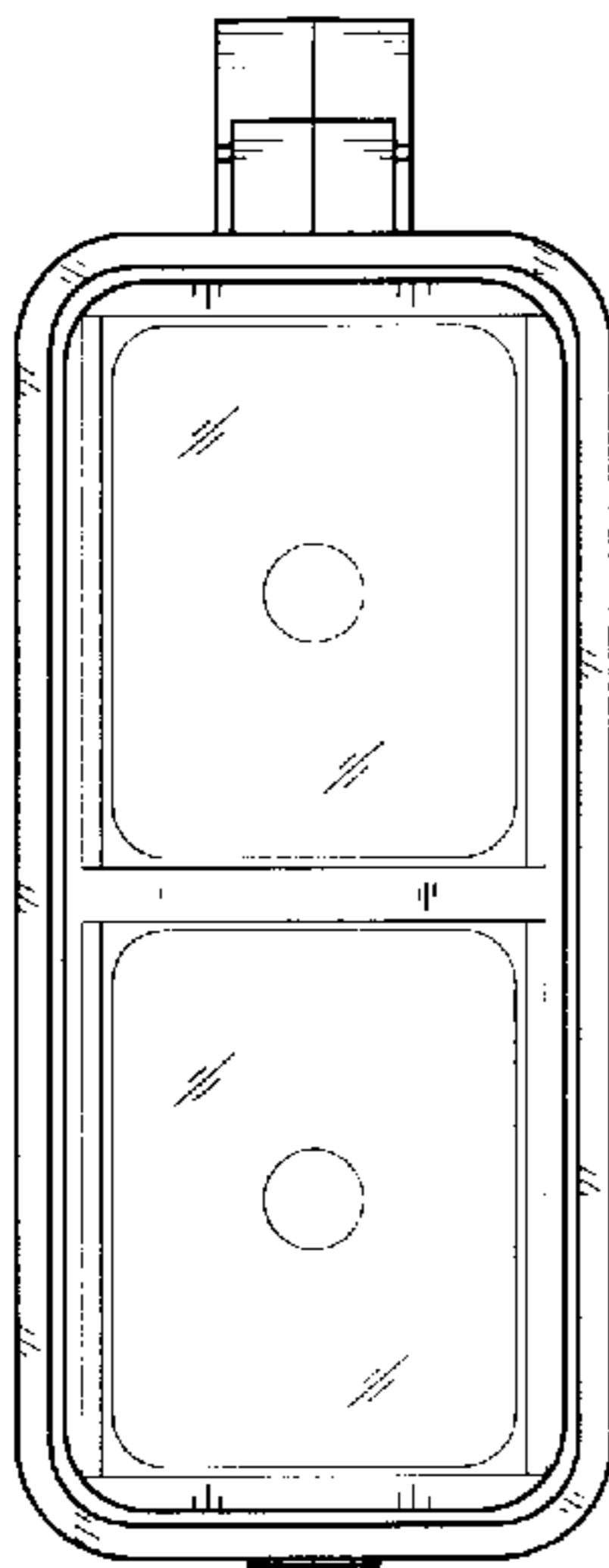

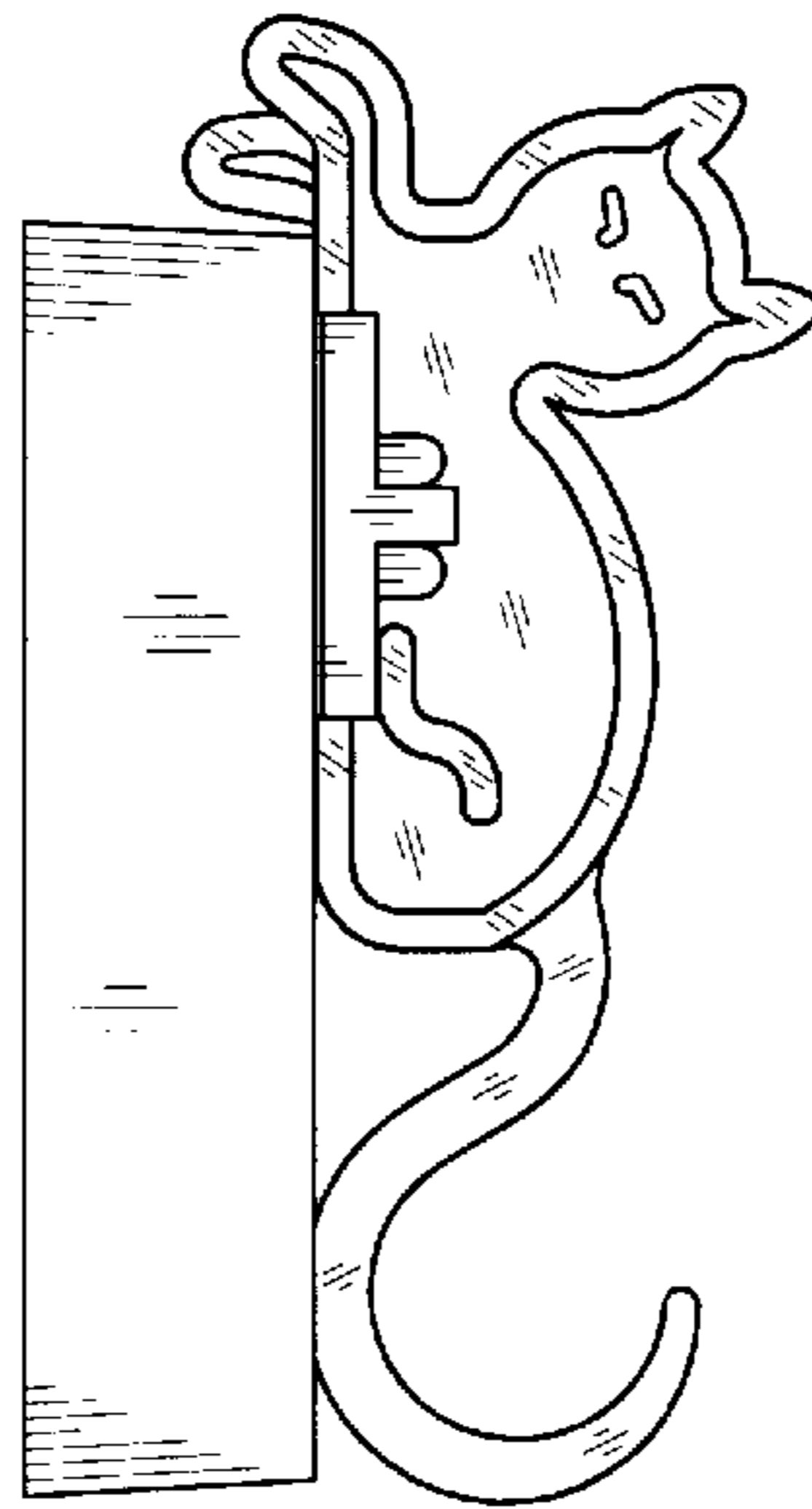

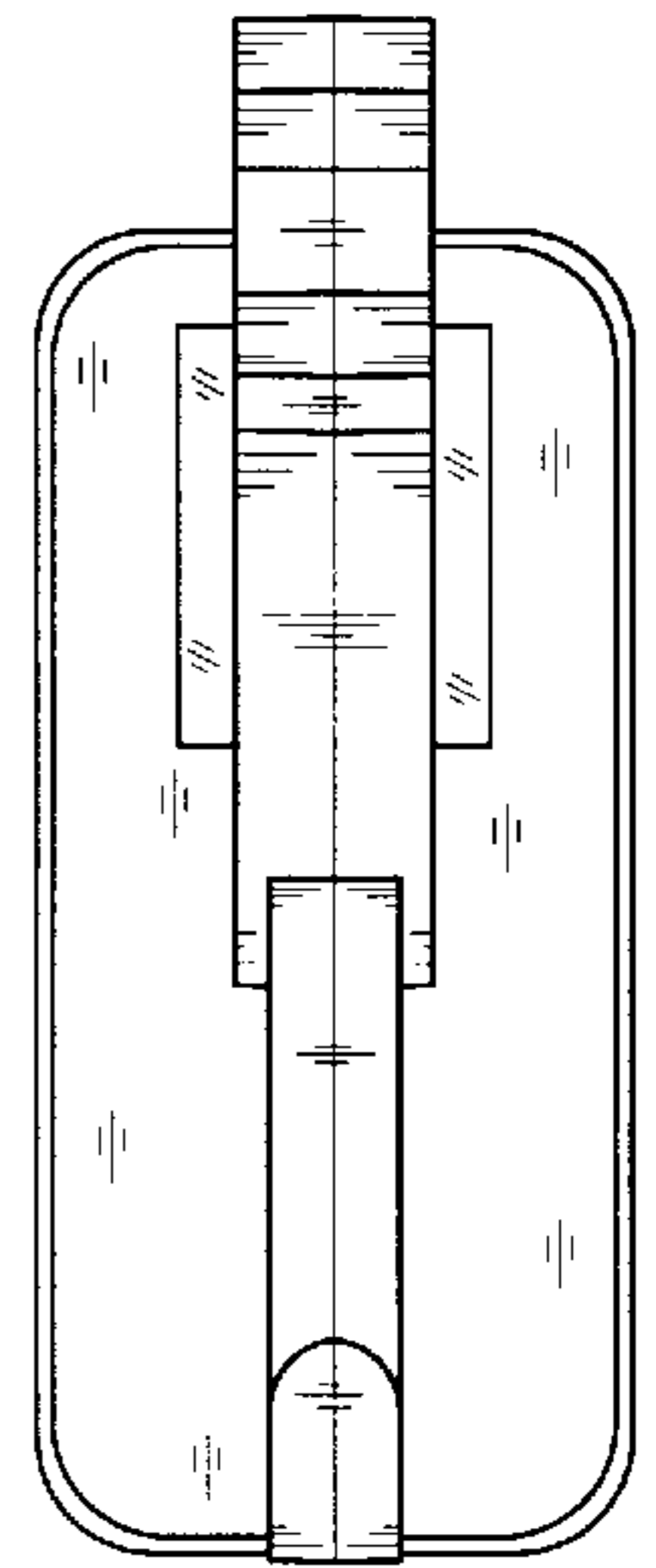

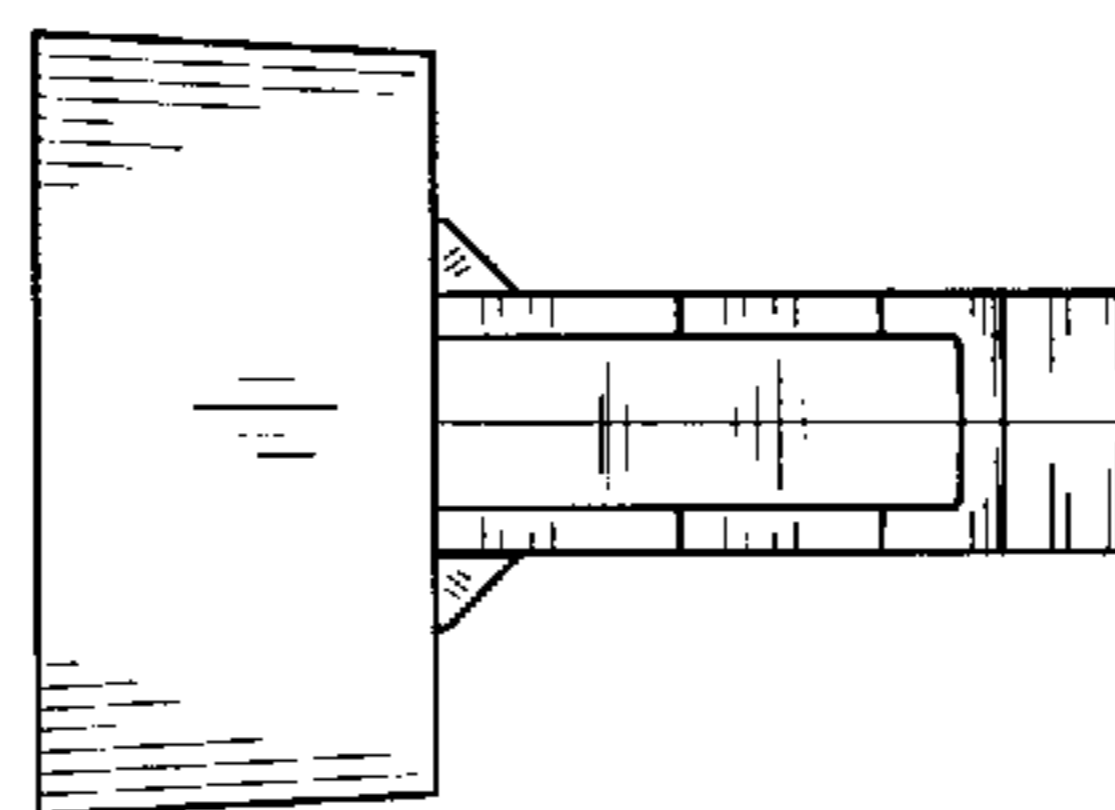

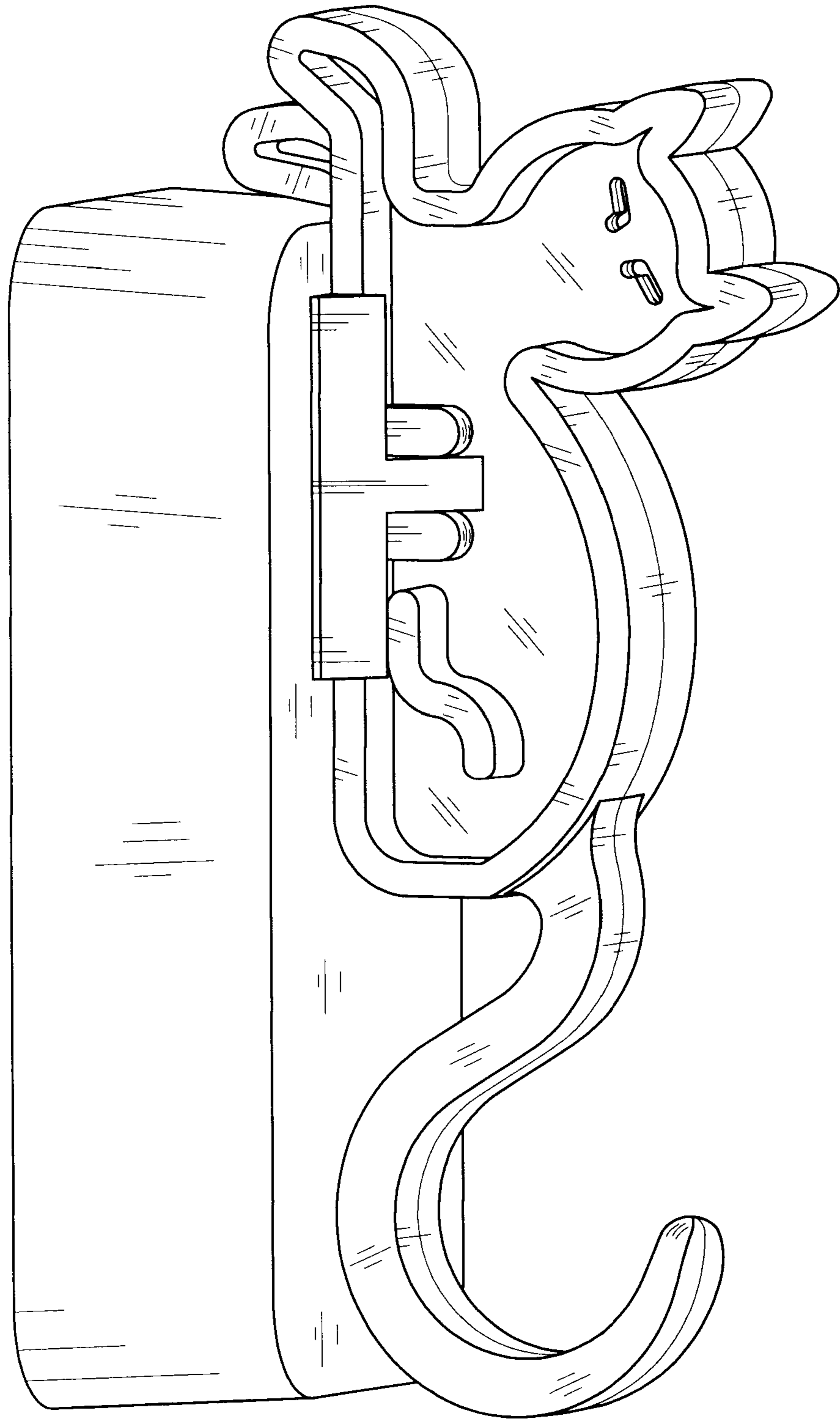
