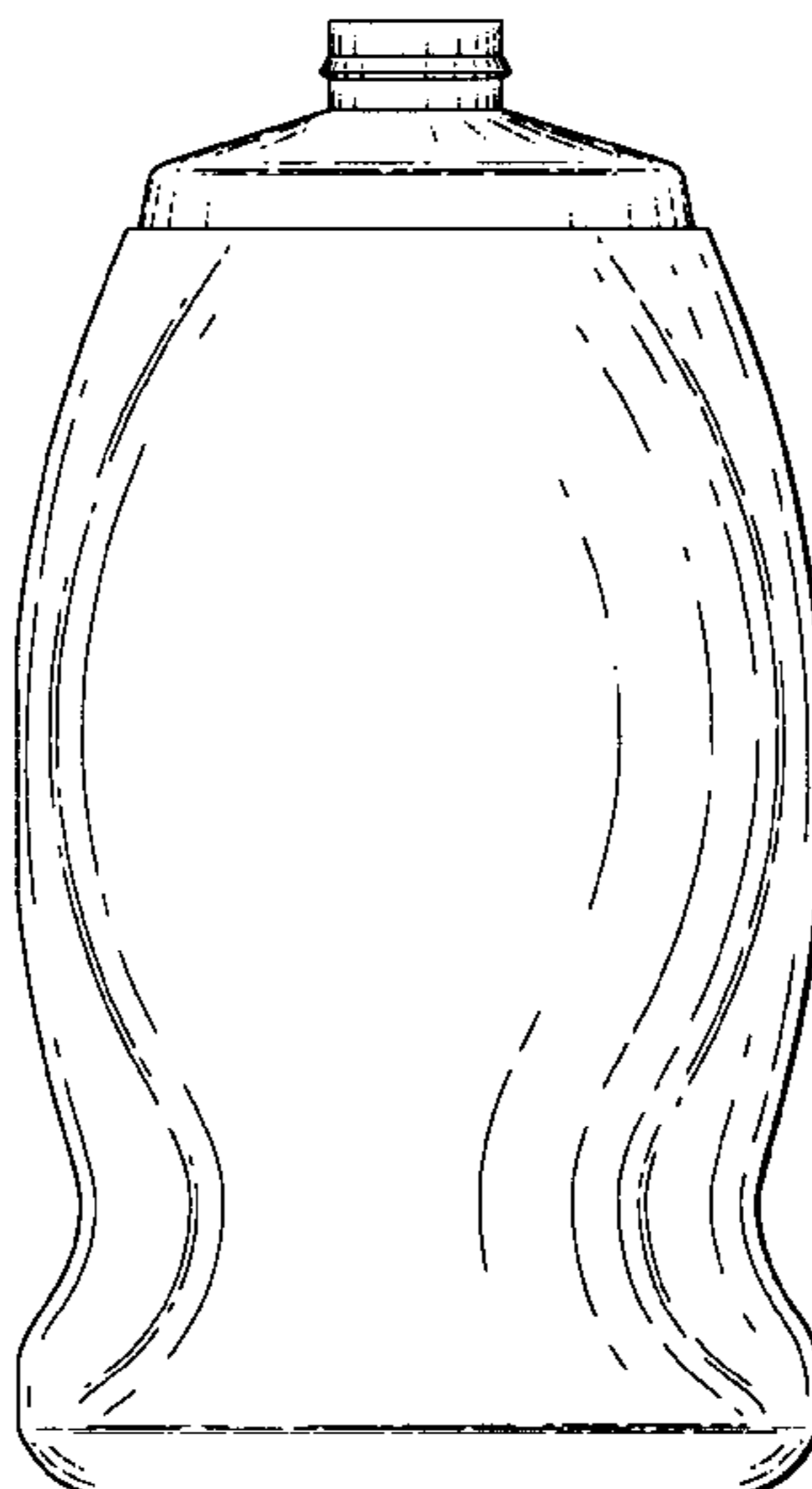
[57] **CLAIM**

The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and left side perspective view of a bottle showing my new design;  
FIG. 2 is an front elevation of a bottle of my new design, the rear elevation being identical thereto;  
FIG. 3 is a side elevation of a bottle showing my design, the opposite side elevation being identical thereto;  
FIG. 4 is a top plan view of a bottle showing my new design;  
FIG. 5 is a bottom plan view of a bottle showing my new design; and,  
FIG. 6 is a front elevation of a second embodiment of the bottle, the claimed portion of the second embodiment, that extends up to the bottom edge of the unclaimed cap, is the same as the corresponding portion of the first embodiment. The broken lines shown in FIG. 6 are for illustrative purposes only and do not form part of the claimed design.

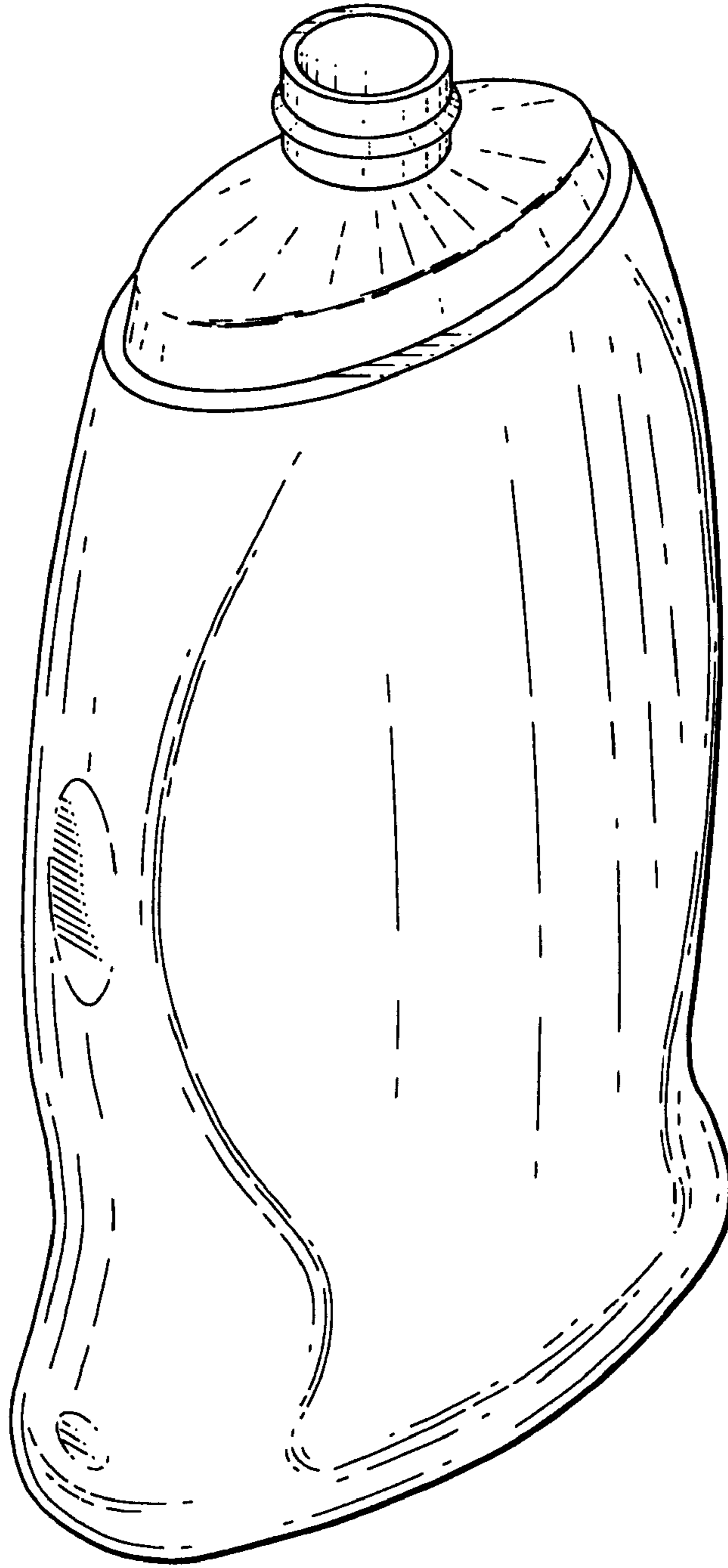

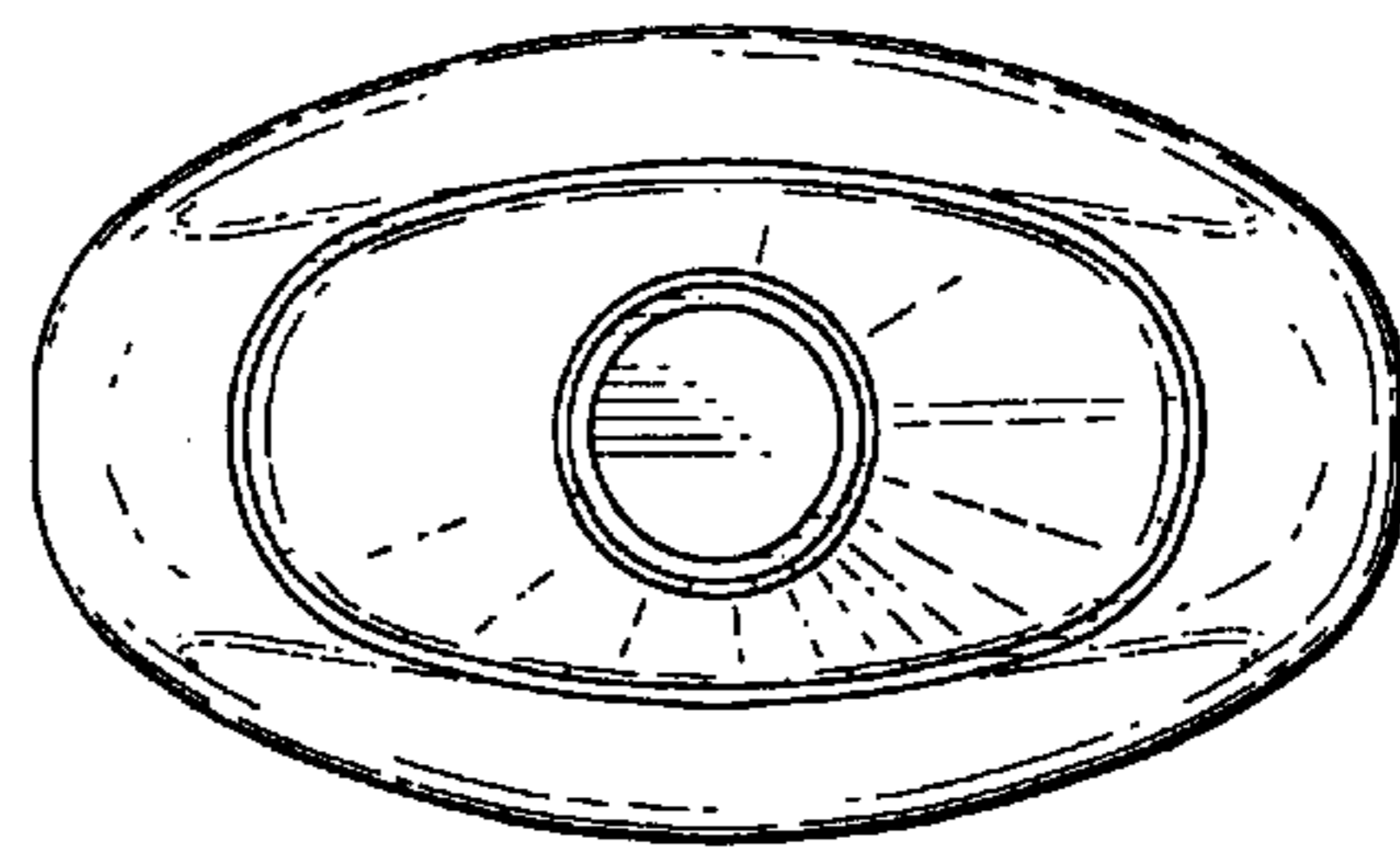

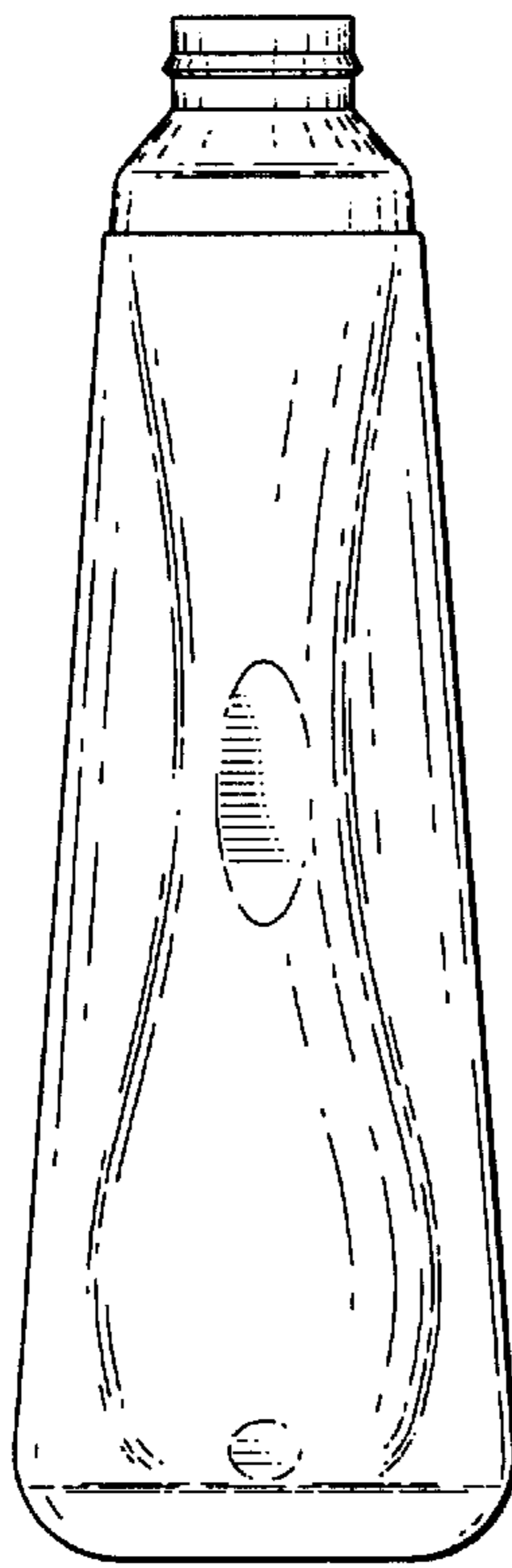

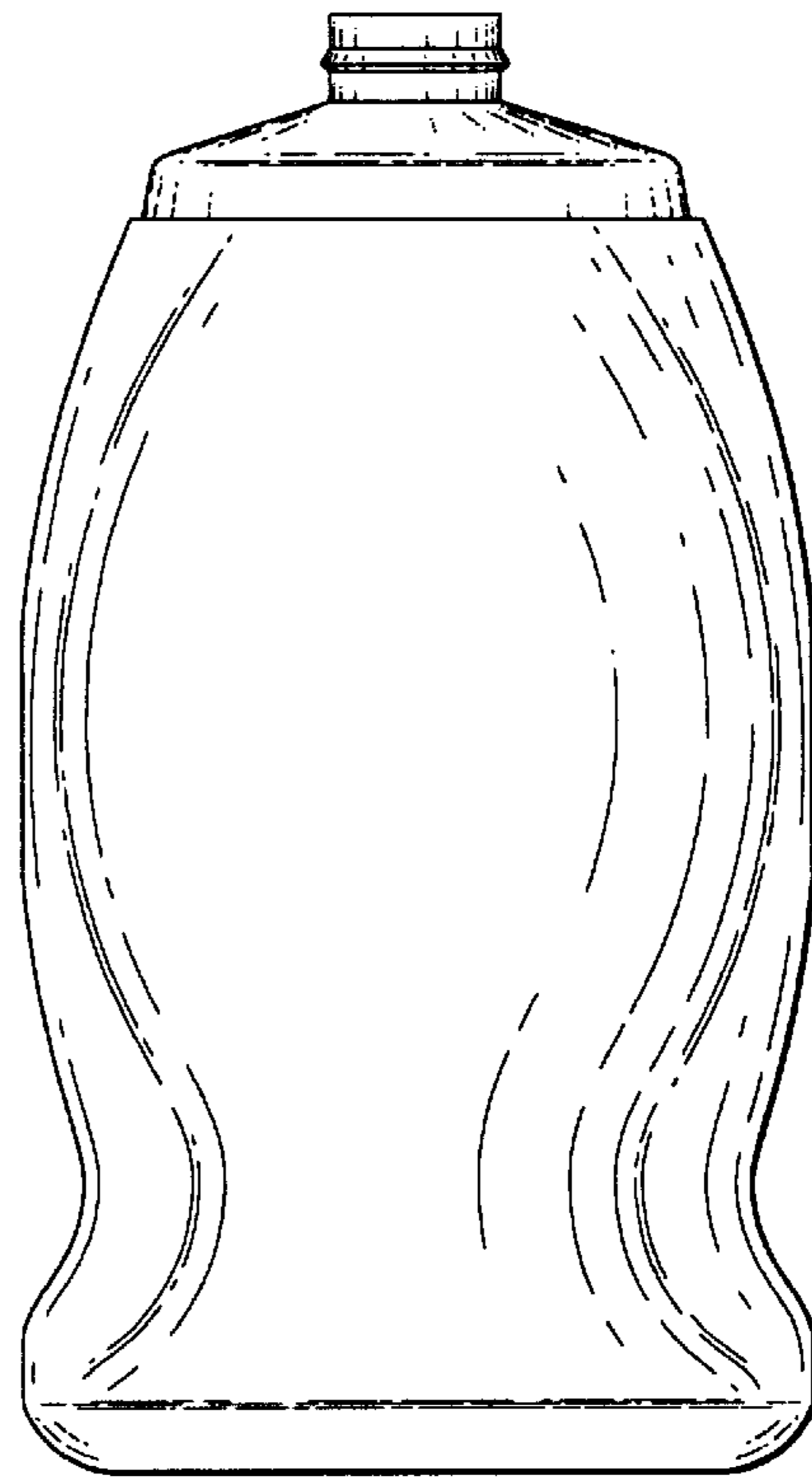

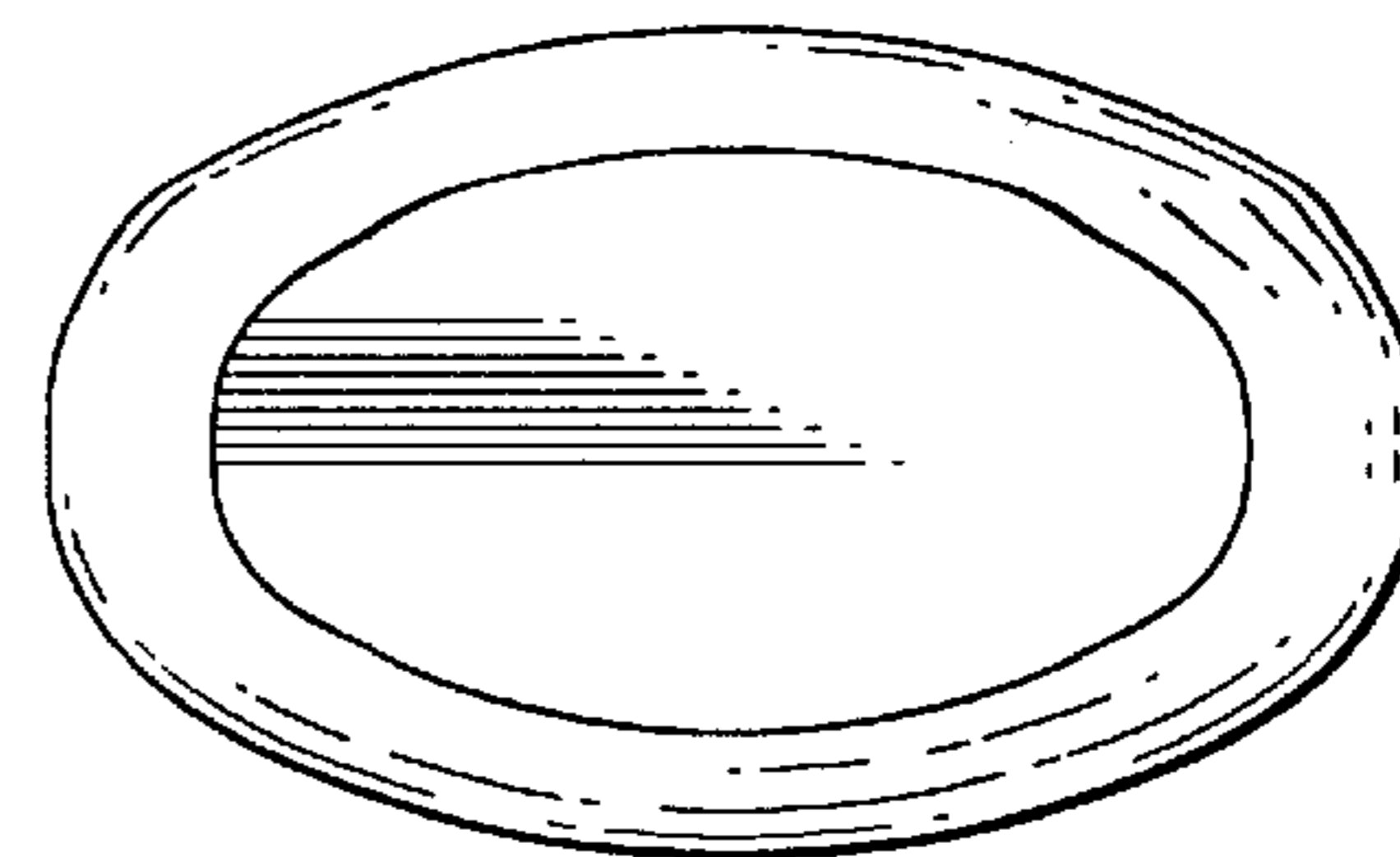

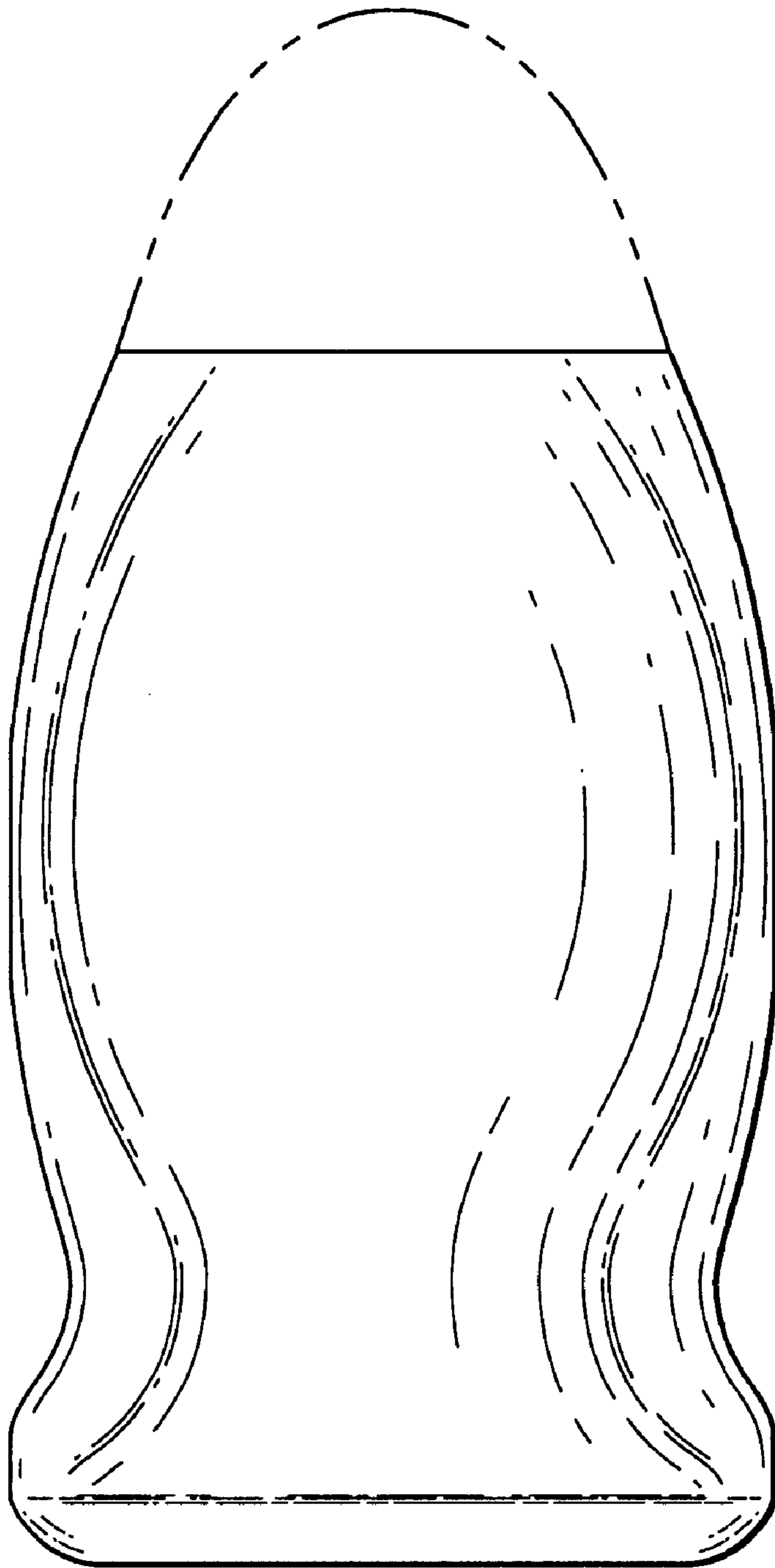
