The ornamental design for a remote controller for video tape recorder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top, front and right side of a remote controller for video tape recorder showing our new design;

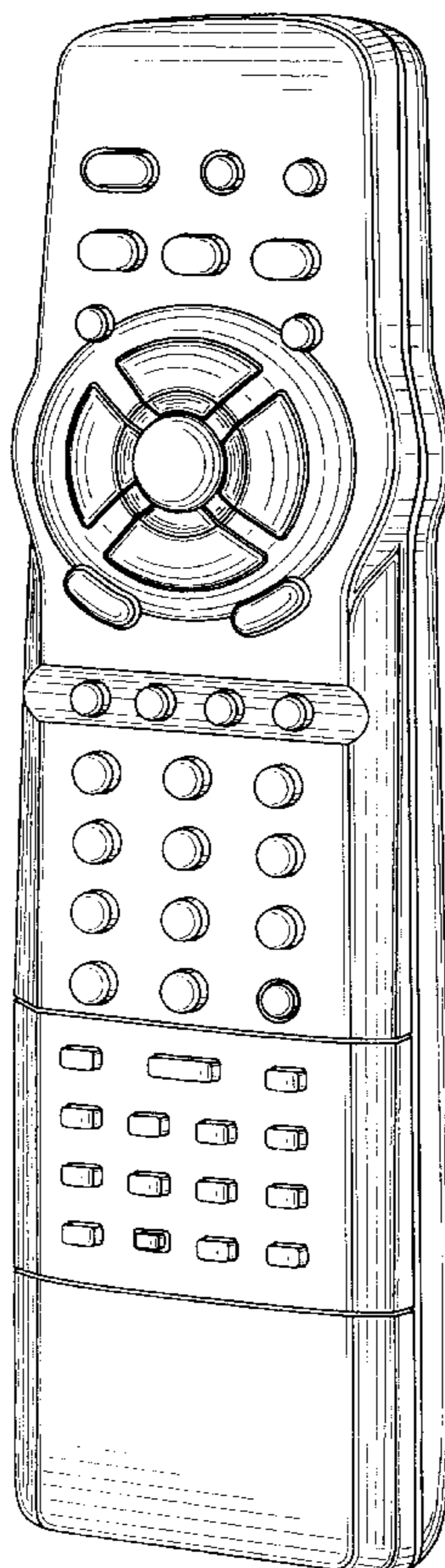

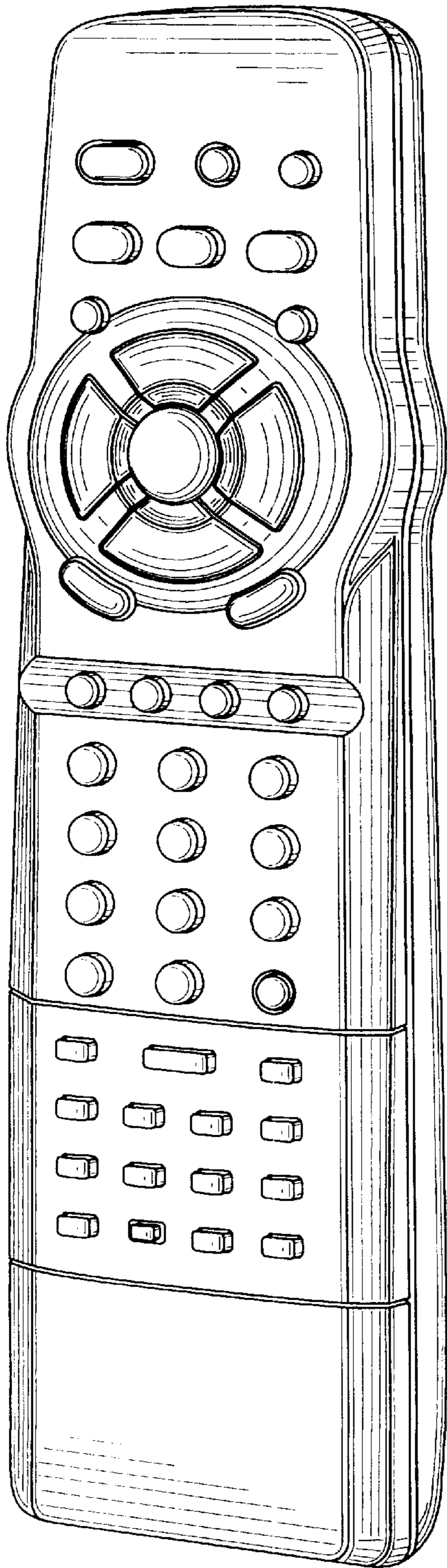

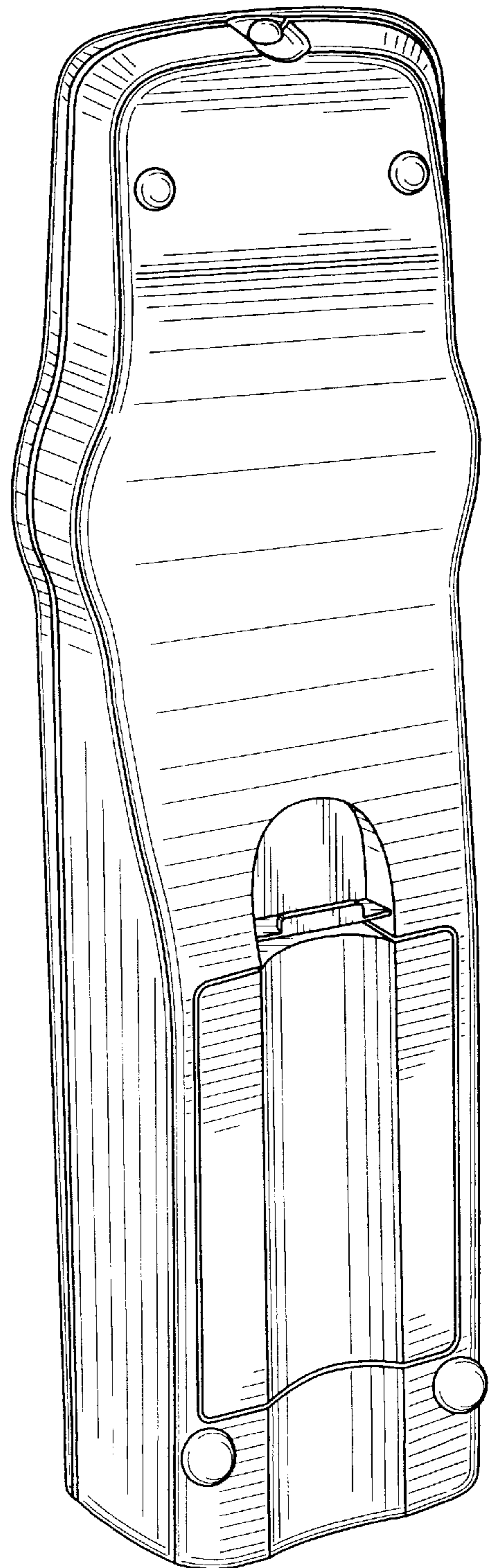

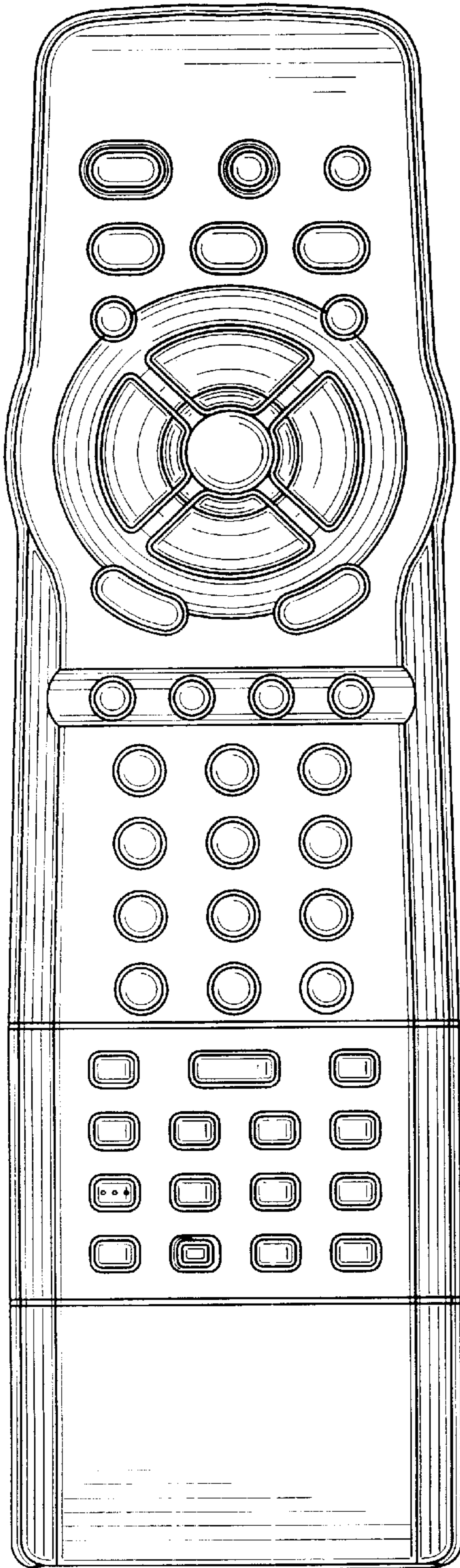

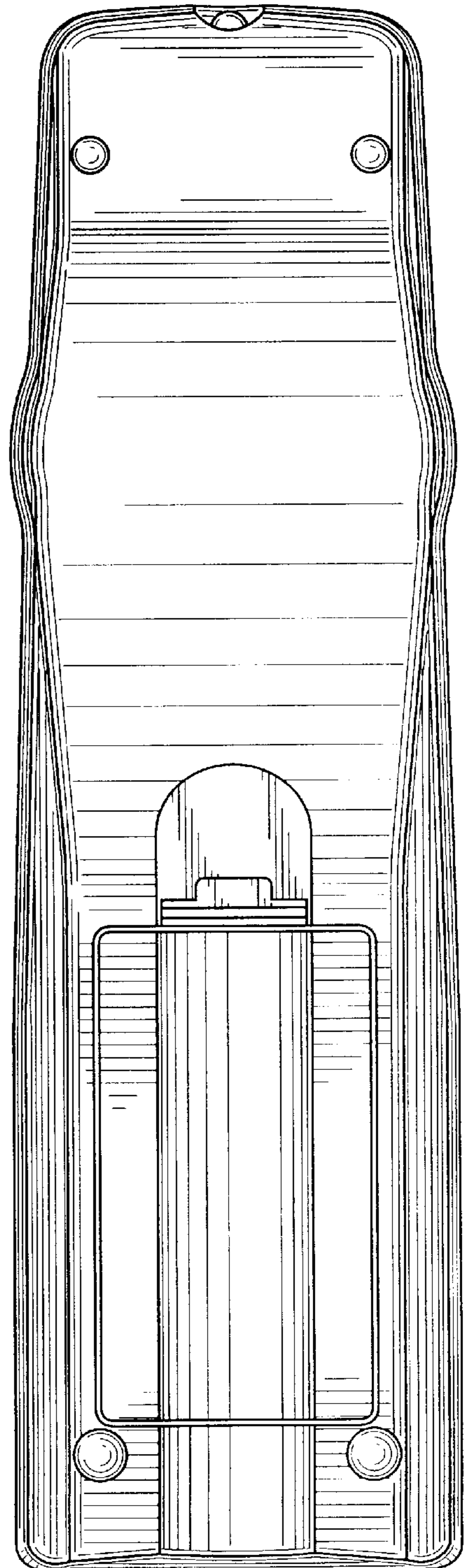

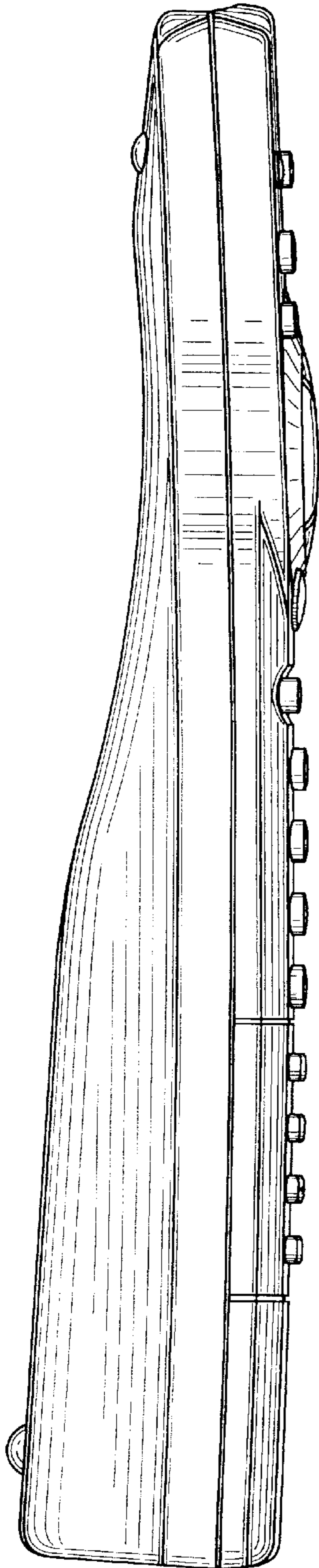

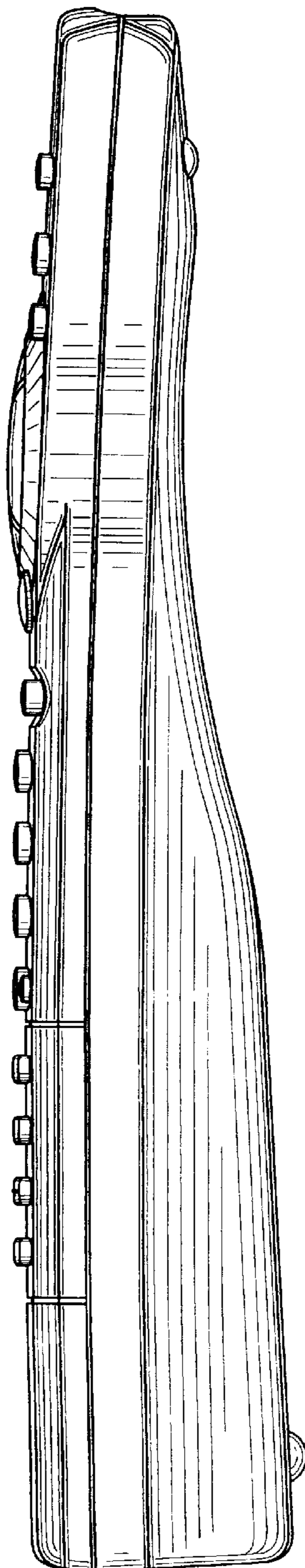

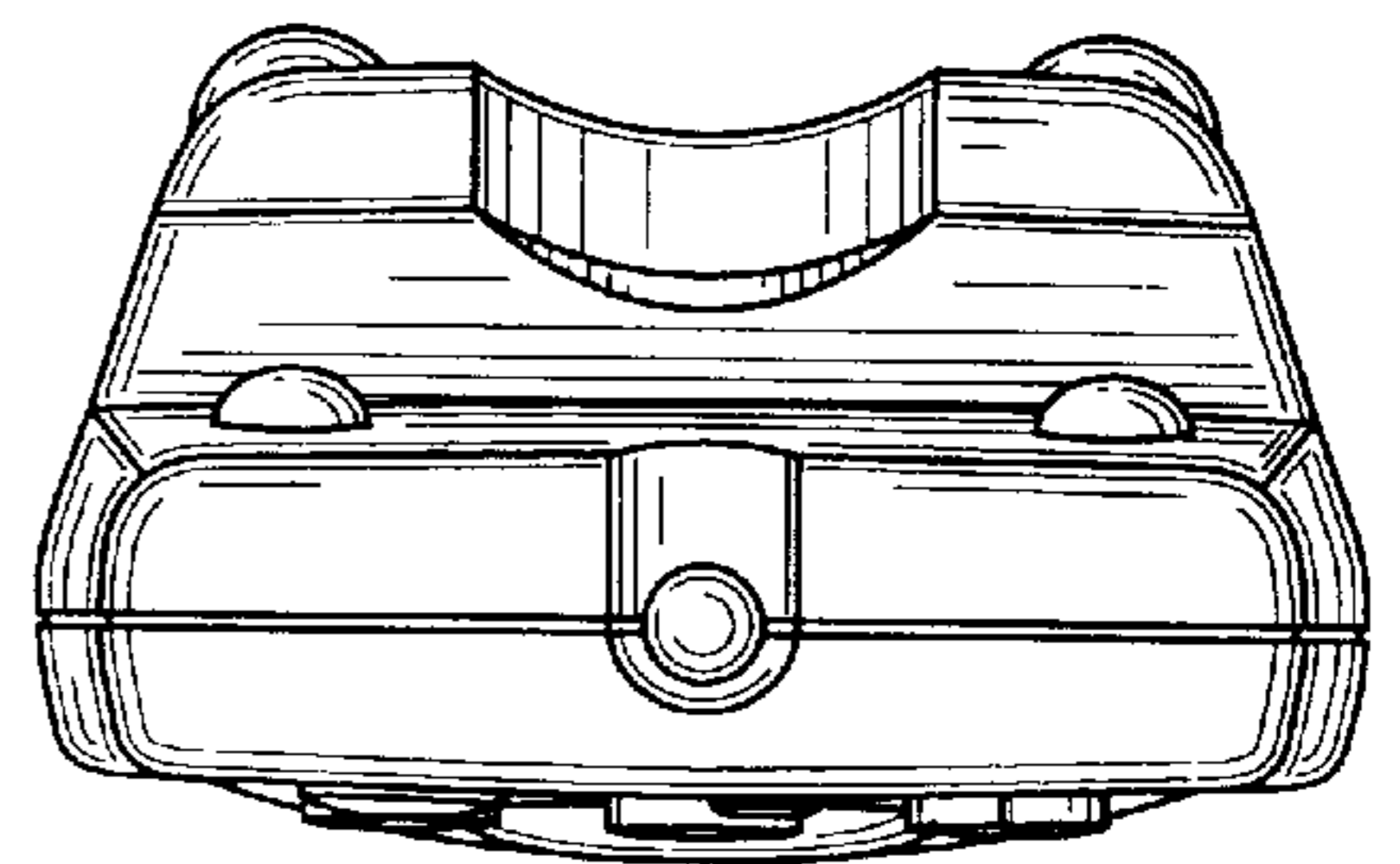
