[57] CLAIM

The ornamental design for a guitar peghead, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a guitar peghead showing my new design;

FIG. 2 is a bottom view thereof;

FIG. 3 is a side view of the guitar peghead viewed from the left side of FIG. 1;

FIG. 4 is a side view of the peghead according to the invention viewed from the right side of FIG. 1;

FIG. 5 is an end view of the guitar peghead viewed from the top of FIG. 1;

FIG. 6 is an end view of the guitar peghead viewed from the bottom of FIG. 1;

FIG. 7 is a top view of another embodiment of the guitar peghead according to the present invention;

FIG. 8 is a bottom view of the guitar peghead shown in FIG. 7;

FIG. 9 is a side view of the guitar peghead viewed from the left in FIG. 7;

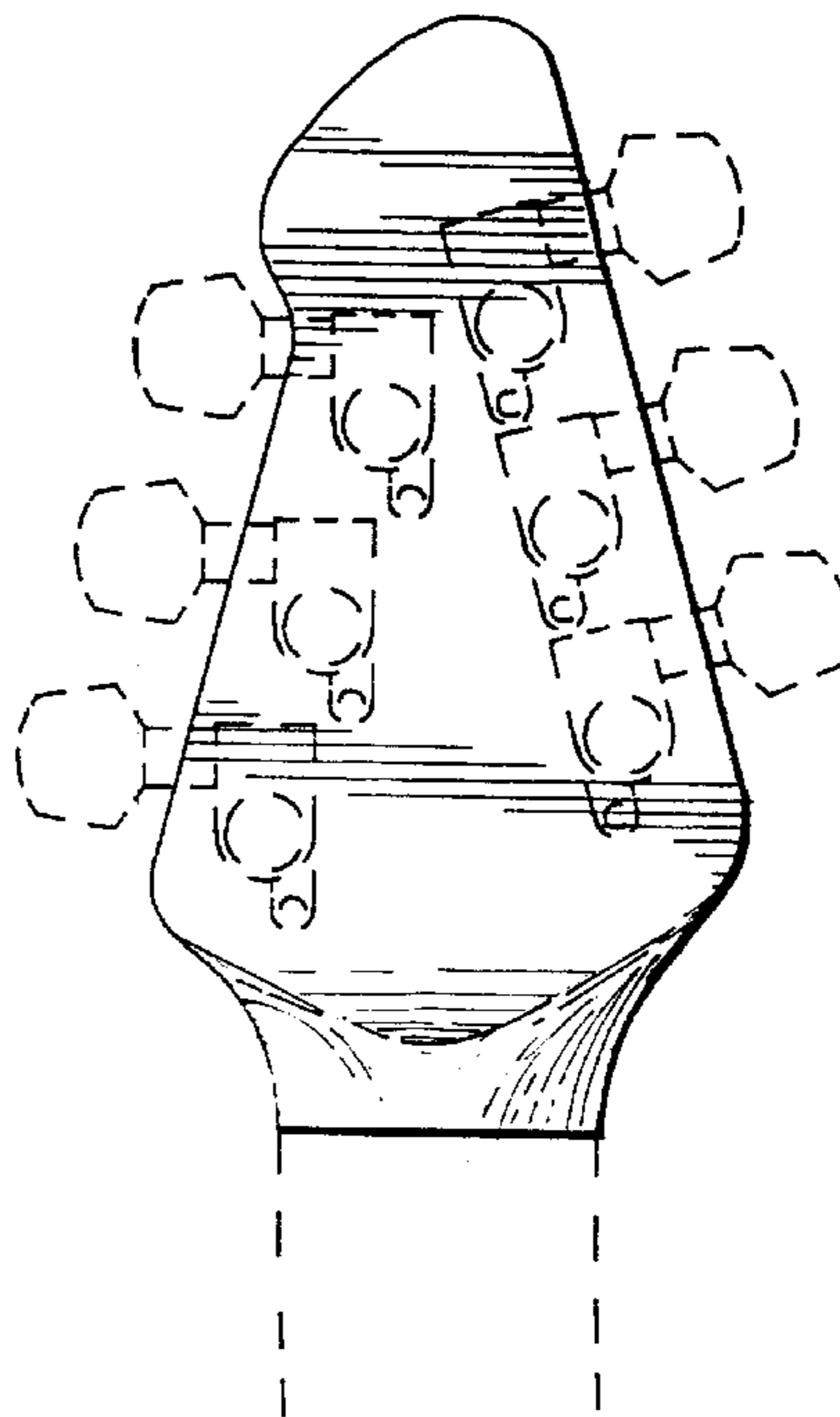
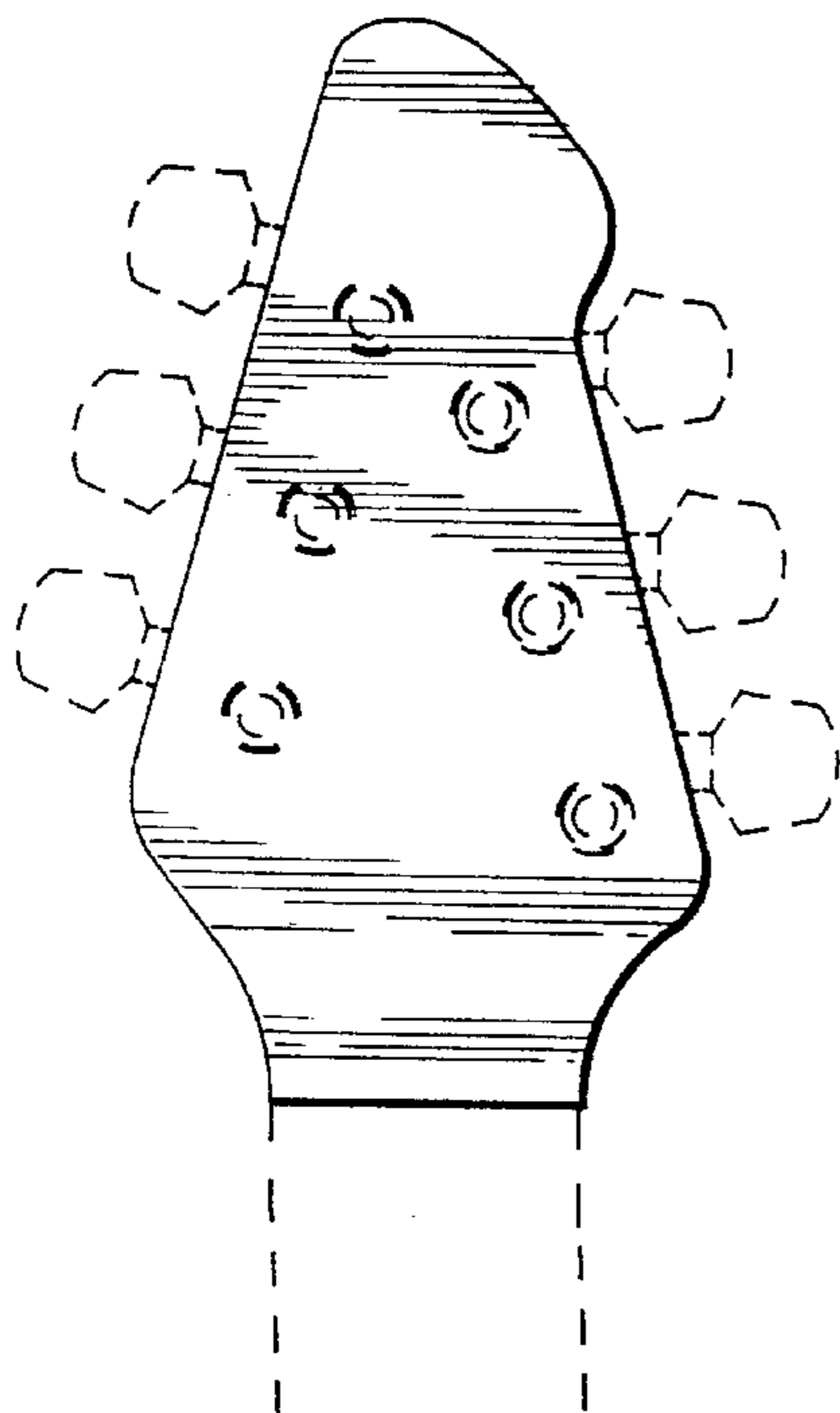
FIG. 10 is a side view of the guitar peghead viewed from the right in FIG. 7;

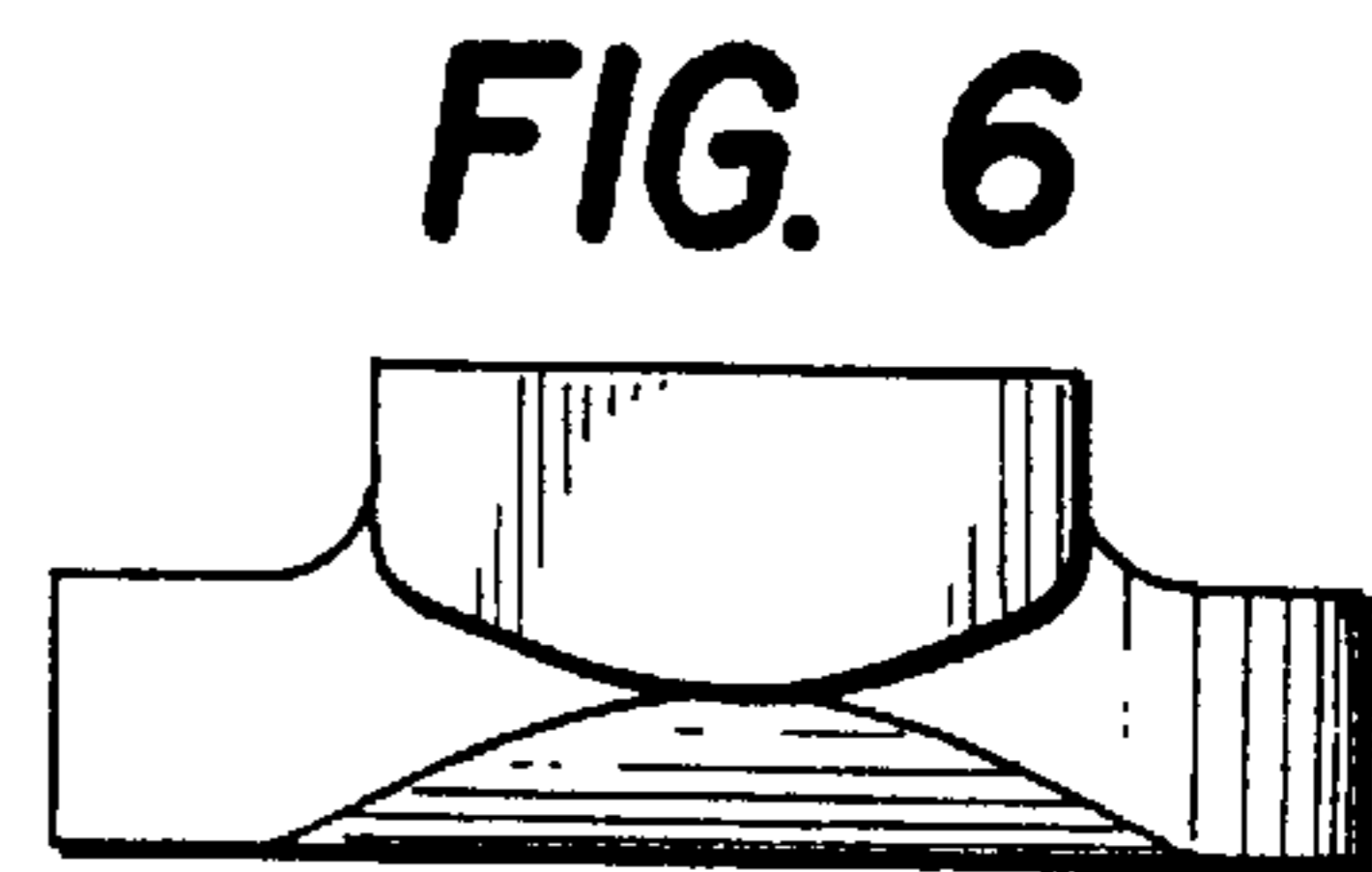
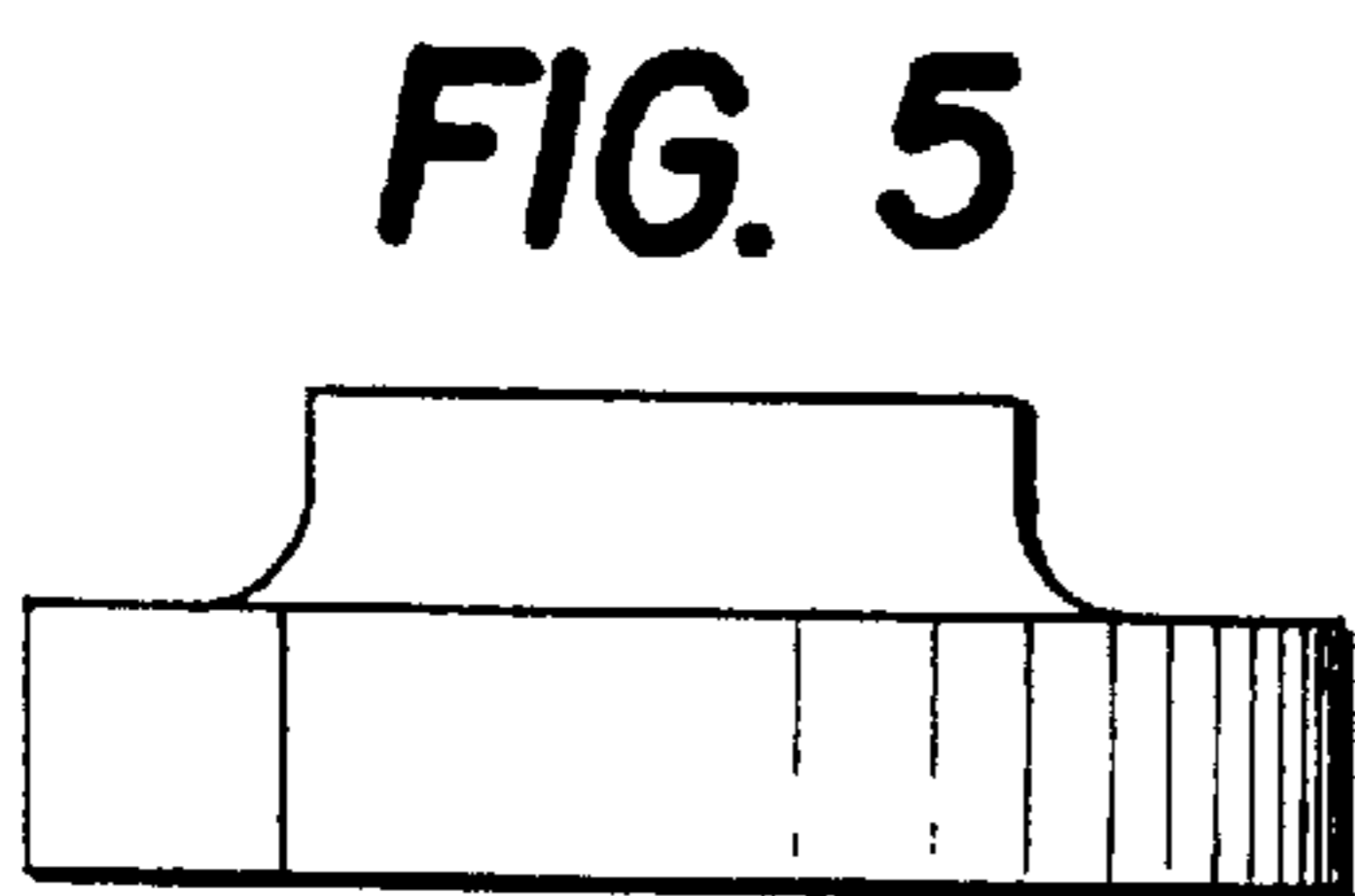
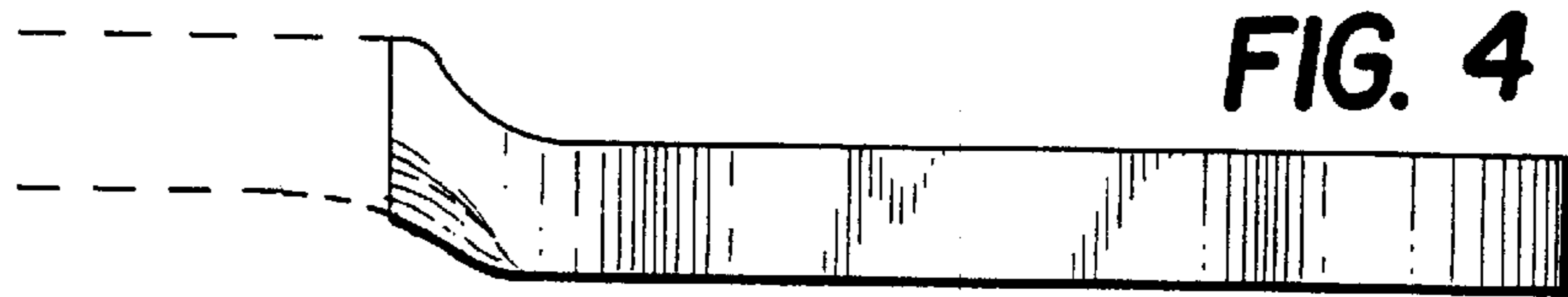
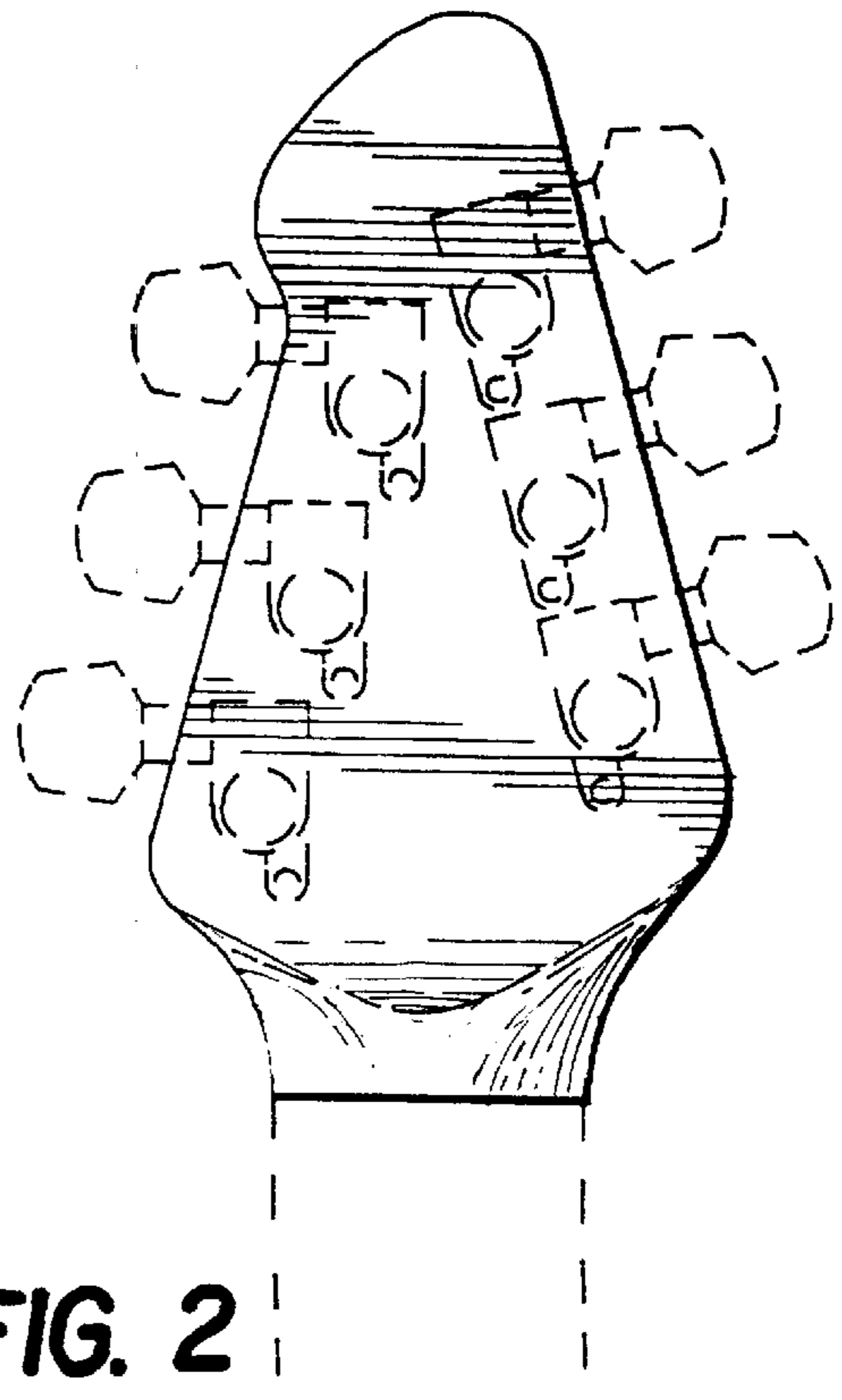
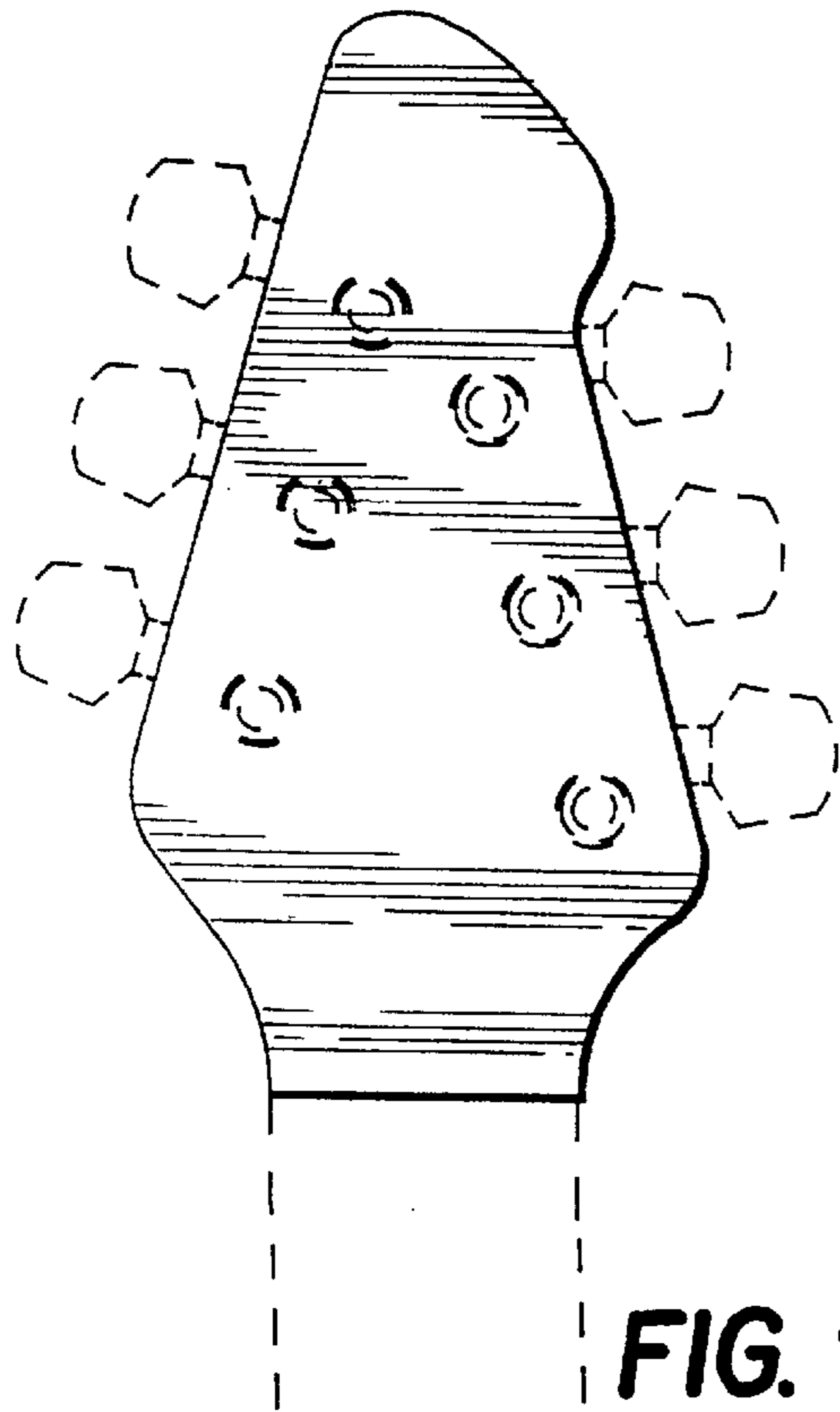
FIG. 11 is an end view of the guitar peghead viewed from the top of FIG. 7; and,

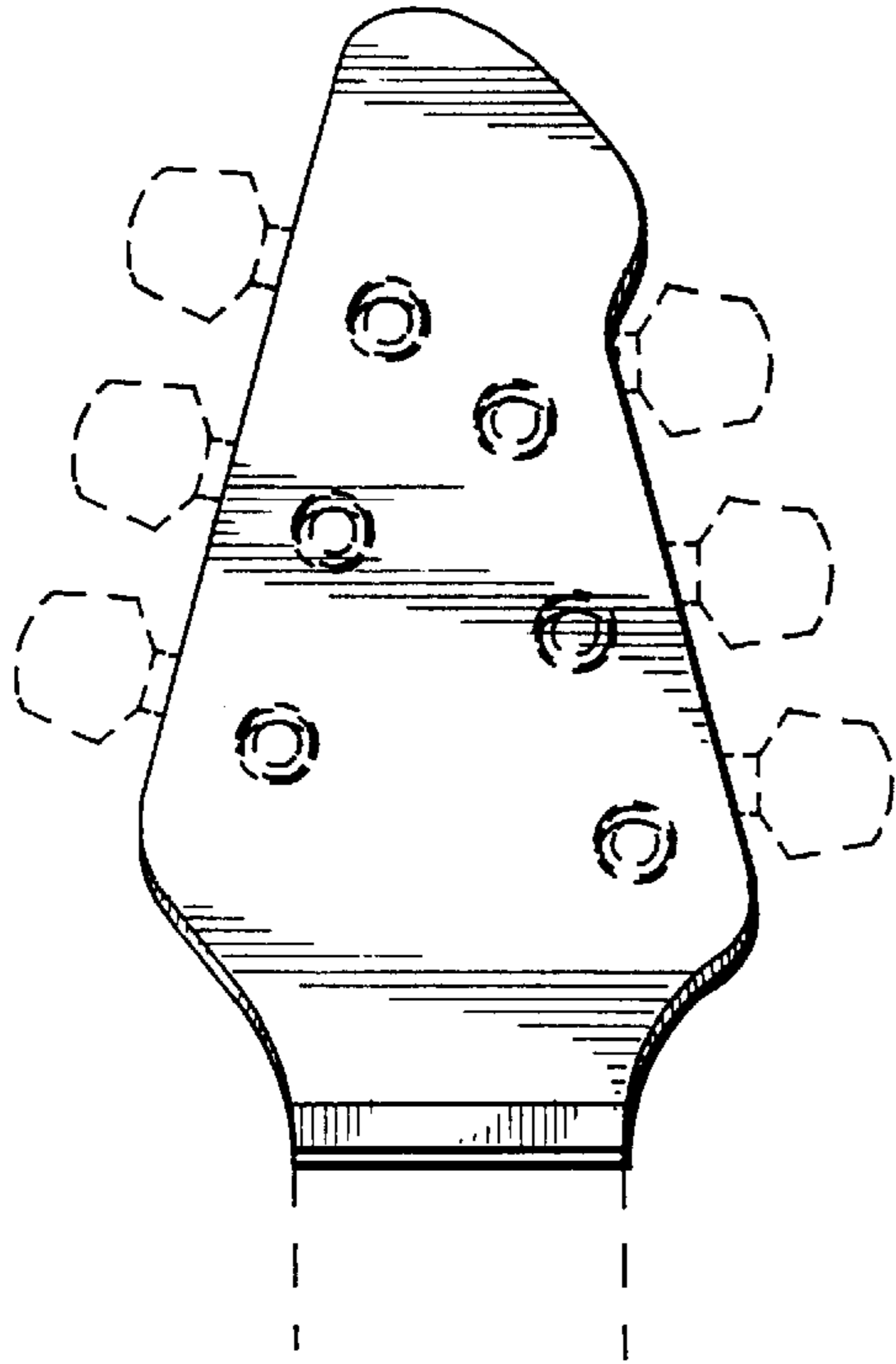

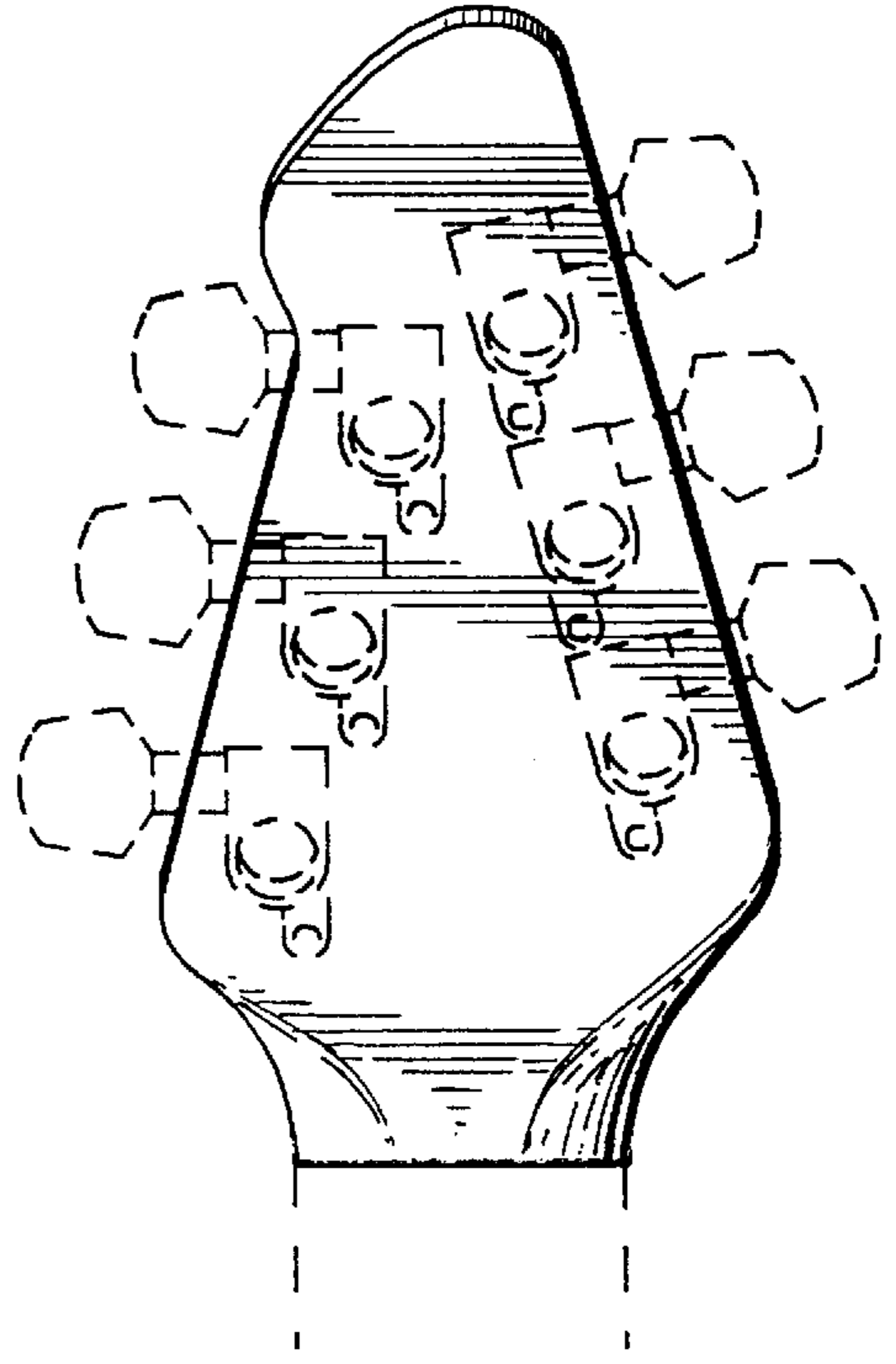

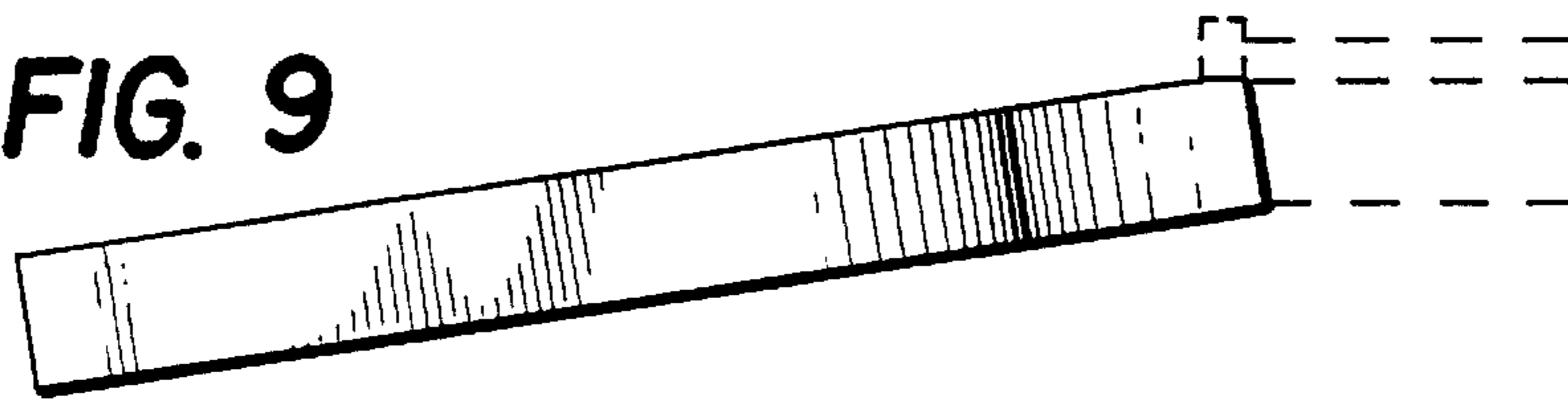

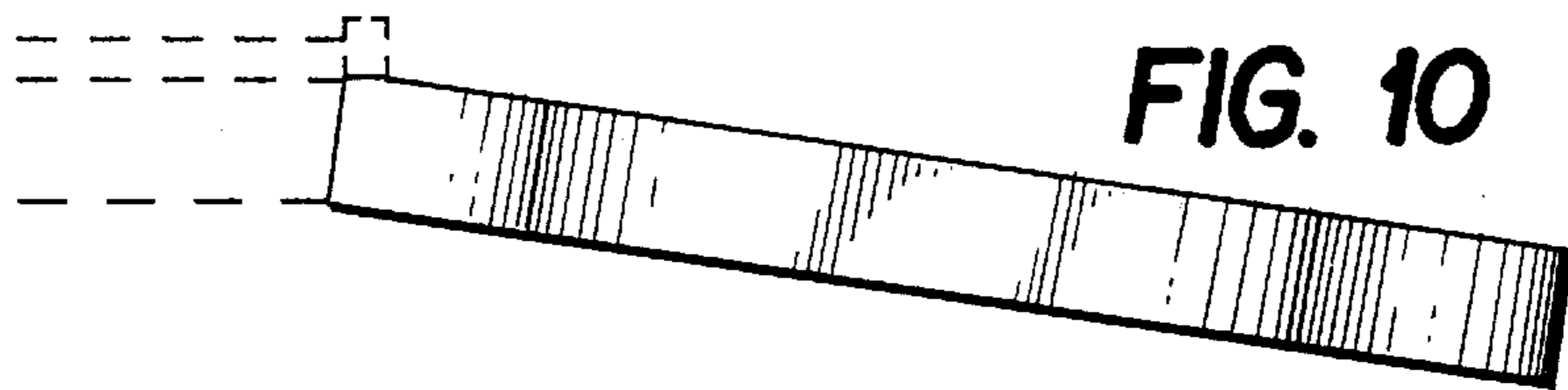

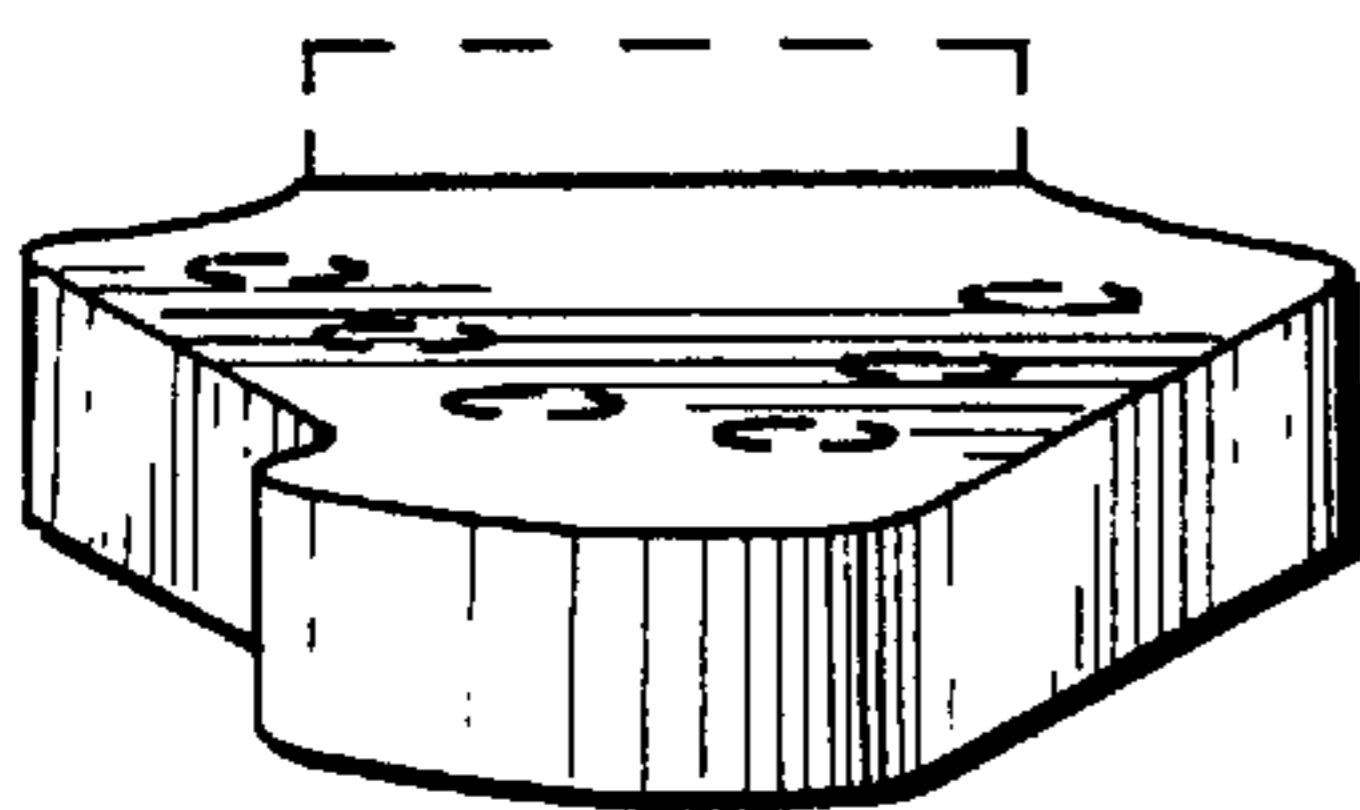
