[57] **CLAIM**

The ornamental design for a butt portion of a "roofing shingle", as shown and described.

DESCRIPTION

FIG. 26 is a top plan view of a twenty sixth embodiment of the butt portion of a roofing shingle;

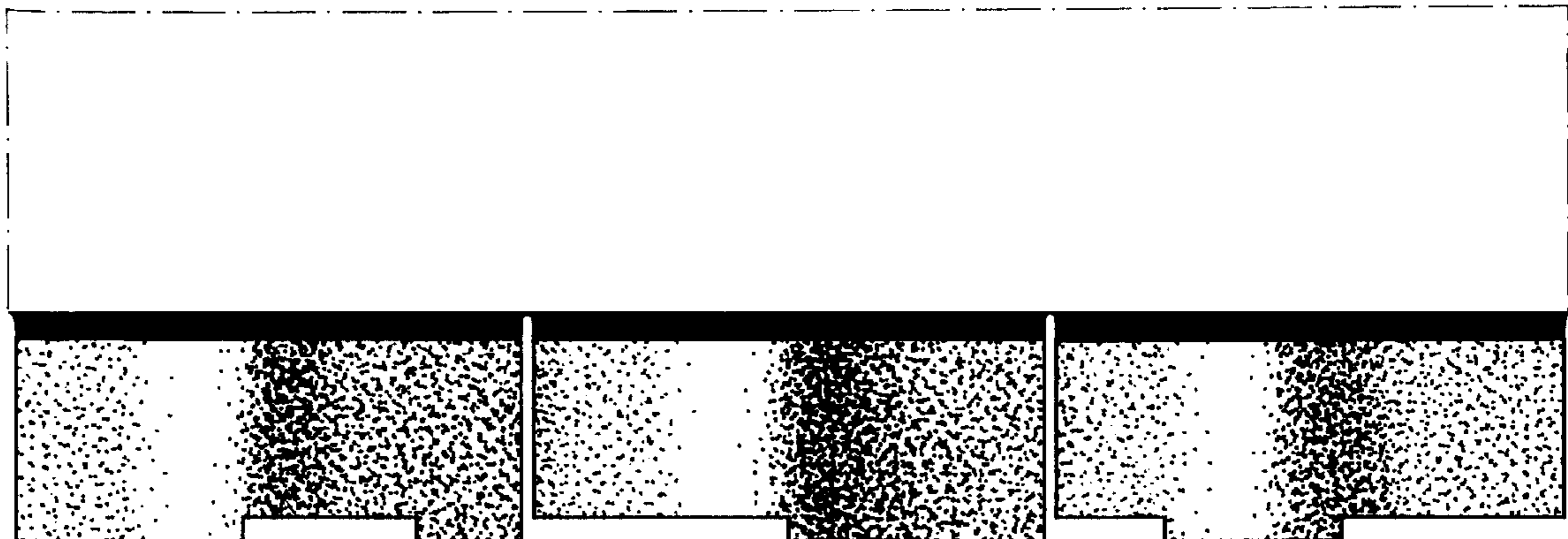


FIG. 27 is a top plan view of a twenty seventh embodiment of the butt portion of a roofing shingle;

The dot-dash lines of the various drawing figures indicate a partial outline of the shingle and which partial outline constitutes environmental structure not forming any part of the present design. The rear elevational view of the butt portion of a roofing shingle is plain and unornamented and forms no part of the present design. The butt portion of a roofing shingle is of conventional thickness, exaggerated in the views for ease of illustration.

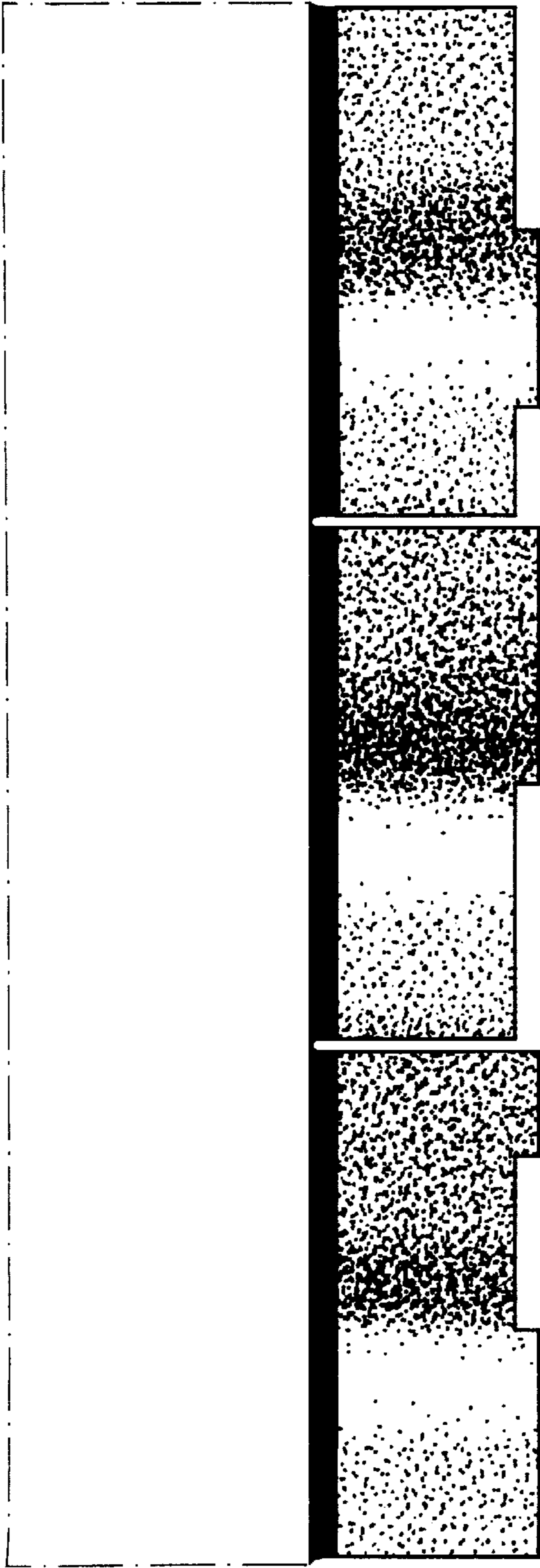

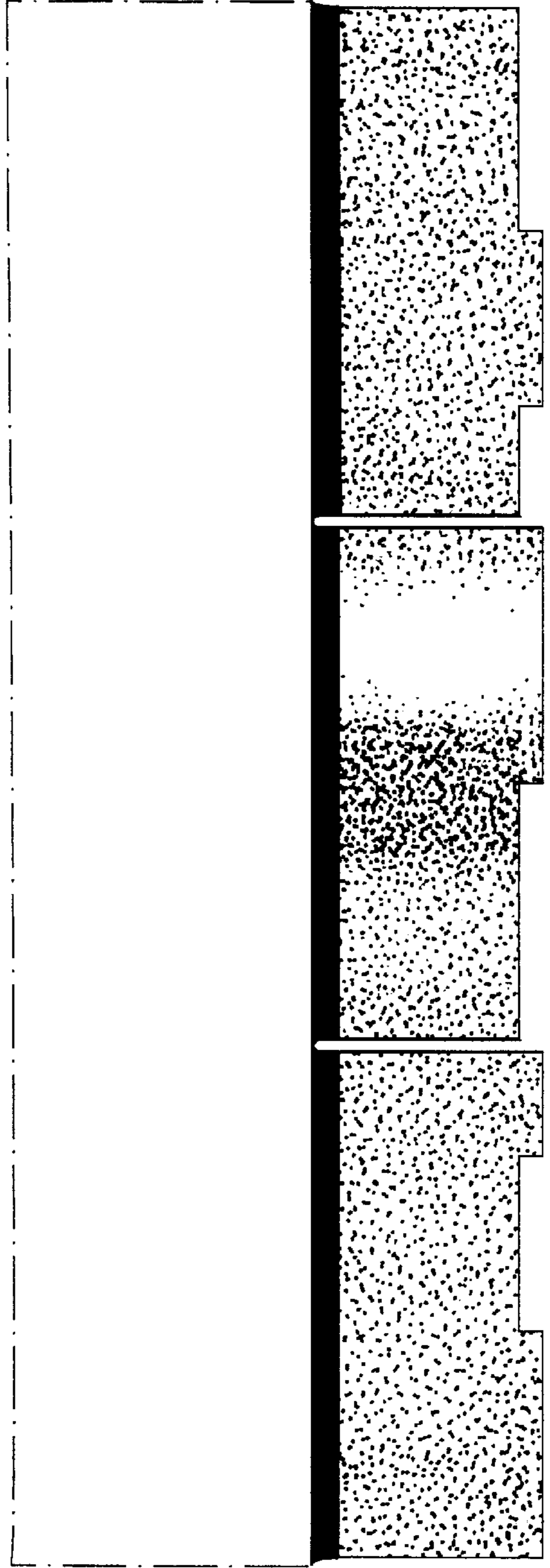

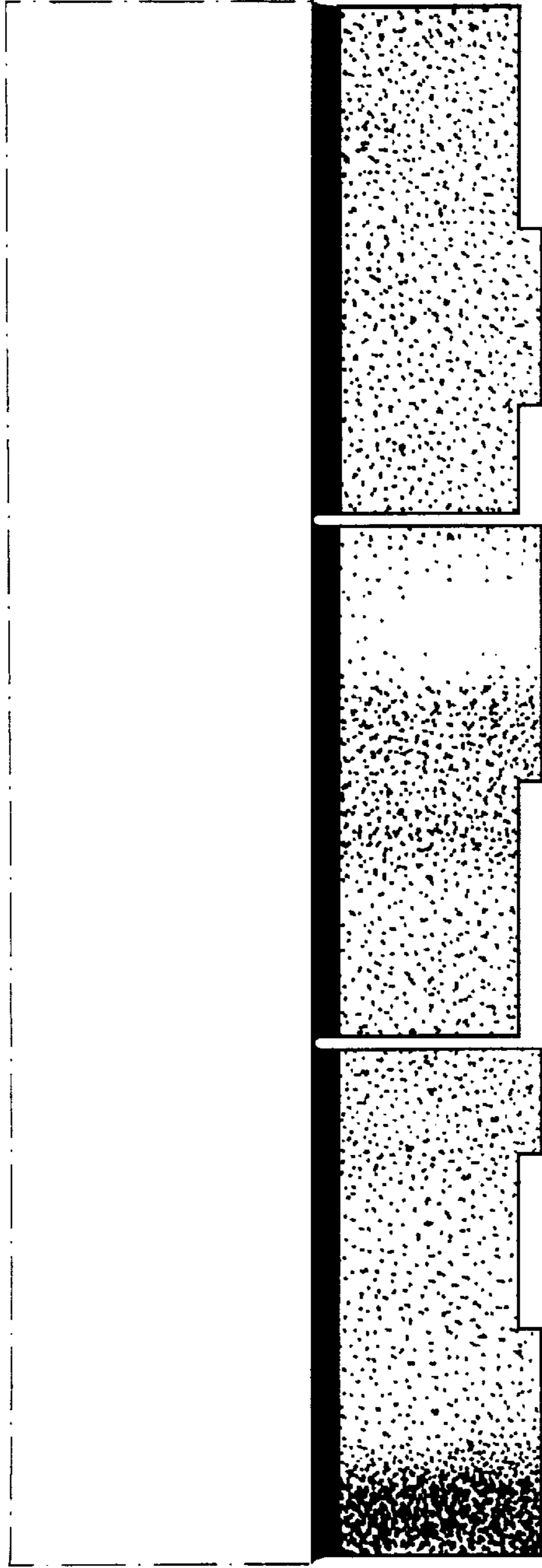

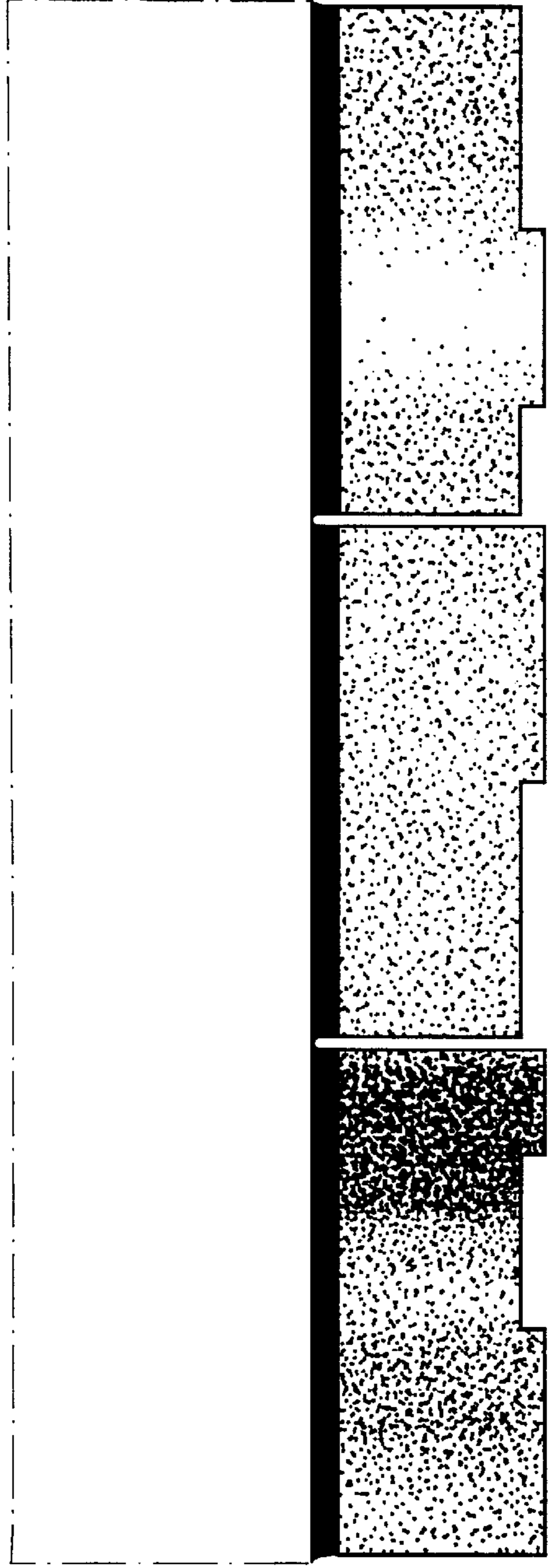

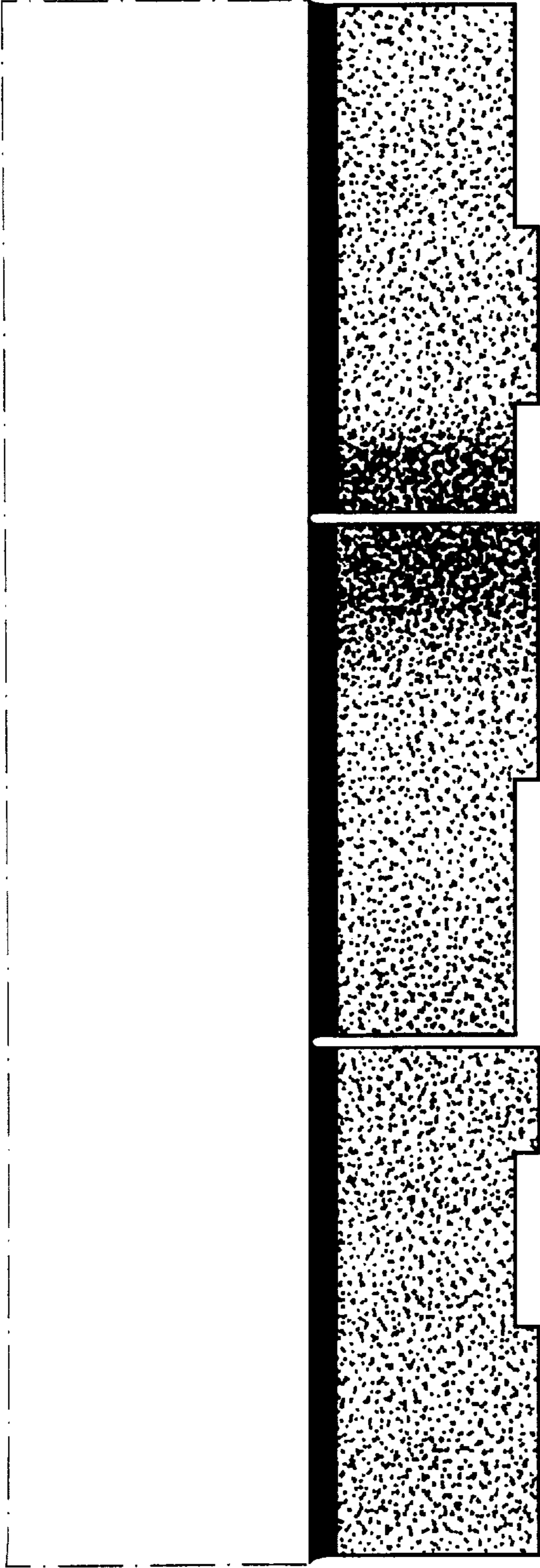

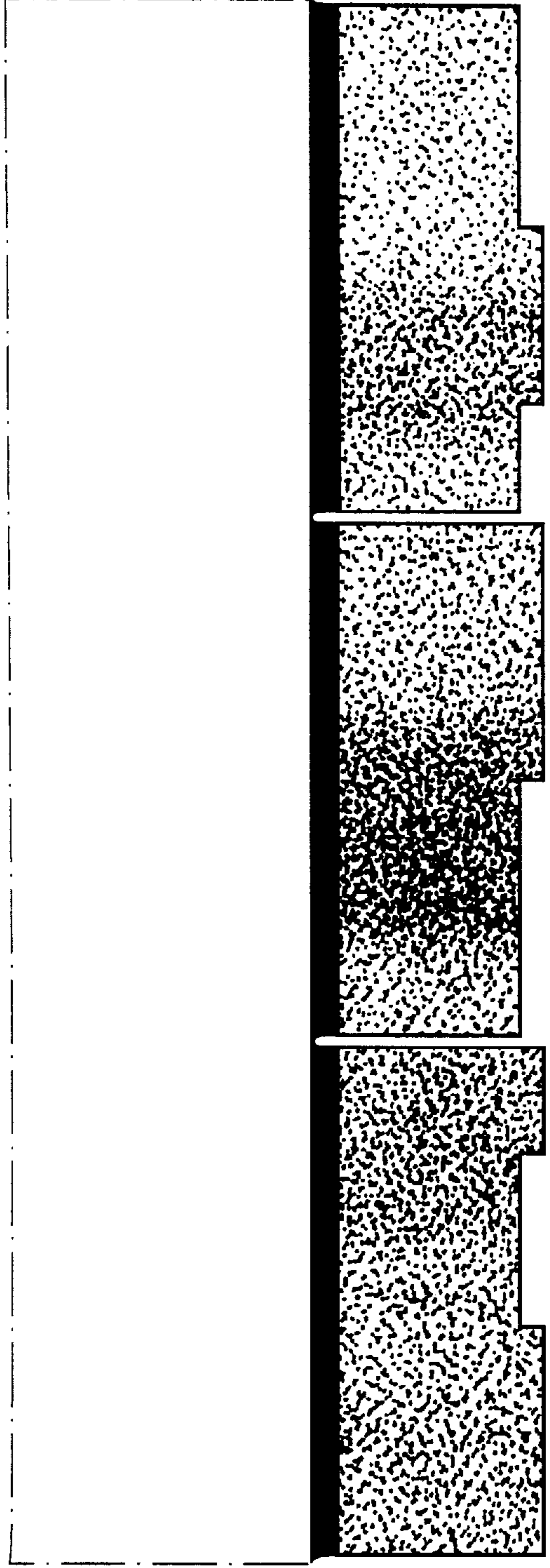

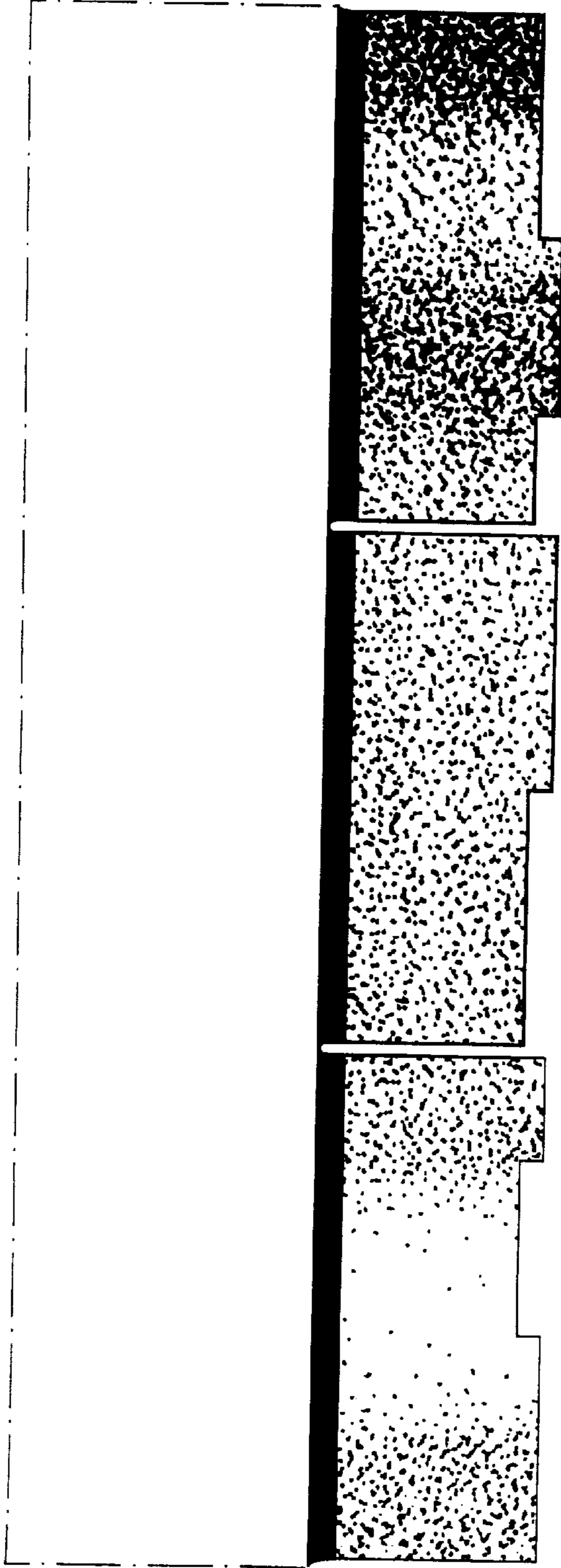

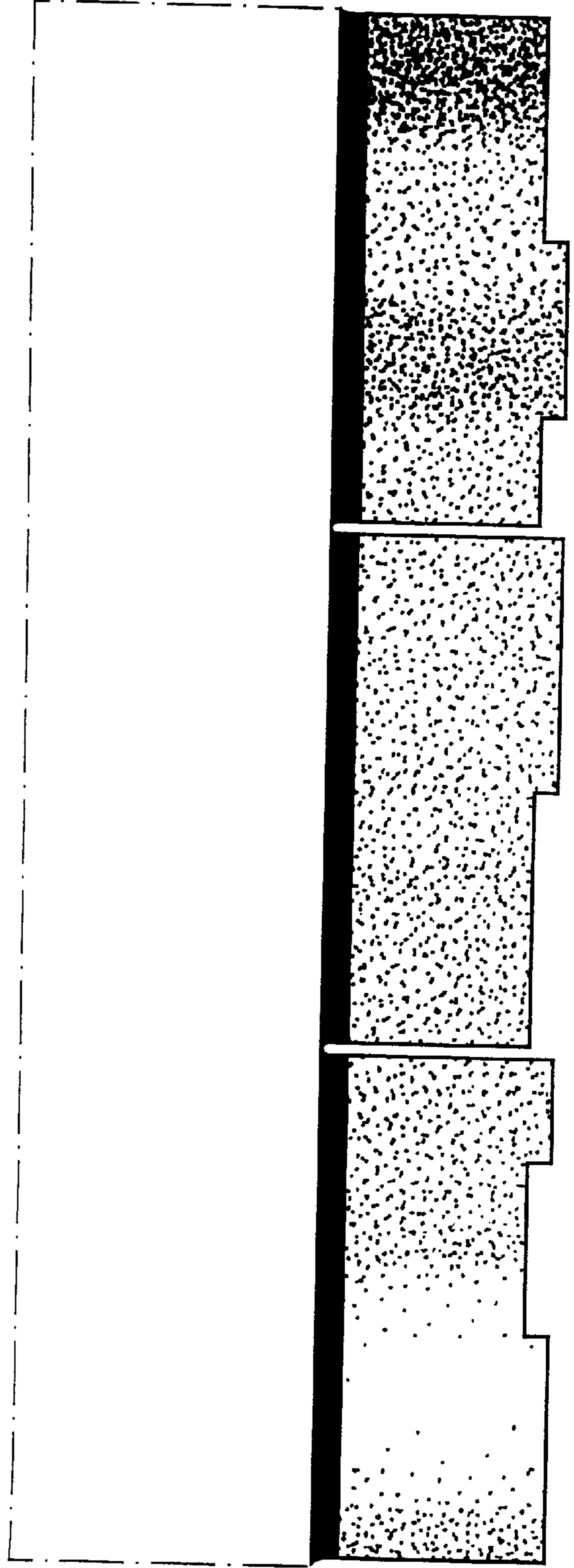

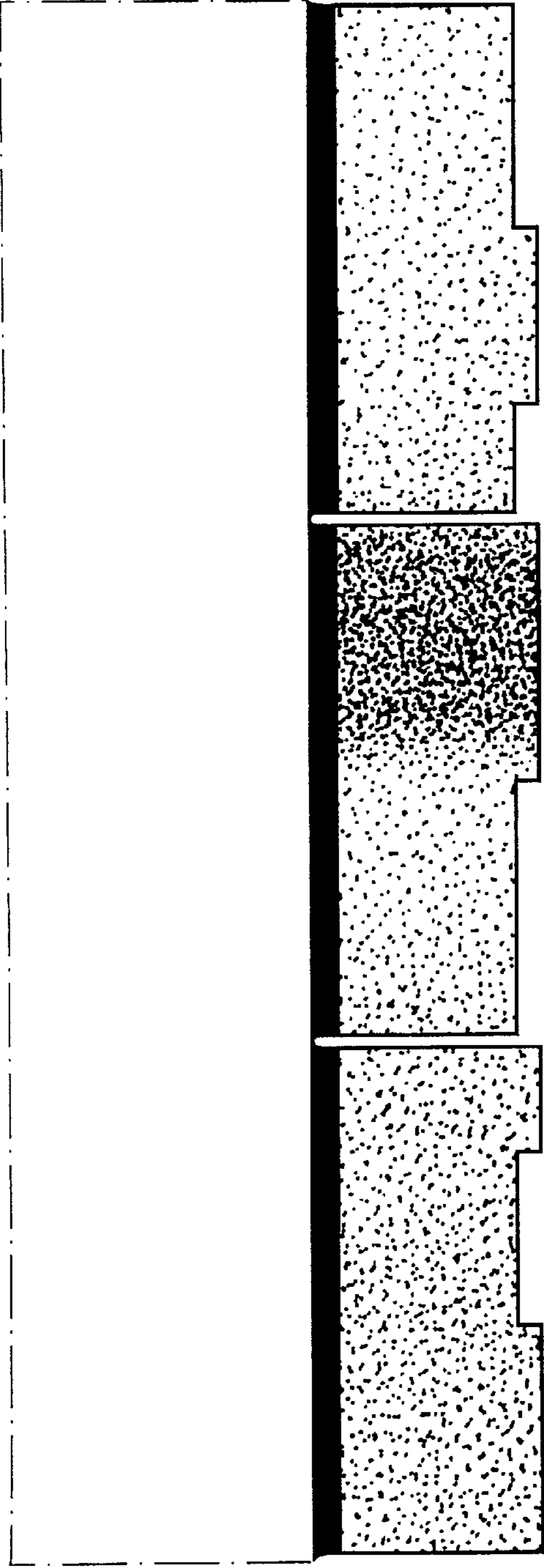

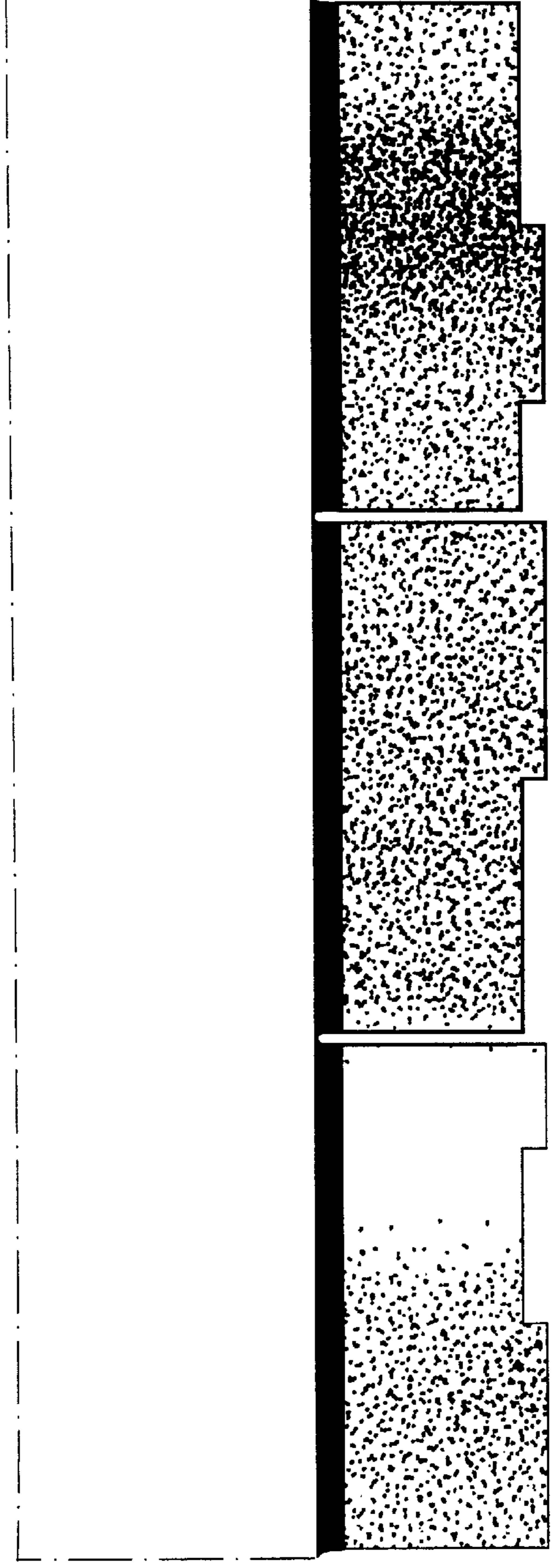

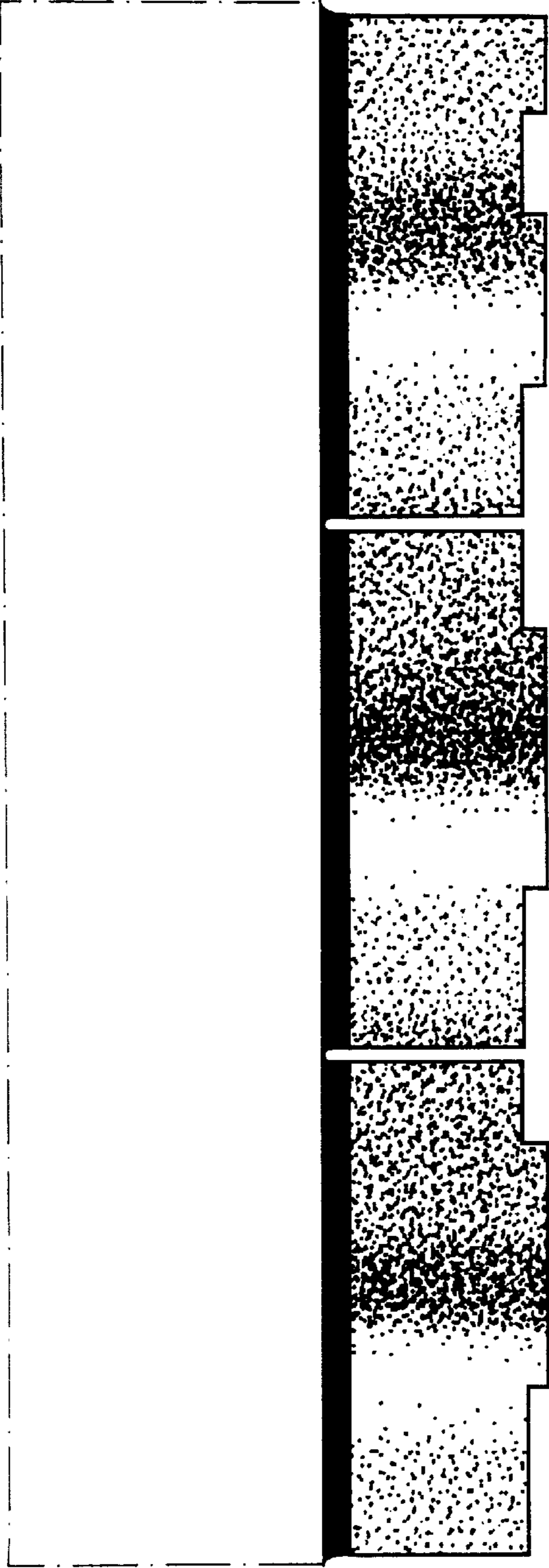
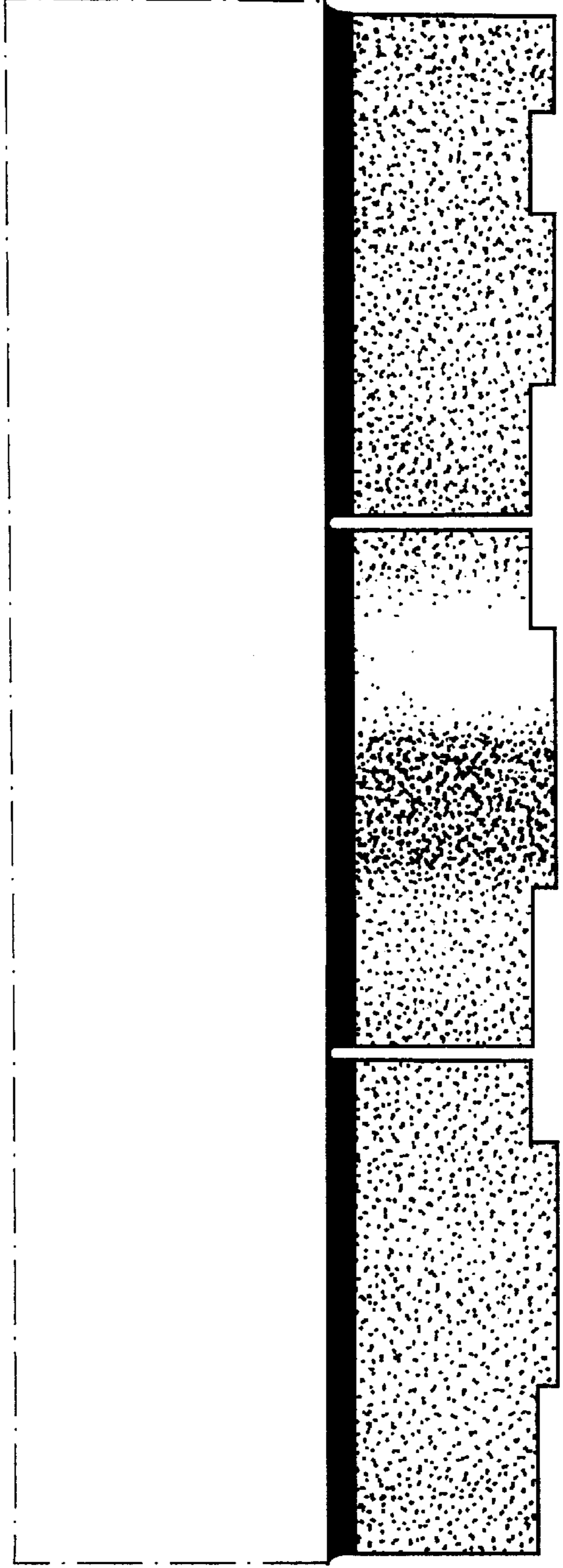

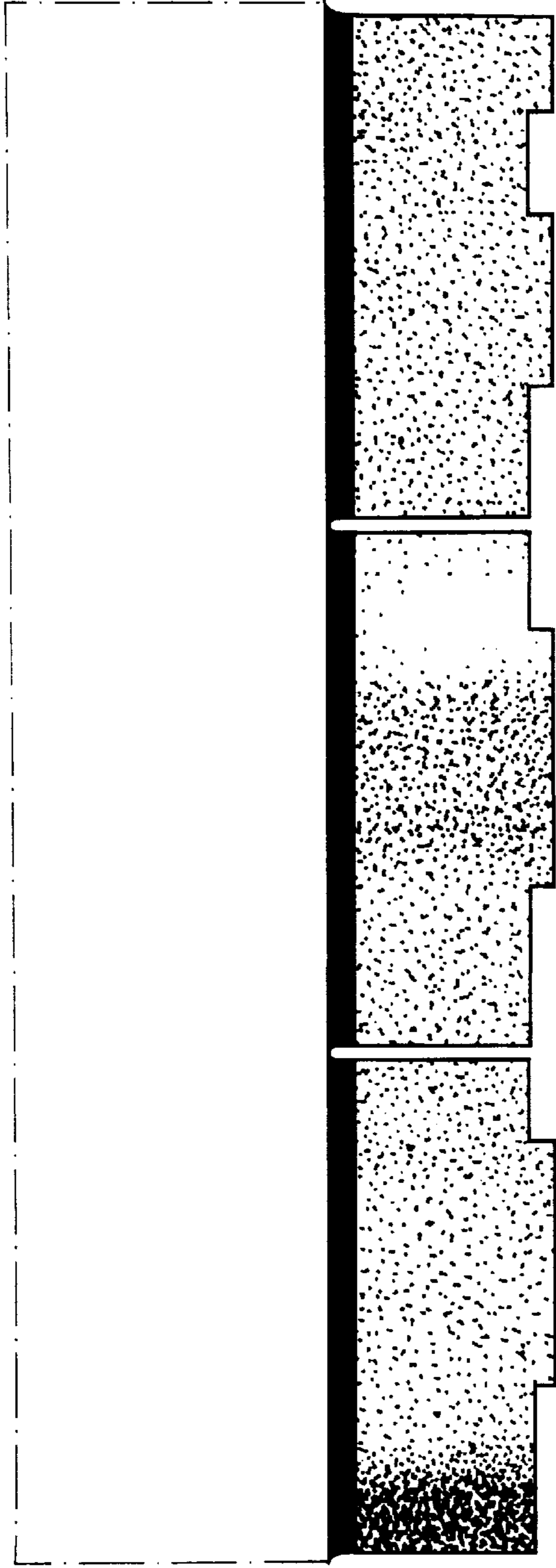

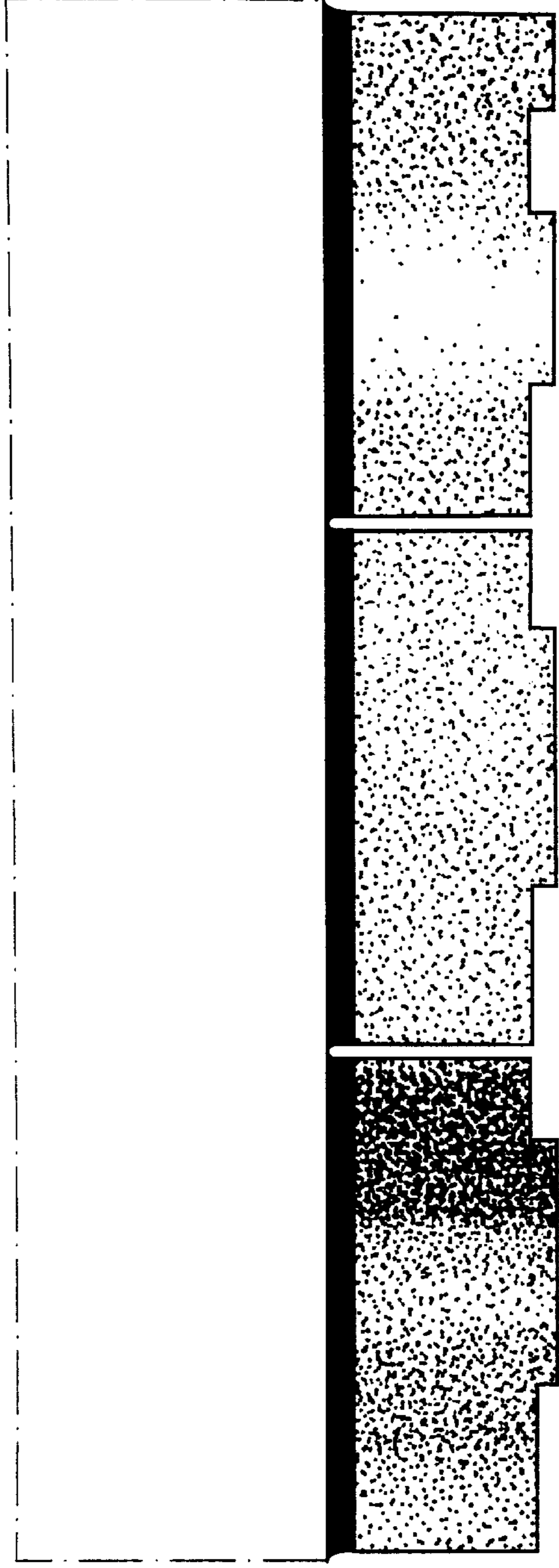

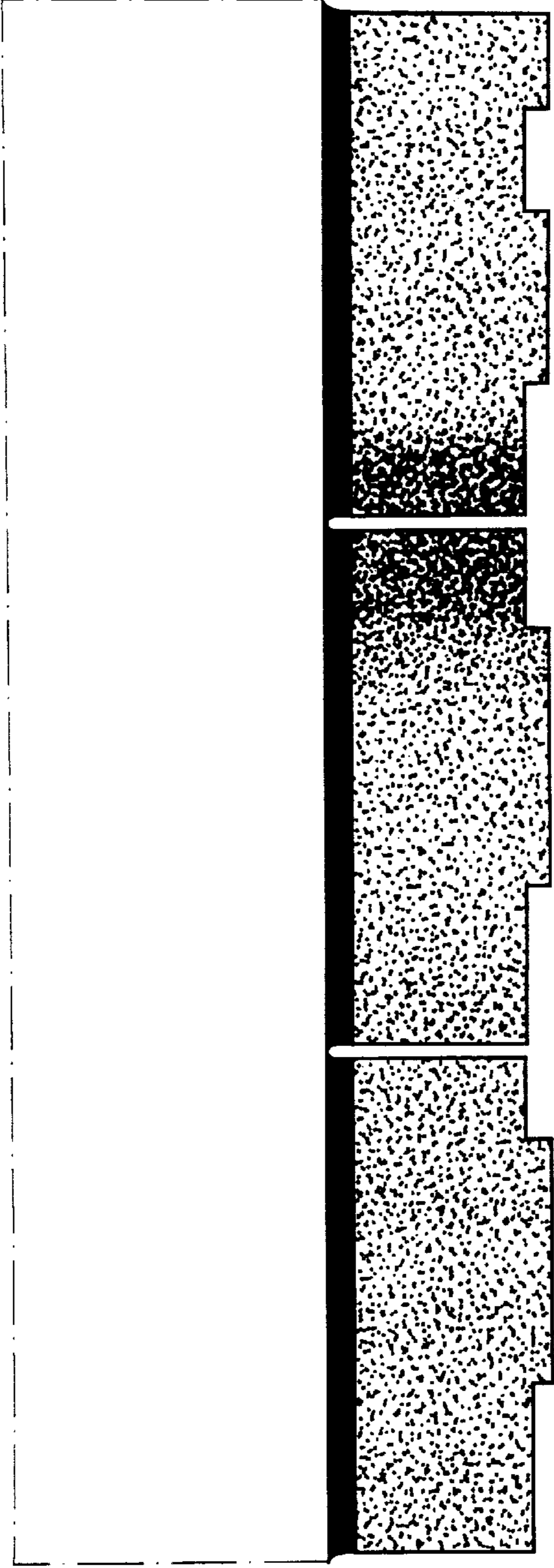
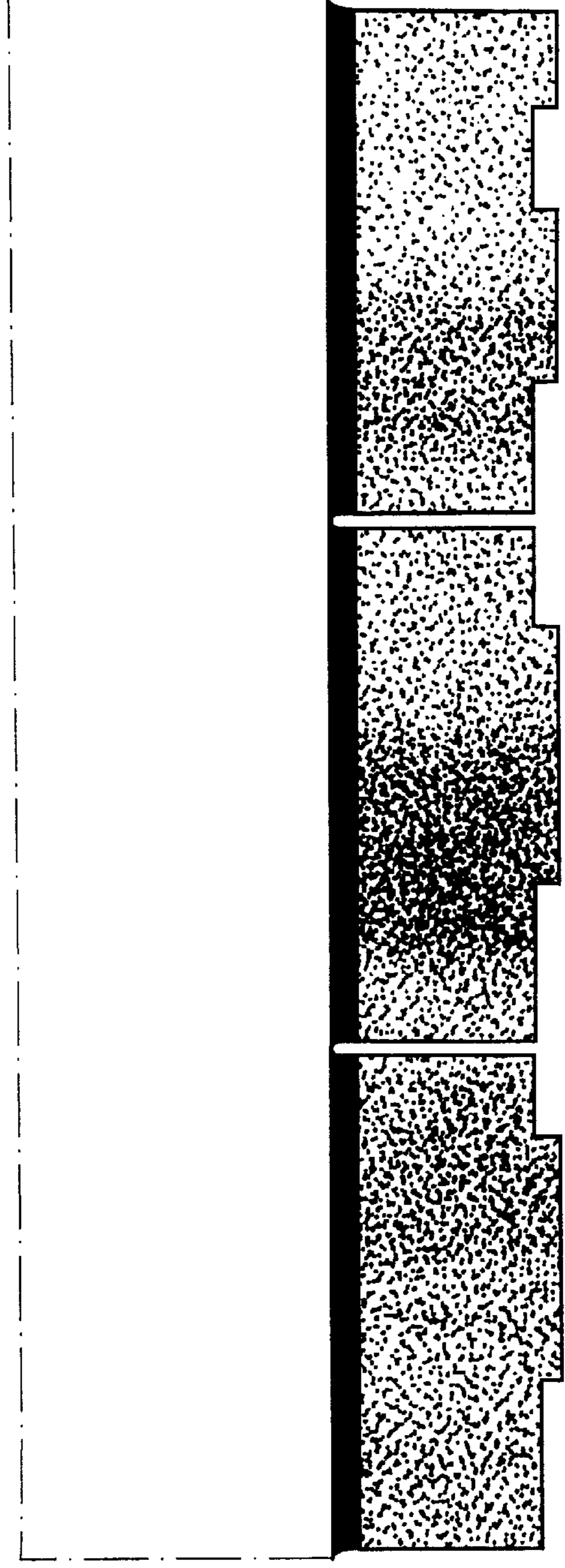

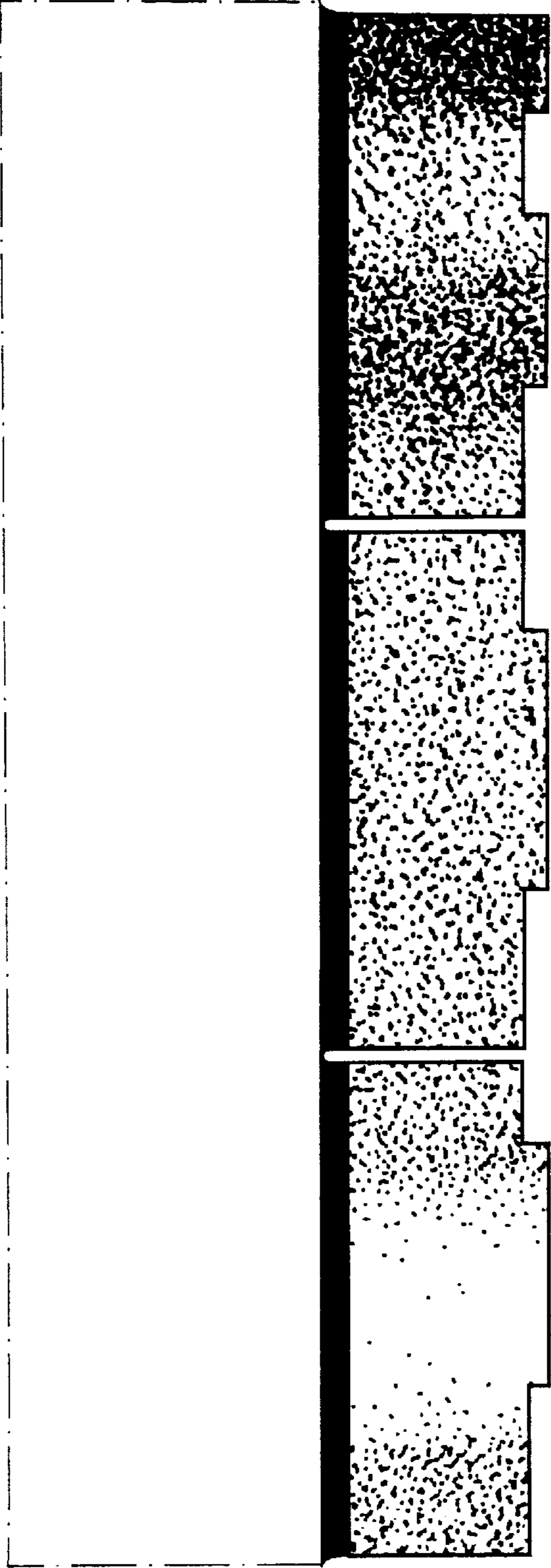

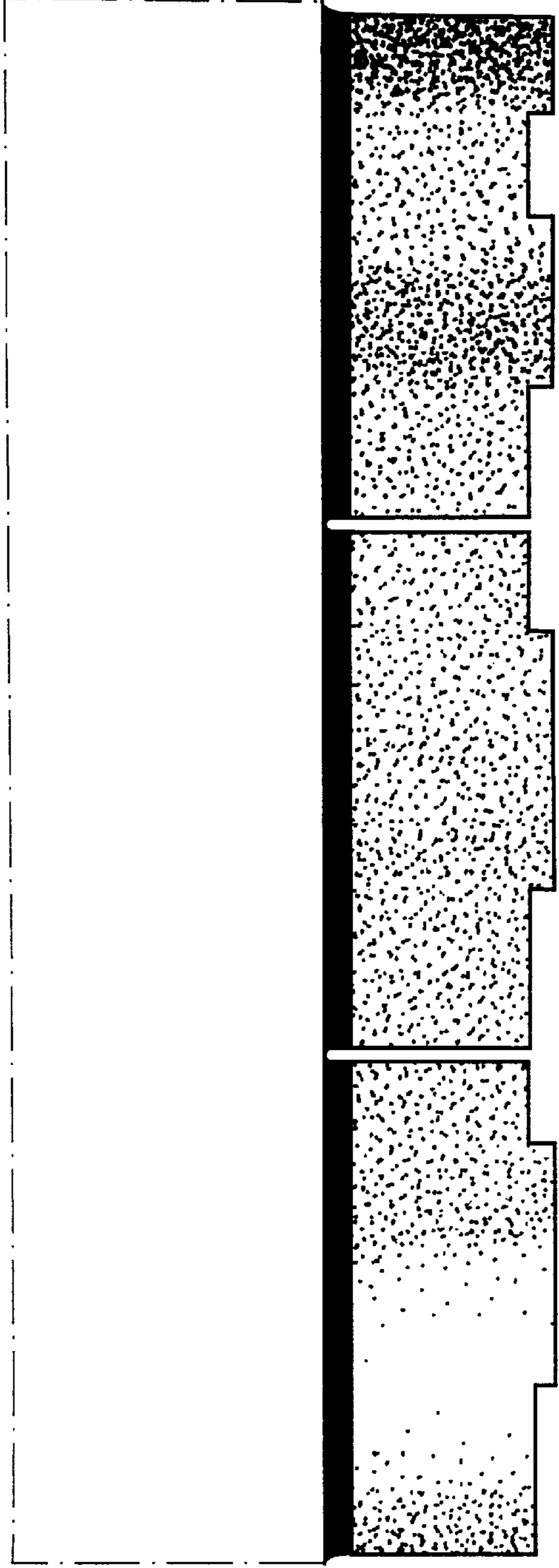

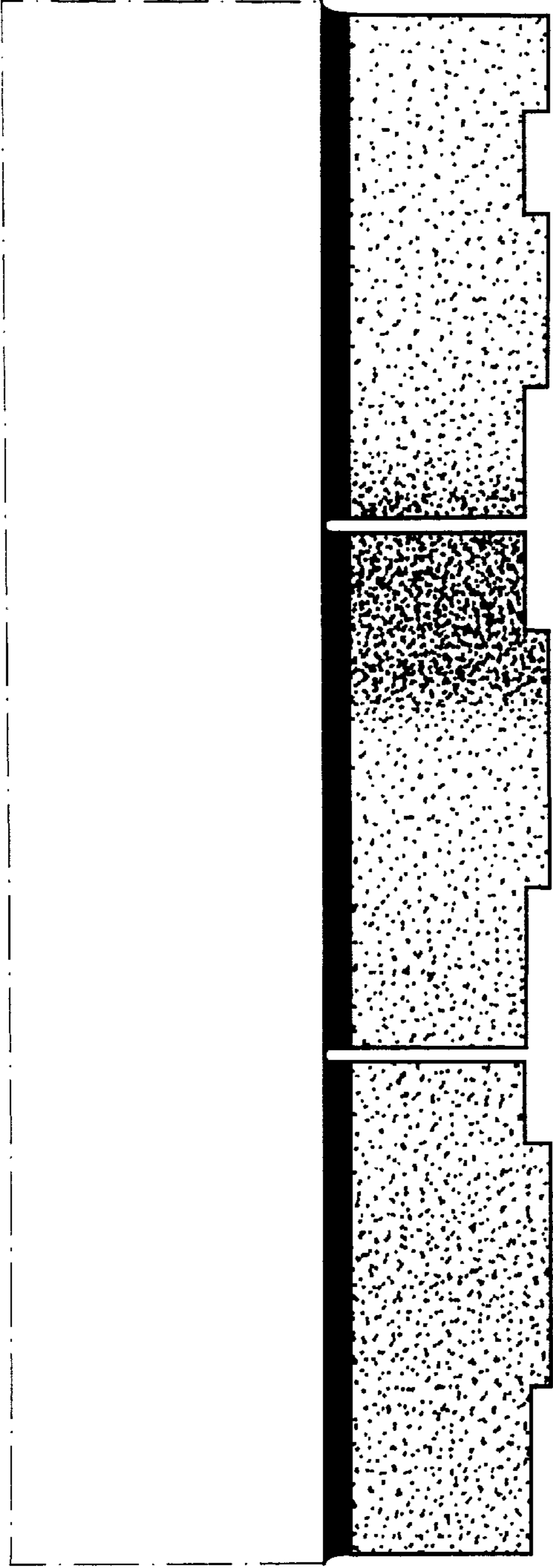

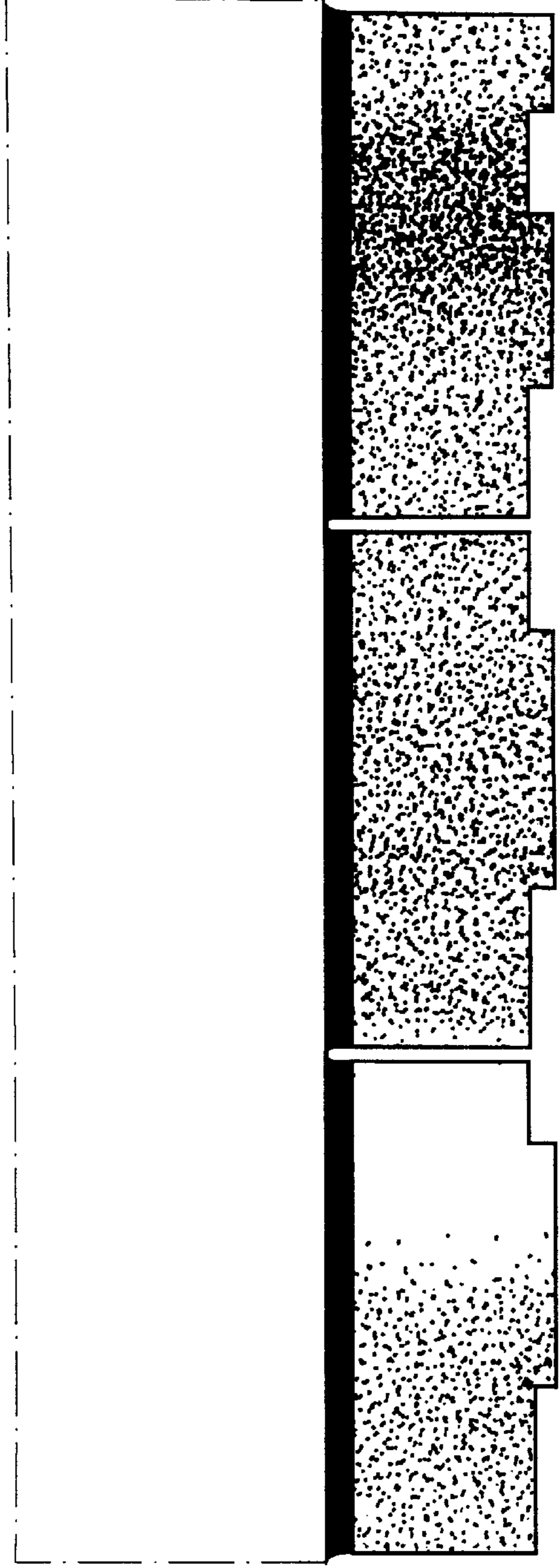

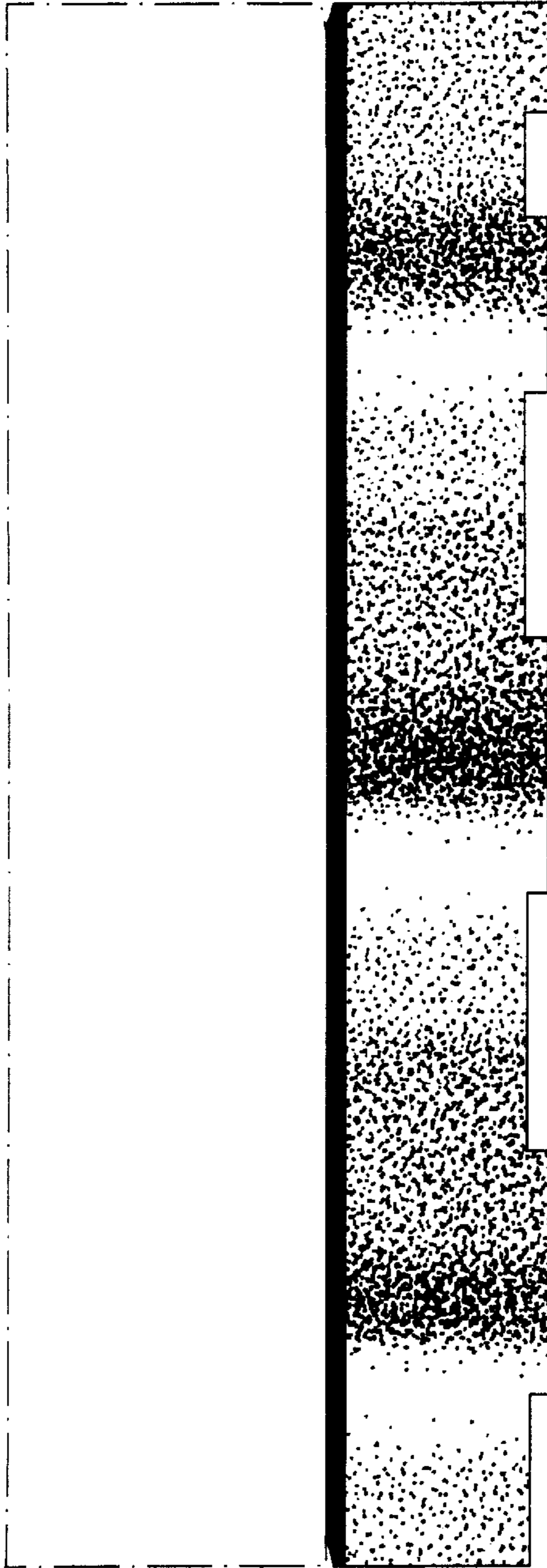

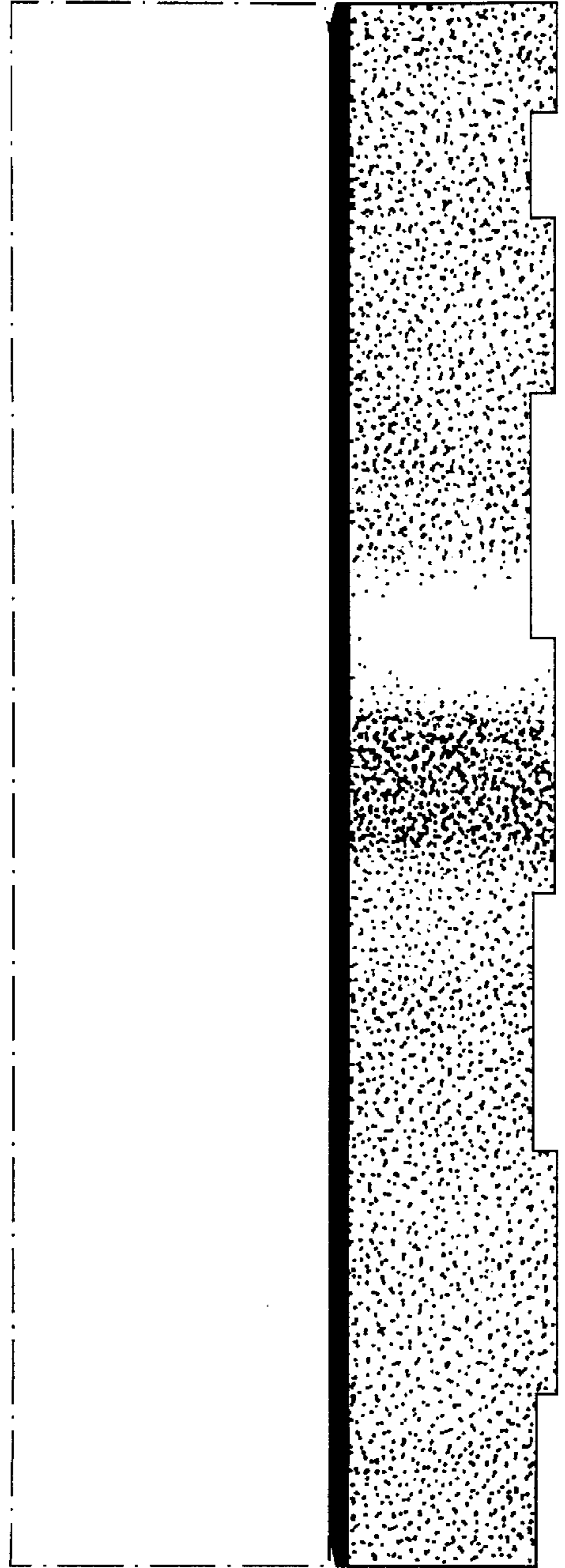

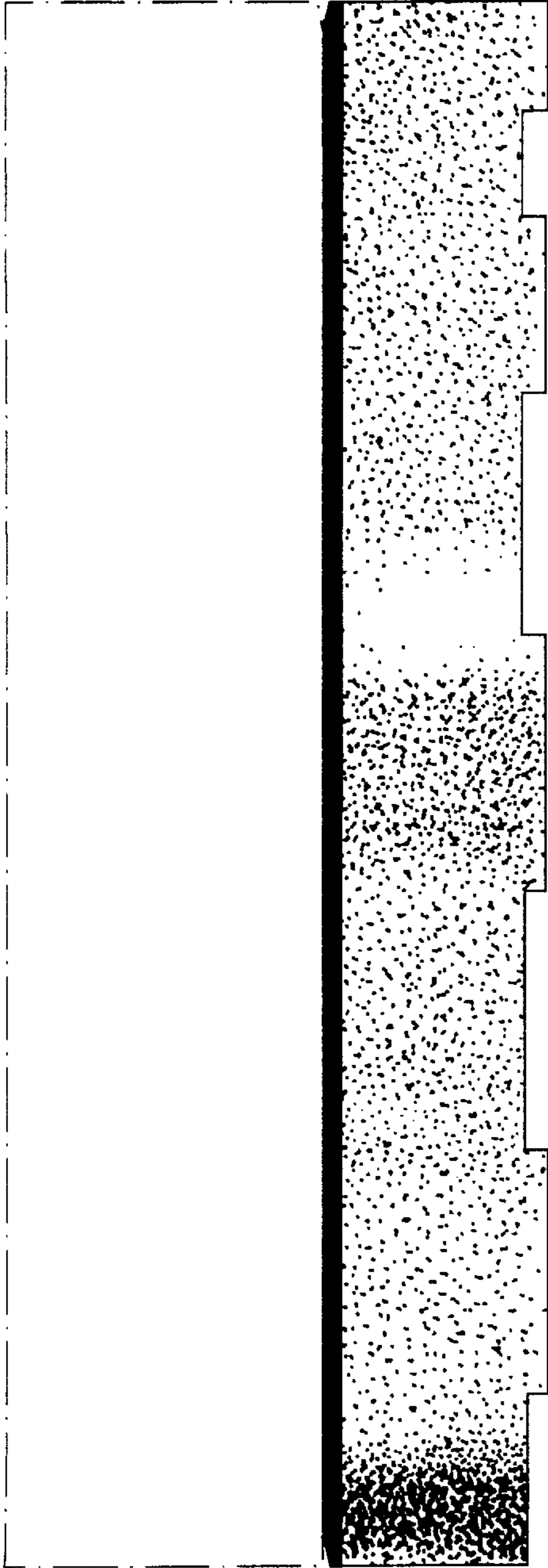

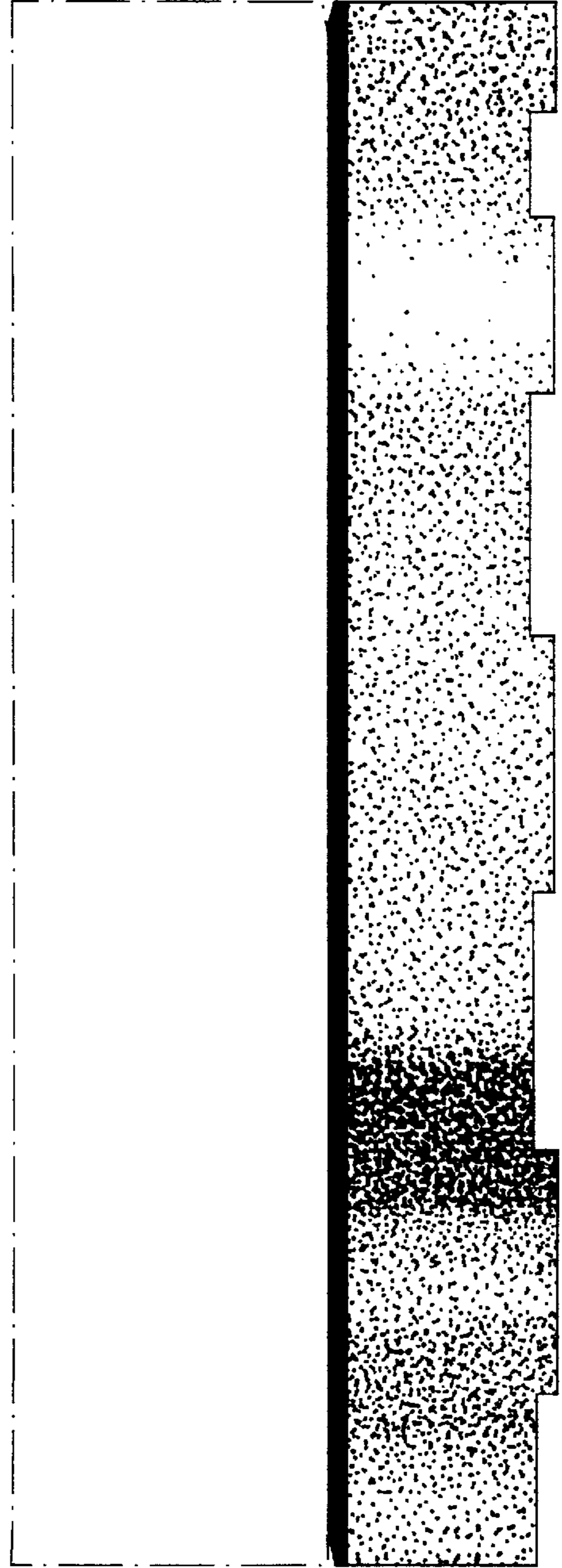

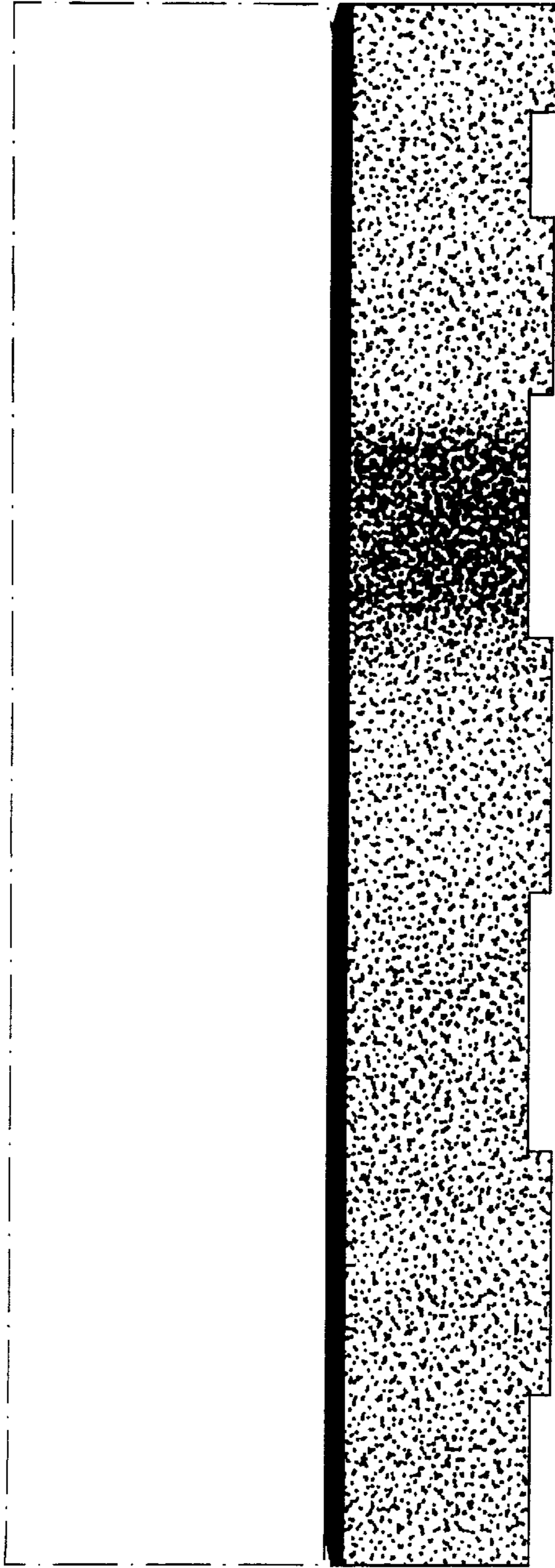

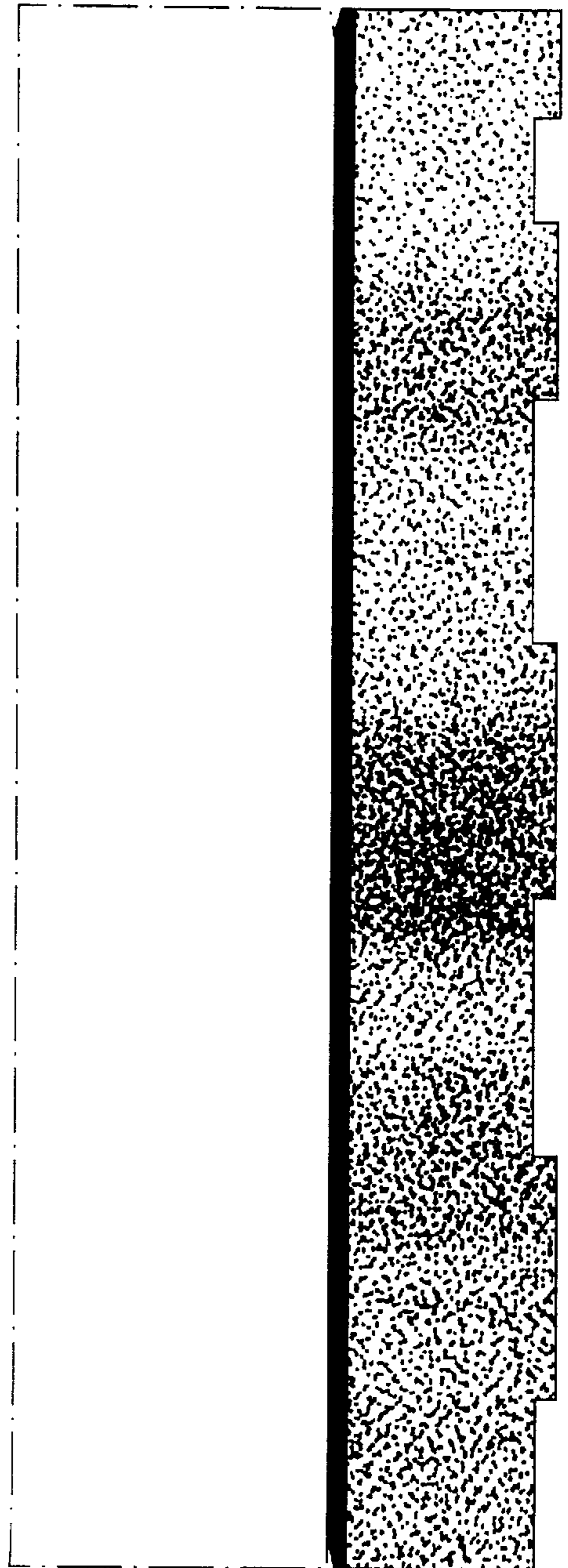

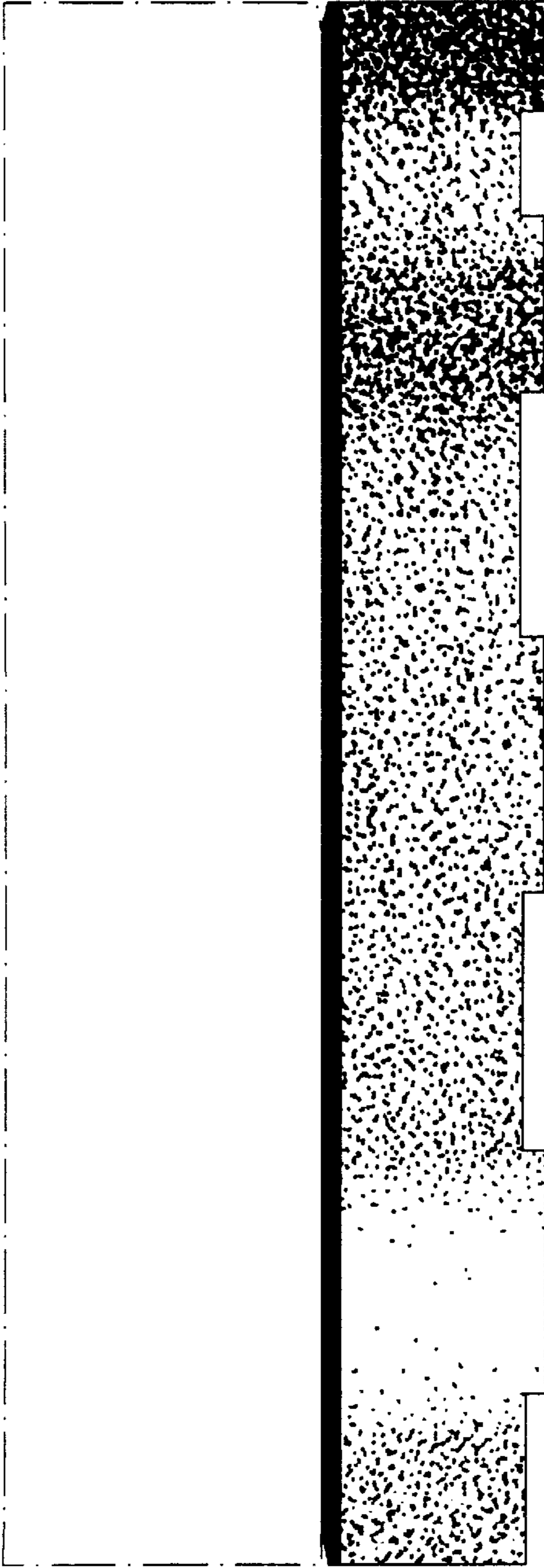

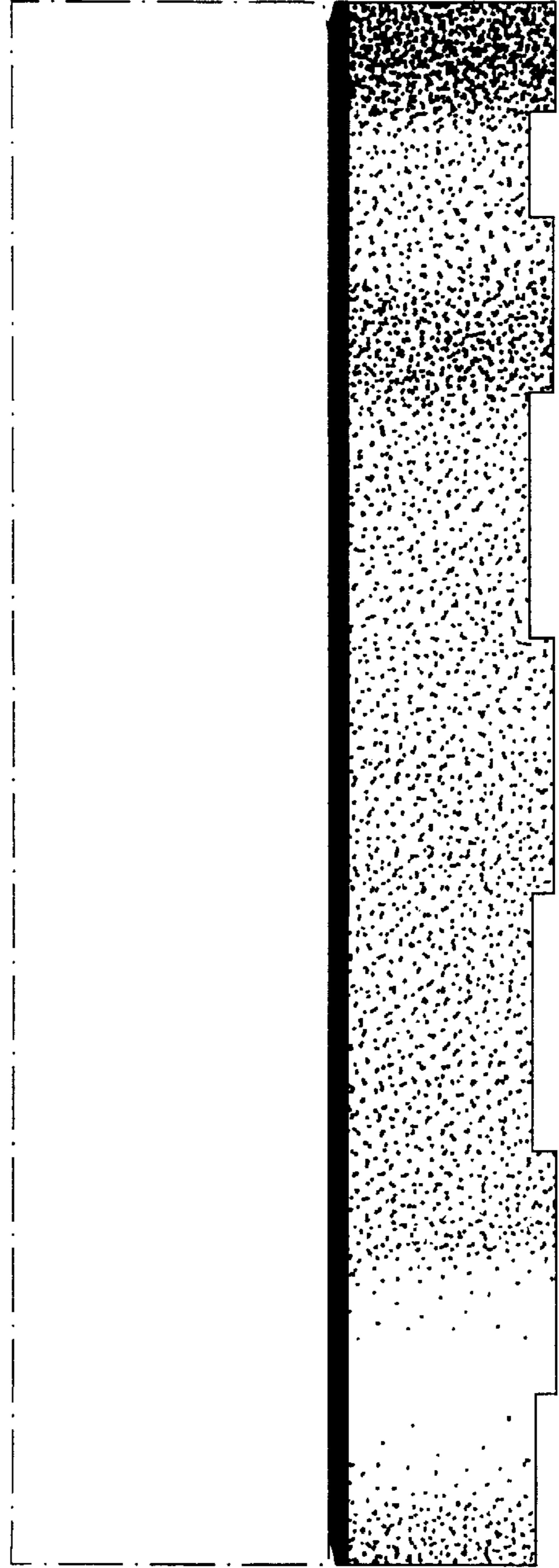

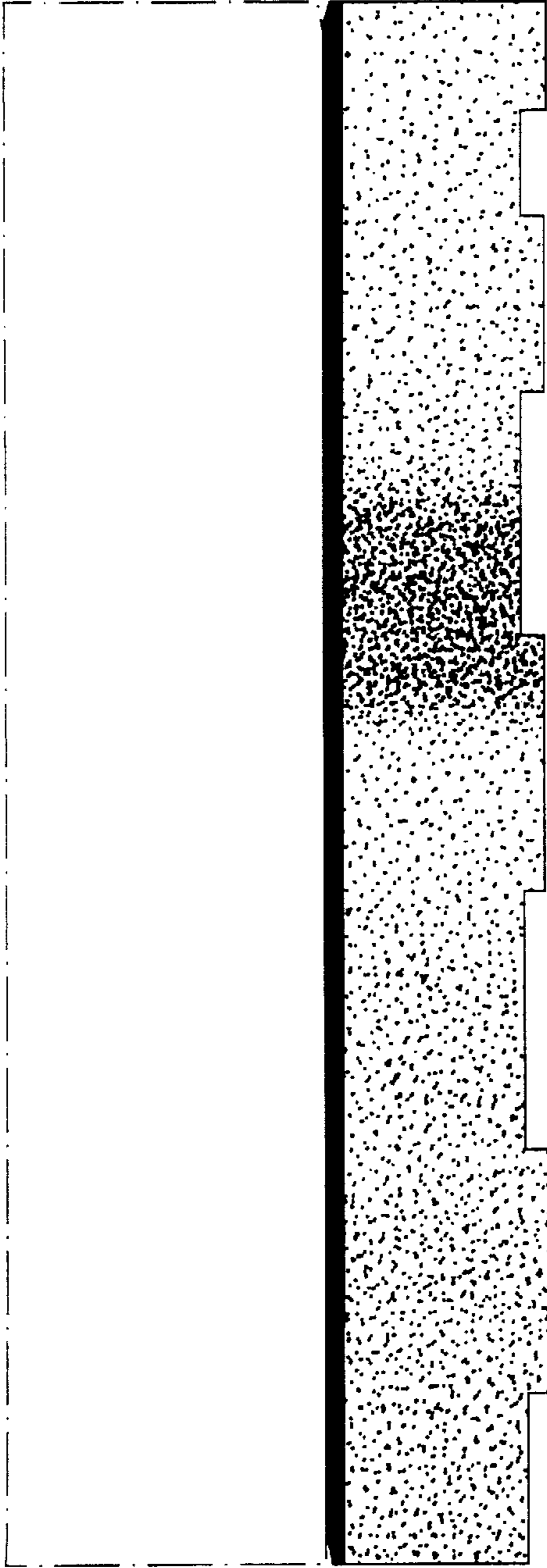

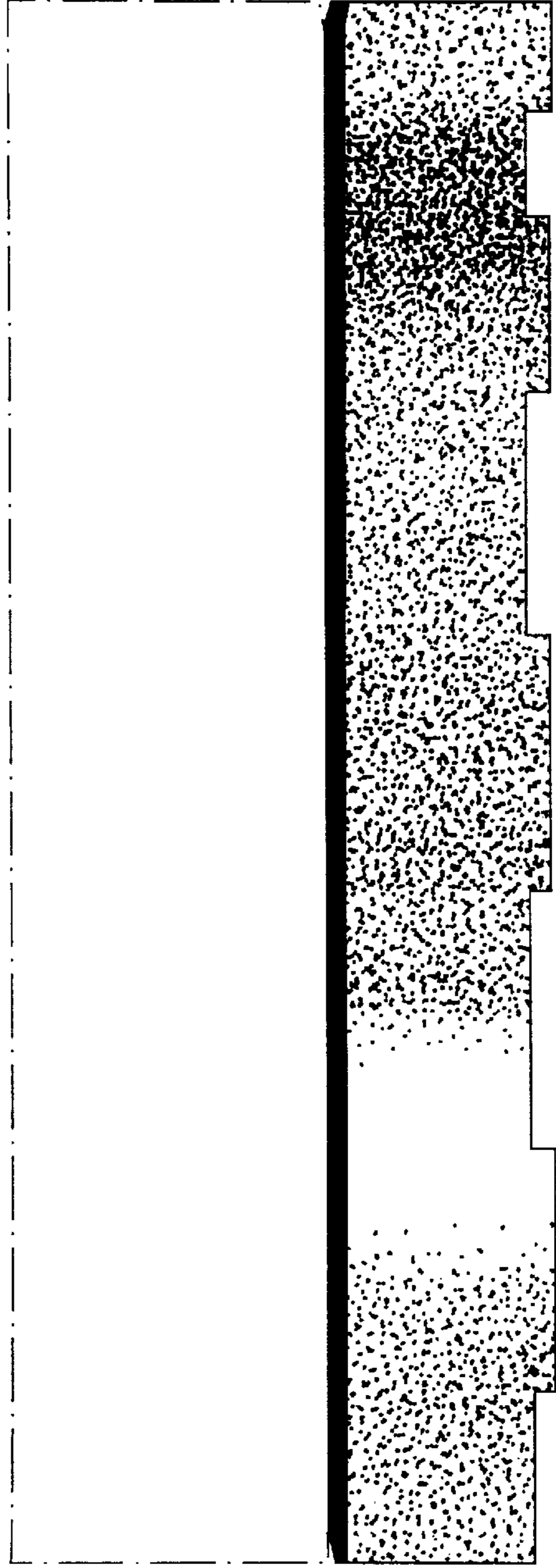

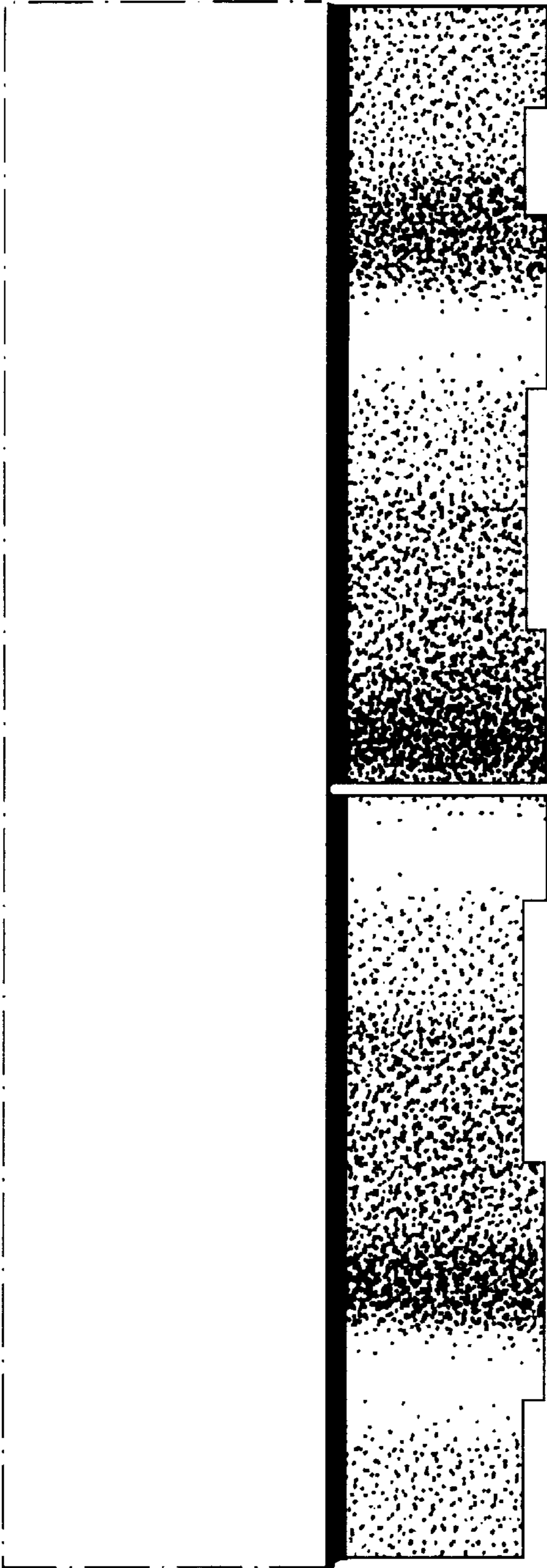

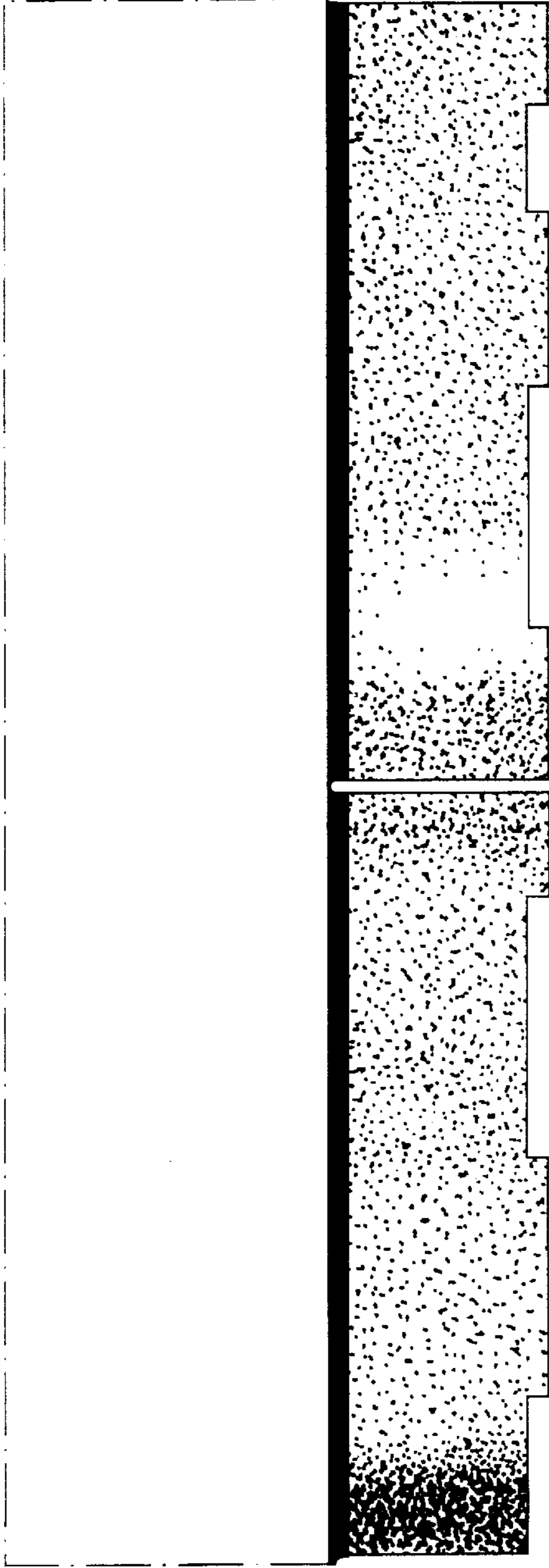

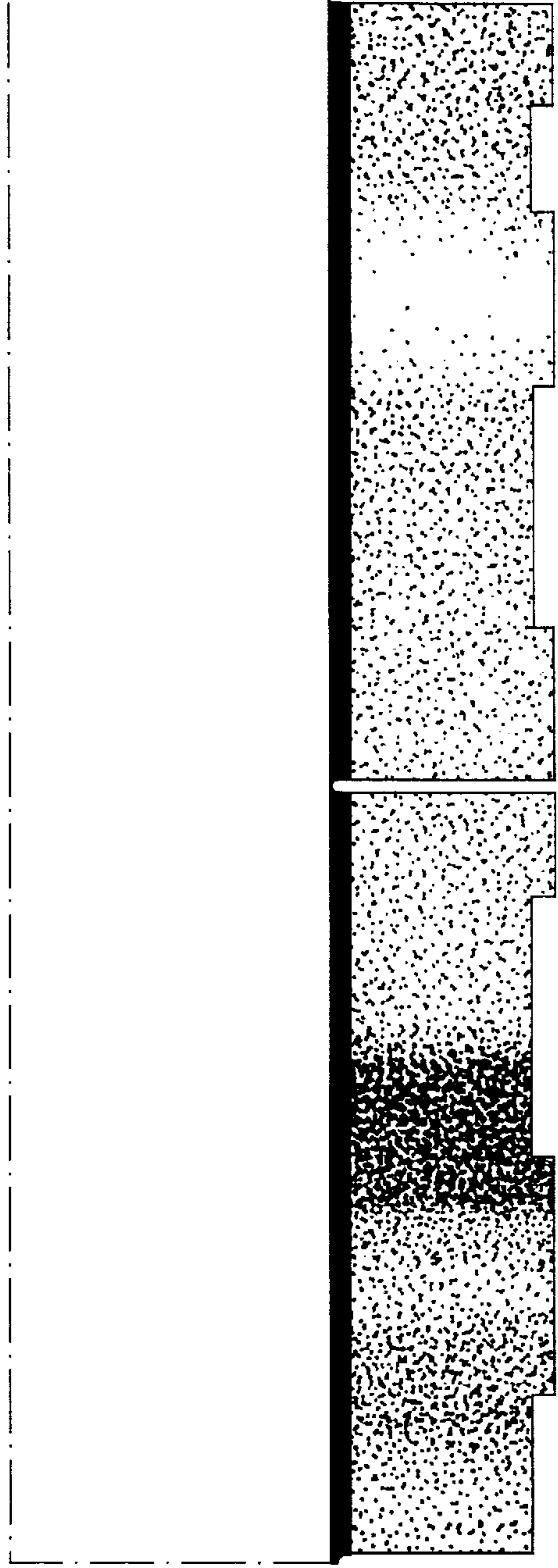

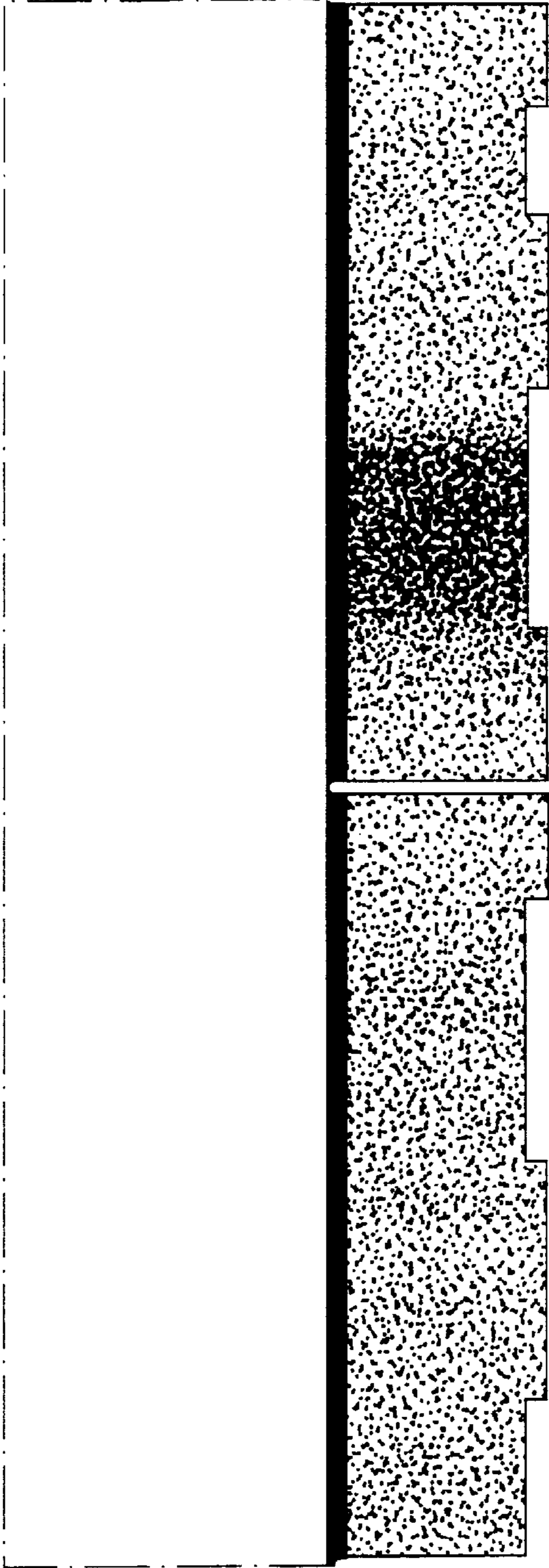

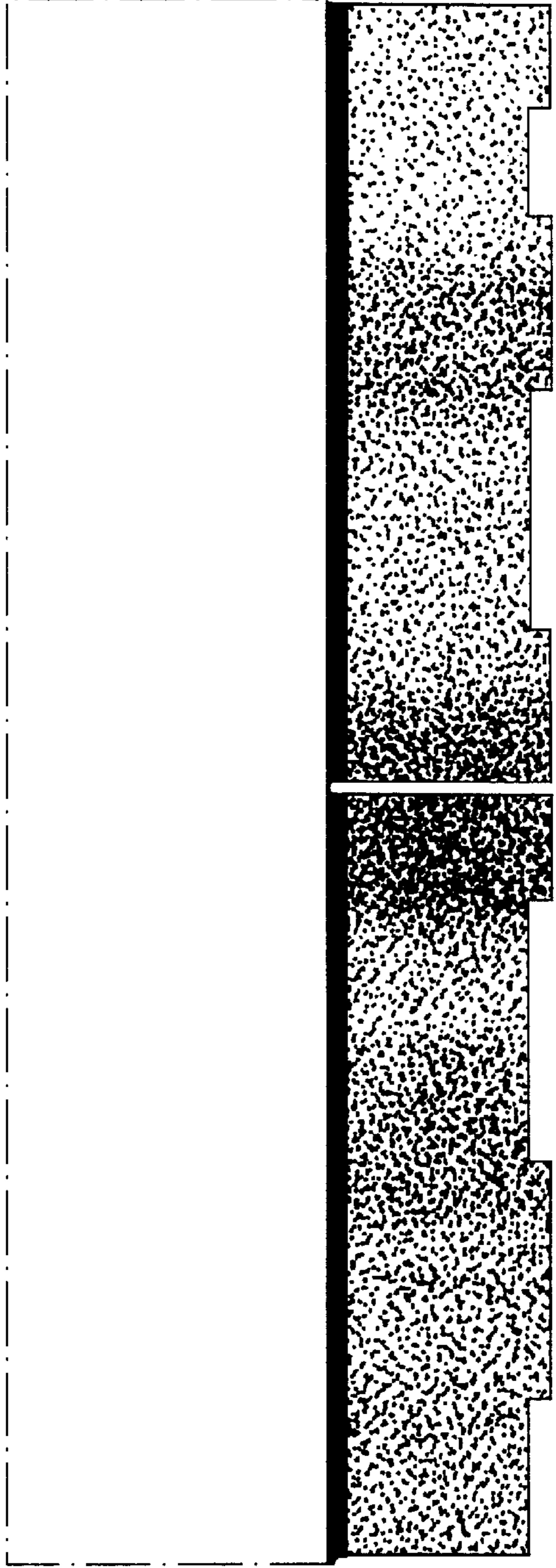

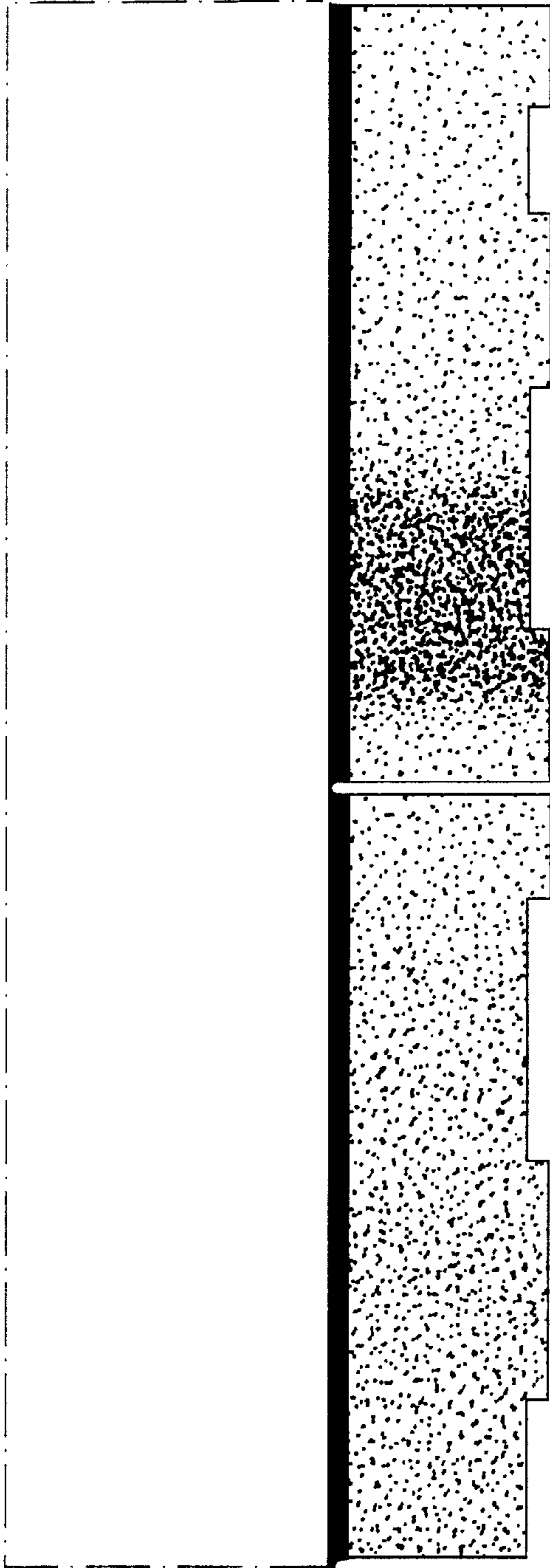
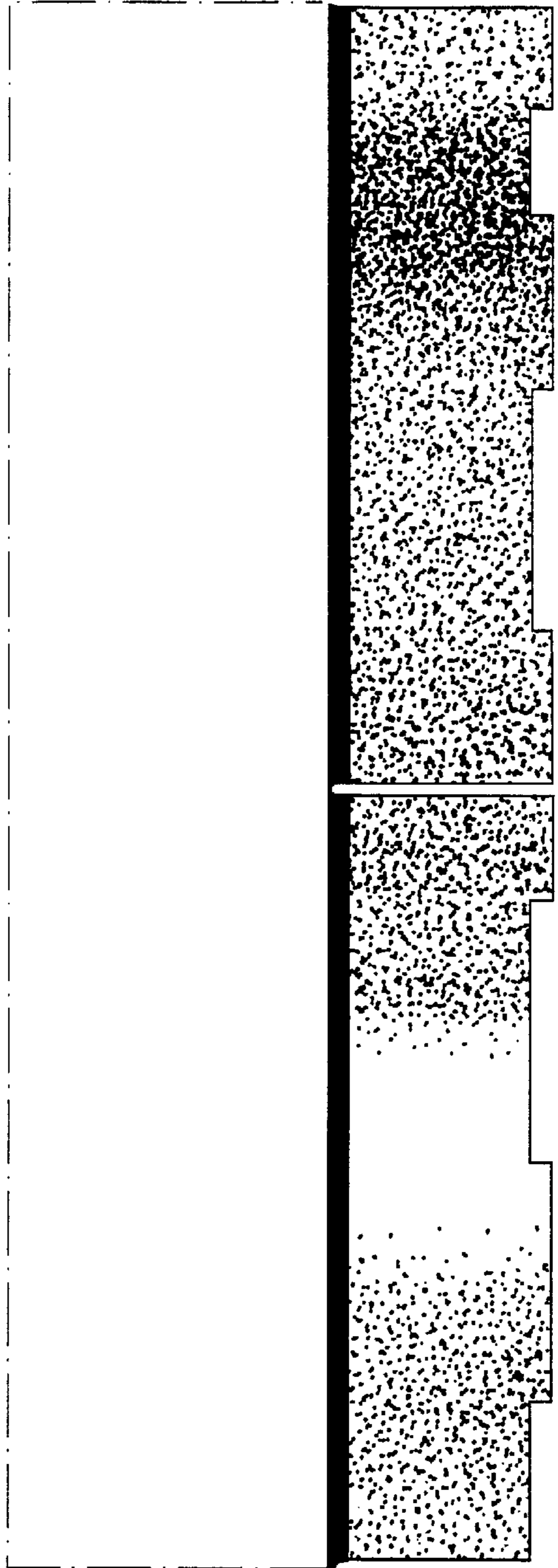

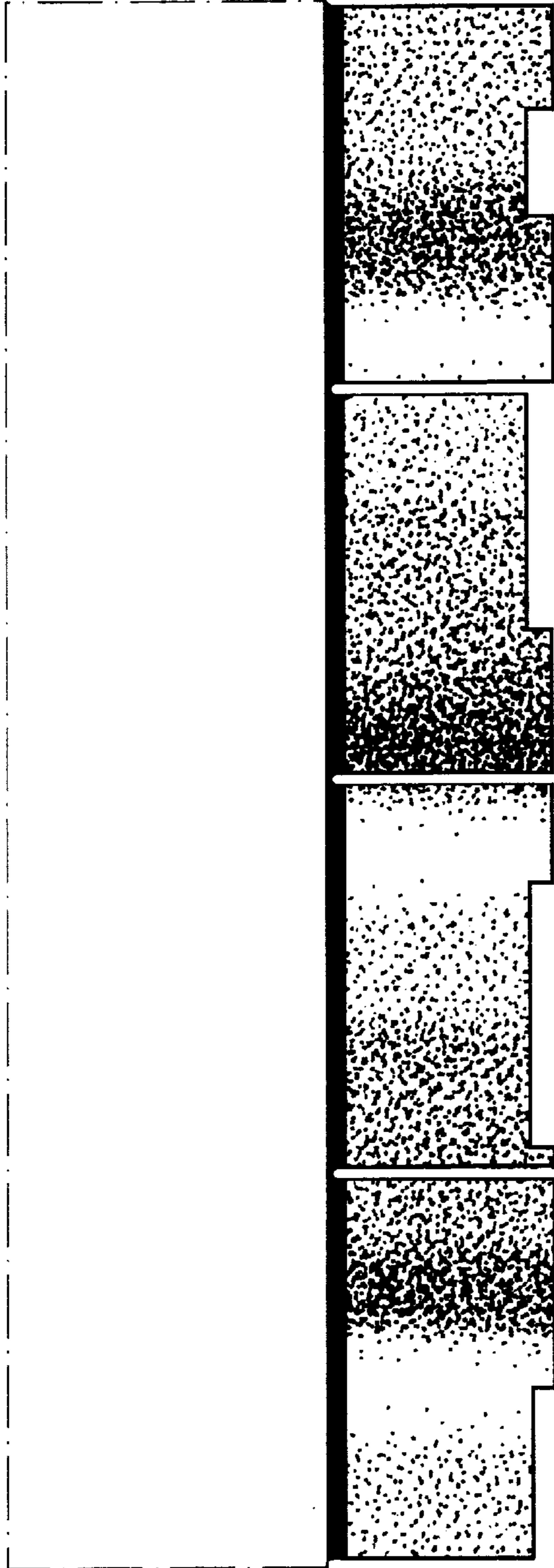

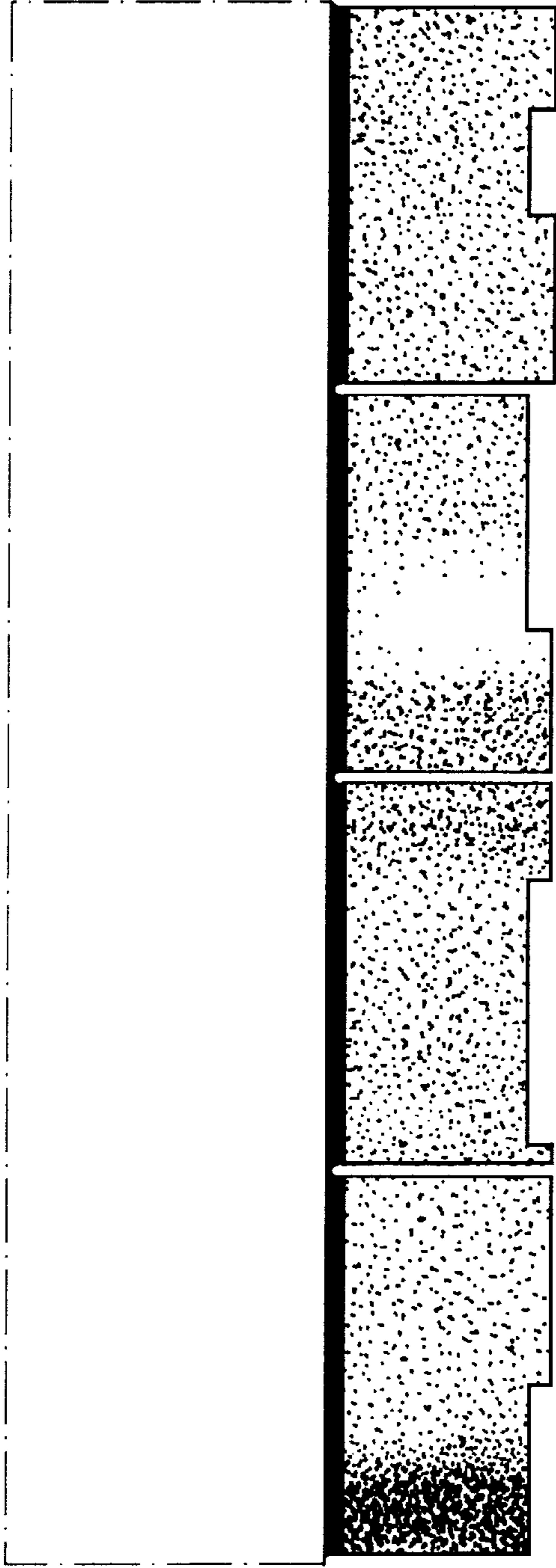

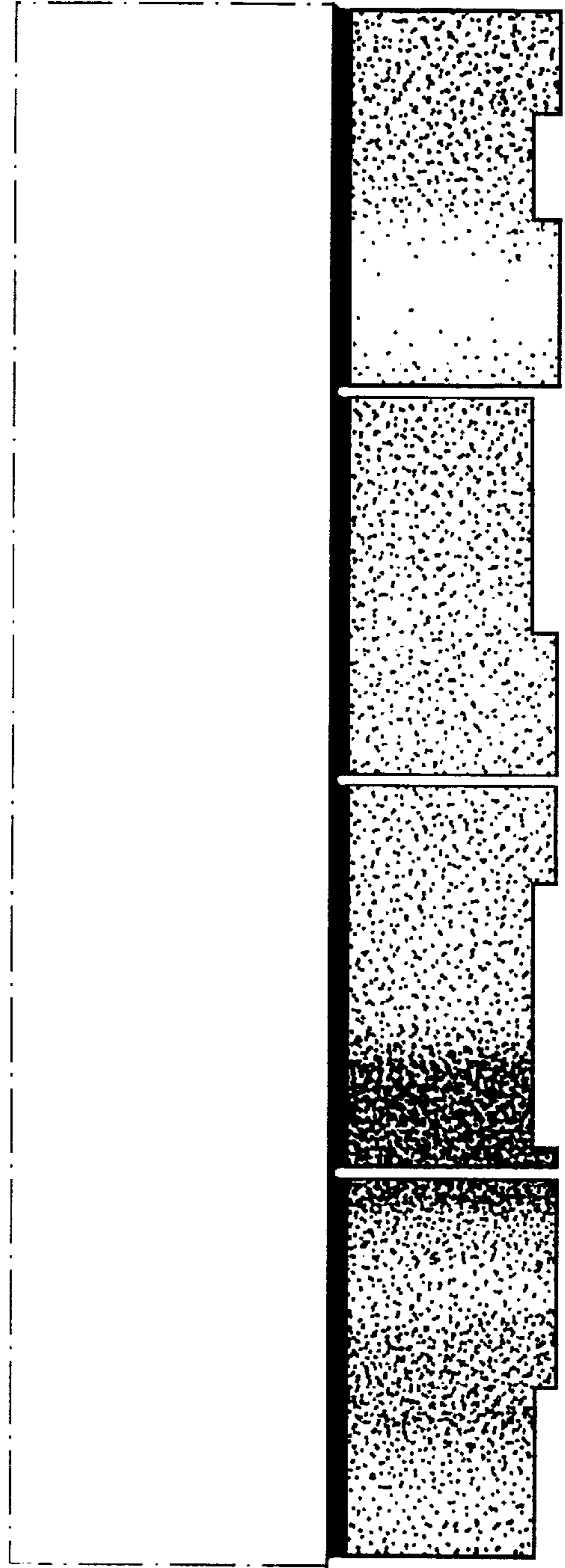

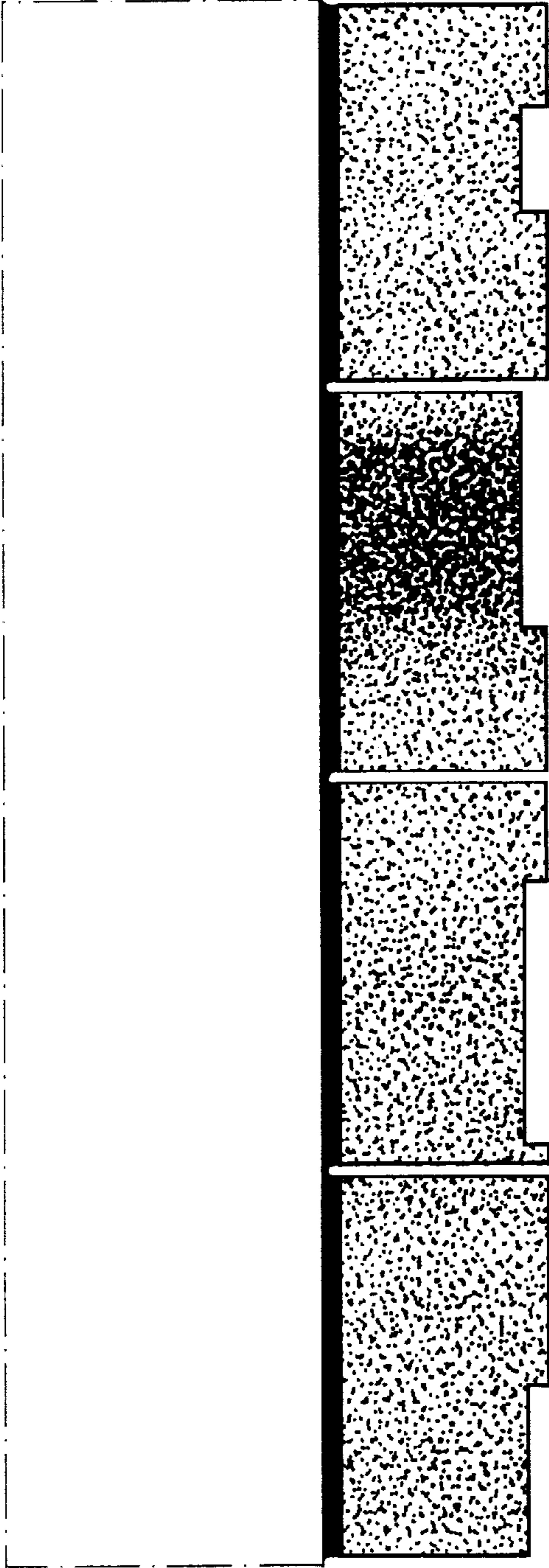
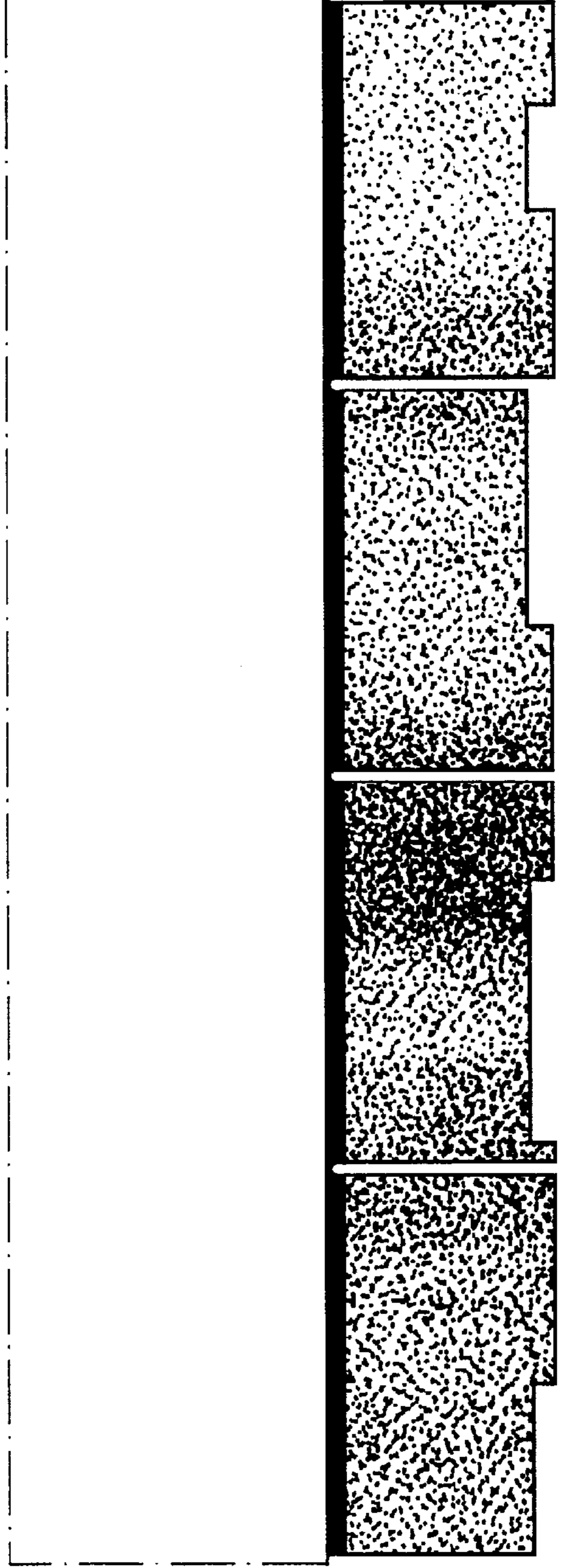

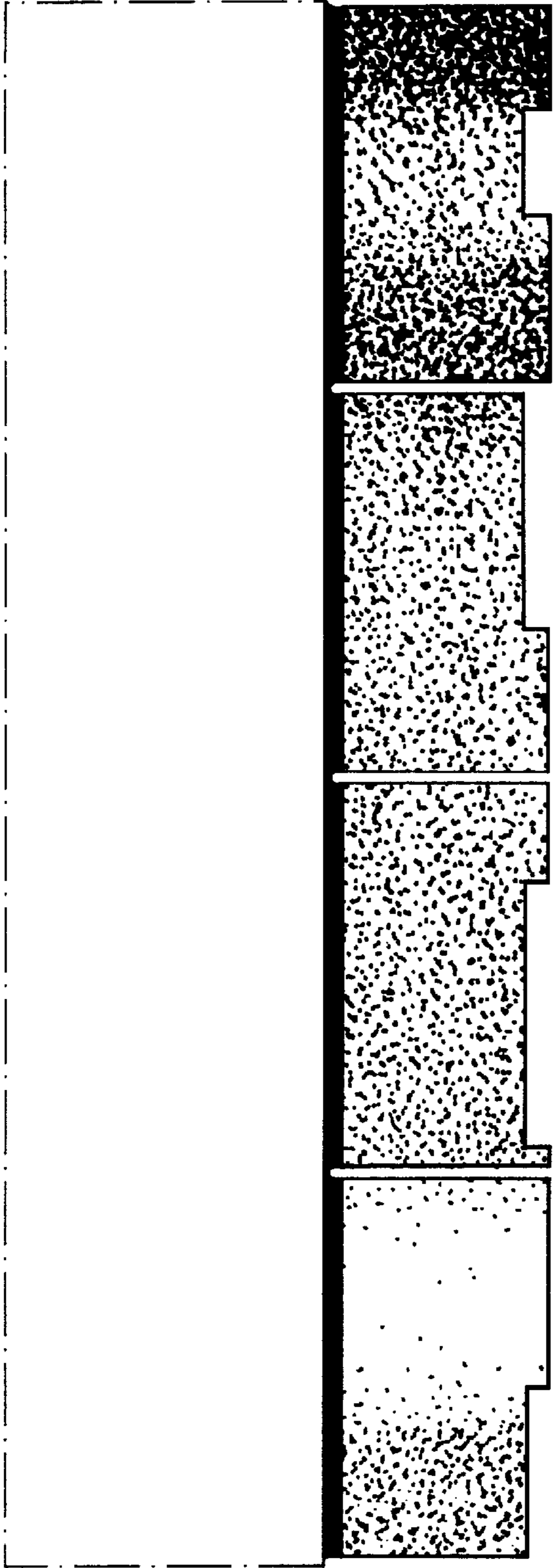

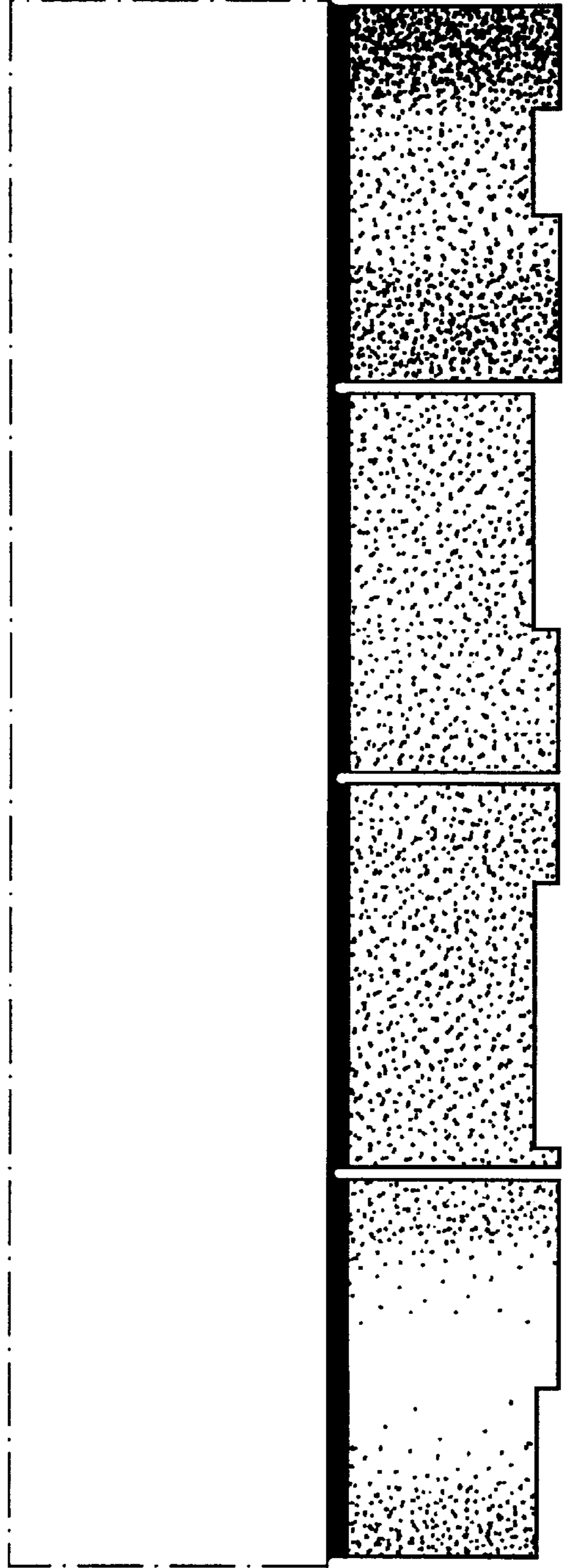

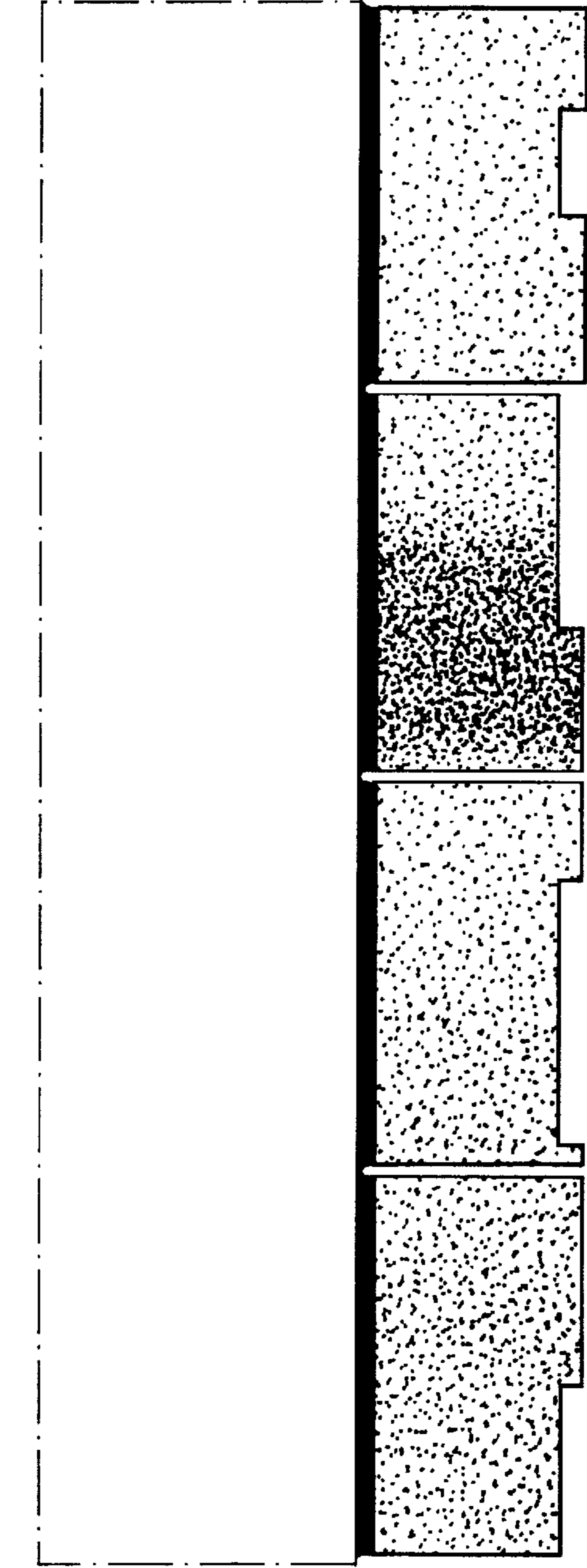

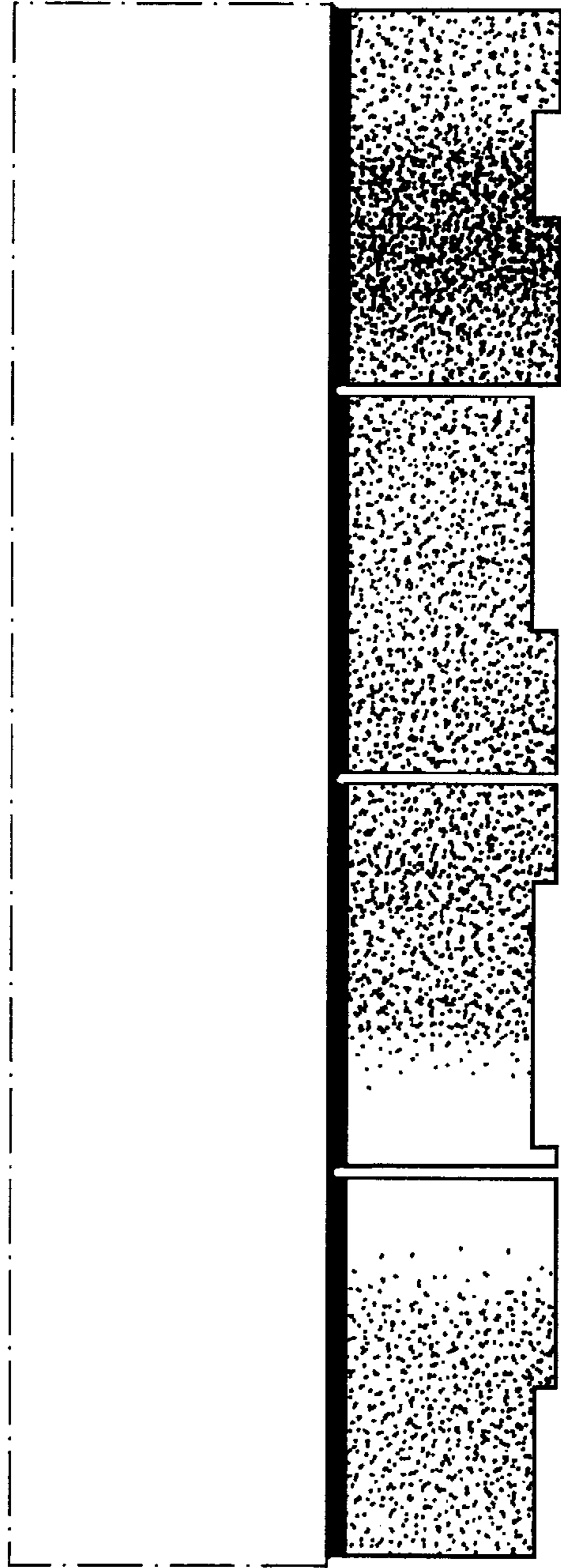

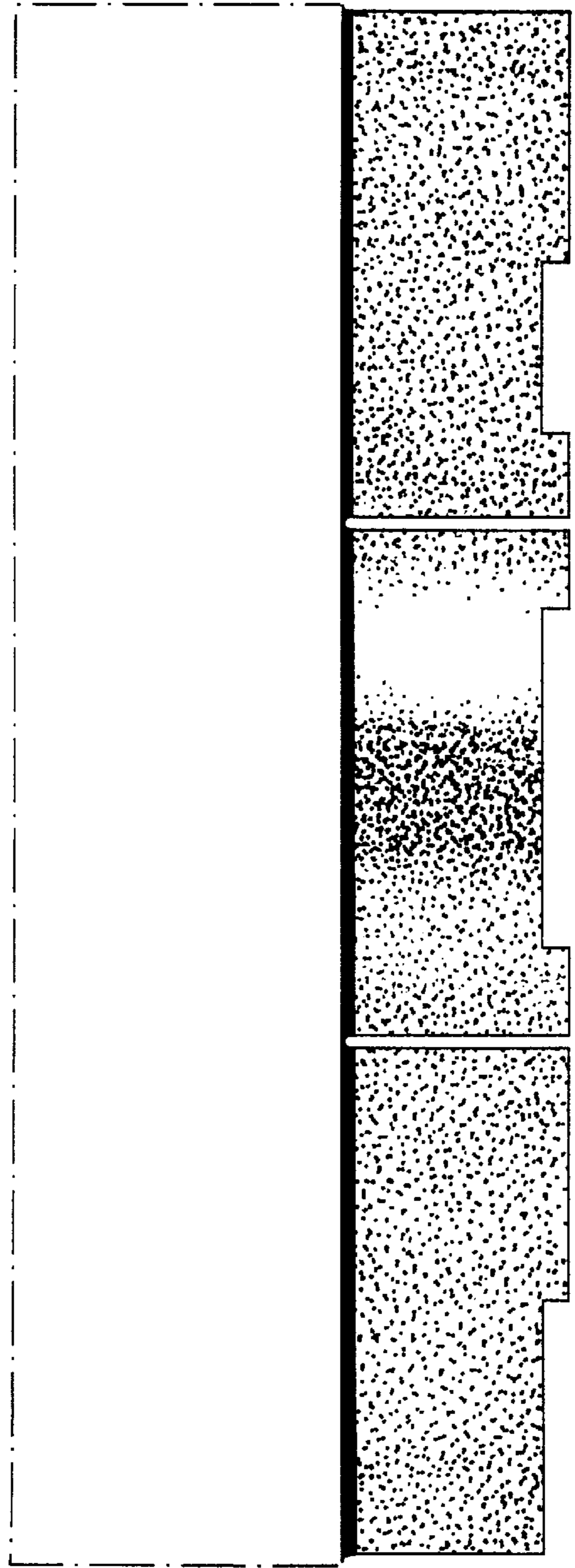

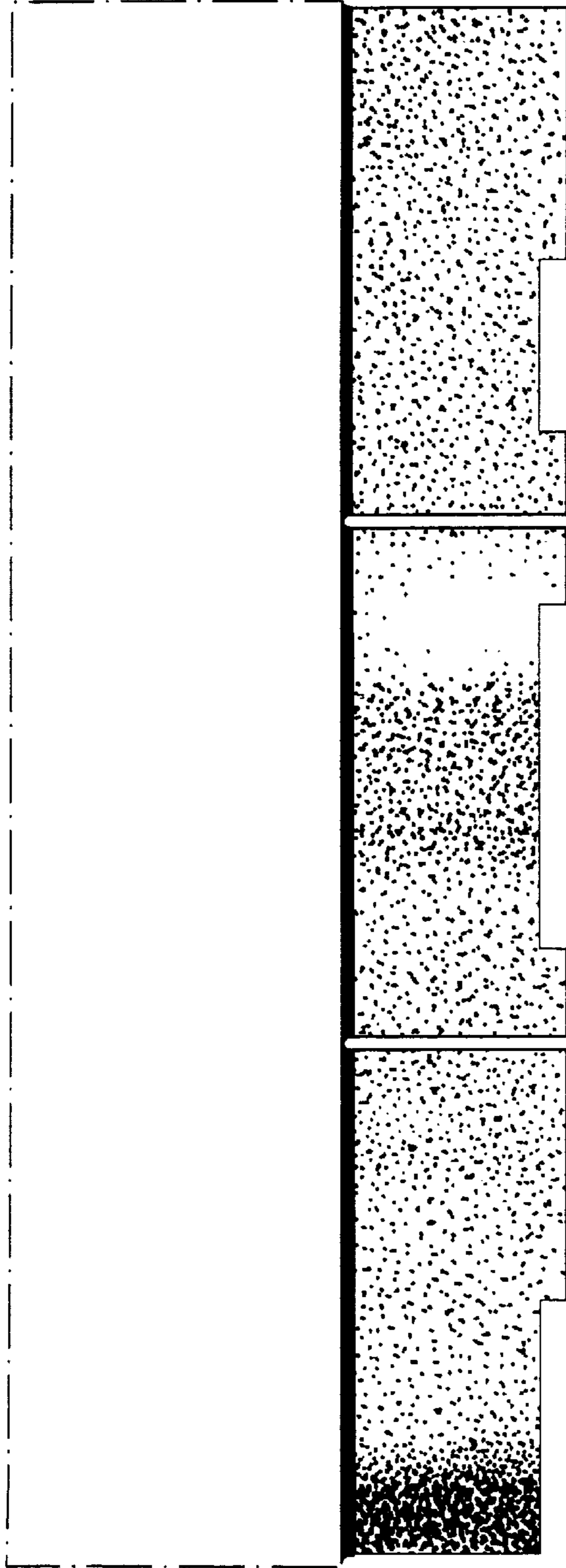

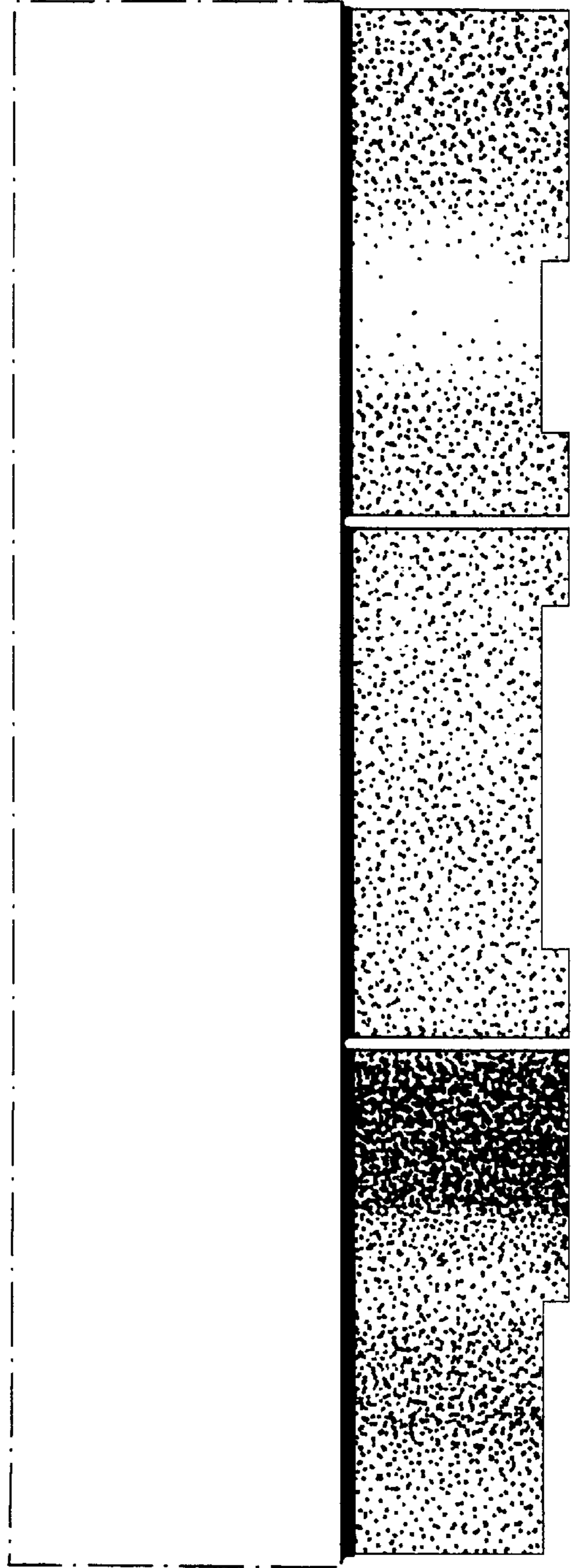

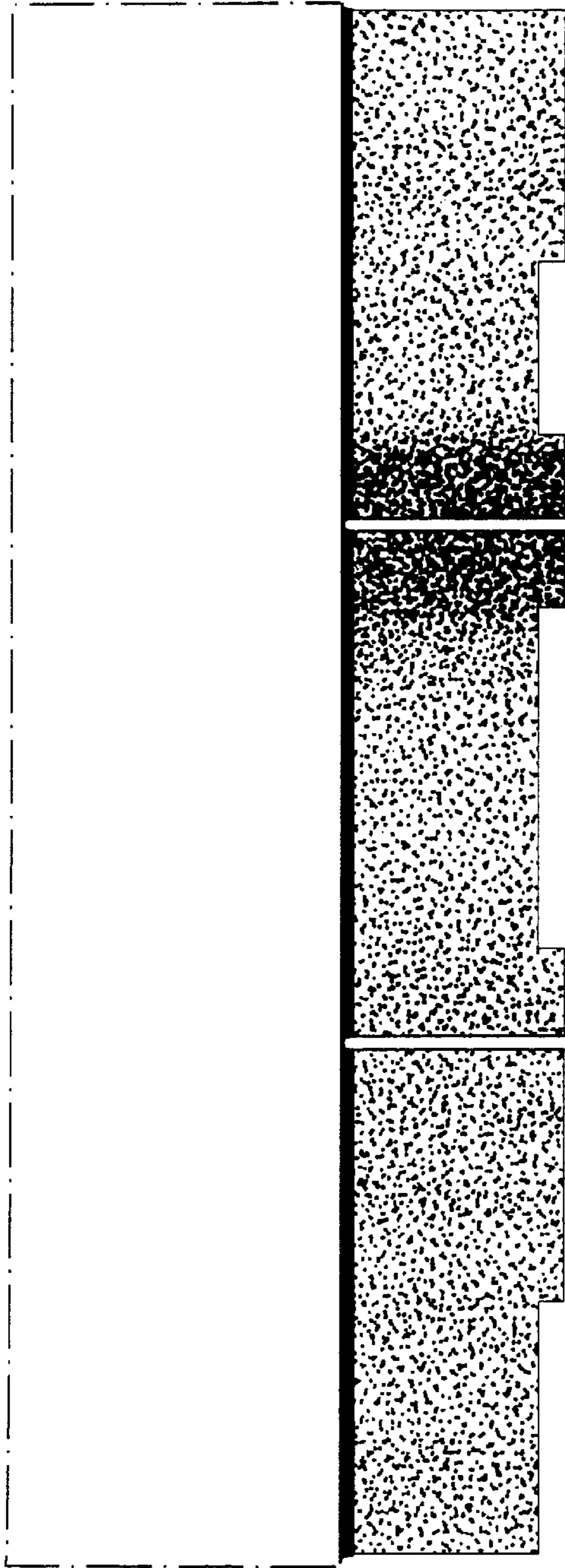

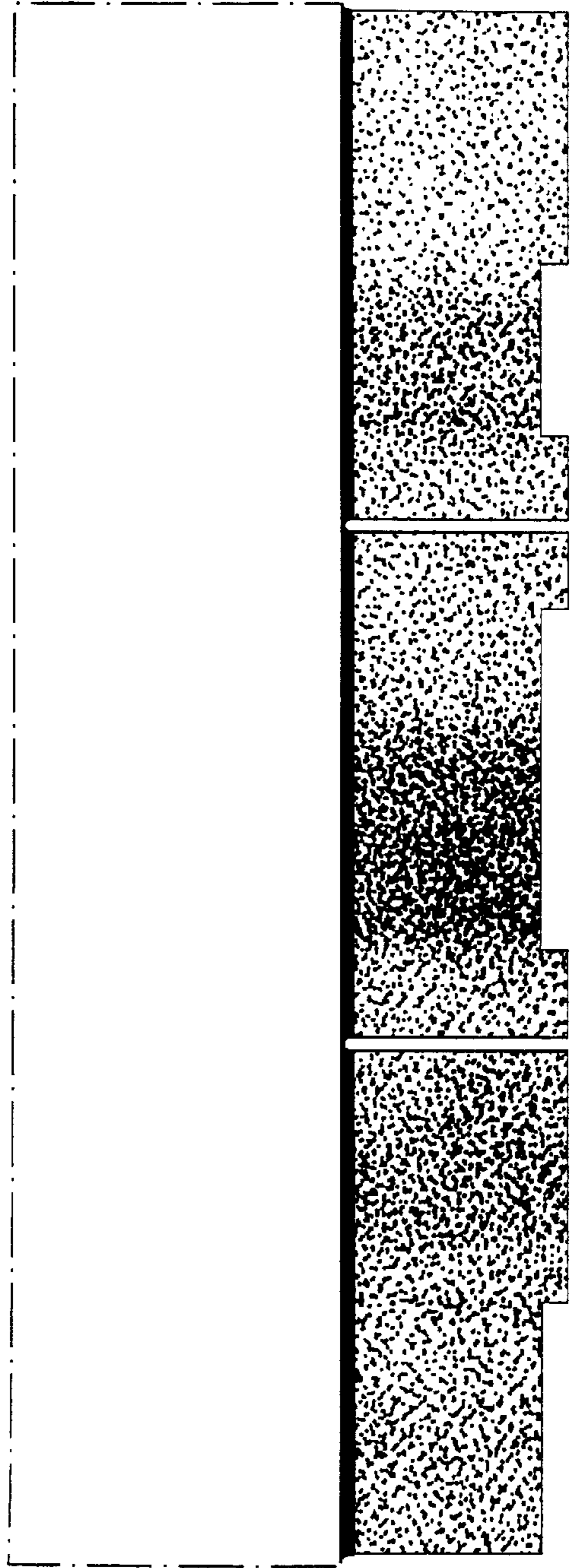

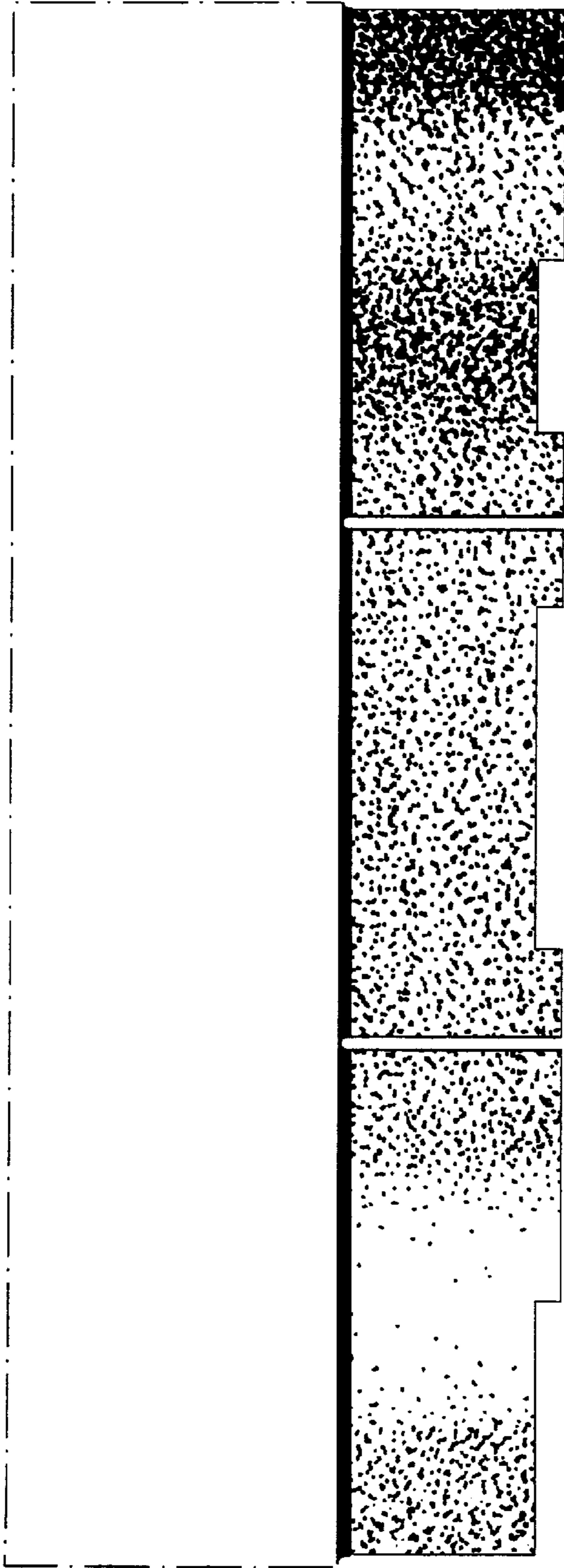

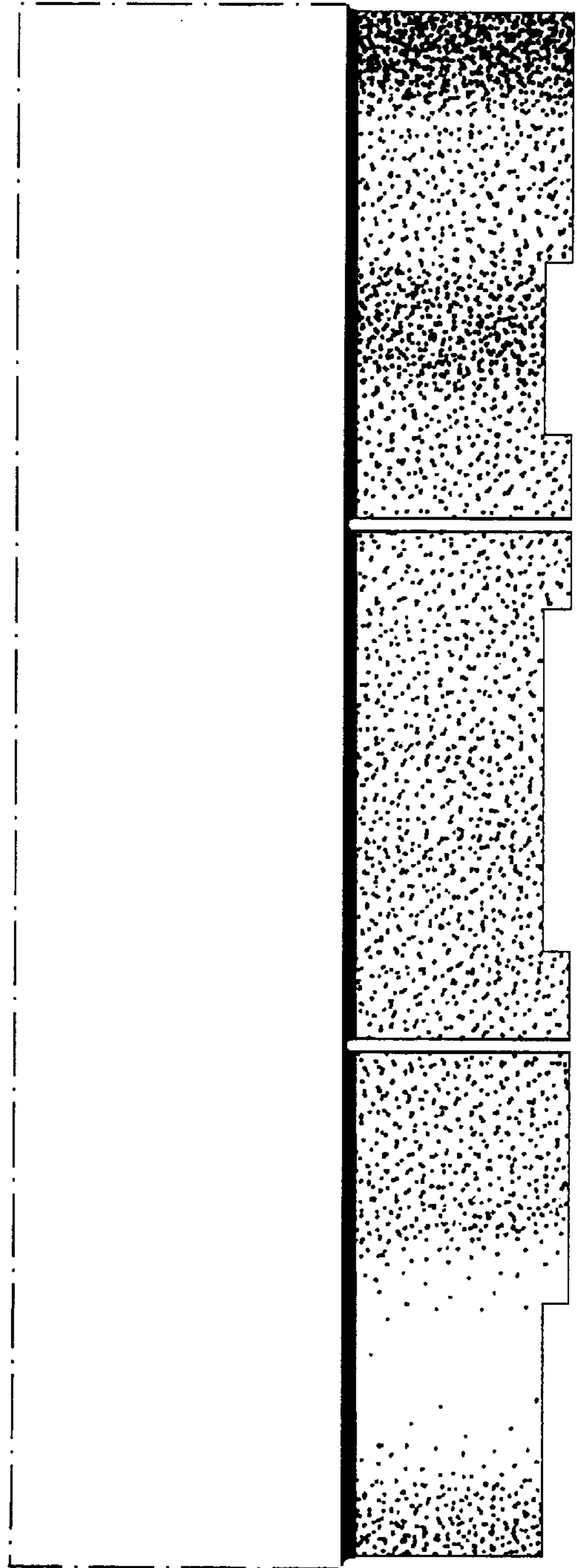

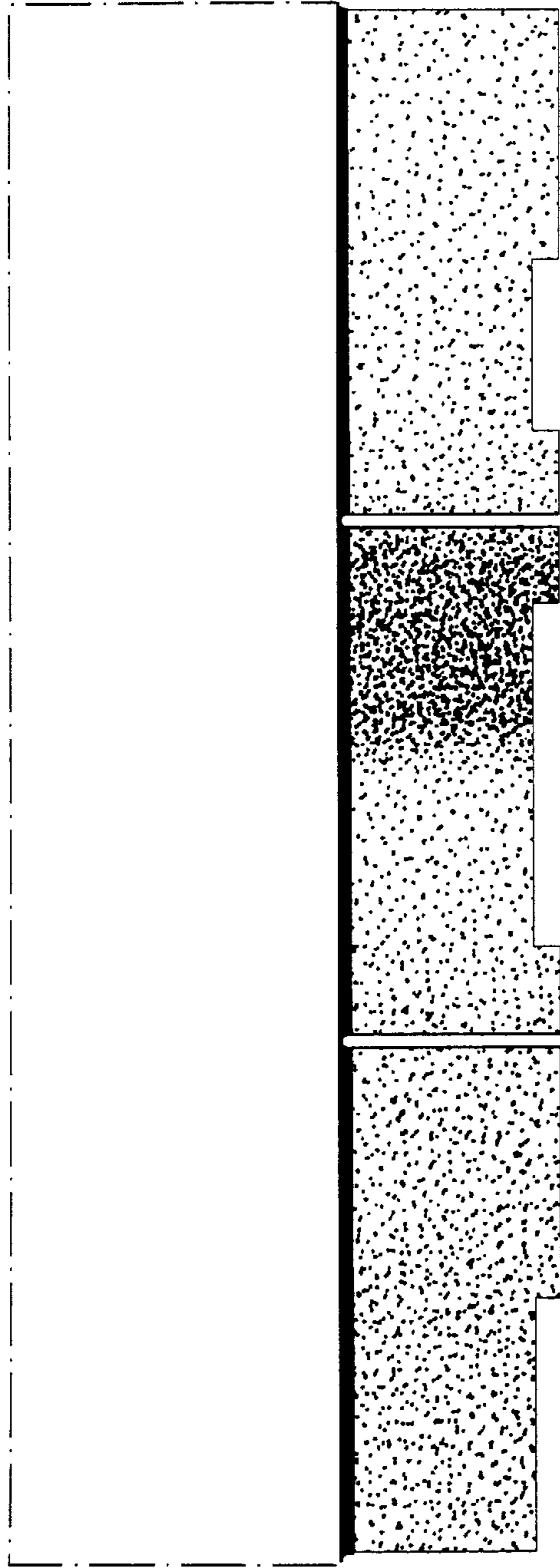

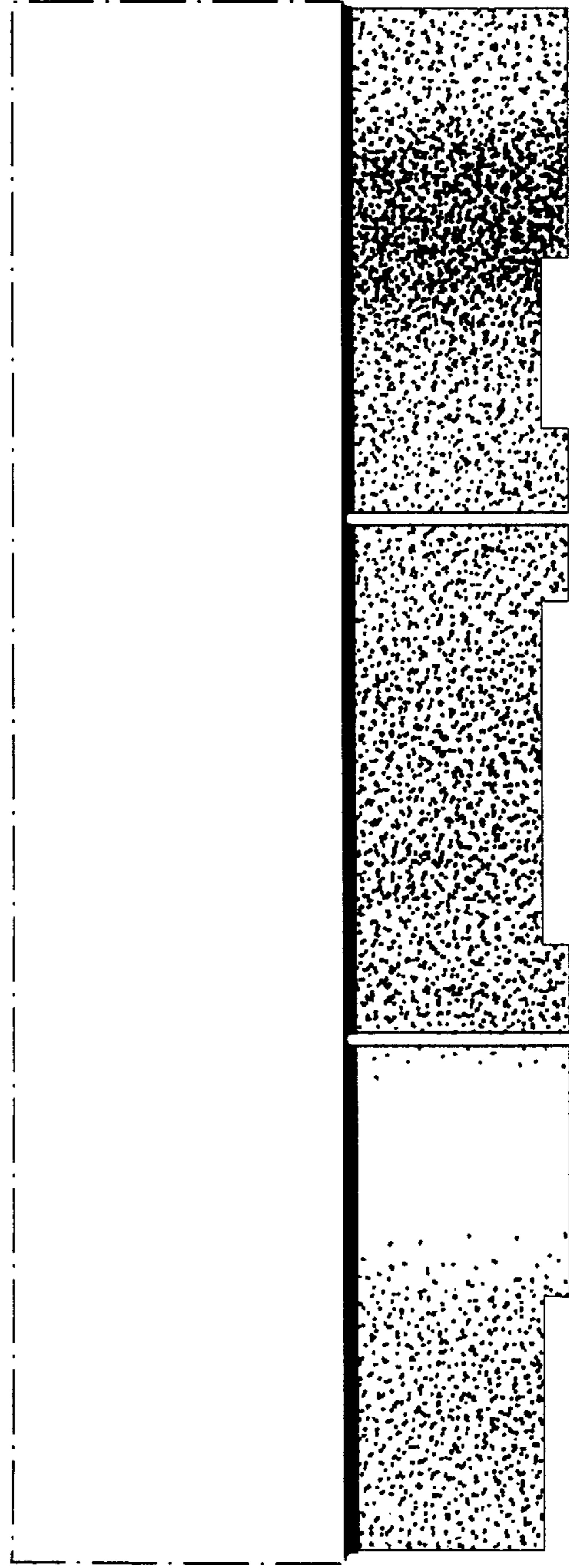
