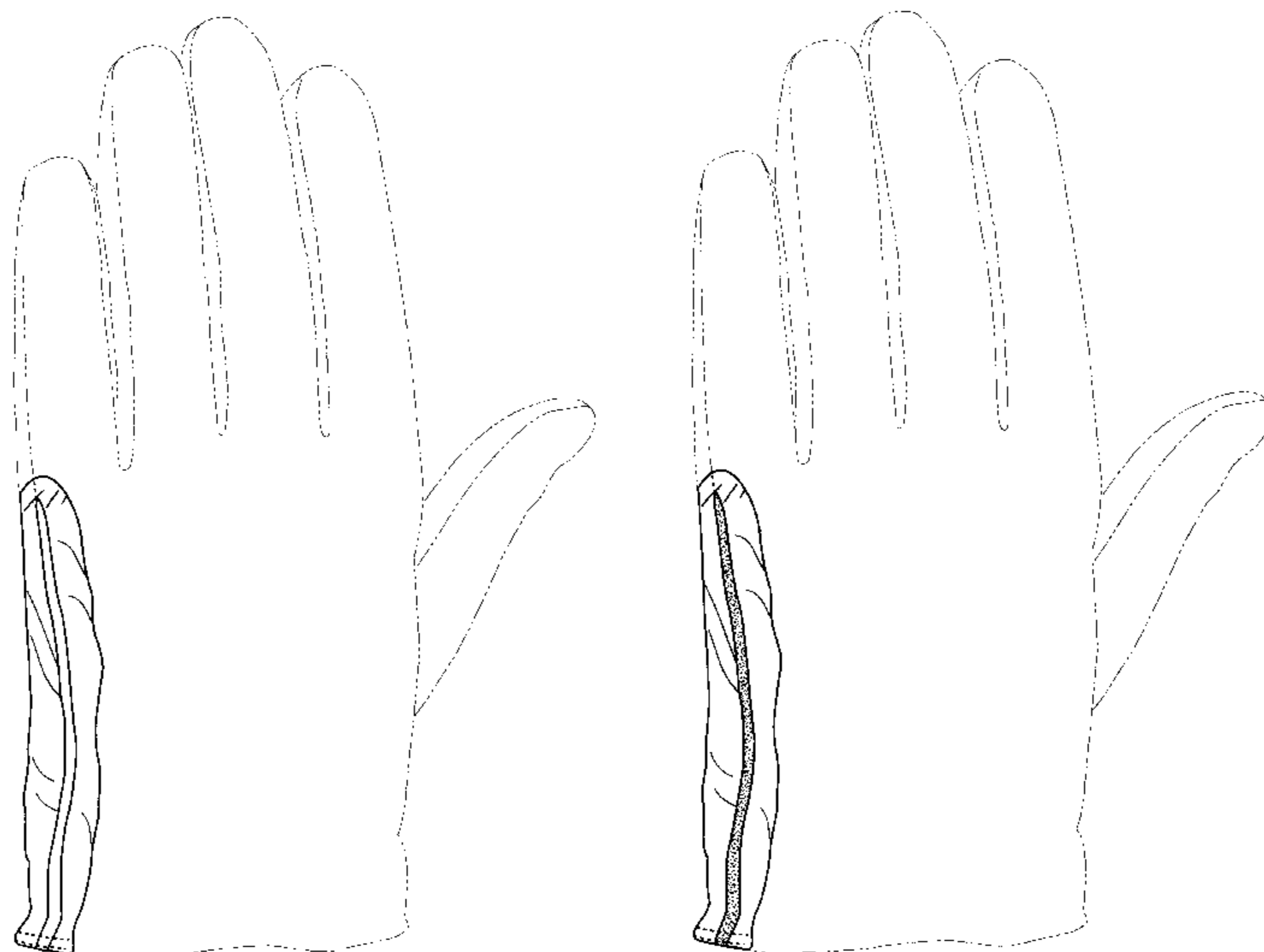
[57] **CLAIM**

The ornamental design for a outside edge seam for a glove, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of an outside edge seam for a glove showing our new design; FIG. 2 is a left side view thereof; FIG. 3 is a back end view thereof; FIG. 4 is a top plan view of an outside edge seam for a glove showing a second embodiment of our new design, wherein the outside edge seam is of a different color from the glove; FIG. 5 is a left side view thereof; and, FIG. 6 is a back end view thereof. The broken lines showing the glove and stitch lines in FIGS. 1-6 are for illustrative purposes only and form no part of the claimed design.

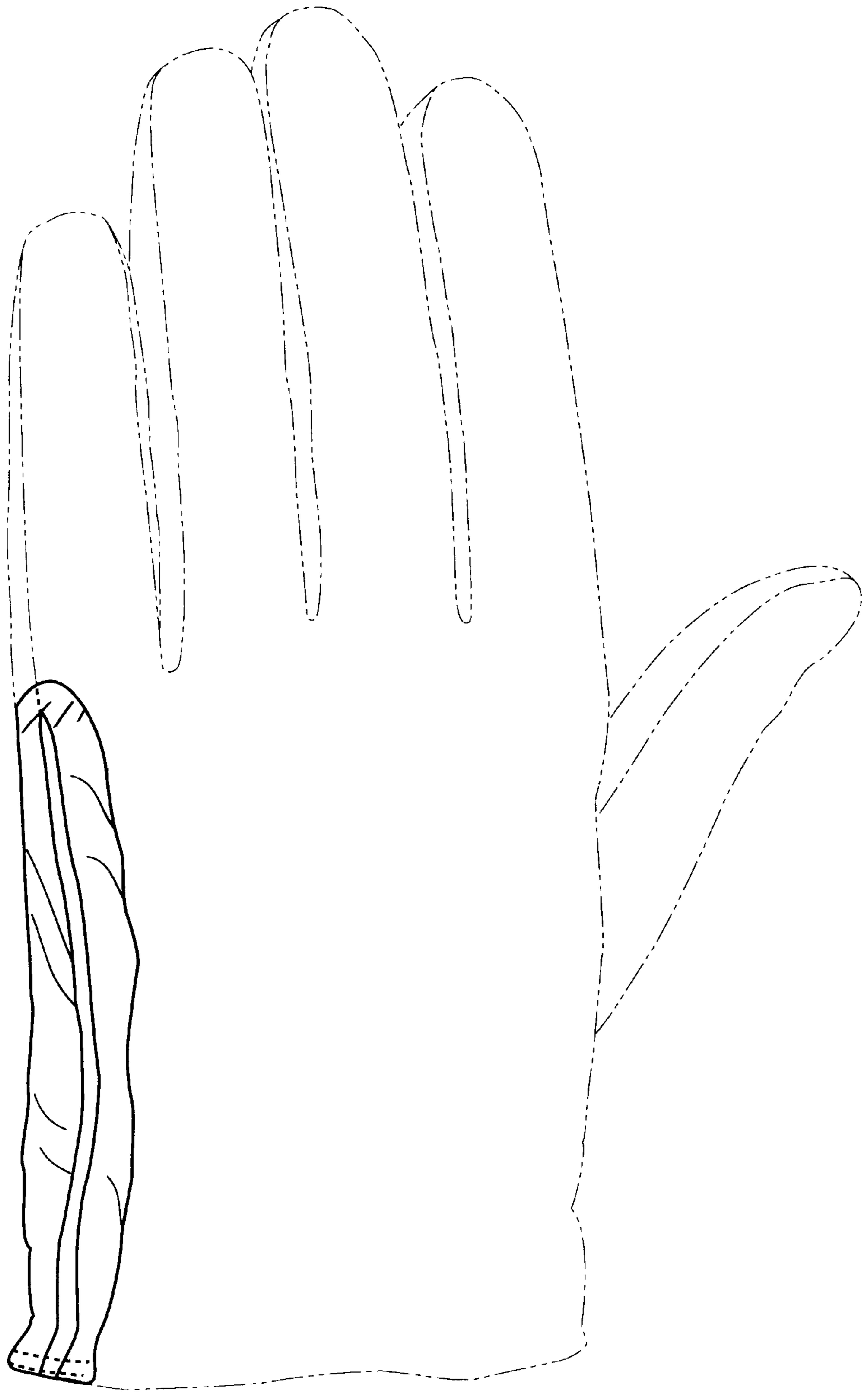

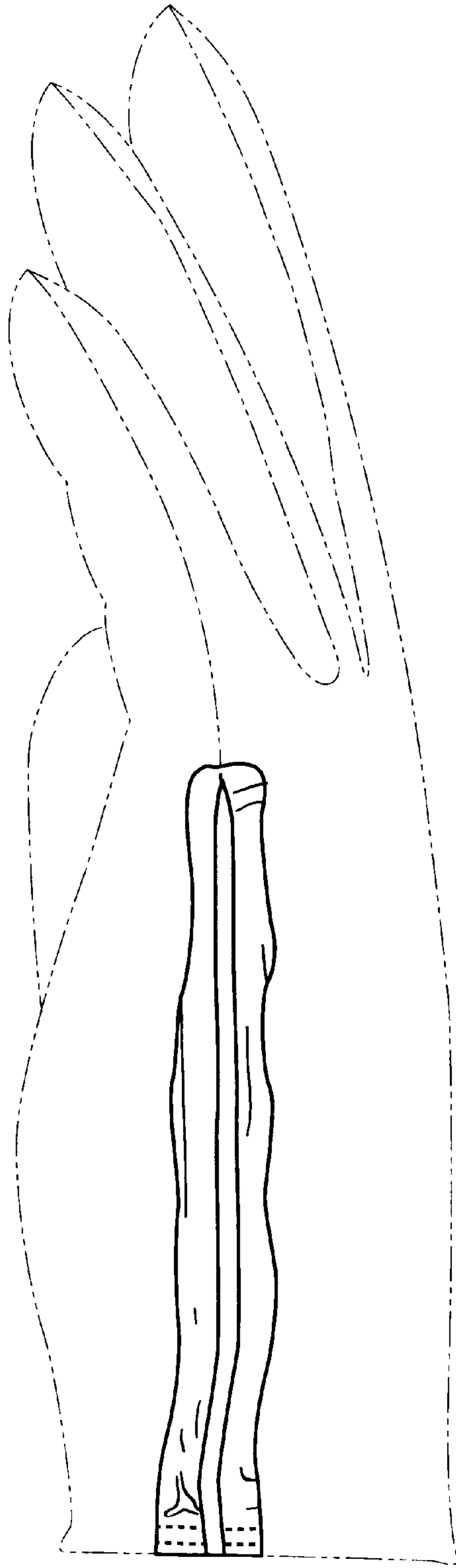
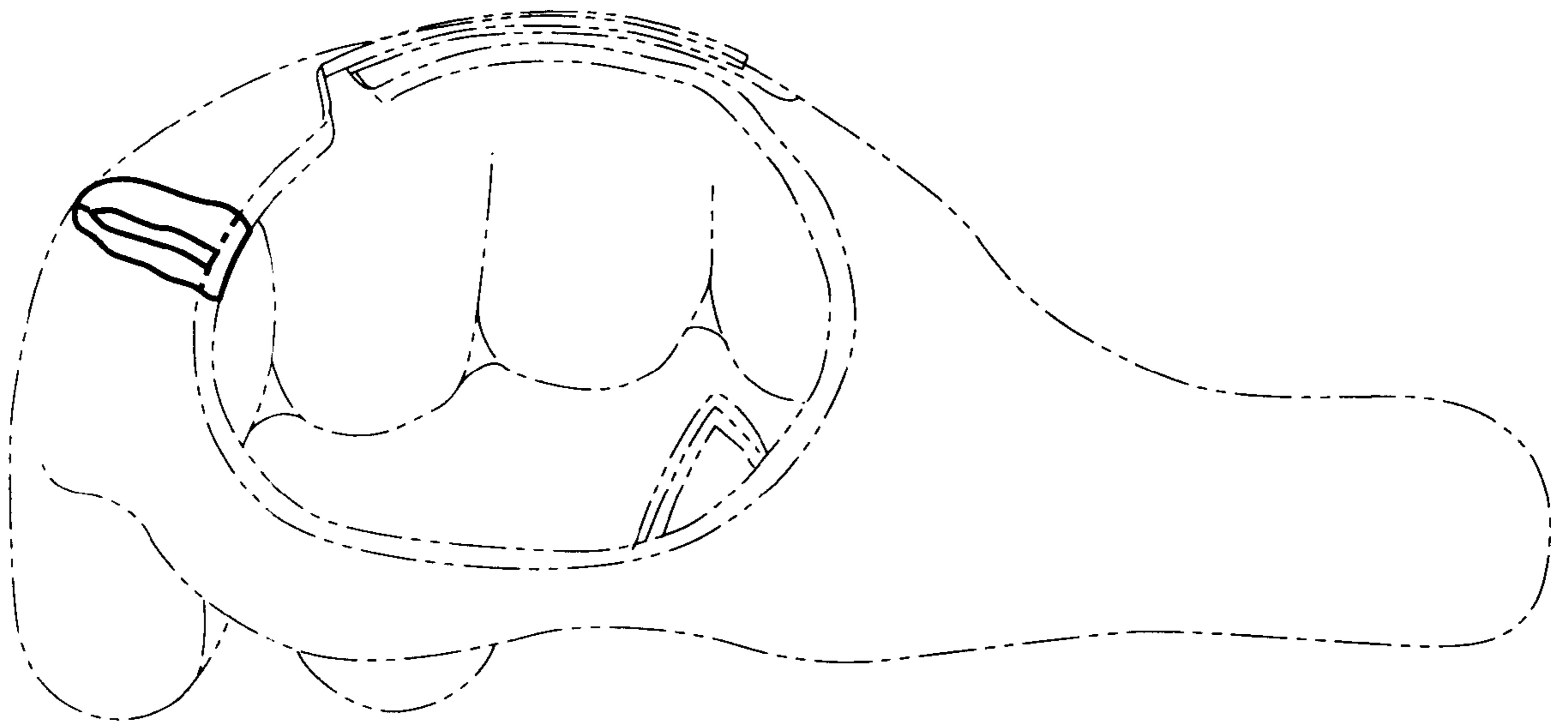

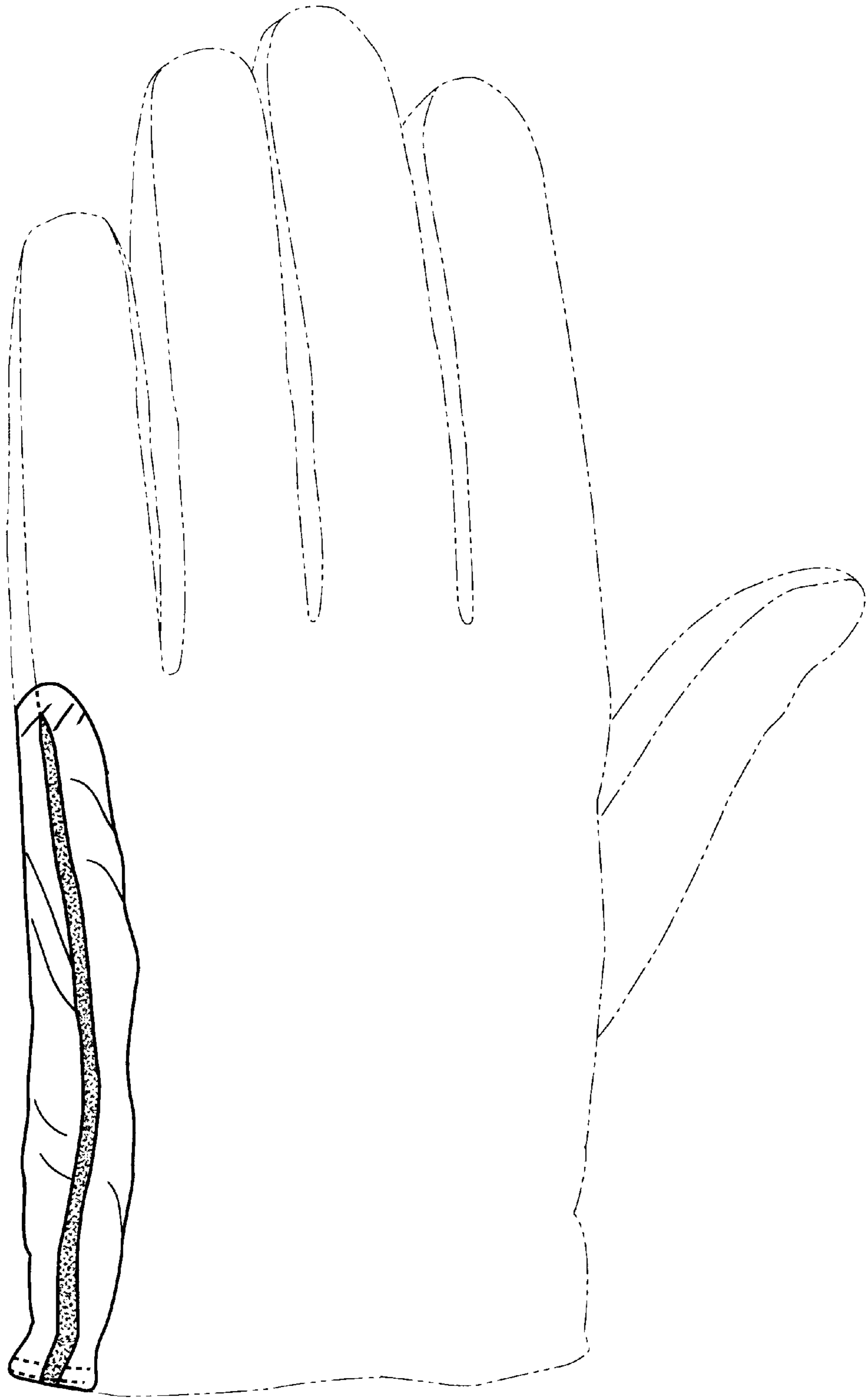

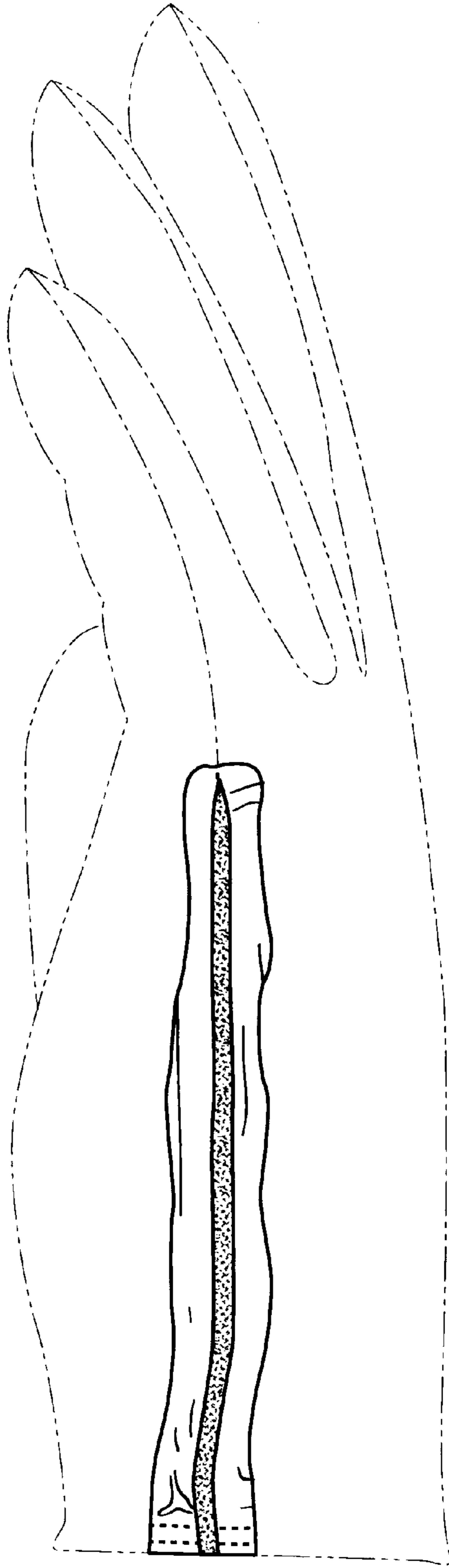

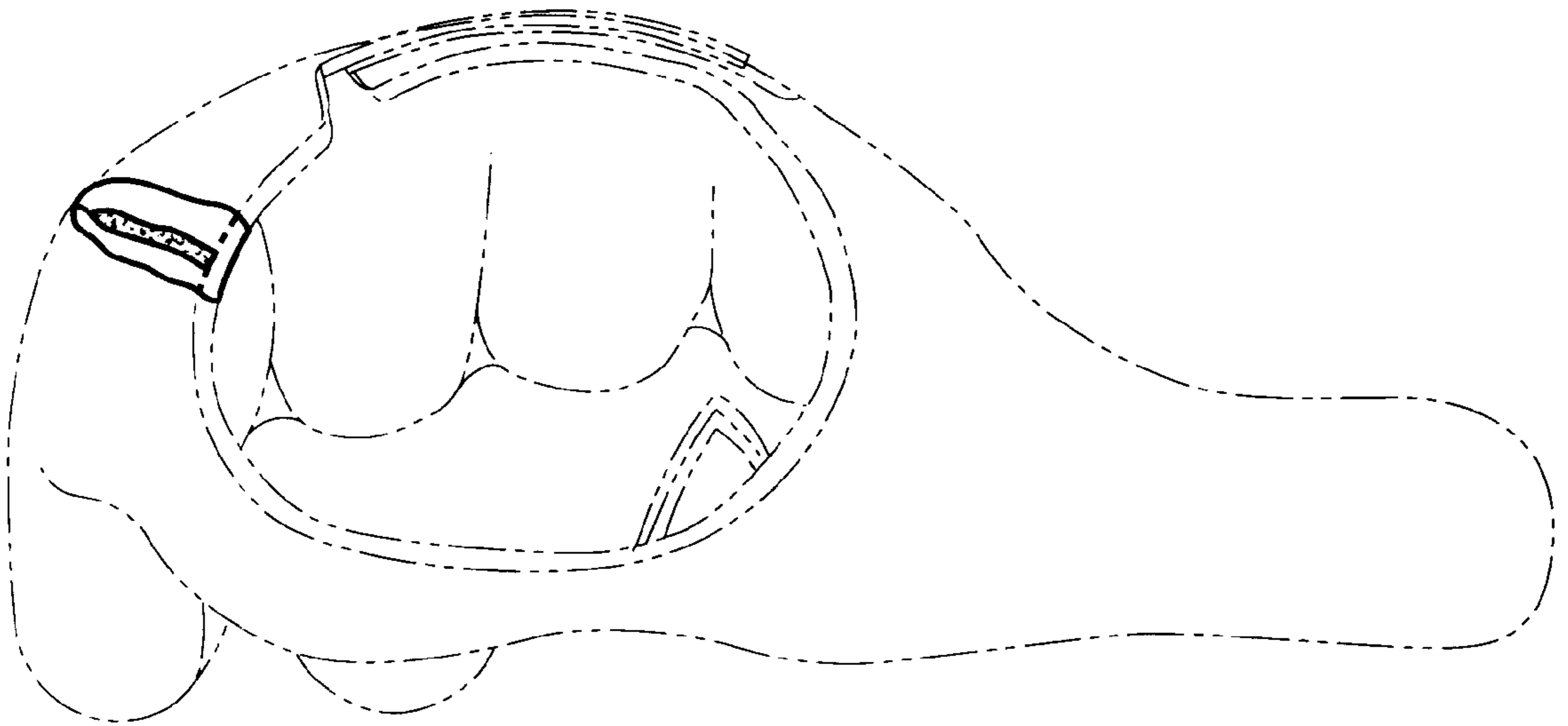
