**DESCRIPTION**

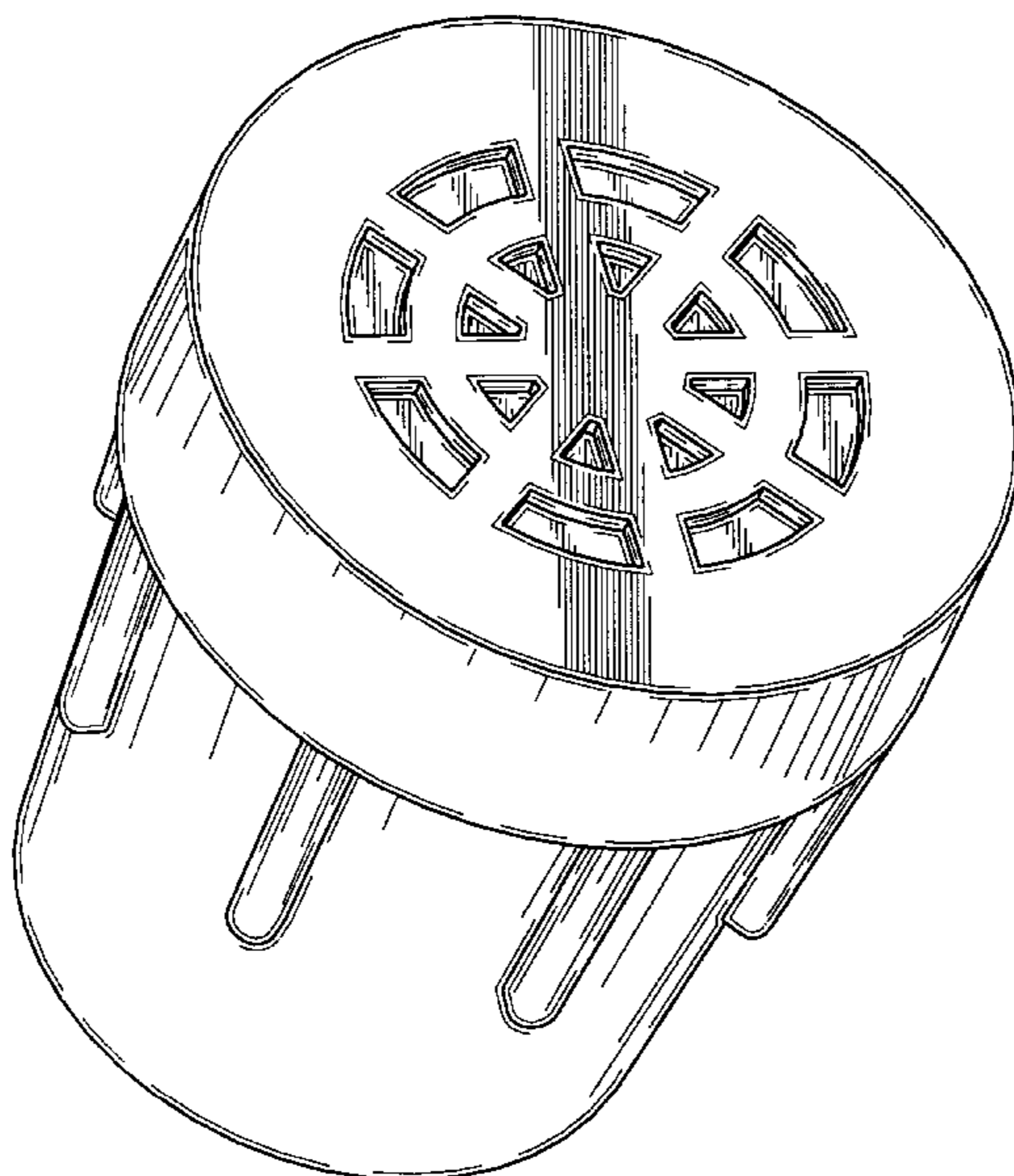
FIG. 1 is a bottom perspective view of a cane tip showing my new design;

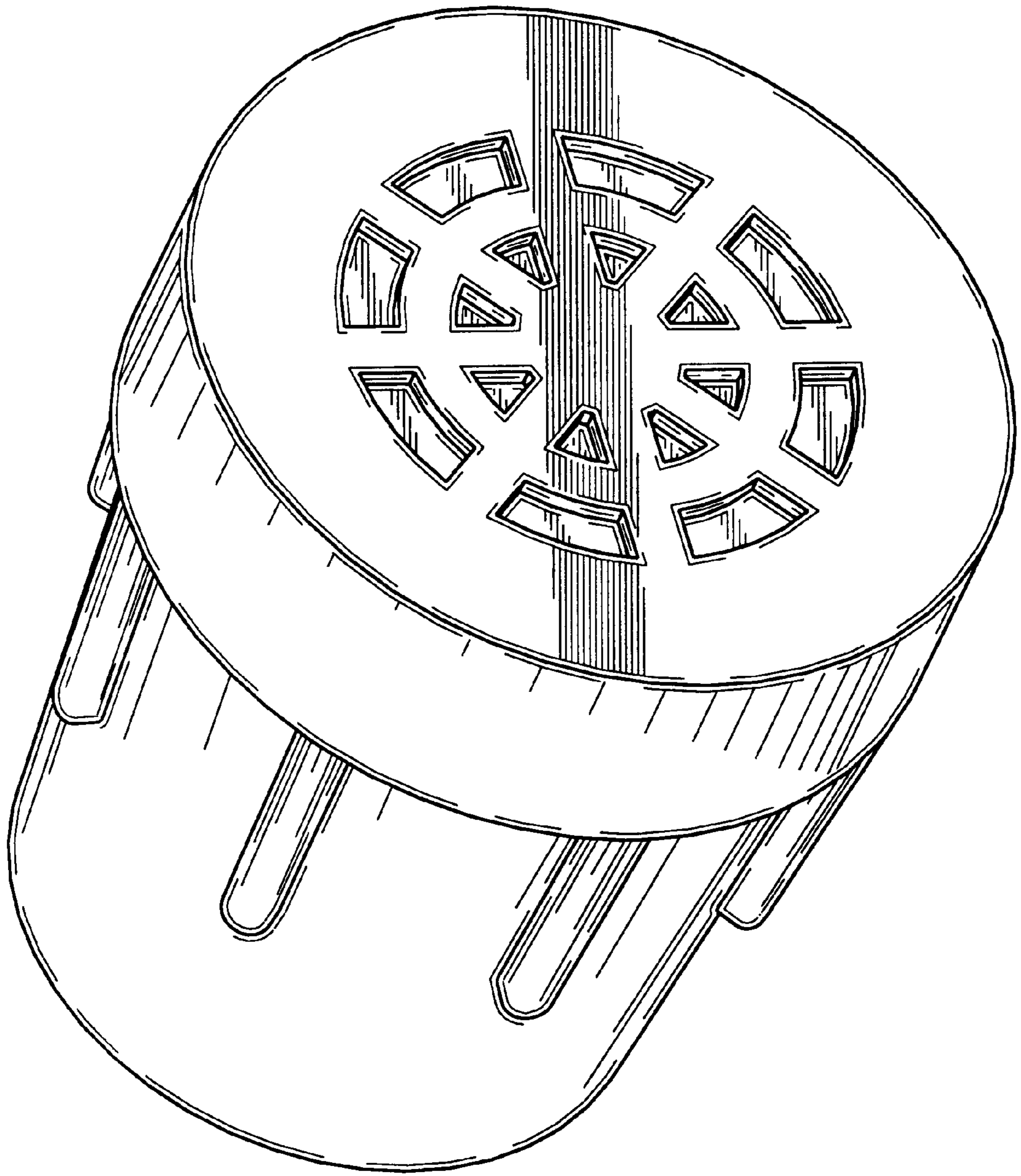

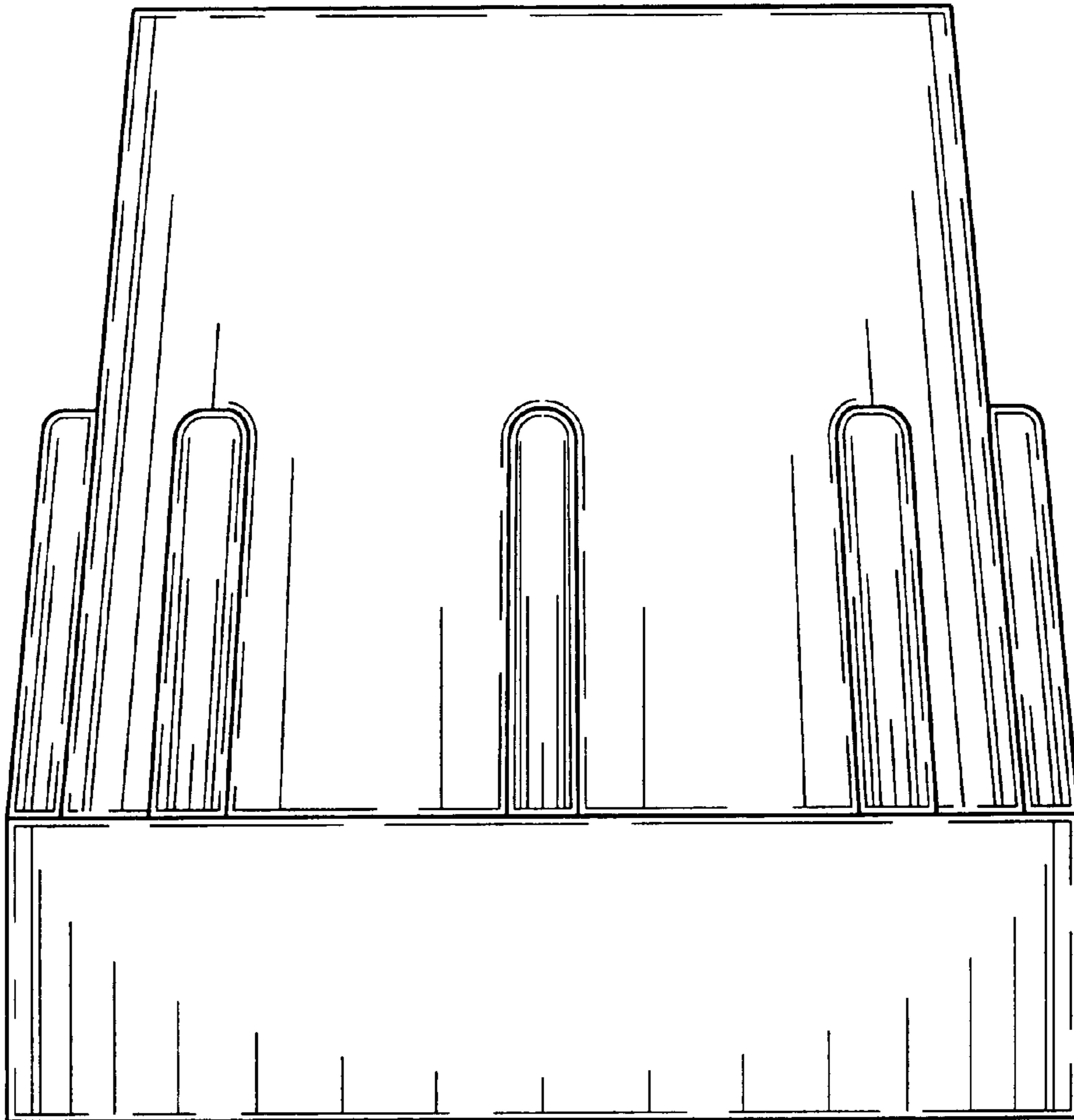

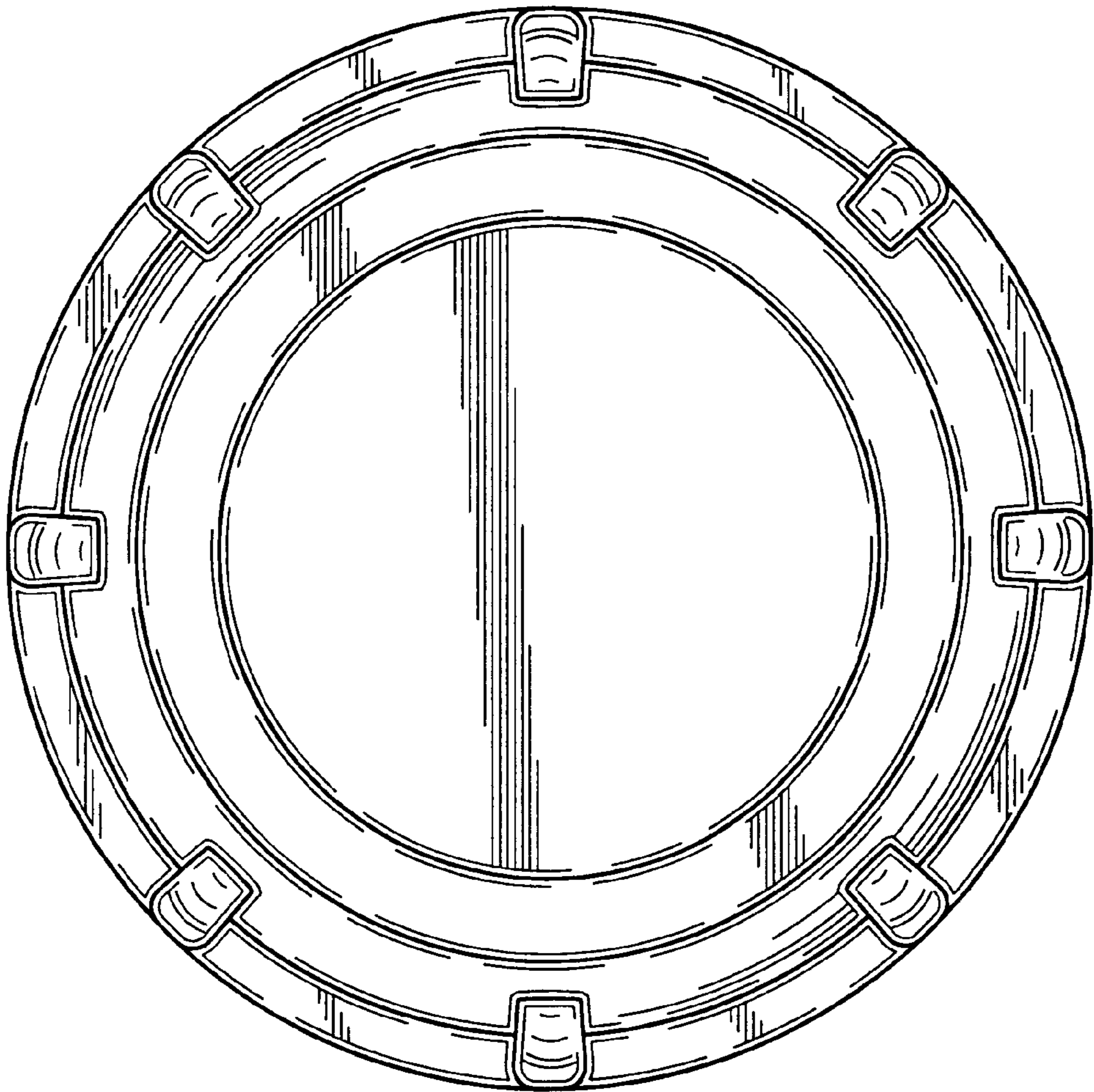

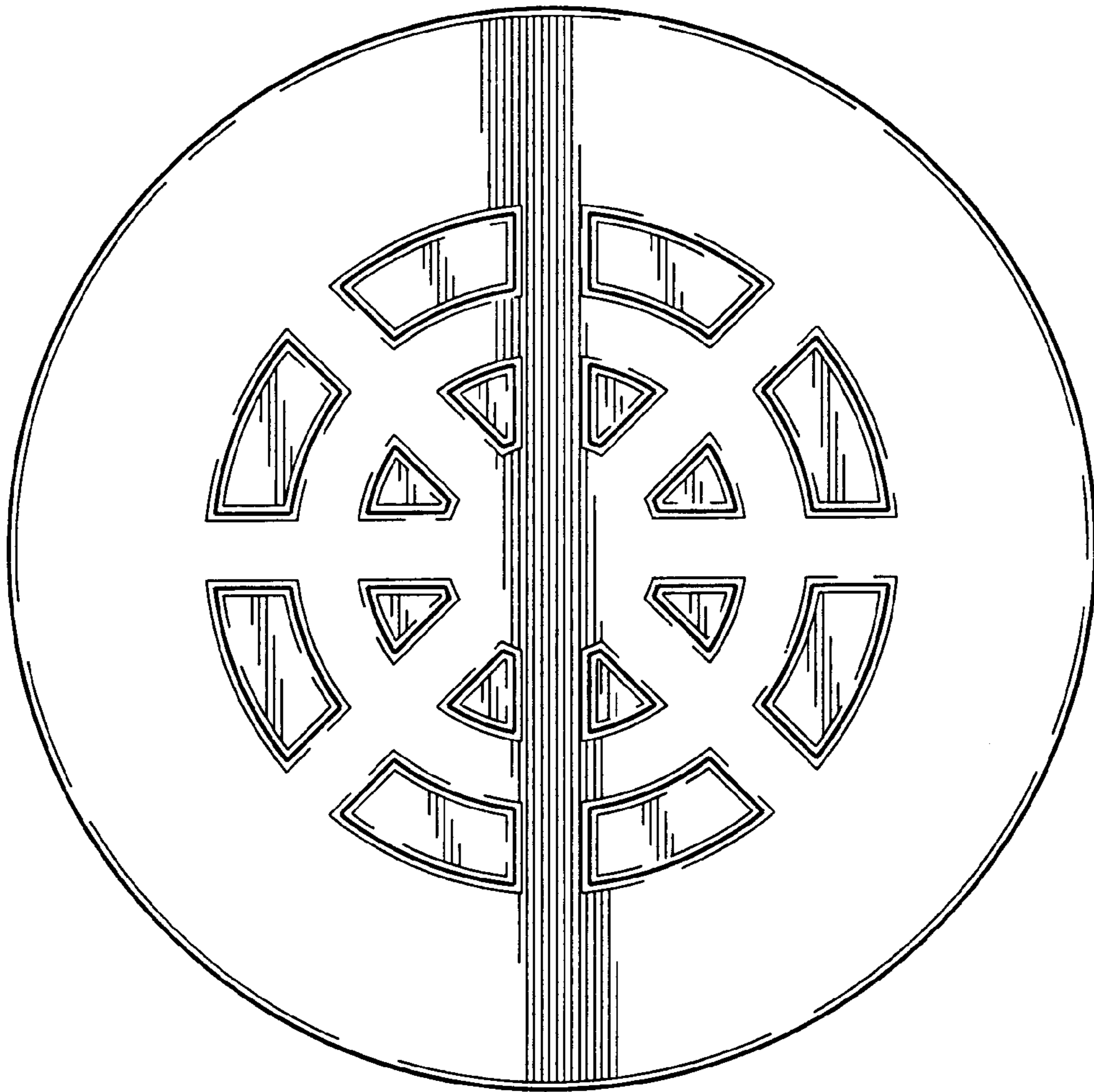
