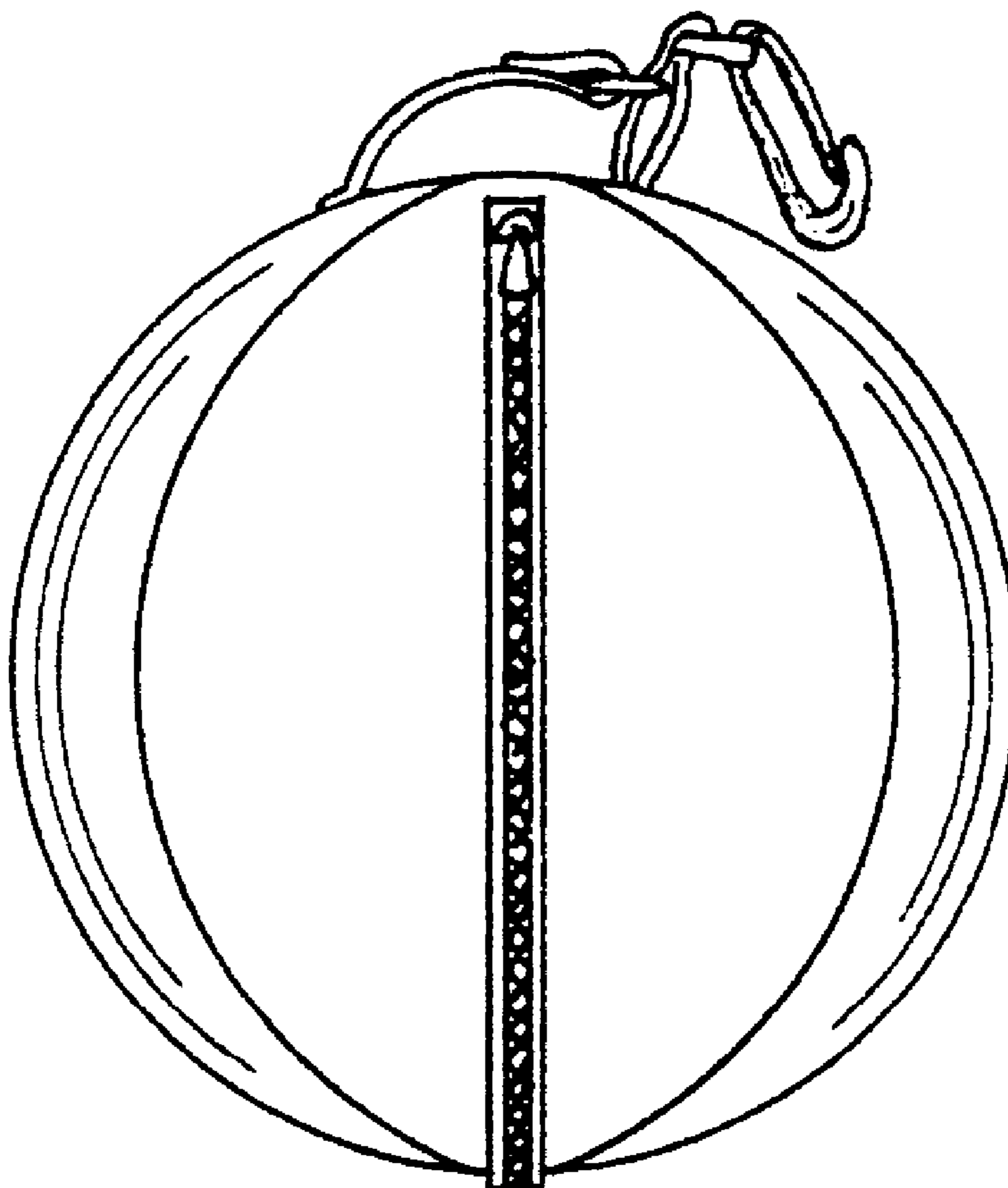
The ornamental design for a flexible ball bag, as shown and described.

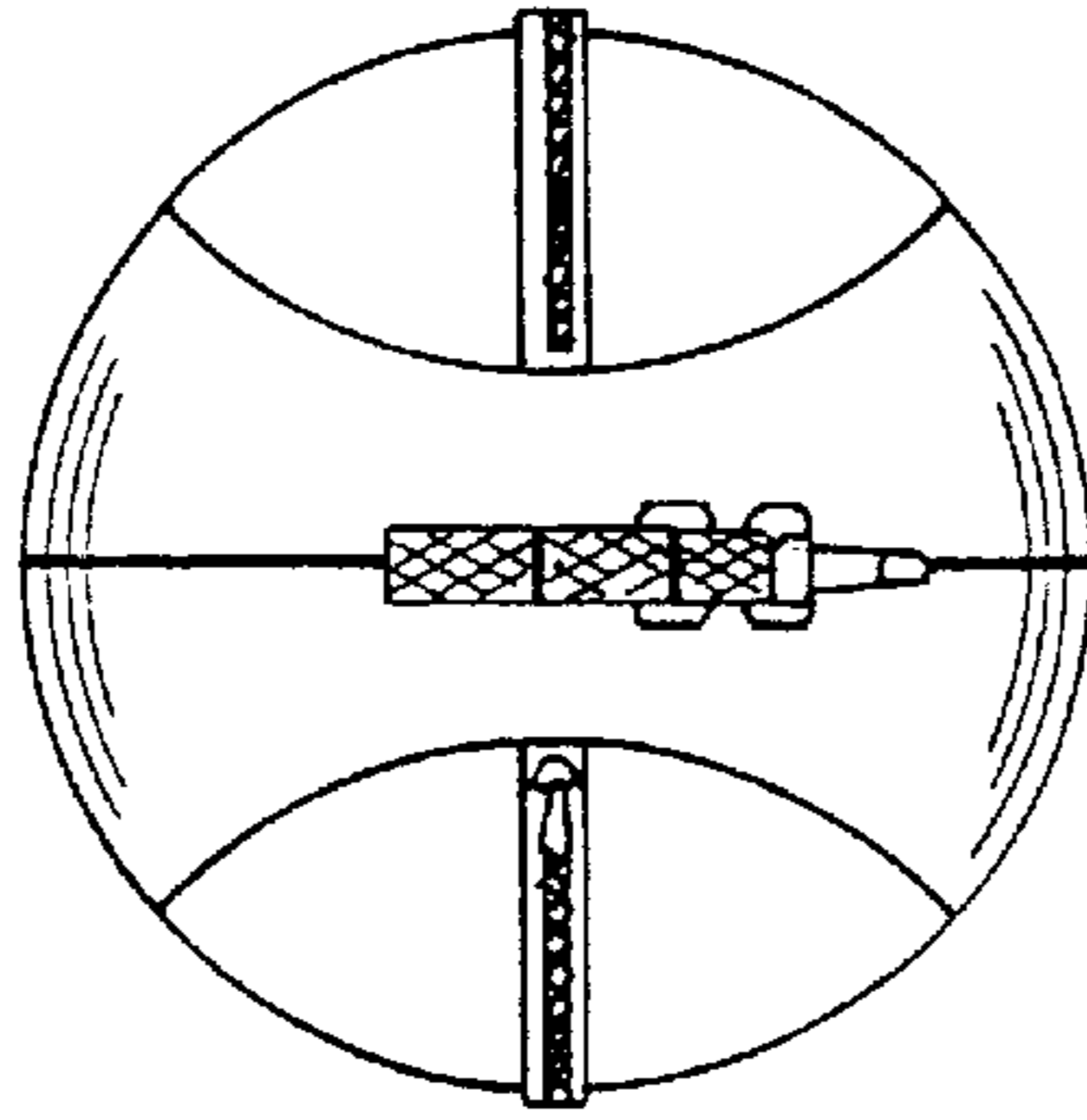
**DESCRIPTION**

FIG. 1 is a top plan view of the flexible ball bag showing a carrying handle oriented perpendicular to a zipper; FIG. 2 is a front elevational view of the flexible ball bag of FIG. 1; FIG. 3 is a right side elevational view of the flexible ball bag of FIG. 2; FIG. 4 is a left side elevational view of the flexible ball bag of FIG. 2; and, FIG. 5 is a bottom plan view of the flexible ball bag of FIG. 2.

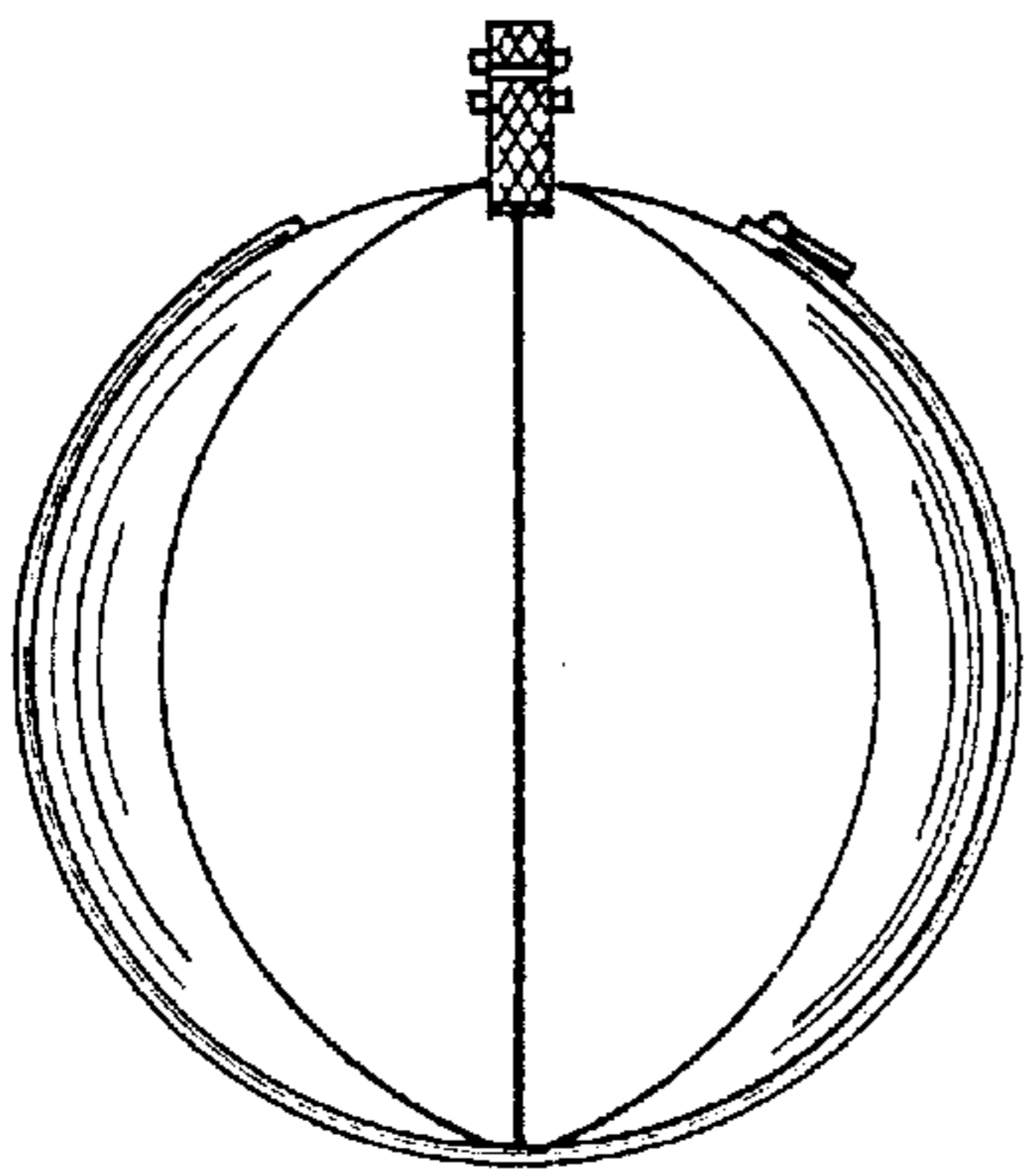
The characteristic feature of this design resides in the distinctive appearance of the carrying handle extending perpendicular to the zipper.

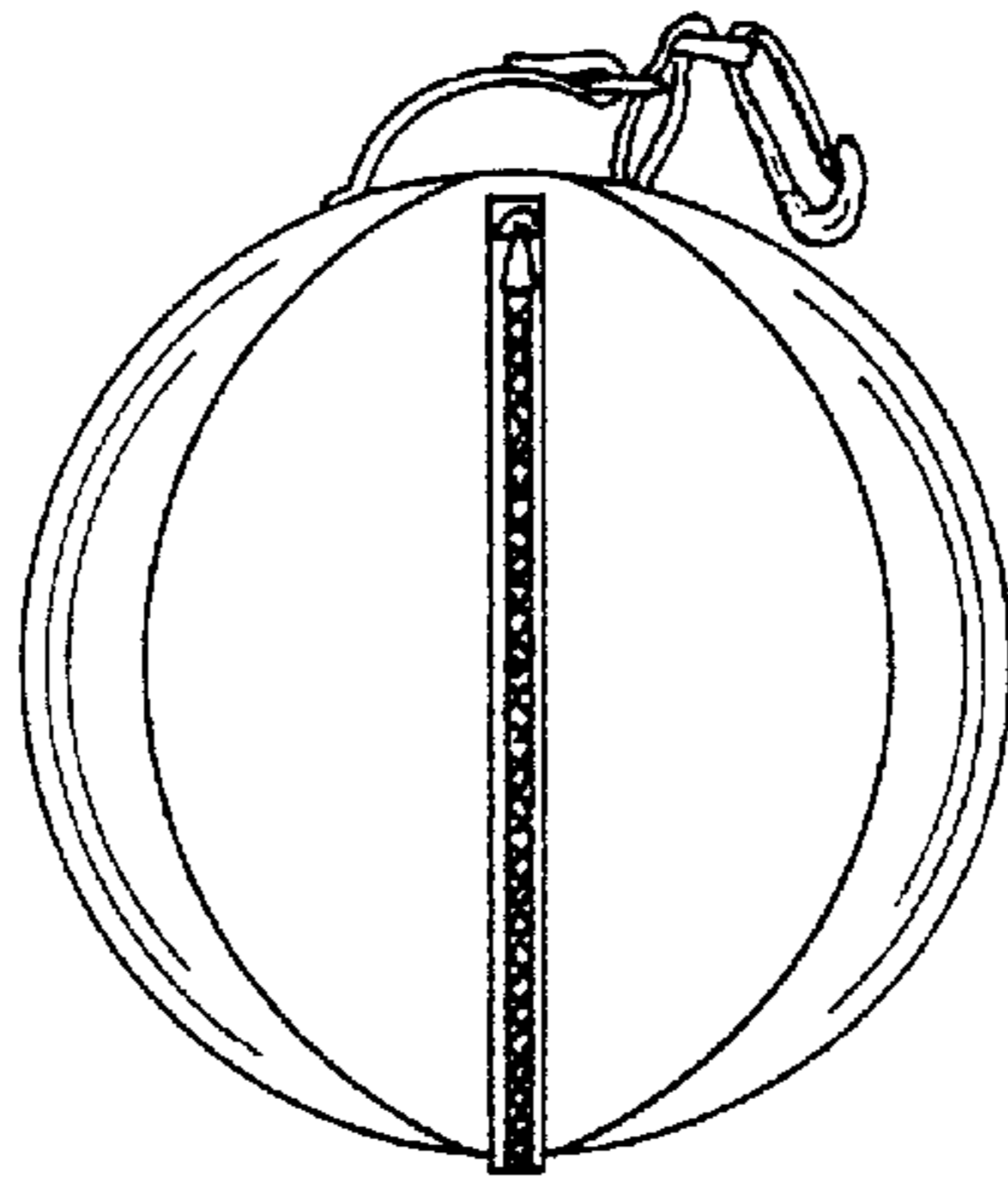




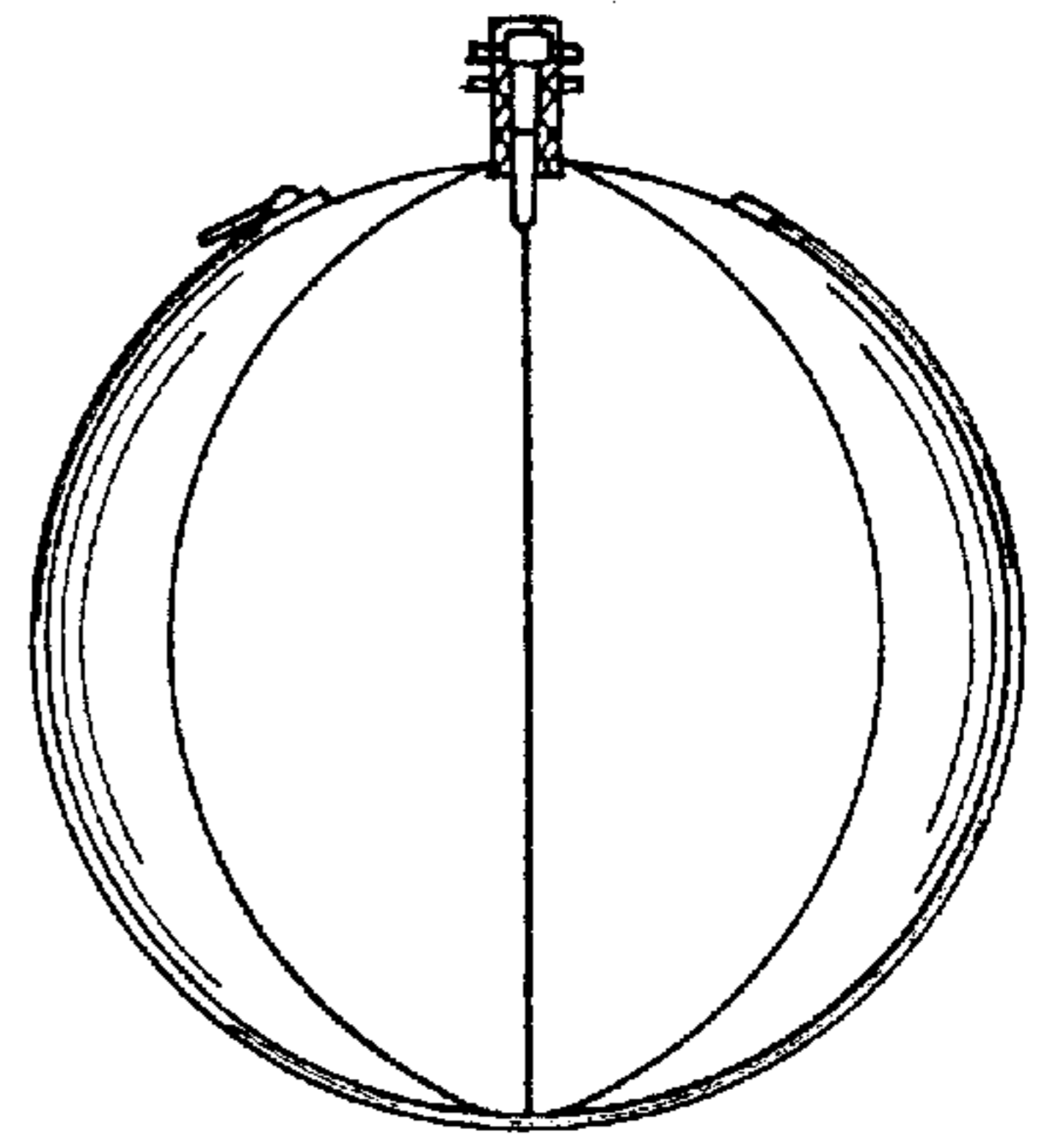

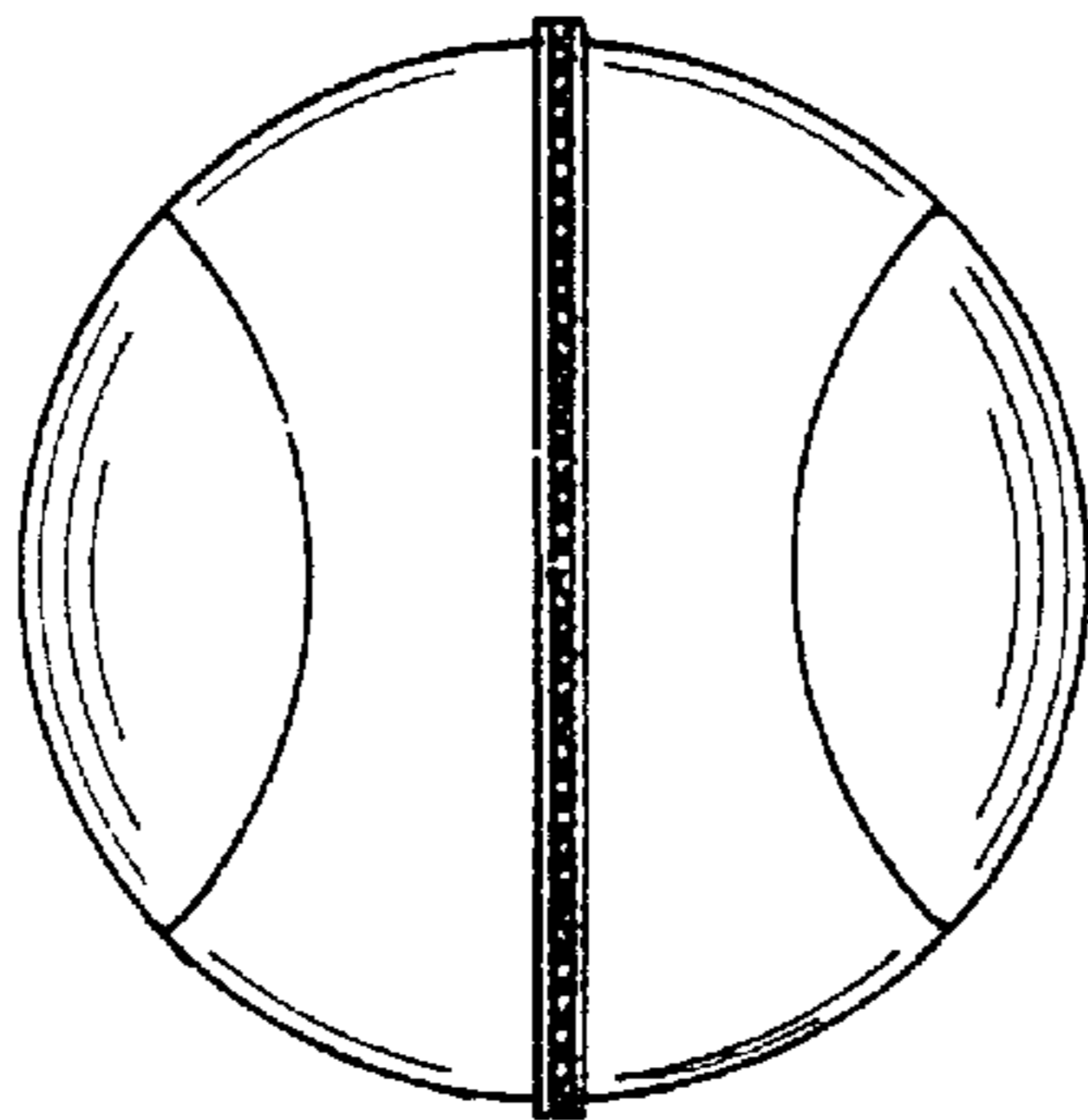
