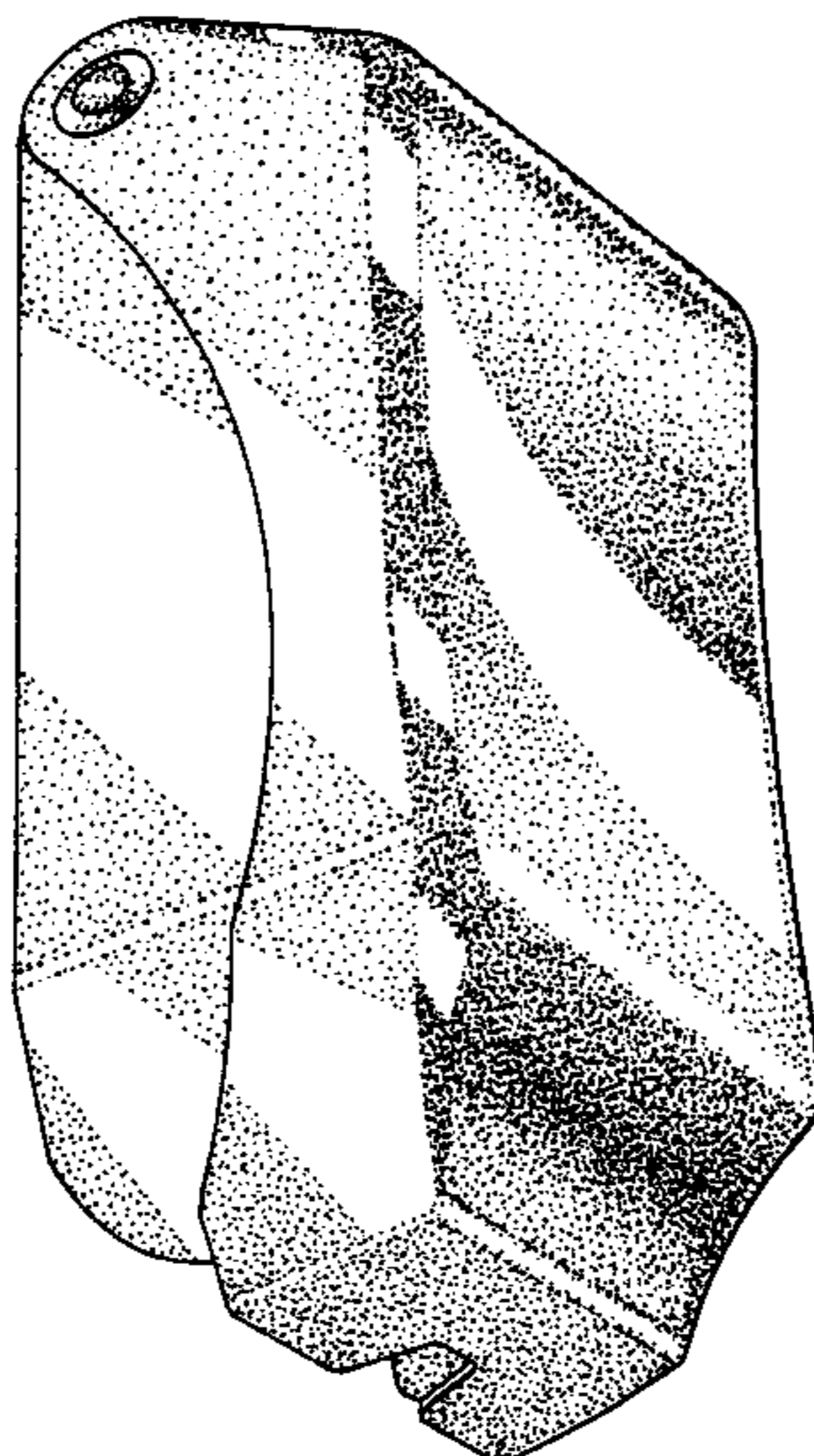
[57] **CLAIM**

The ornamental design for a hinged dispenser housing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an ornamental design for a hinged dispenser housing, in accordance with the invention; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side elevational view thereof, with the left side being a mirror image; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom view thereof; and, FIG. 6 is a rear elevational view thereof.

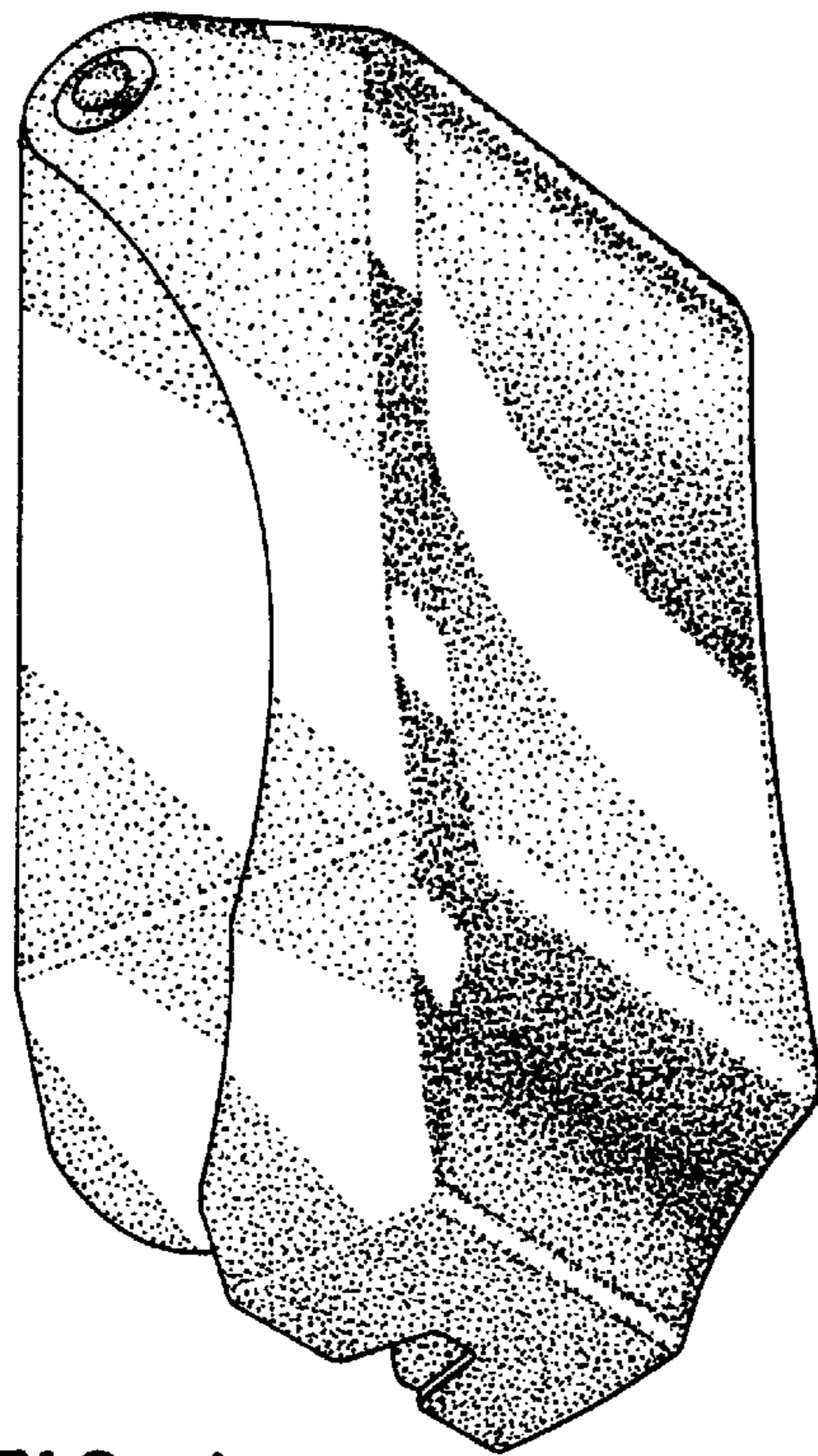

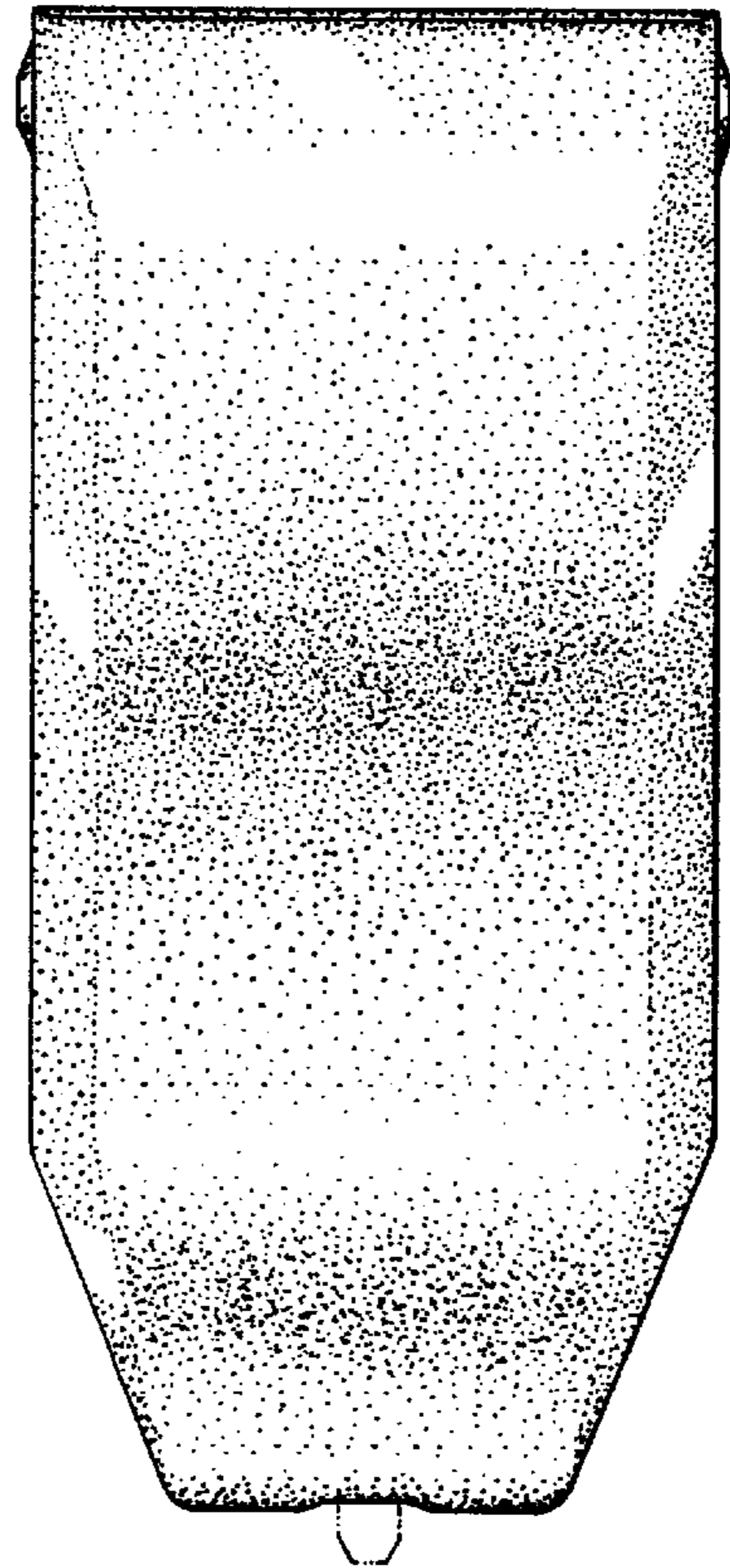

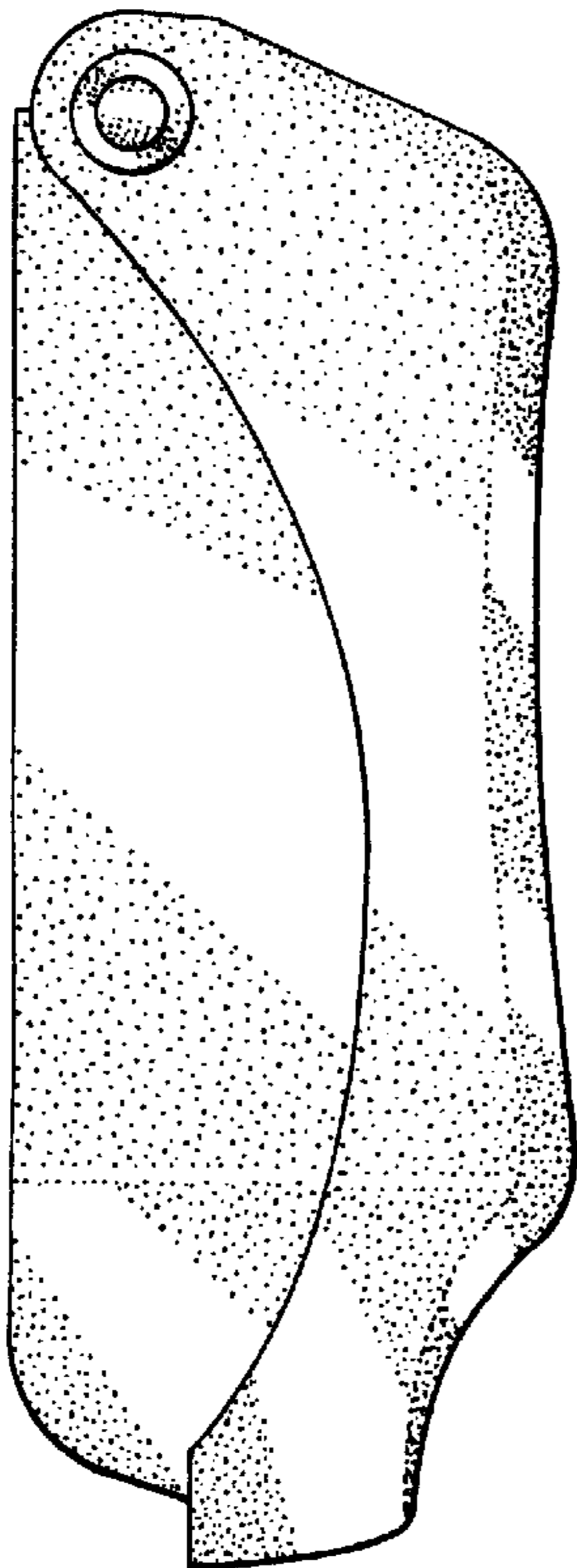

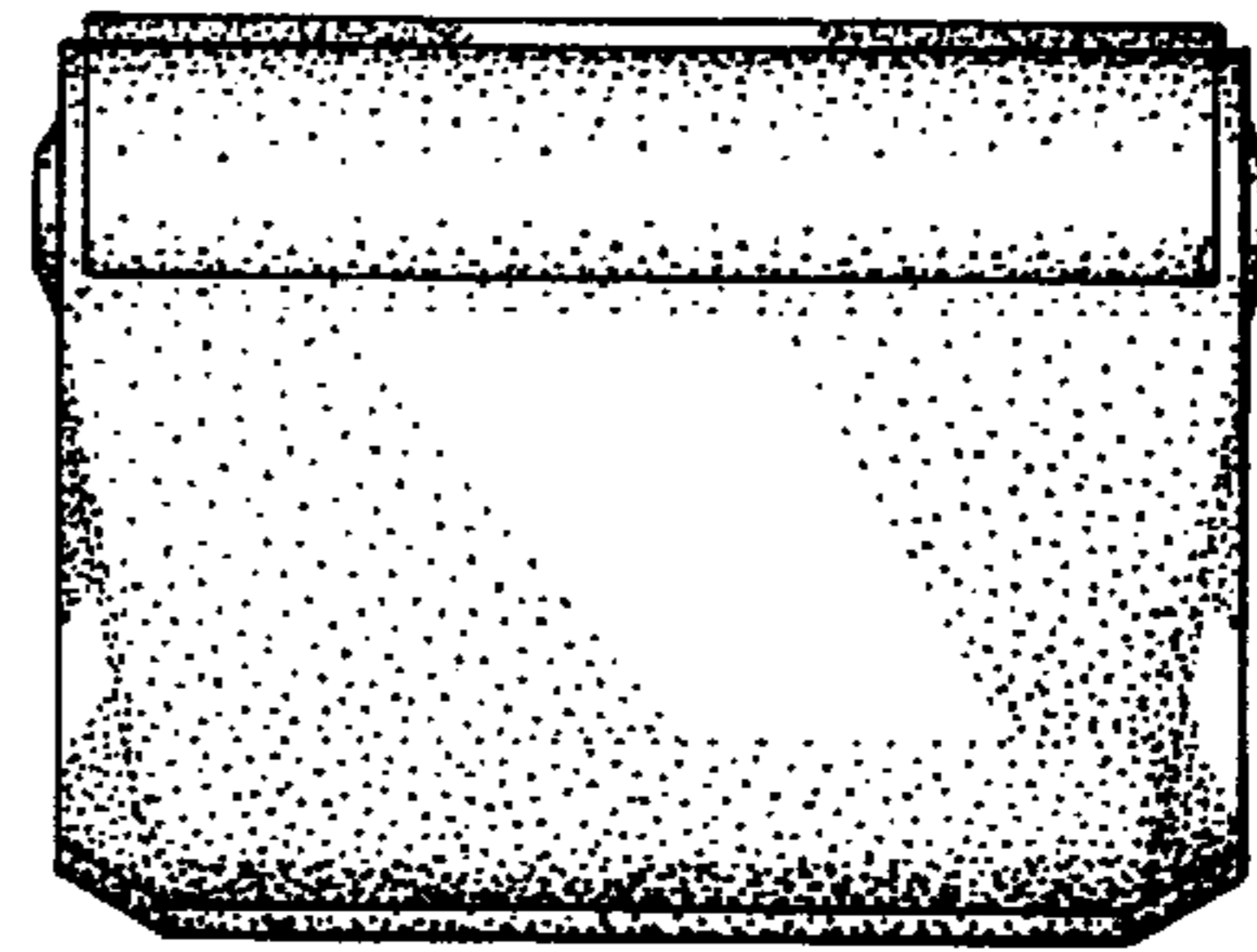

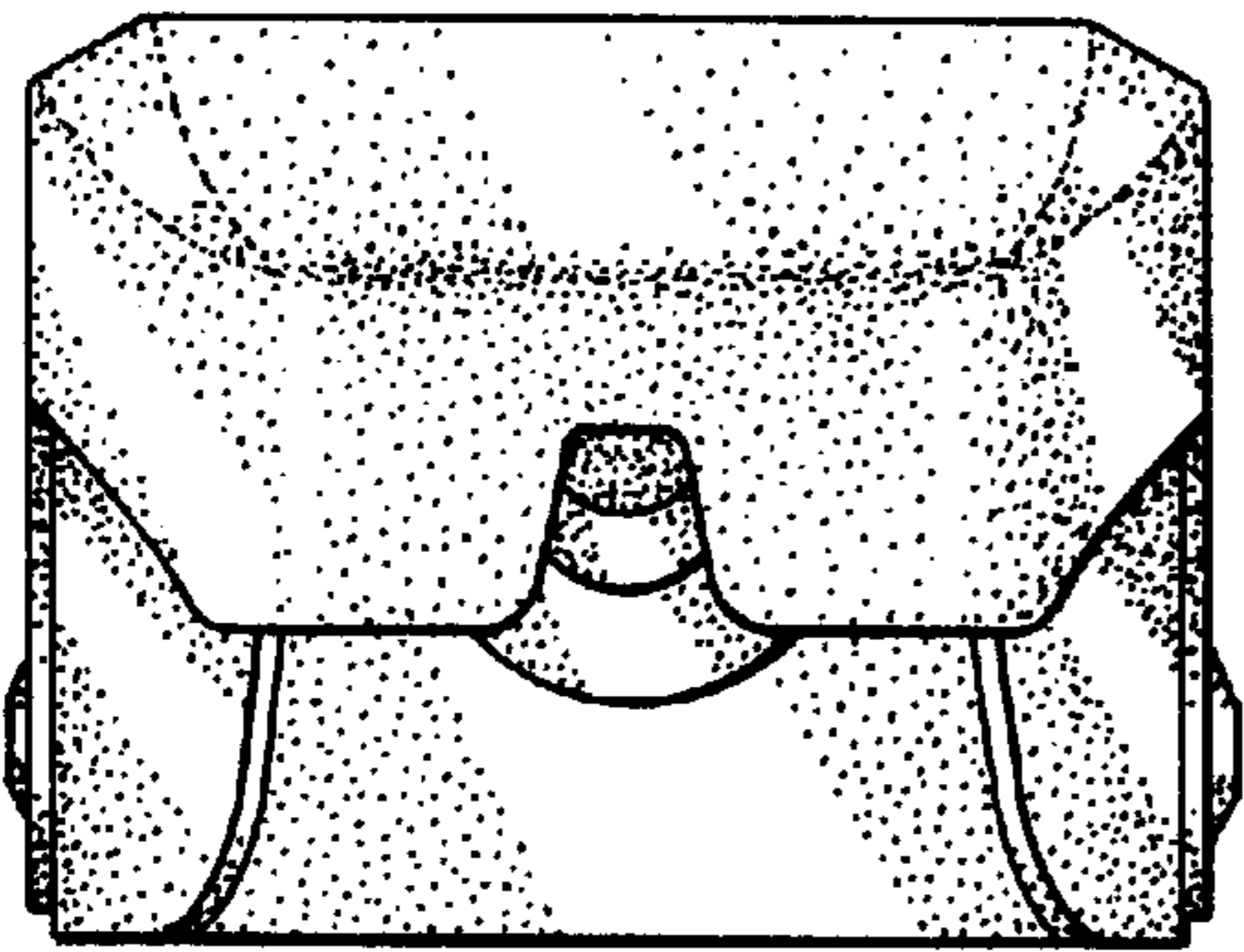

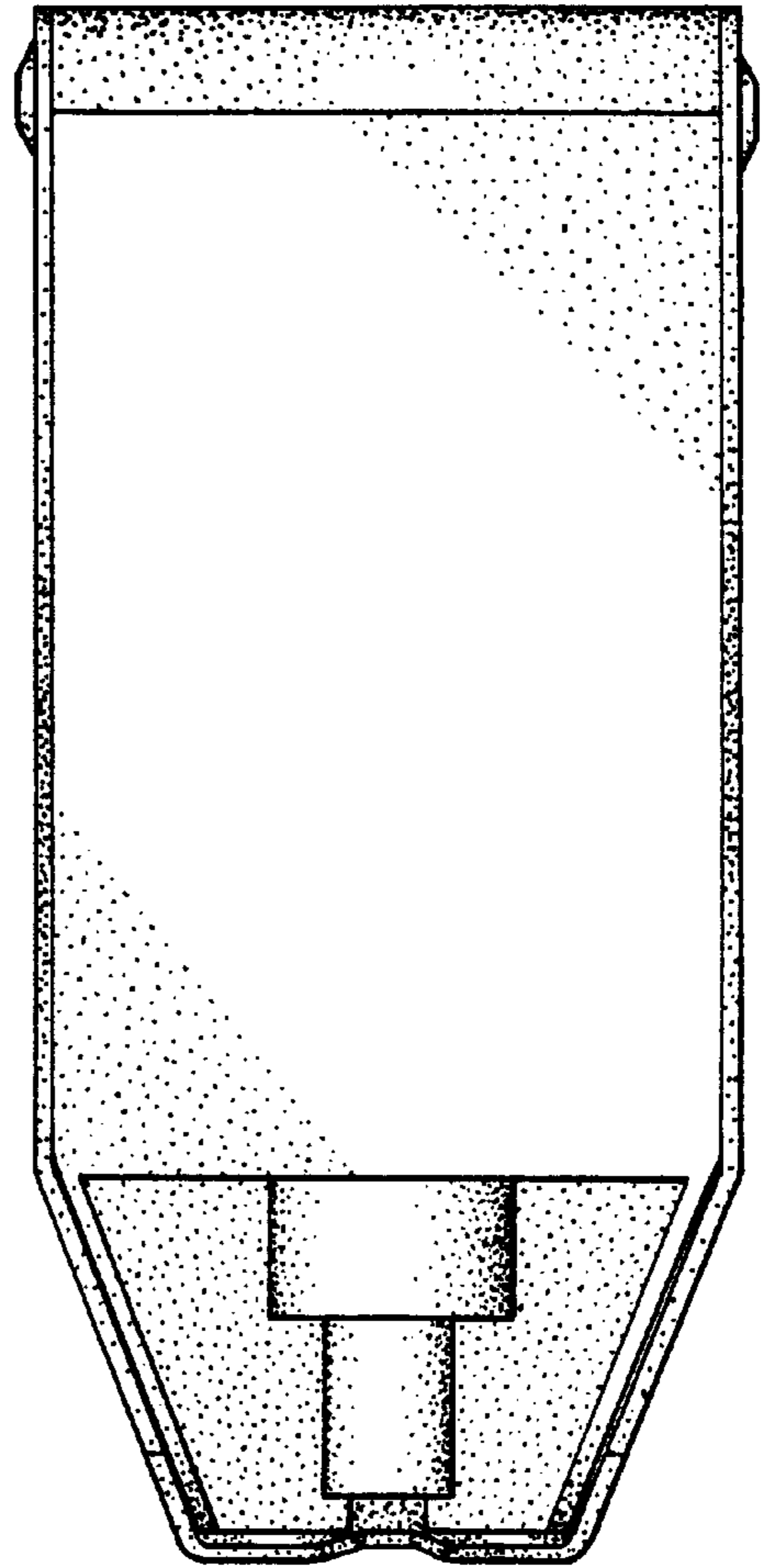
