FIG. 16 is a rear perspective view of the present invention shown in a folded position, mounted on a typical vehicle.

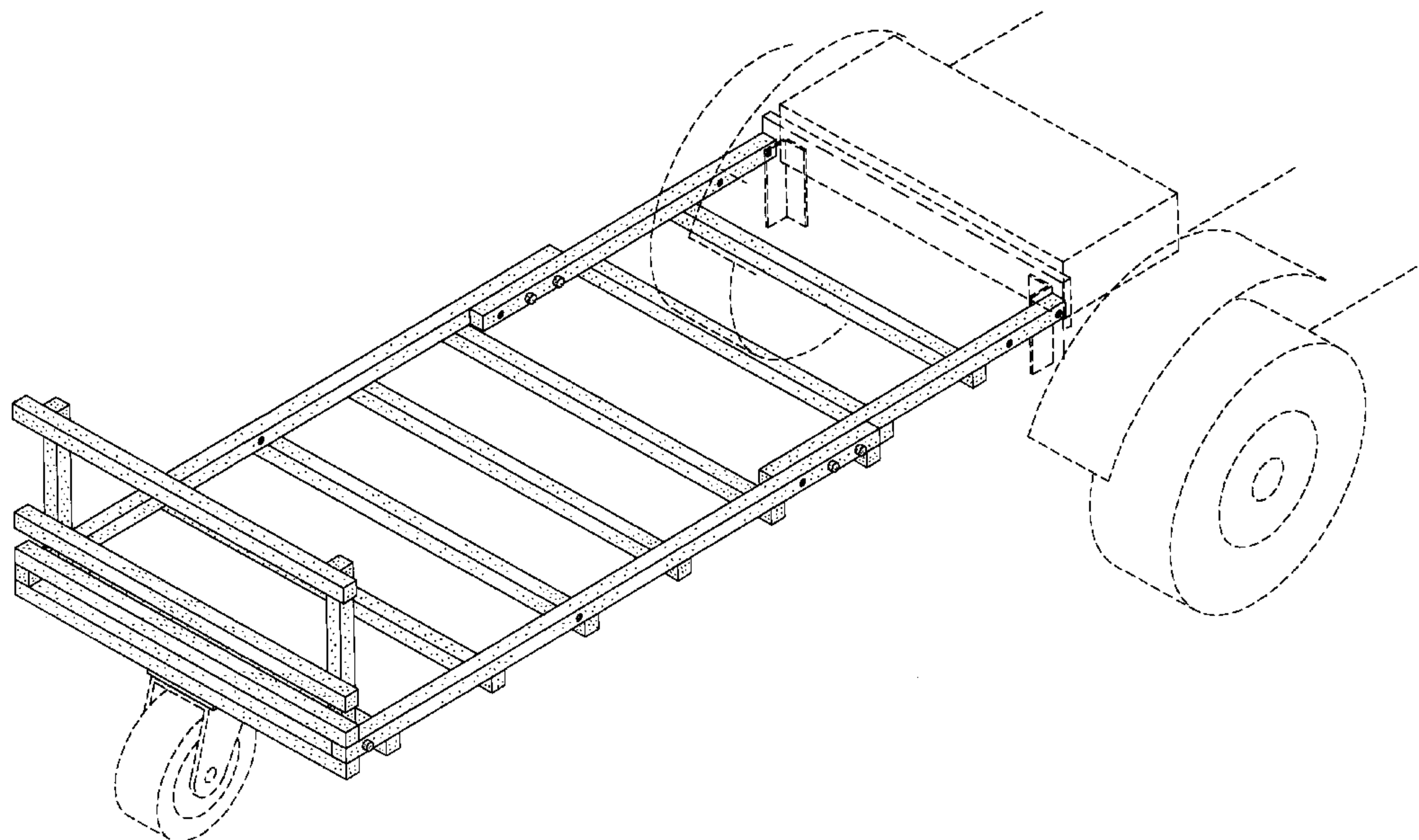
The vehicle, caster wheel and mounting brackets shown in broken lines are illustrative of environmental structure and are not part of the claimed design.

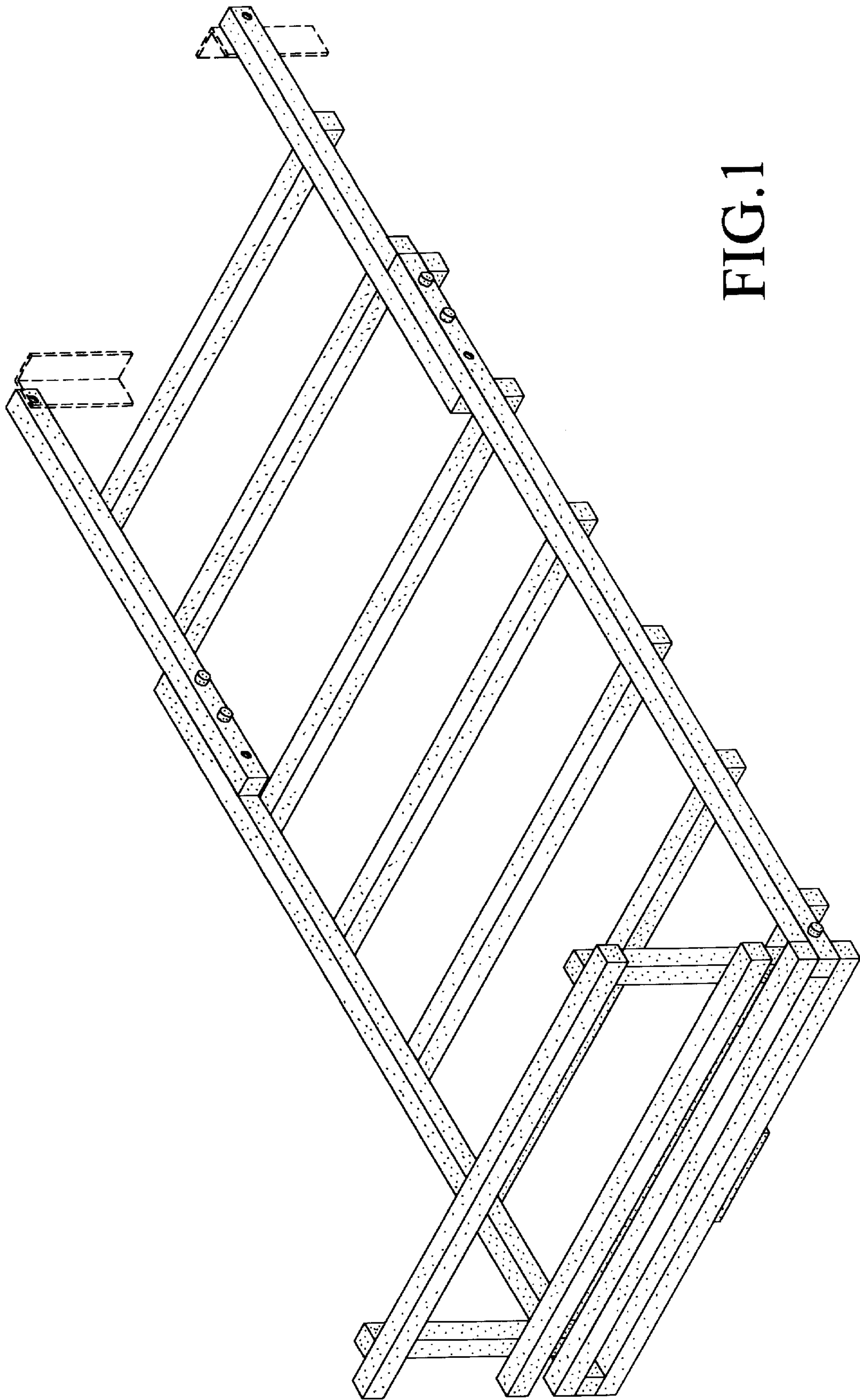

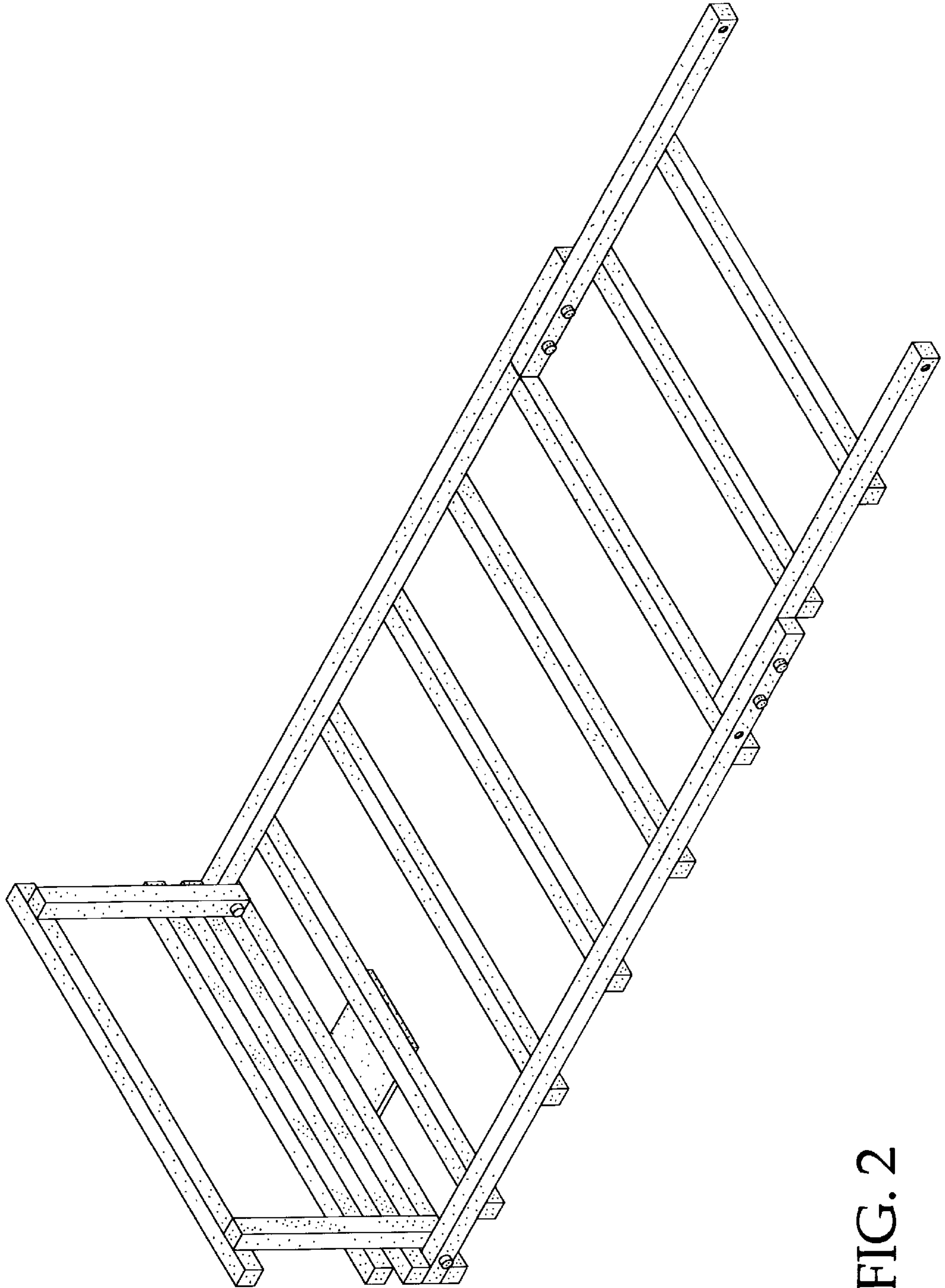

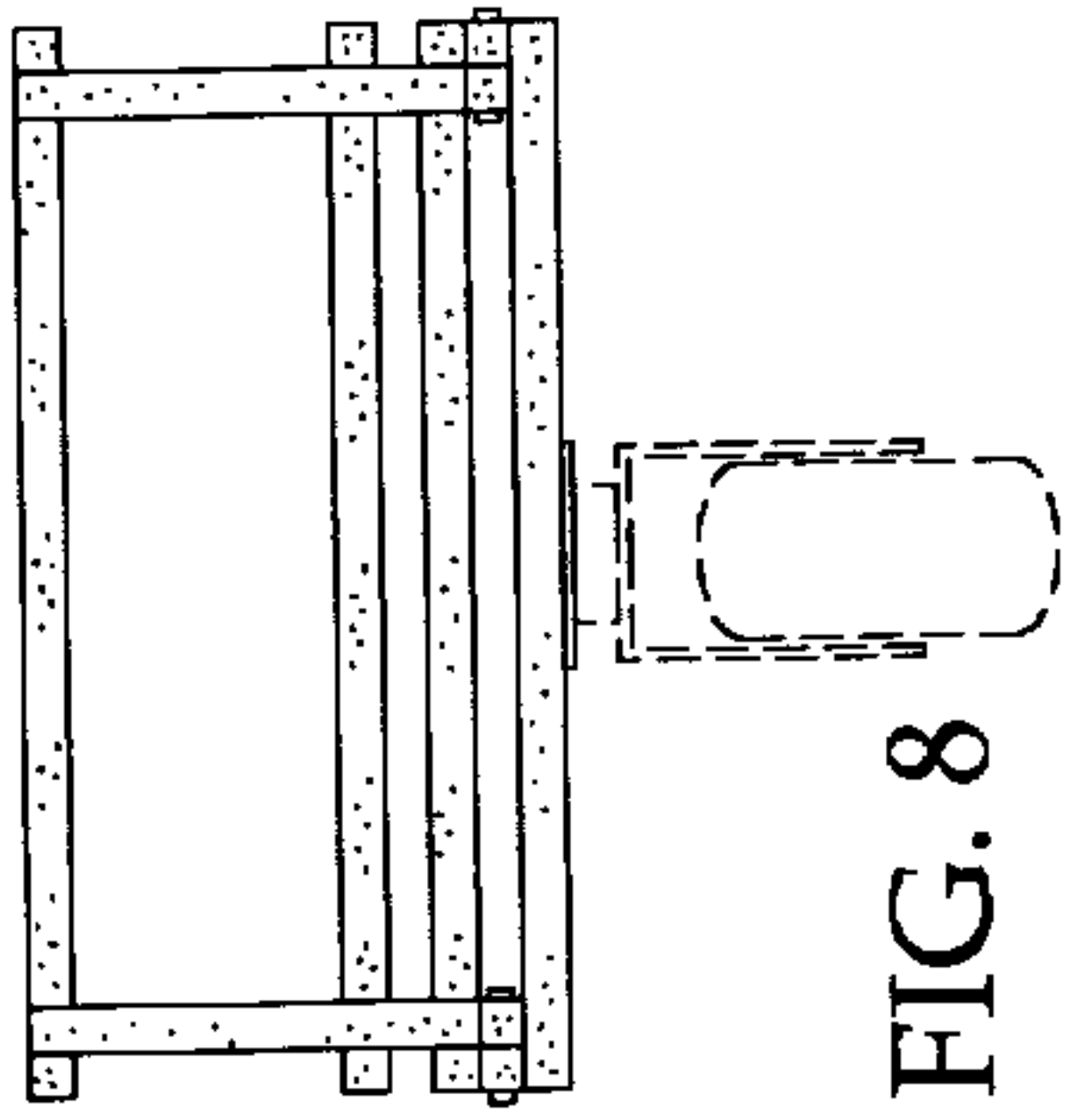

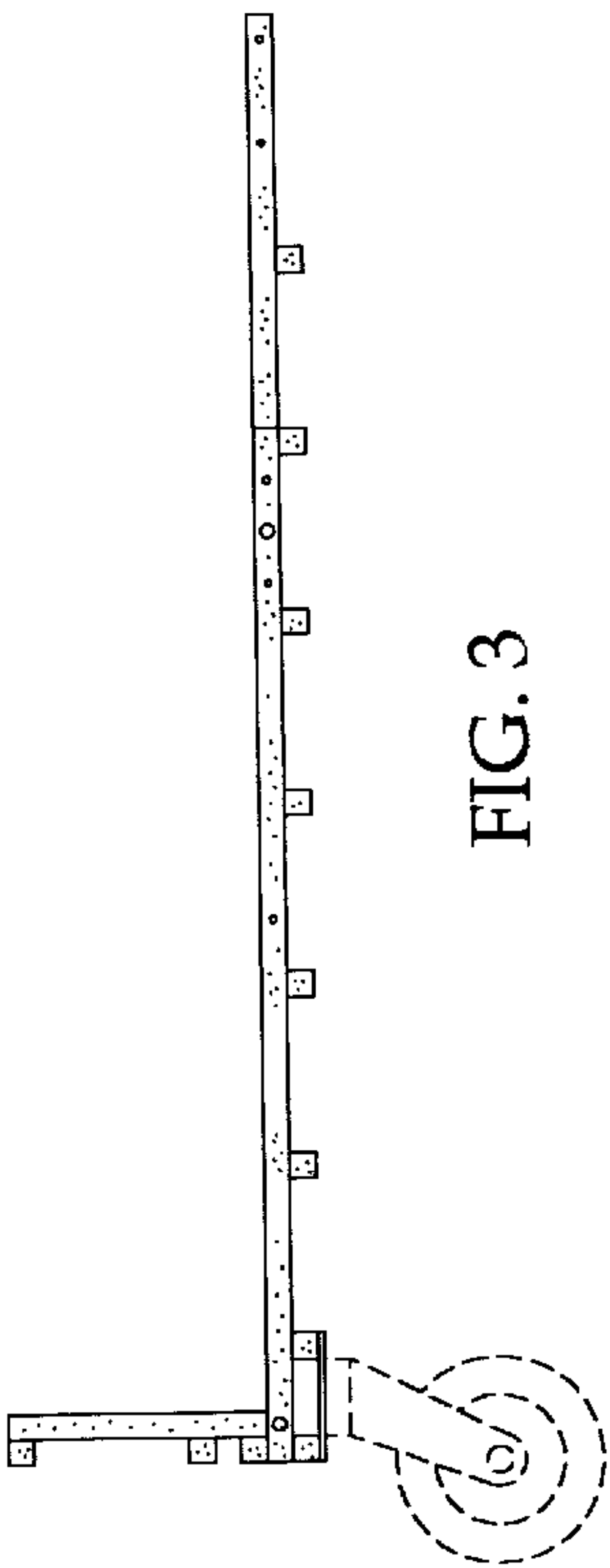

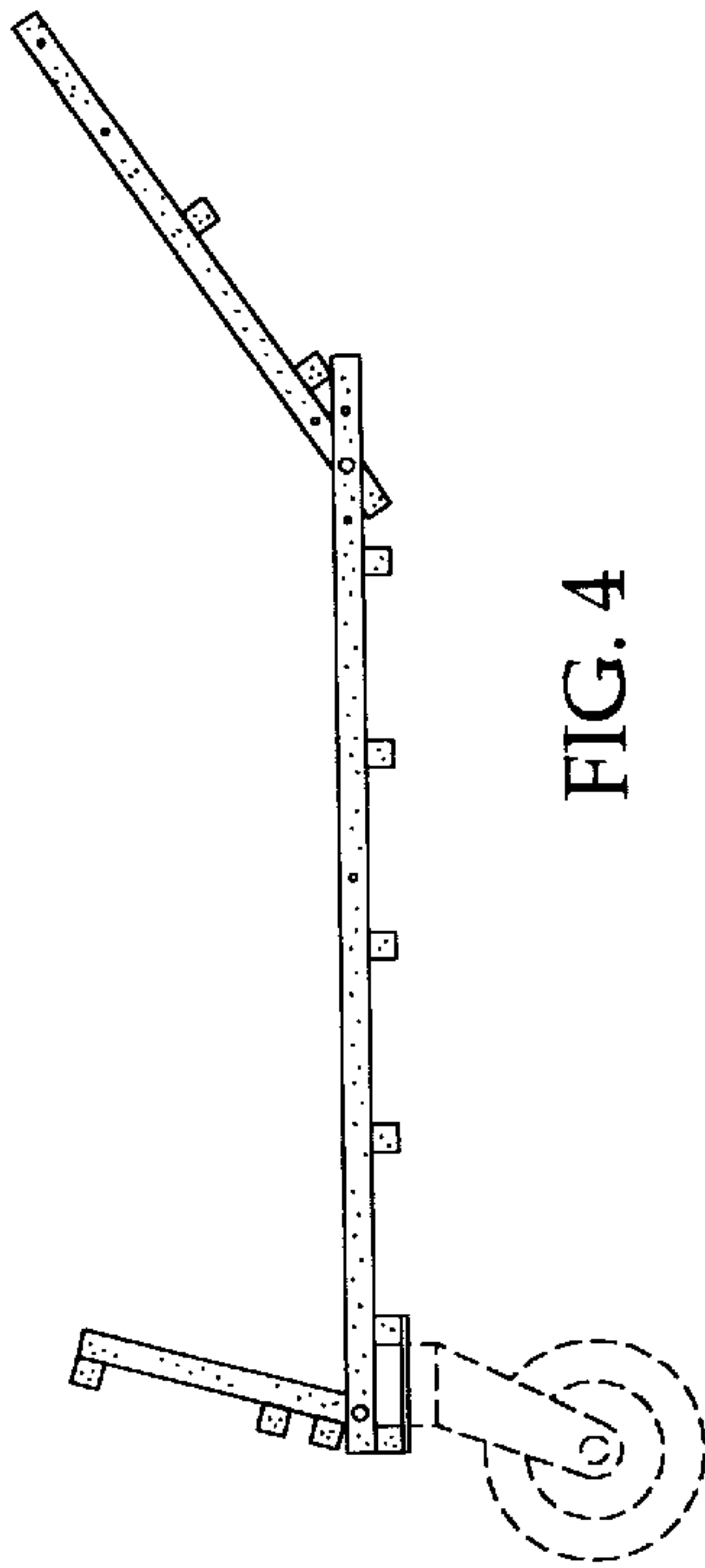

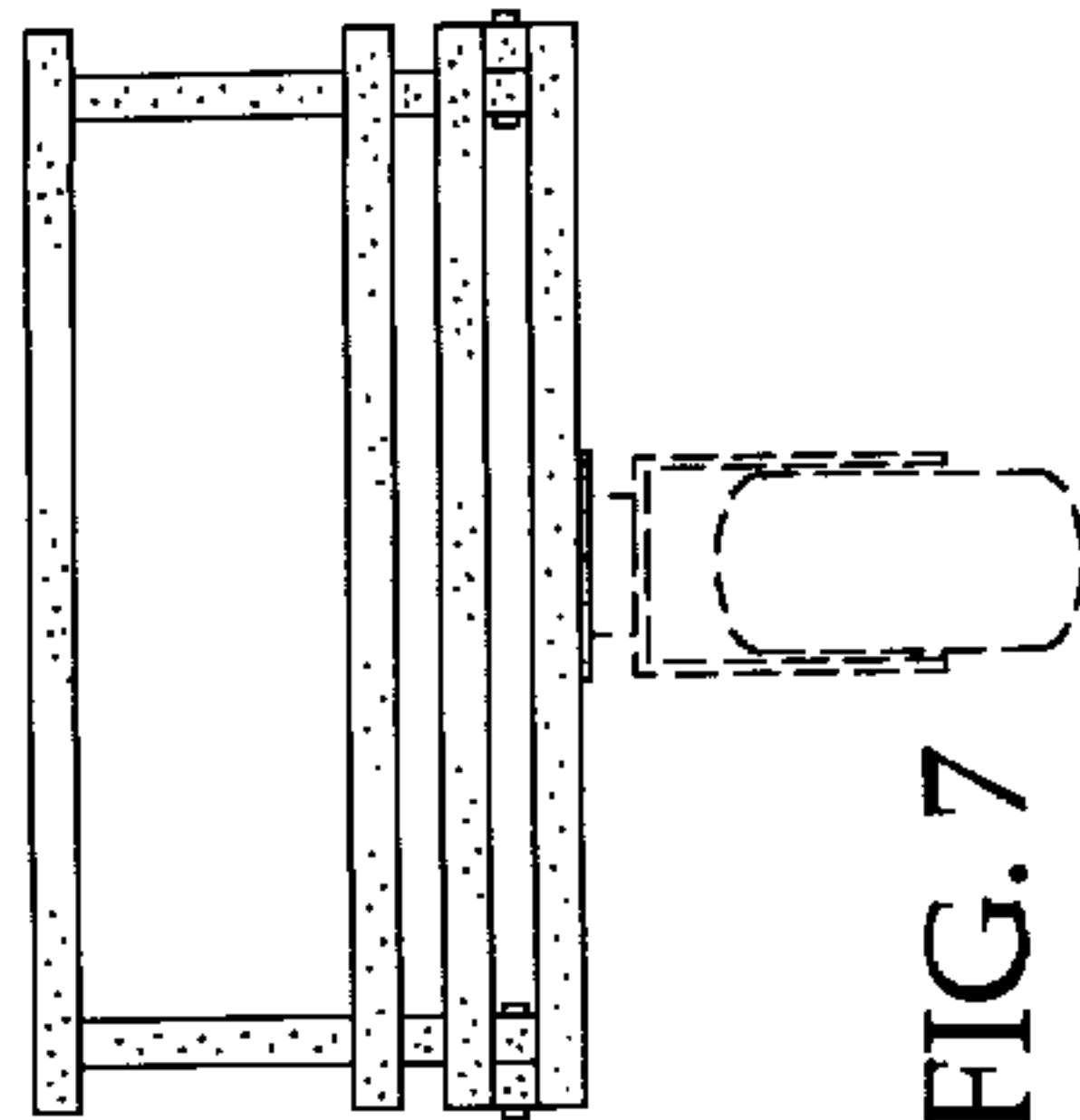

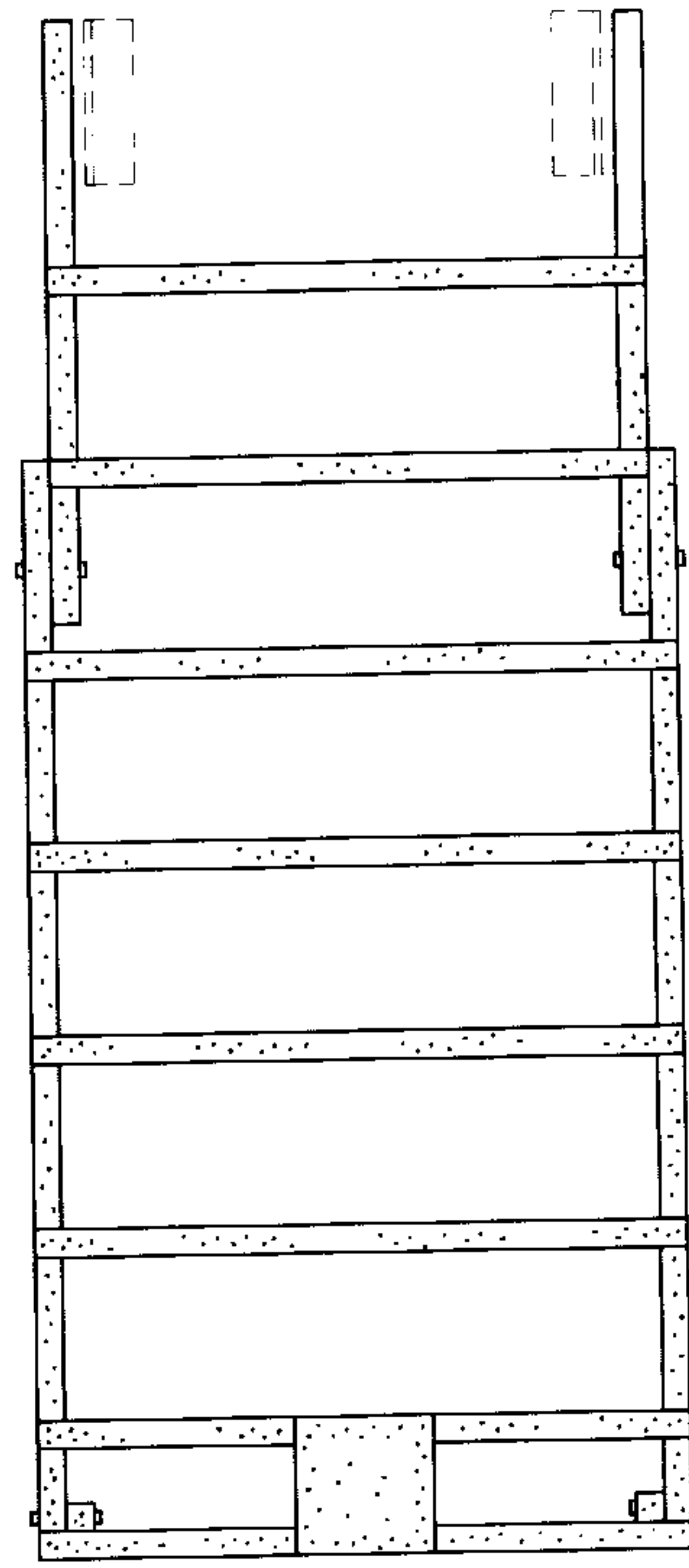

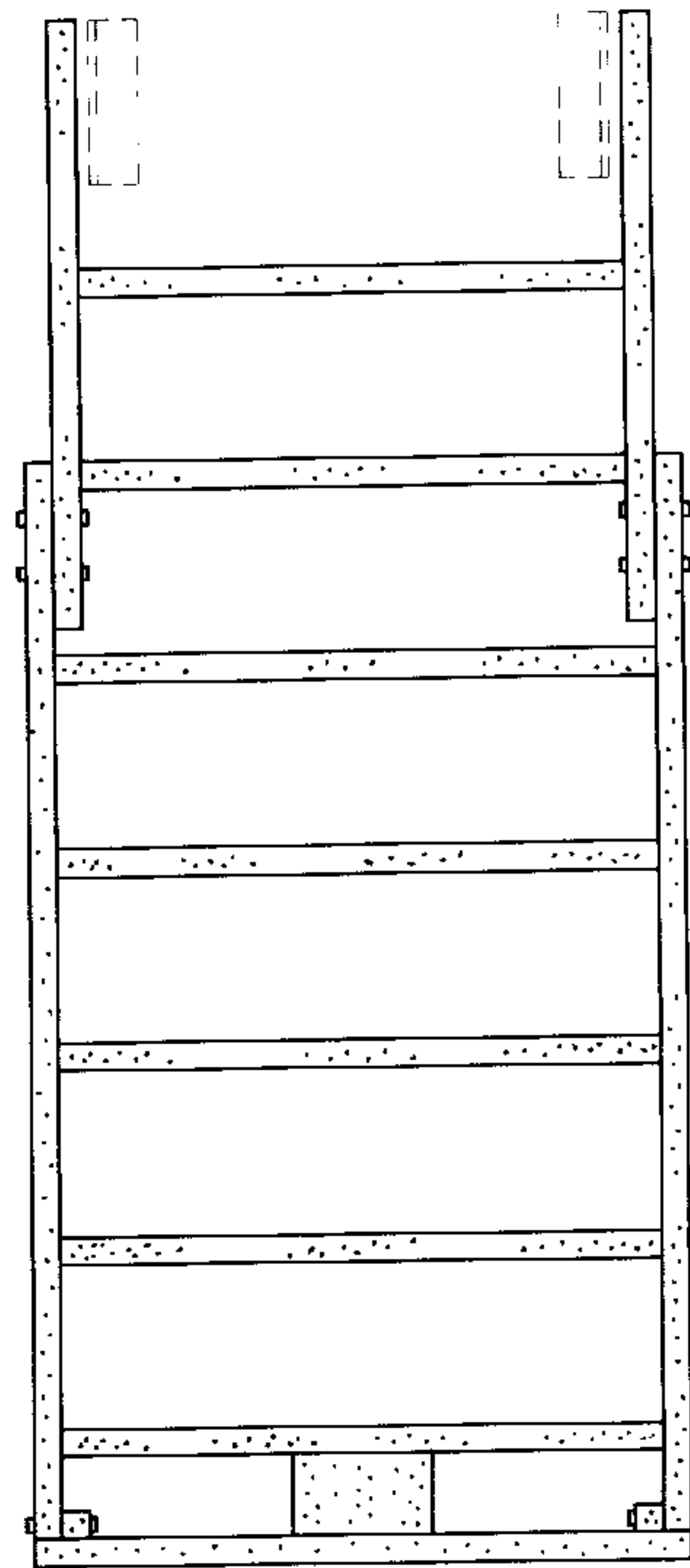

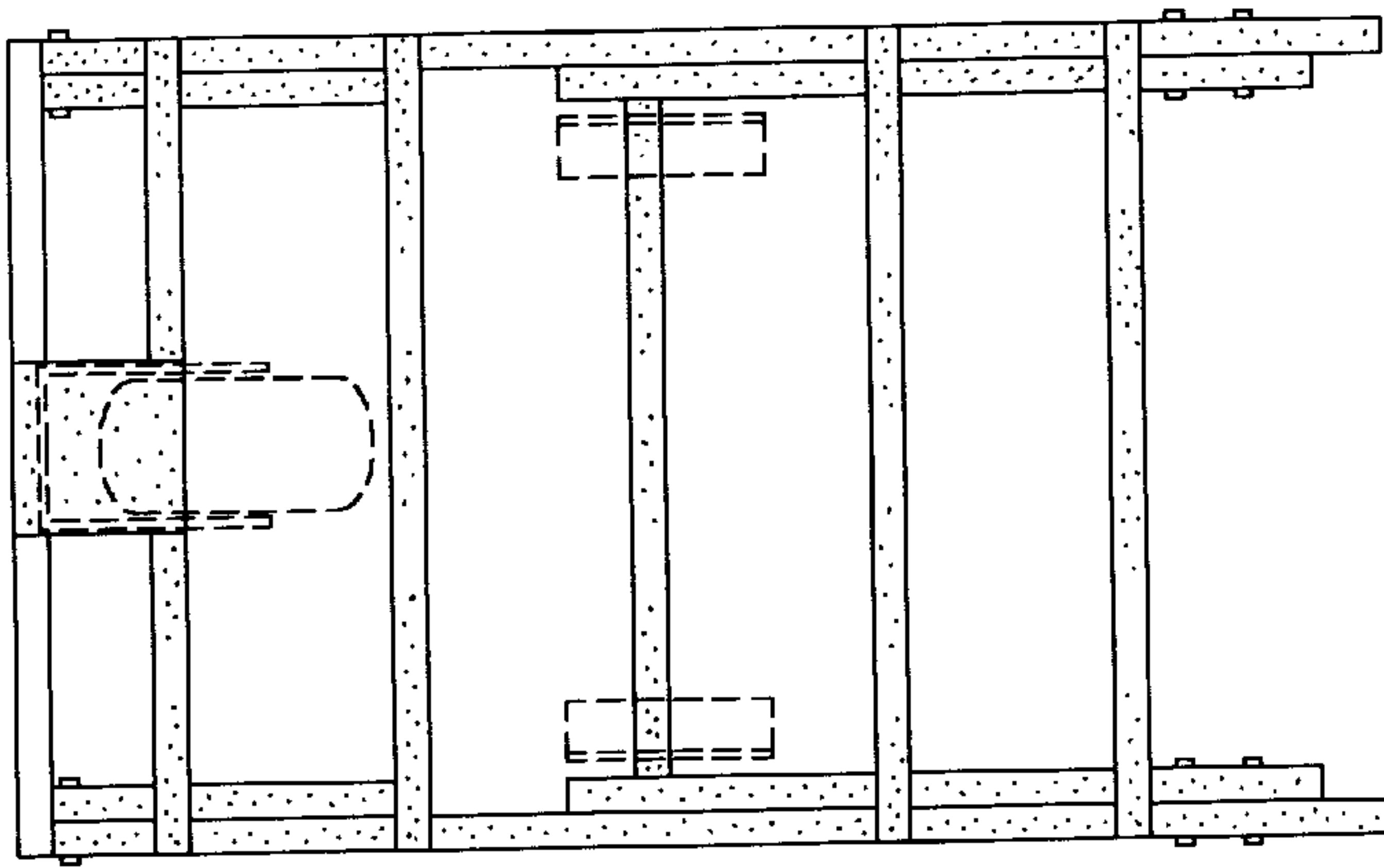

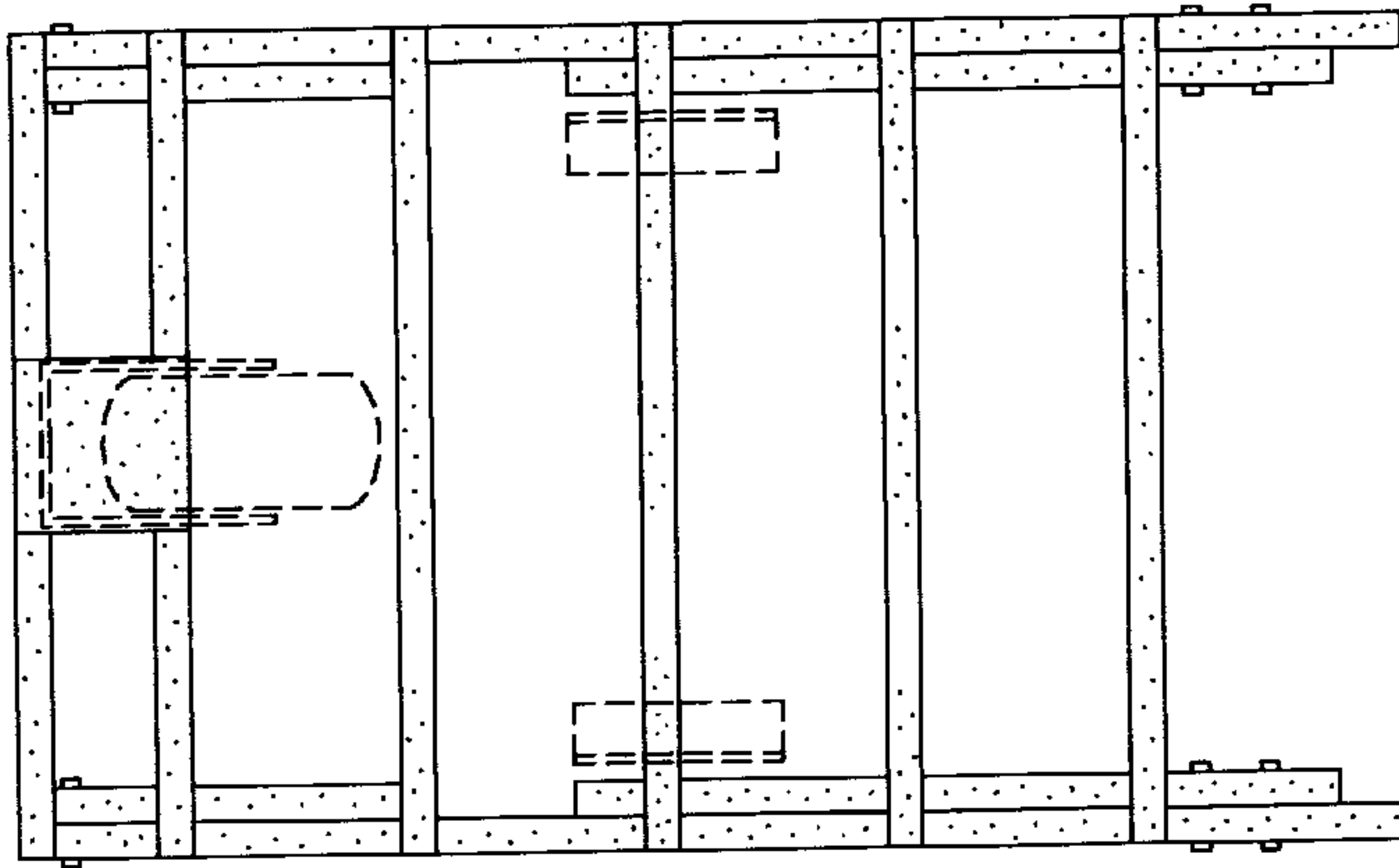

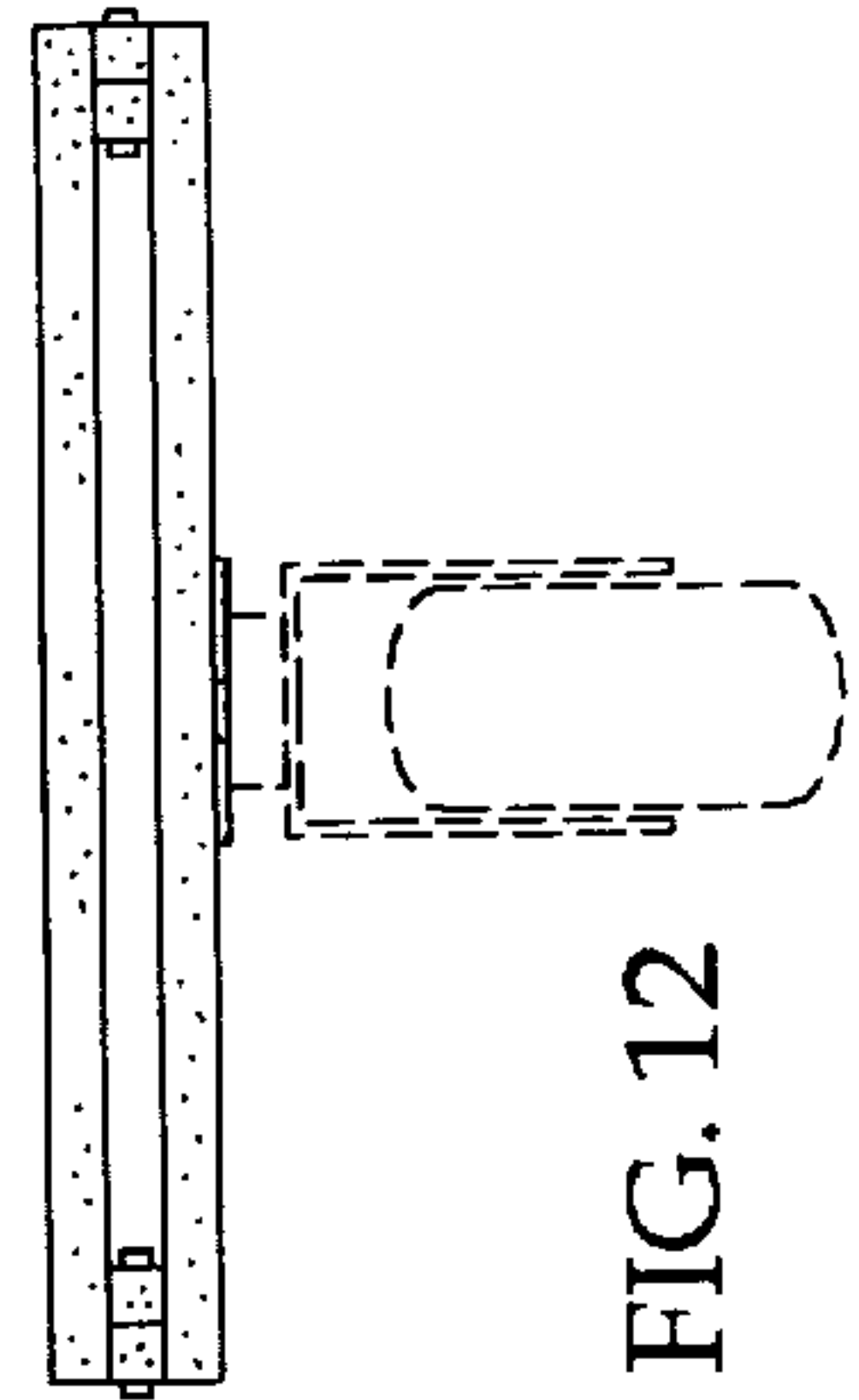

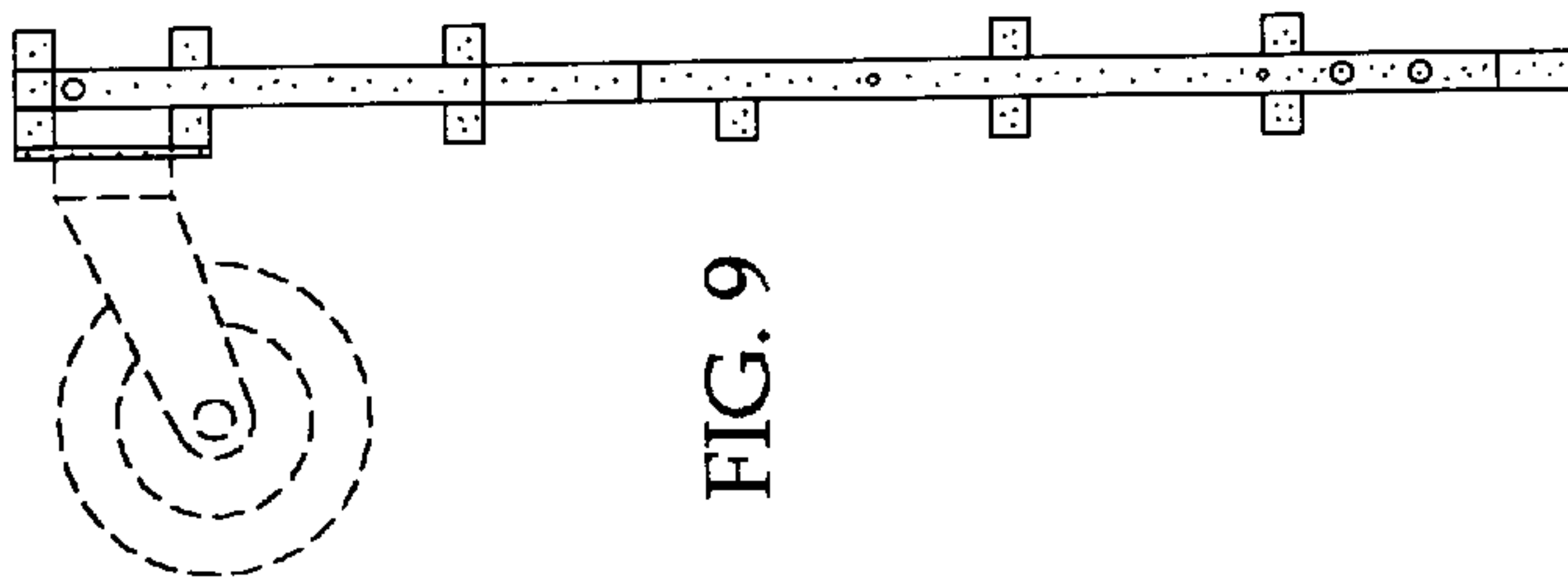

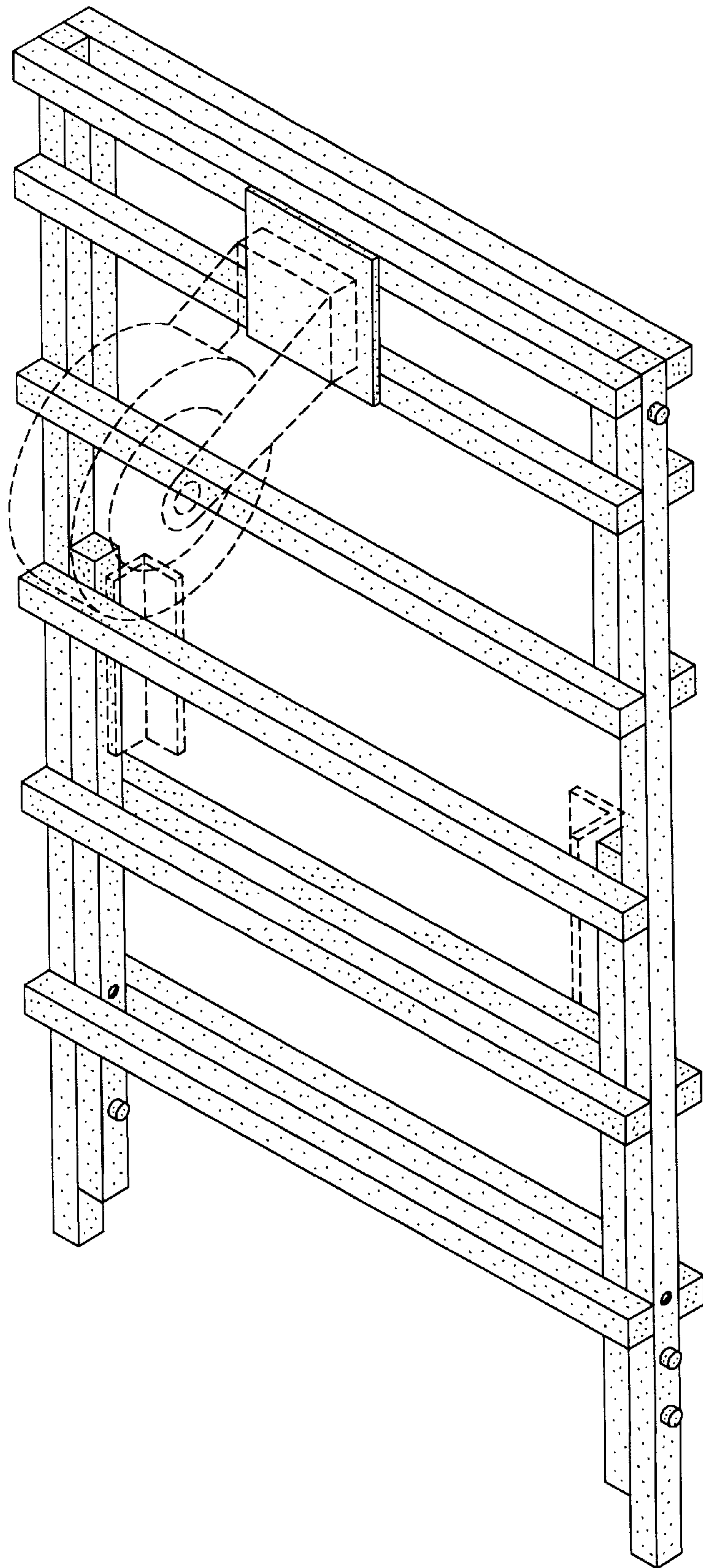

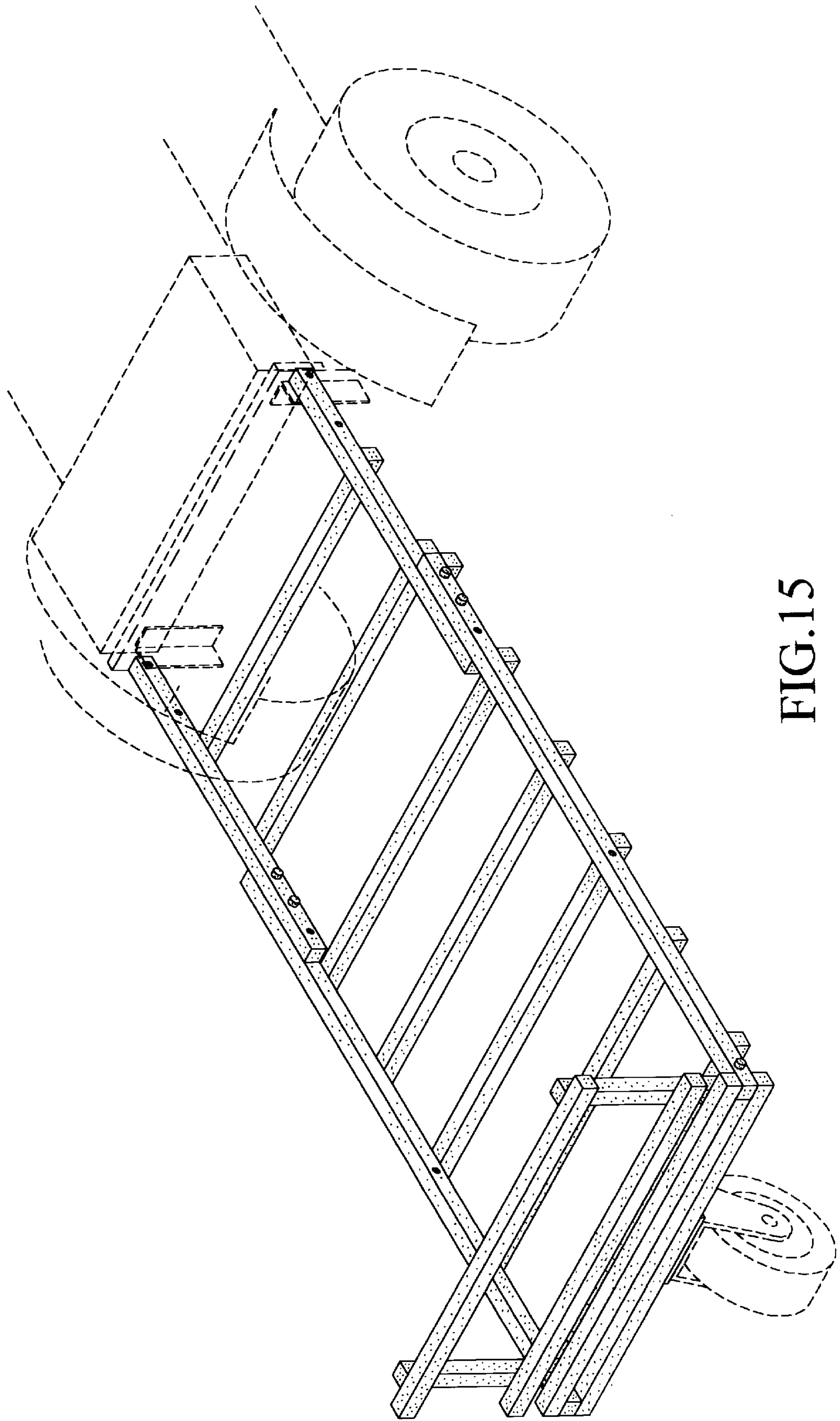

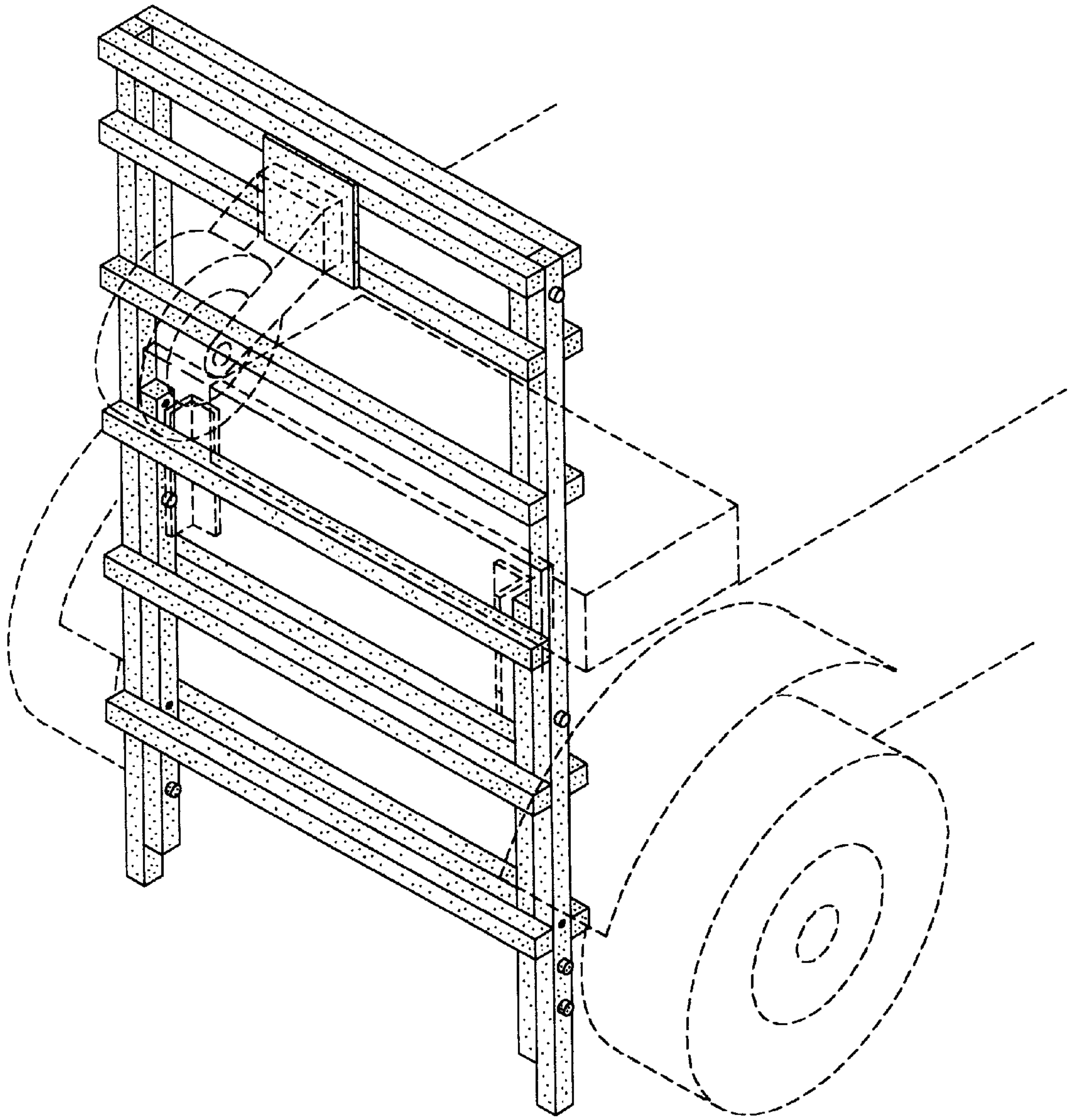
