### [57] CLAIM

The ornamental design for a vehicle article carrier bracket, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a vehicle article carrier bracket showing my new design, with the bracket shown inserted in a slat on a vehicle rooftop;  
FIG. 2 is an enlarged perspective view thereof;  
FIG. 3 is an enlarged top view thereof;  
FIG. 4 is an enlarged left side view thereof;  
FIG. 5 is an enlarged front view thereof;  
FIG. 6 is an enlarged right side view thereof; and,  
FIG. 7 is an enlarged rear view thereof.  
The broken line showing of environment in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

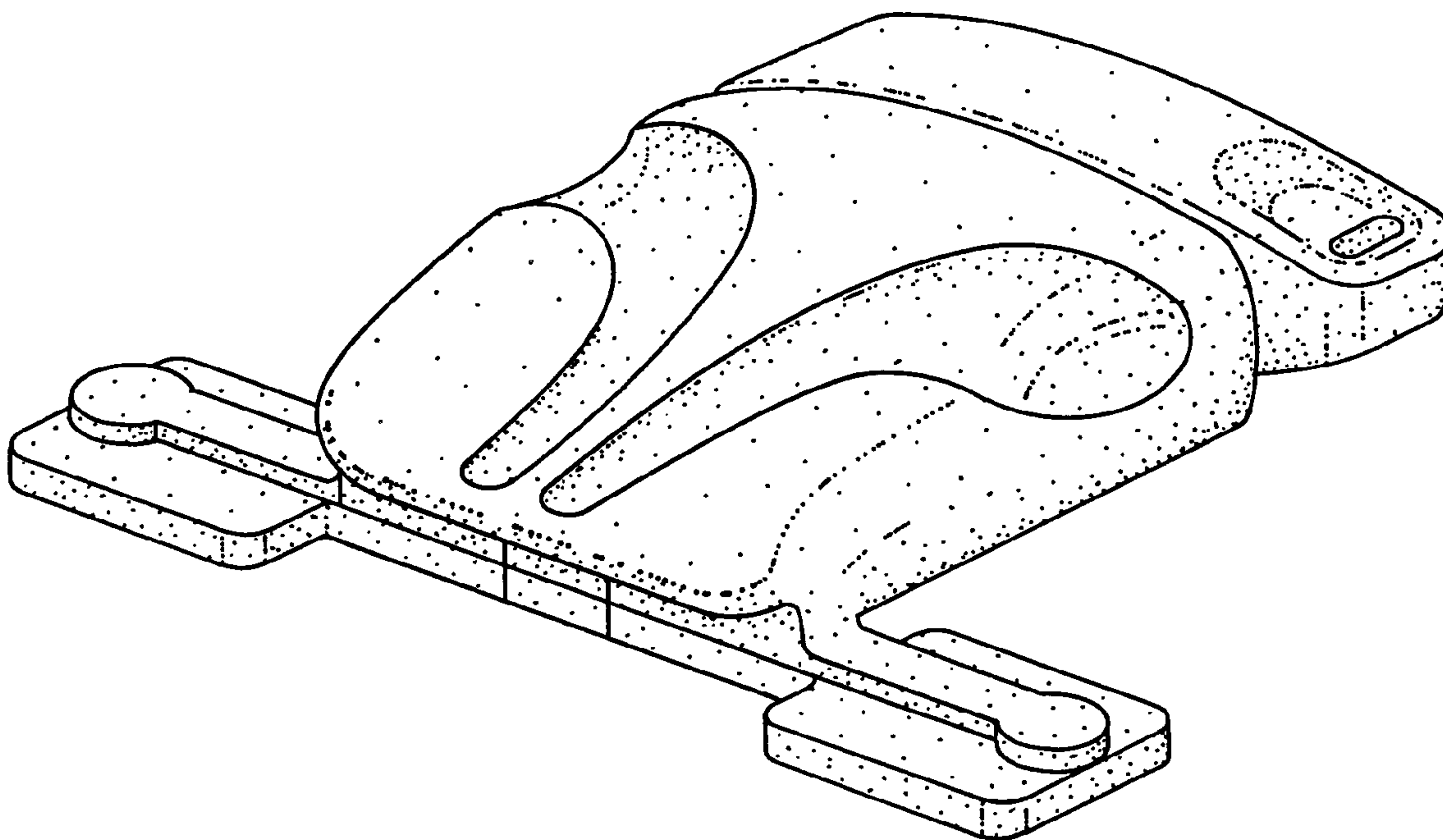

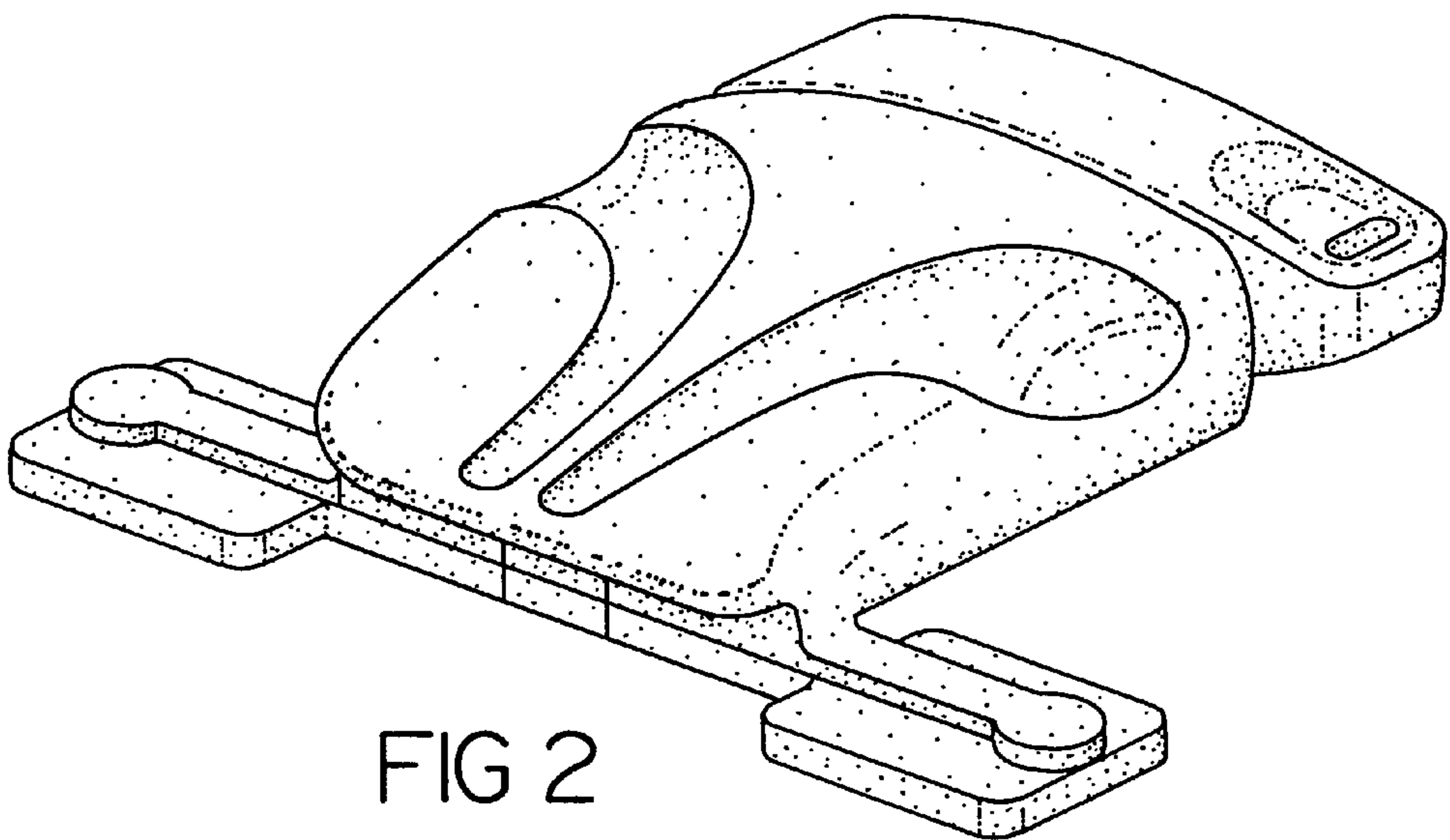
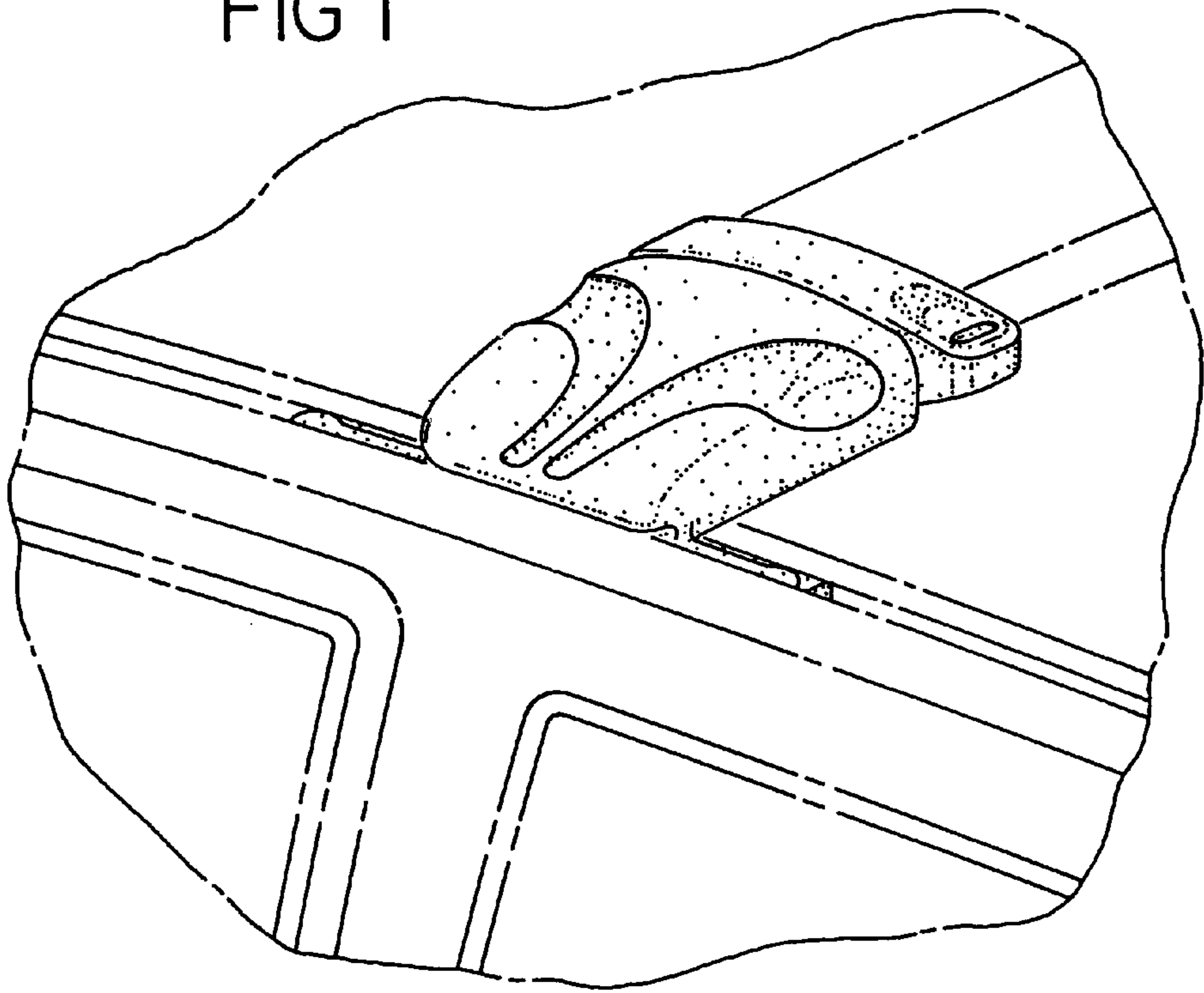

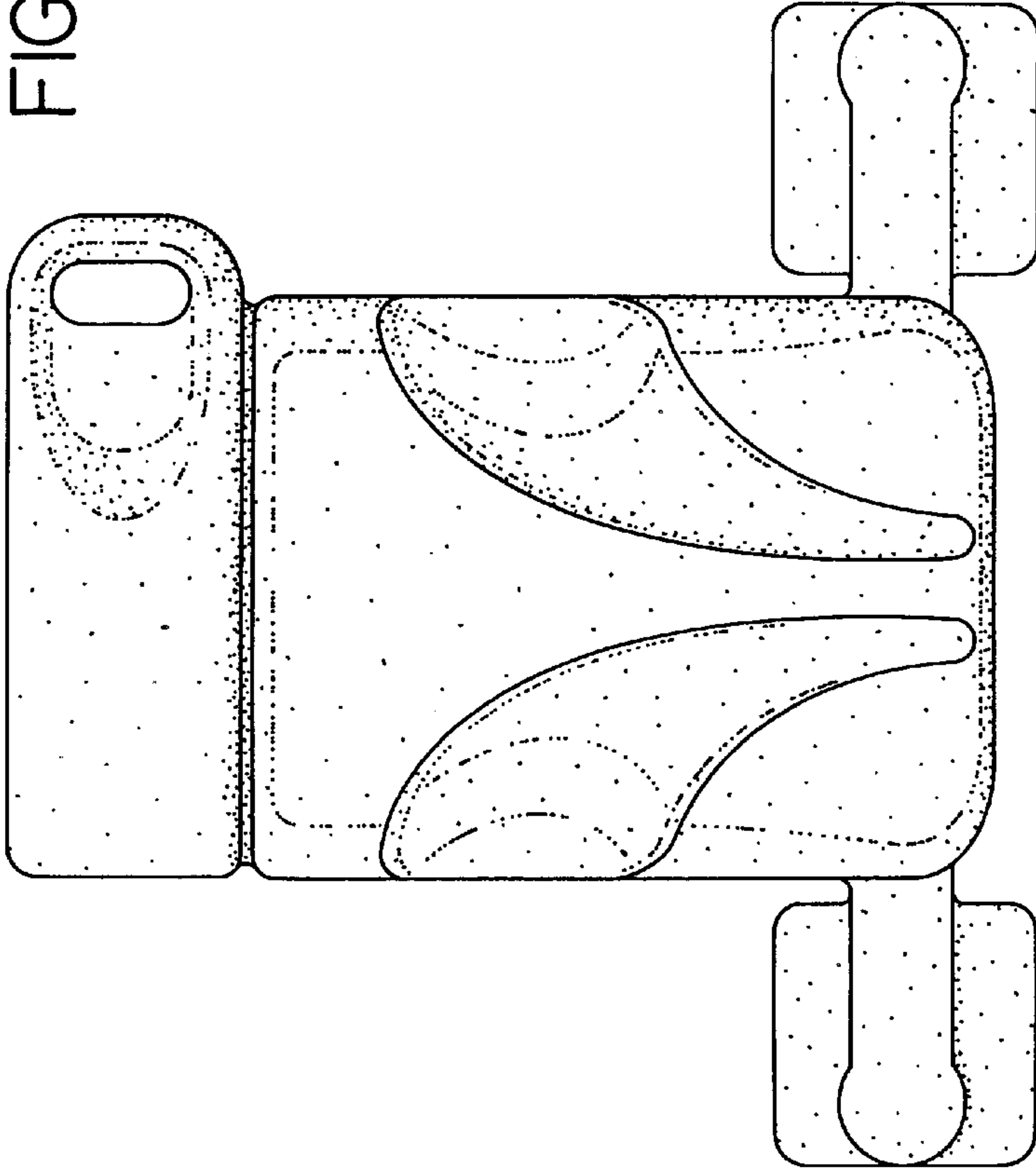

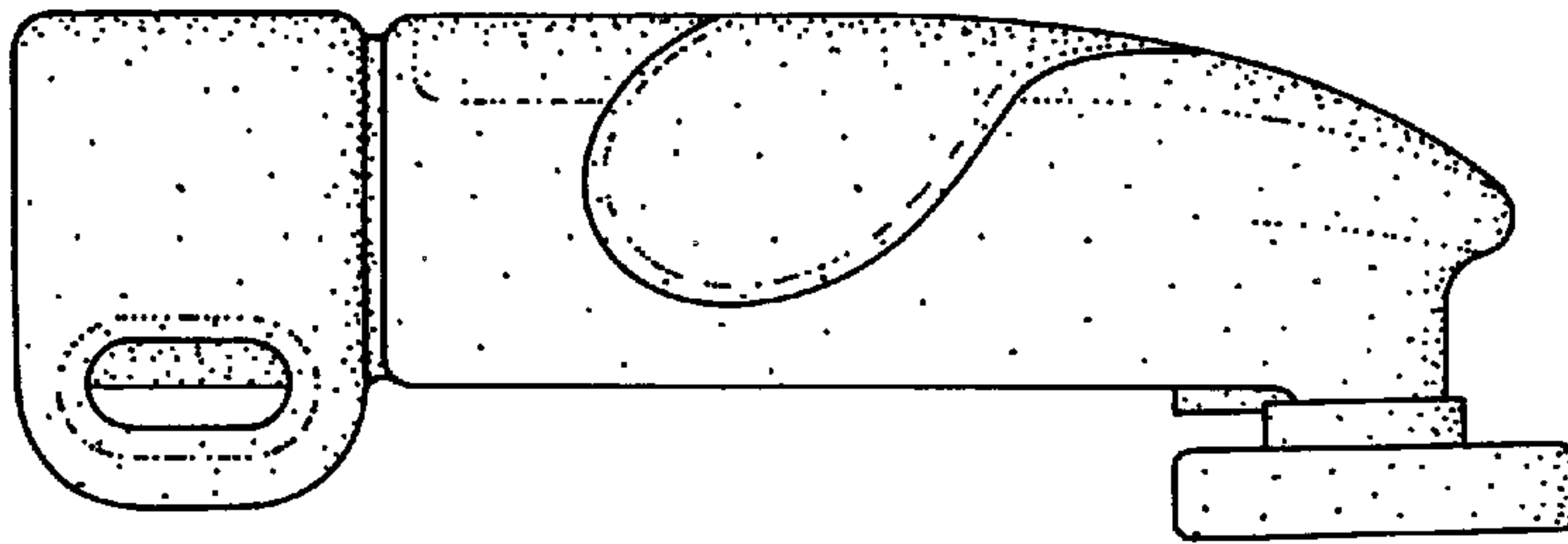
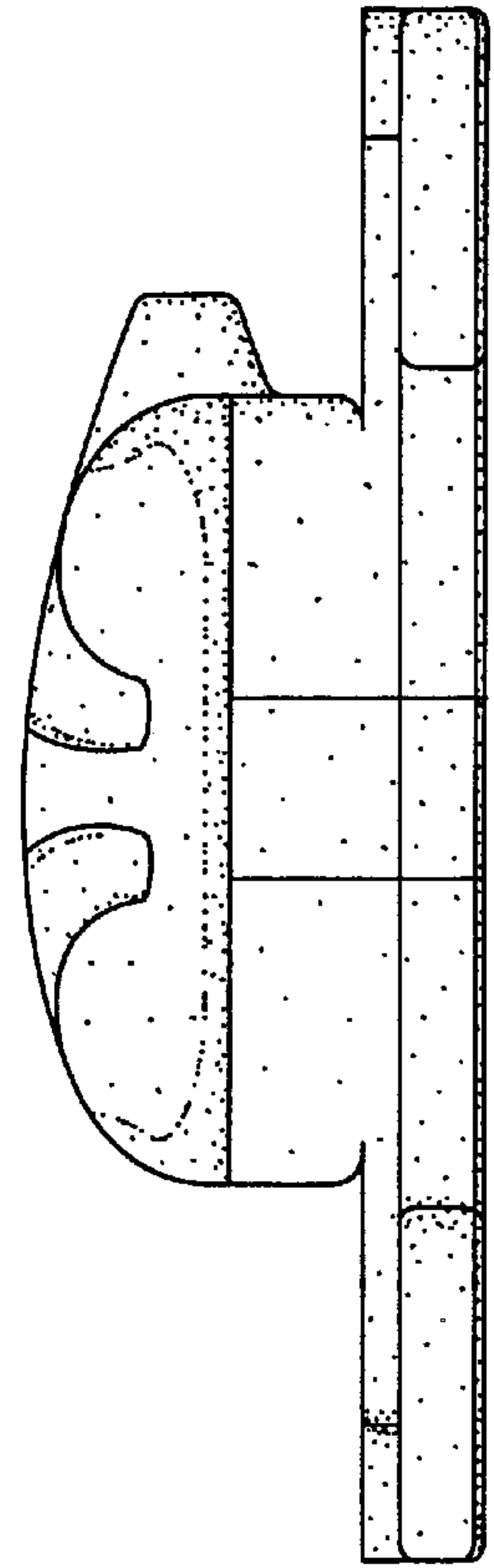

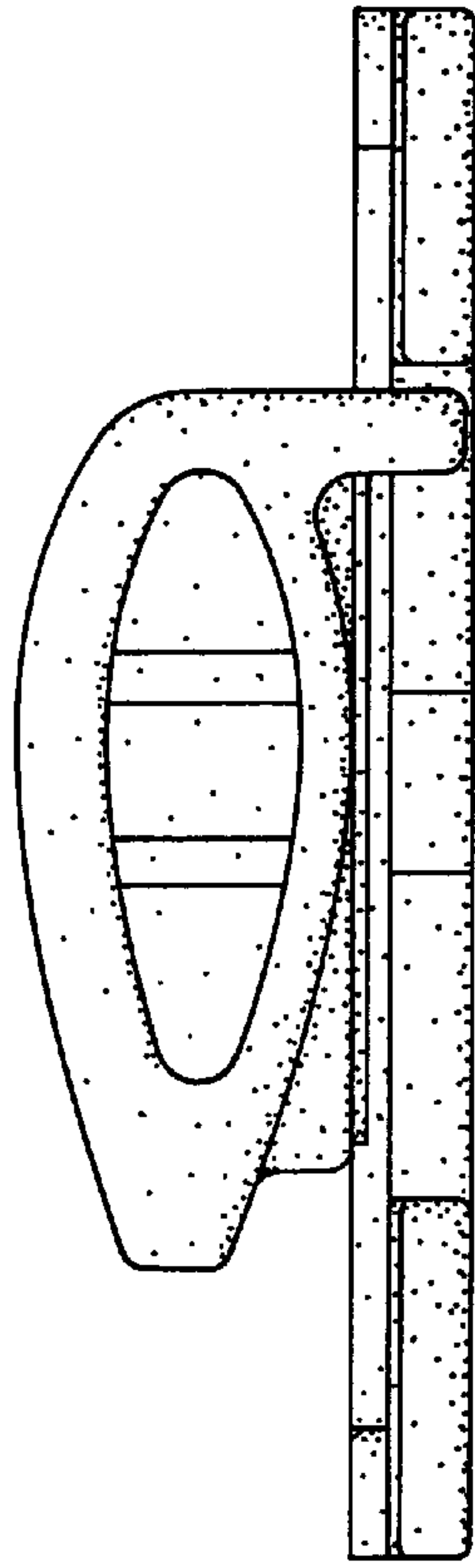

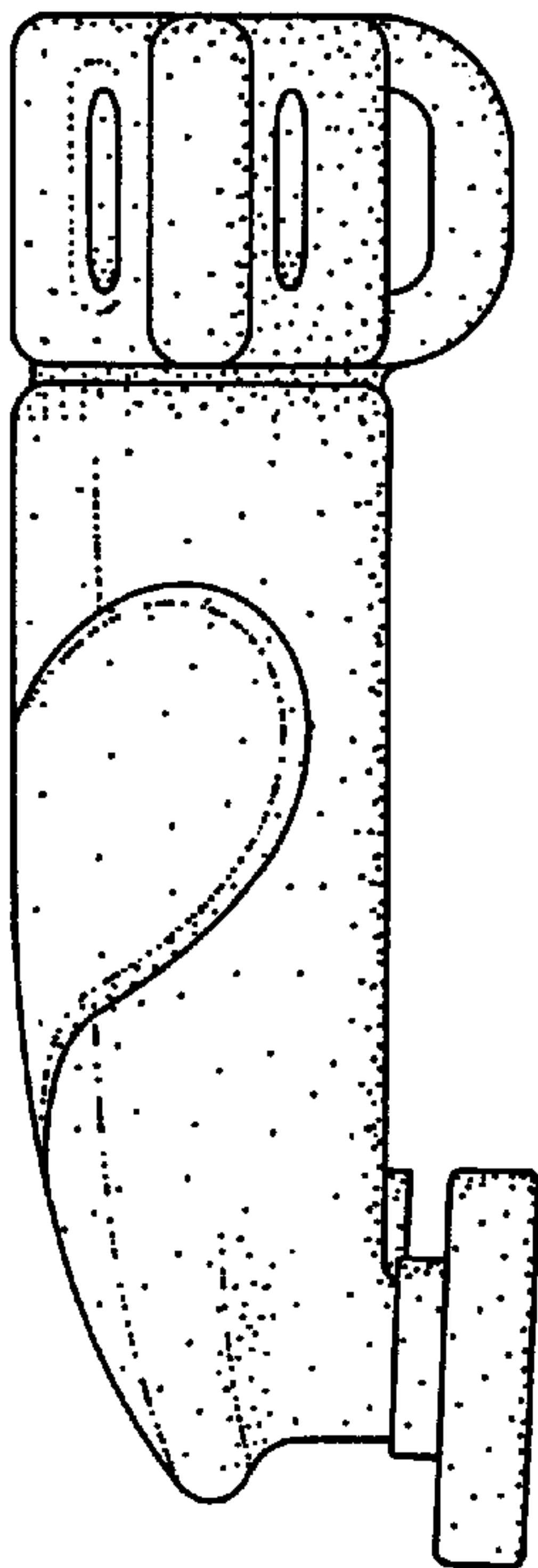
