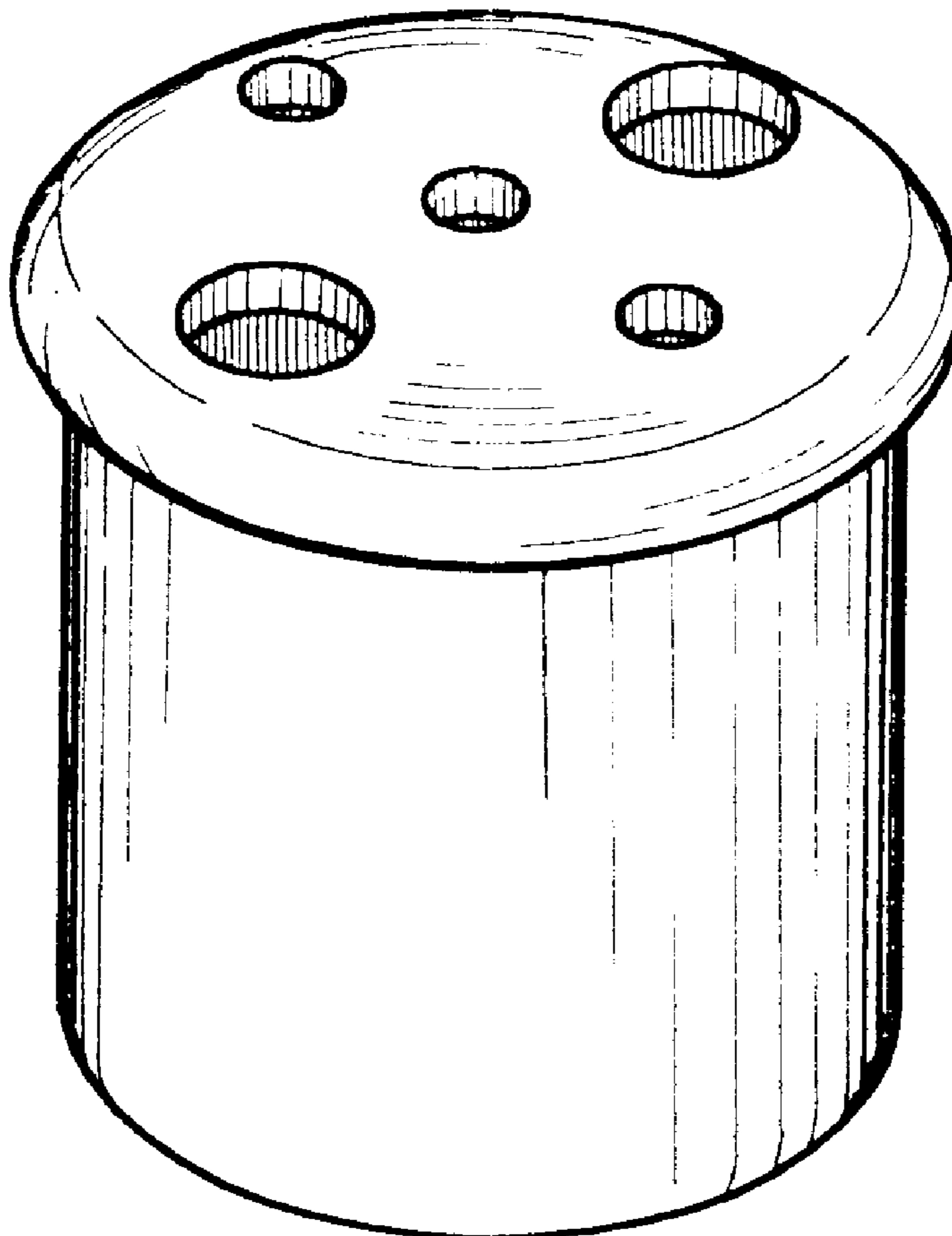

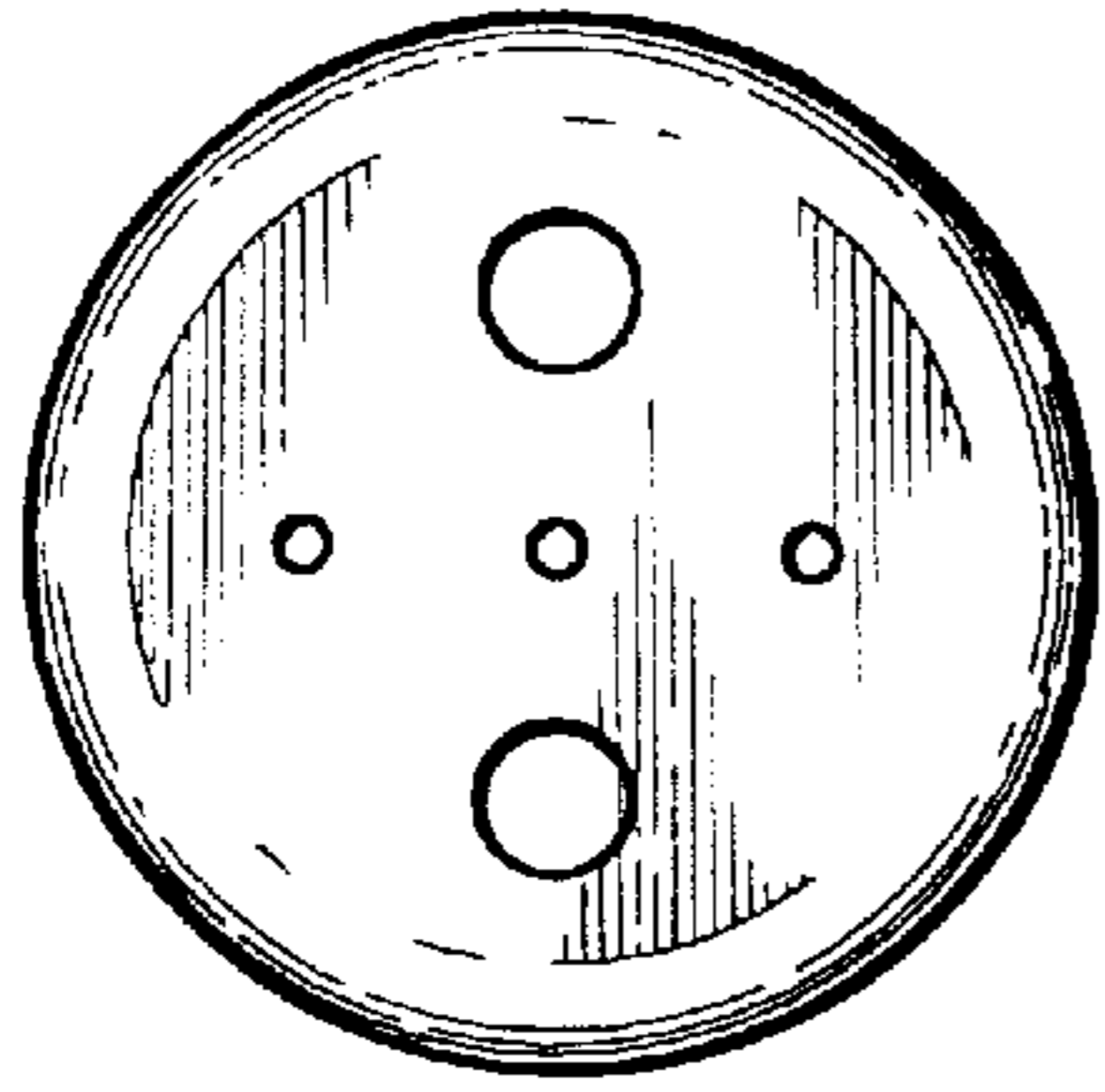

### DESCRIPTION

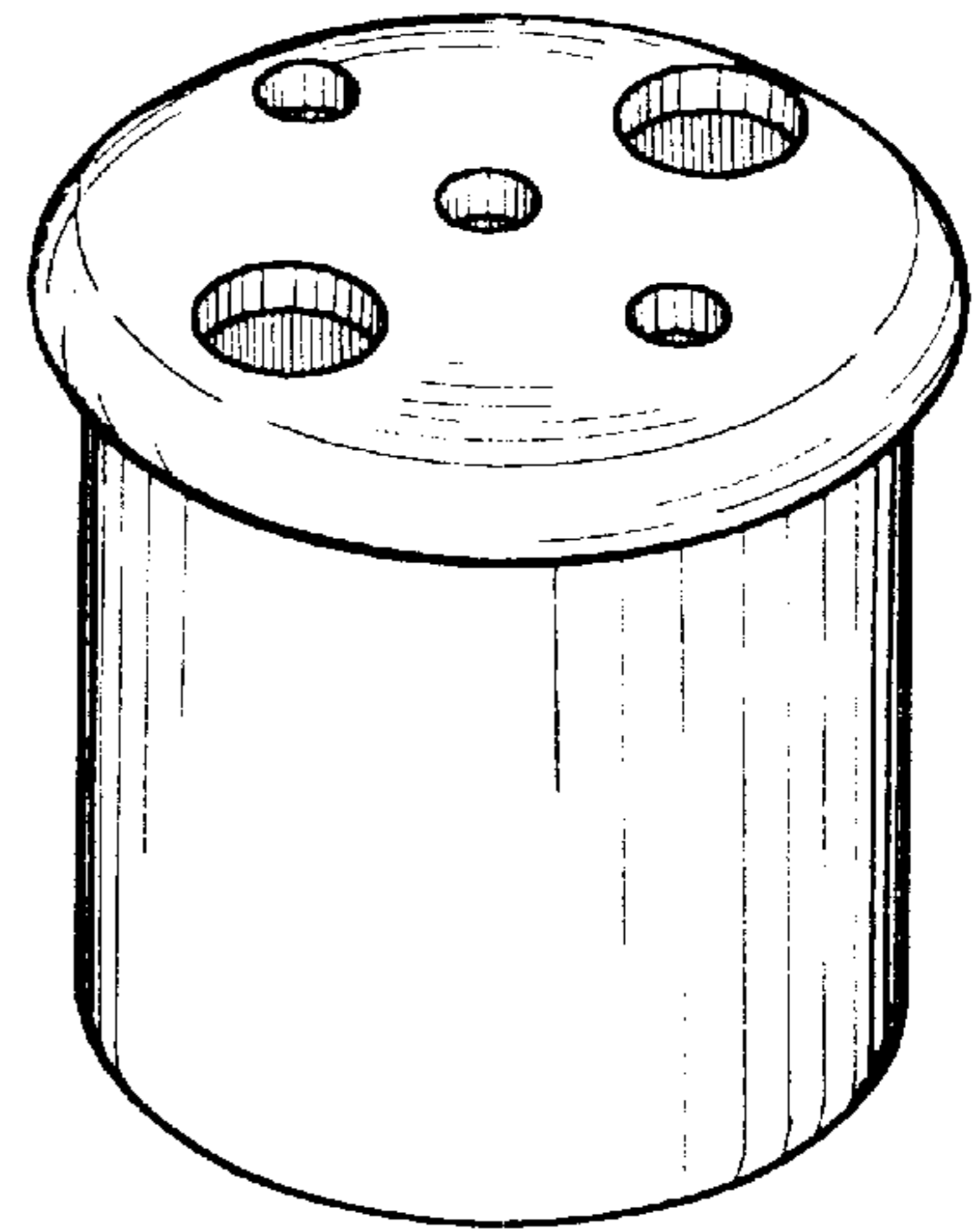
FIG. 1 is a top perspective view of a styletette end cap showing my new design;

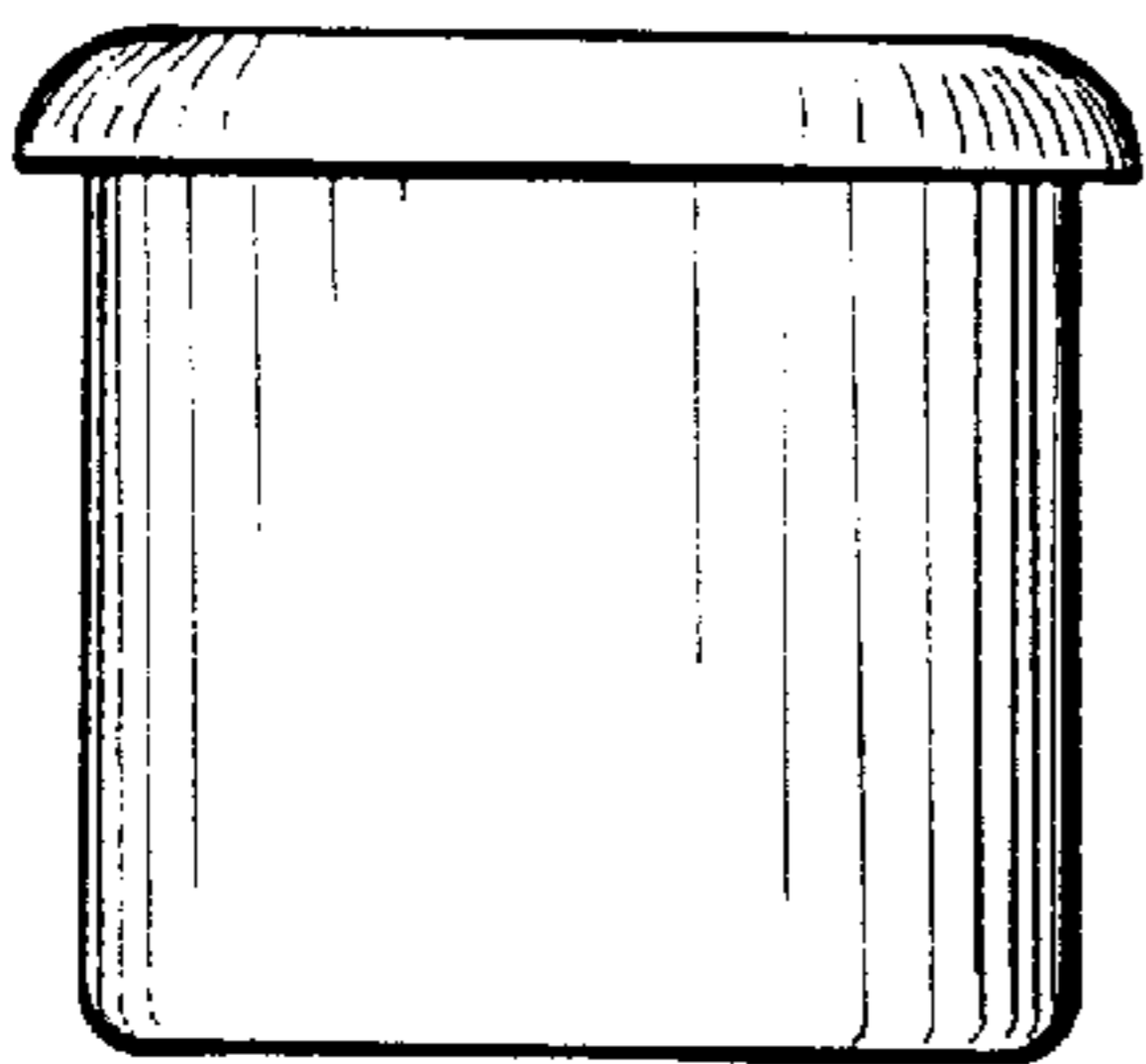




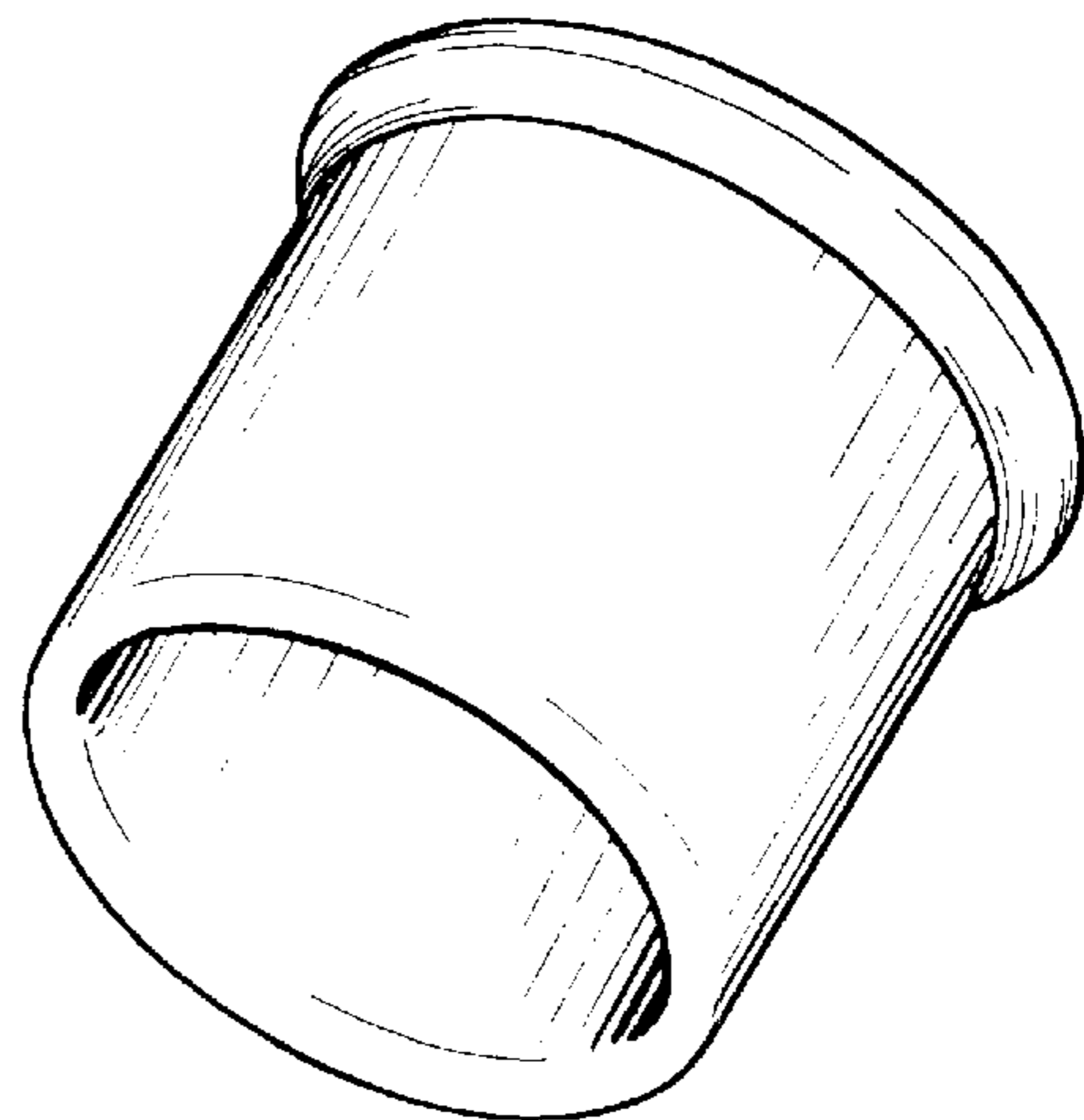

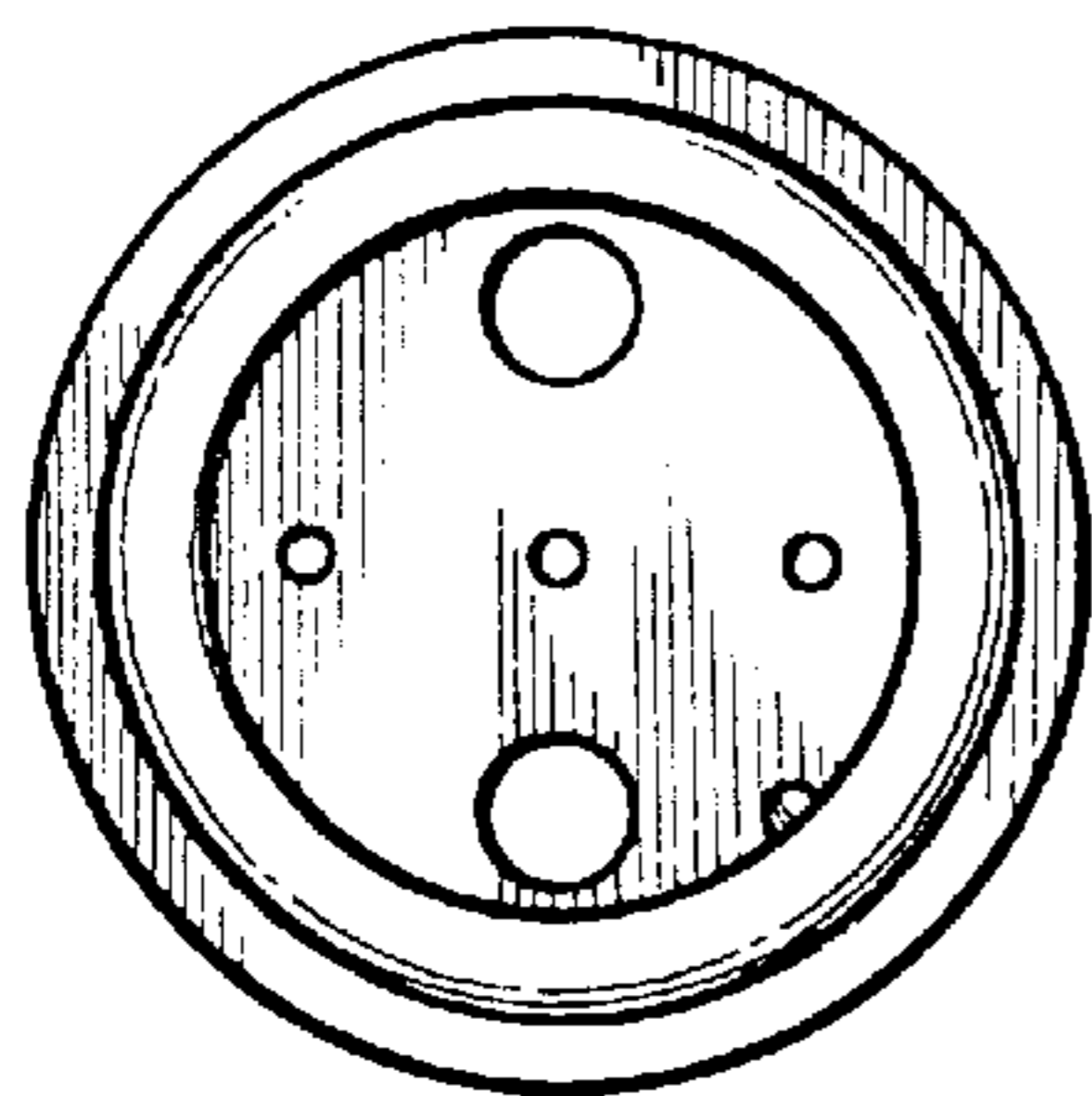
