[57] **CLAIM**

The ornamental design for: strap for safely securing a leash to a hand of a user, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view showing my new design for a strap for safely securing a leash to the hand of a user; FIG. 2 is a left side elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a rear elevational view thereof; and, FIG. 6 is a front elevational view thereof.

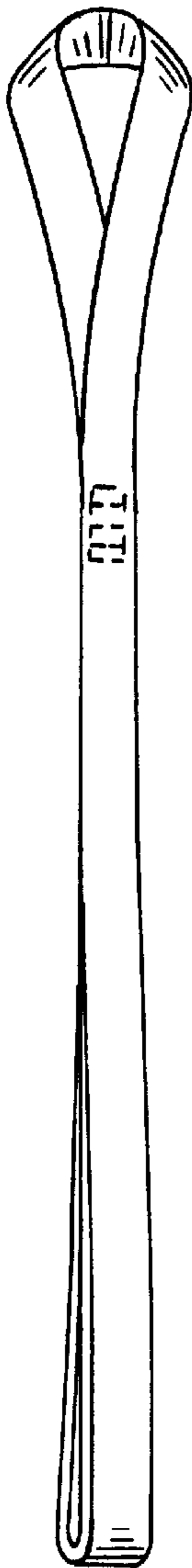

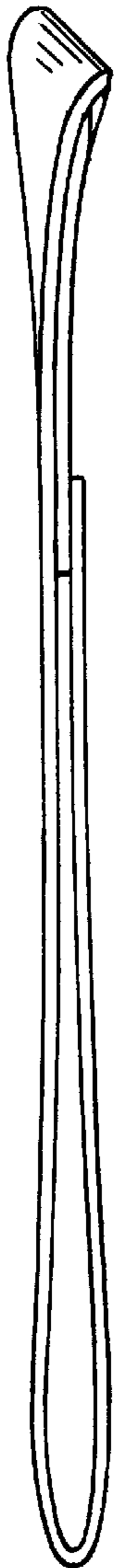

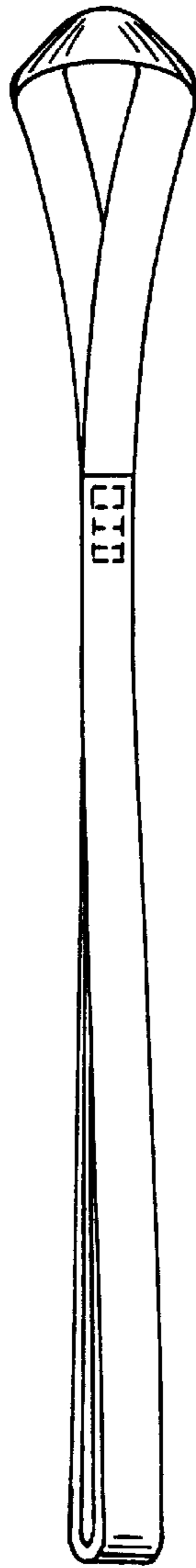

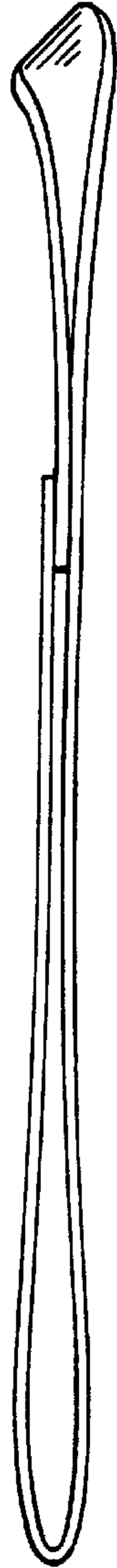
