DESCRIPTION

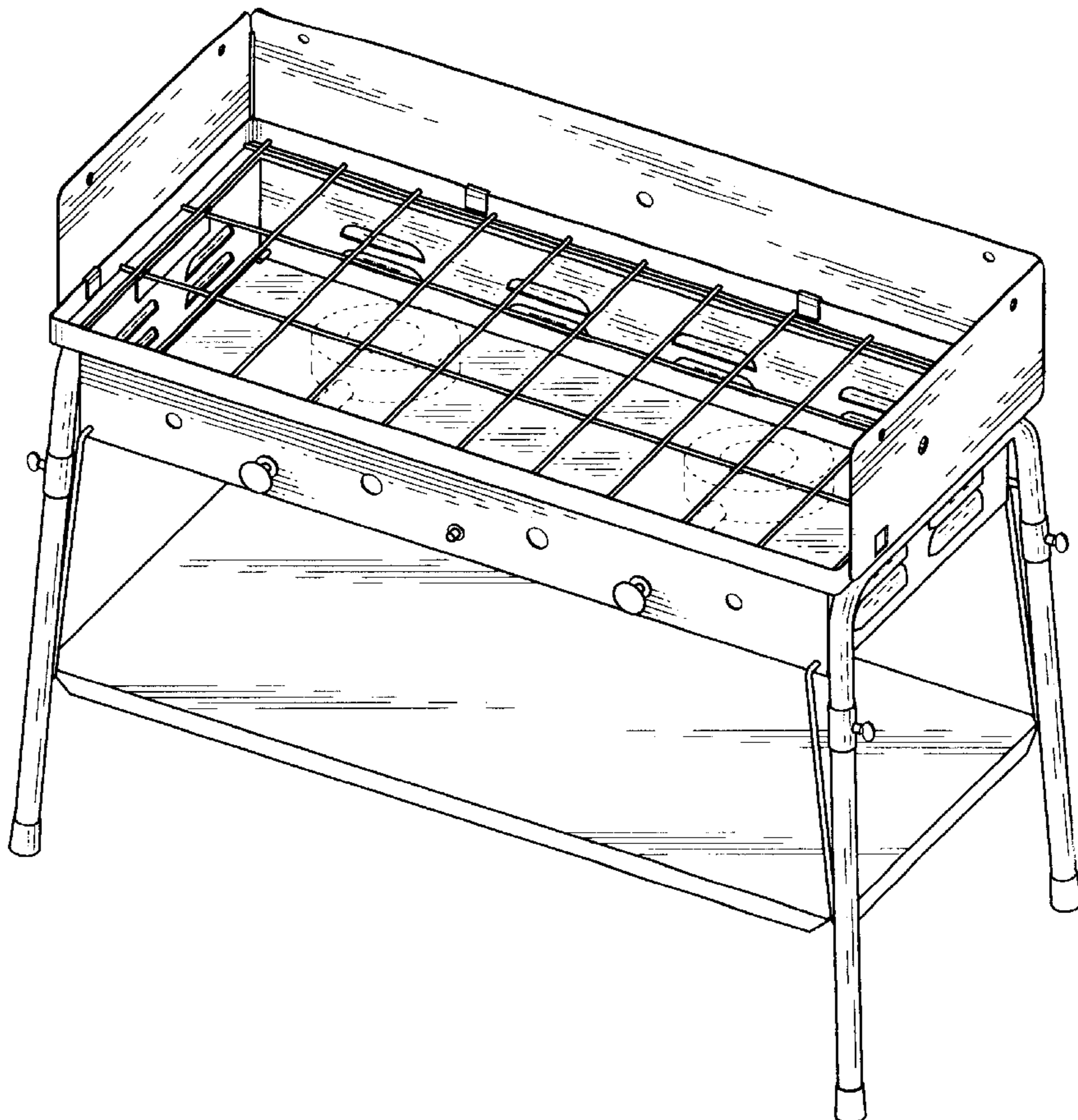
FIG. 1 is a front perspective view of an outdoor cooking stove showing our new design;

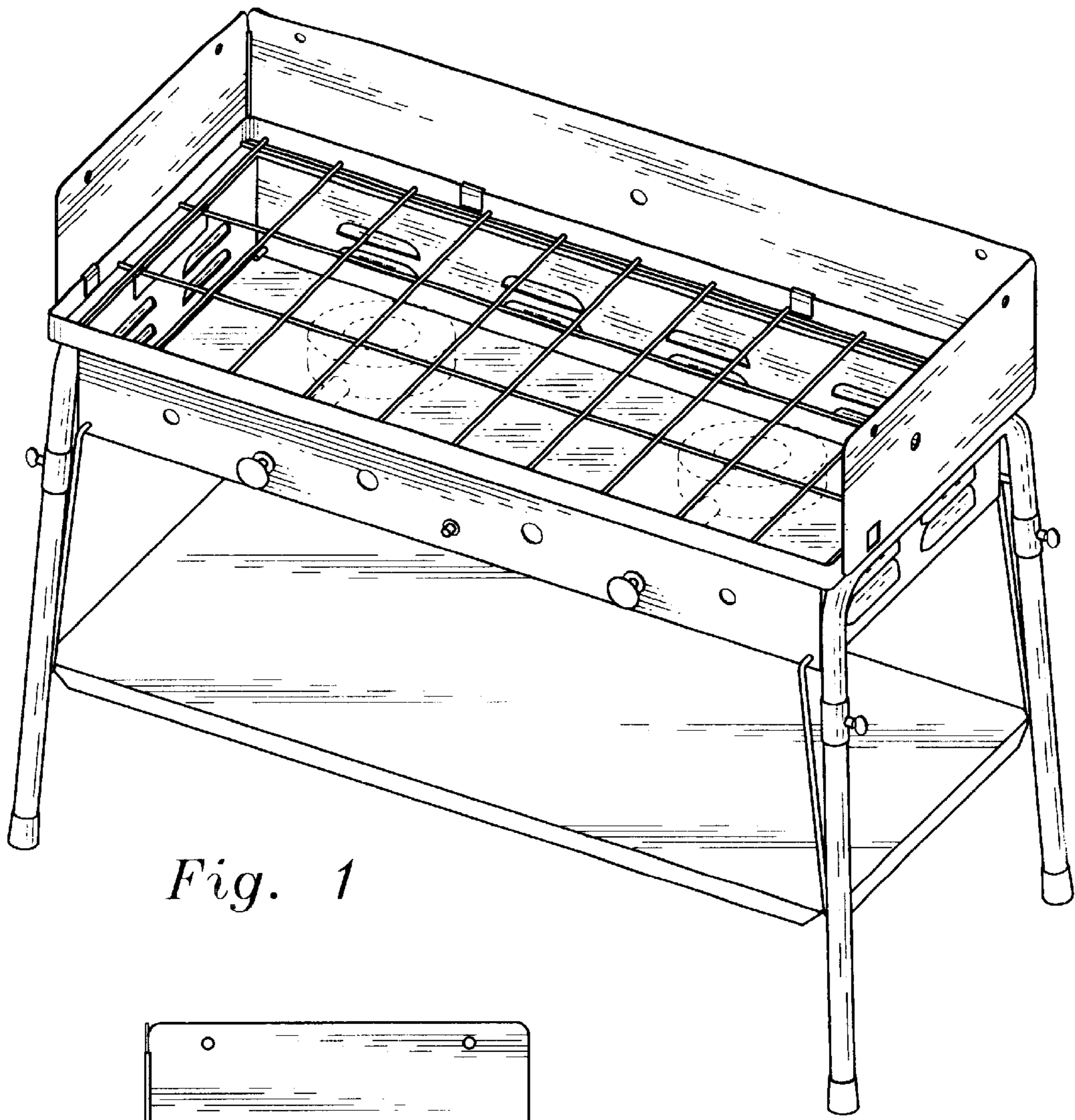

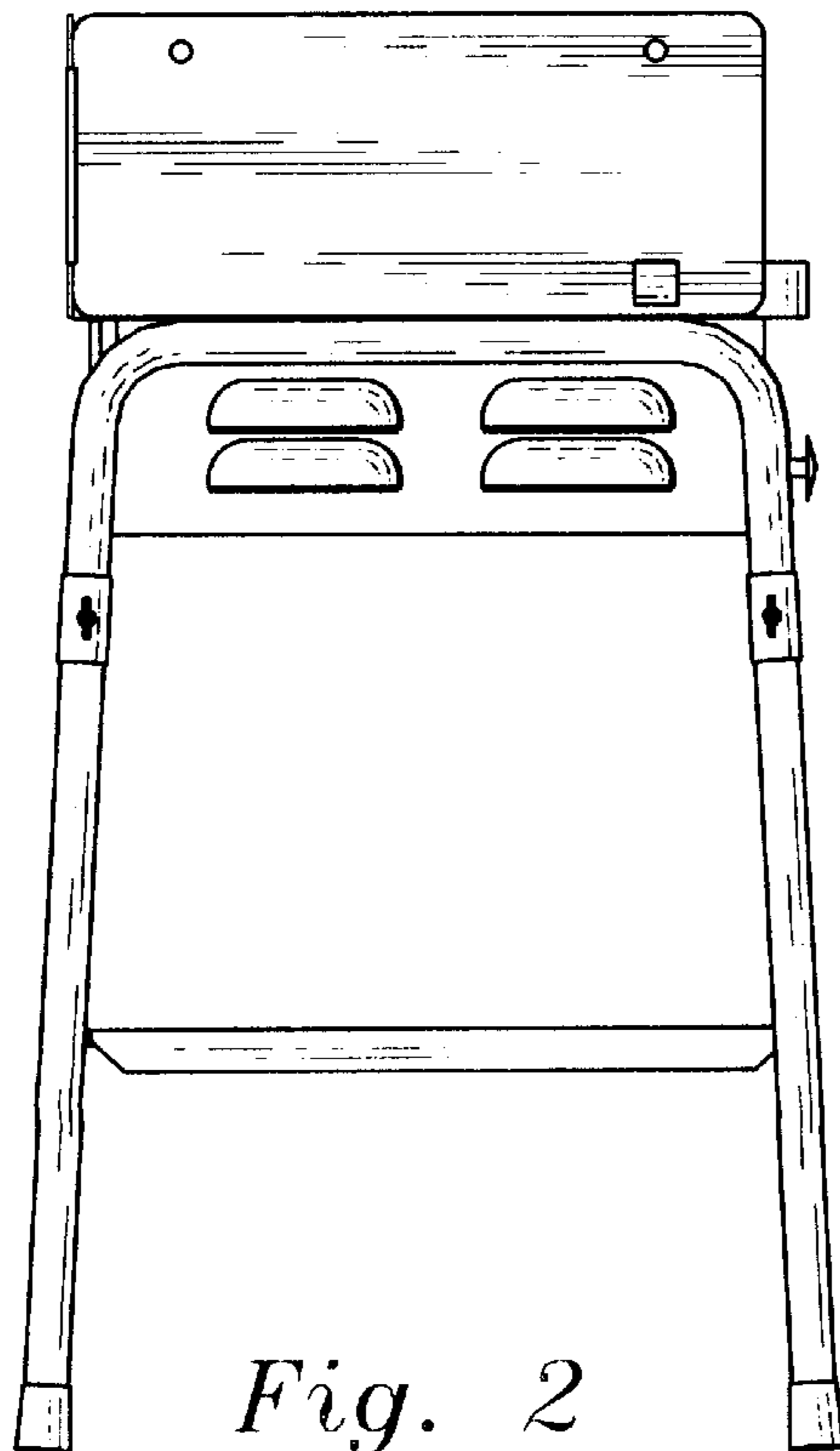

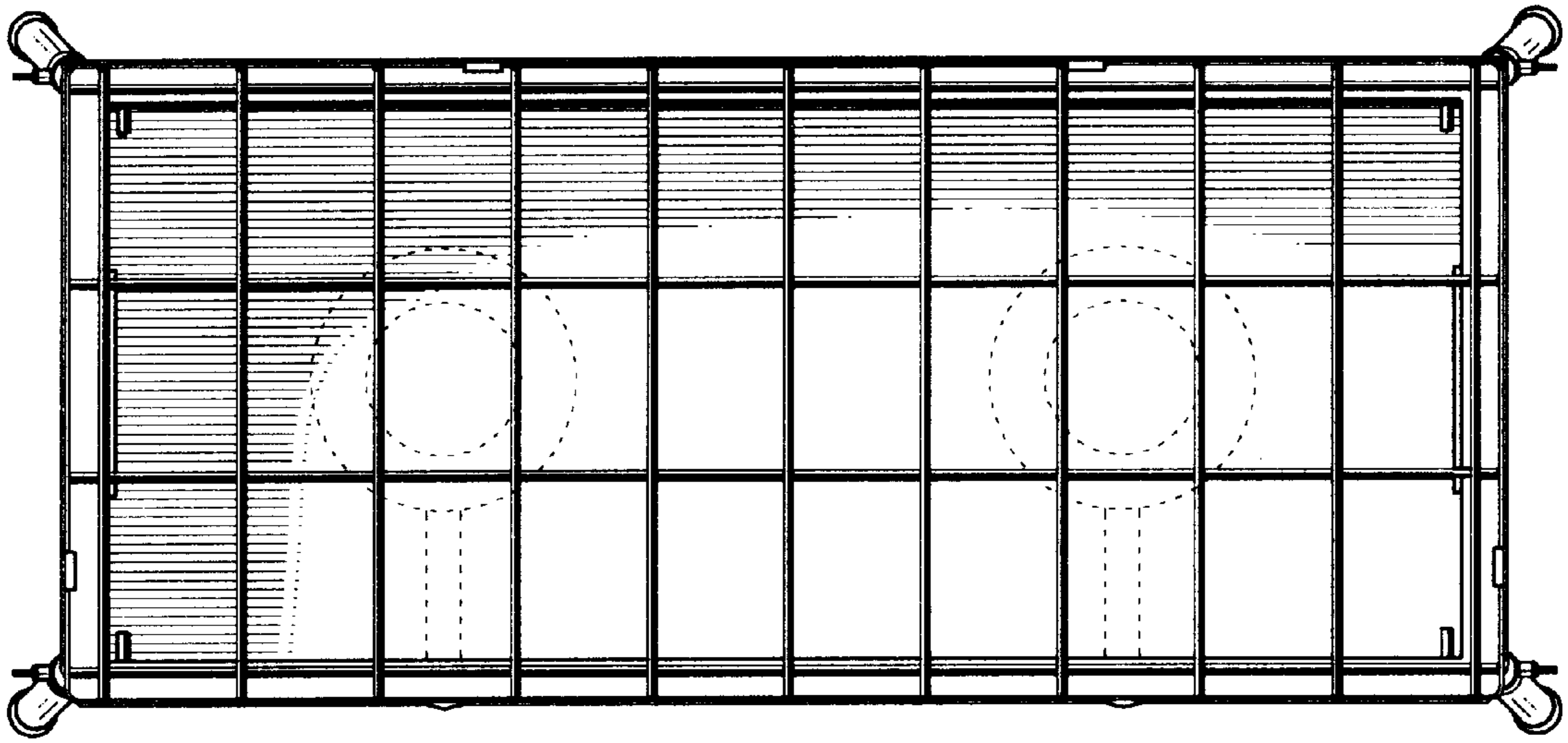

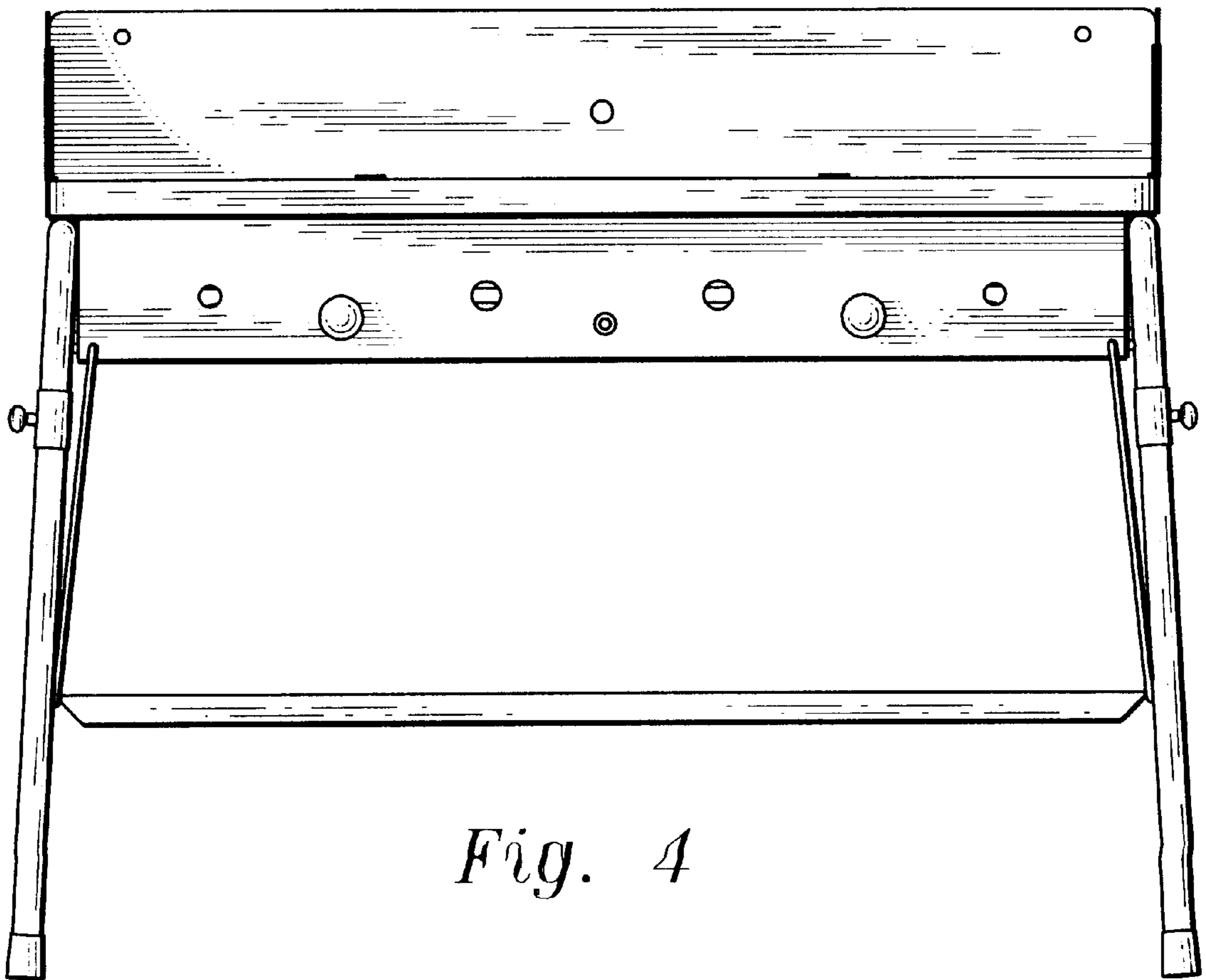

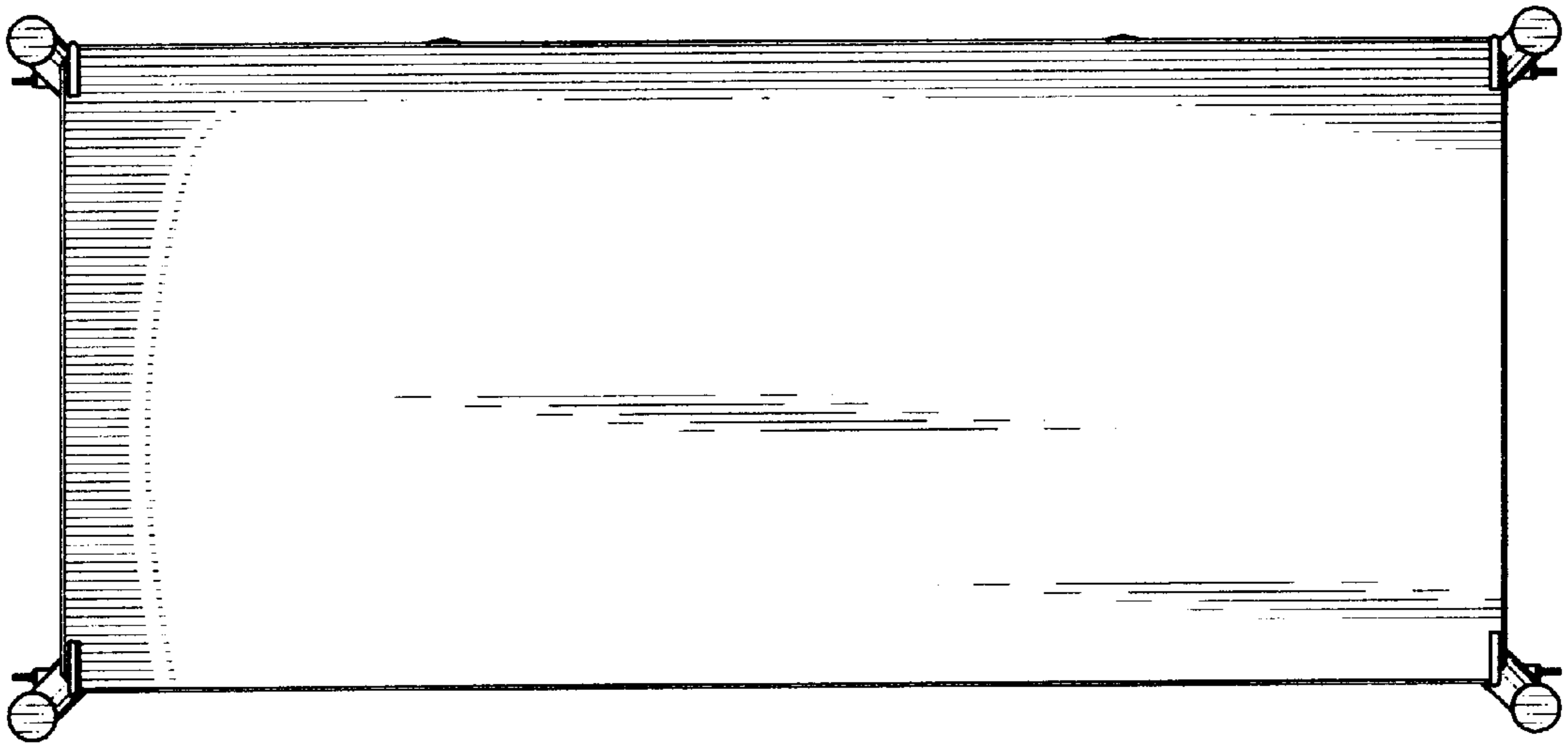

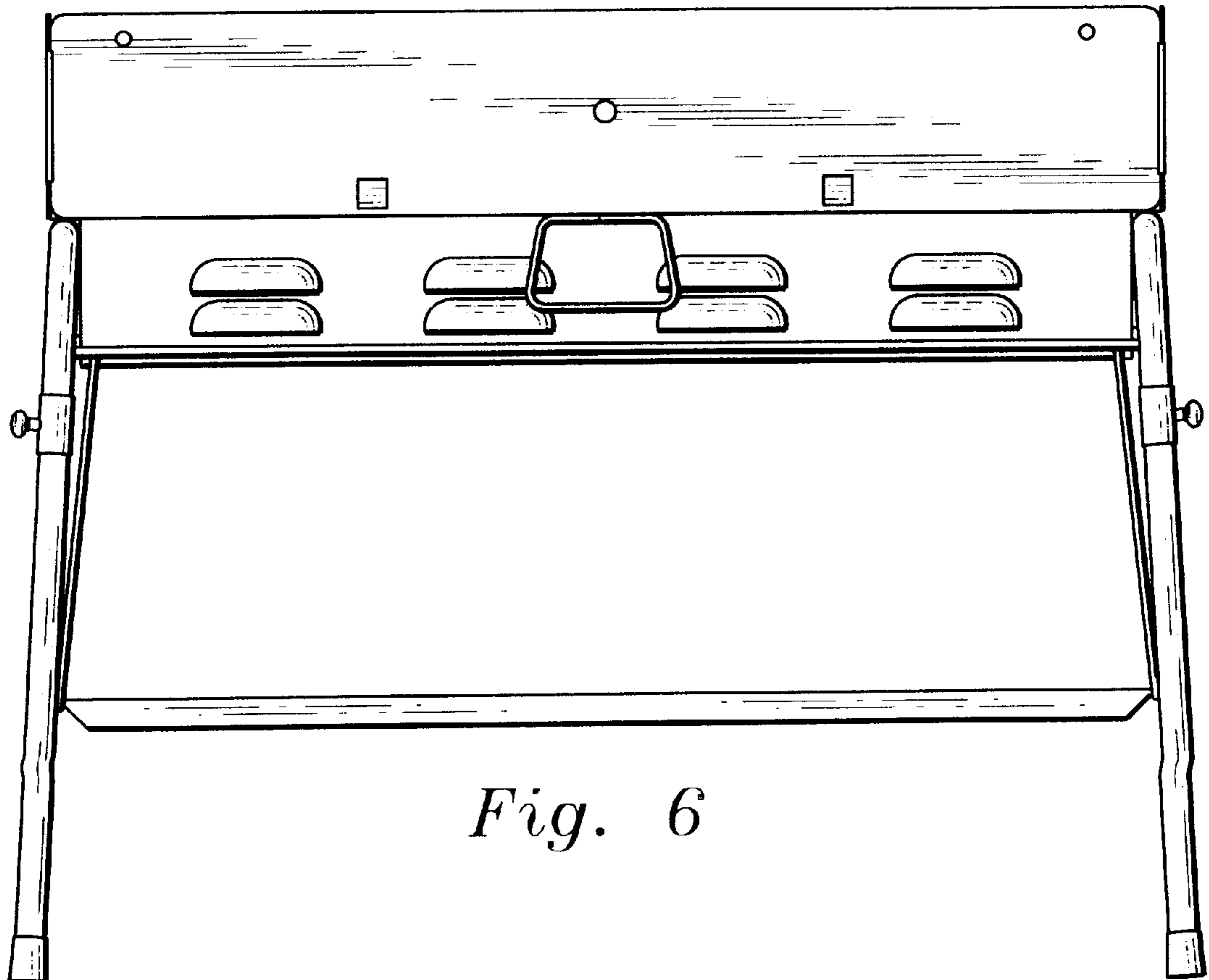
