The ornamental design for a portable telephone, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom, and left side perspective view showing our new design for a portable telephone with the keypad cover closed, with broken line matter being for illustrative purposes only and forming no part of the claimed design.

FIG. 2 is a front, bottom, and left side perspective view showing our new design for a portable telephone with the keypad cover open, with broken line matter being for illustrative purposes only and forming no part of the claimed design.

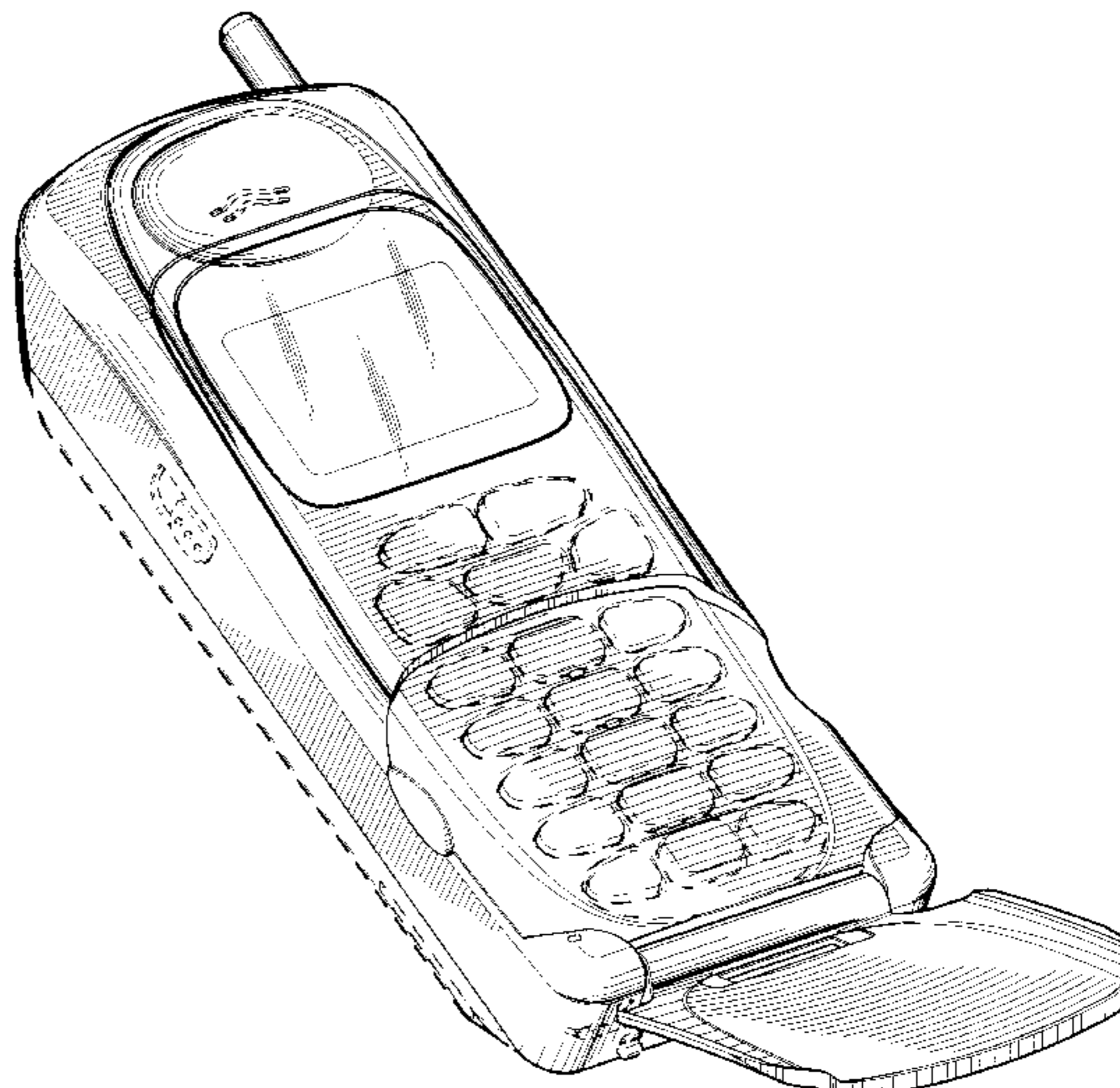
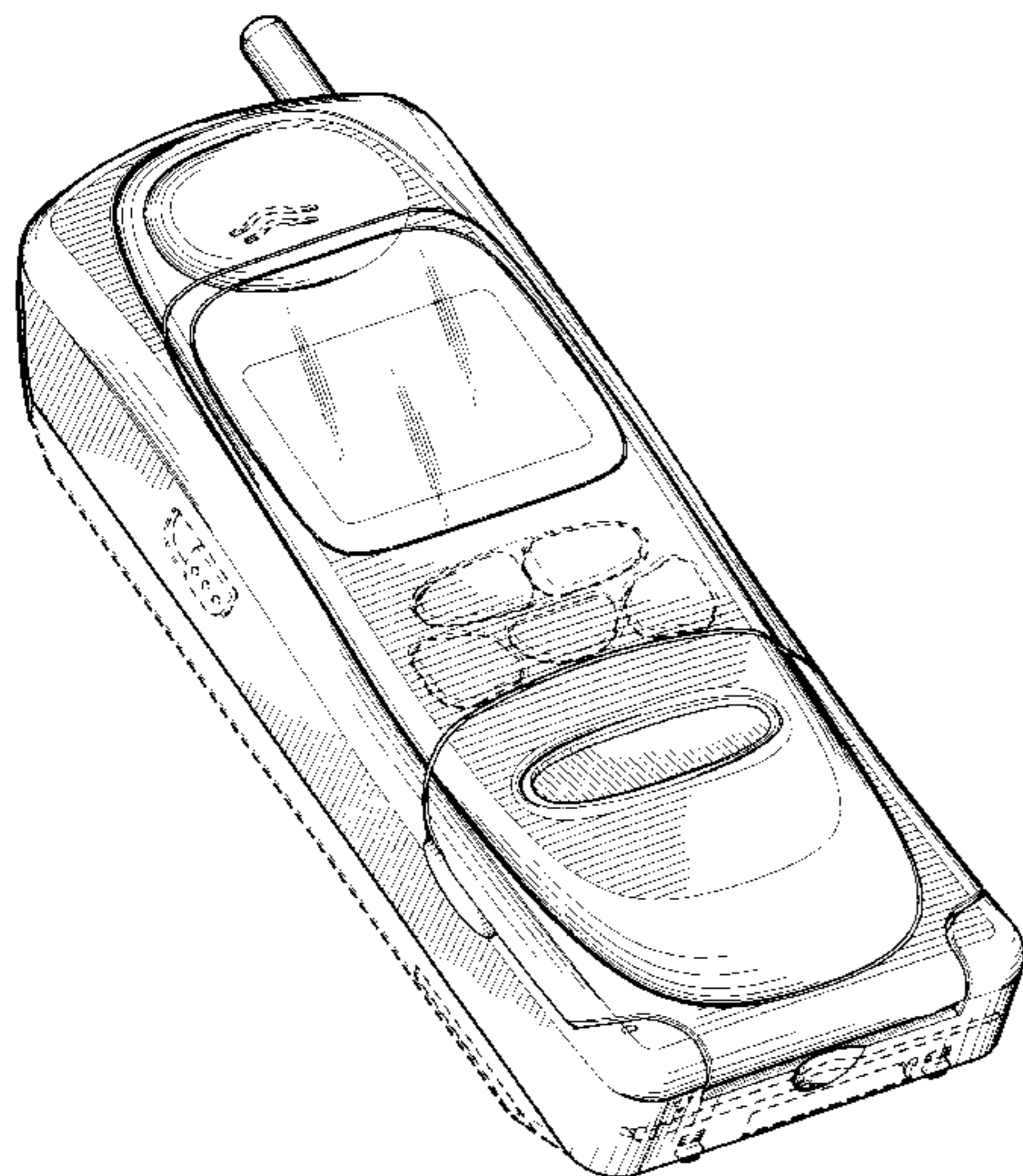

FIG. 5 is a top plan view of the portable telephone with the keypad cover closed, with broken line matter being for illustrative purposes only and forming no part of the claimed design; and,

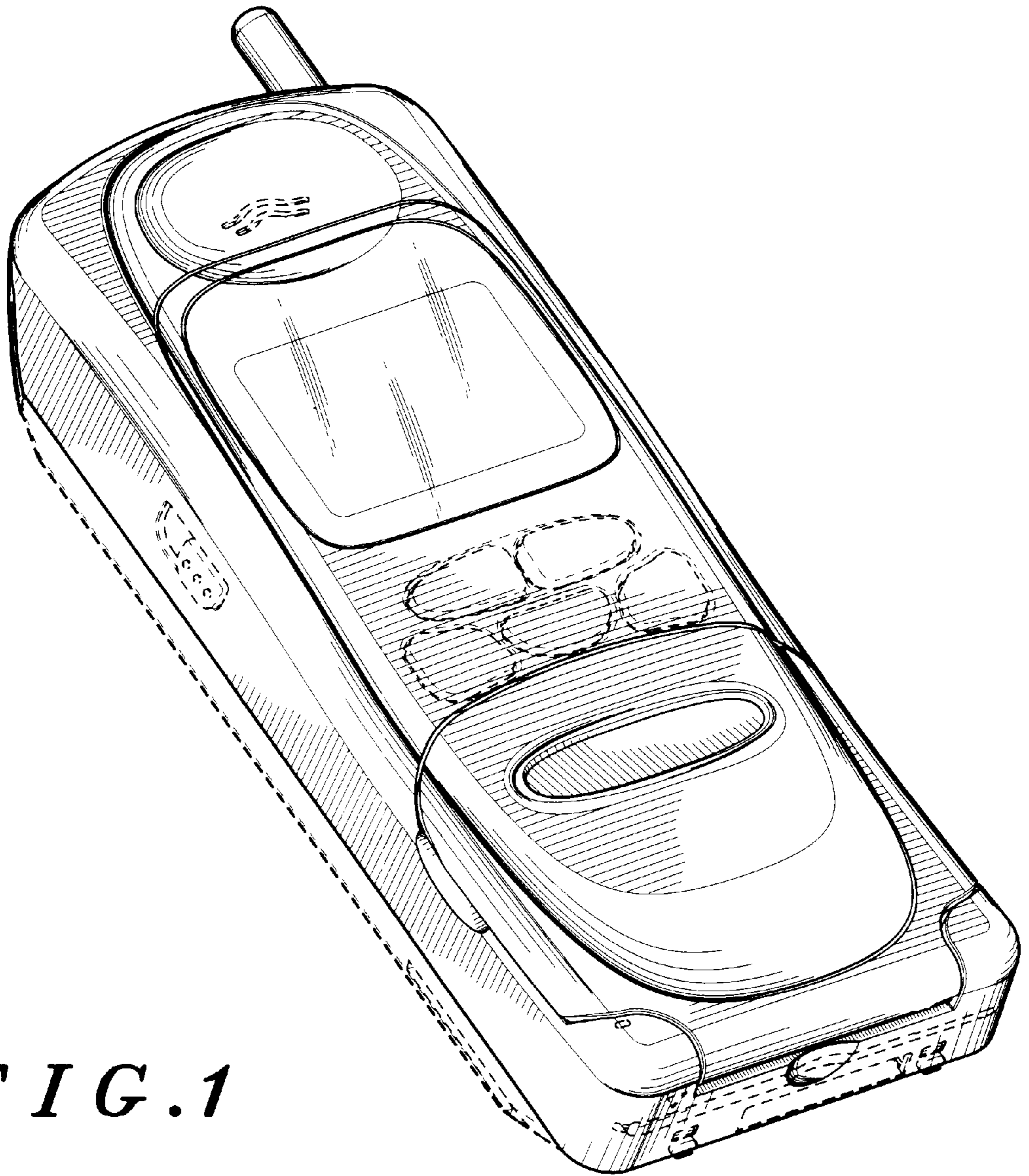

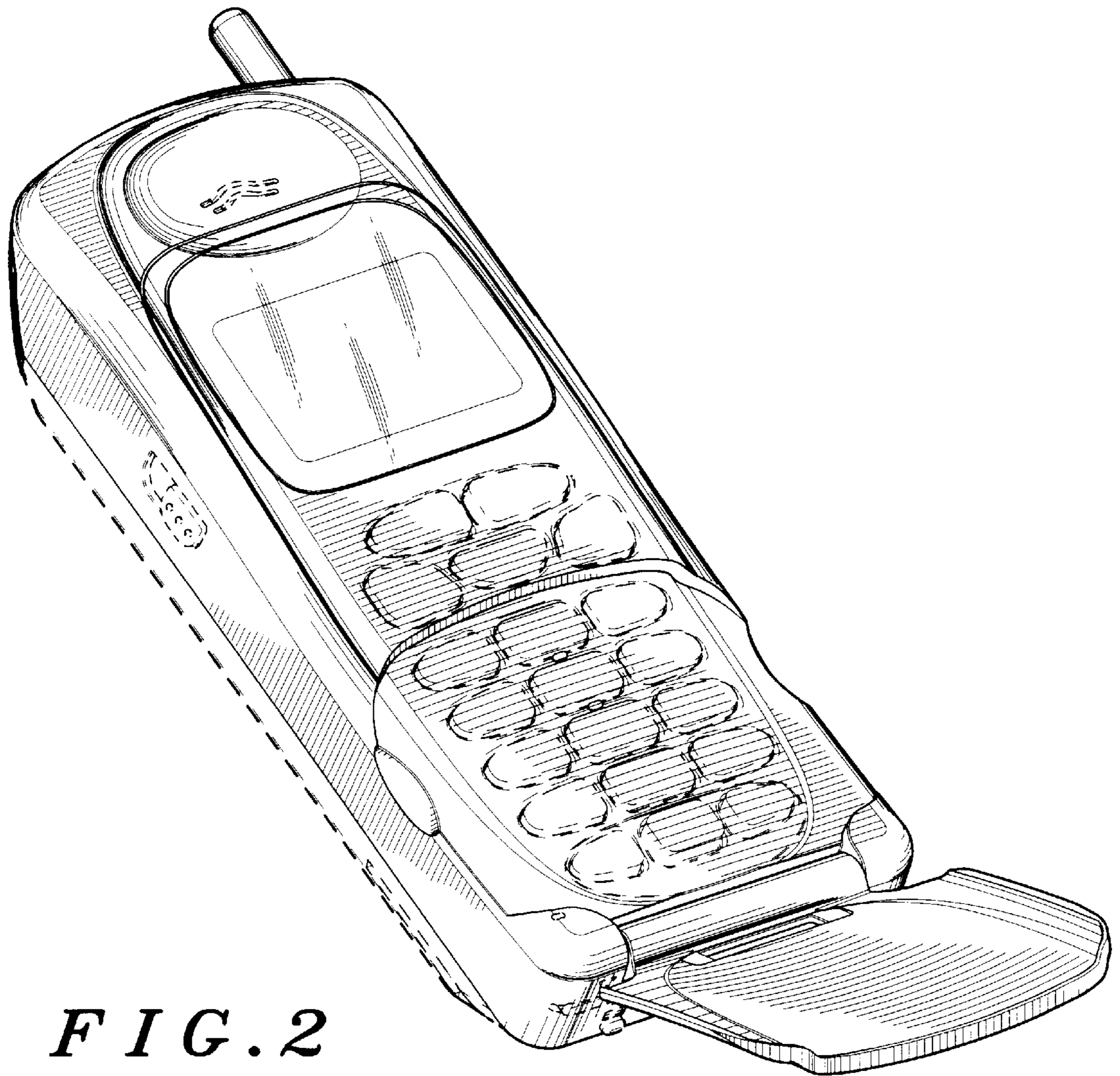

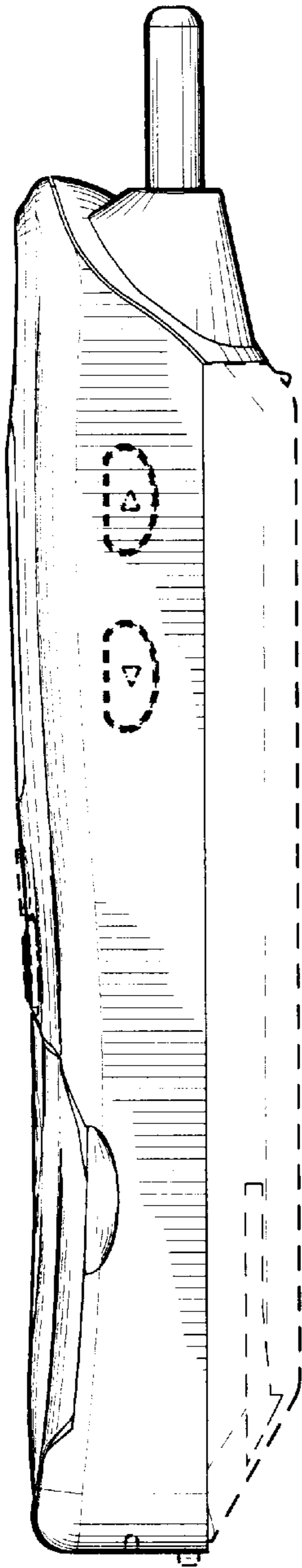

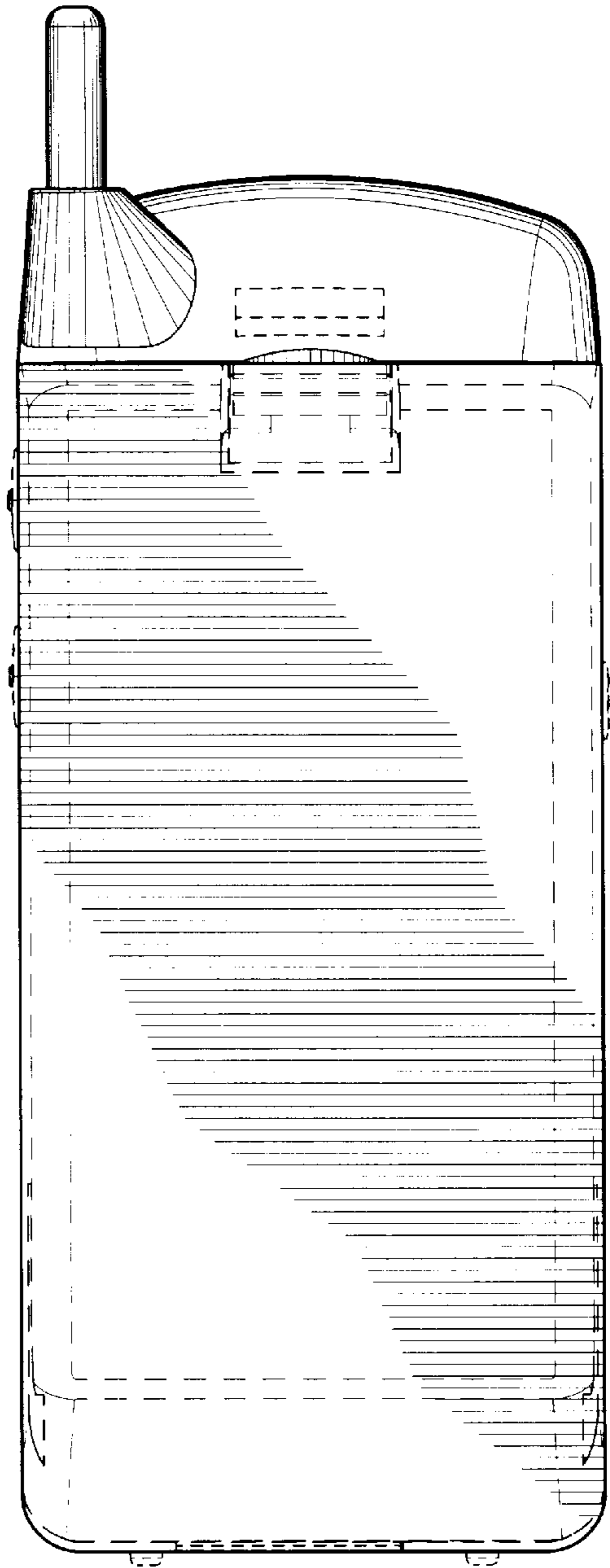
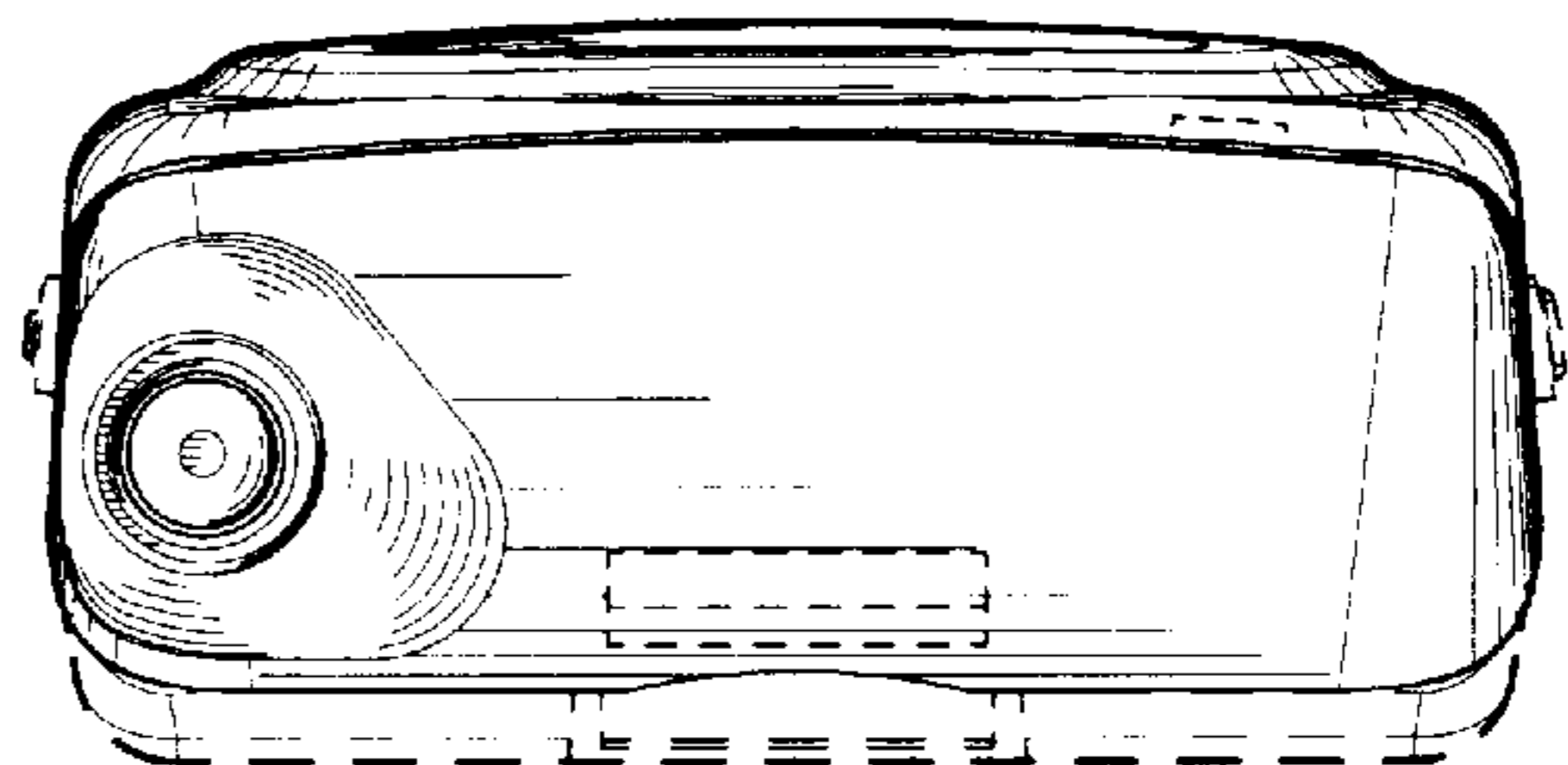

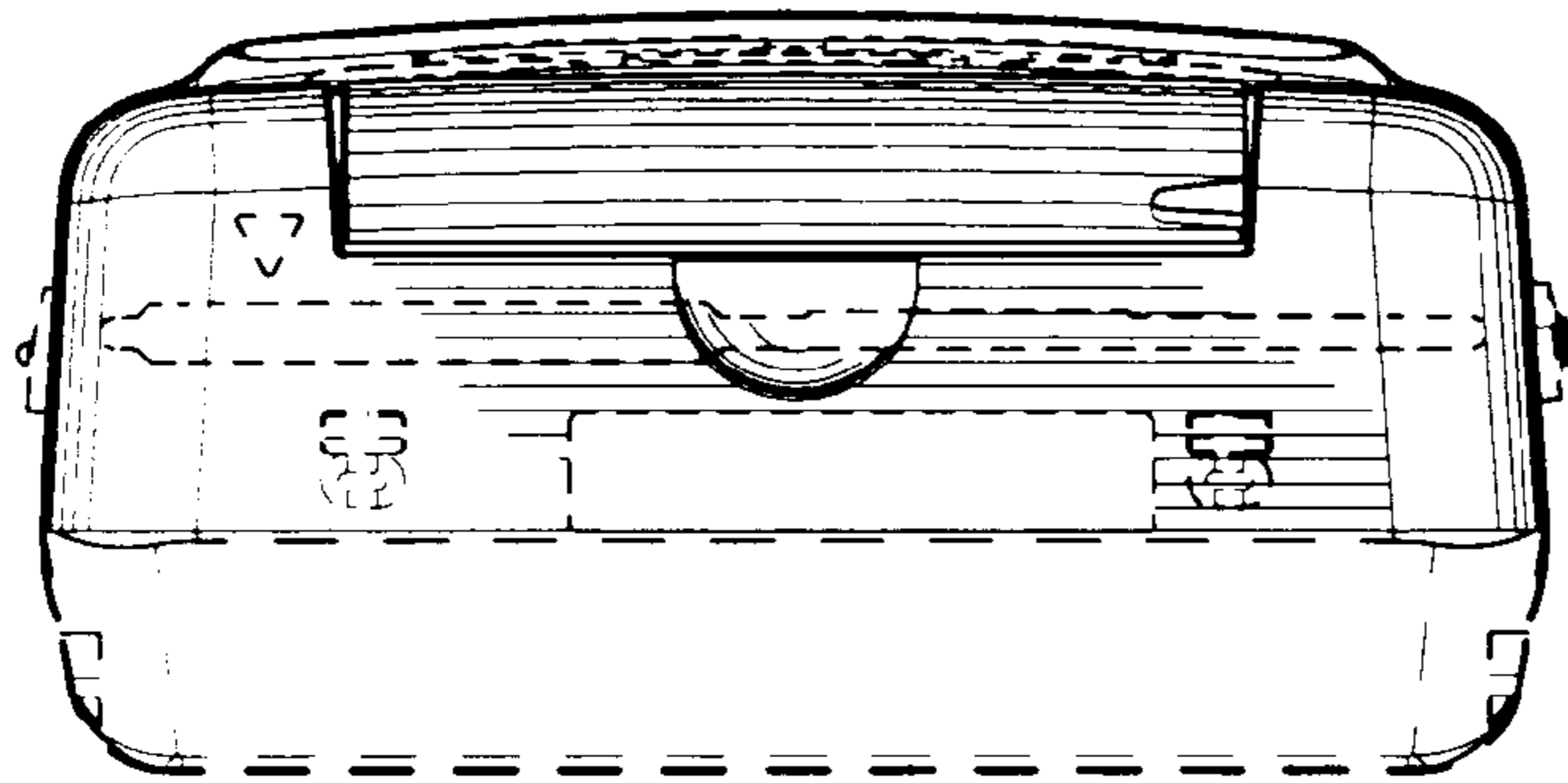
