[57] CLAIM

The ornamental design for a wetsuit neck, as shown and described.

DESCRIPTION

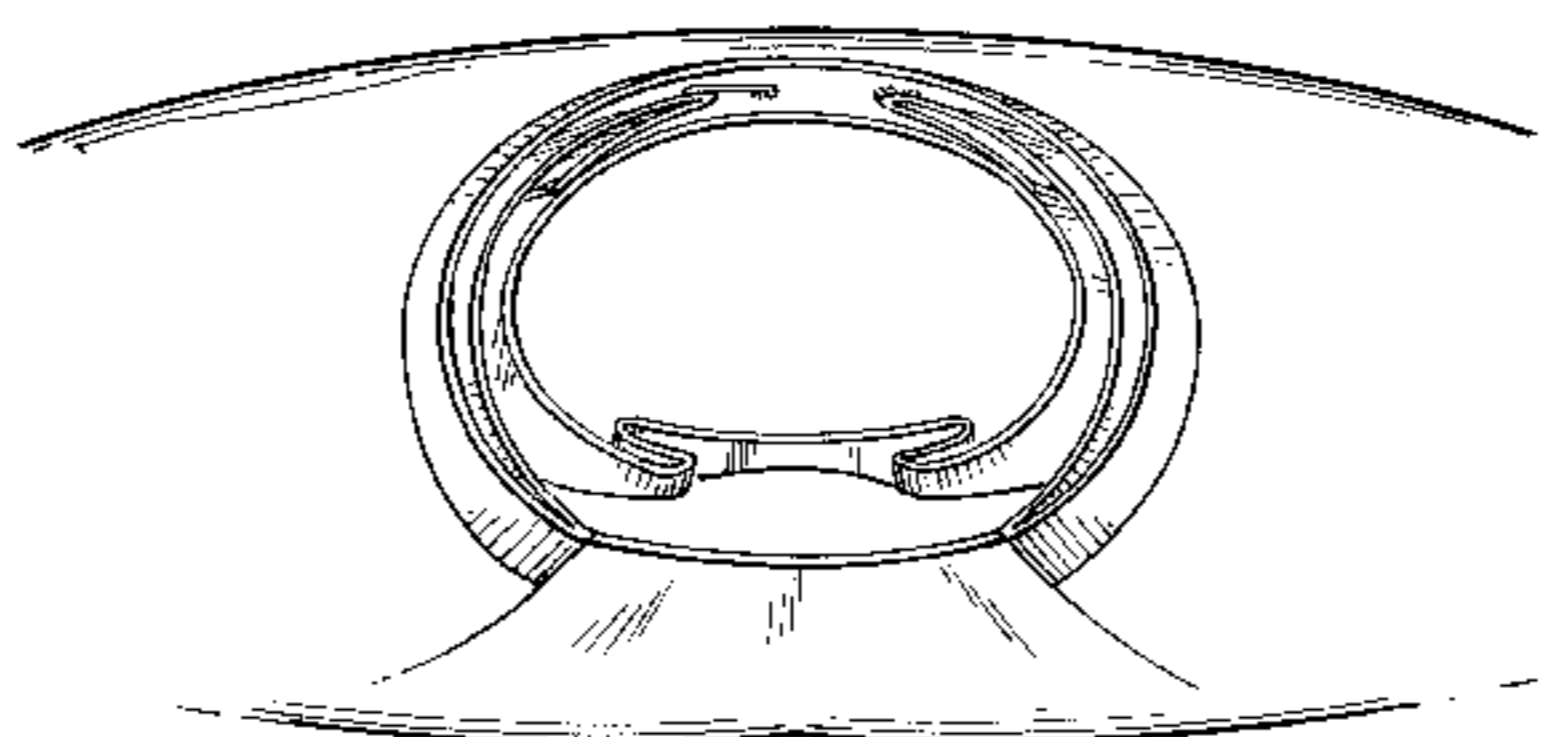


FIG. 2 is a rear perspective view of FIG. 1;

FIG. 1 is a front perspective view of a wetsuit neck showing our new design; the broken lines showing the remainder of the wetsuit in FIGS. 1 and 2 being for illustrative purposes only and forming no part of the claimed design;

FIG. 3 is an enlarged front perspective view of the wetsuit neck shown in FIG. 1;
FIG. 4 is a rear perspective view of FIG. 3;

FIG. 7 is a front elevational view of FIG. 3; and,
FIG. 8 is a right side elevational view of FIG. 3, the left side being a mirror image.

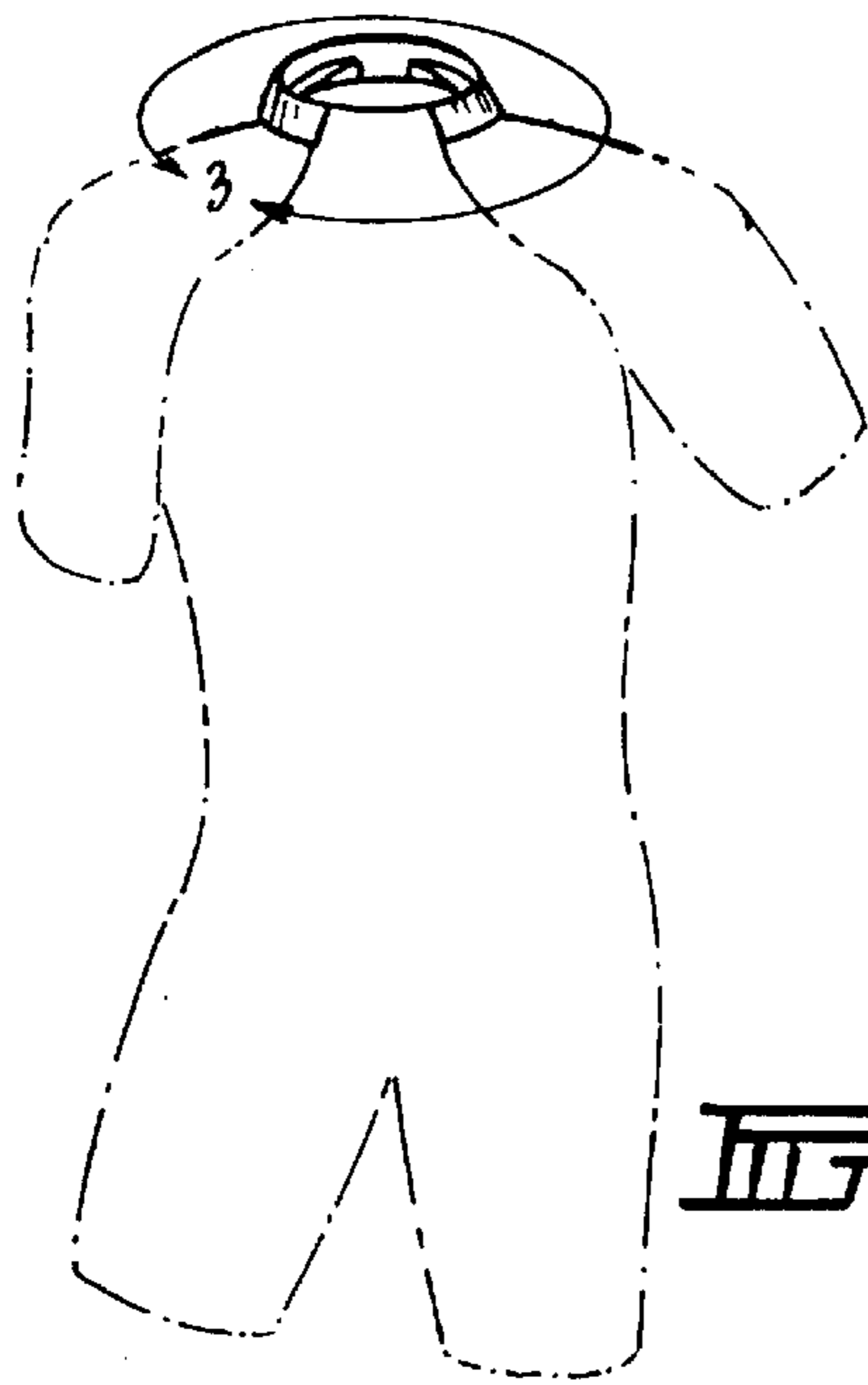

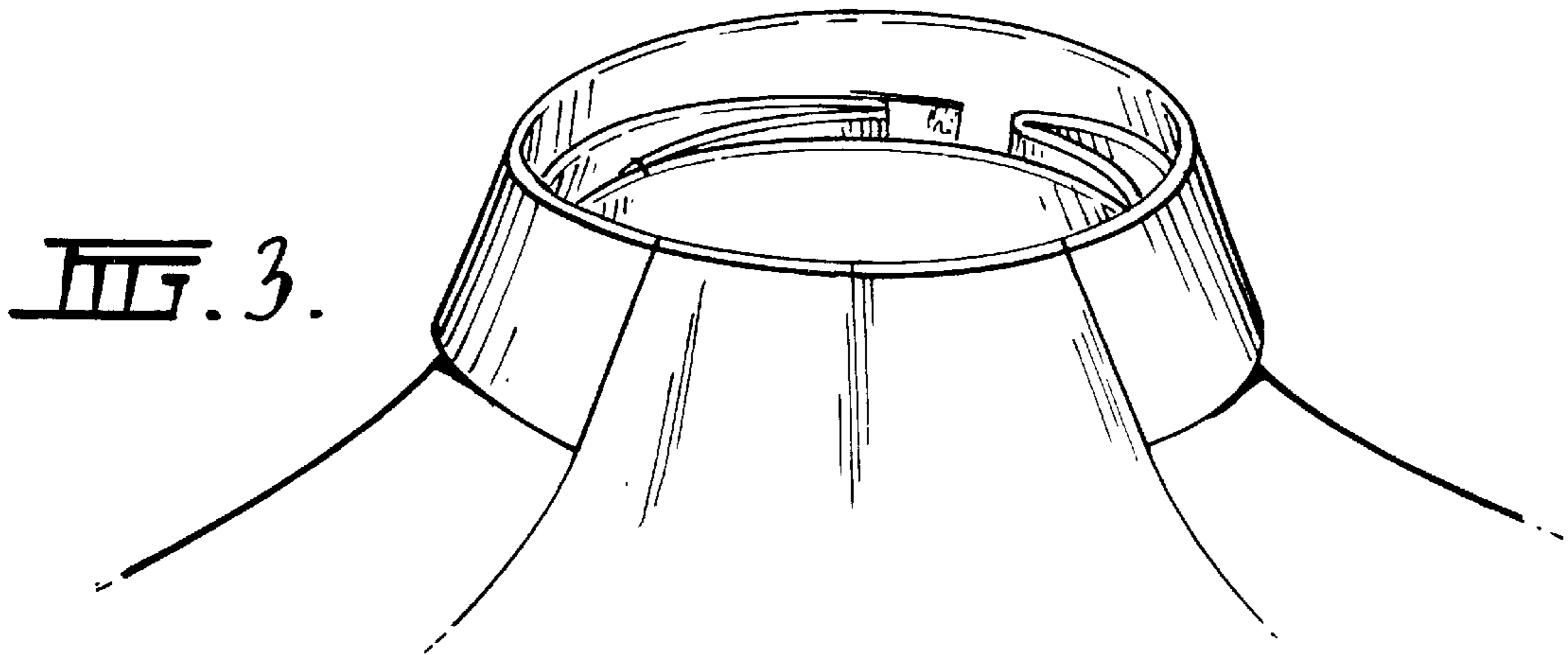

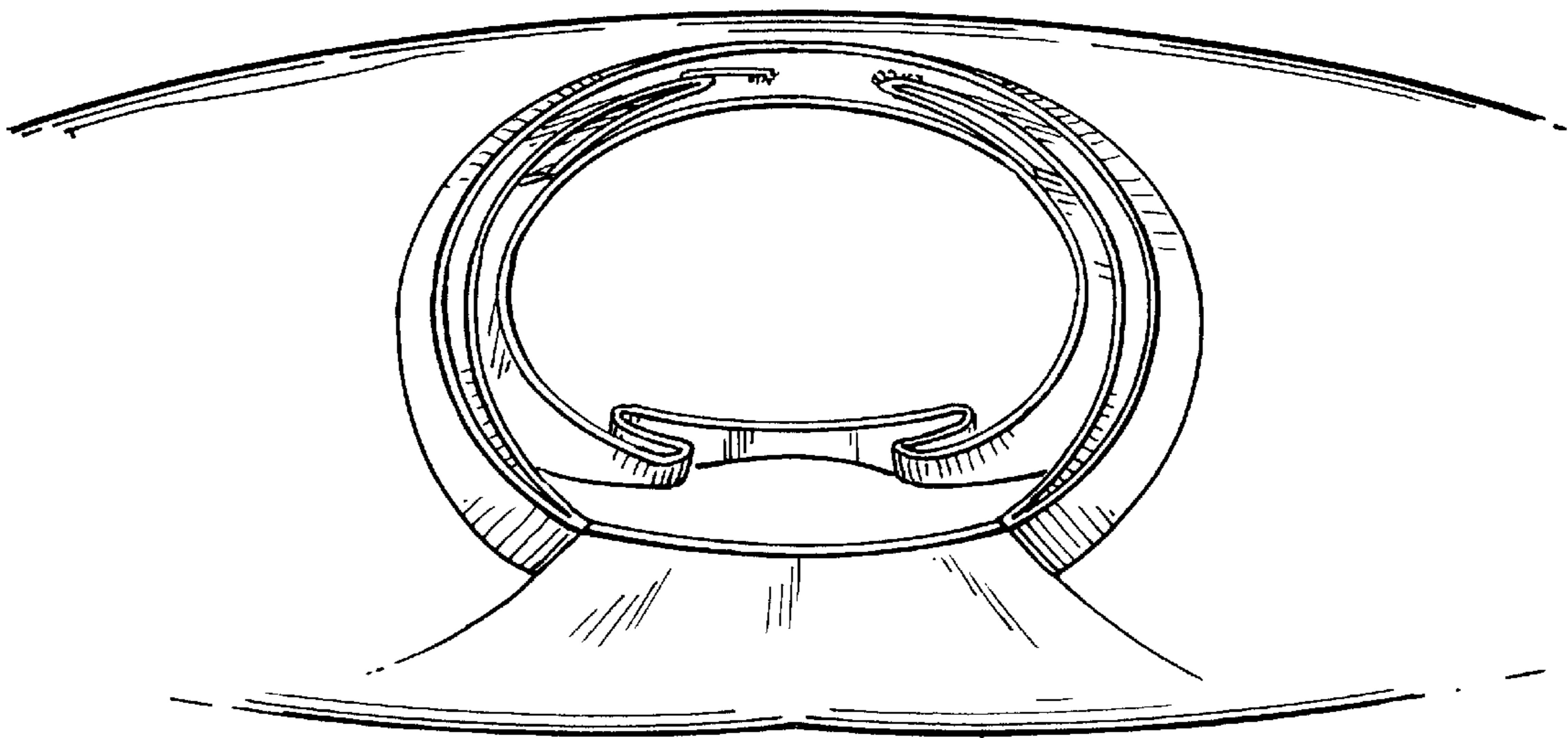

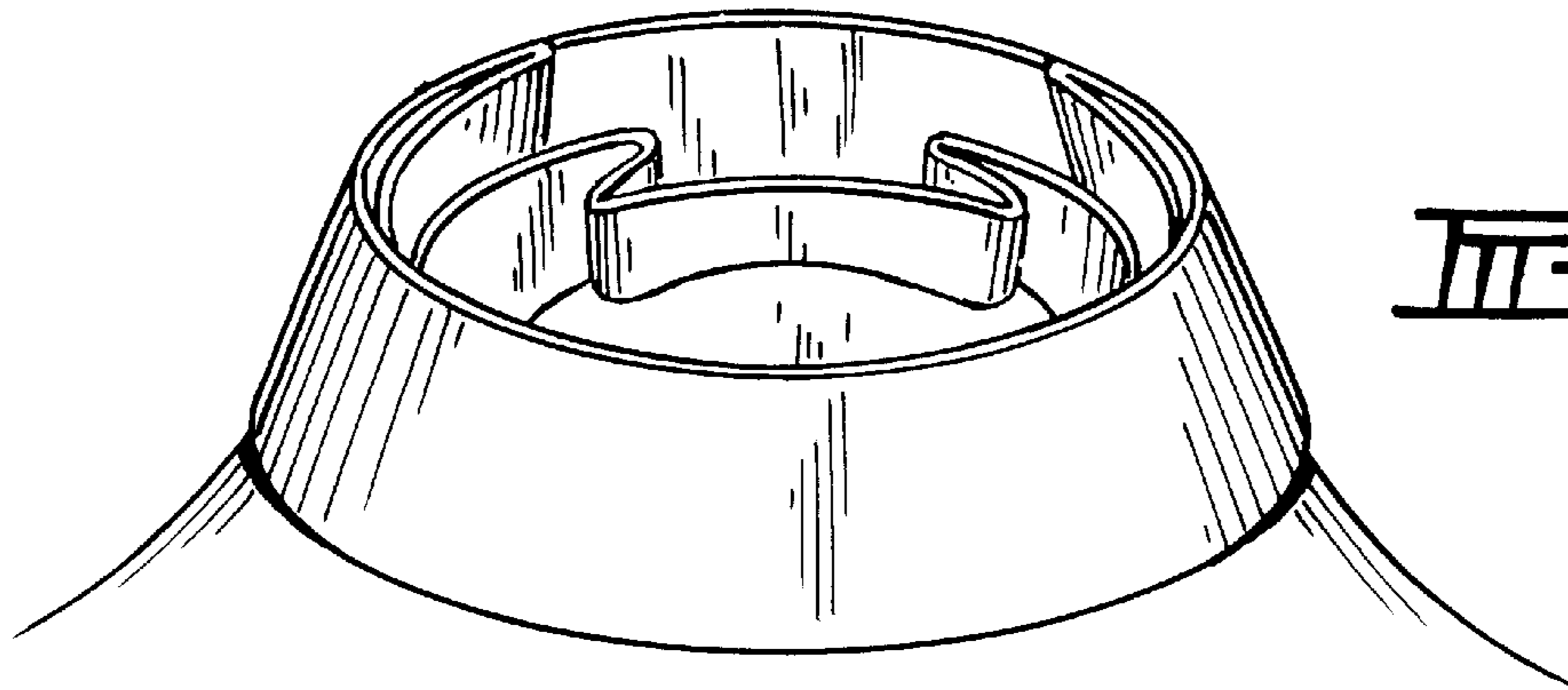

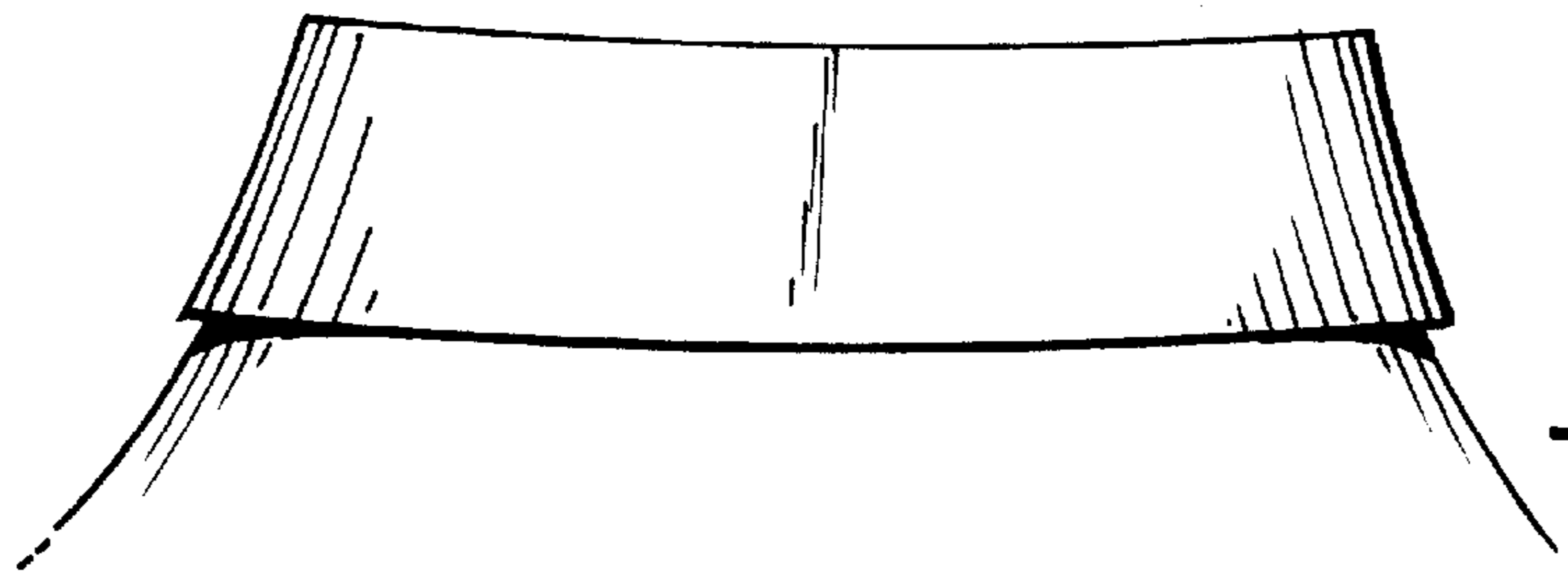

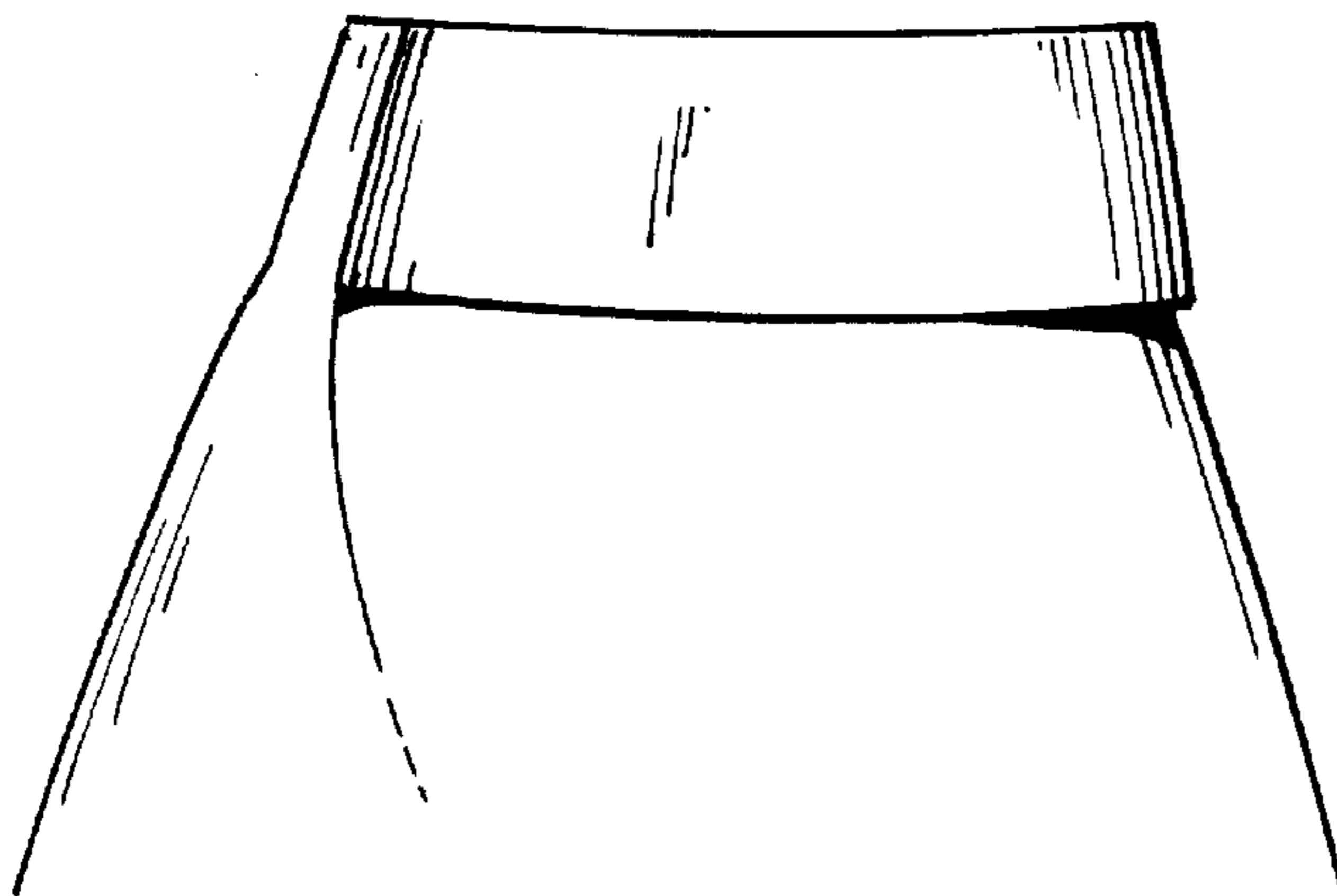
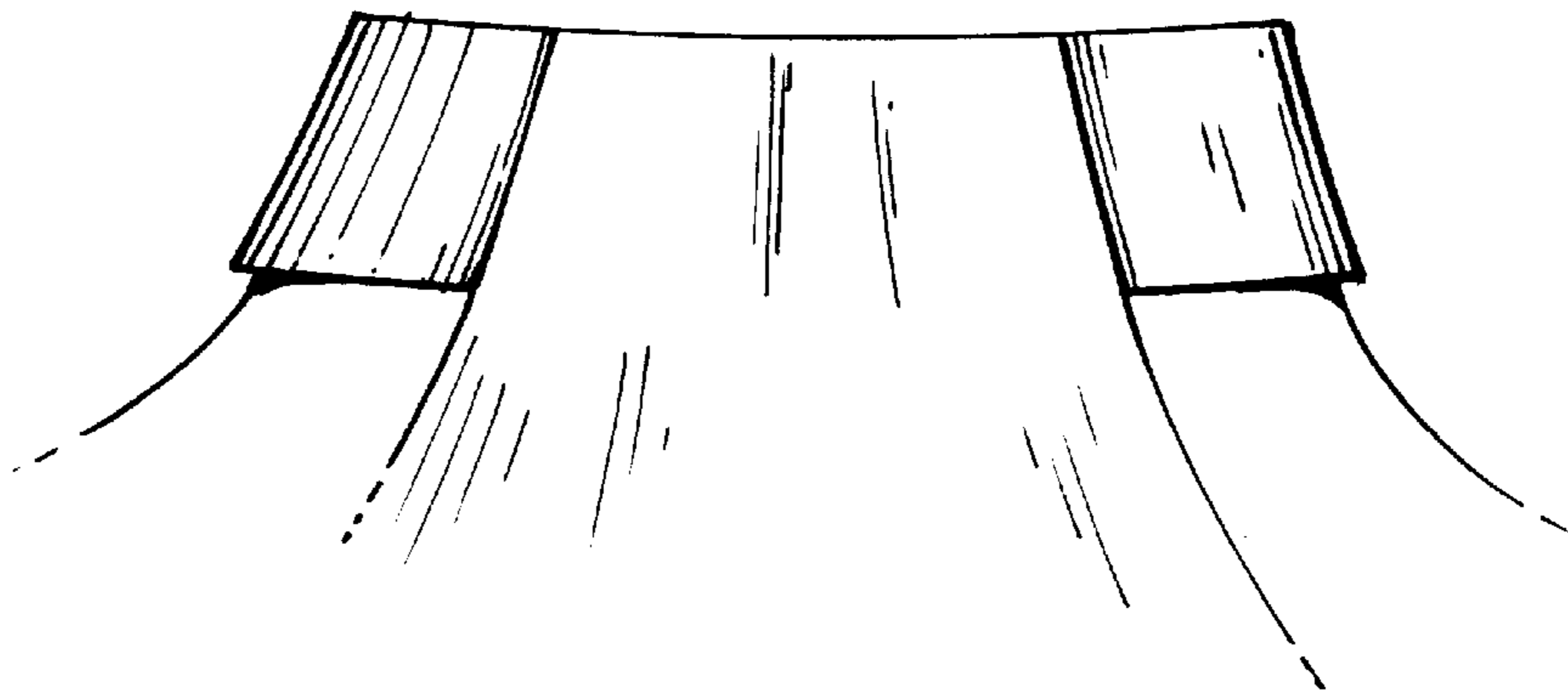
