[57] **CLAIM**

The ornamental design for a base for a car seat, as shown and described.

**DESCRIPTION**

FIG. 1 is a top left front perspective view of a base for a car seat showing my new design;

FIG. 2 is a left side elevational view thereof; the right side elevational view being a mirror image;

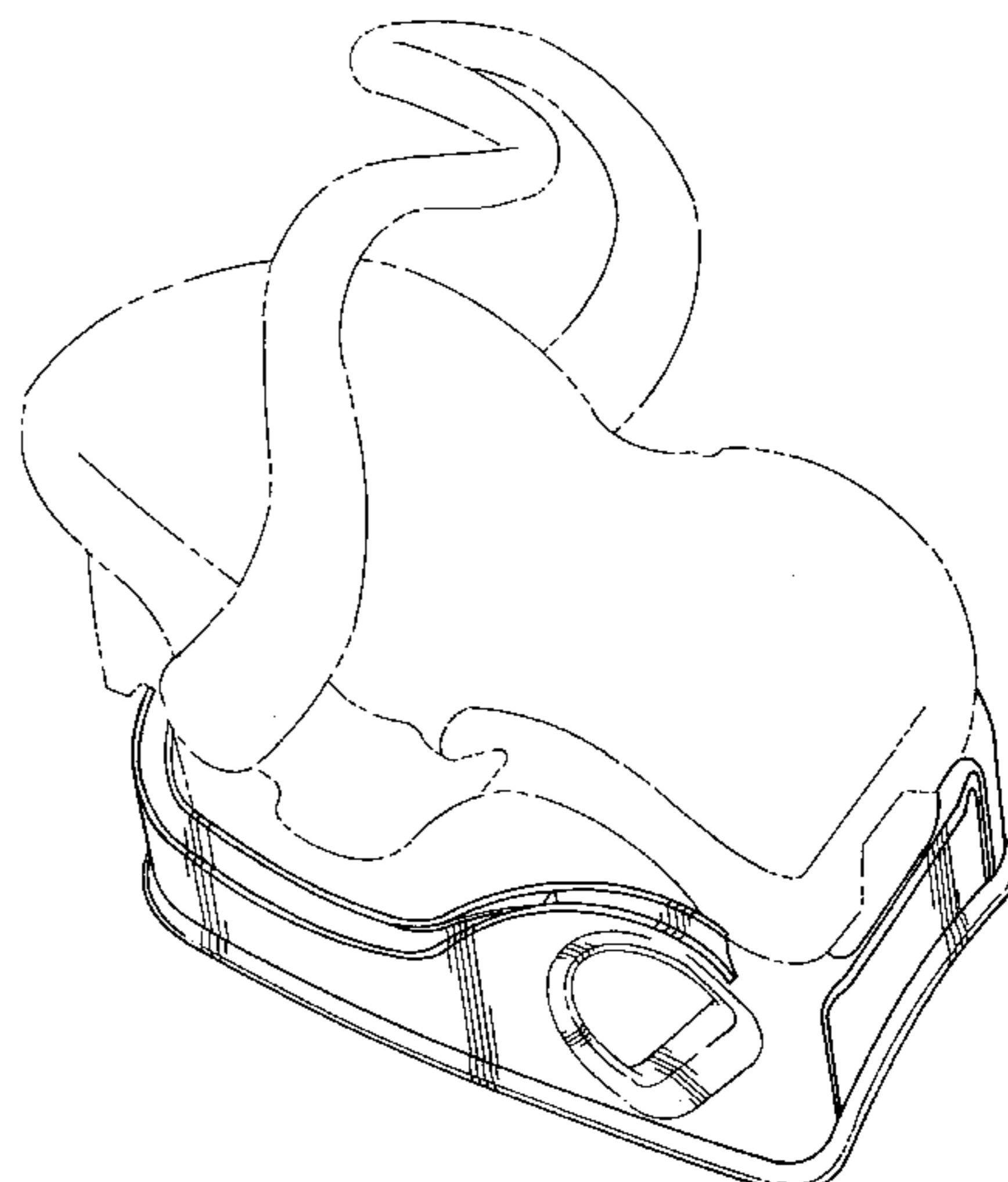
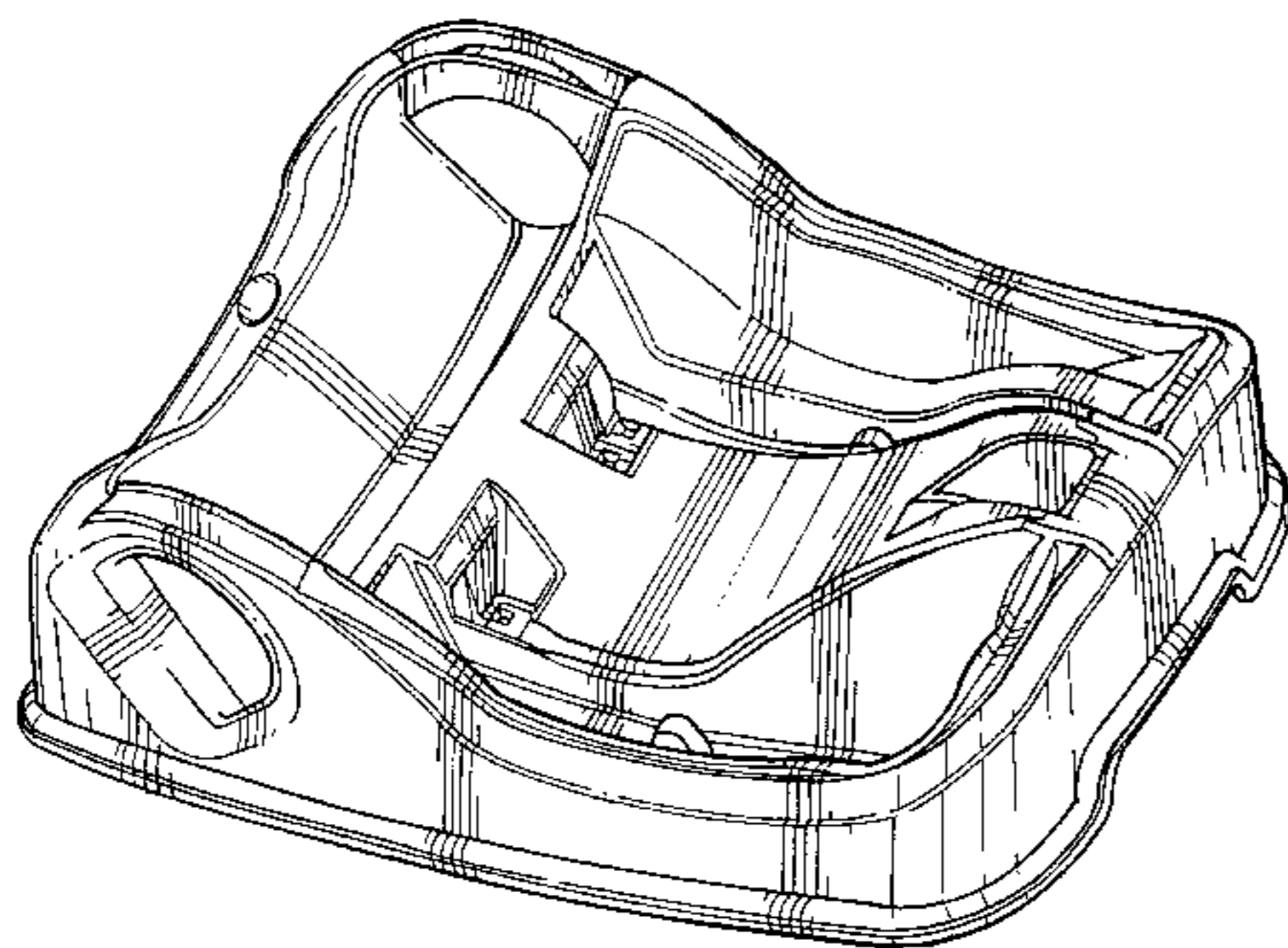
FIG. 3 is a top plan view thereof;

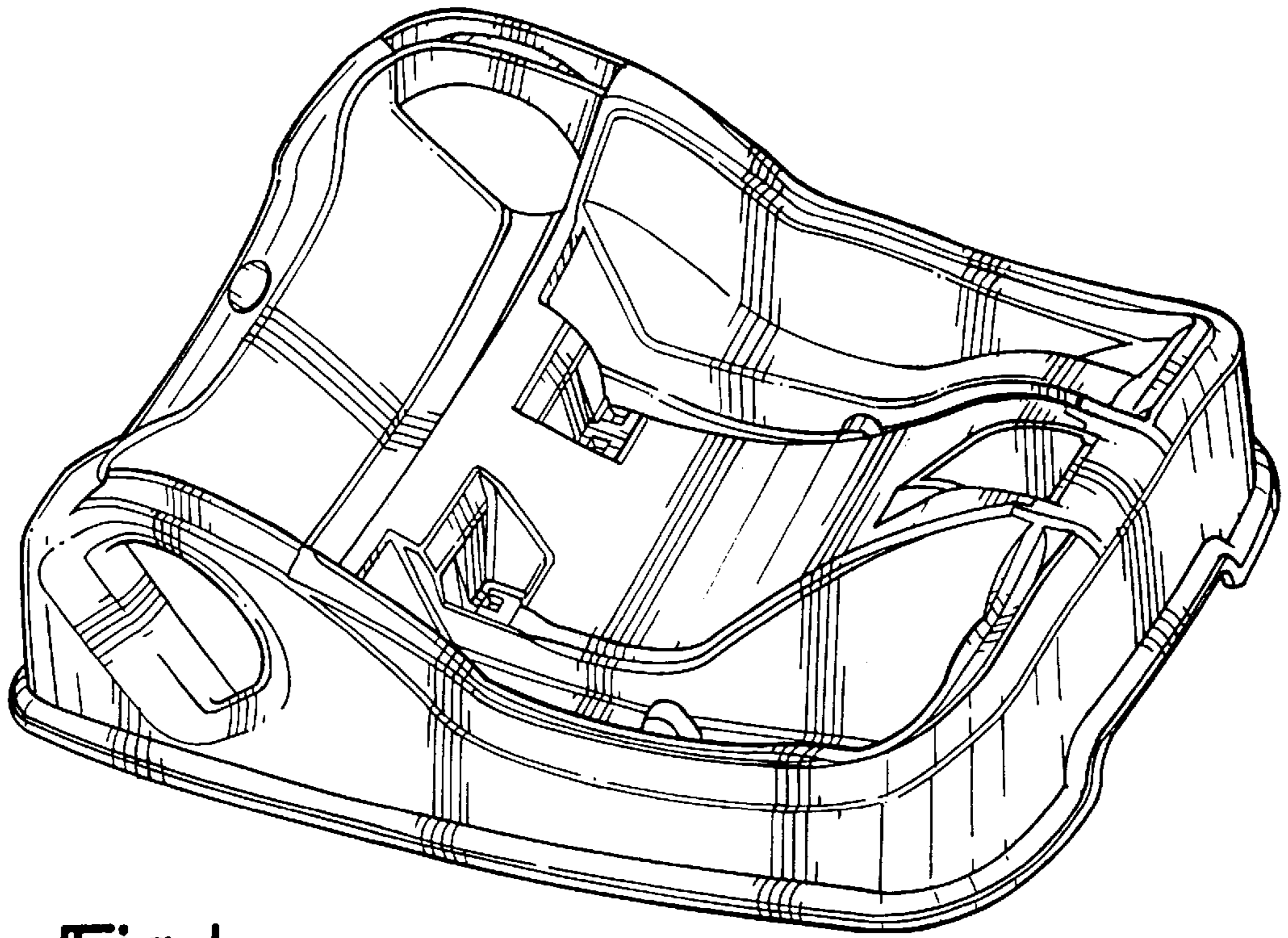

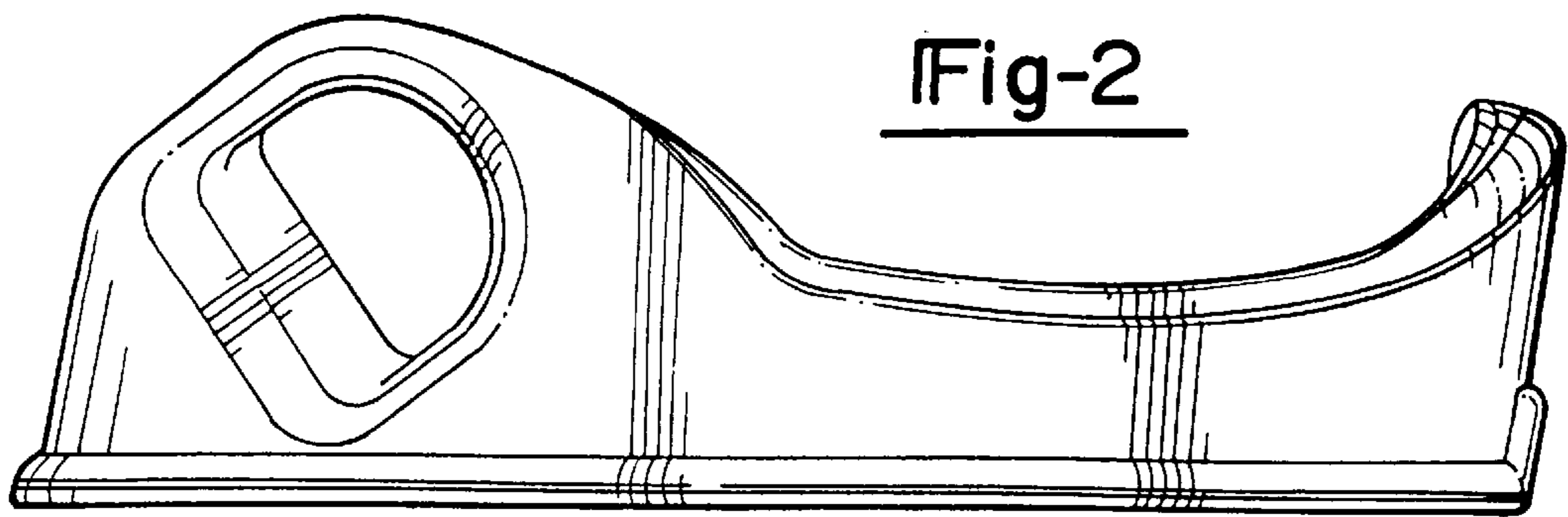

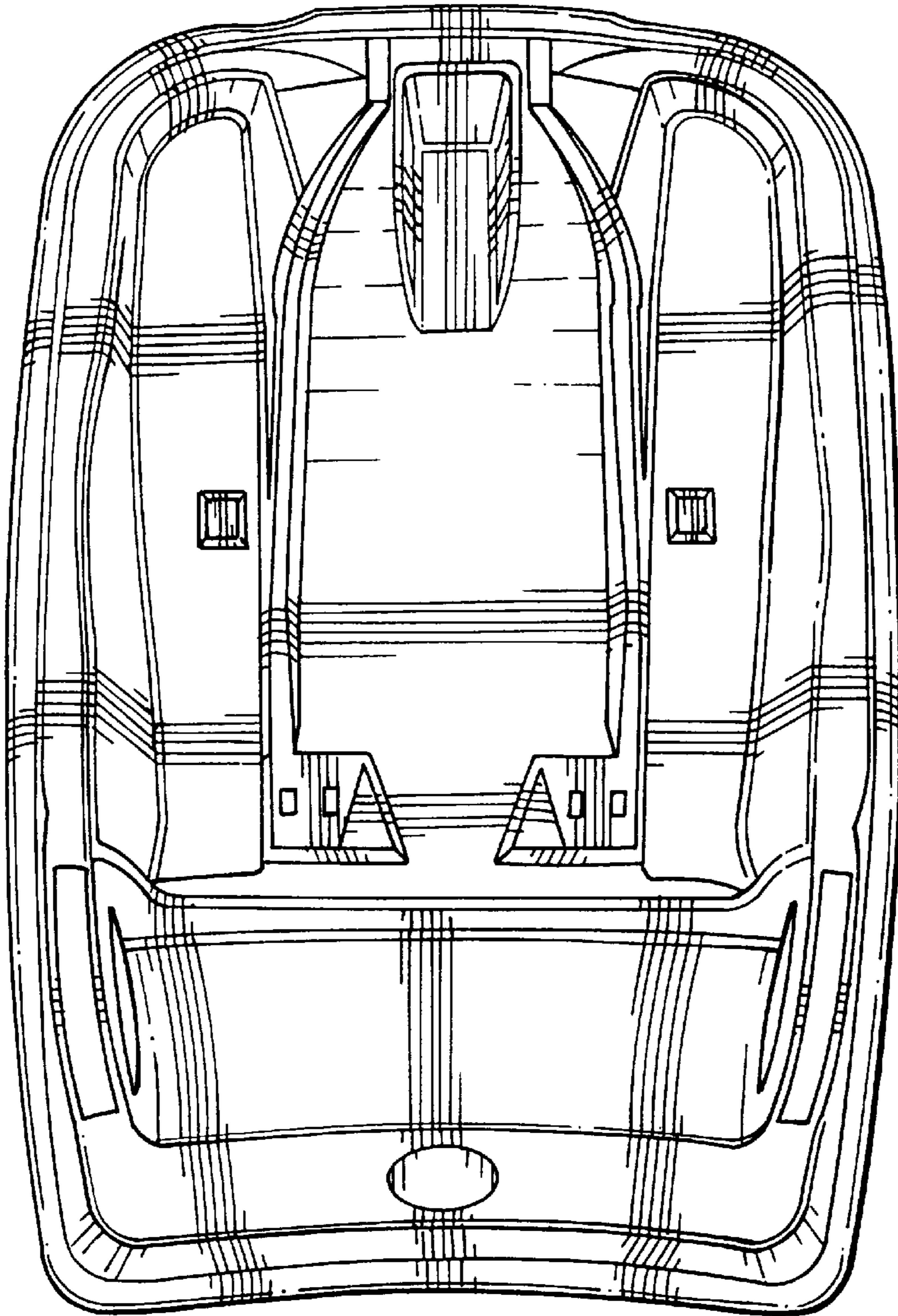

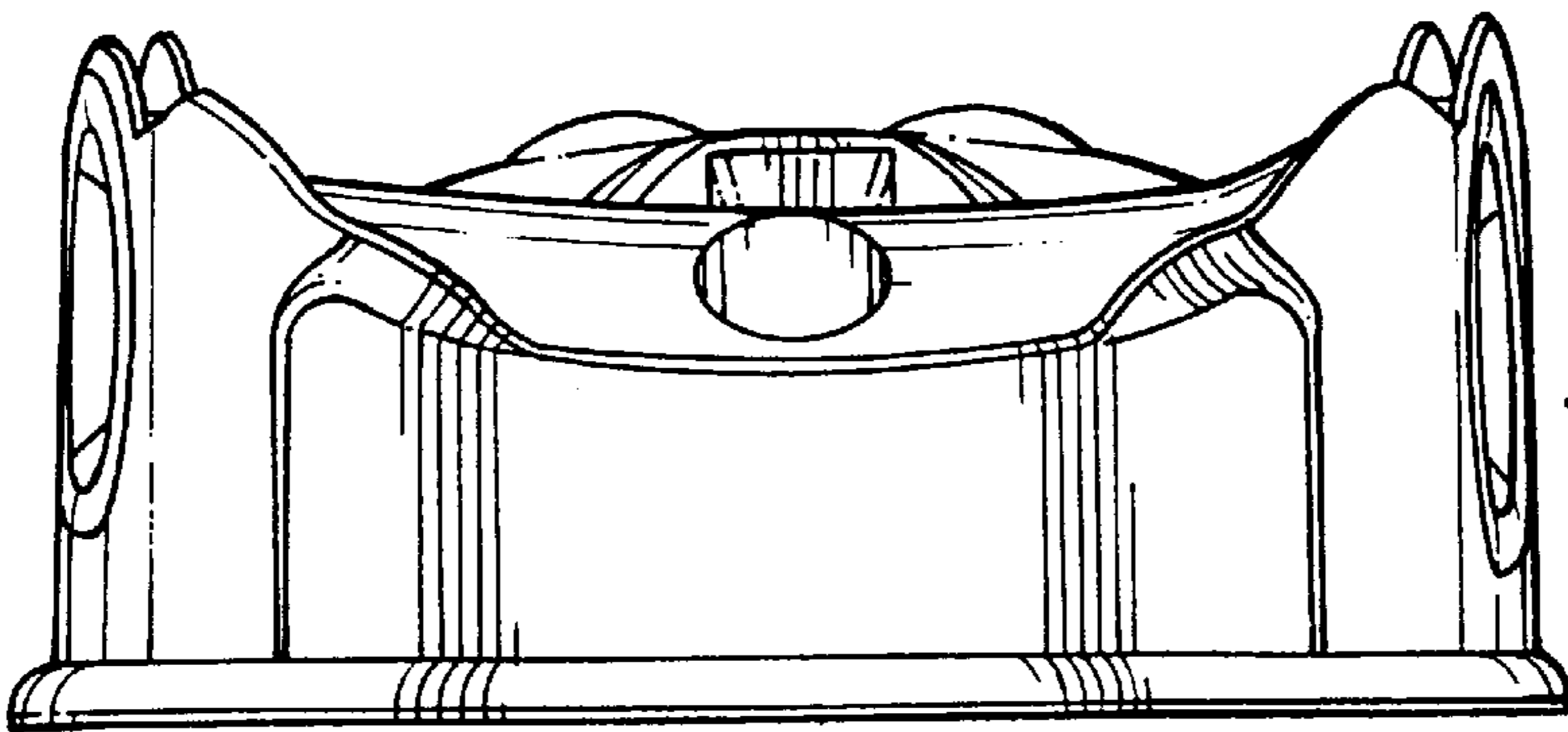

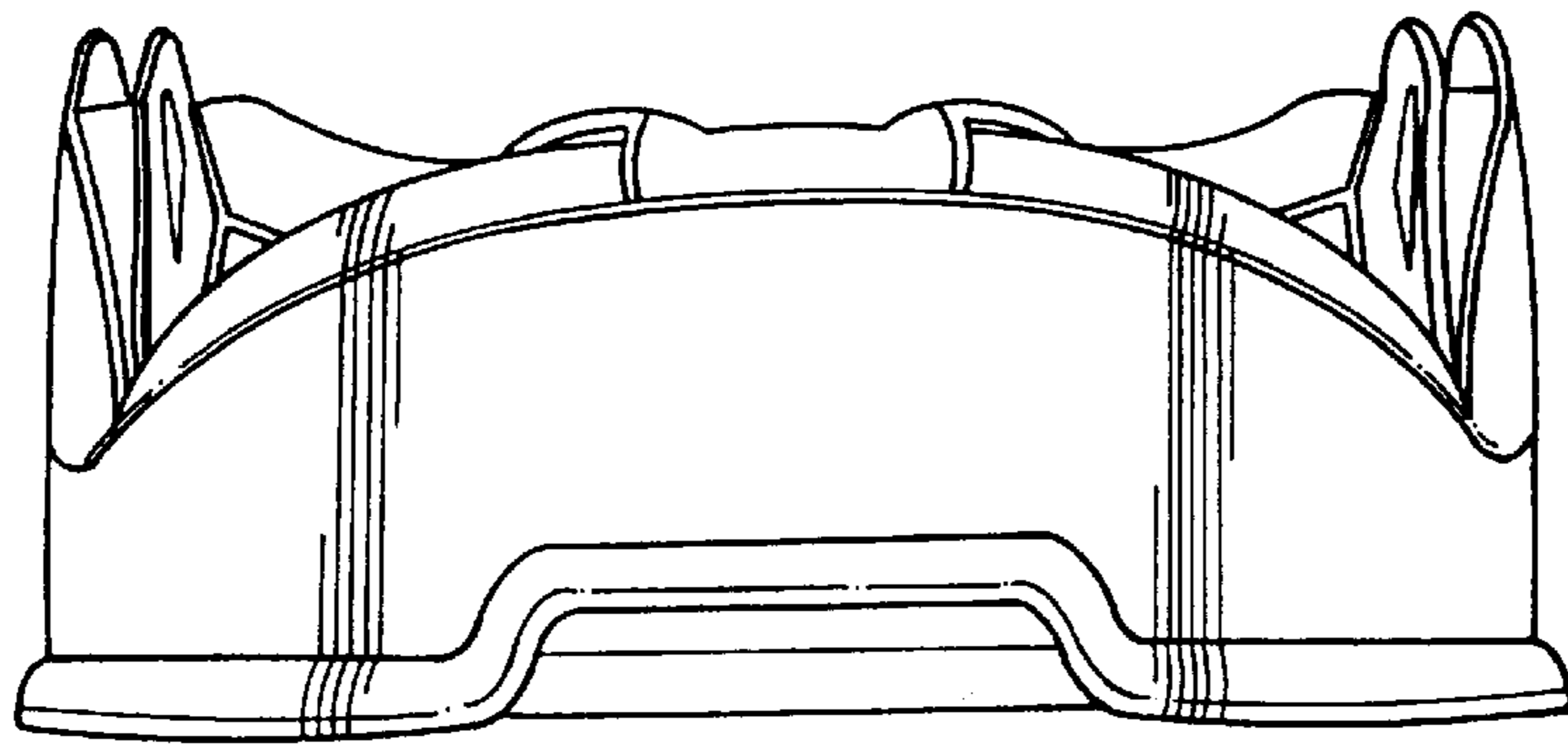

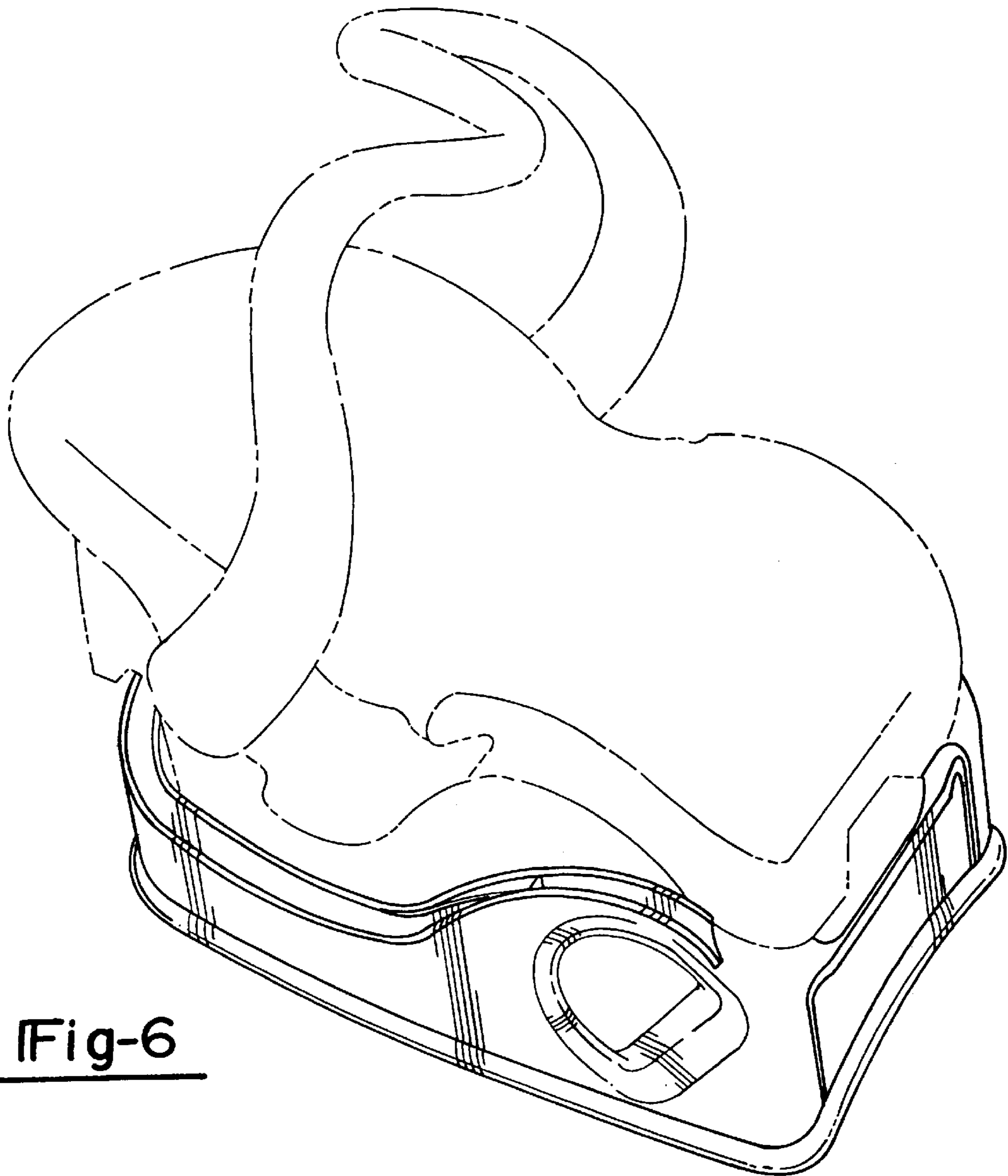
