The ornamental design for a sofa frame, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sofa frame comprising the new design;

FIG. 2 is a left view identical to mirror image of right side view thereof;

FIG. 3 is a back view thereof;


FIG. 4 is a front view thereof;












