DESCRIPTION

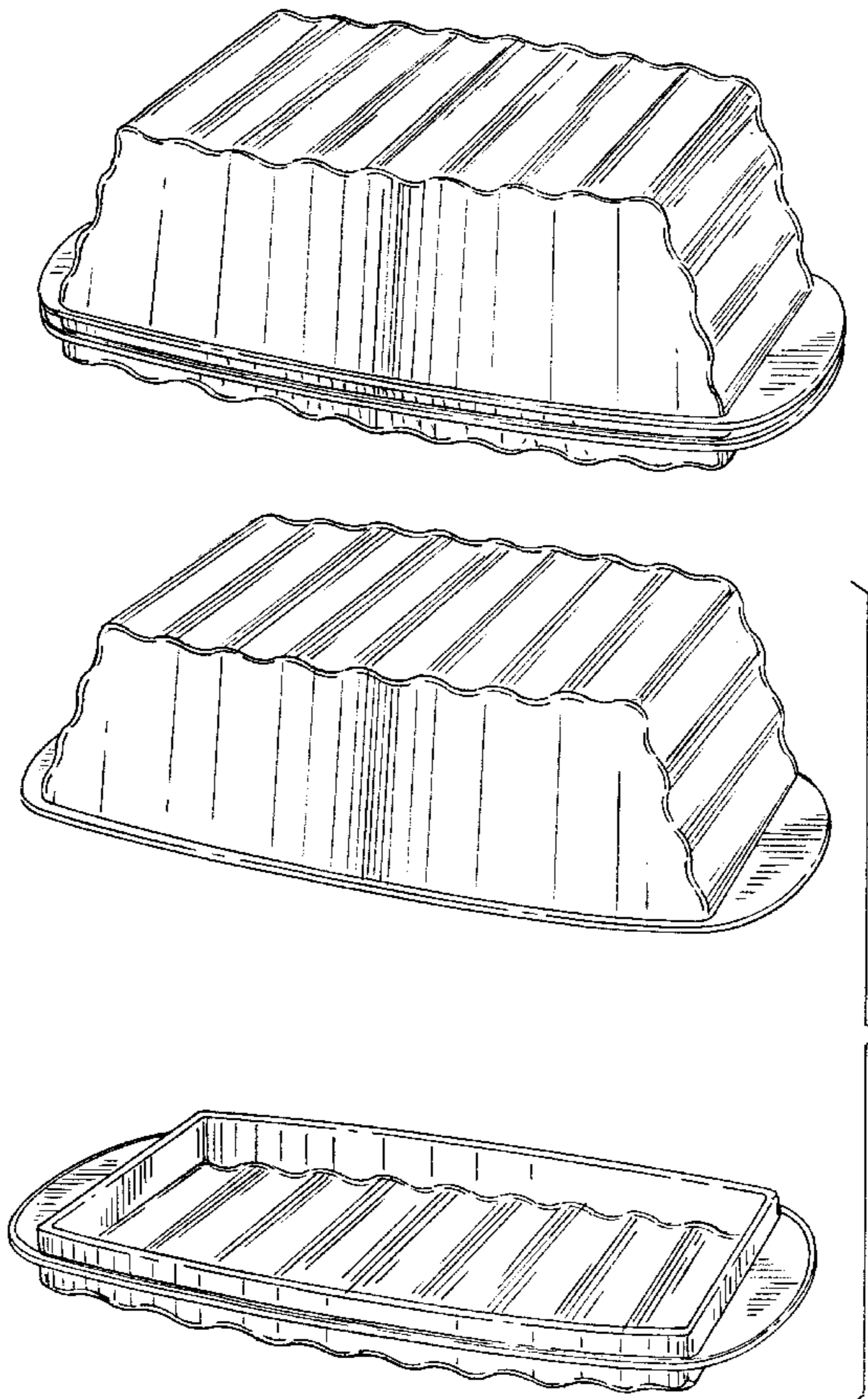
FIG. 1 is a top and front perspective view of the bread server showing our new design;

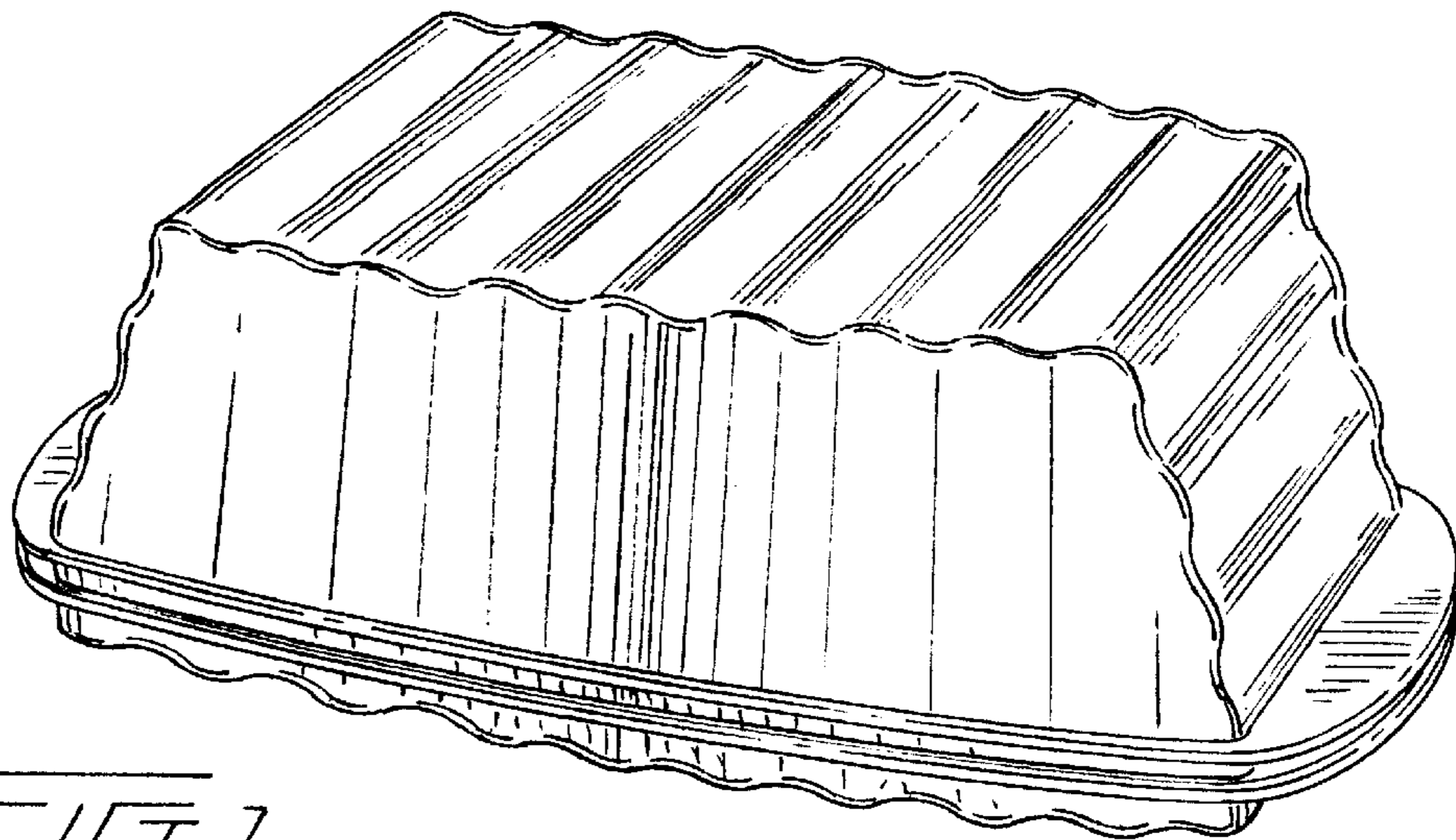

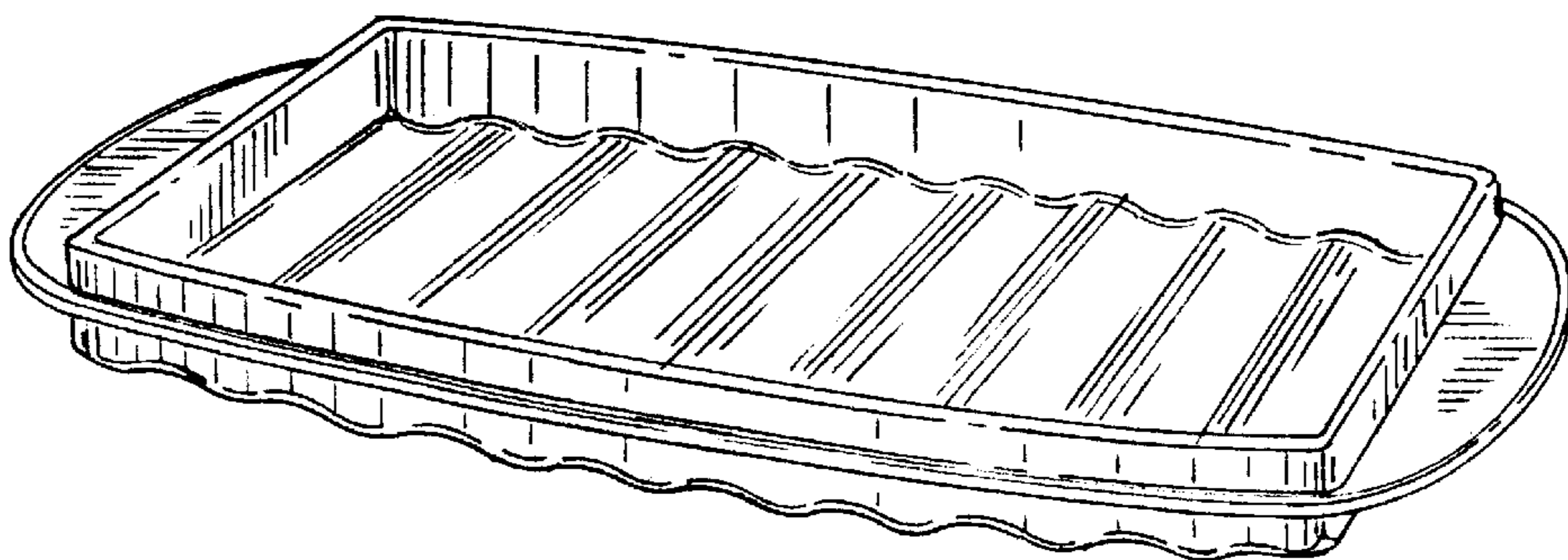
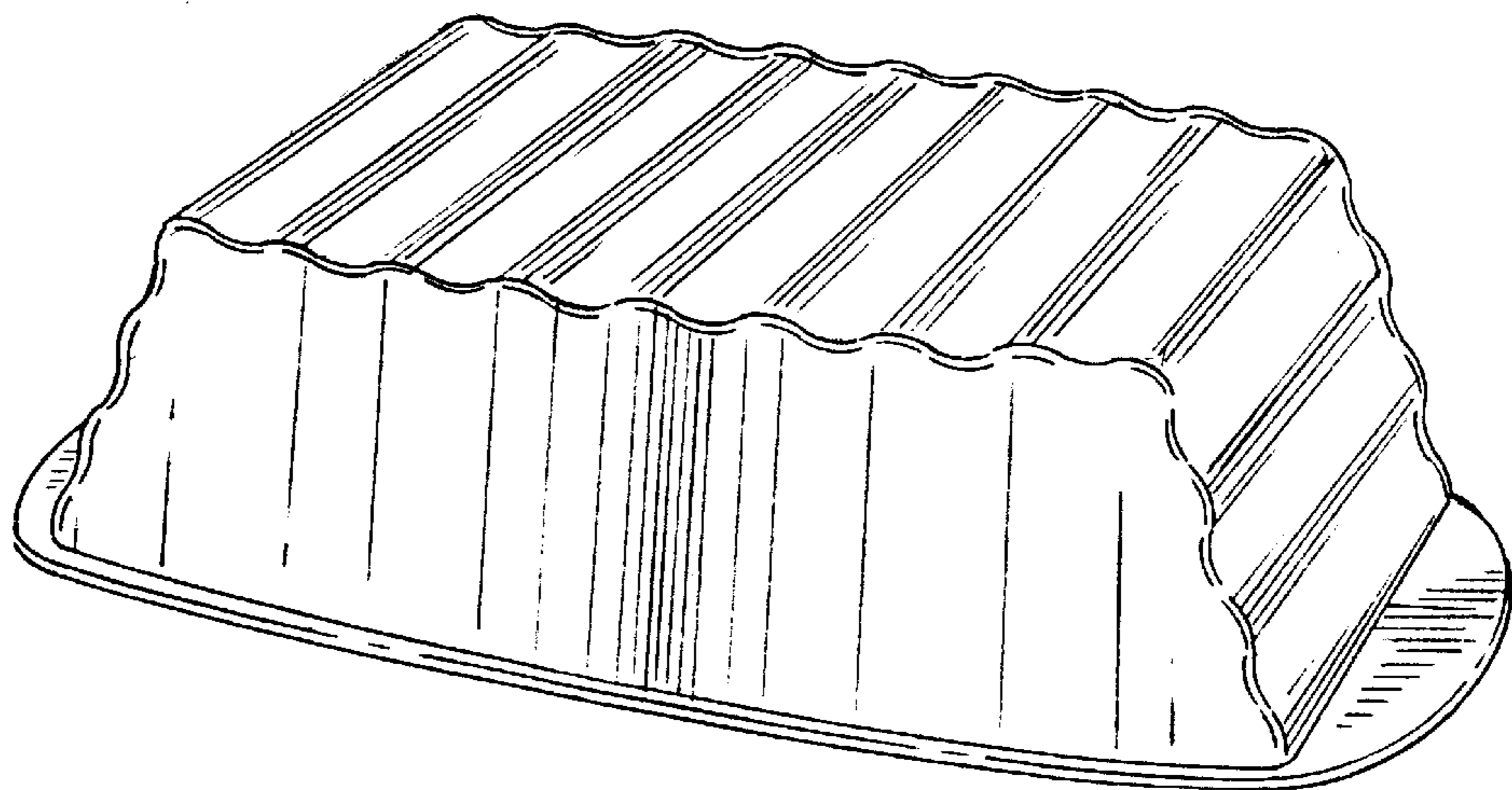

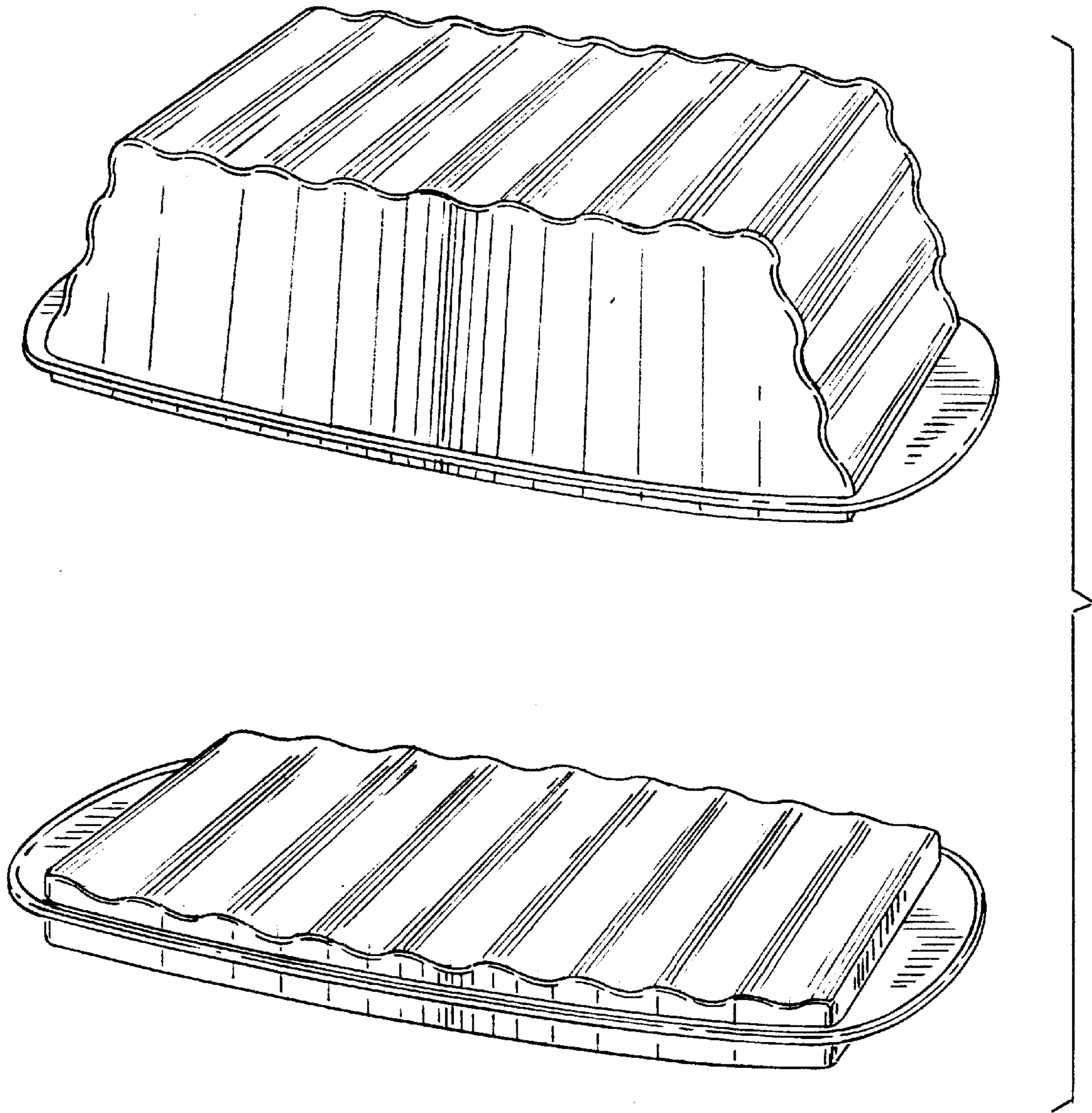

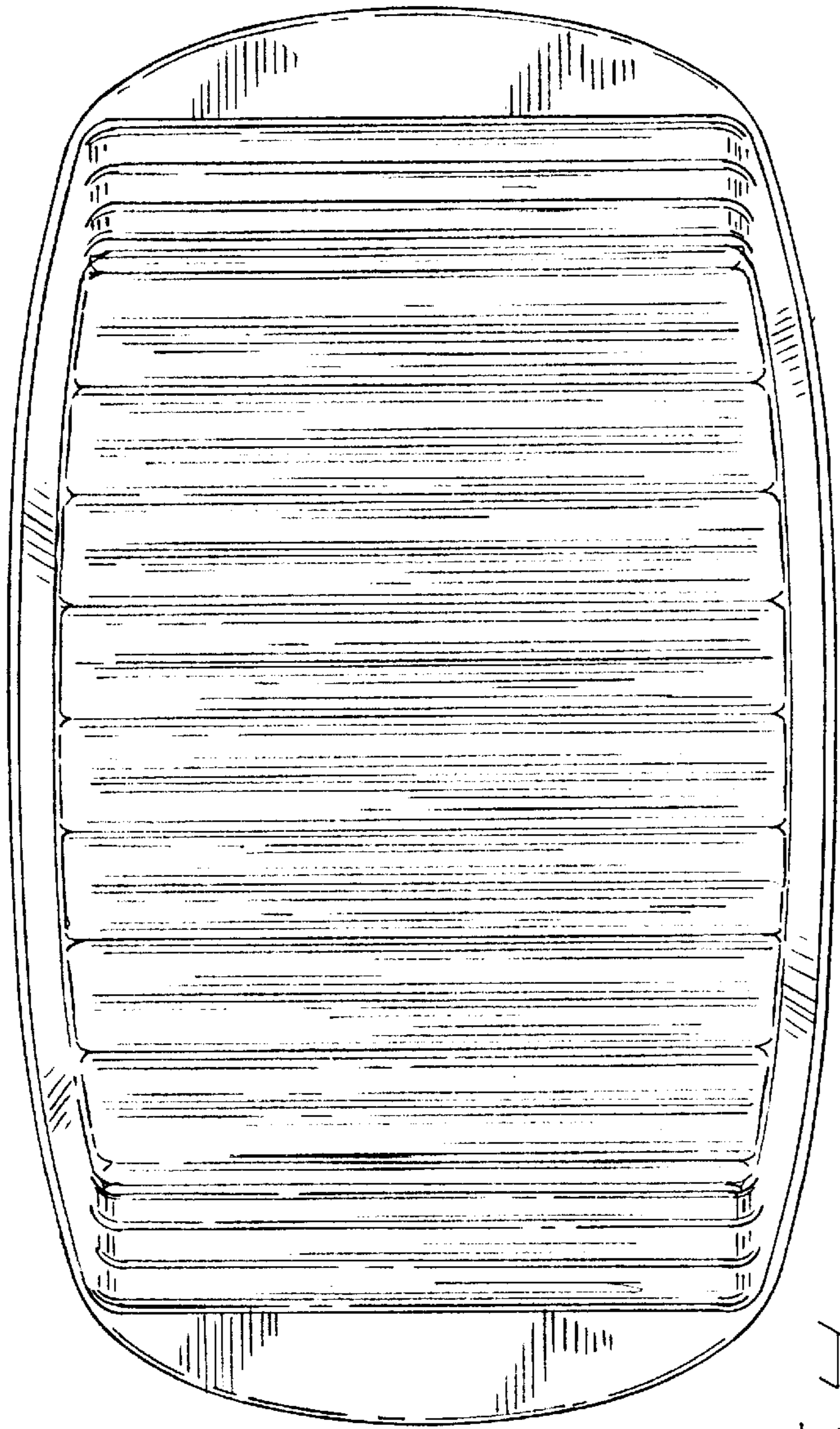

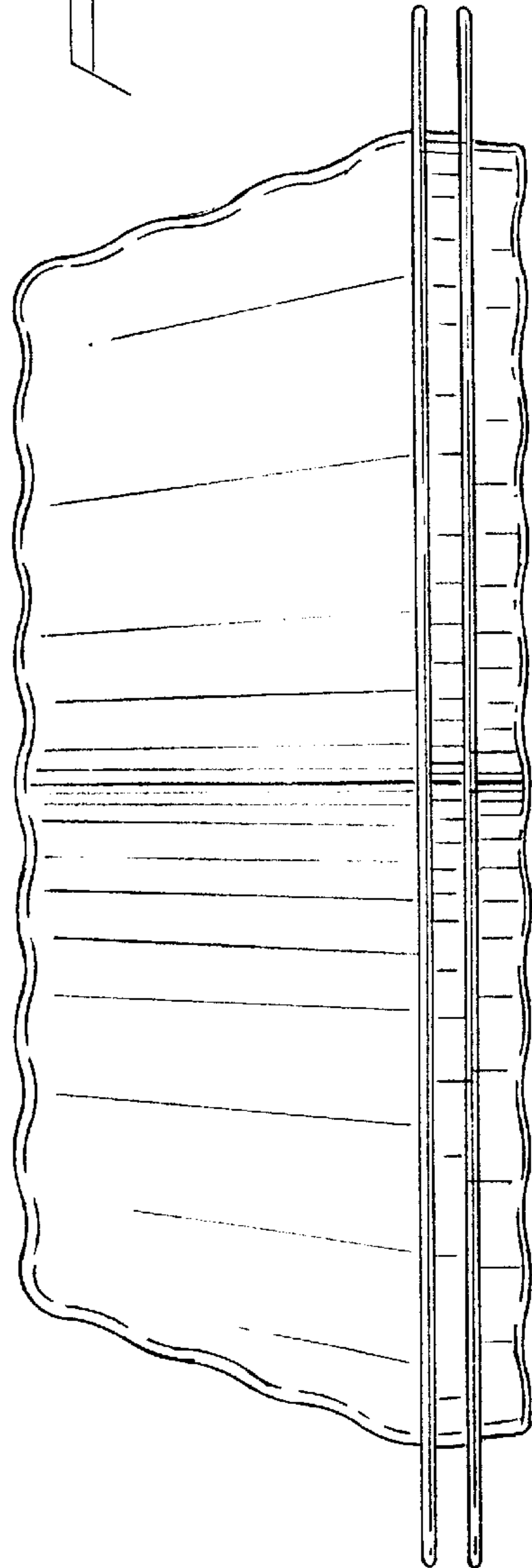

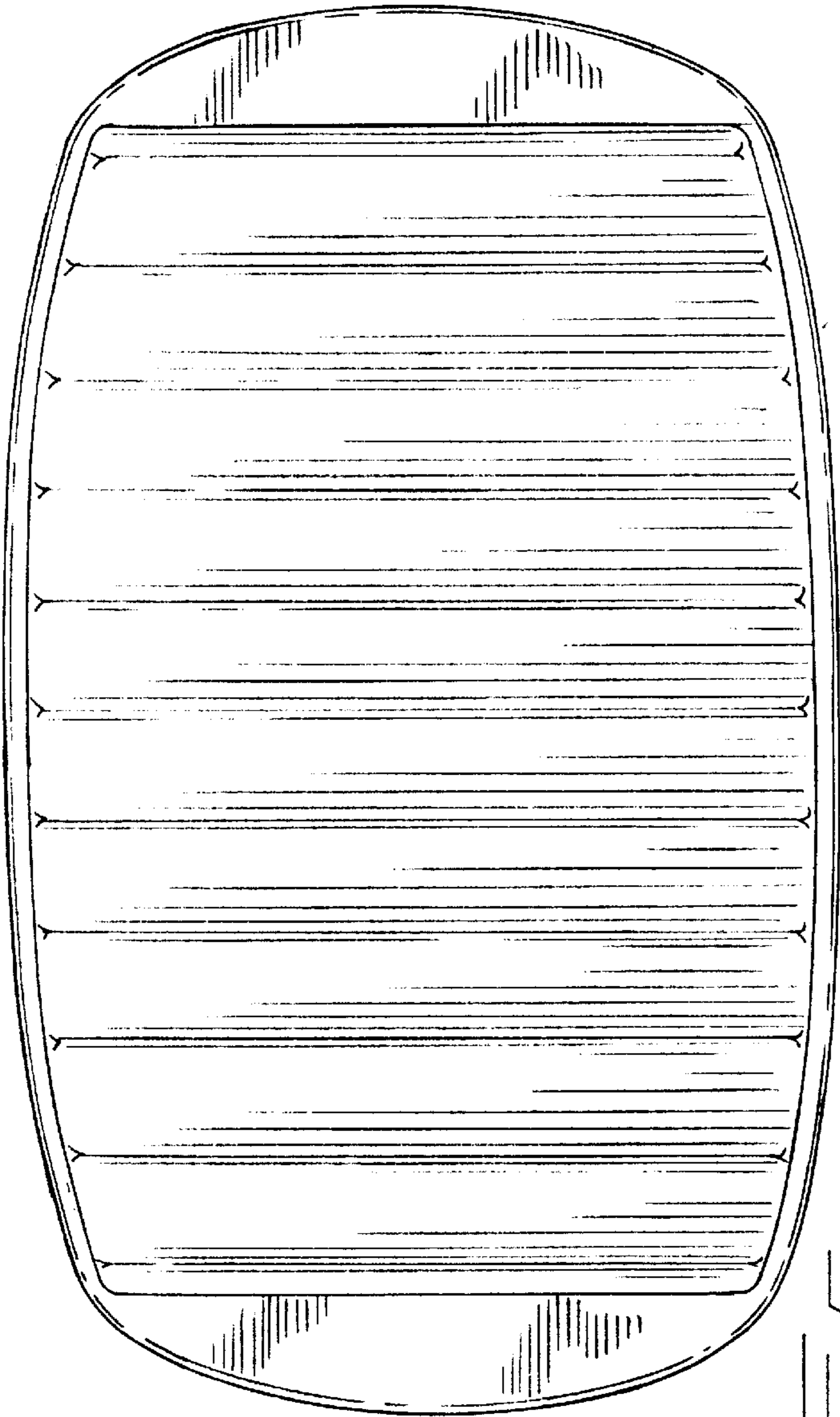

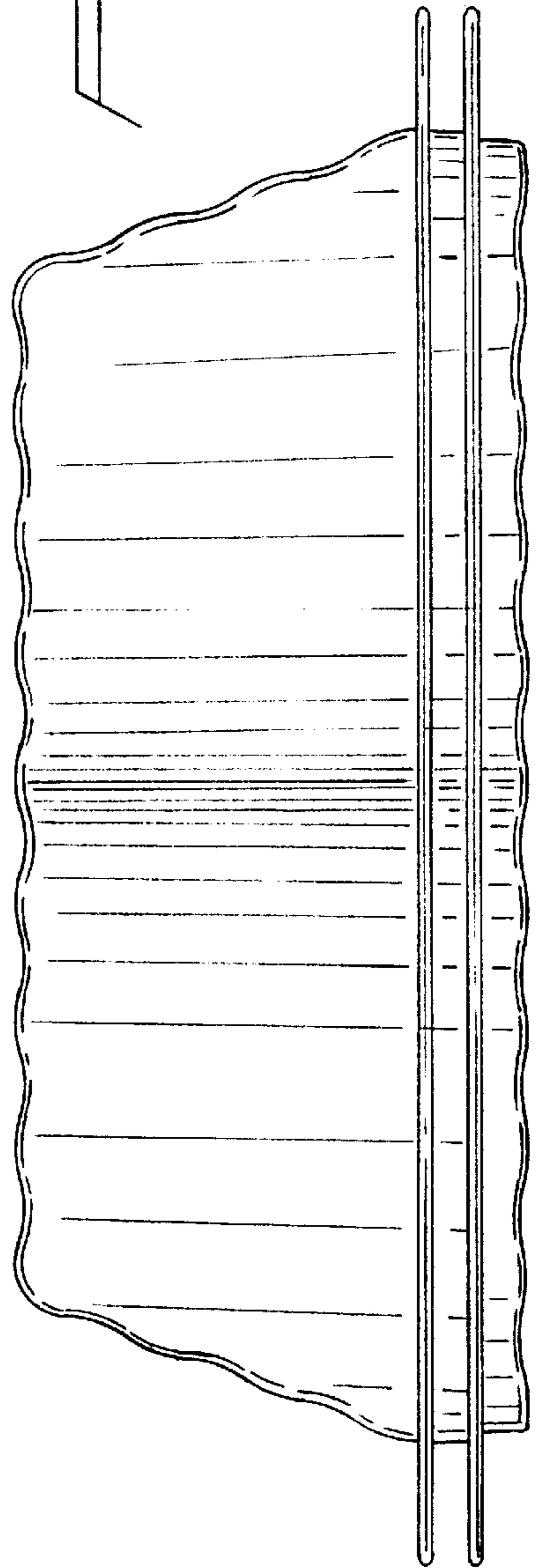

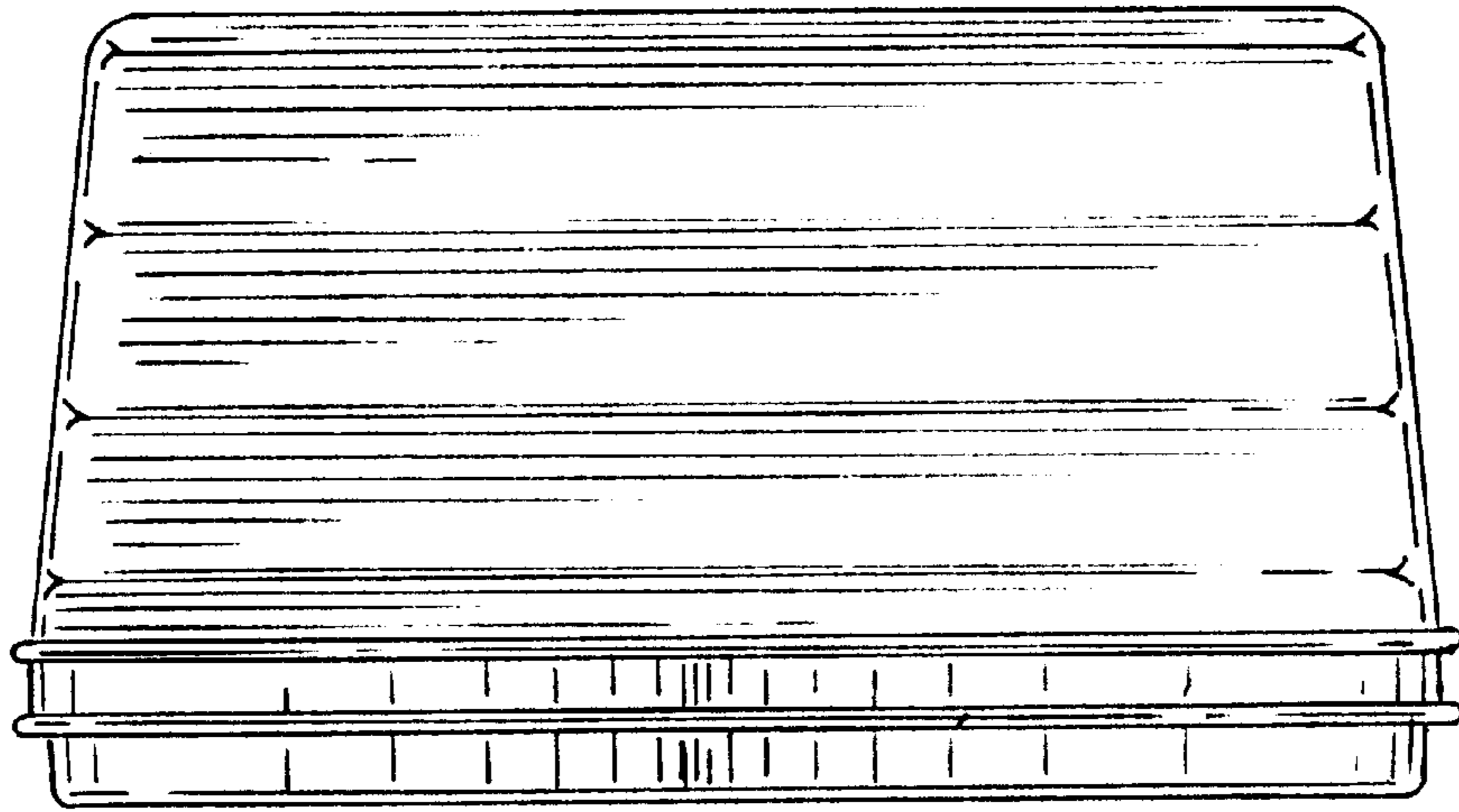

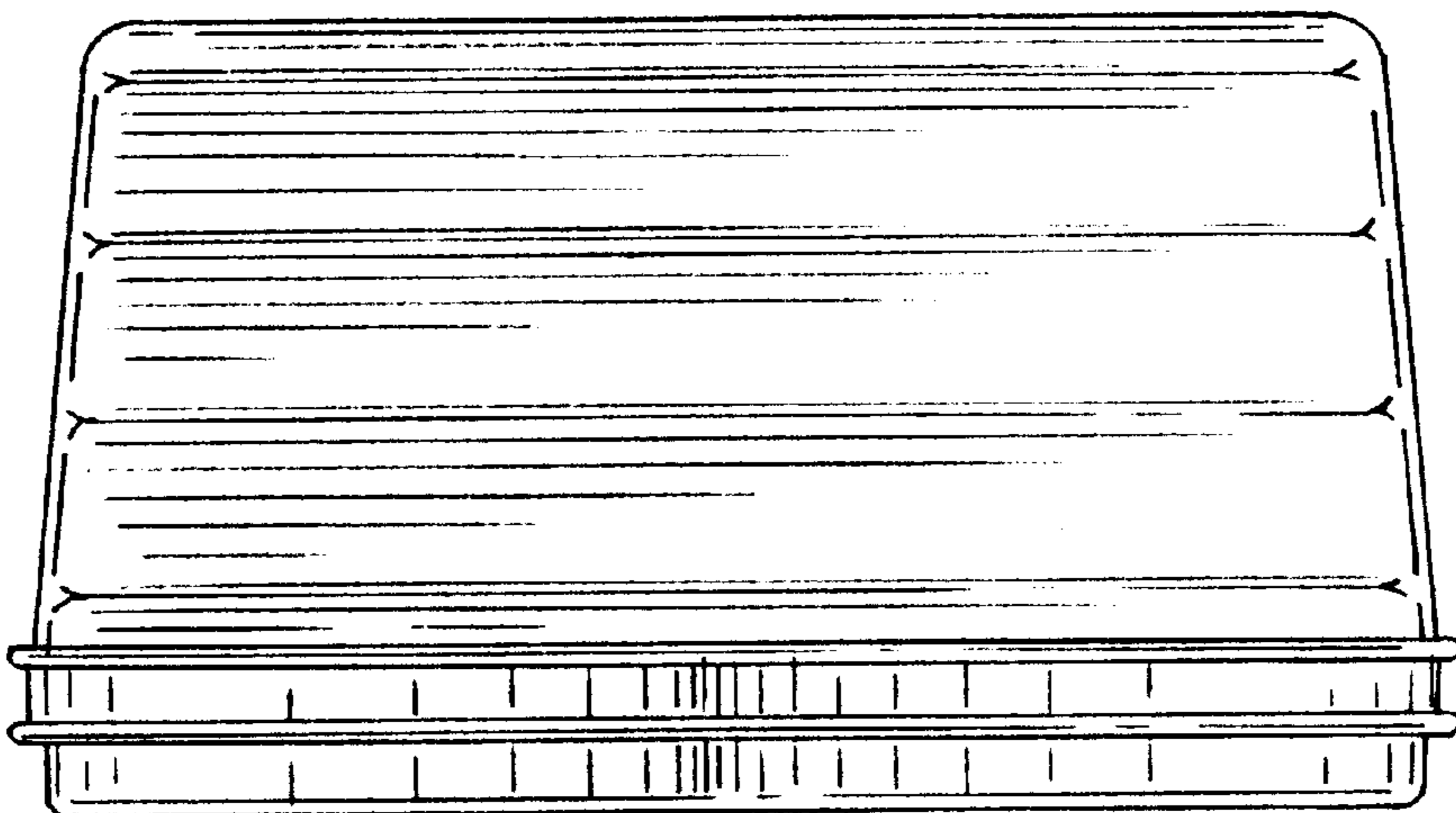
