[57] **CLAIM**

I claim the ornamental design for a beverage container holder, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a beverage container holder;

FIG. 2 is a front view of the beverage container holder shown in FIG. 1;

FIG. 3 is a rear view of the beverage container holder shown in FIG. 1;

FIG. 4 is a right side view of the beverage container holder shown in FIG. 1;

FIG. 5 is a left side view of the beverage container holder shown in FIG. 1;

FIG. 6 is a top view of the beverage container holder shown in FIG. 1;

FIG. 7 is a bottom view of the beverage container holder shown in FIG. 1;

FIG. 8 is an isometric view of a second embodiment of a beverage container holder;

FIG. 9 is a front view of the beverage container holder shown in FIG. 8;

FIG. 10 is a rear view of the beverage container holder shown in FIG. 8;

FIG. 11 is a right side view of the beverage container holder shown in FIG. 8;

FIG. 12 is a left side view of the beverage container holder shown in FIG. 8;

FIG. 13 is a top view of the beverage container holder shown in FIG. 8;

FIG. 14 is a bottom view of the beverage container holder shown in FIG. 8;

FIG. 15 is an isometric view of a third embodiment of a beverage container holder;

FIG. 16 is a front view of the beverage container holder shown in FIG. 15;

FIG. 17 is a rear view of the beverage container holder shown in FIG. 15;

FIG. 18 is a right side view of the beverage container holder shown in FIG. 15;

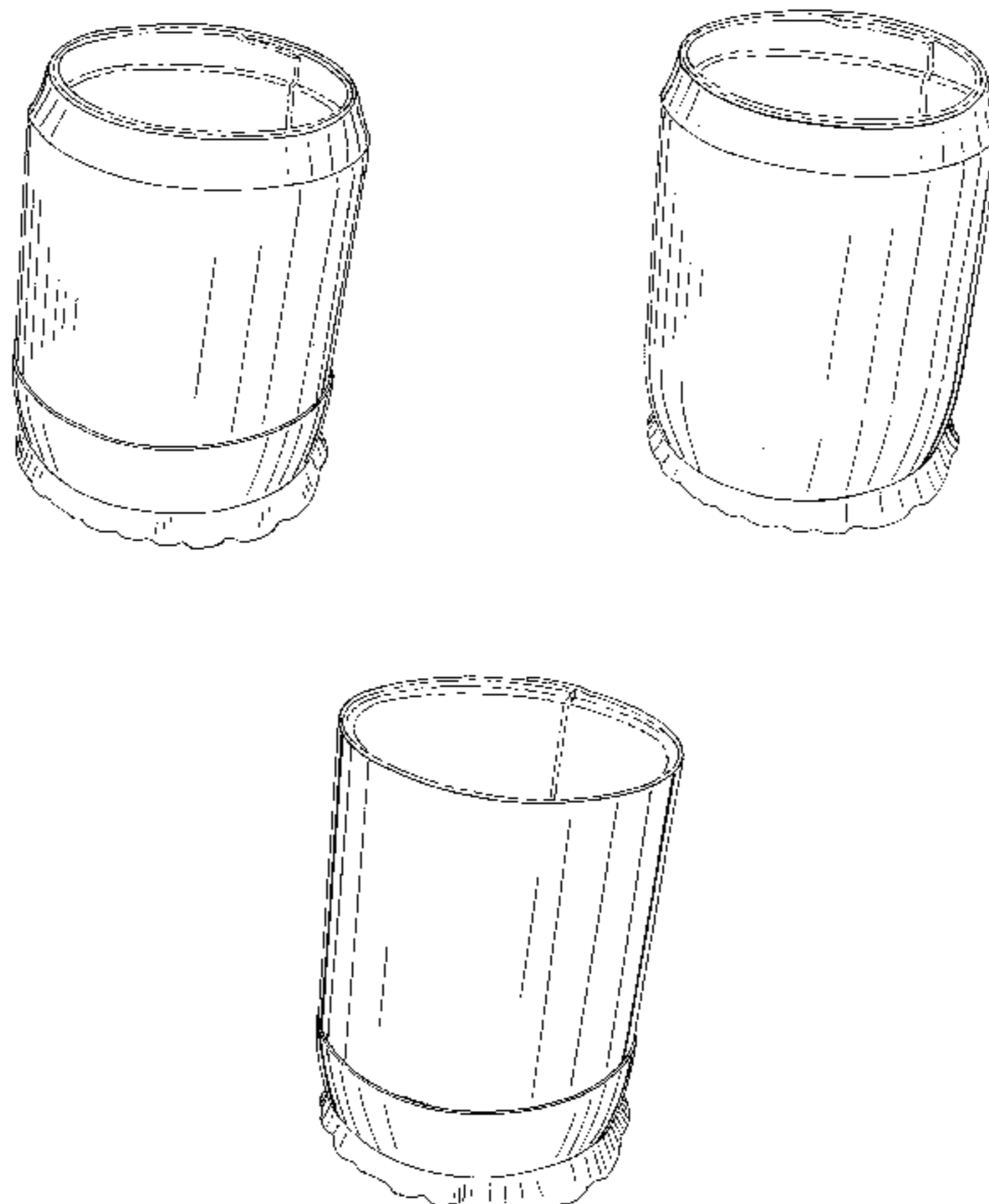
FIG. 19 is a left side view of the beverage container holder shown in FIG. 15;

FIG. 20 is a top view of the beverage container holder shown in FIG. 15;

FIG. 21 is a bottom view of the beverage container holder shown in FIG. 15; and,

FIG. 22 is a bottom view of a fourth embodiment of a beverage container holder.

The isometric, front, rear, right side, left side and top views of the fourth embodiment of the beverage container holder are identical to the corresponding FIG. 1 through FIG. 6 views.

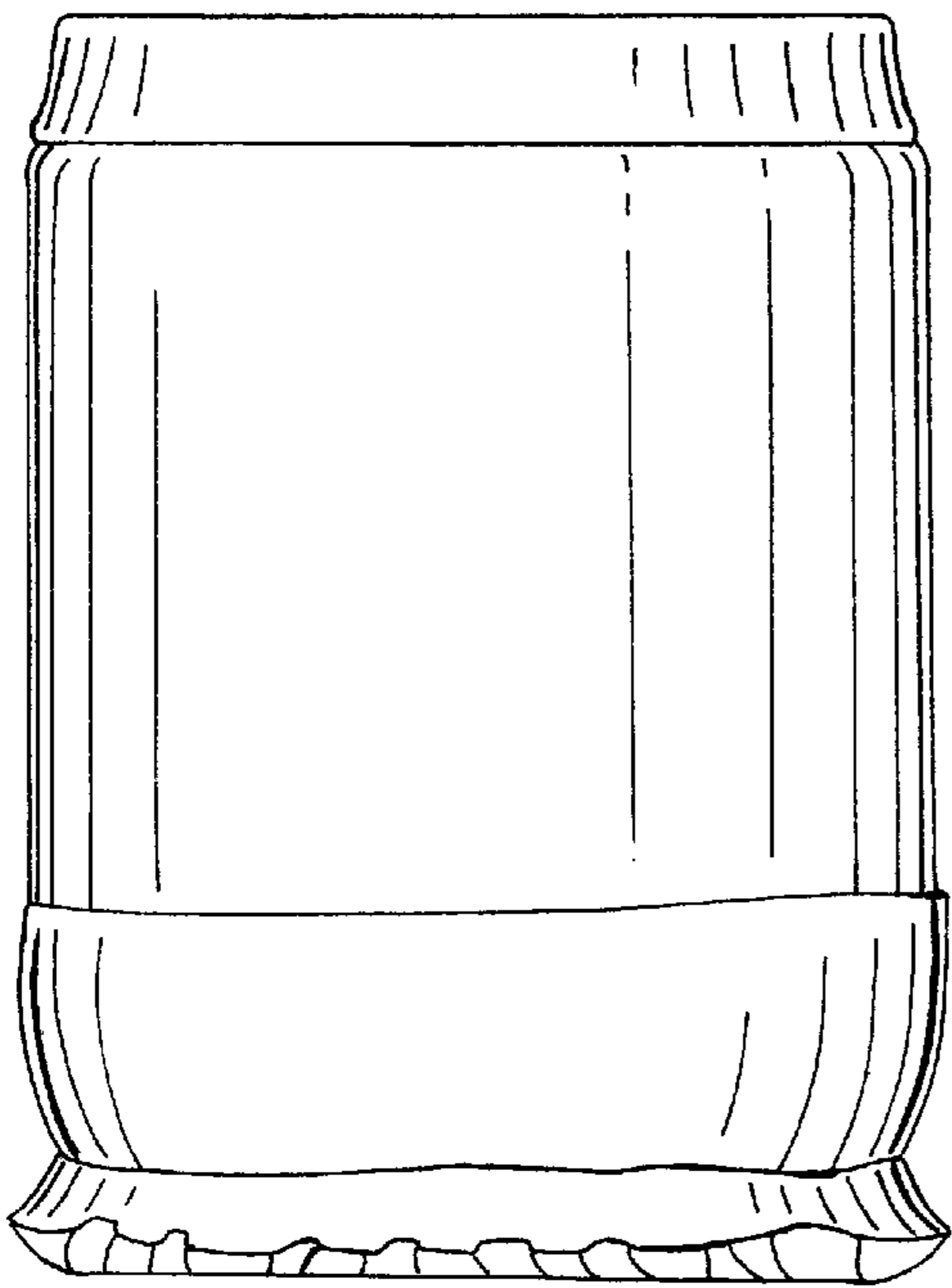
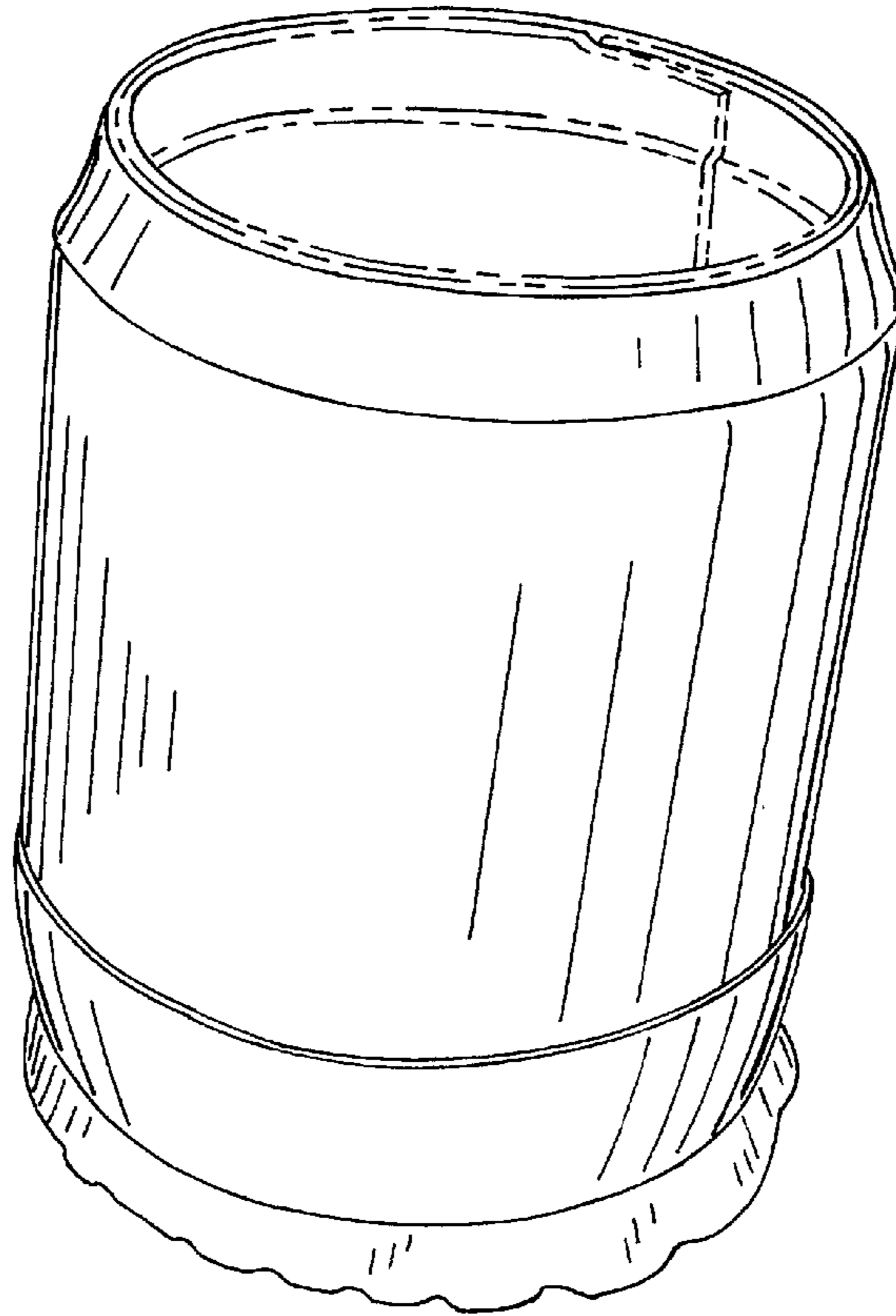

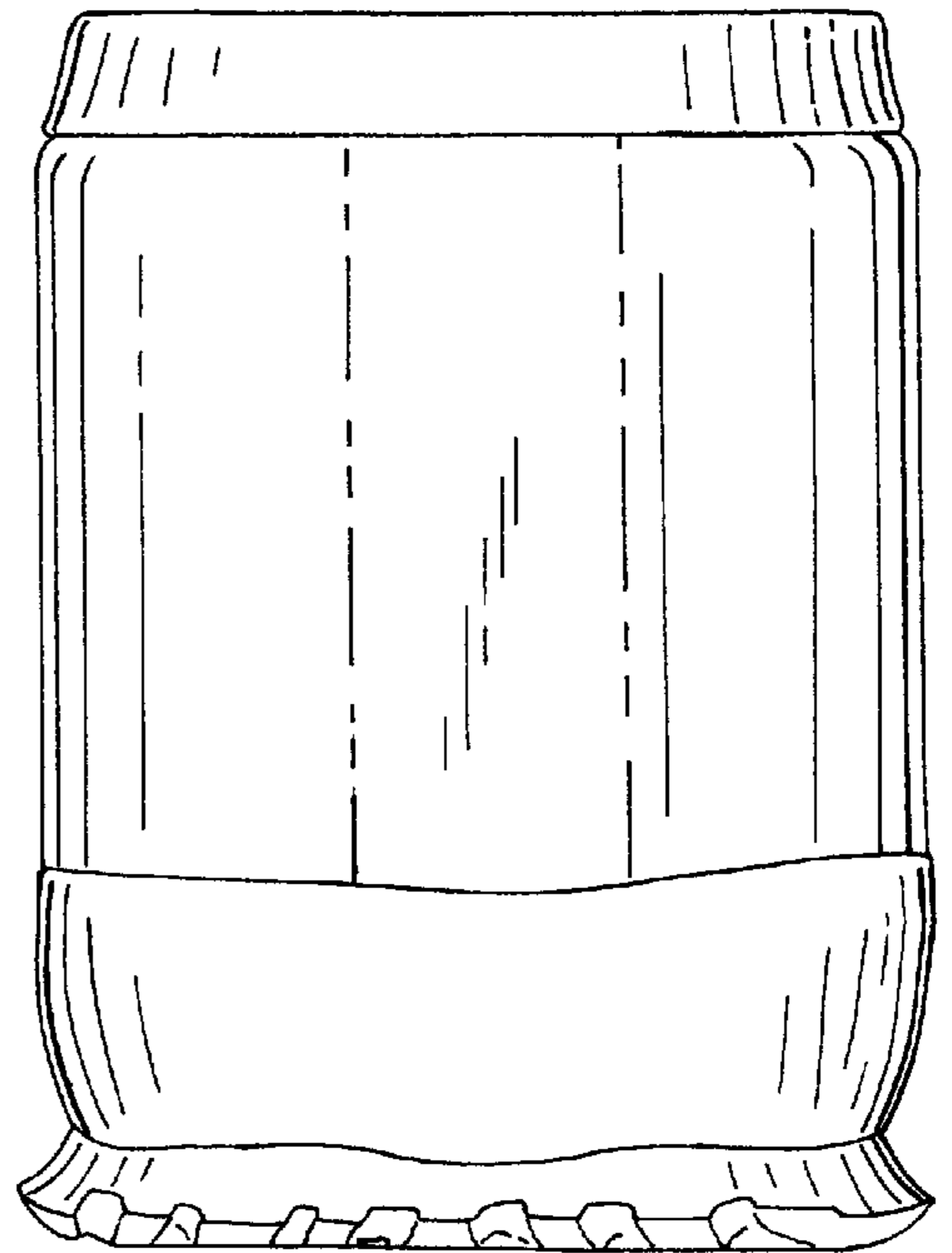

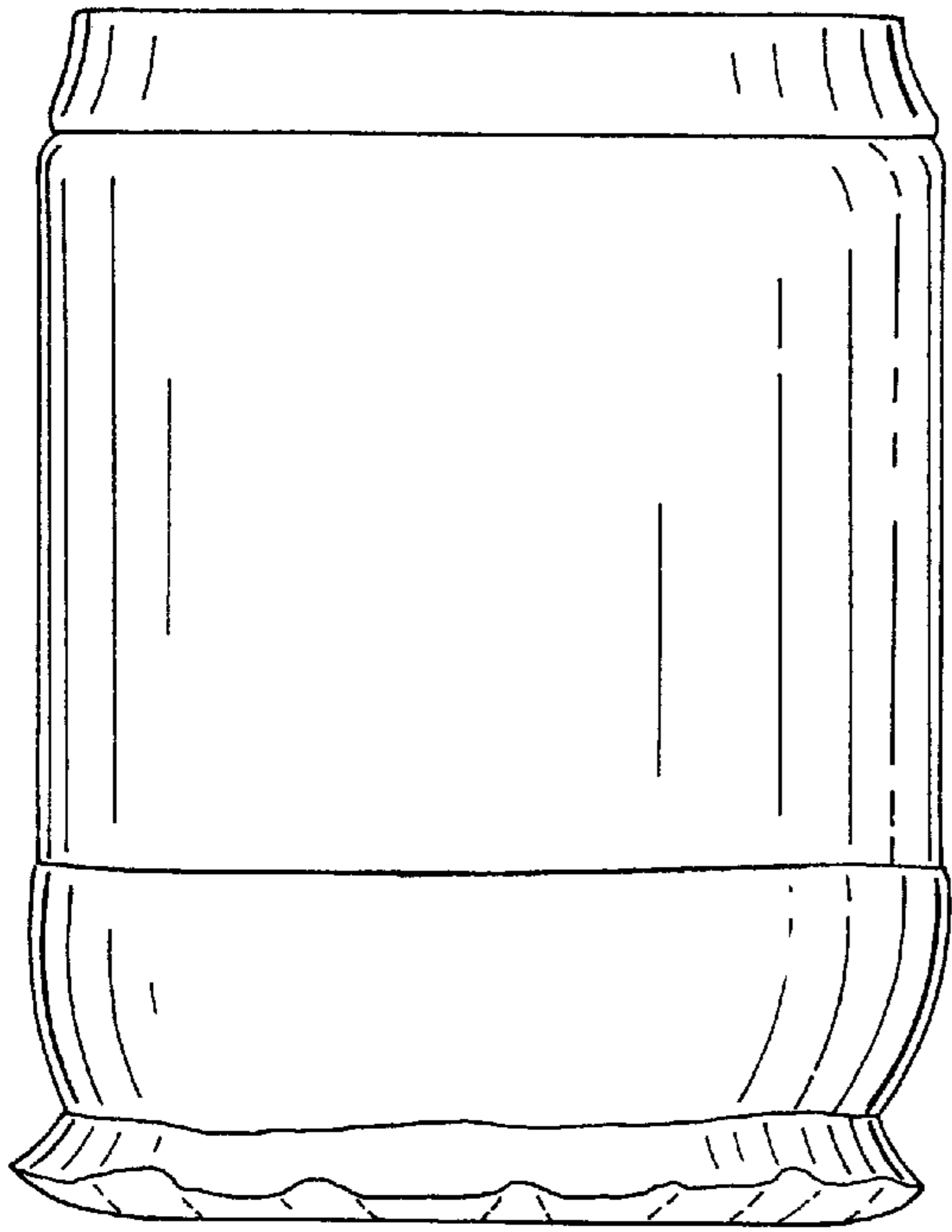

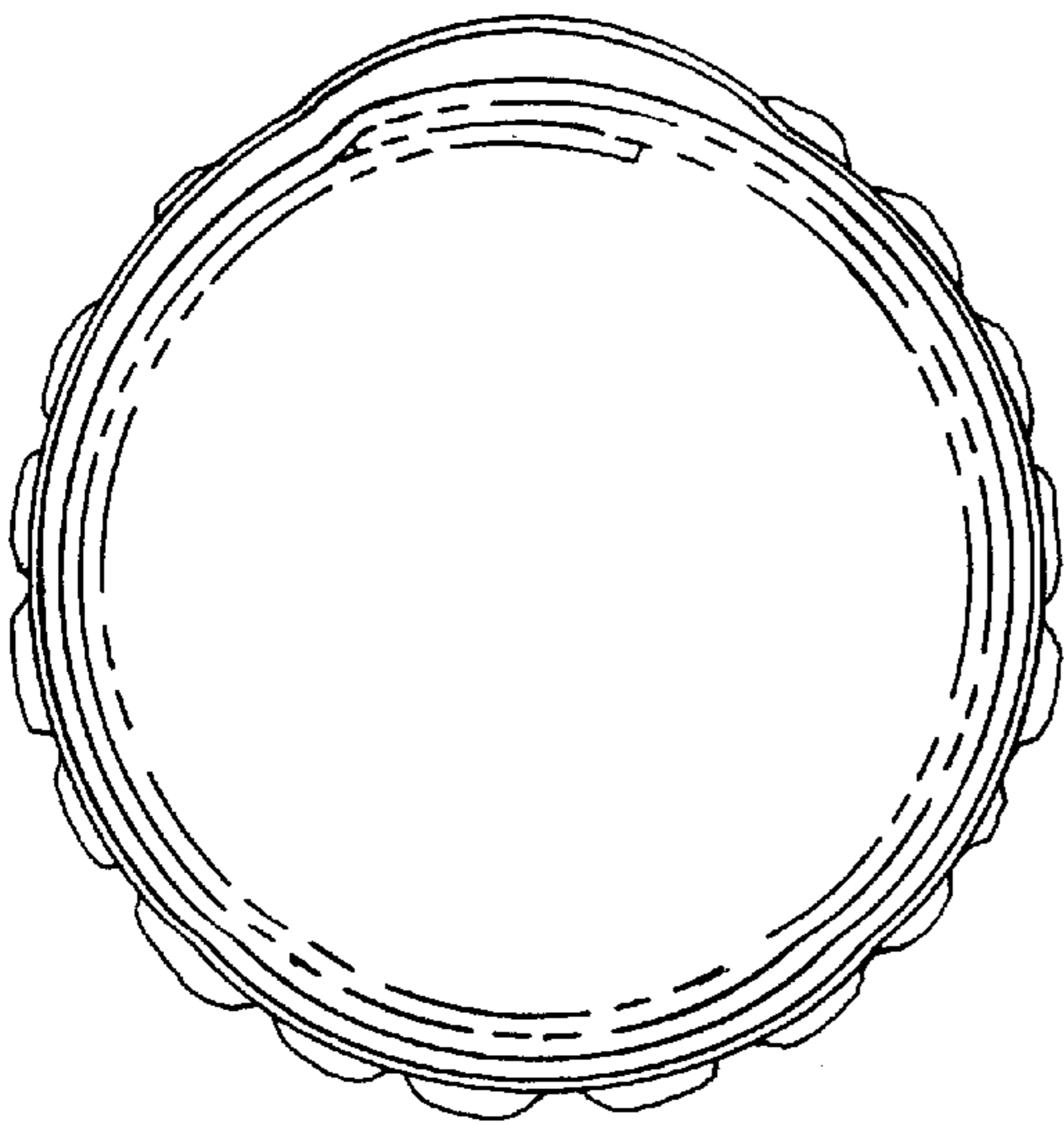
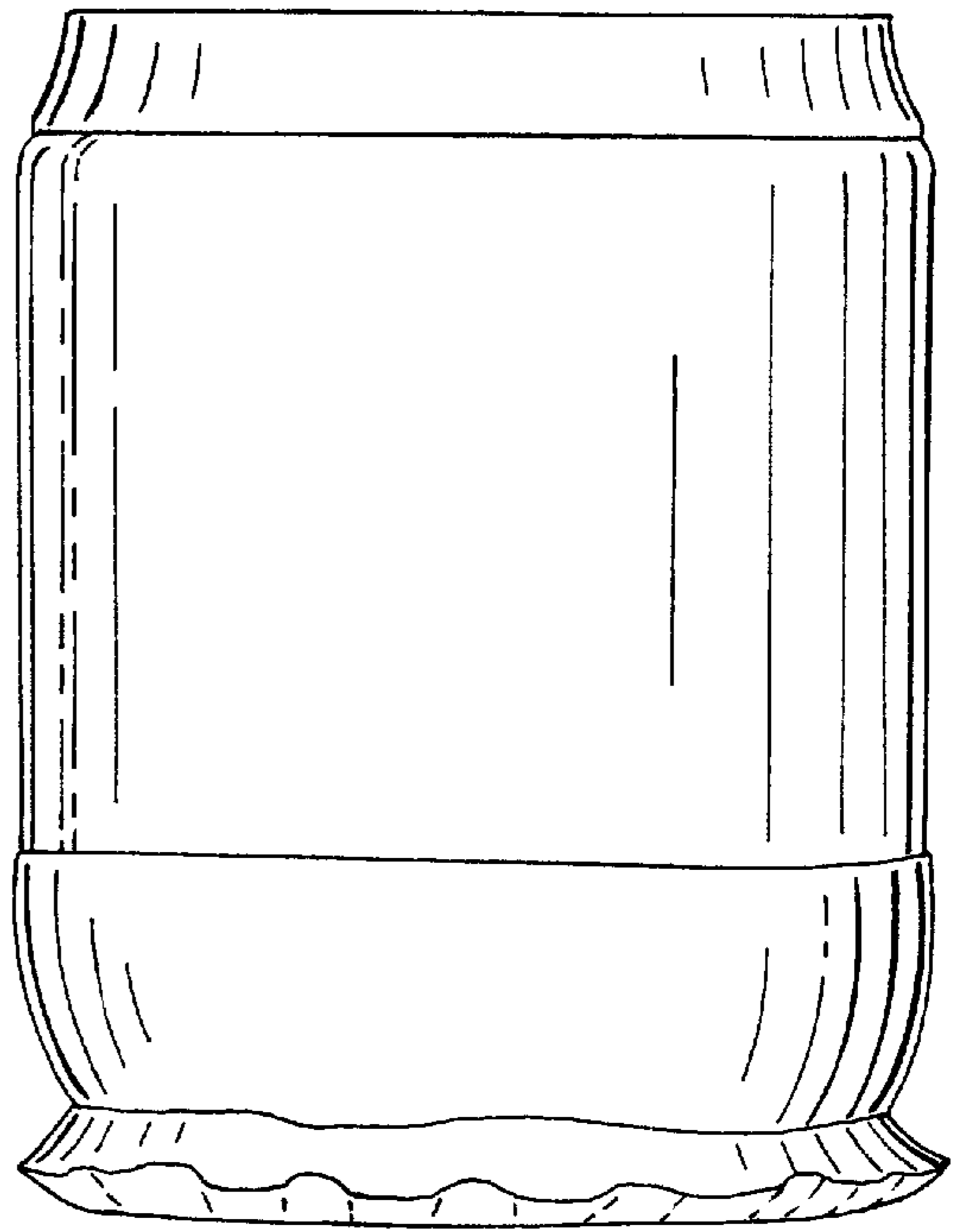

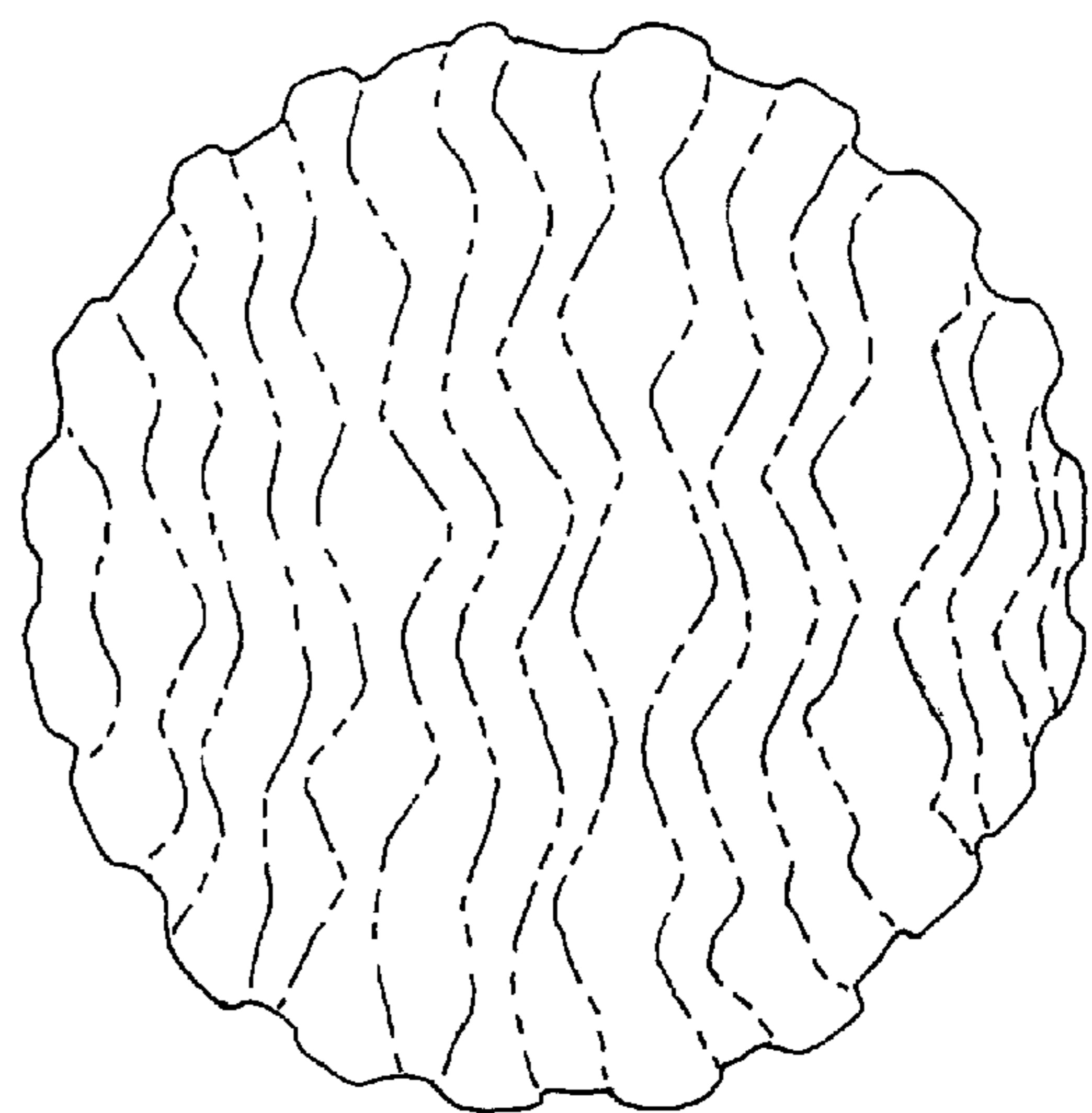

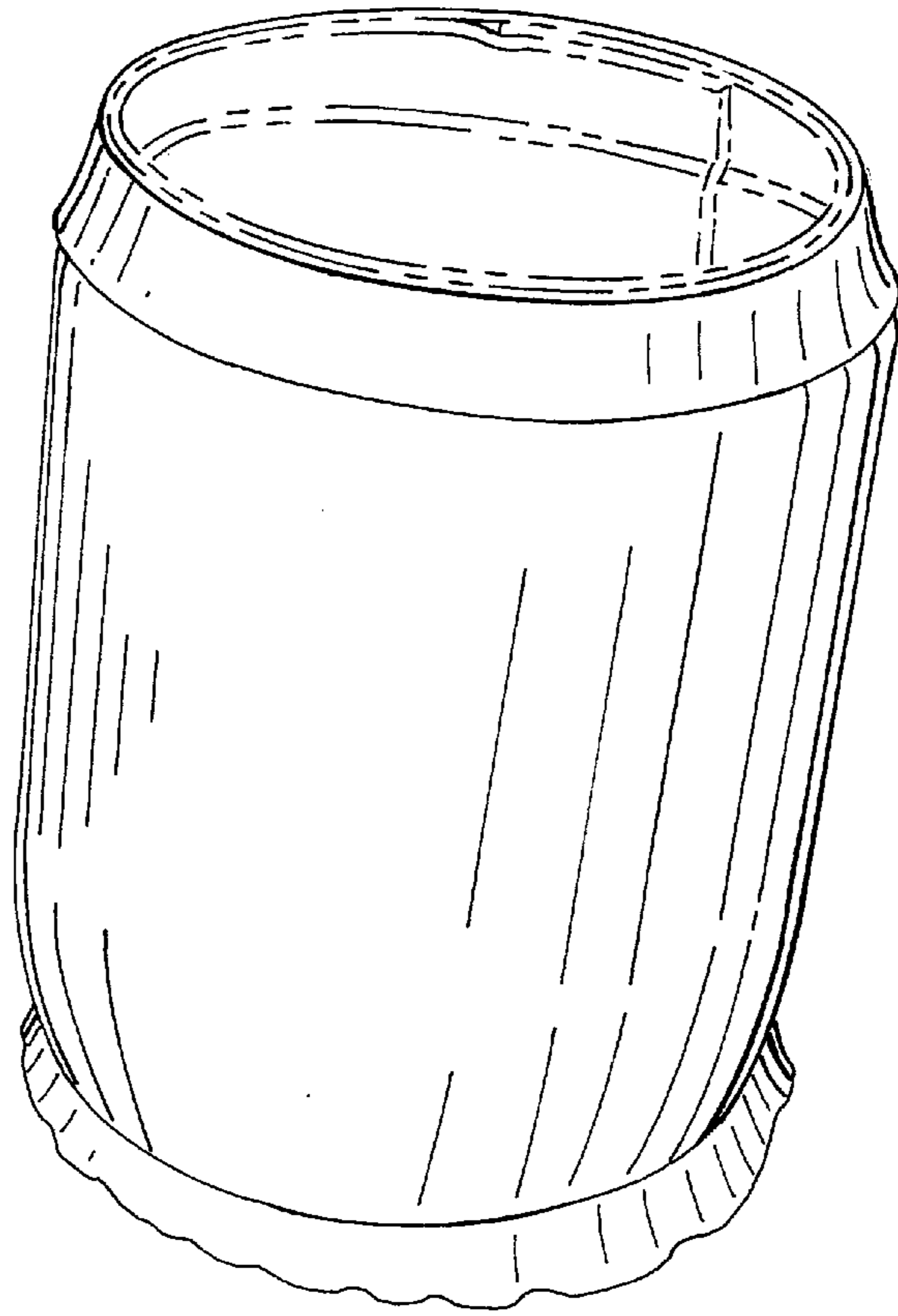

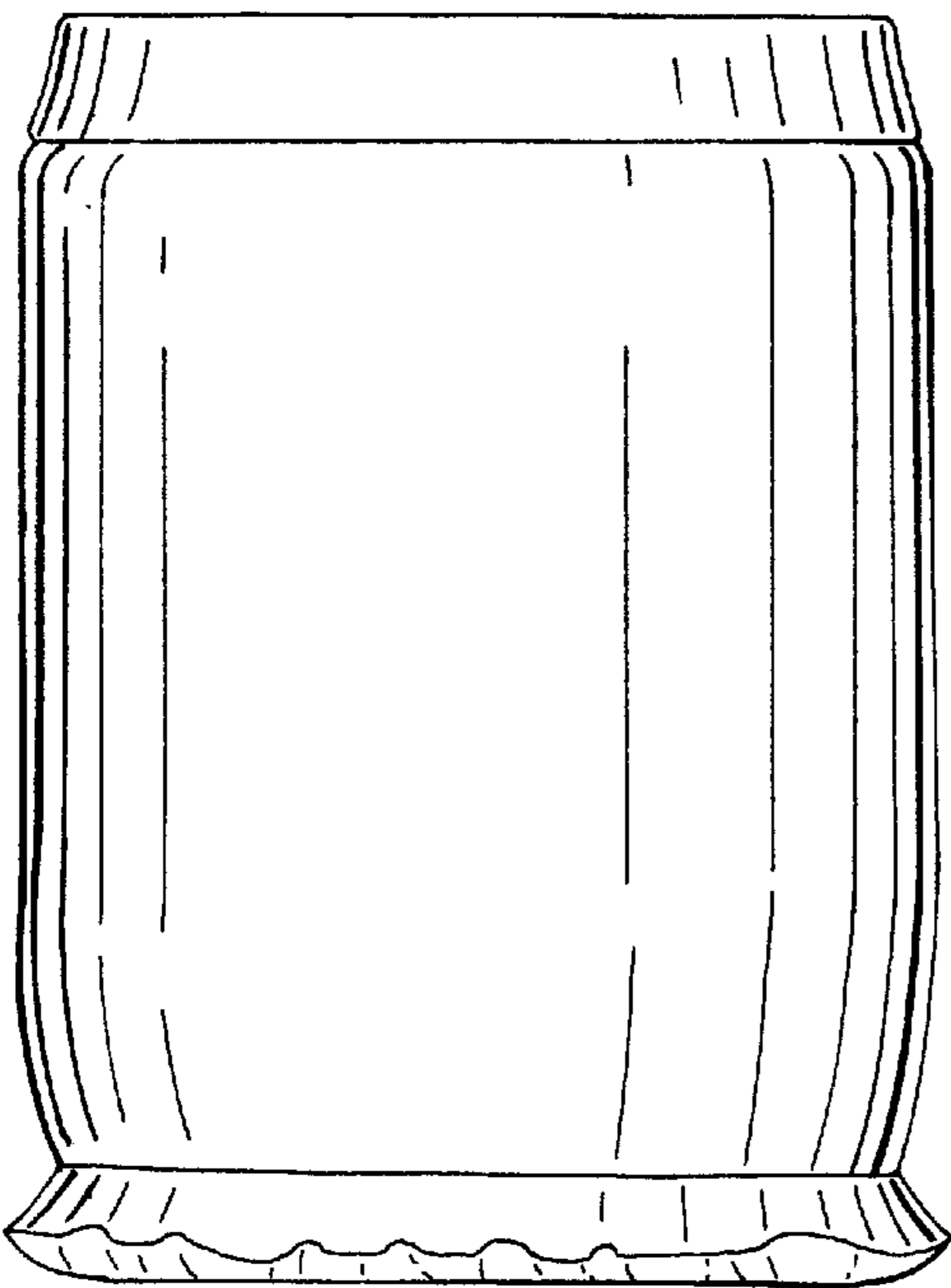

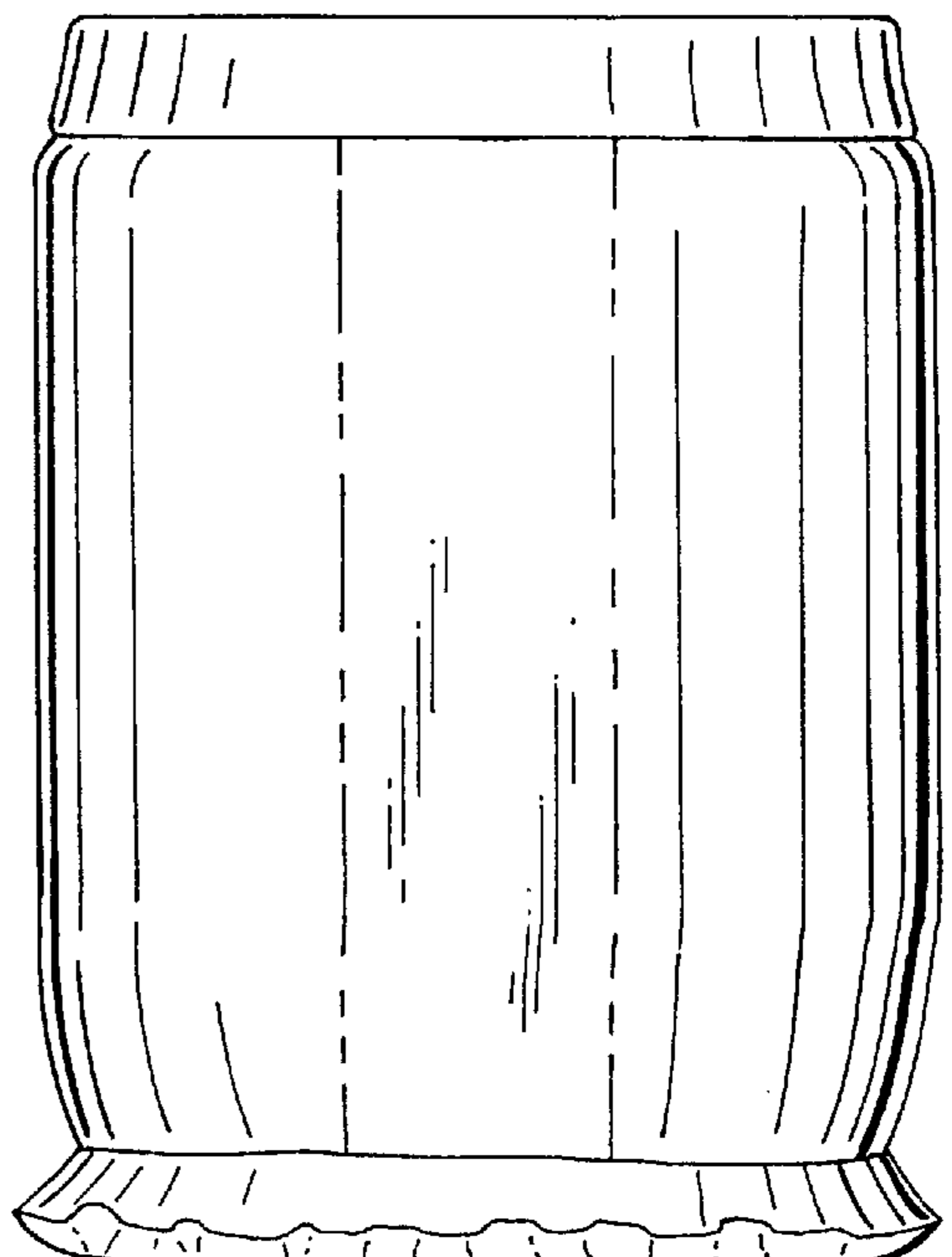

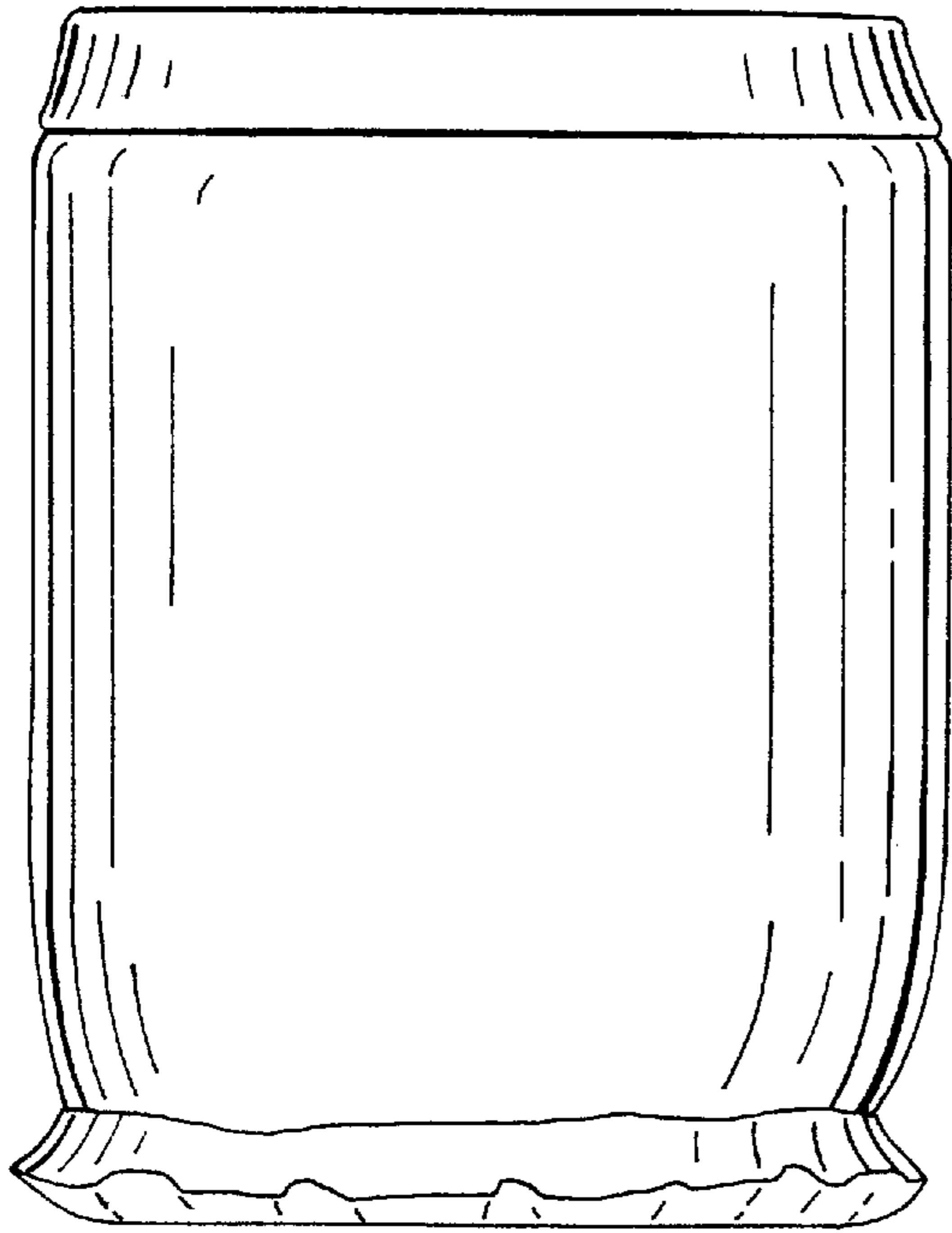

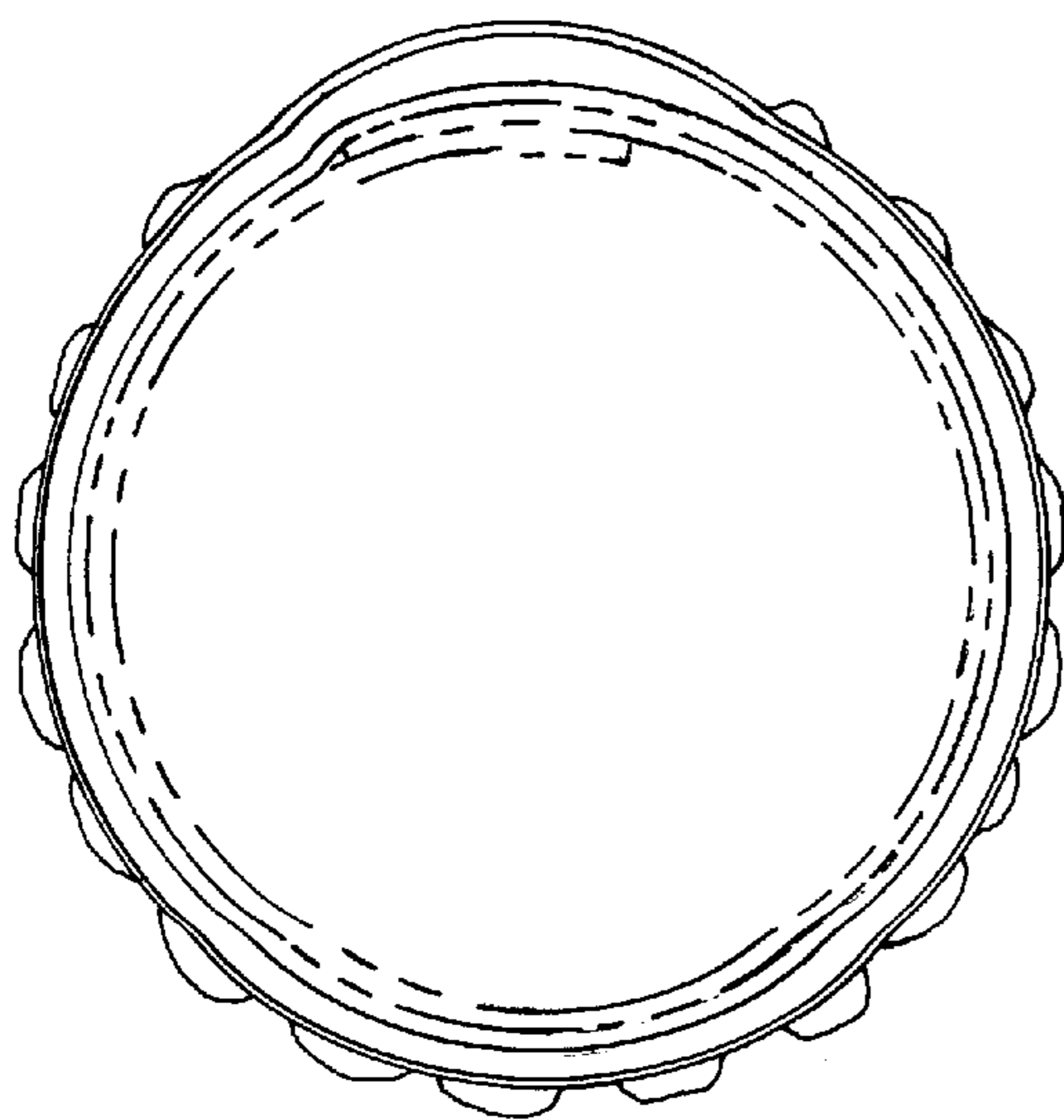
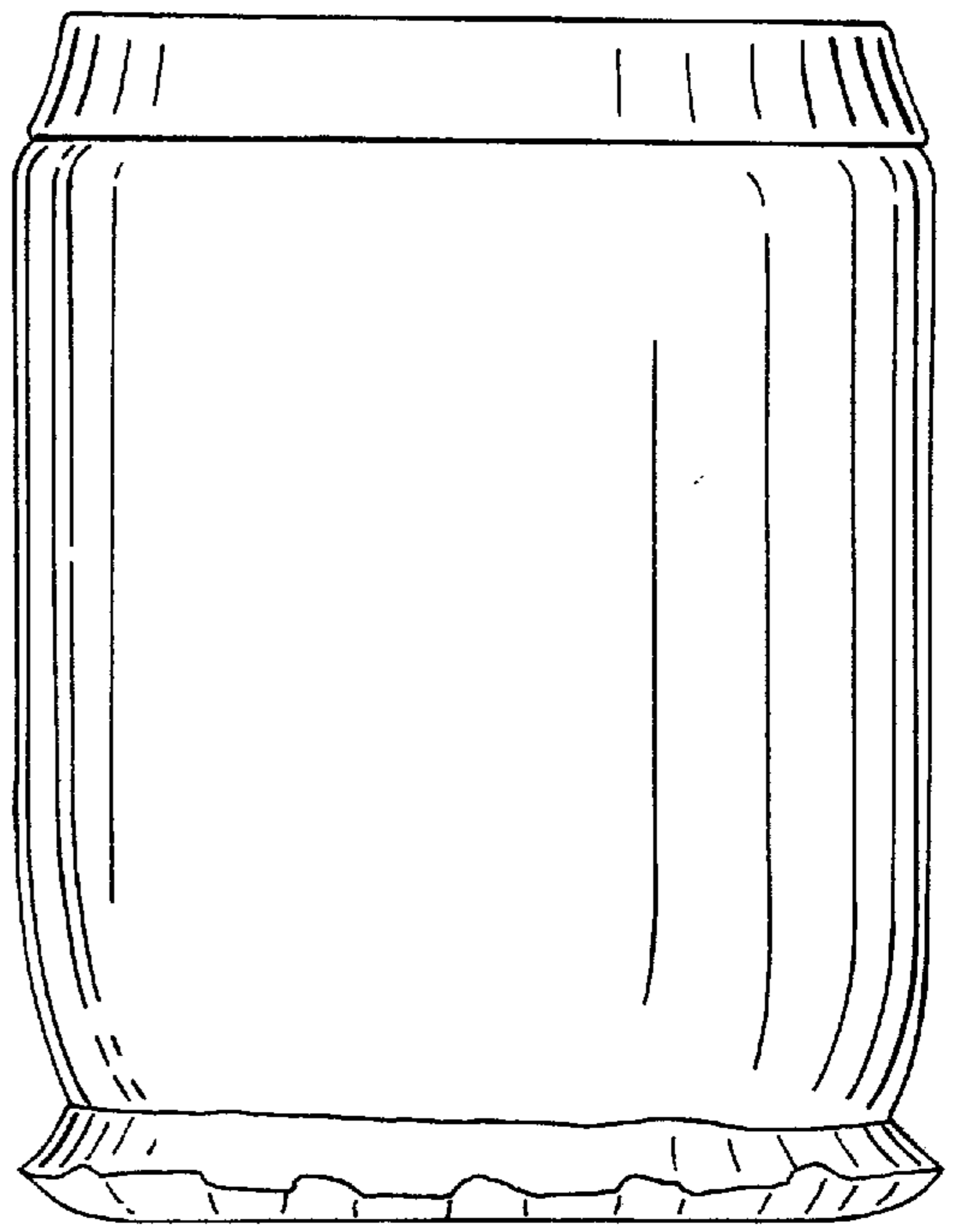

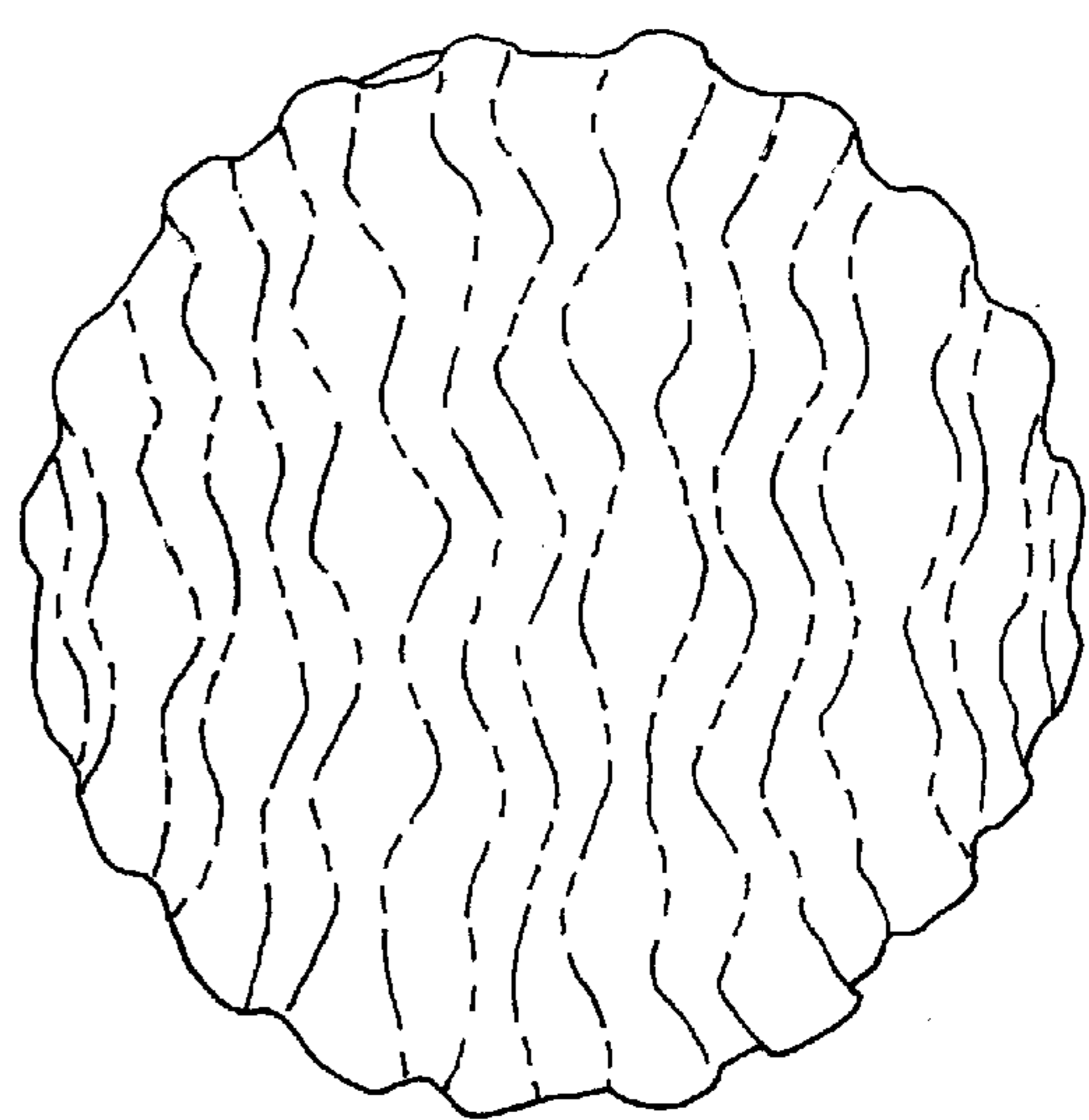

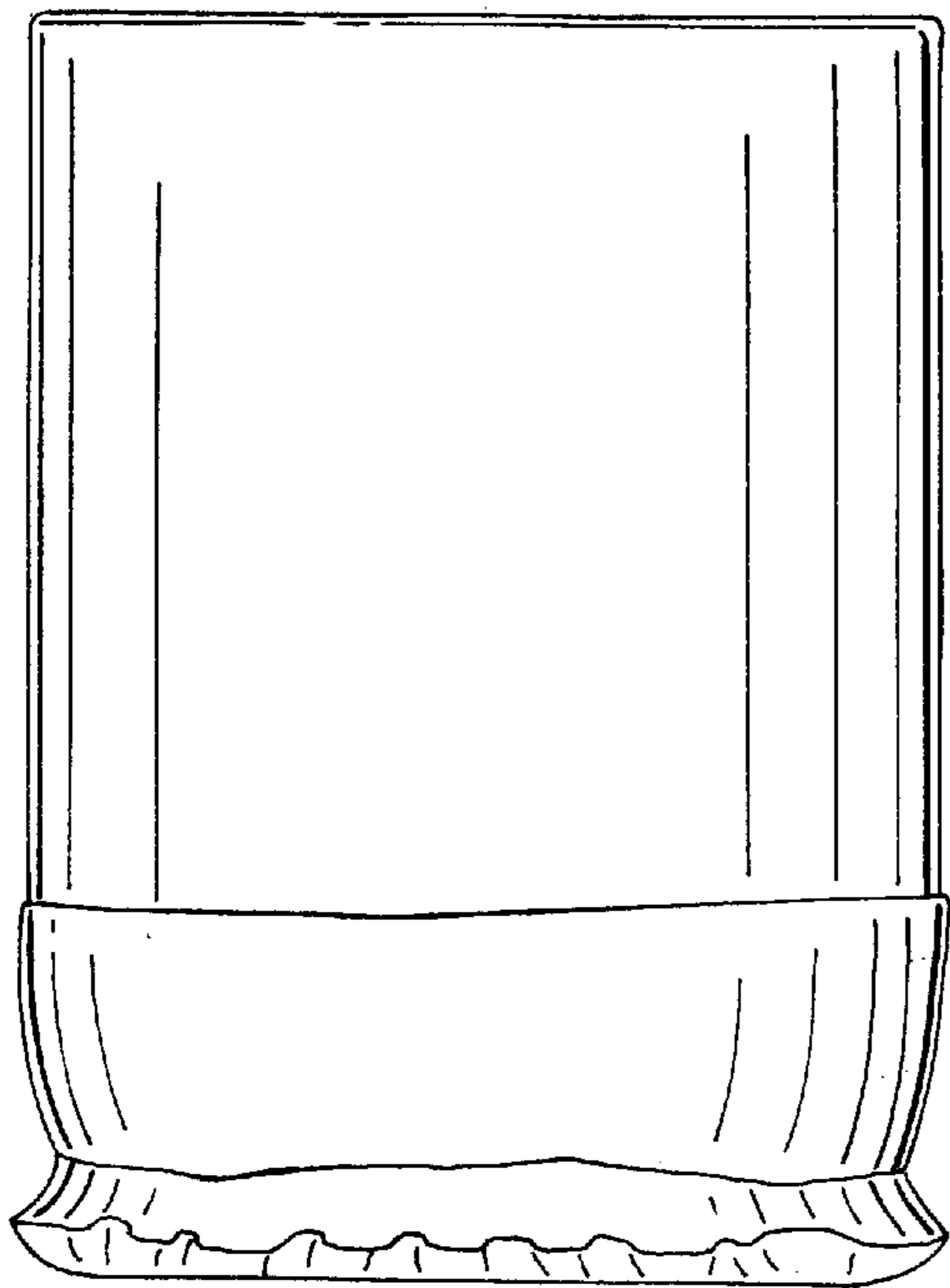
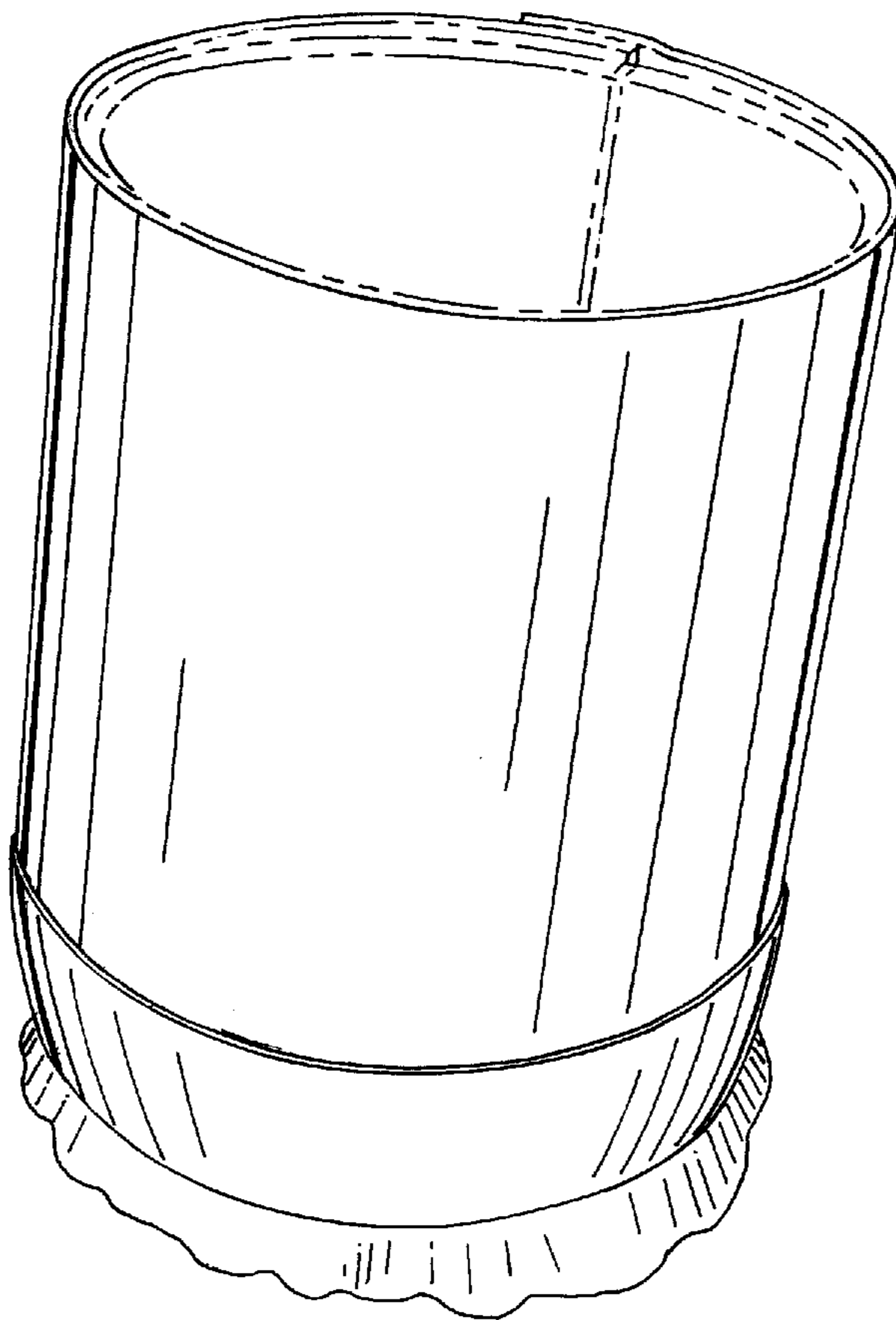

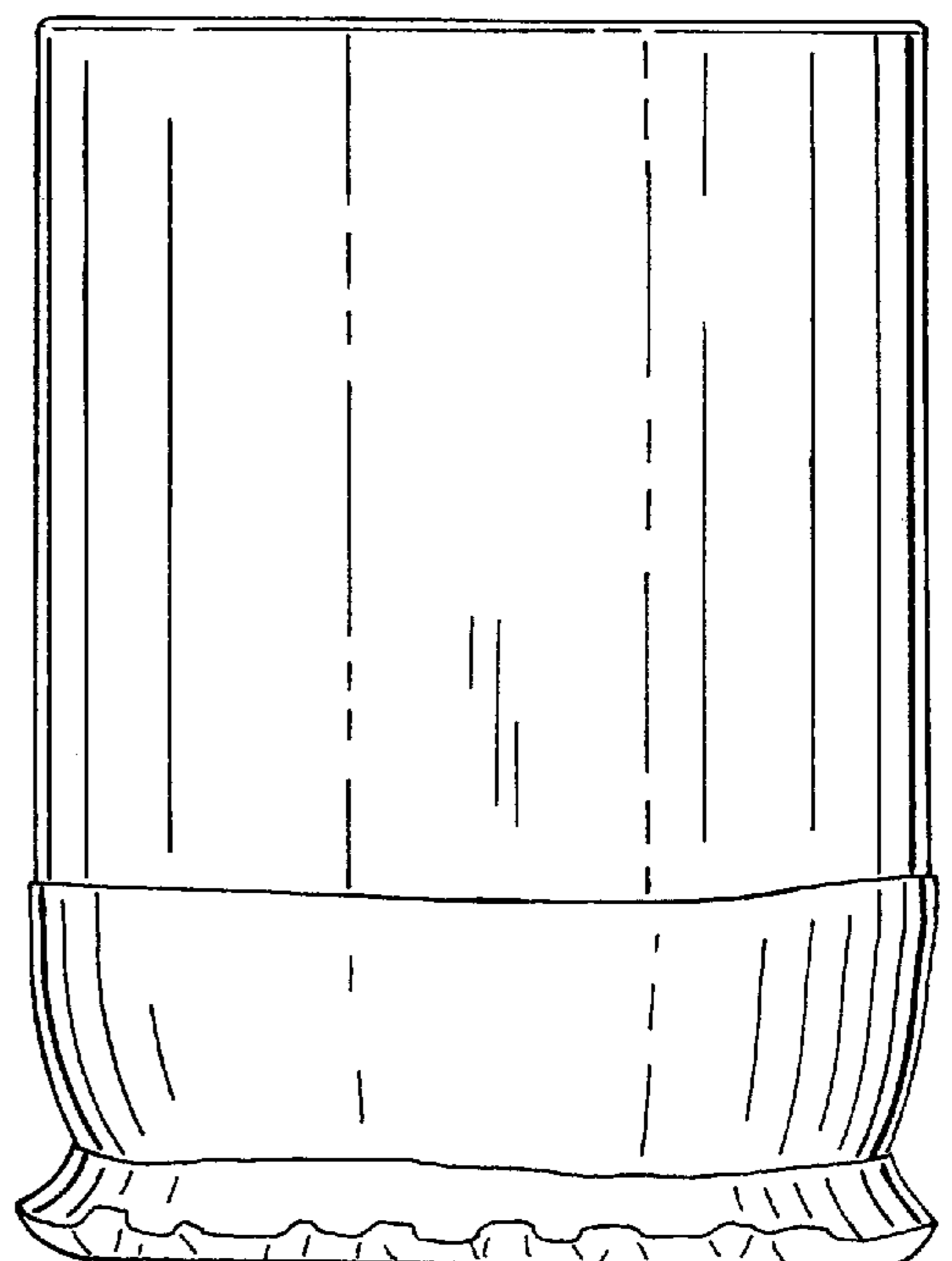

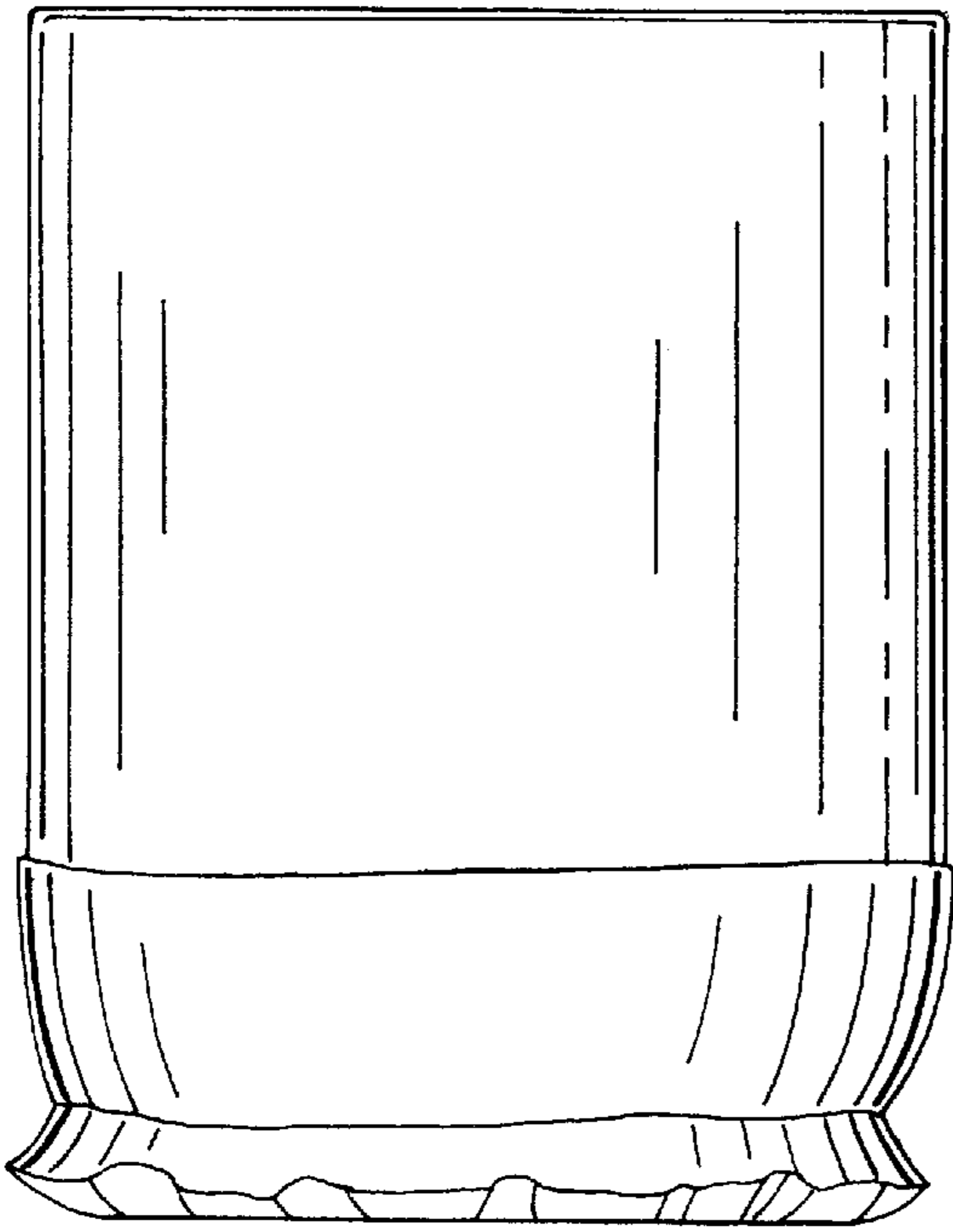

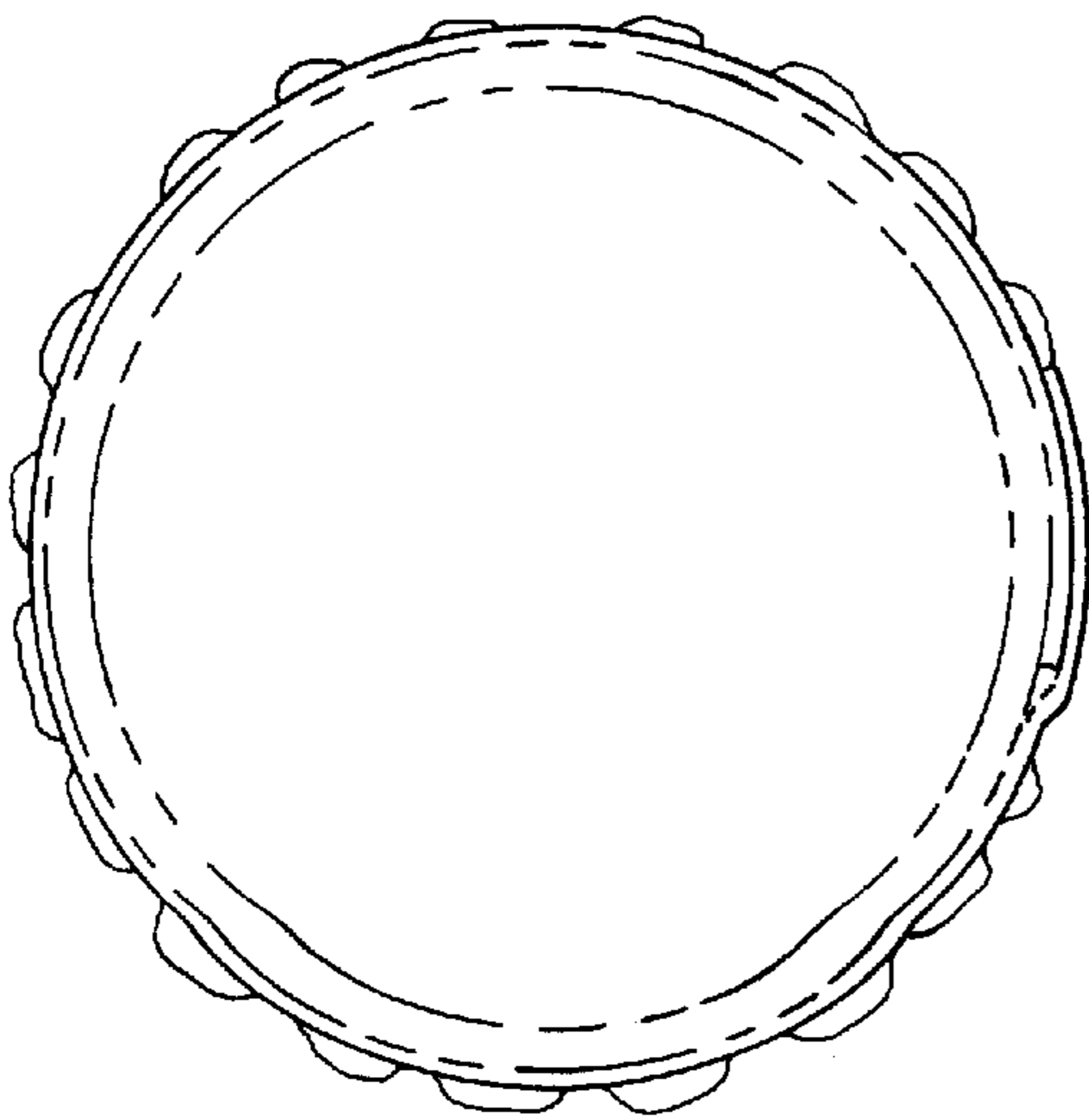
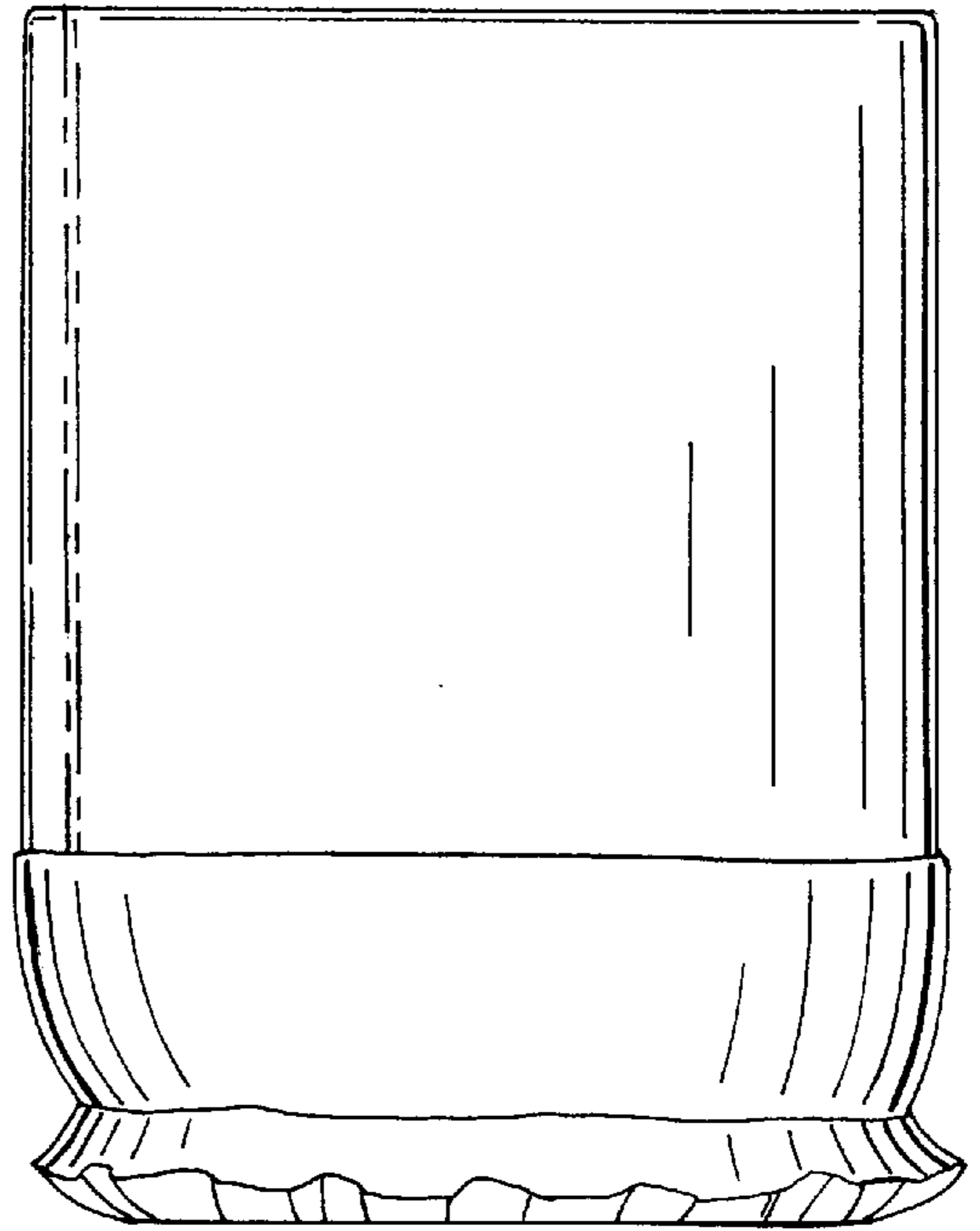

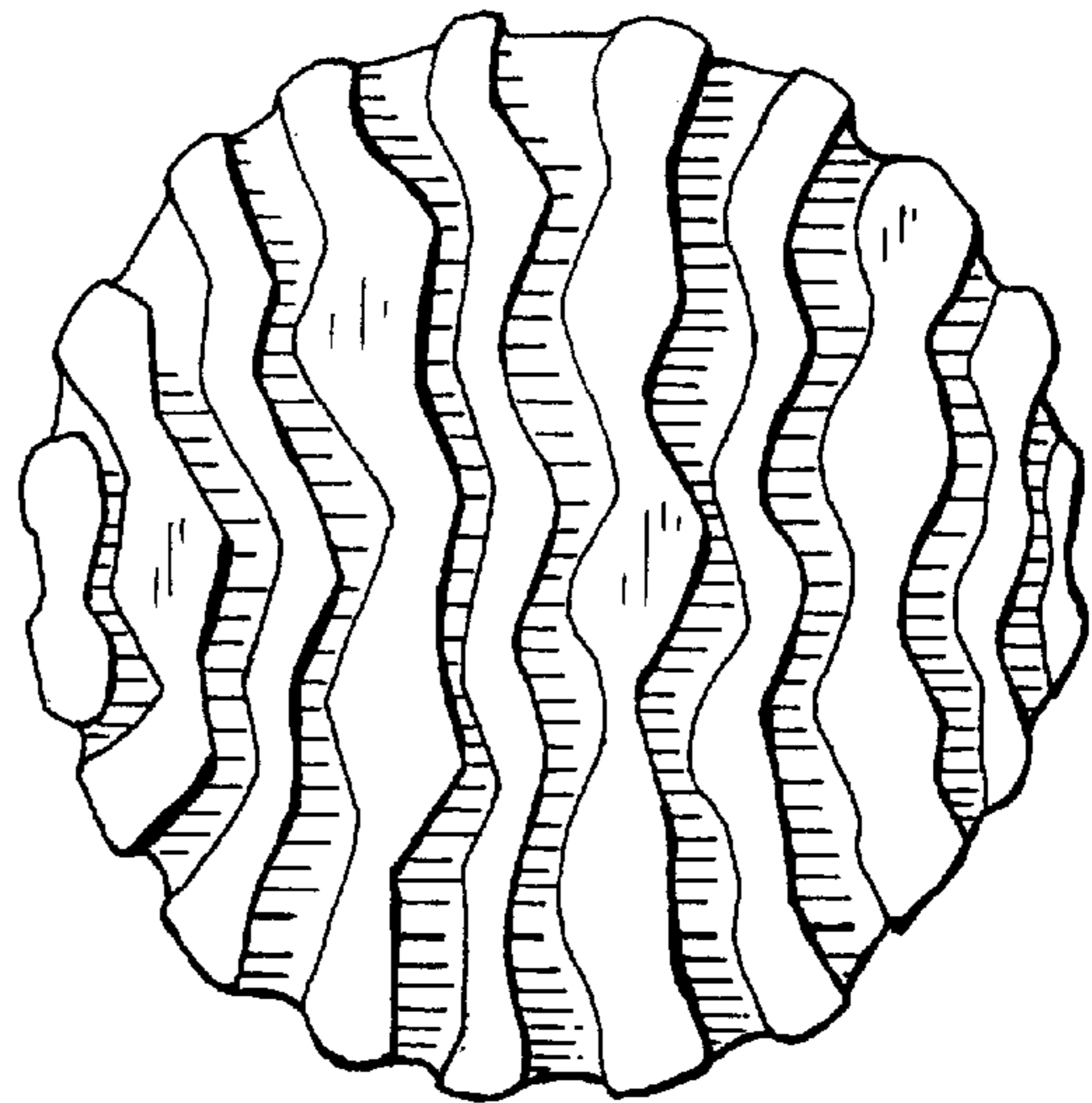

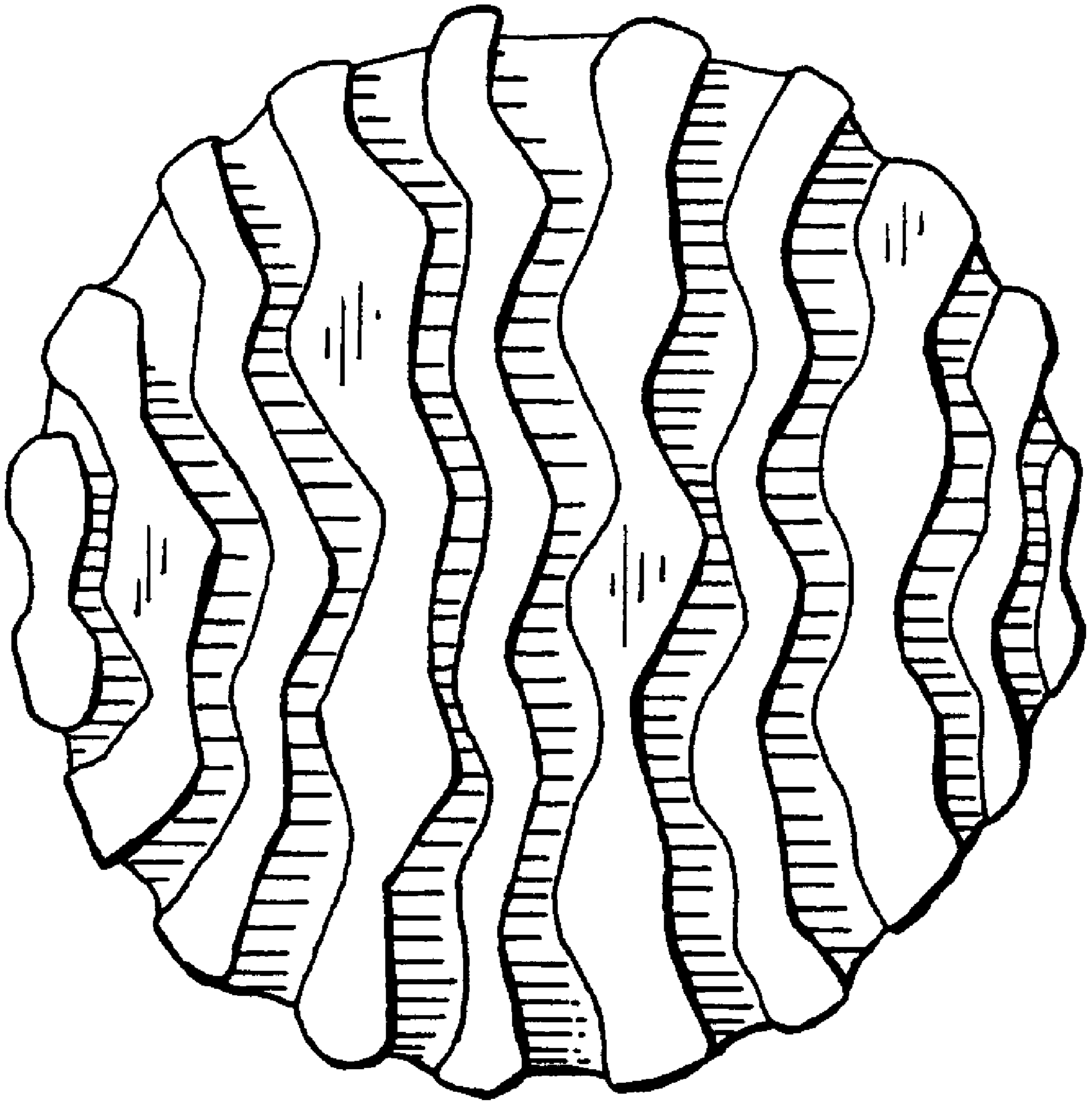
