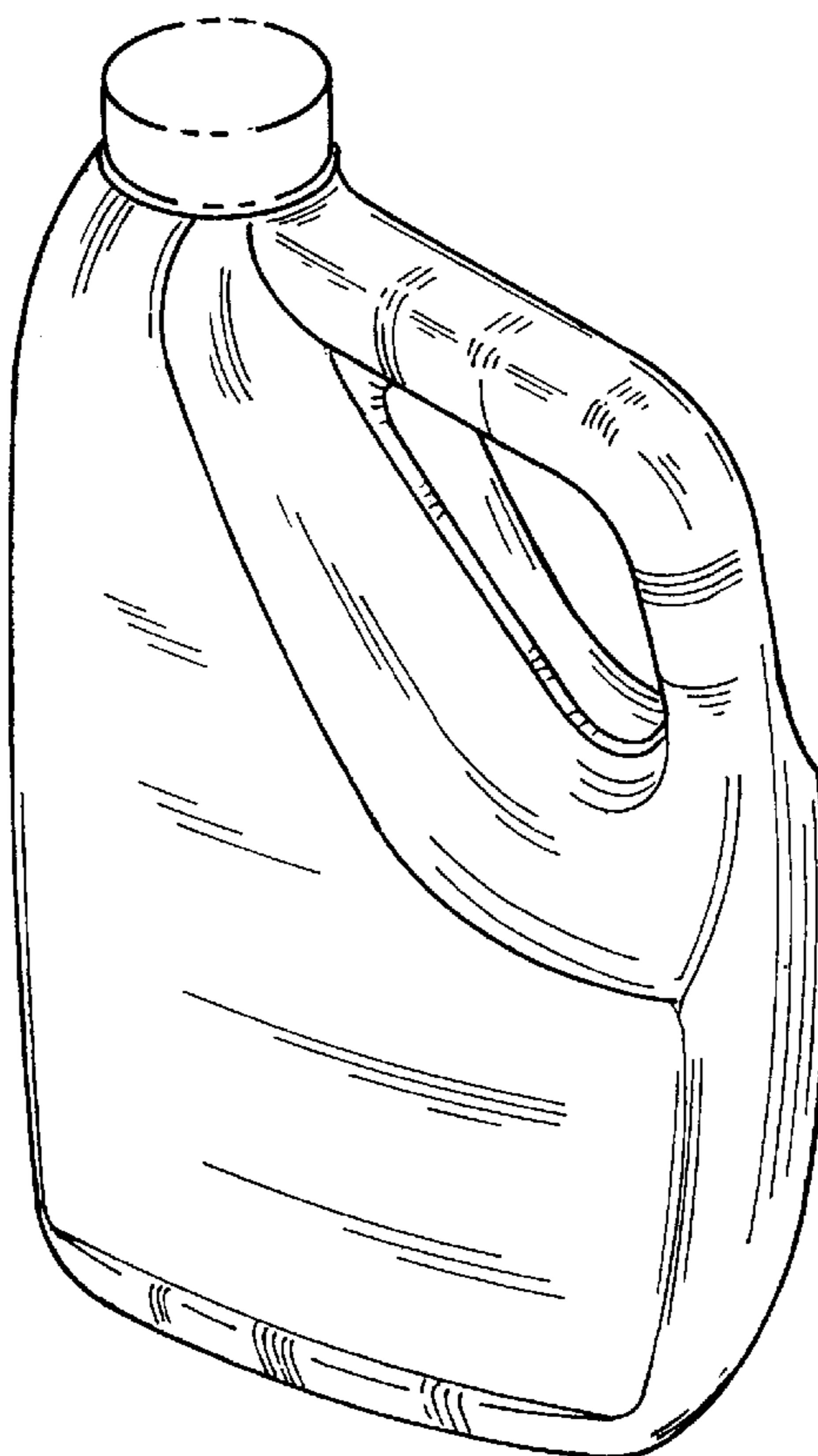
[57] **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a $\frac{3}{4}$ perspective view of the bottle of our invention, FIG. 2 is a front view of the bottle of our invention, the opposite side being a mirror image. FIG. 3 is a top view of the bottle of our invention. FIG. 4 is a left side view of the bottle of our invention. FIG. 5 is a right side view of the bottle of our invention; and, FIG. 6 is a bottom view of the bottle of our invention. The broken line showing of the cap is for illustrative purposes only and forms no part of the claimed design.

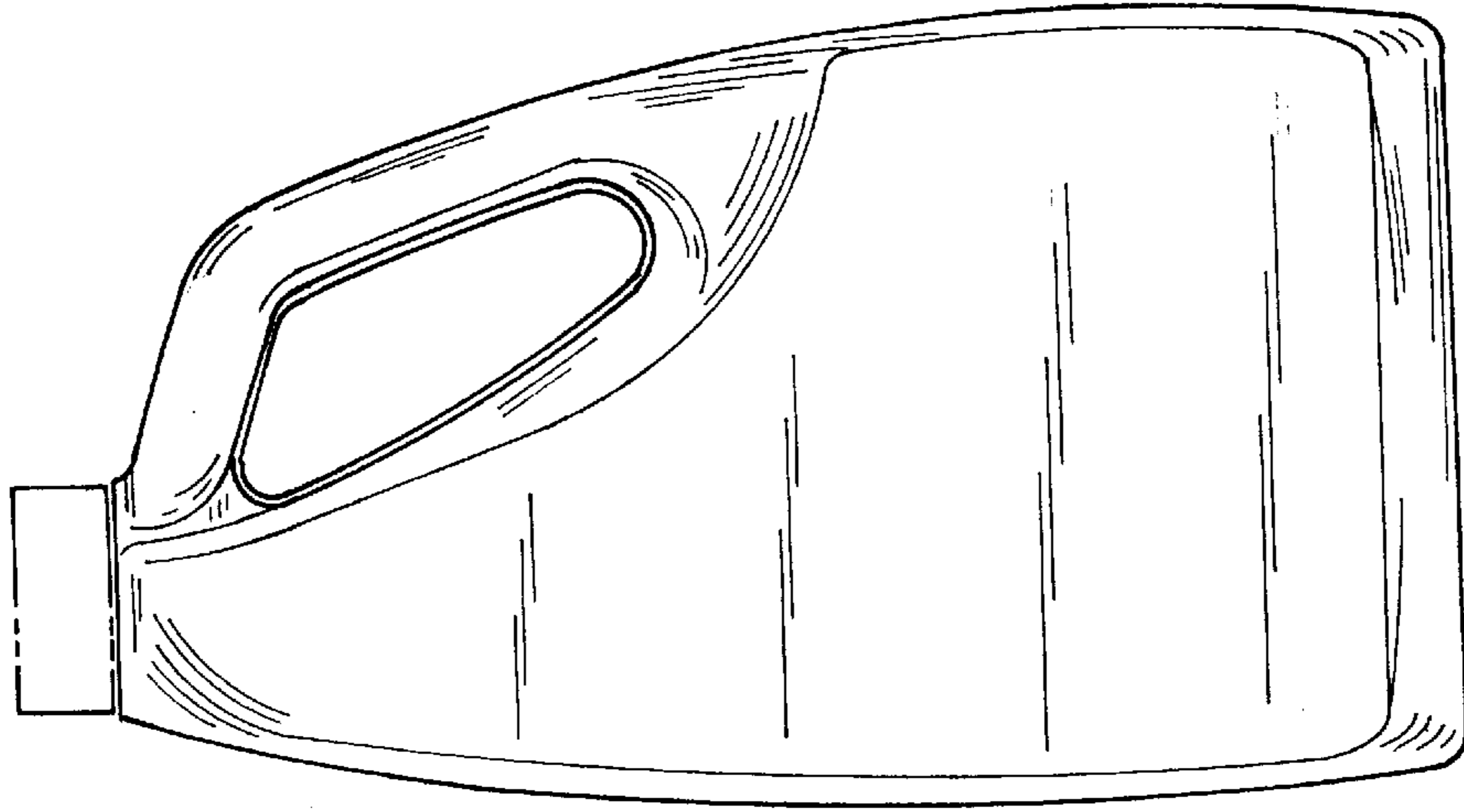

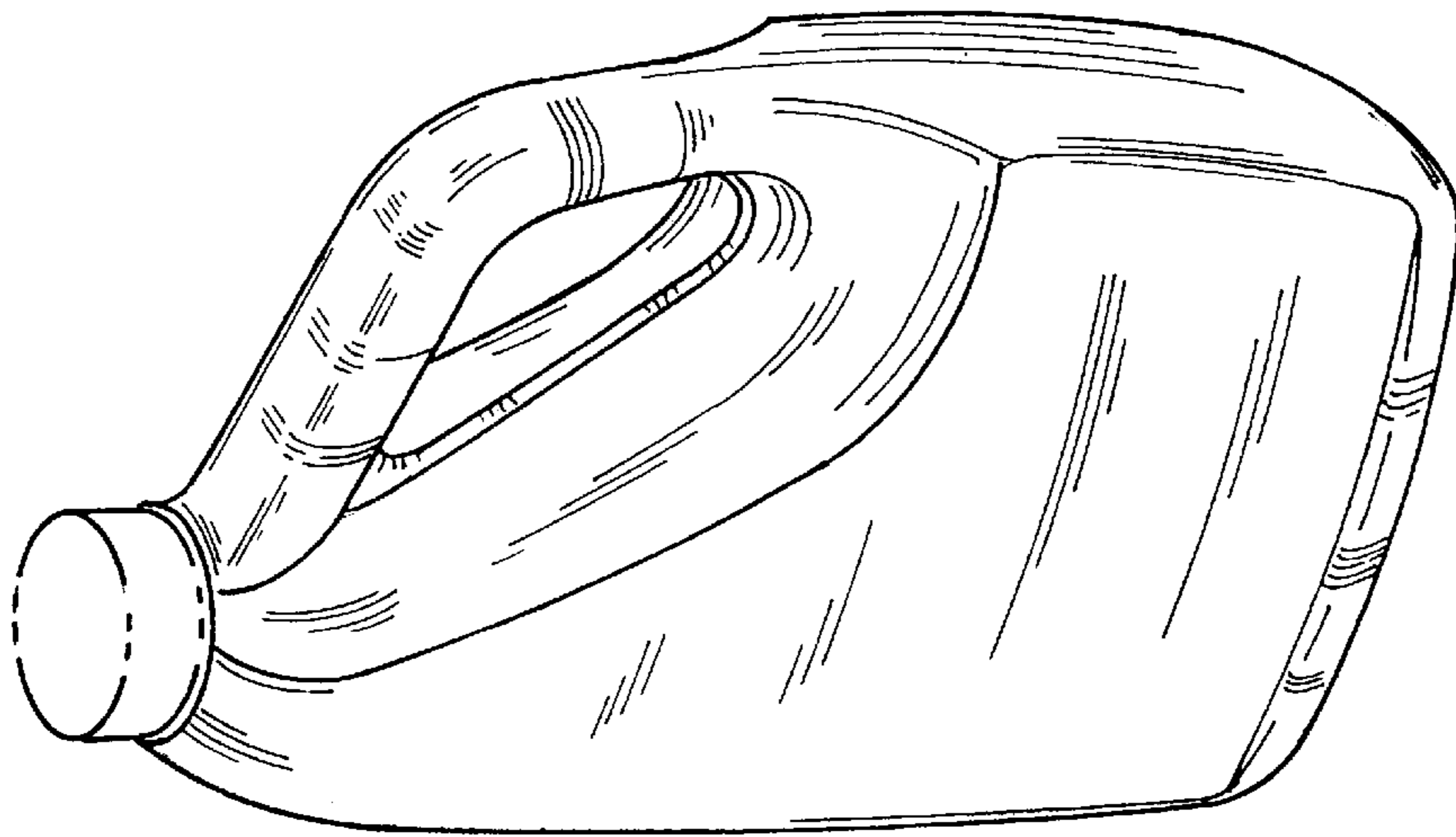

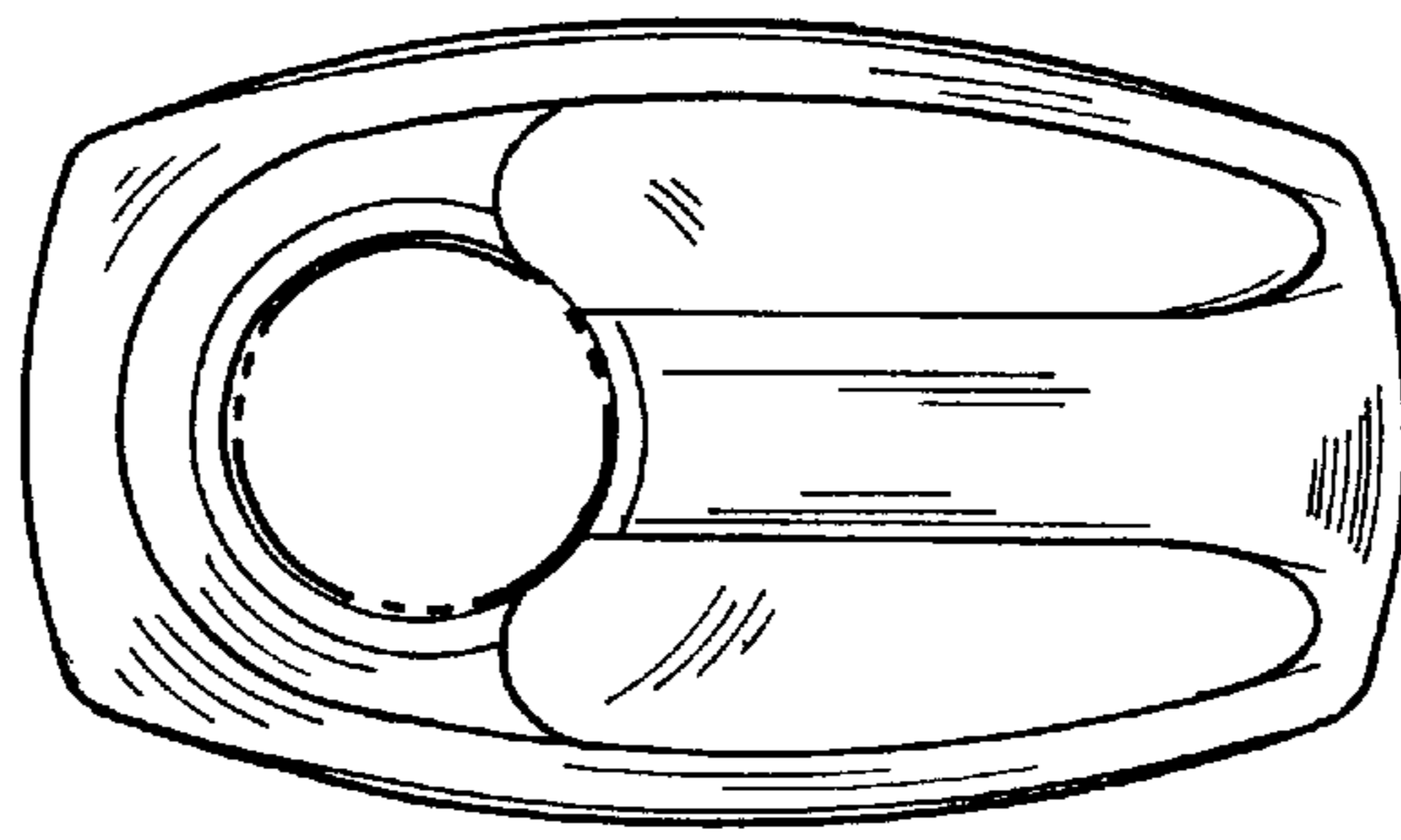

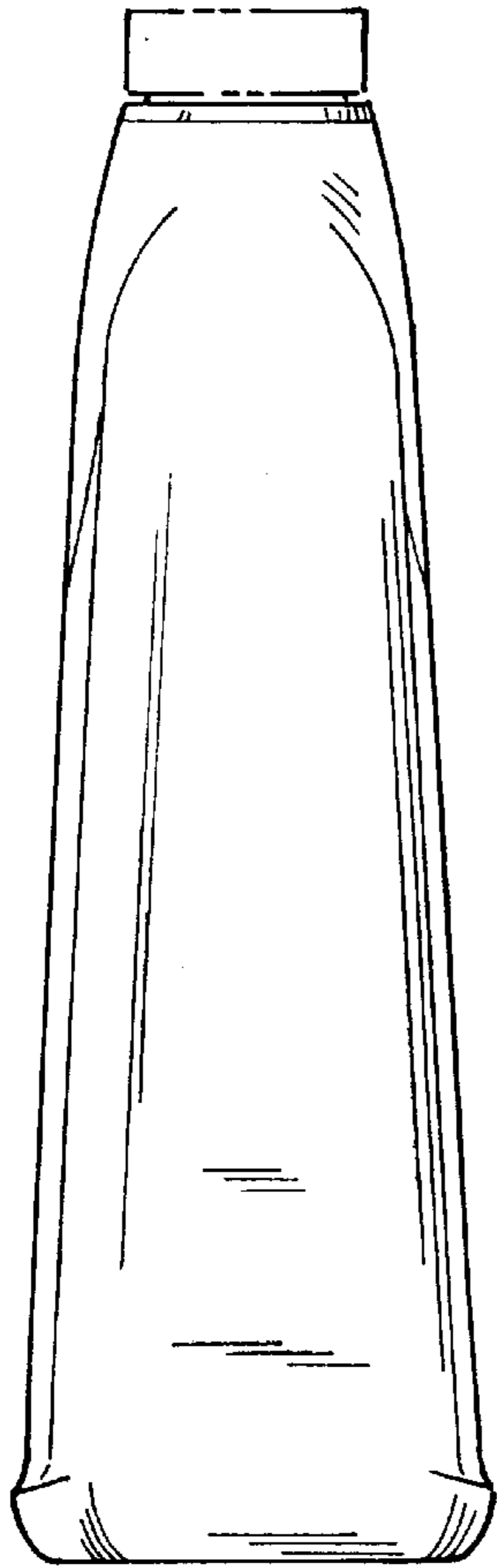

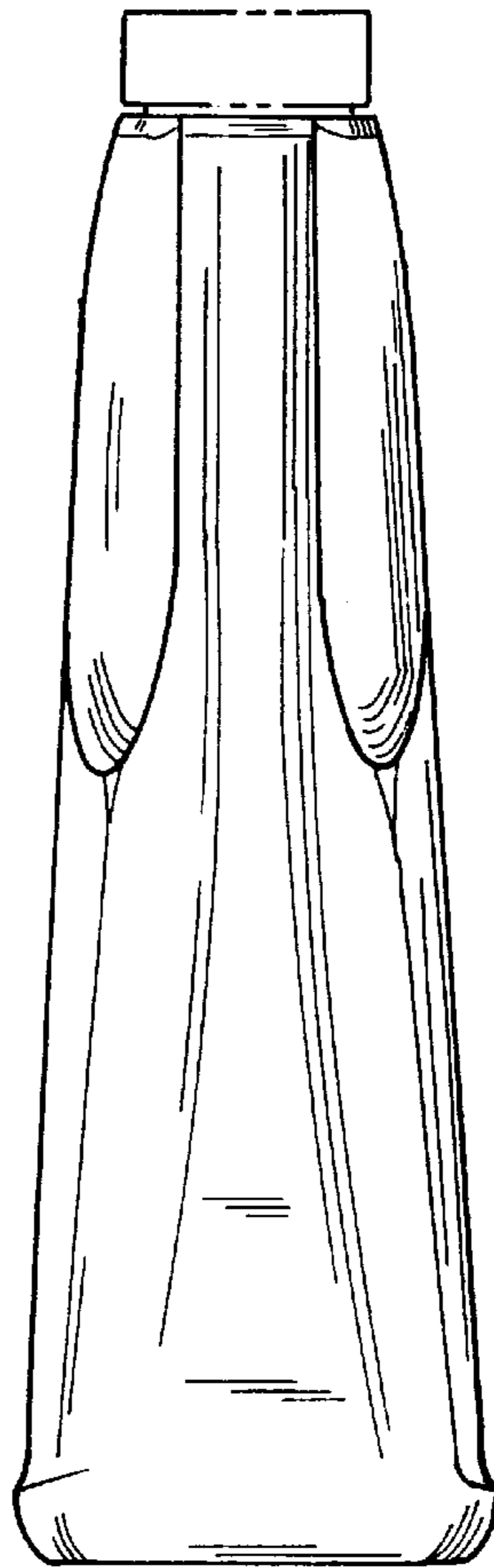

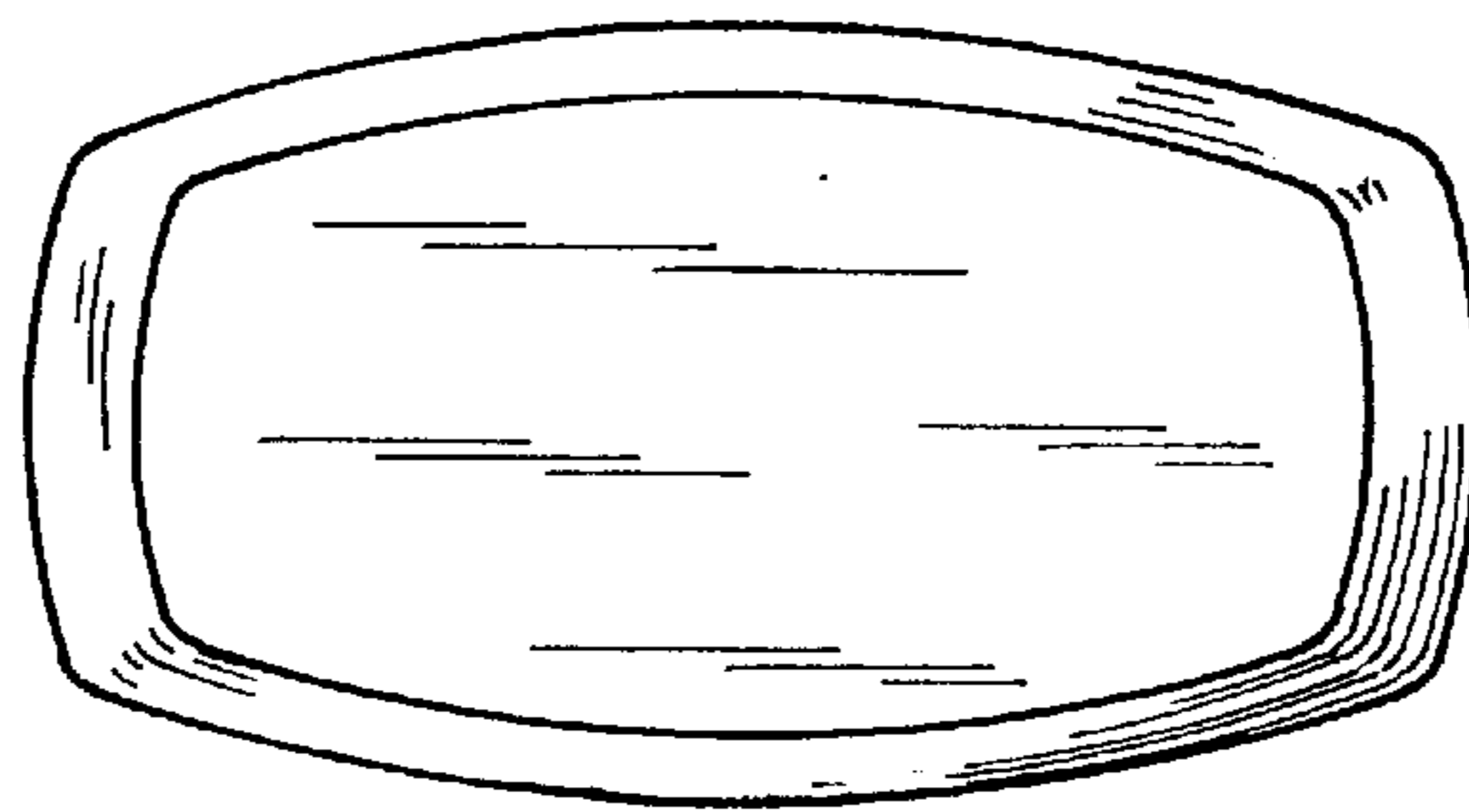
