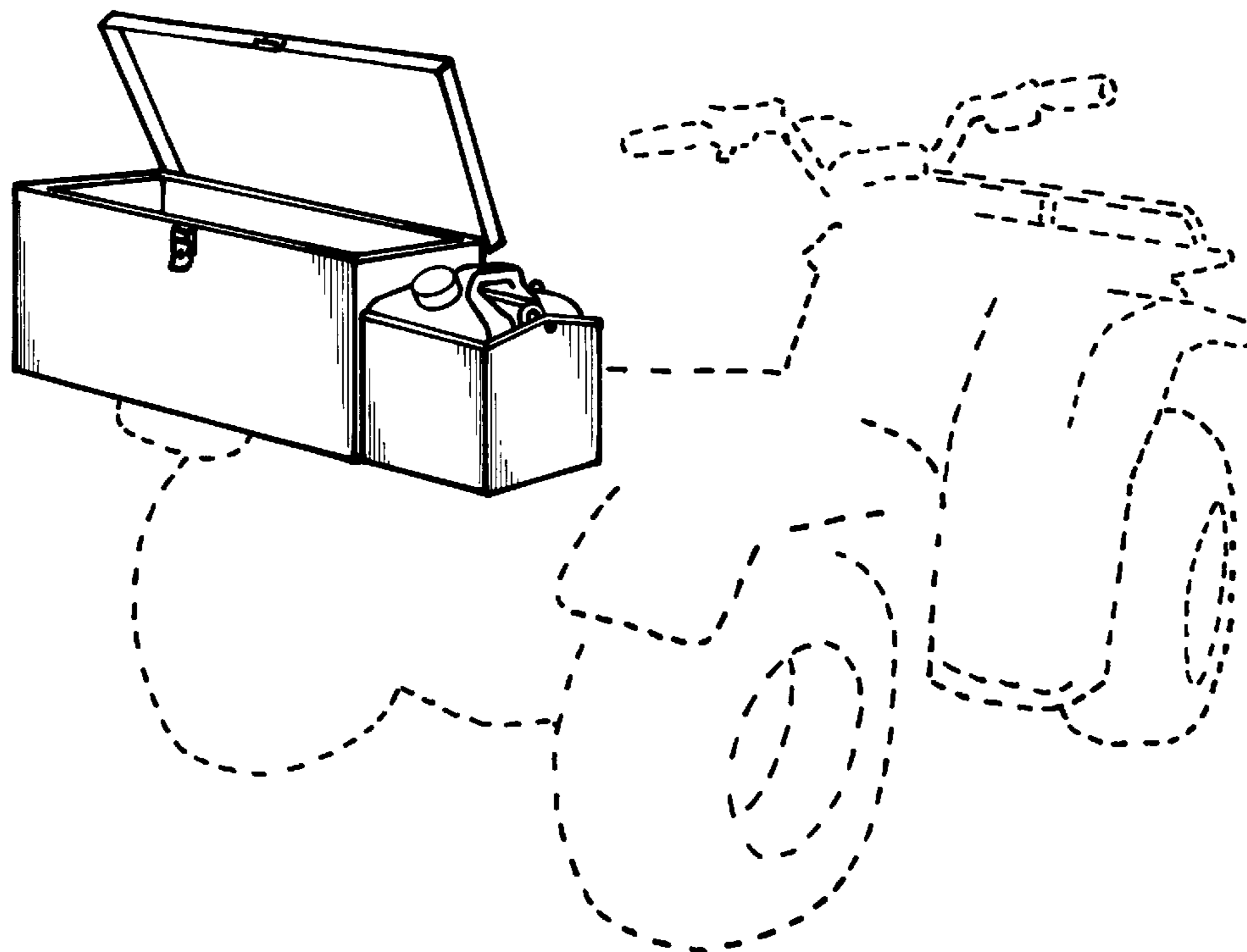
[57] **CLAIM**

The ornamental design for carrier for all terrain vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a carrier for all terrain vehicle, showing my new design, it being understood that the portions of the interior which are not visible in FIG. 1 form no part of the claimed design;
FIG. 2 is an enlarged front plan view of the carrier for all terrain vehicle, shown with the lid in closed position;
FIG. 3 is an enlarged rear plan view thereof;
FIG. 4 is an enlarged right side view thereof;
FIG. 5 is an enlarged left side view thereof;
FIG. 6 is an enlarged top plan view thereof;
FIG. 7 is an enlarged bottom plan view thereof;
FIG. 8 is a front perspective view of a second embodiment of a carrier for all terrain vehicle, showing my new design, it being understood that the portions of the interior which are not visible in FIG. 8 form no part of the claimed design;
FIG. 9 is an enlarged front plan view of the second embodiment of the carrier for all terrain vehicle, shown with the lid in closed position;
FIG. 10 is an enlarged rear plan view thereof;
FIG. 11 is an enlarged right side view thereof;
FIG. 12 is an enlarged left side view thereof;
FIG. 13 is an enlarged top plan view thereof; and,
FIG. 14 is an enlarged bottom plan view thereof.

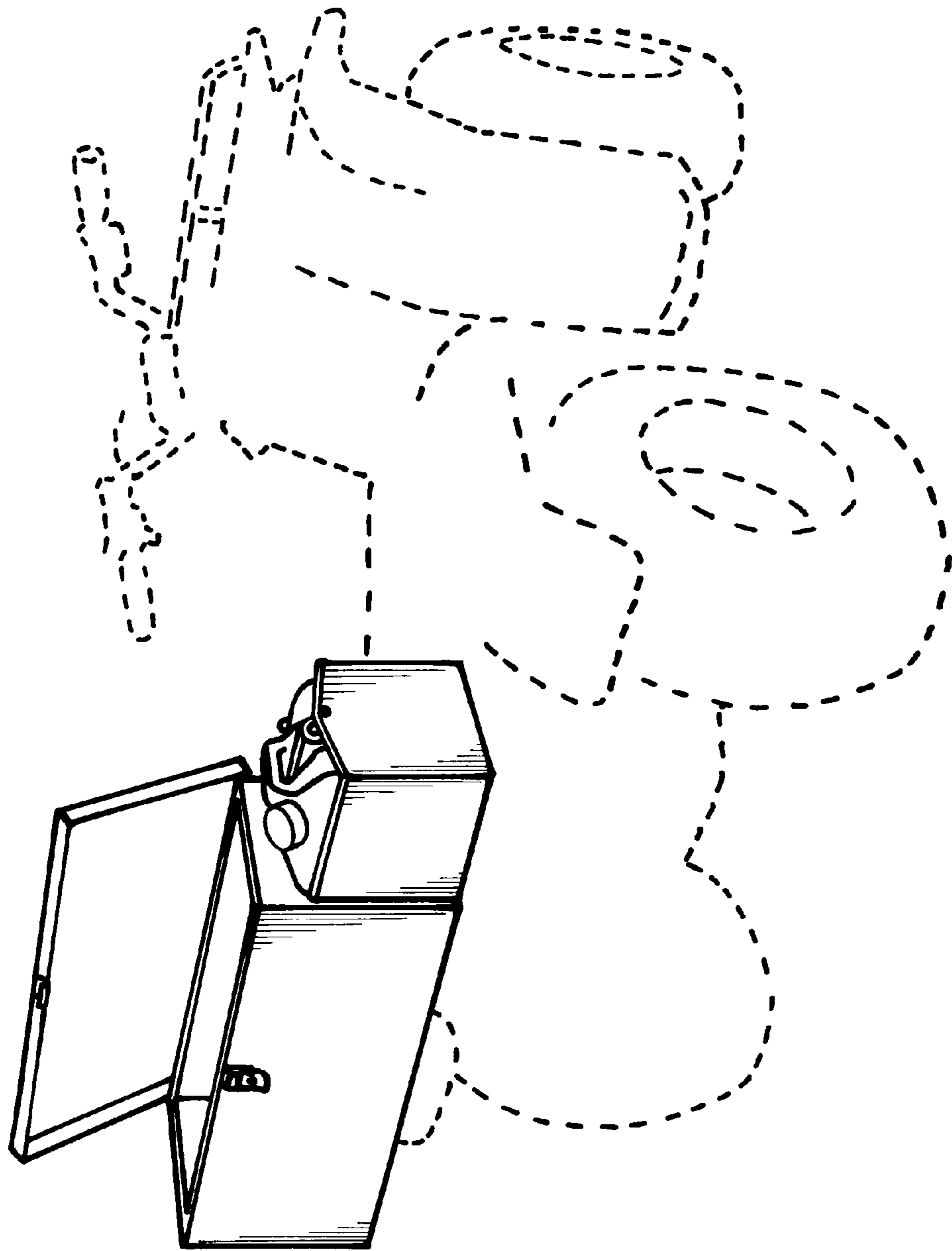

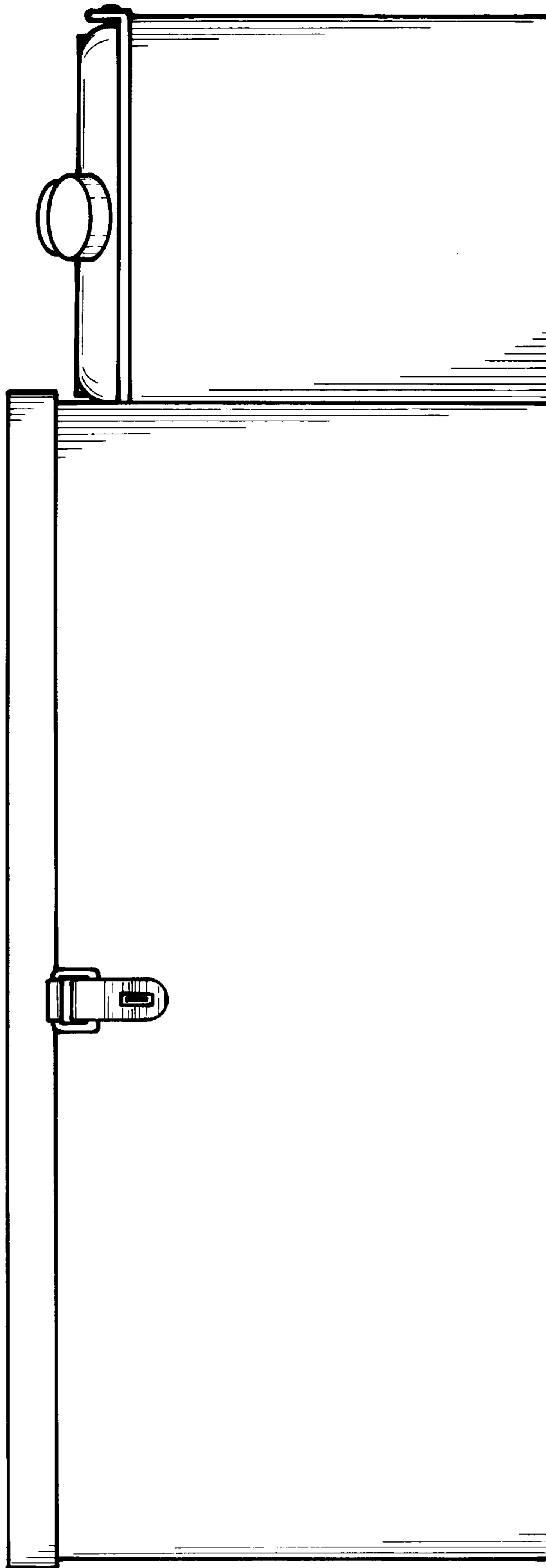

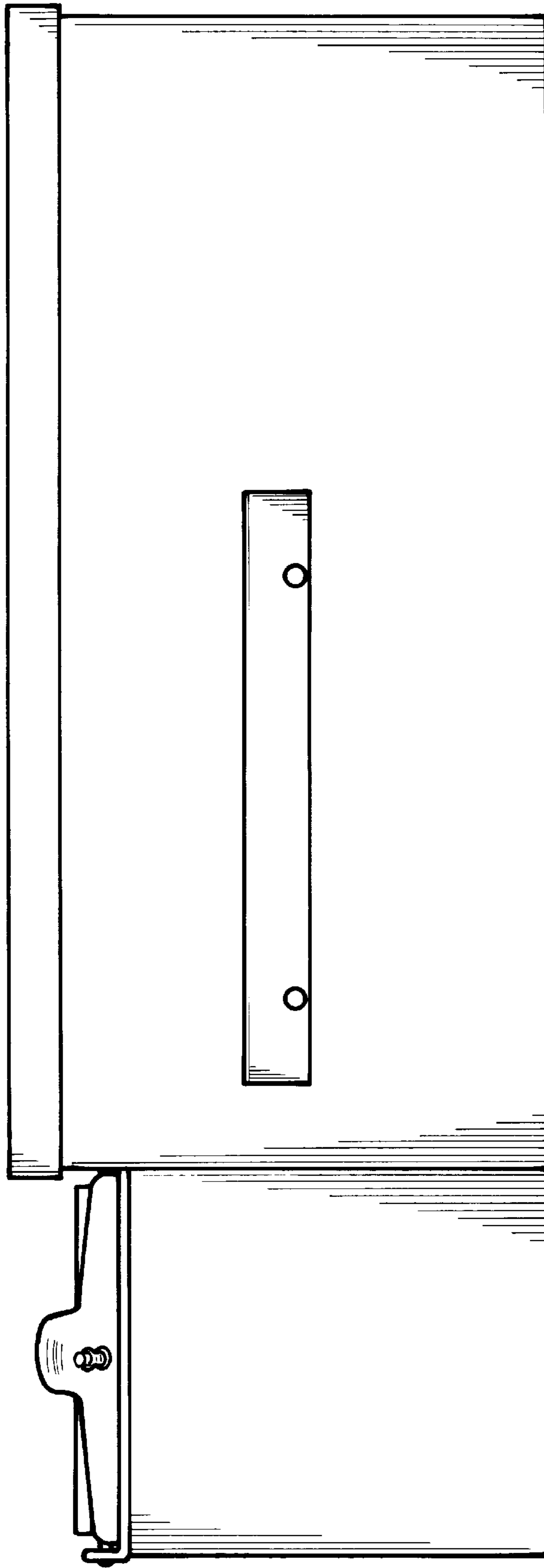

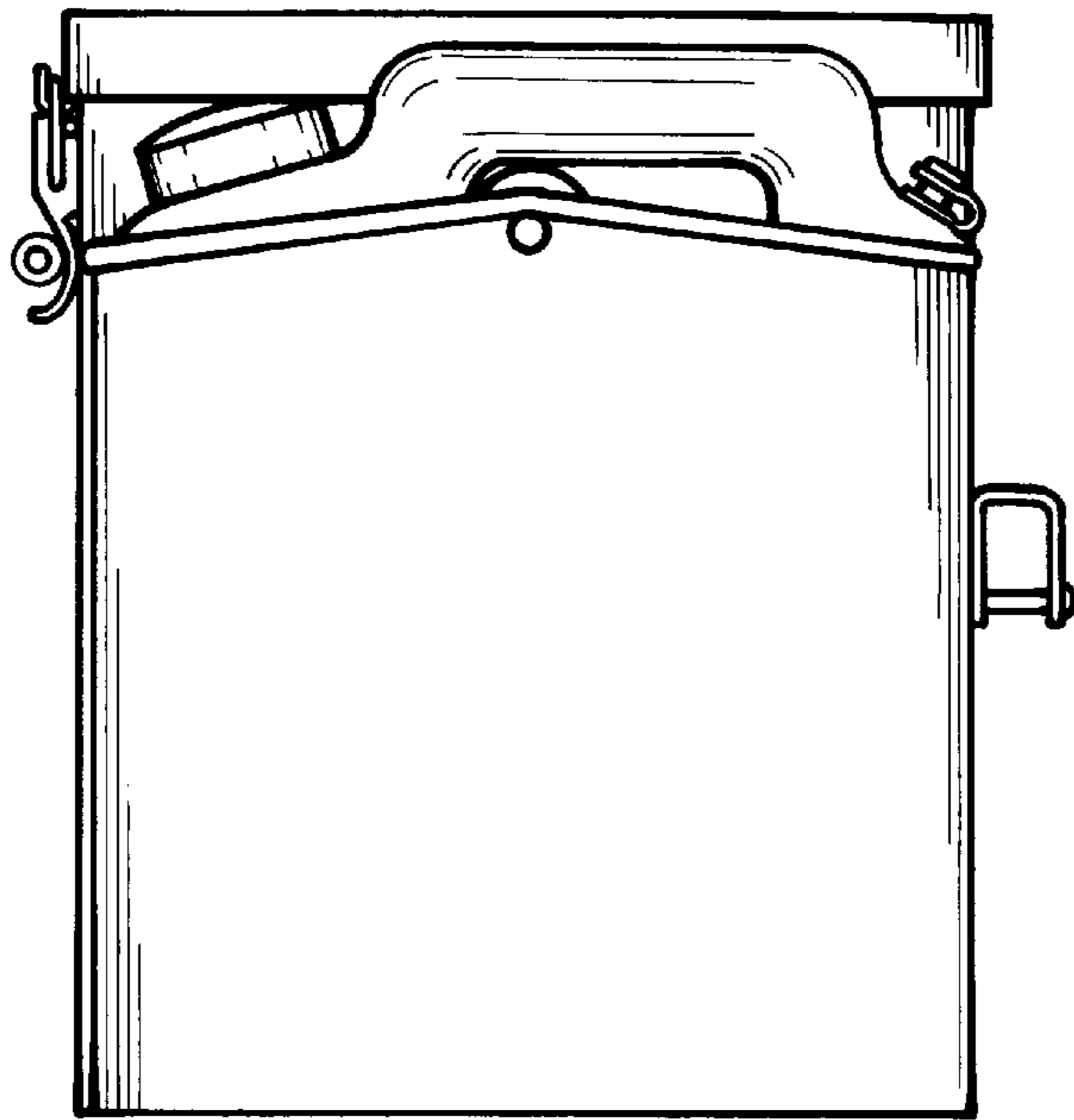

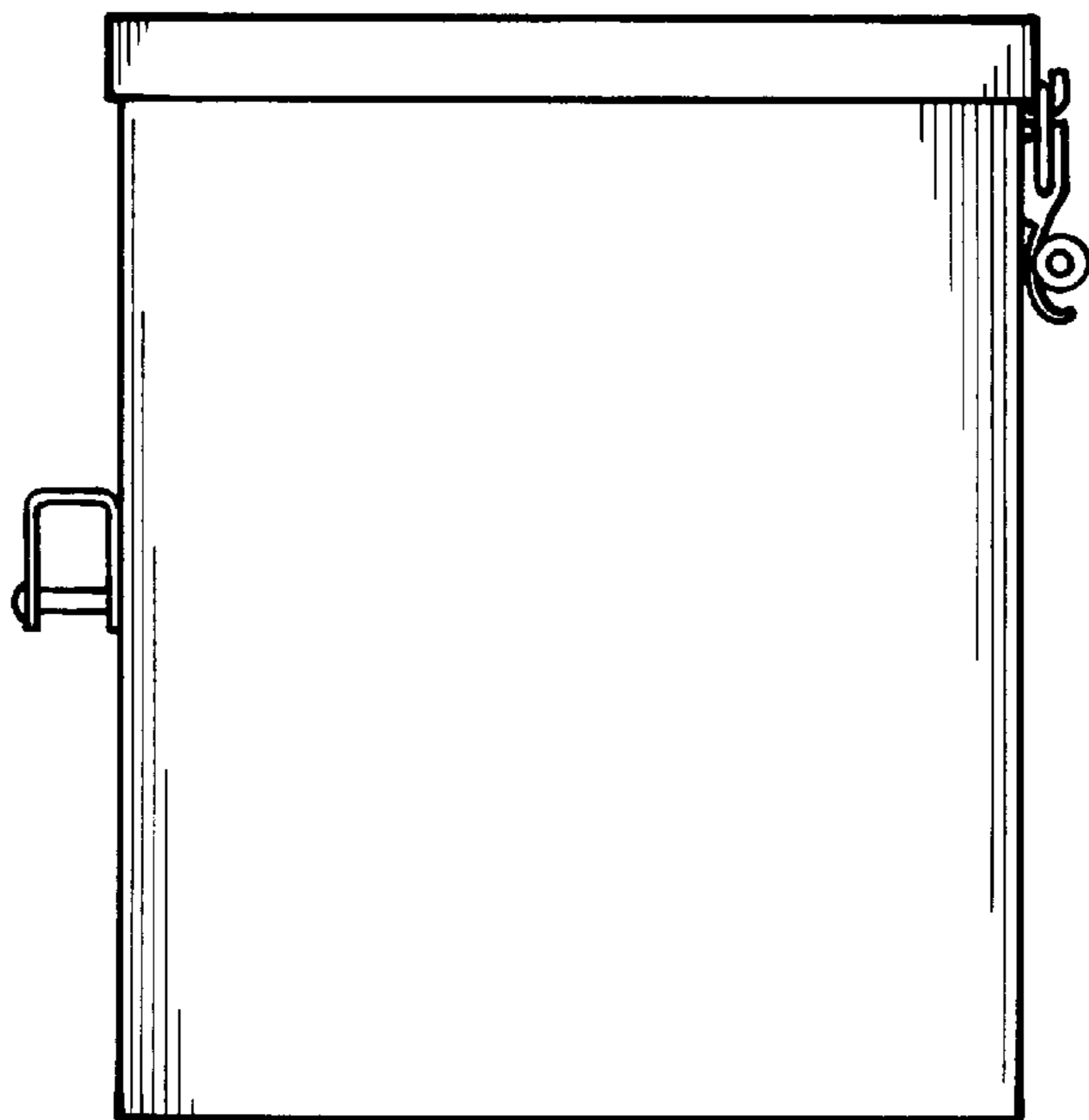

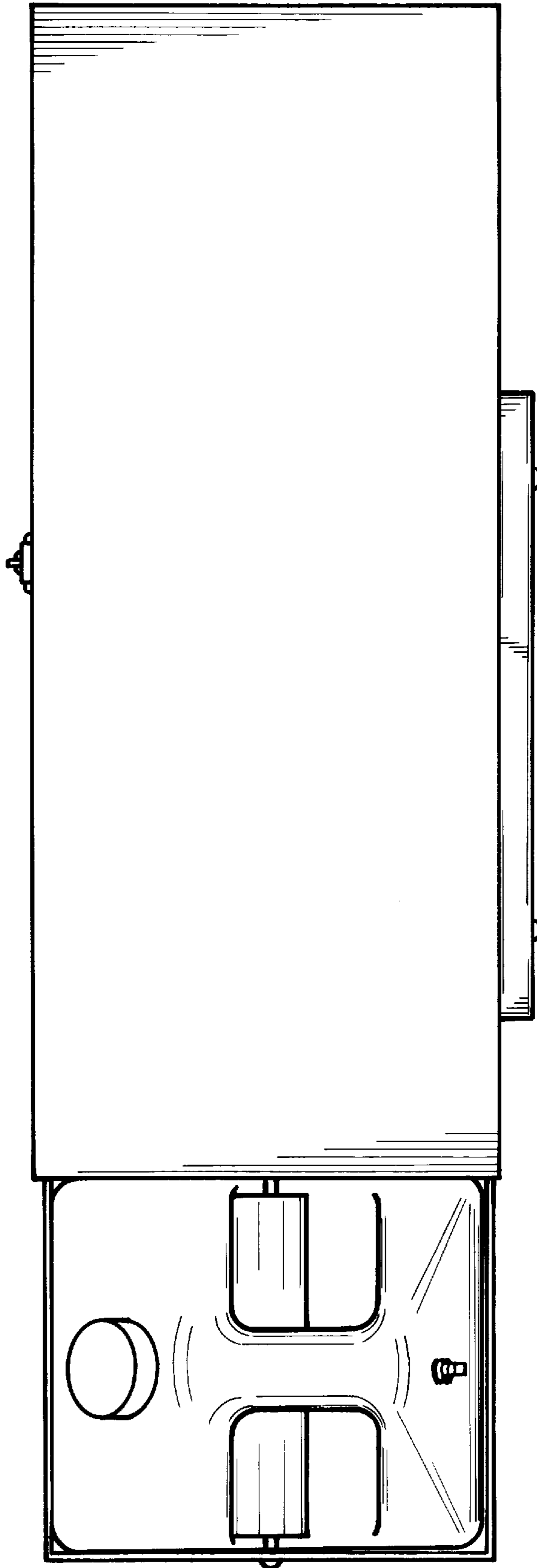

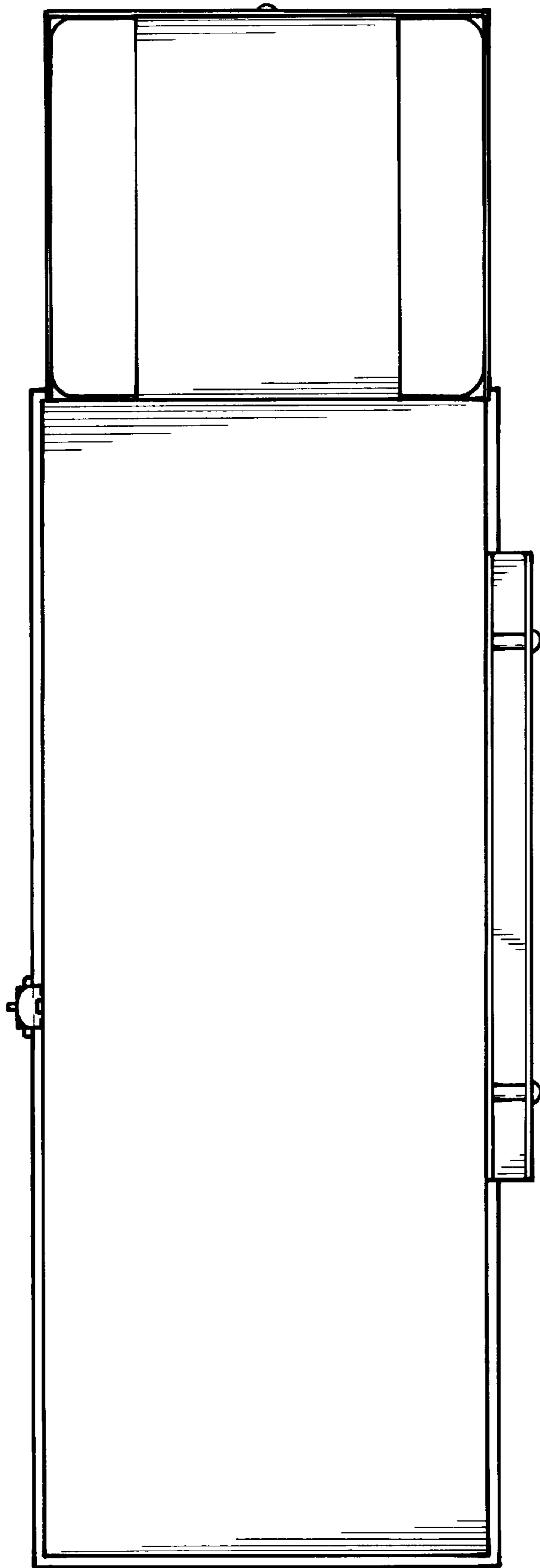

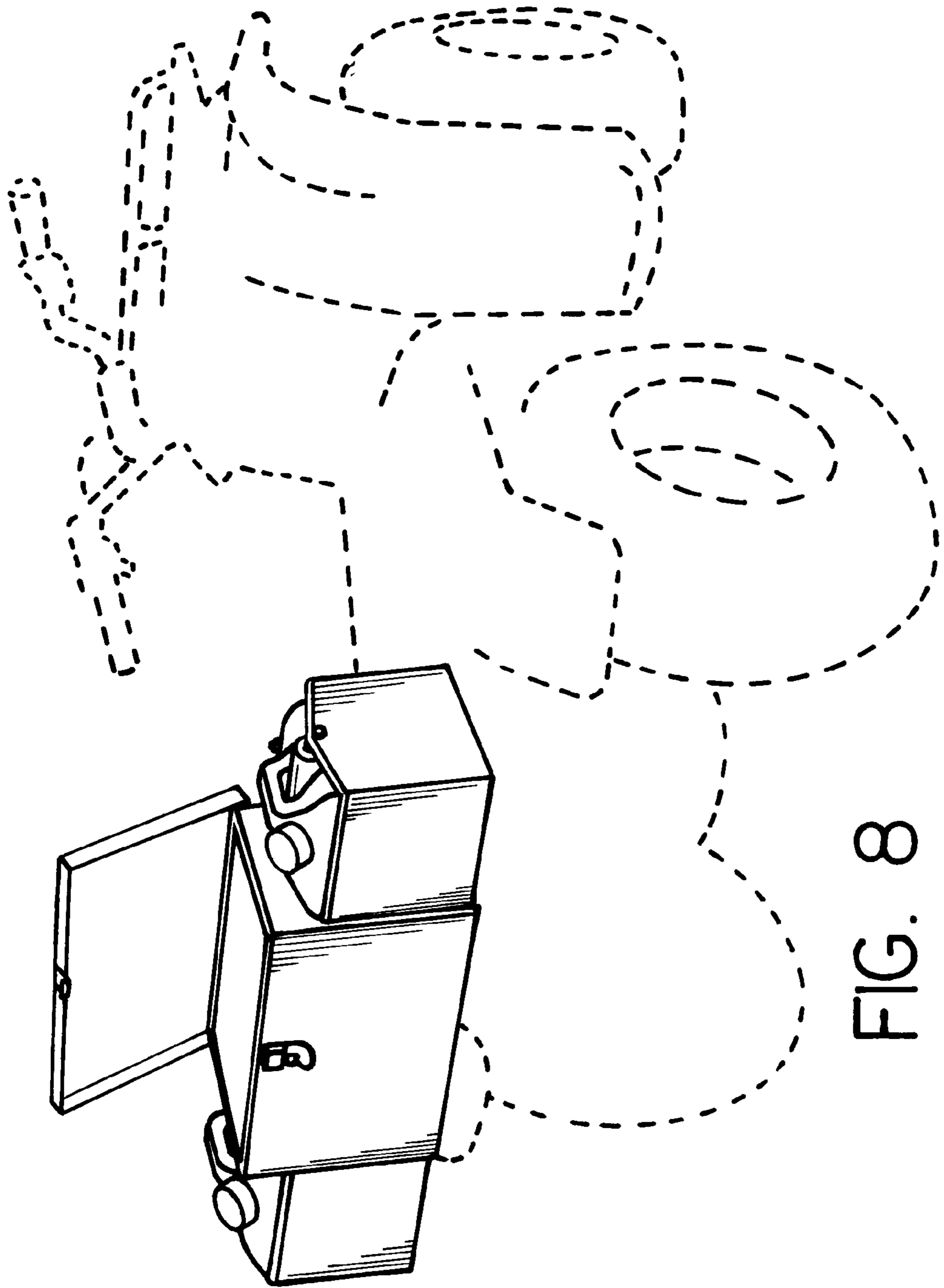

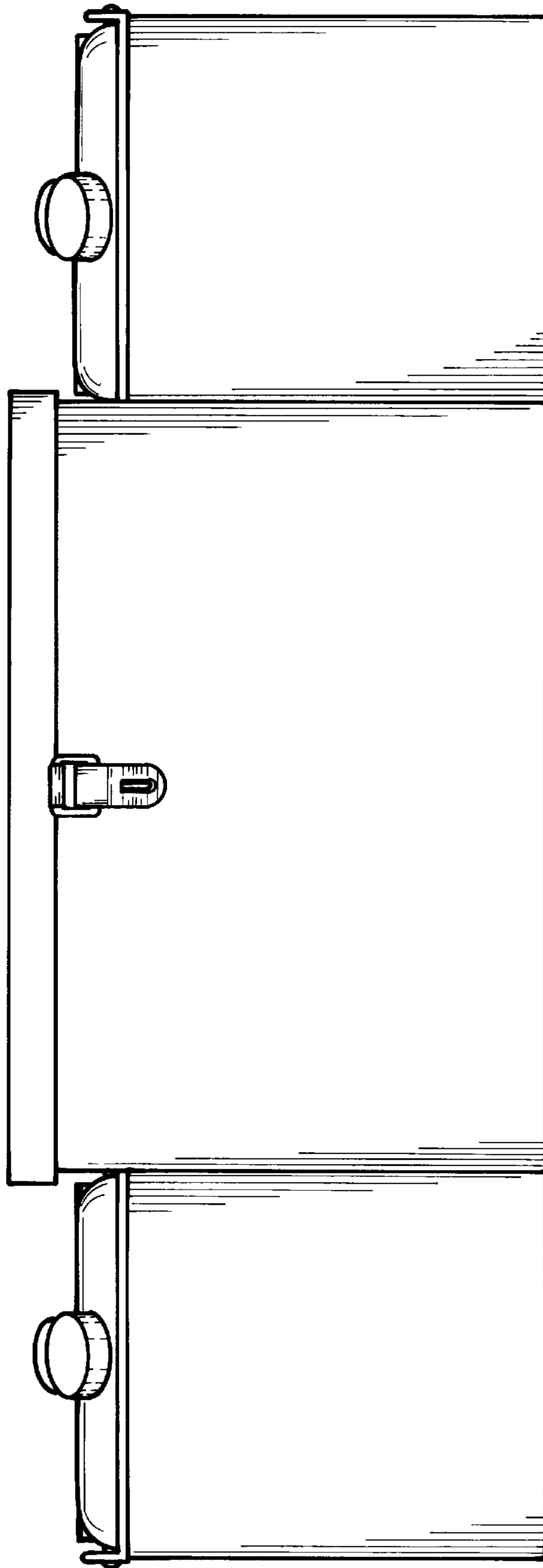

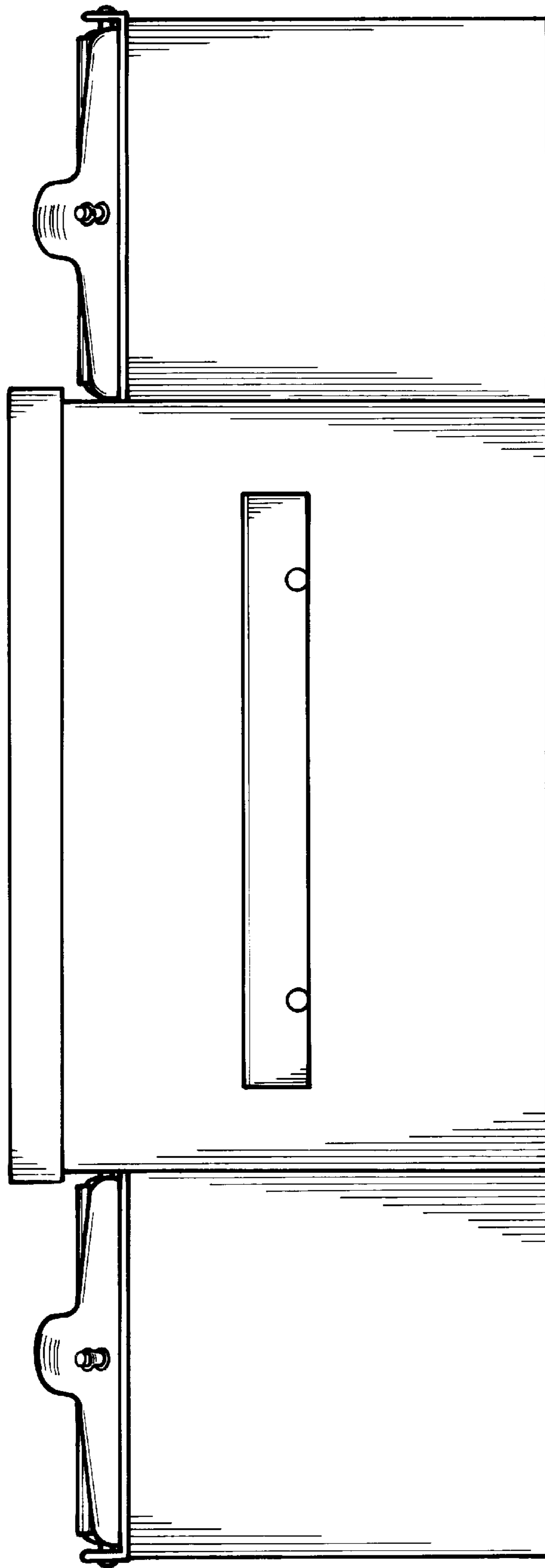

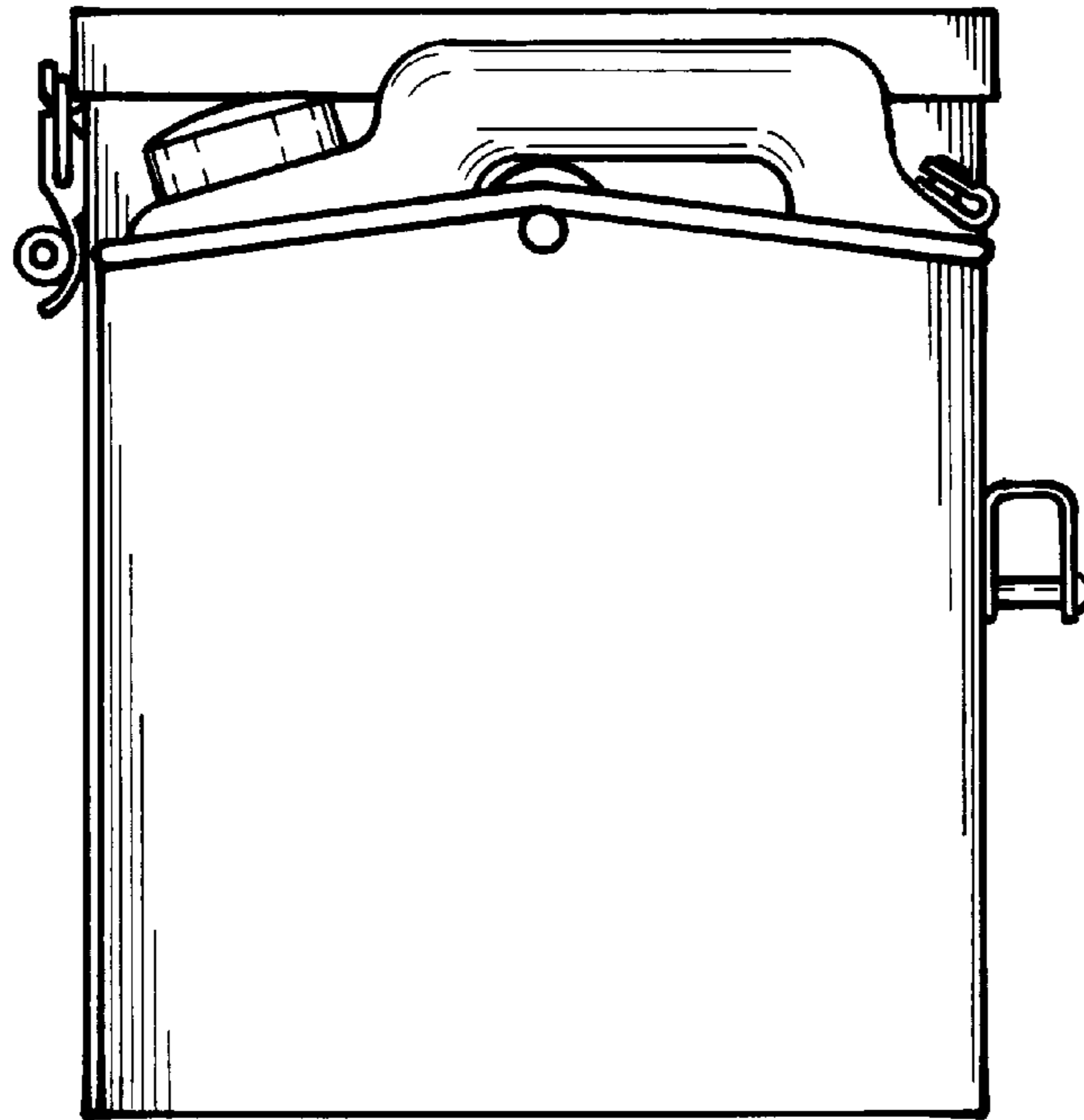

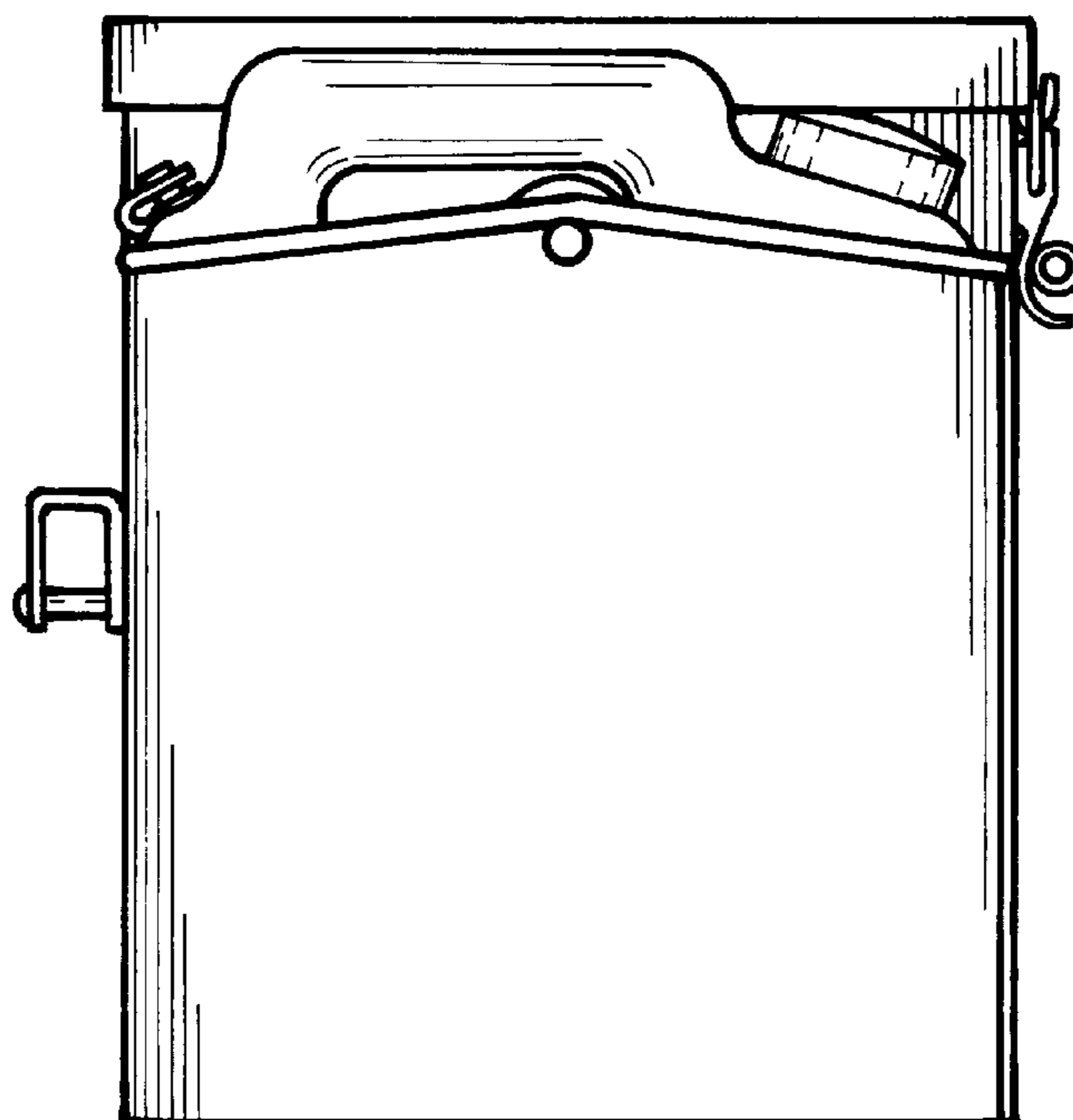

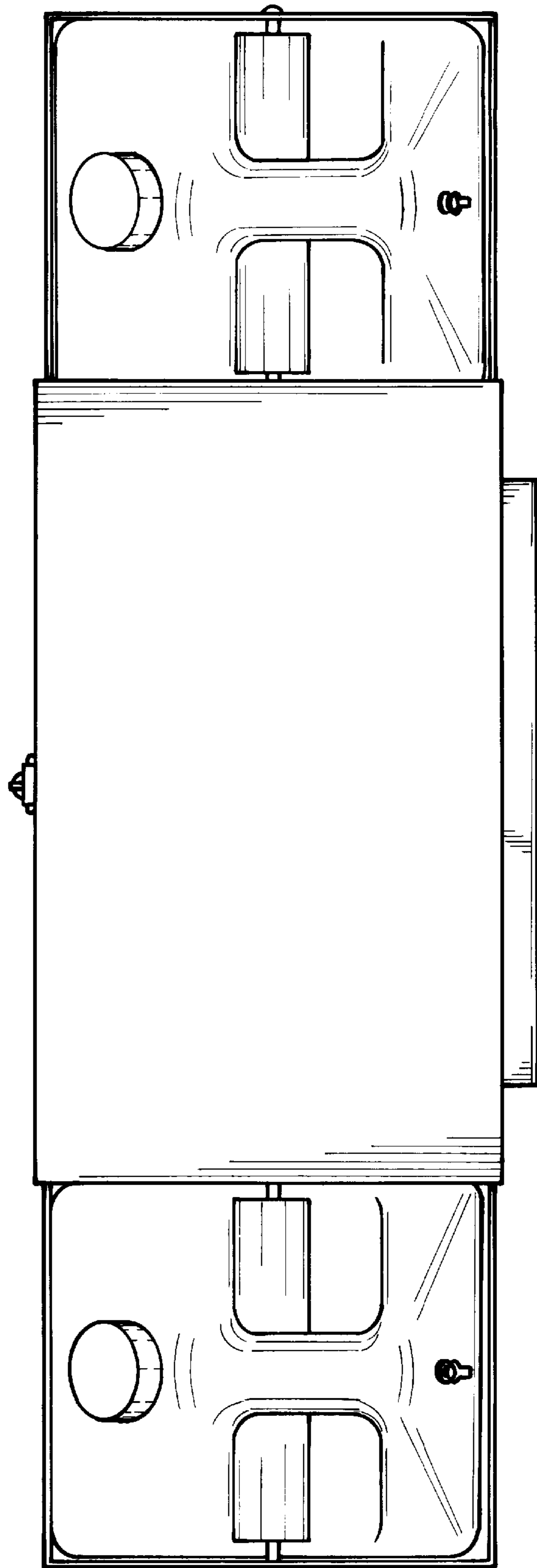

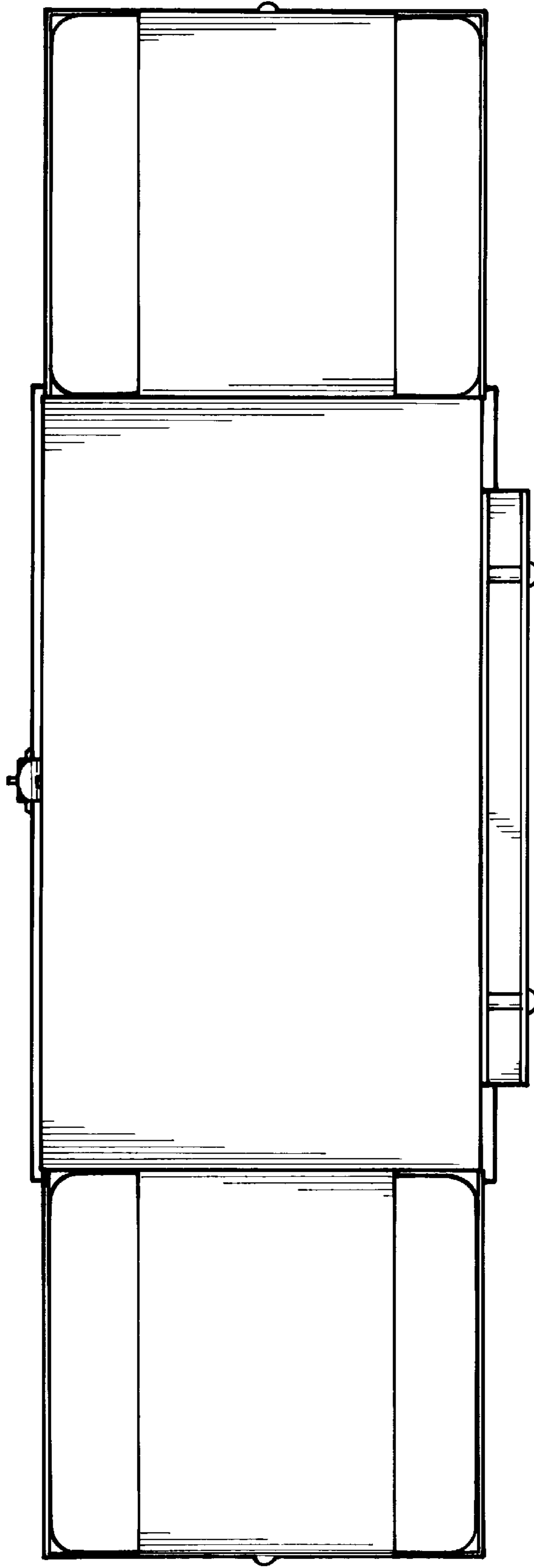
