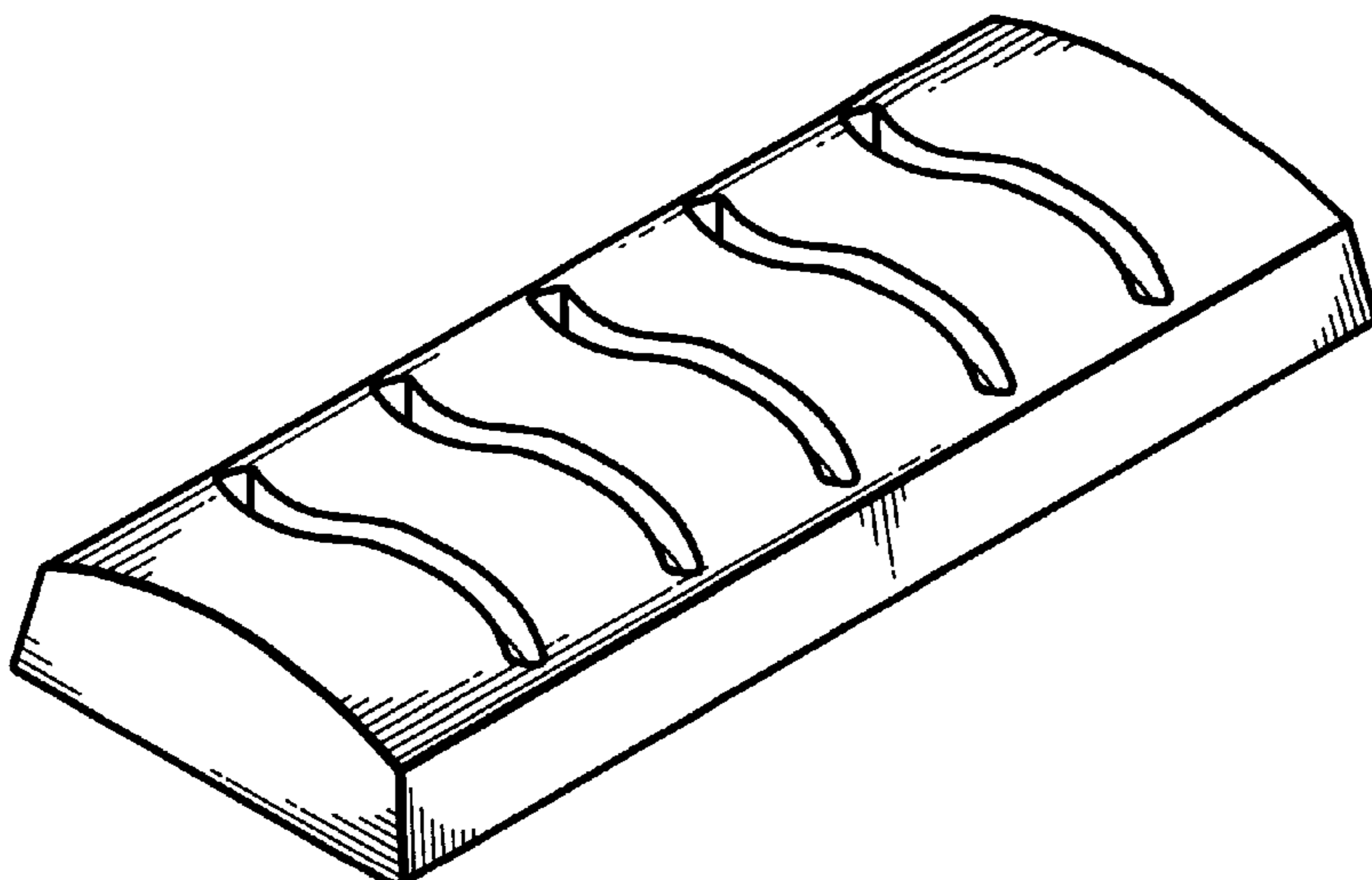
[57] **CLAIM**

We claim the ornamental design for a chocolate bar, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of our new chocolate bar;
 FIG. 2 is a top view thereof;
 FIG. 3 is a bottom view thereof;
 FIG. 4 is a front side view thereof, the back view being the same;
 FIG. 5 is a right side view thereof, the left side view being the same;
 FIG. 6 is a perspective view of a second embodiment of our new chocolate bar;
 FIG. 7 is a top view thereof;
 FIG. 8 is a bottom view thereof;
 FIG. 9 is a front side view thereof, the back view being the same; and,
 FIG. 10 is a right side view thereof, the left side view being the same.

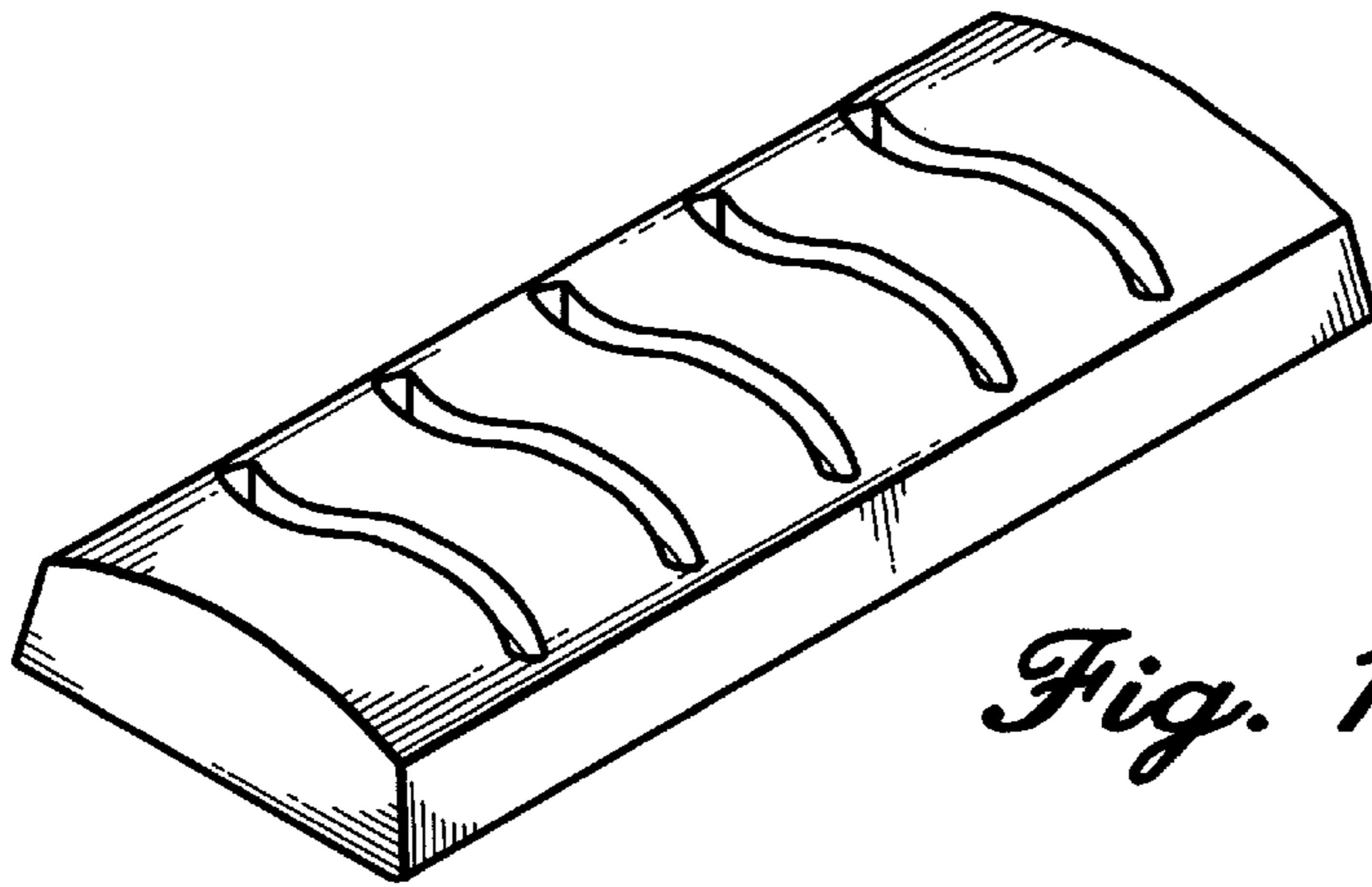

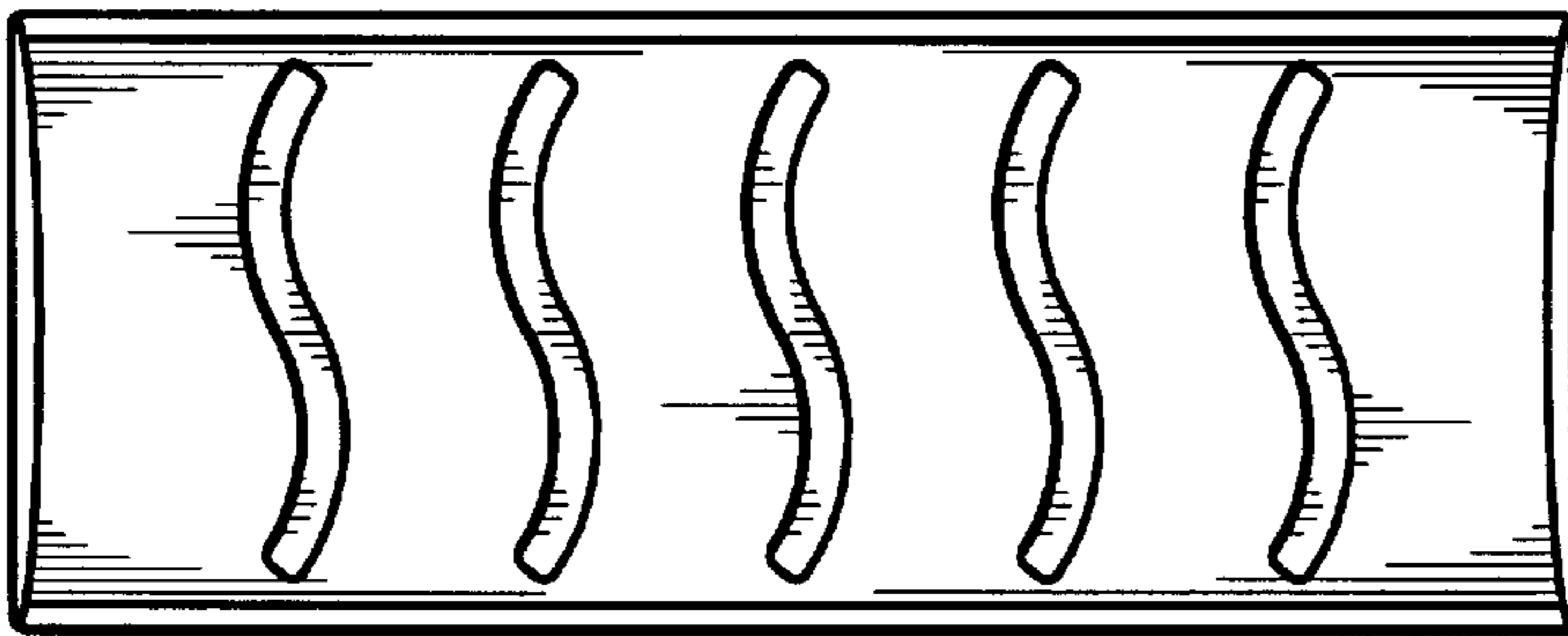

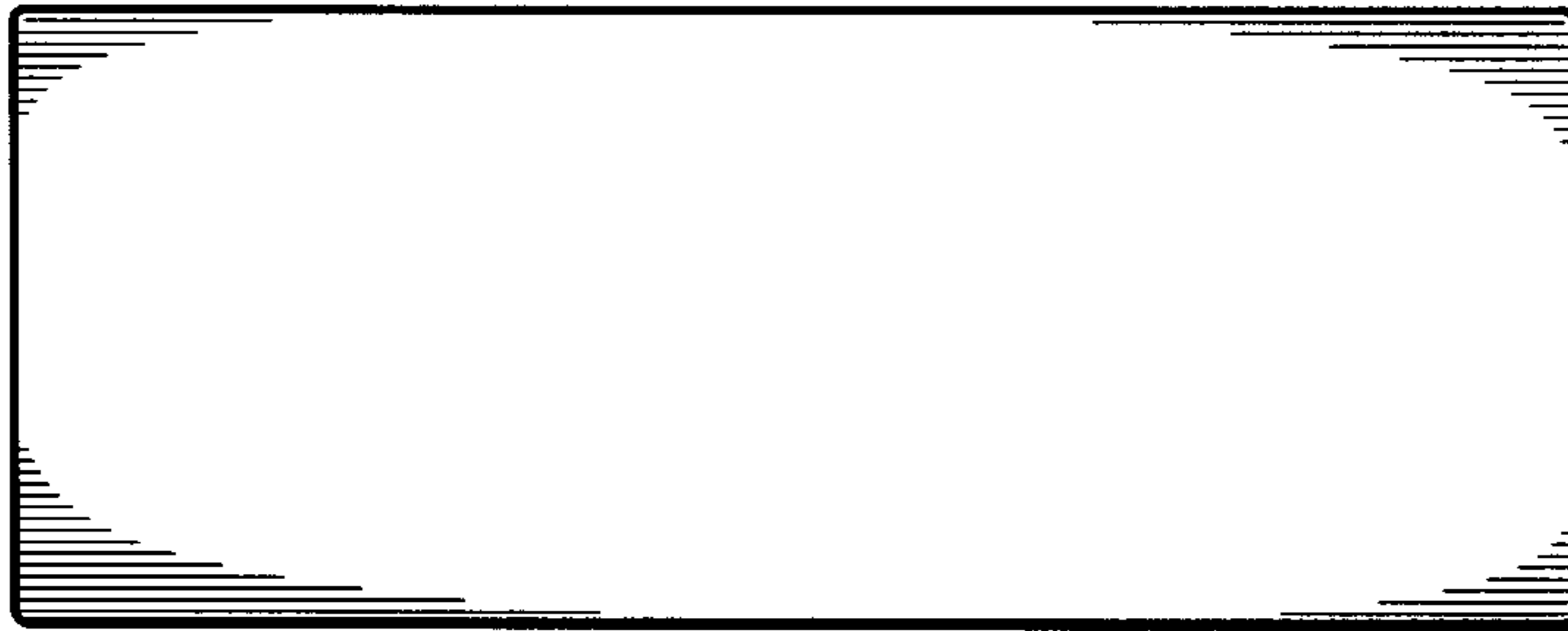

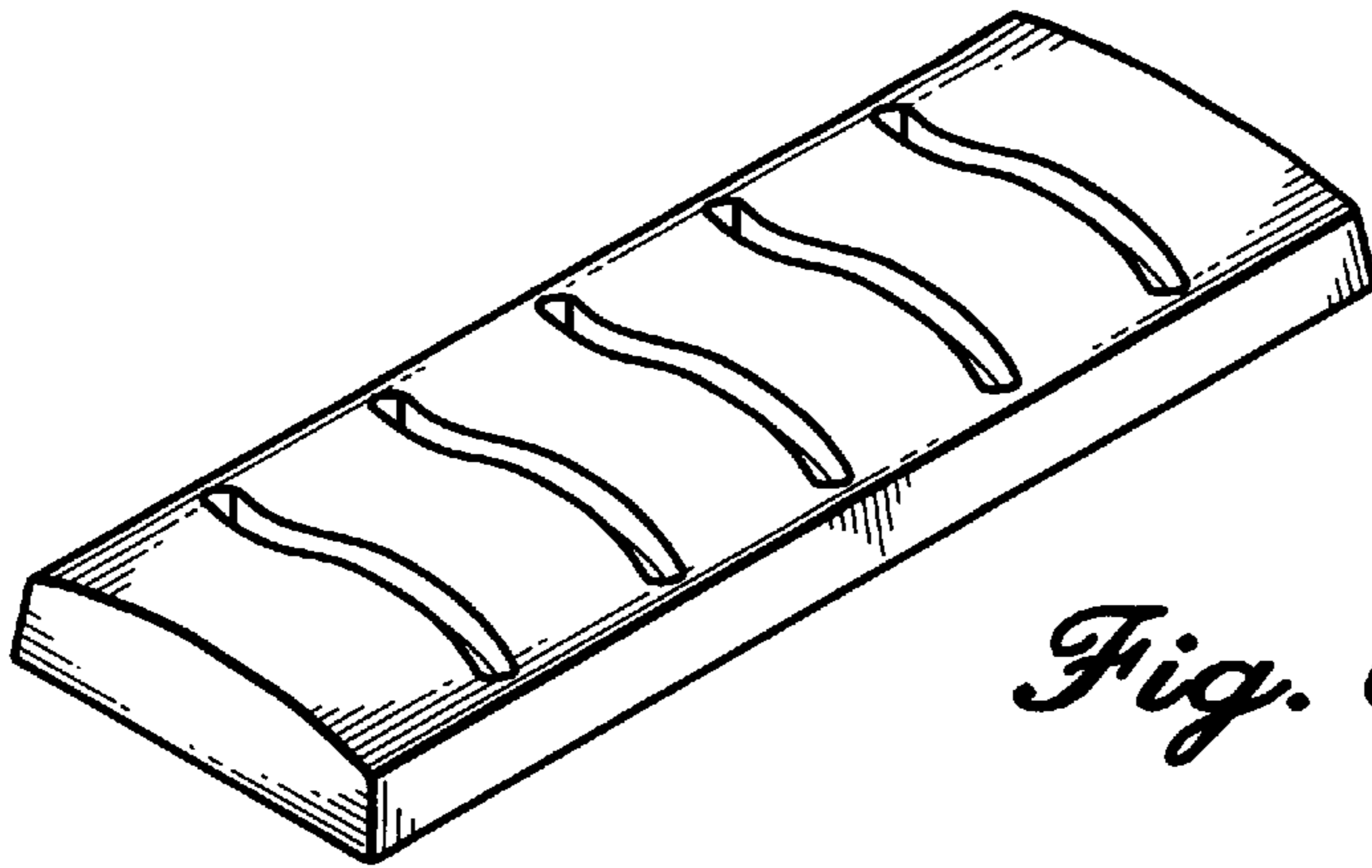

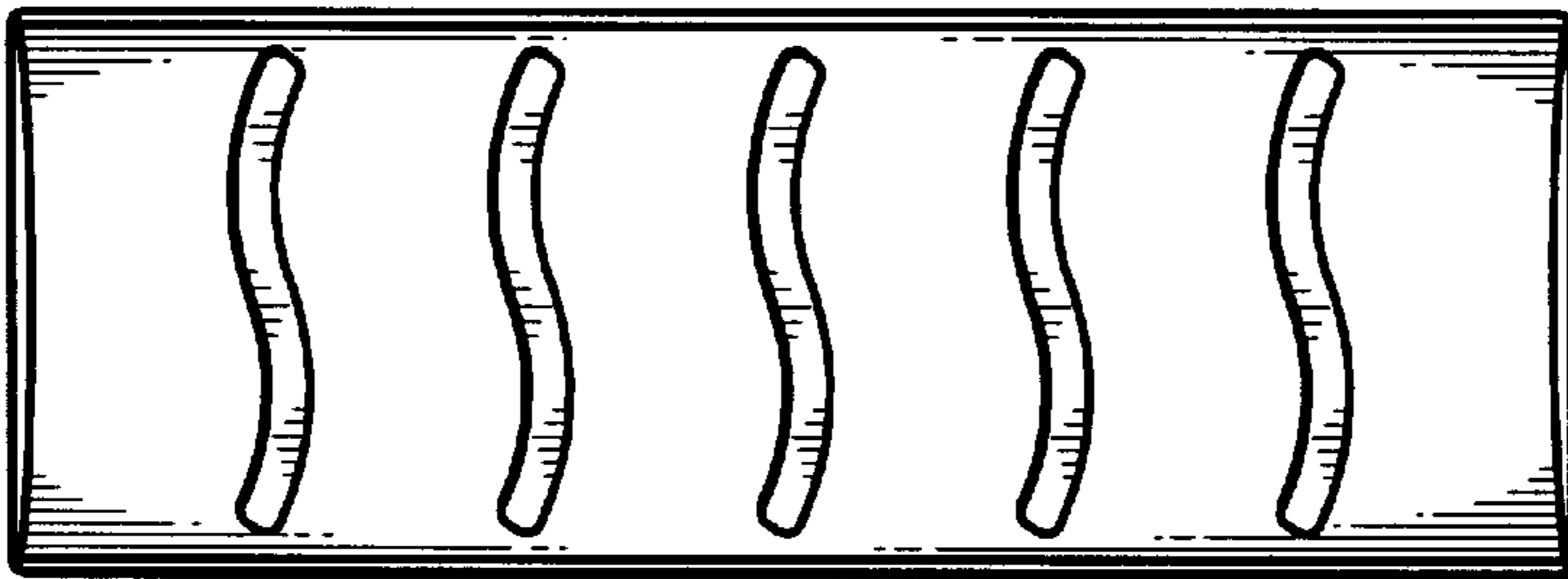

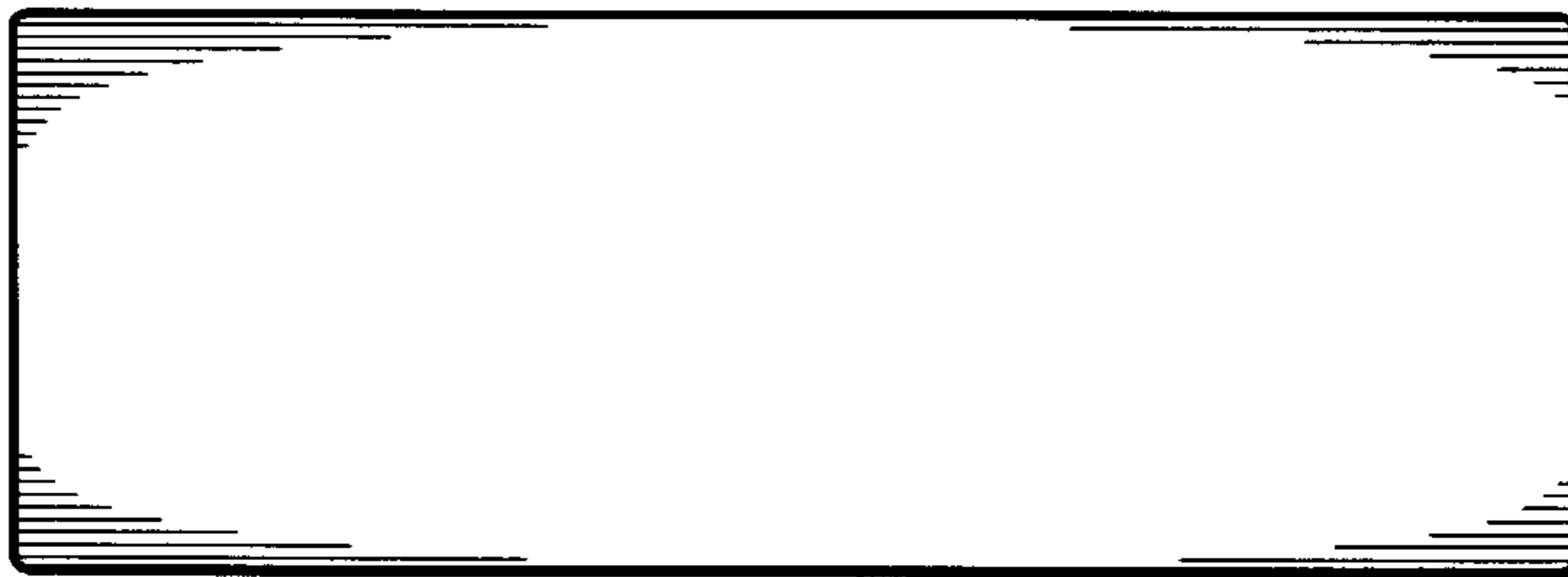
