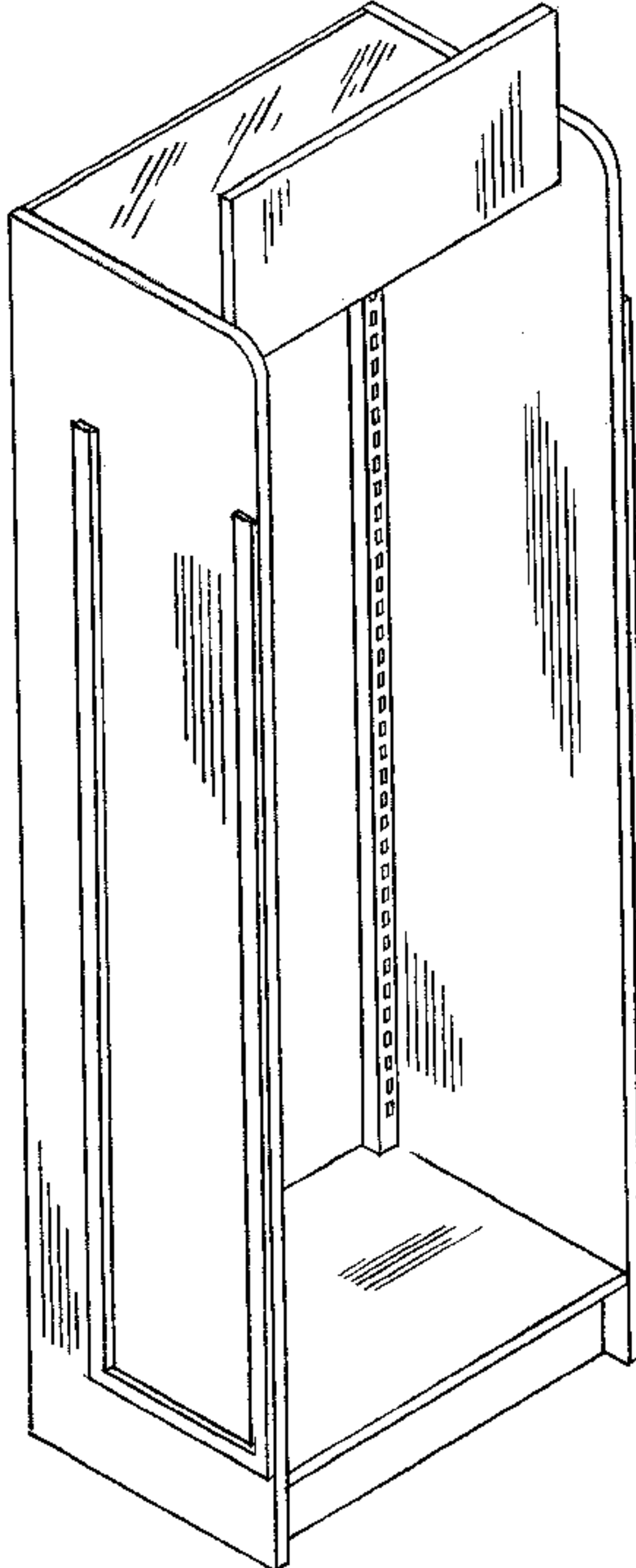
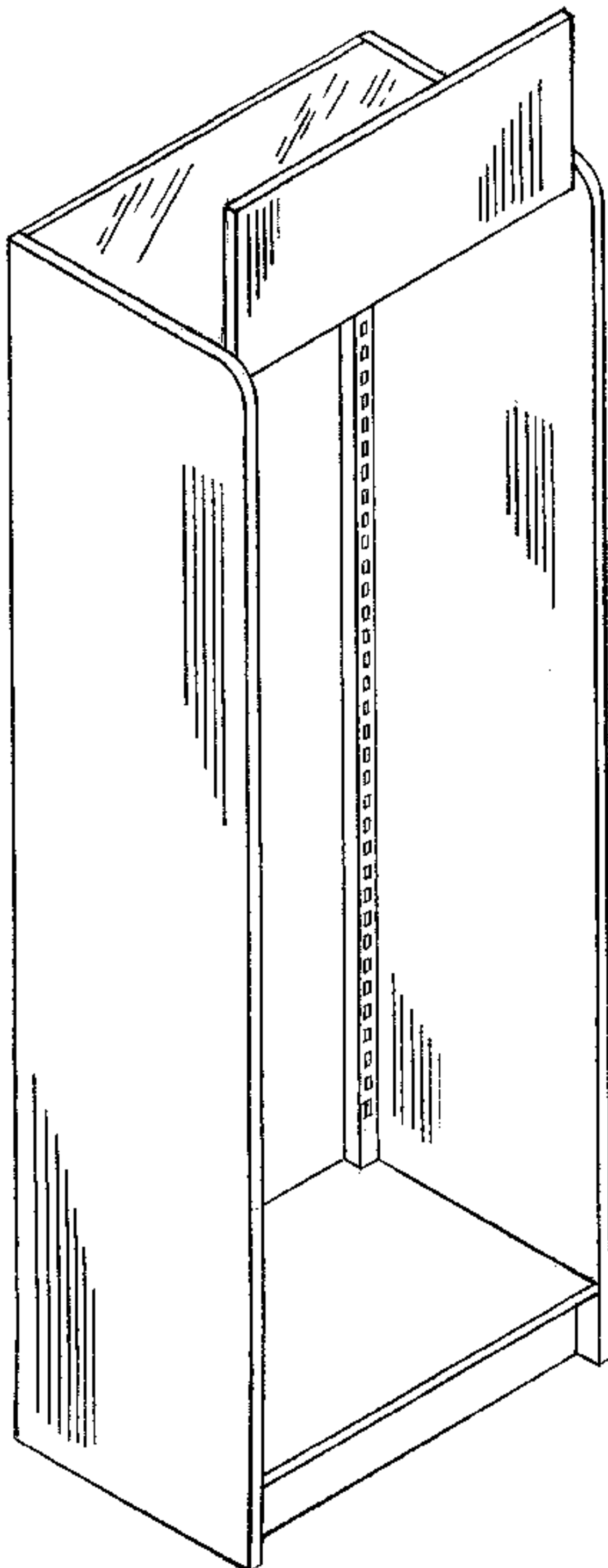
[57] **CLAIM**

The ornamental design for a hosiery display, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing my new design;
FIG. 2 is a front and left side perspective view of a second embodiment of my new design, the front and right side perspective view being a mirror image;
FIG. 3 is a front and left side perspective view of a third embodiment of my new design, the front and right side perspective view being a mirror image;
FIG. 4 is a front and left side perspective view of a fourth embodiment of my new design, the front and right side perspective view being a mirror image;
FIG. 5 is a front elevtional view of FIG. 1;
FIG. 6 is a top view of FIGS. 2 and 4 on a reduced scale;
FIG. 7 is a bottom view of FIG. 6;
FIG. 8 is a right side elevational view of FIG. 4 on a reduced scale;
FIG. 9 is a rear view of FIG. 6;
FIG. 10 is a left side elevational view of FIG. 4 on a reduced scale;
FIG. 11 is a top view of FIGS. 1 and 3 on a reduced scale;
FIG. 12 is a bottom view of FIG. 11;
FIG. 13 is a right side elevational view of FIGS. 1 and 3 on a reduced scale;
FIG. 14 is a rear view of FIG. 11; and,
FIG. 15 is a left side elevational view of FIGS. 1 and 3 on a reduced scale.
The right and left side view of the second embodiment are substantially the same as the fourth embodiment, shown in FIGS. 8 and 10.
The broken lines shown in the drawing are for illustrative purposes only and form no part of the claimed design.

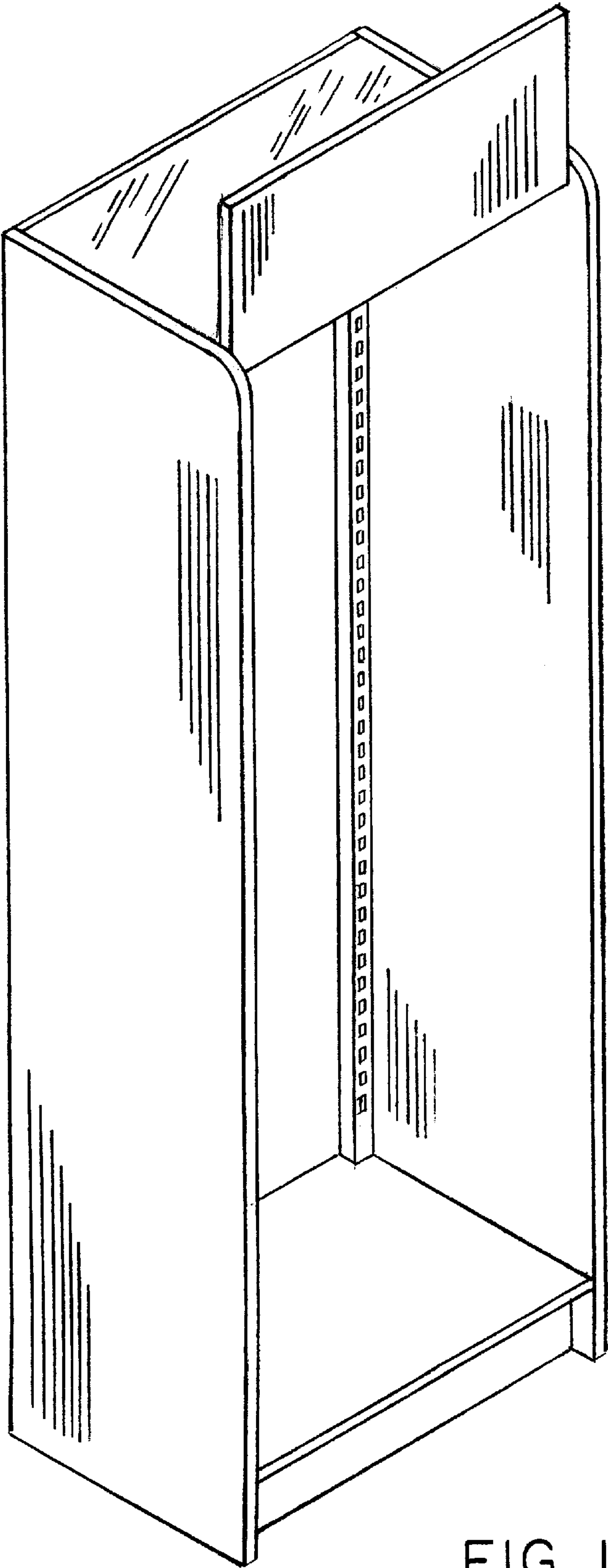

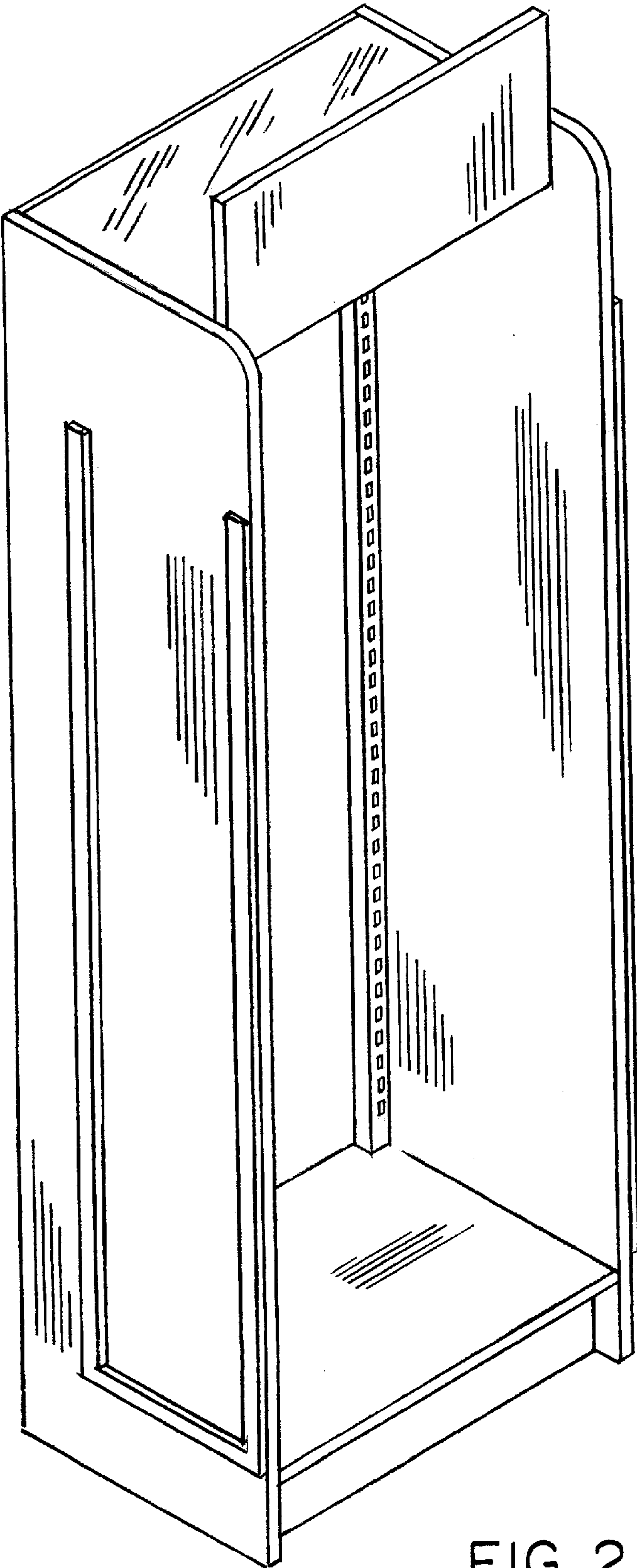

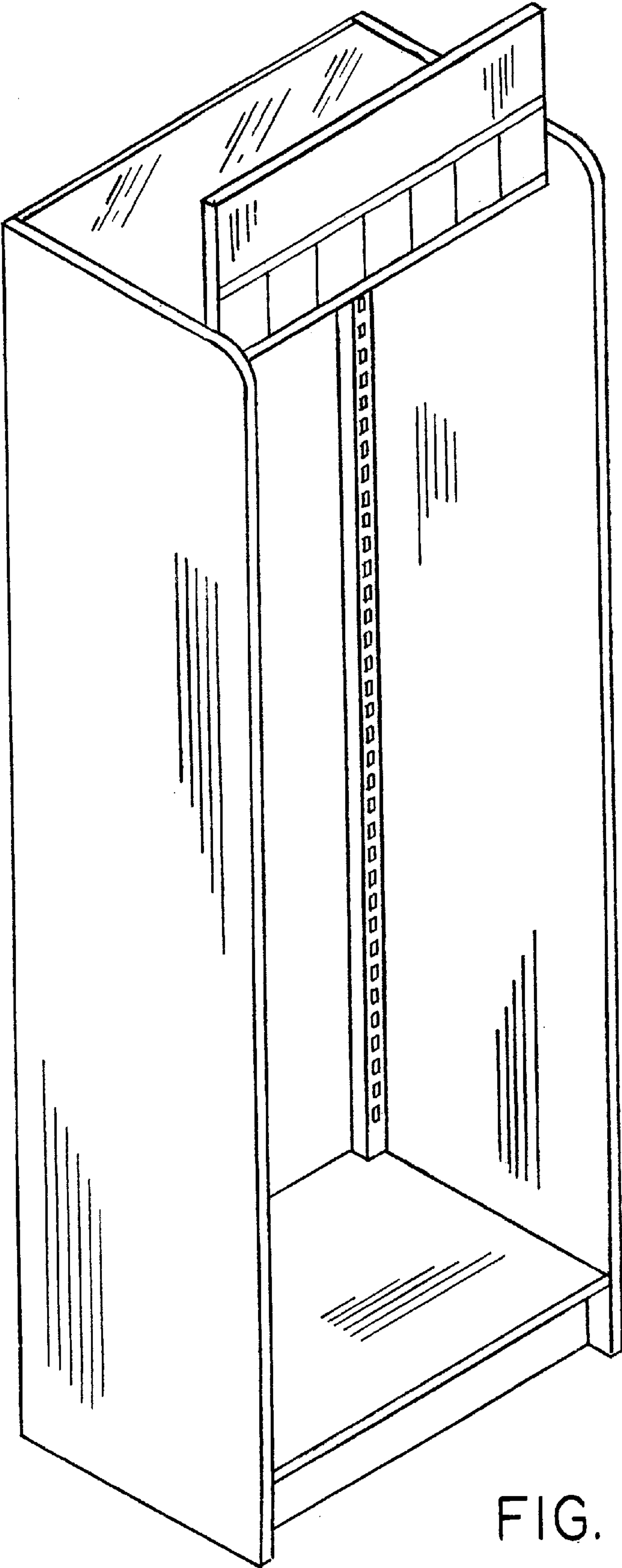

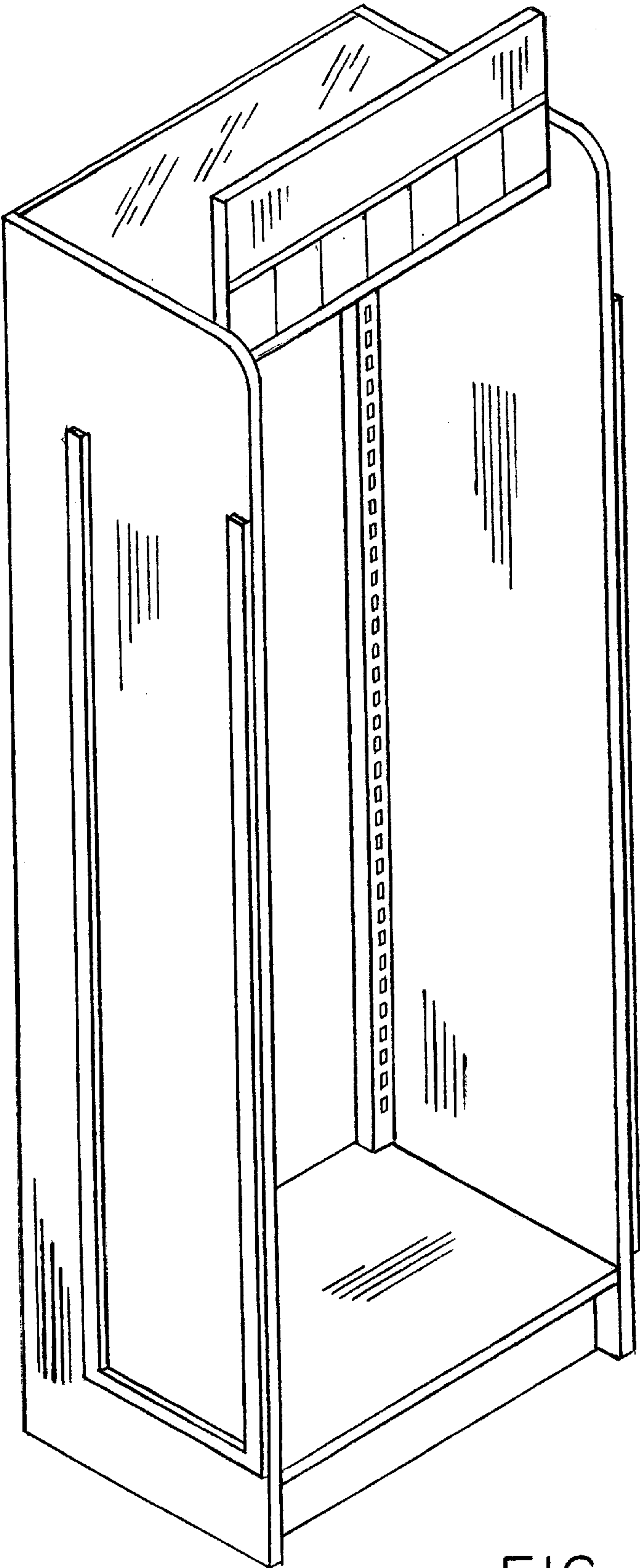

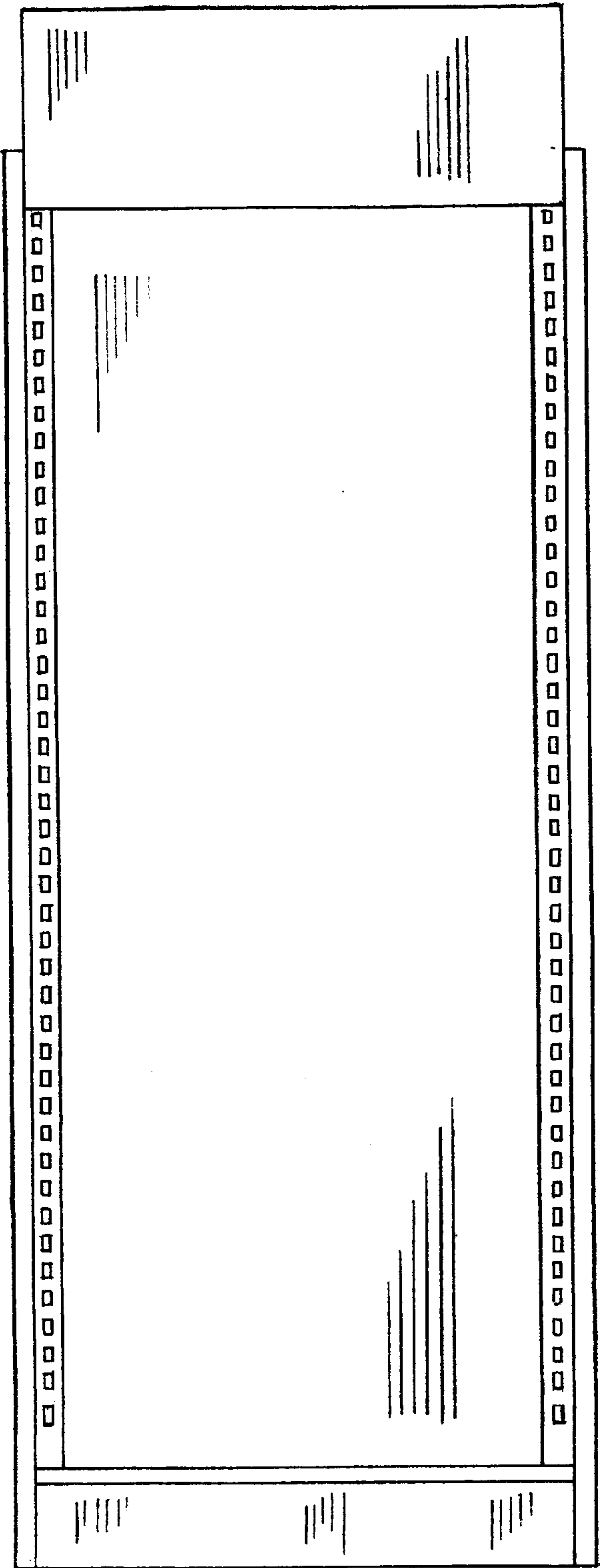

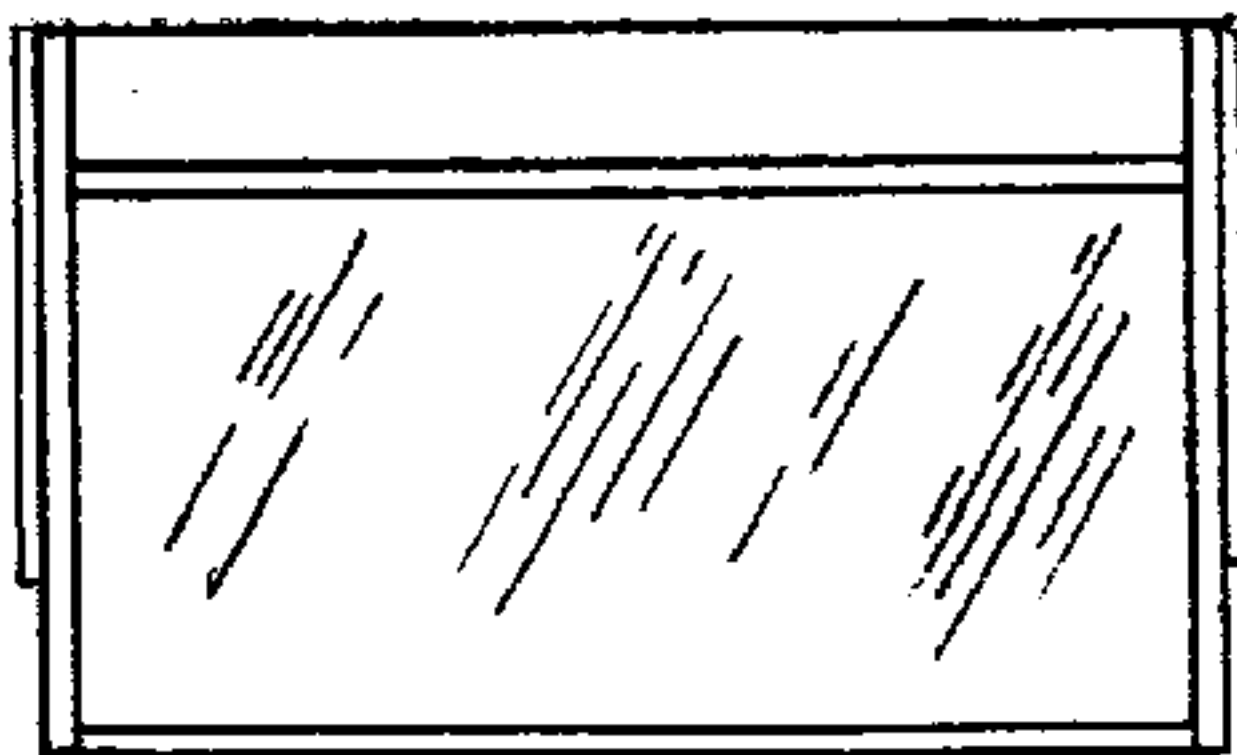

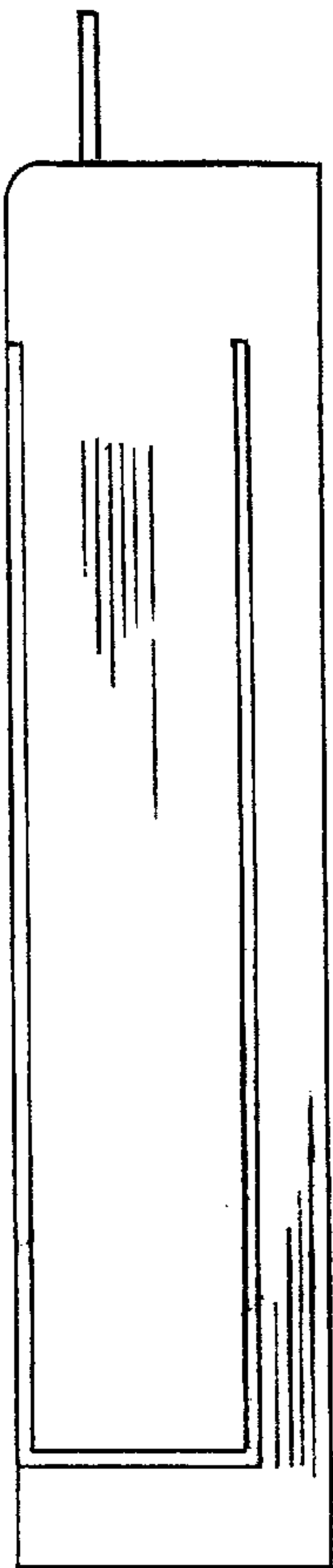

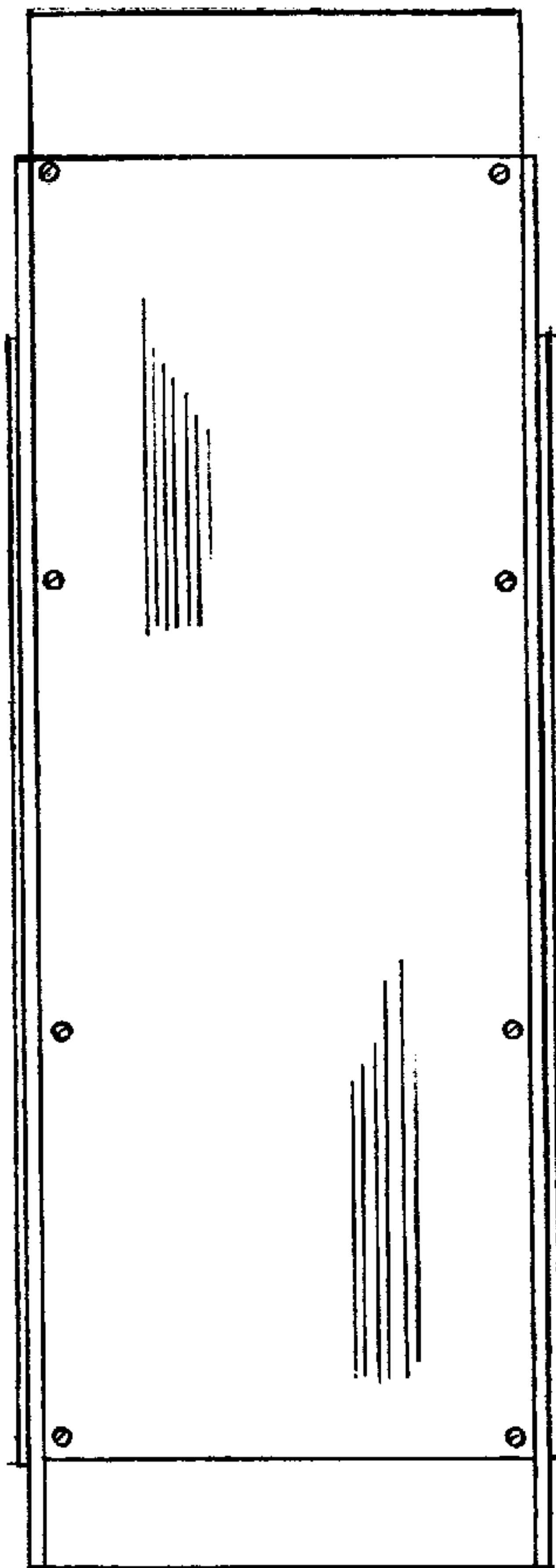

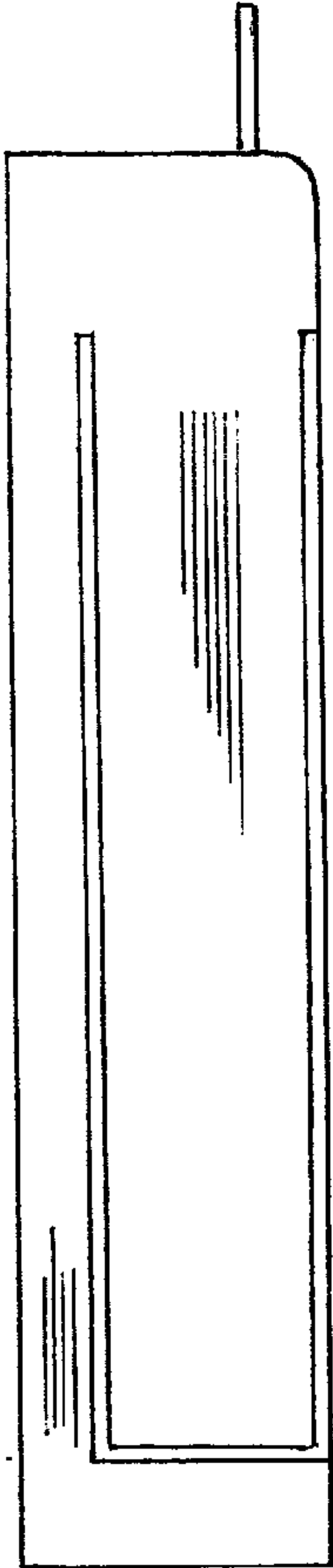

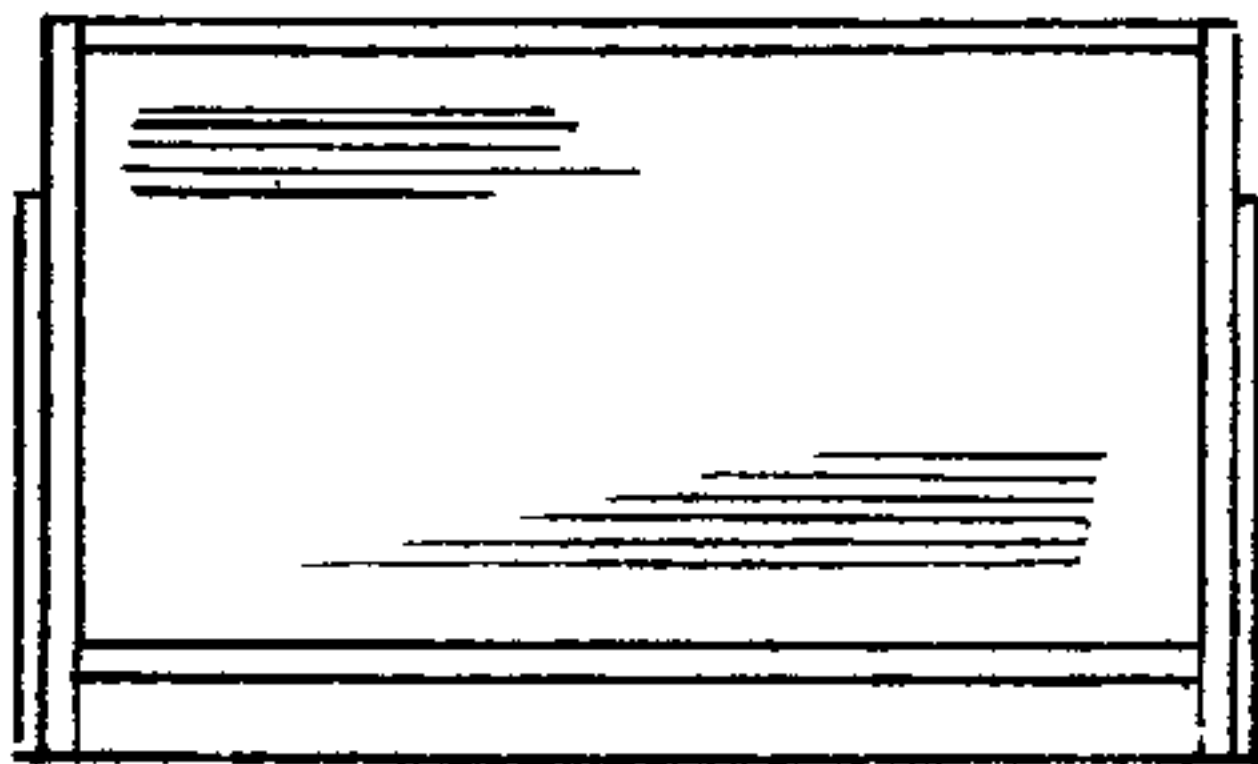

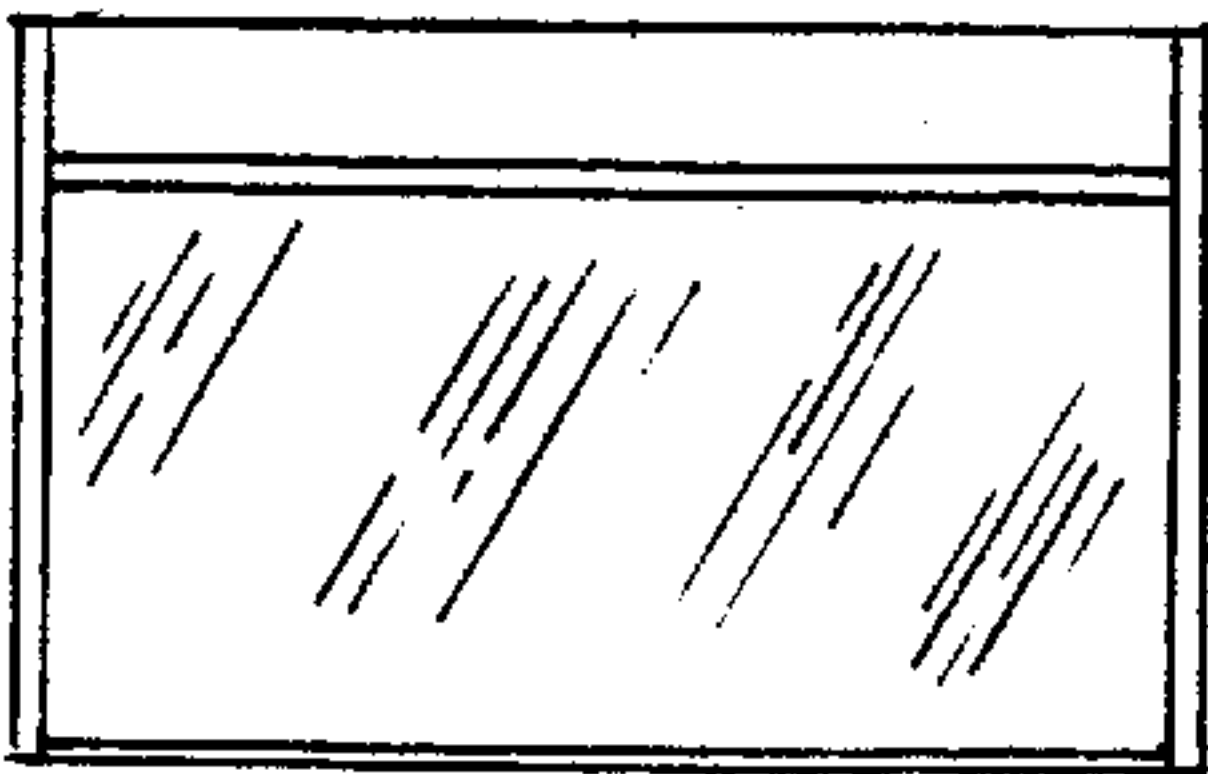

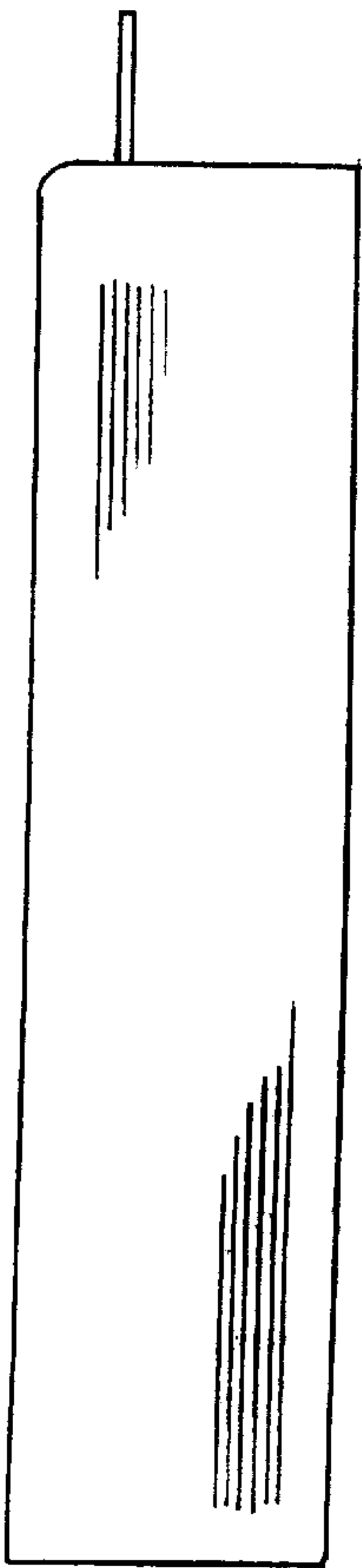

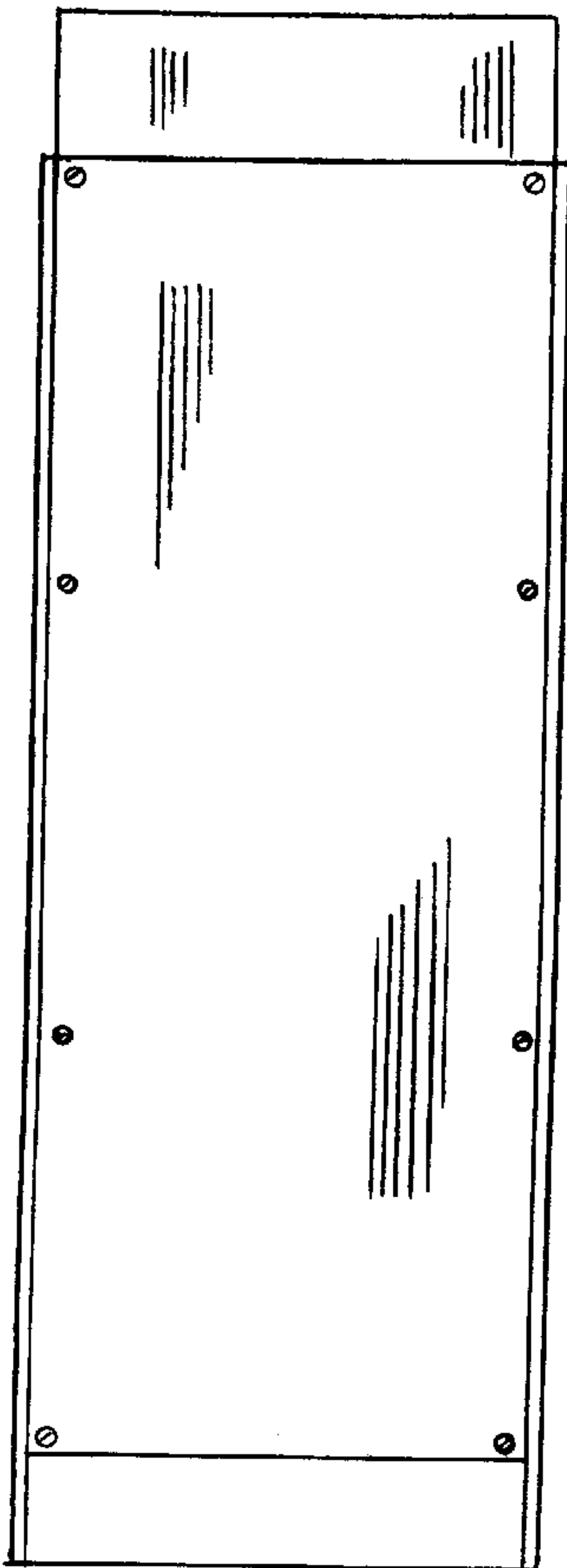

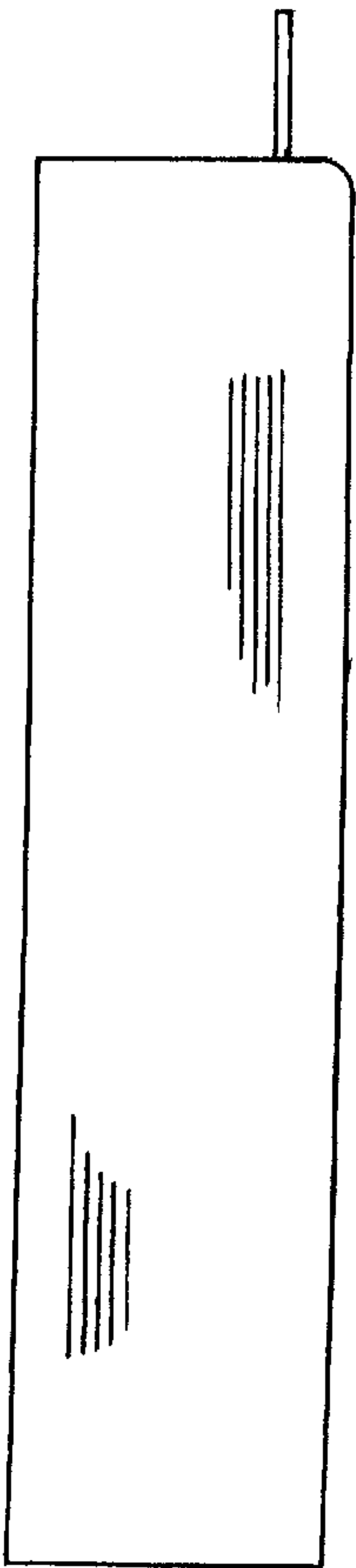

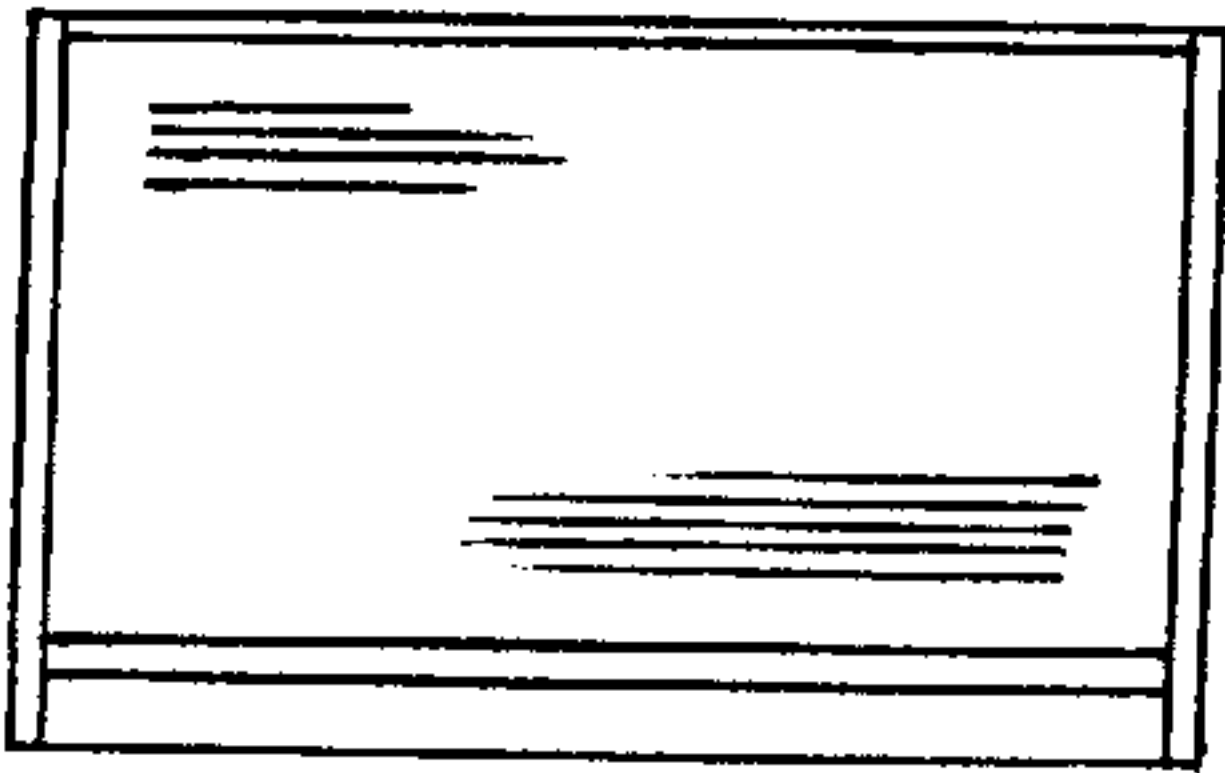
