[57] **CLAIM**

The ornamental design for a rechargeable battery, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a rechargeable battery showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a right side elevational view thereof; and FIG. 7 is a rear elevational view thereof; FIG. 8 is a perspective view of a second embodiment of a rechargeable battery showing my new design; FIG. 9 is a top plan view thereof; FIG. 10 is a left side elevational view thereof; FIG. 11 is a front elevational view thereof; FIG. 12 is a bottom plan view thereof; FIG. 13 is a right side elevational view thereof; and, FIG. 14 is a rear elevational view thereof.

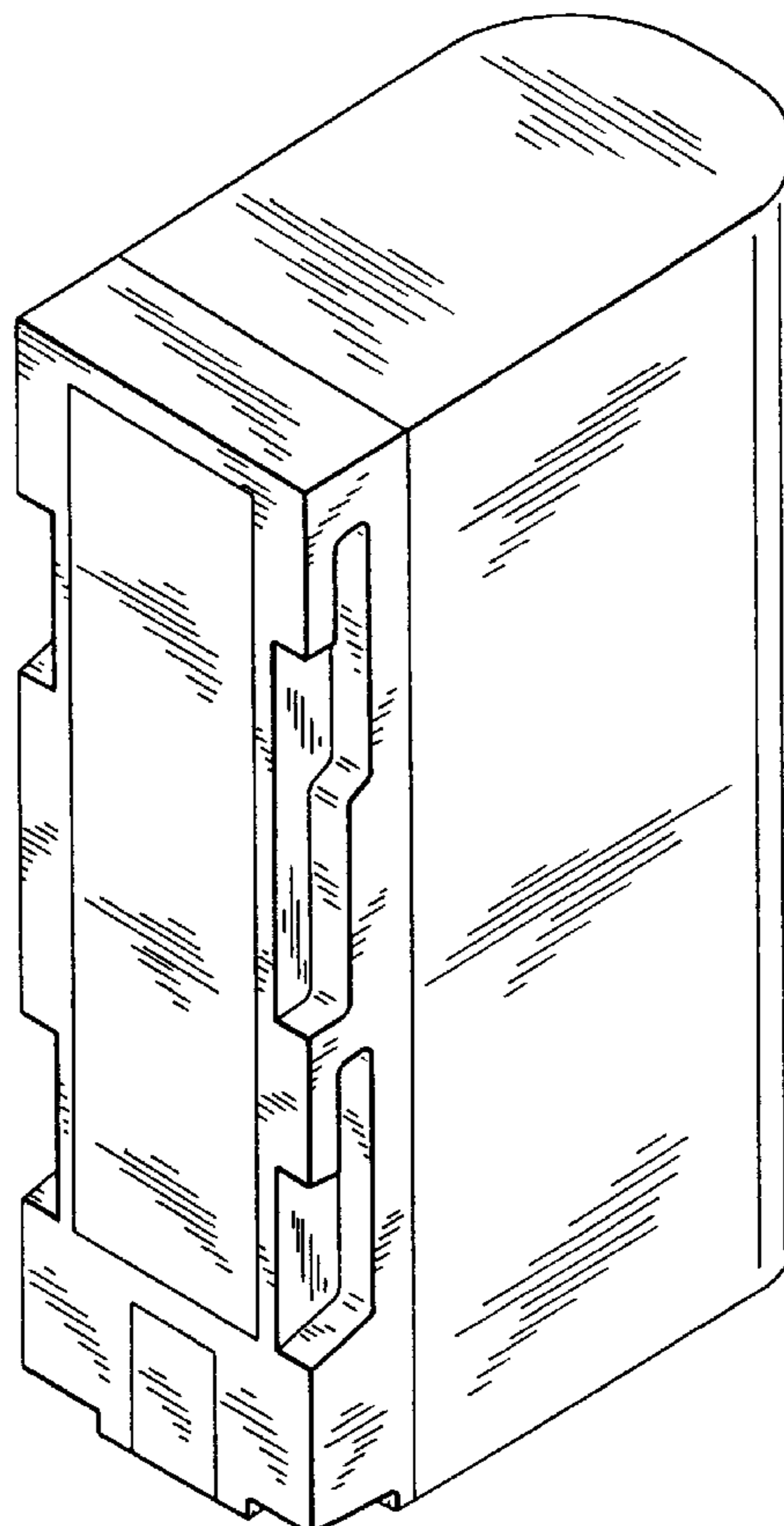

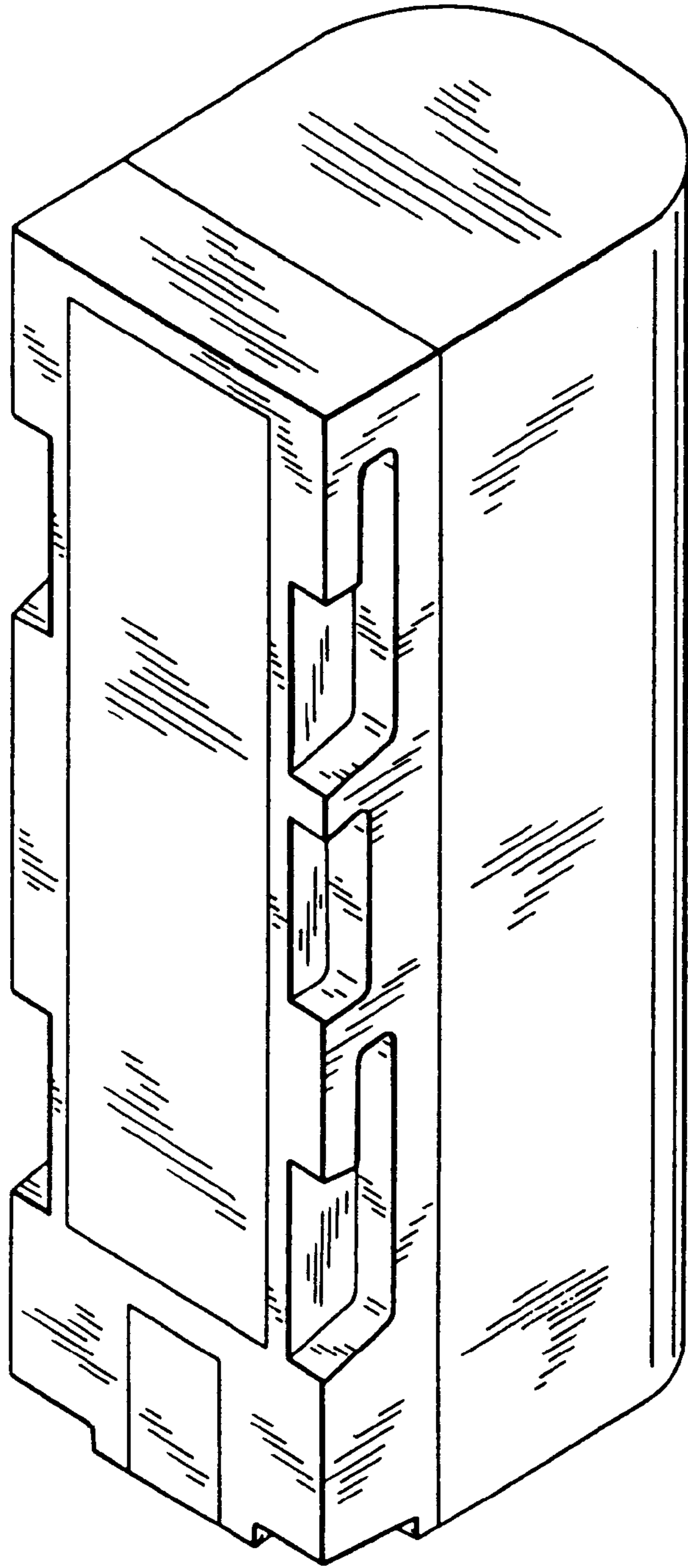

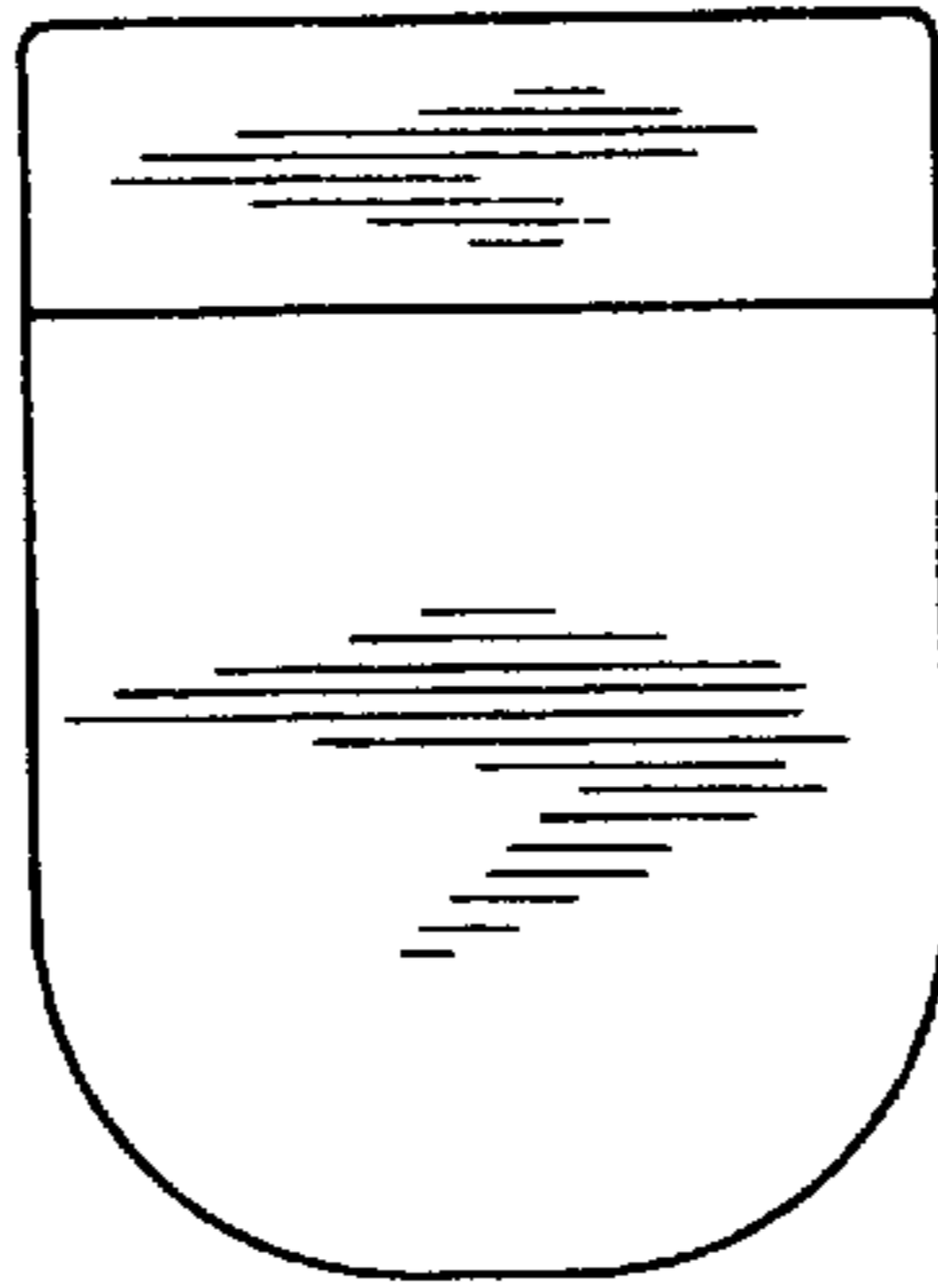

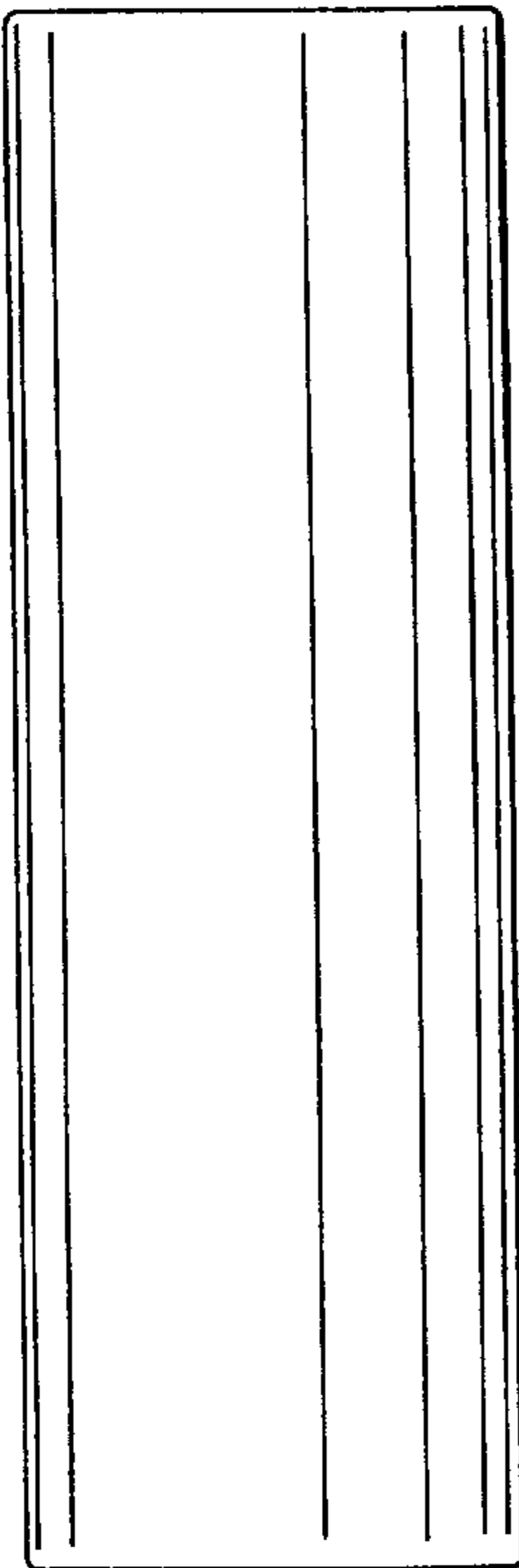

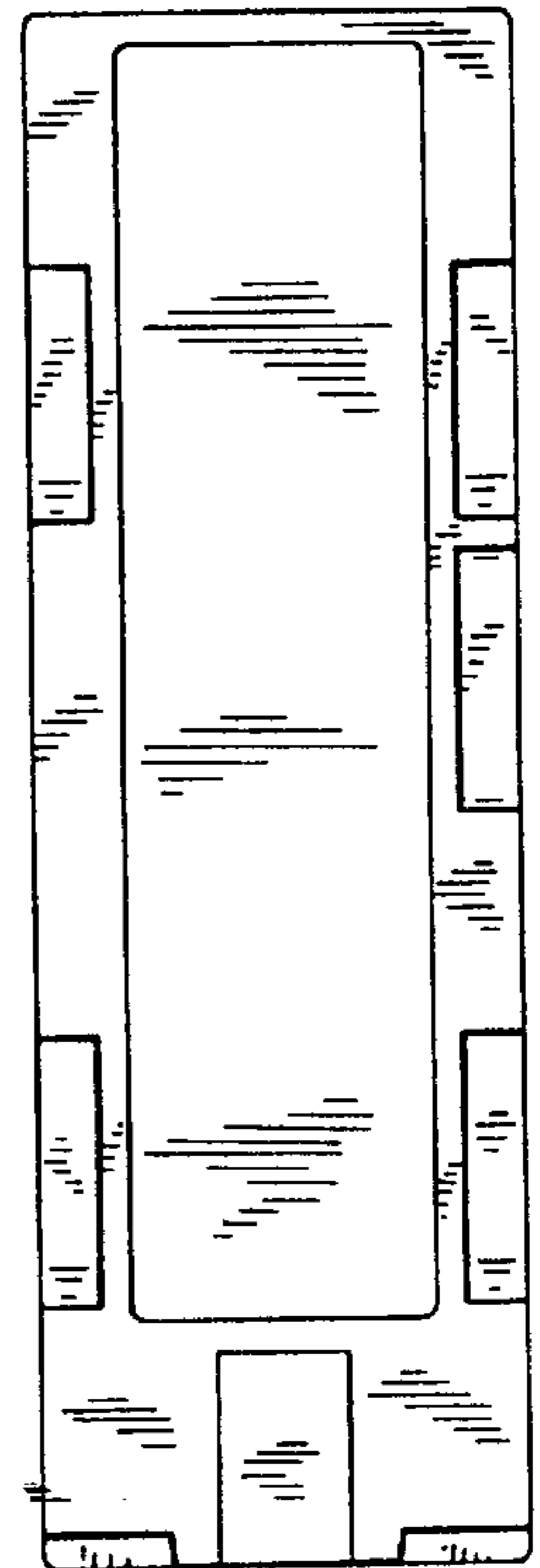

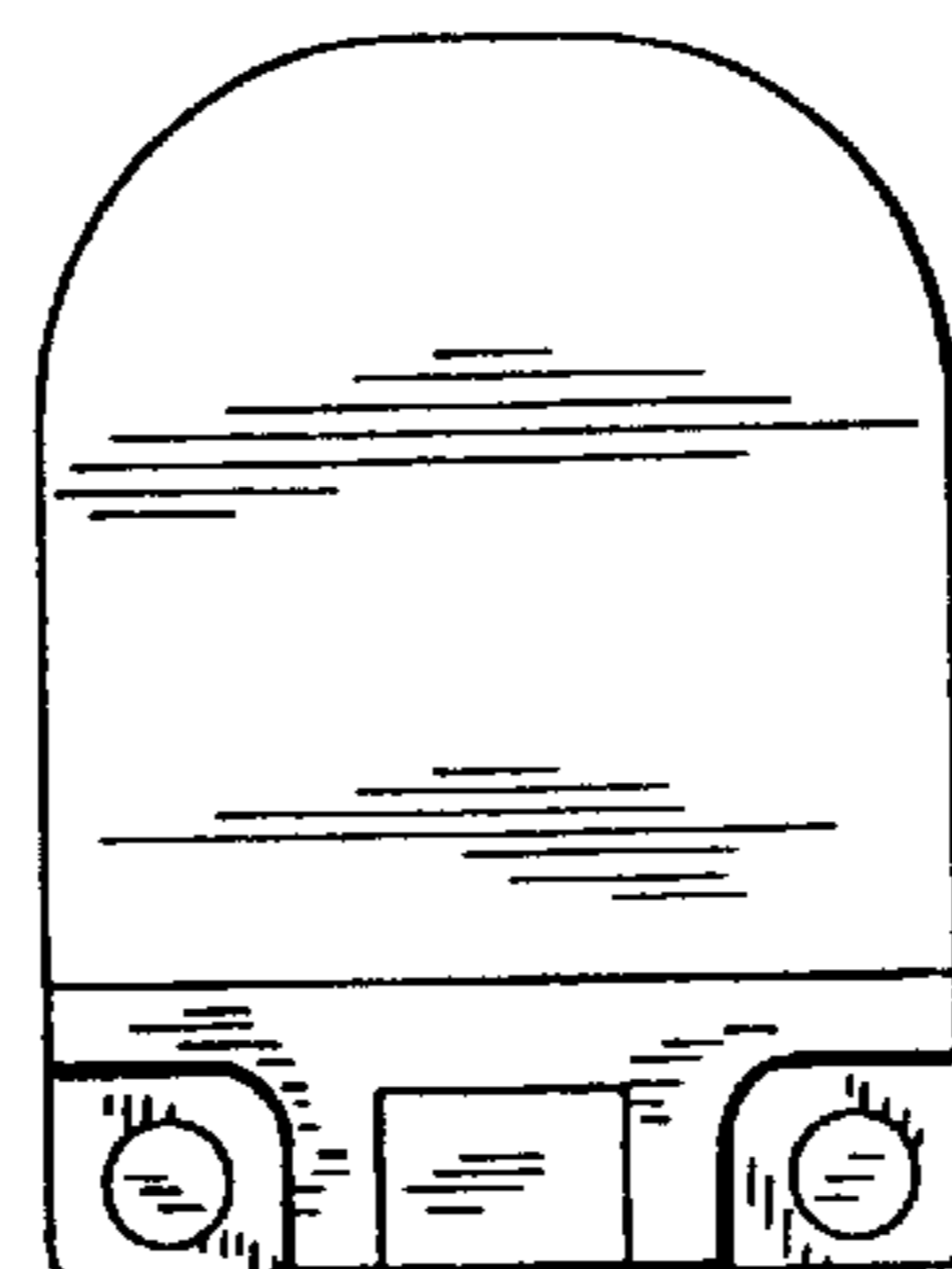

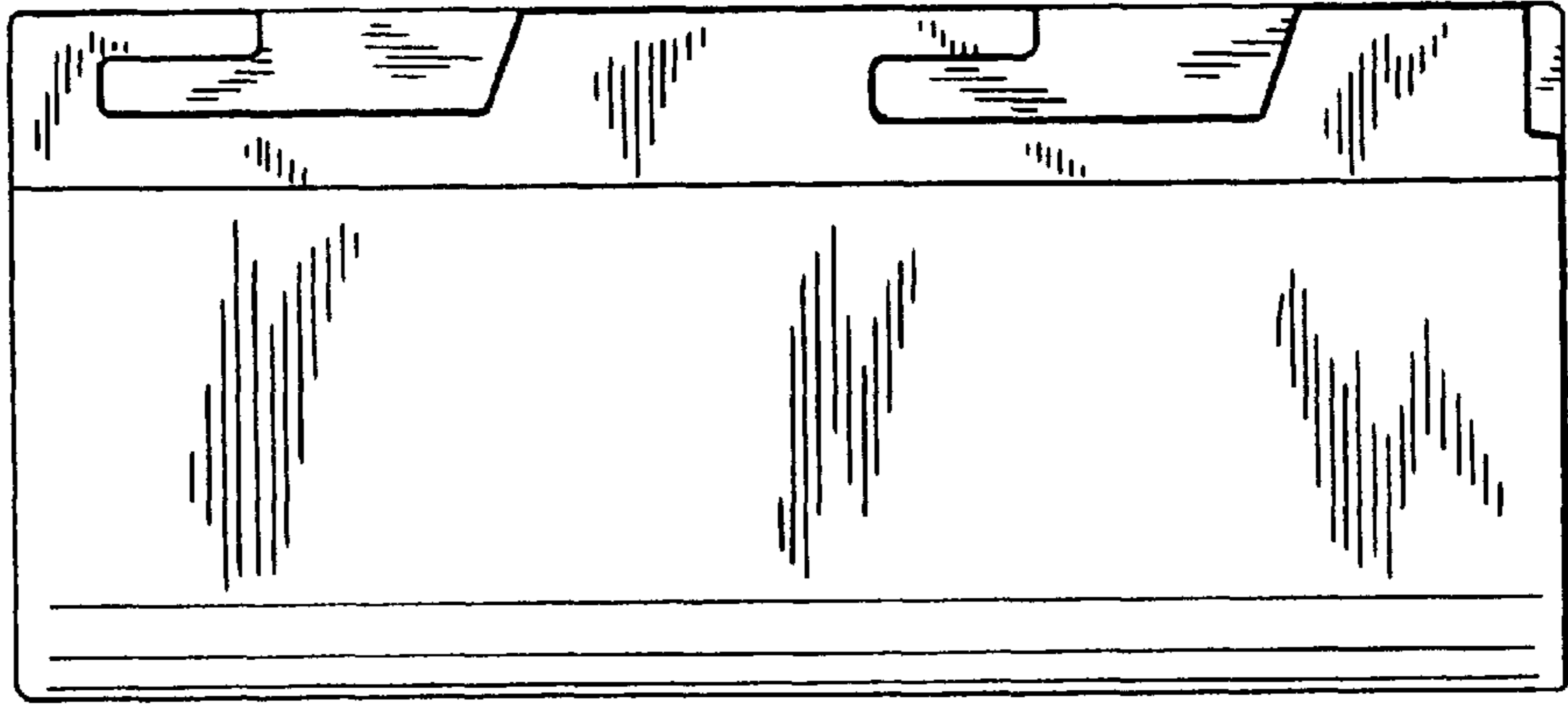

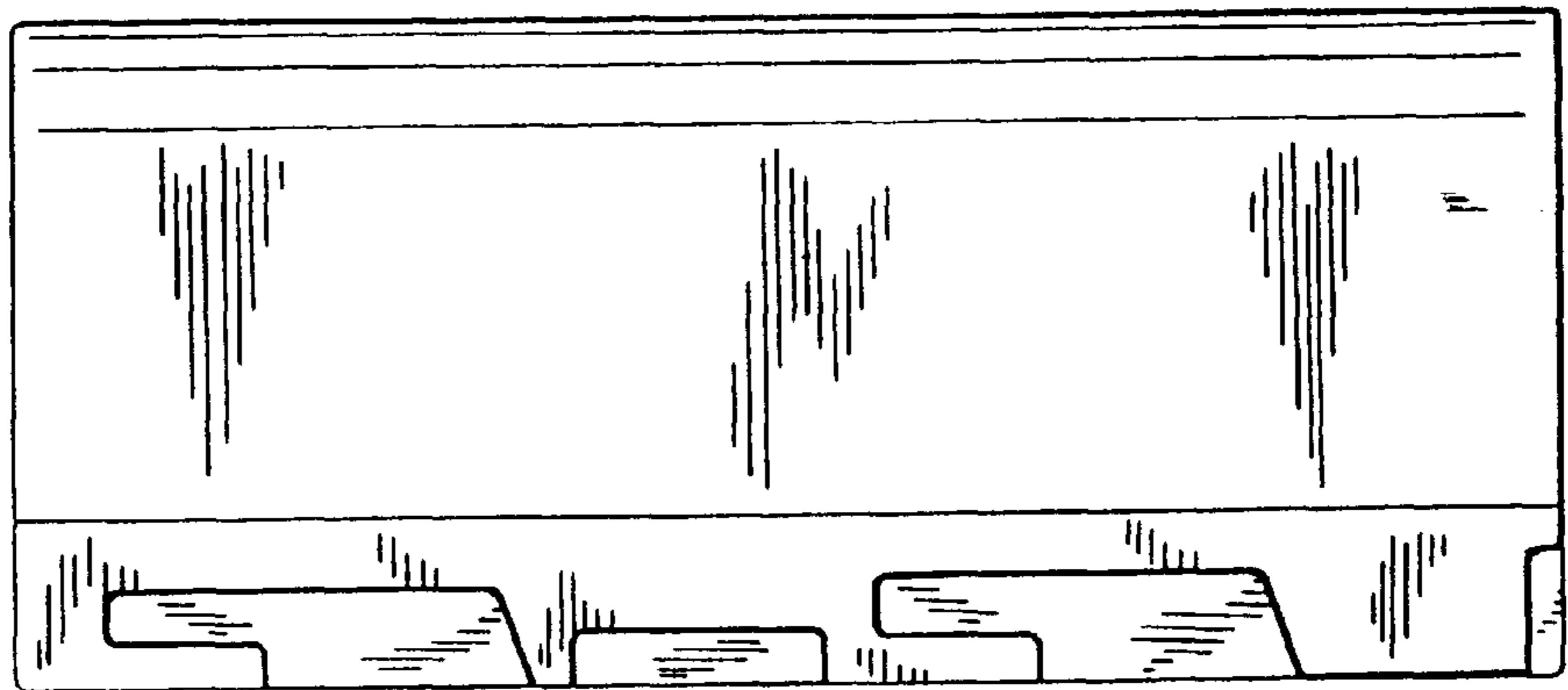

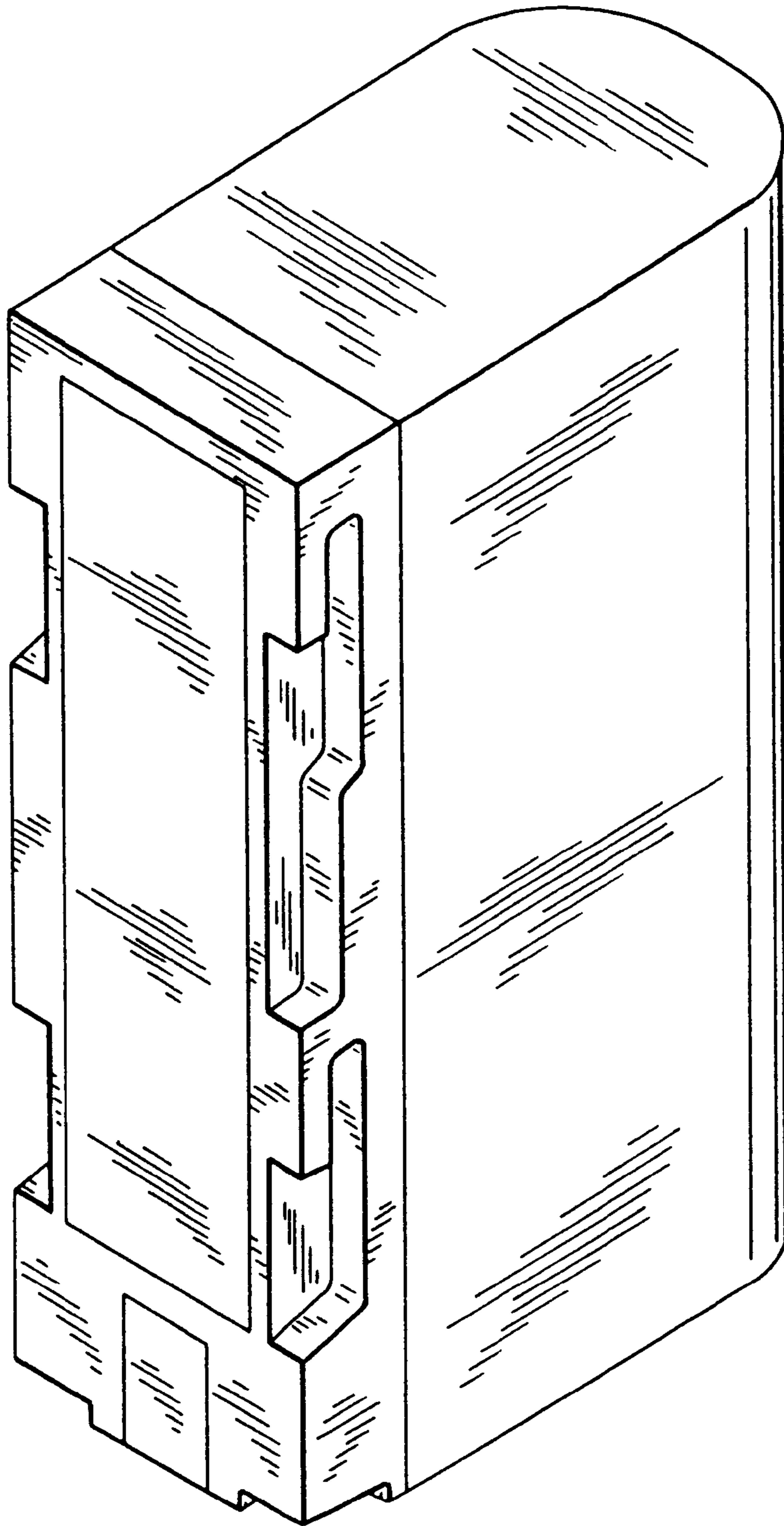

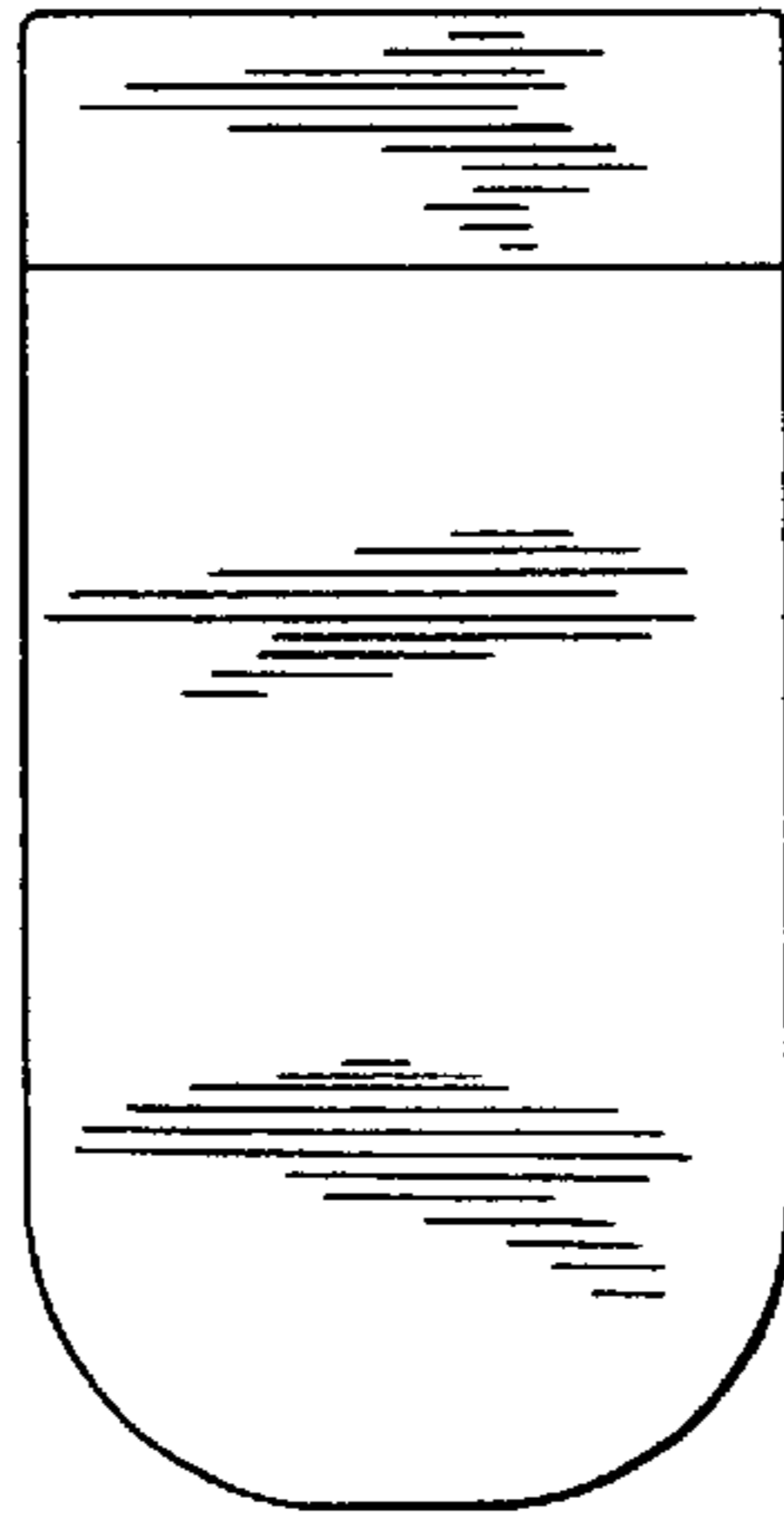

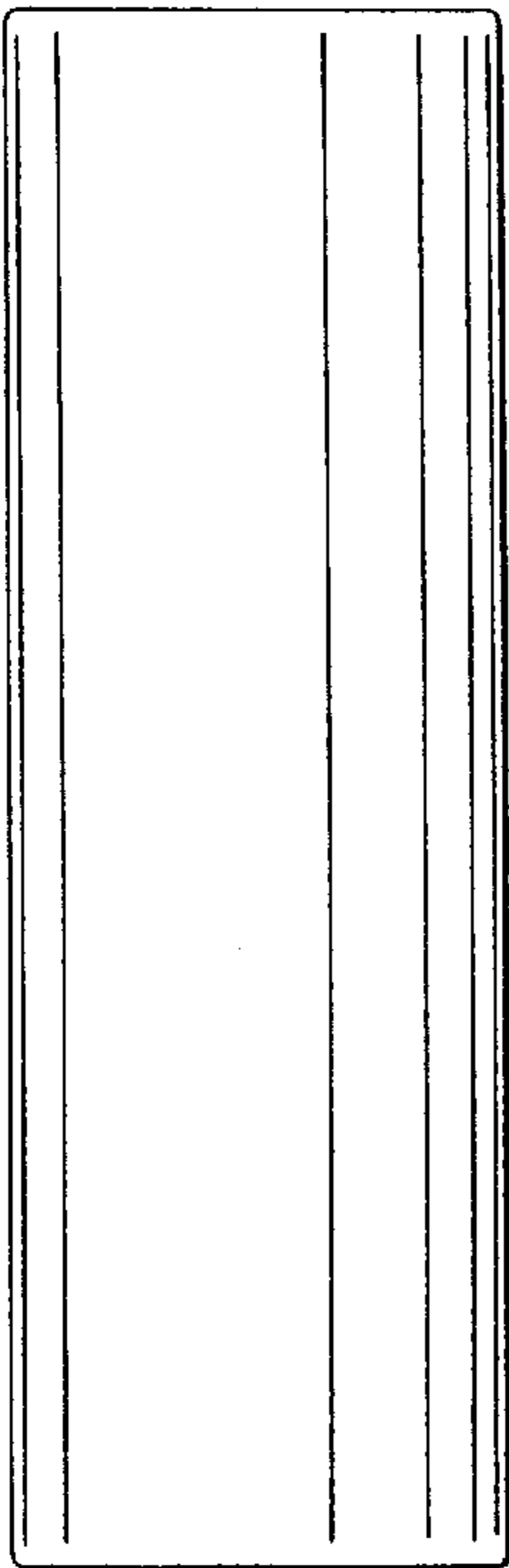

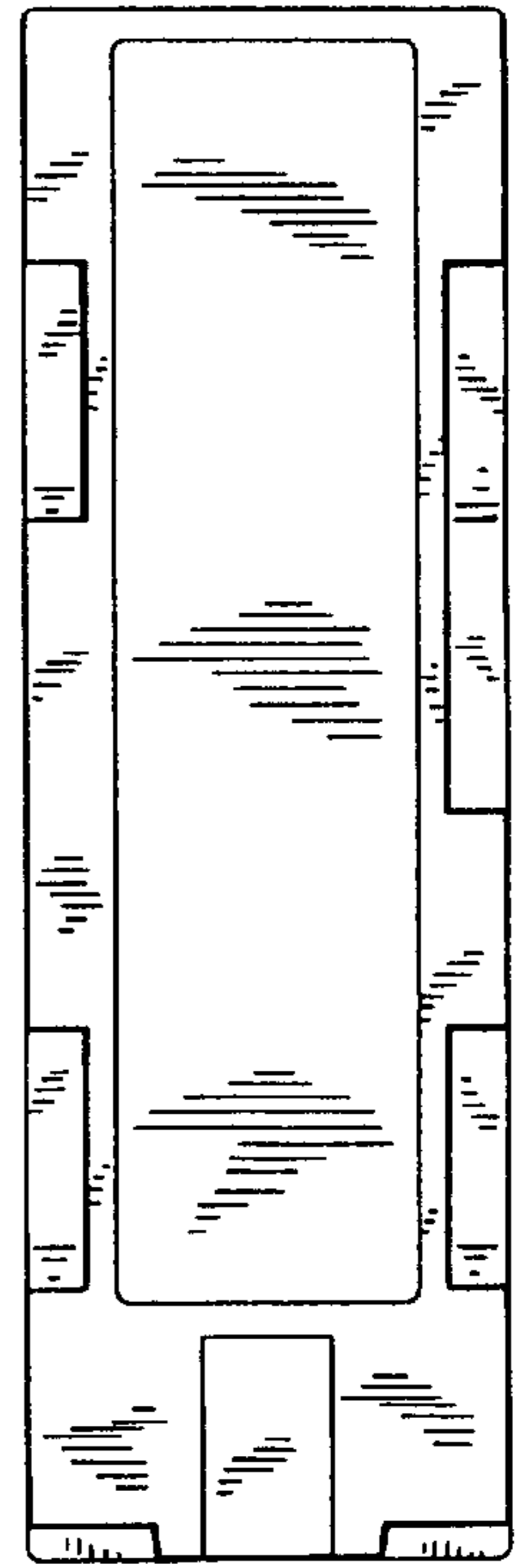

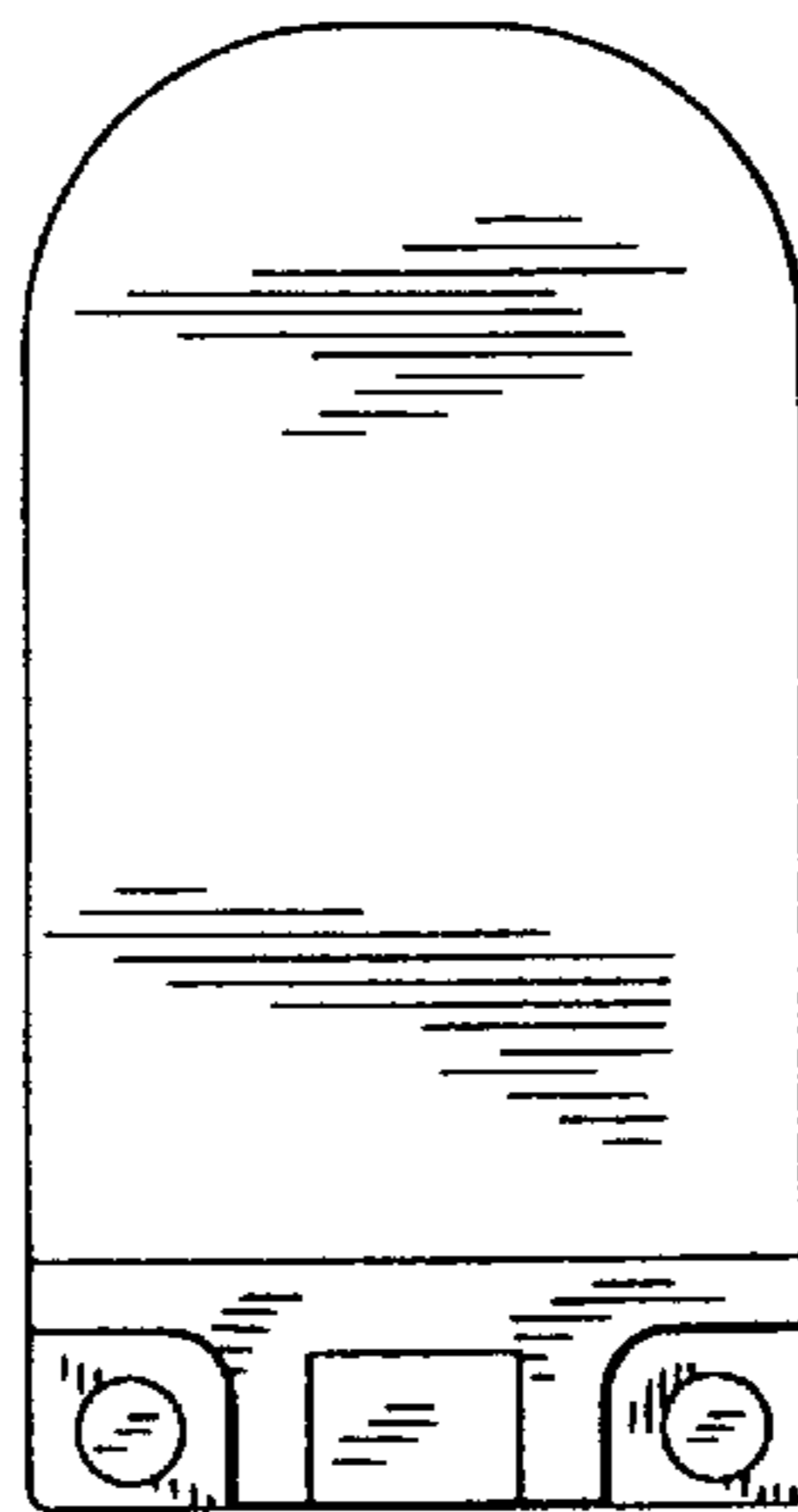

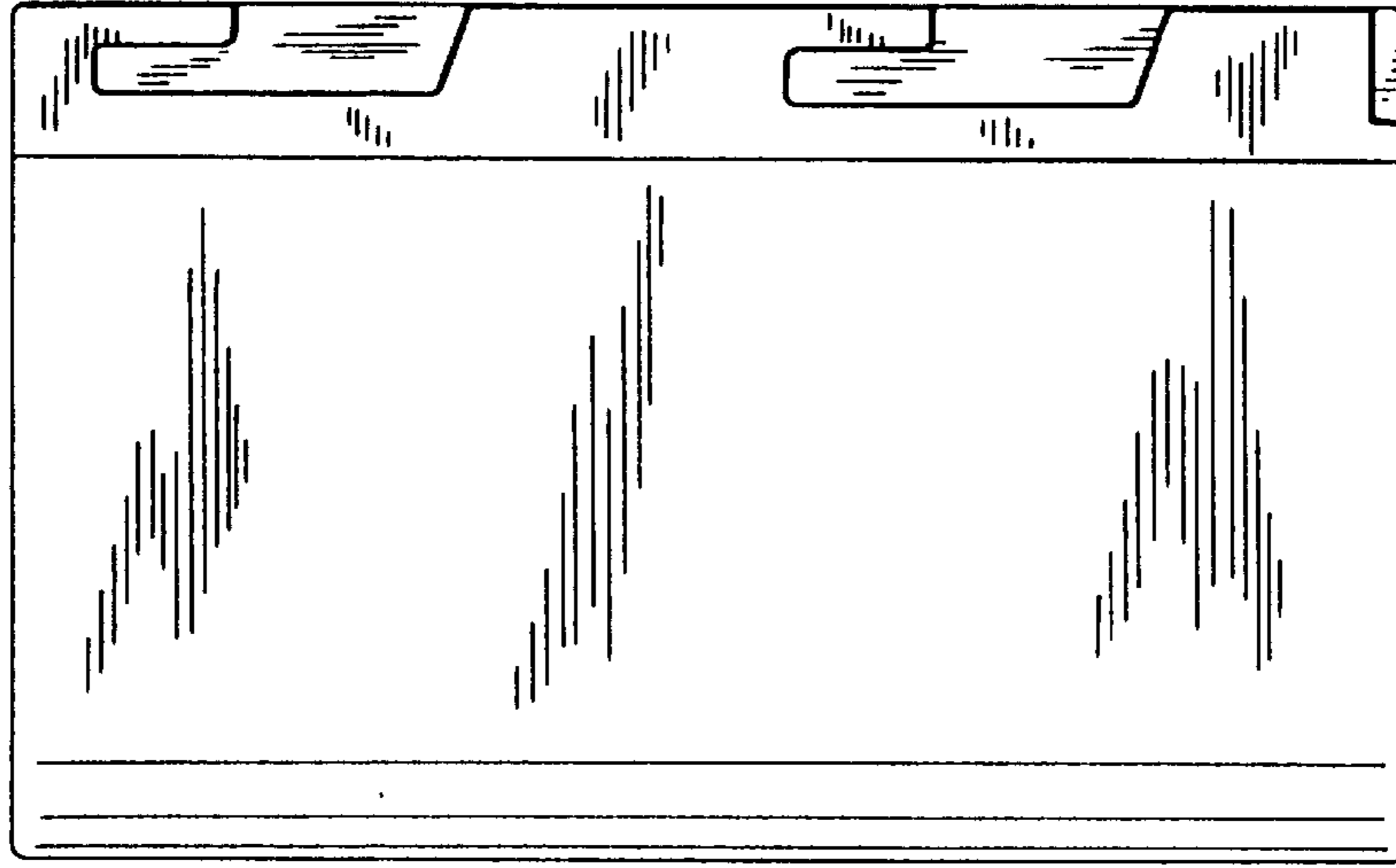
