DESCRIPTION

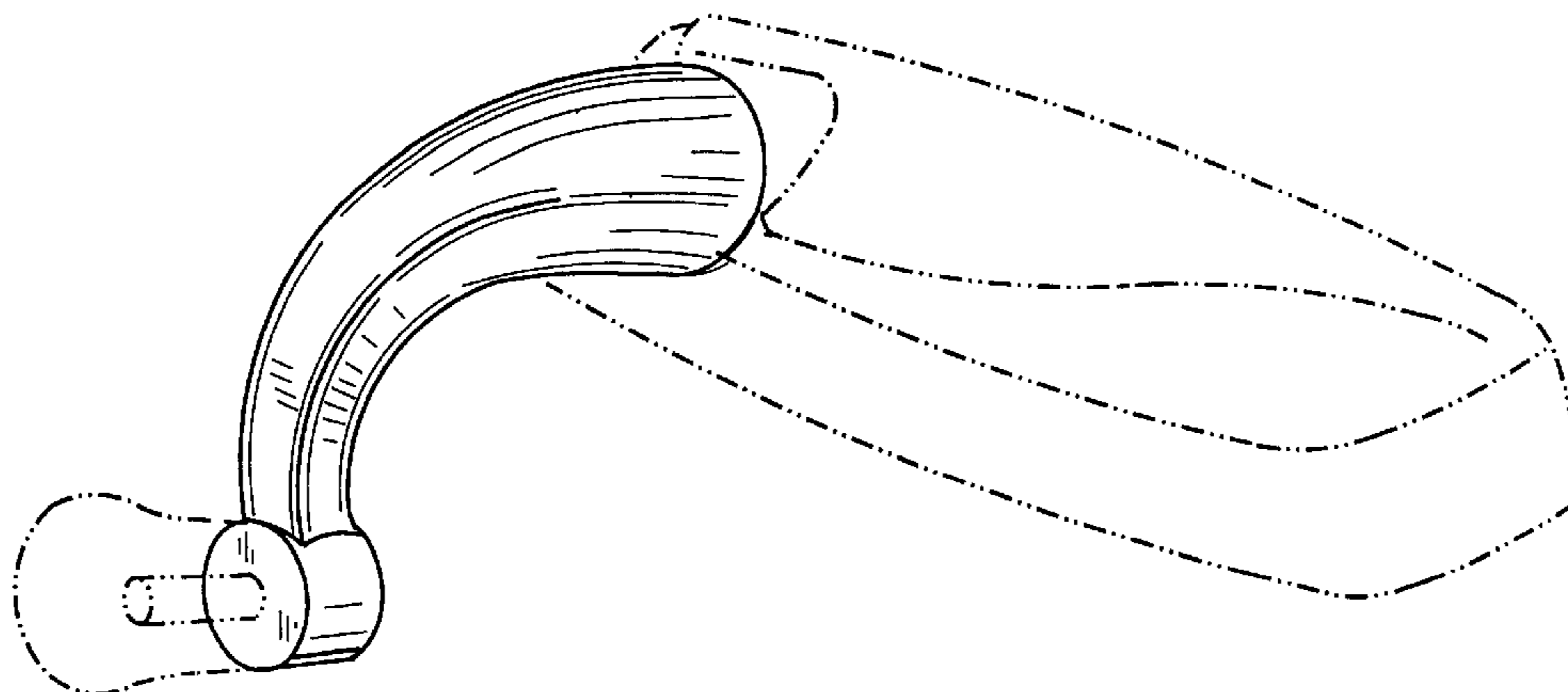

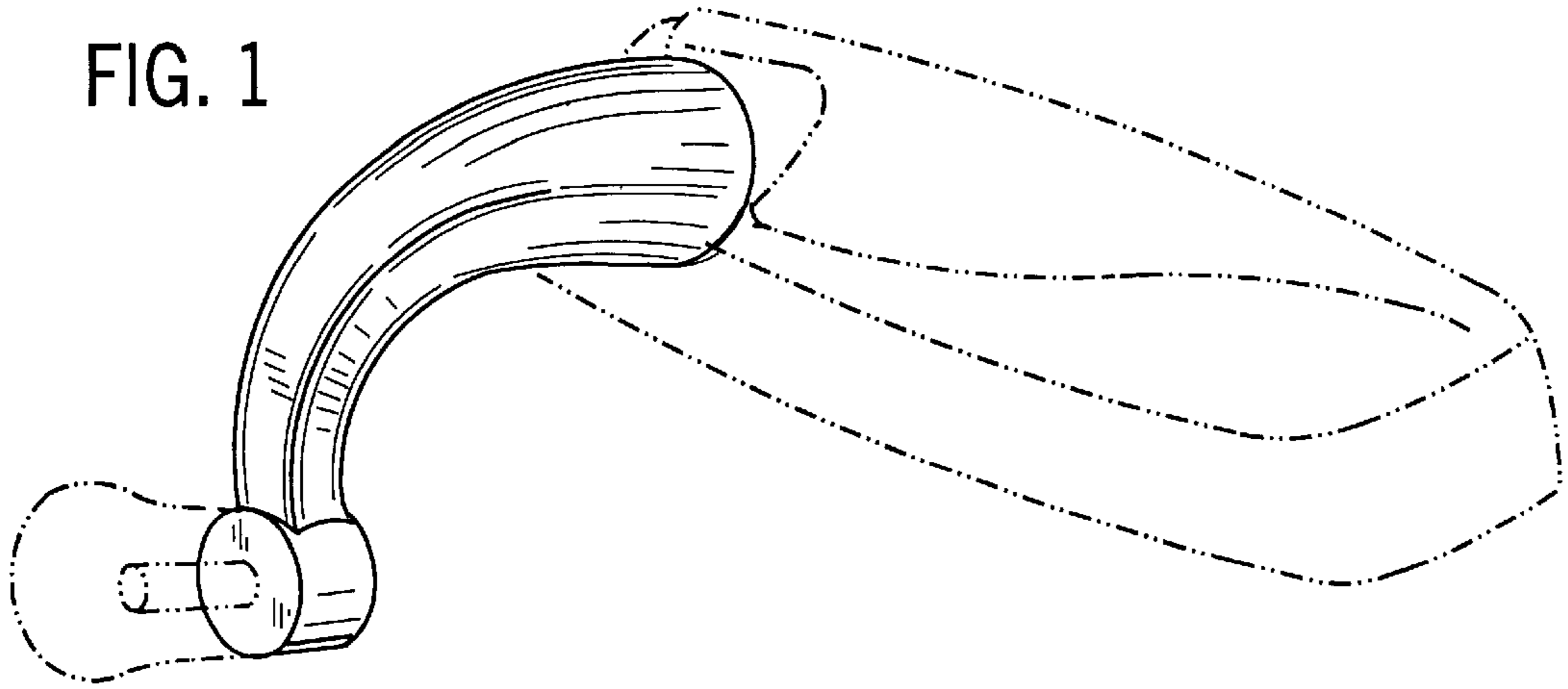

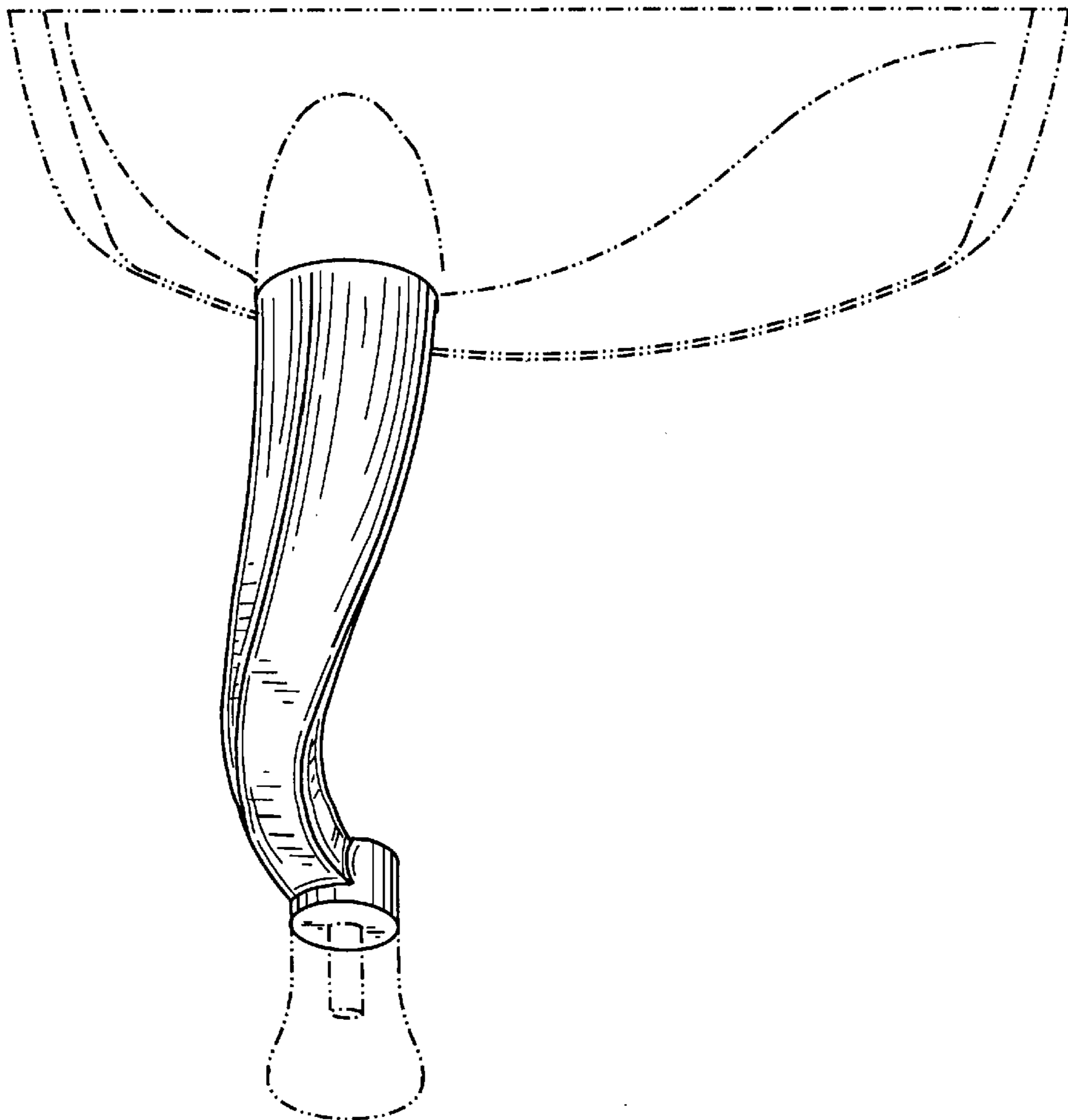

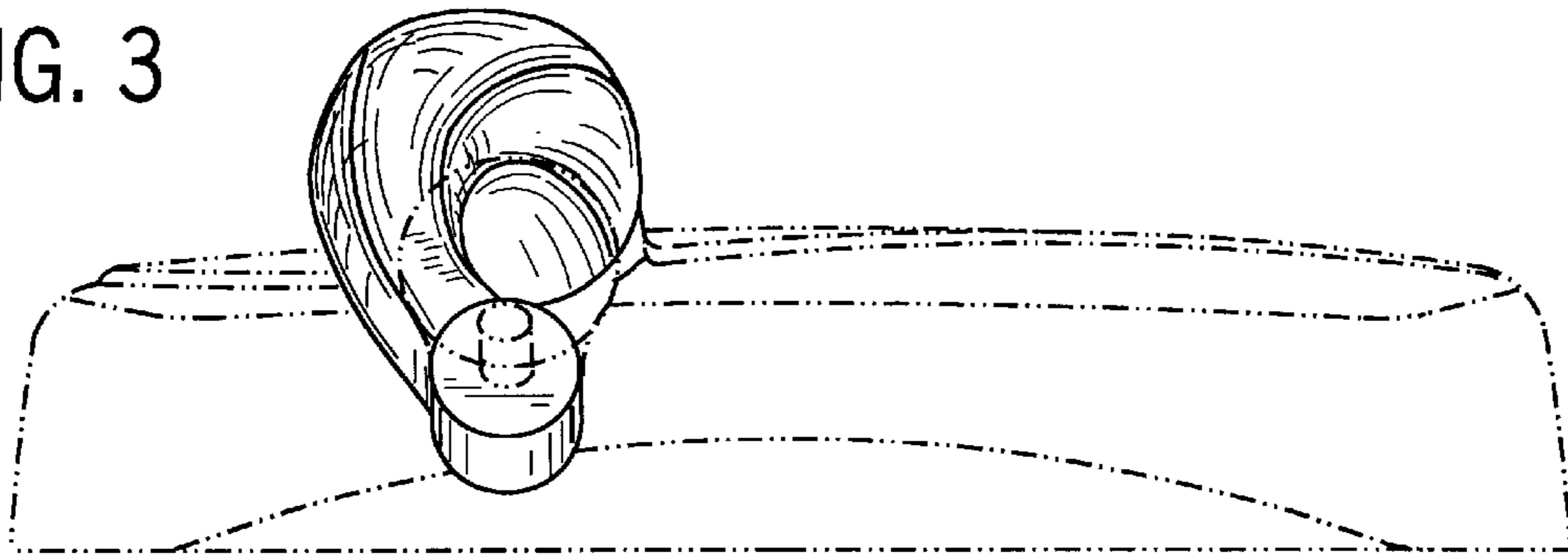

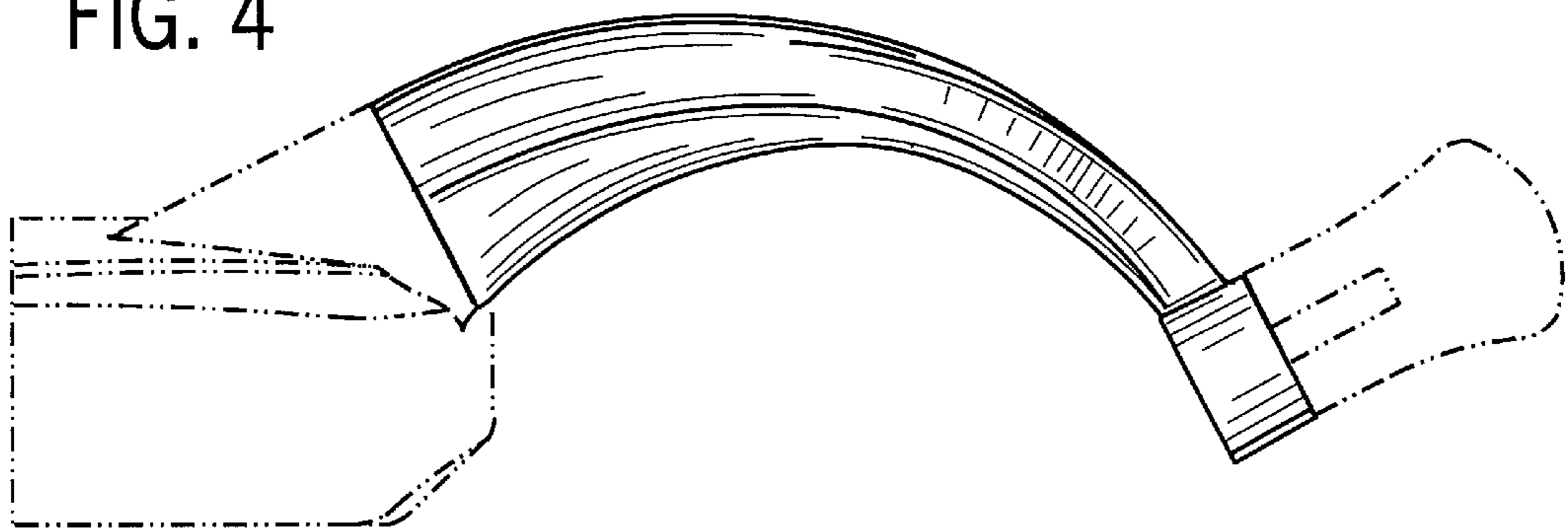

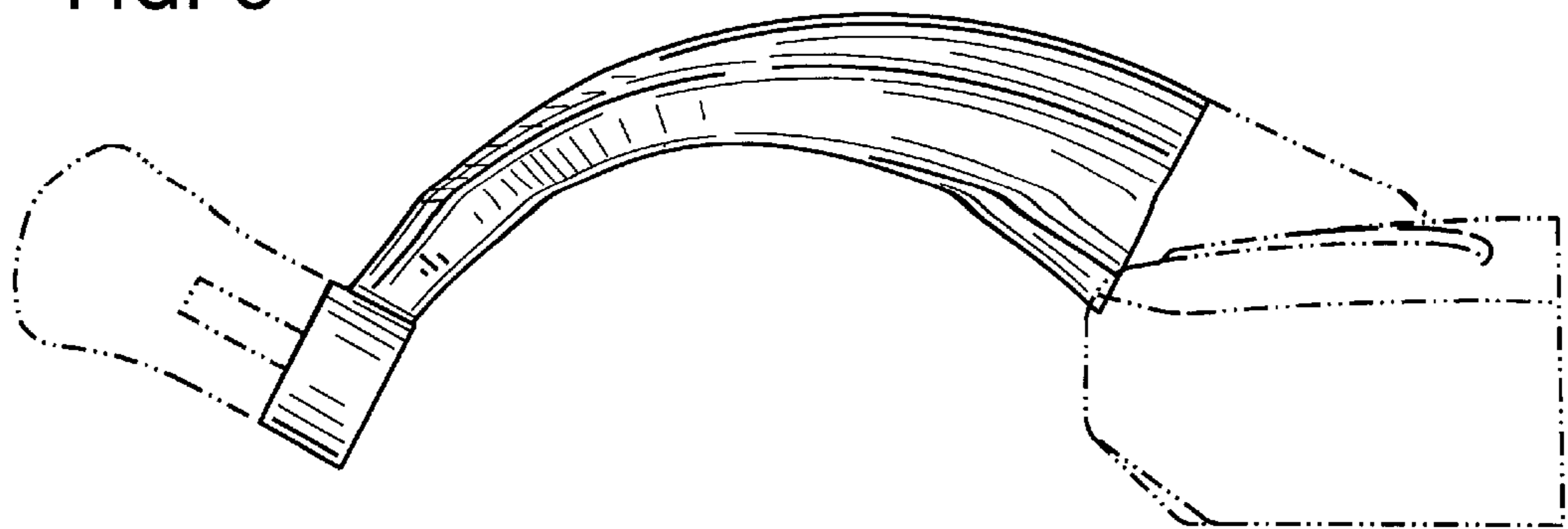

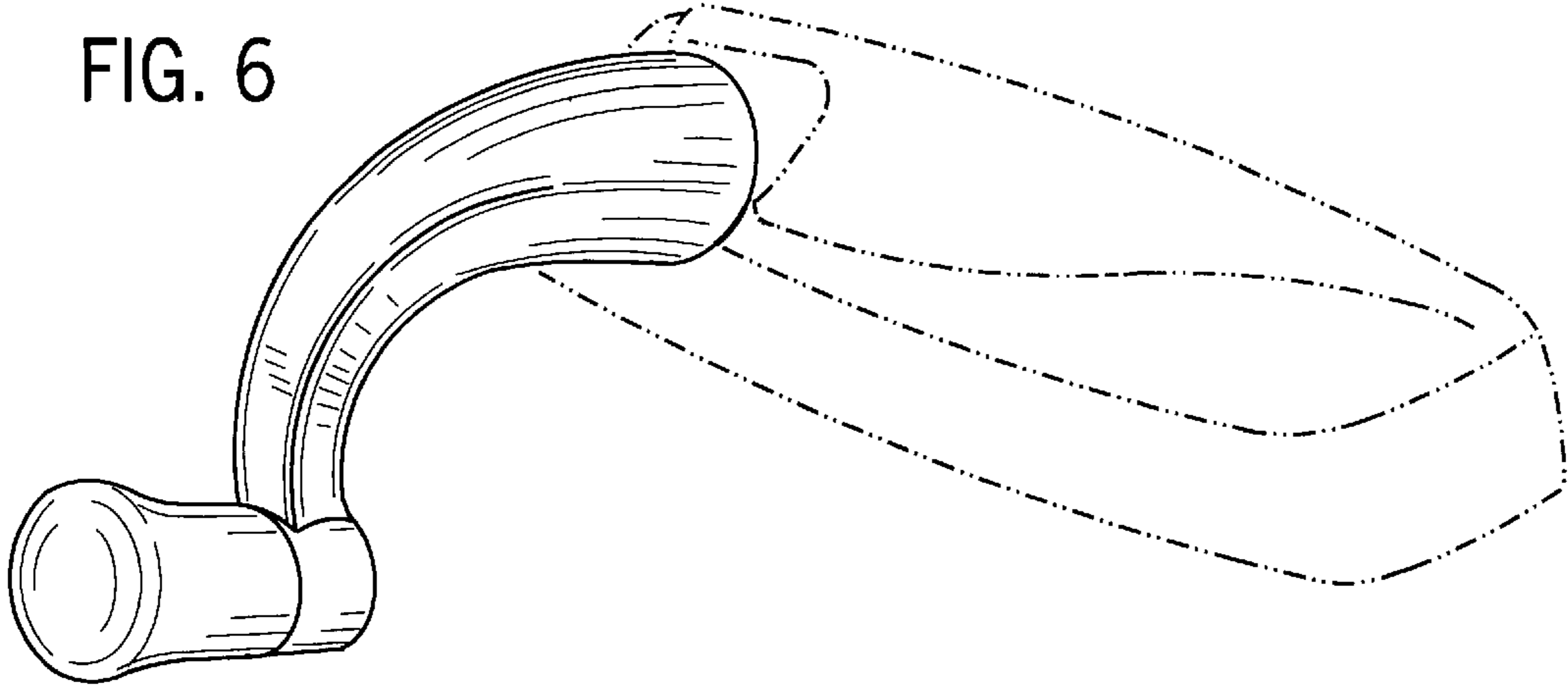

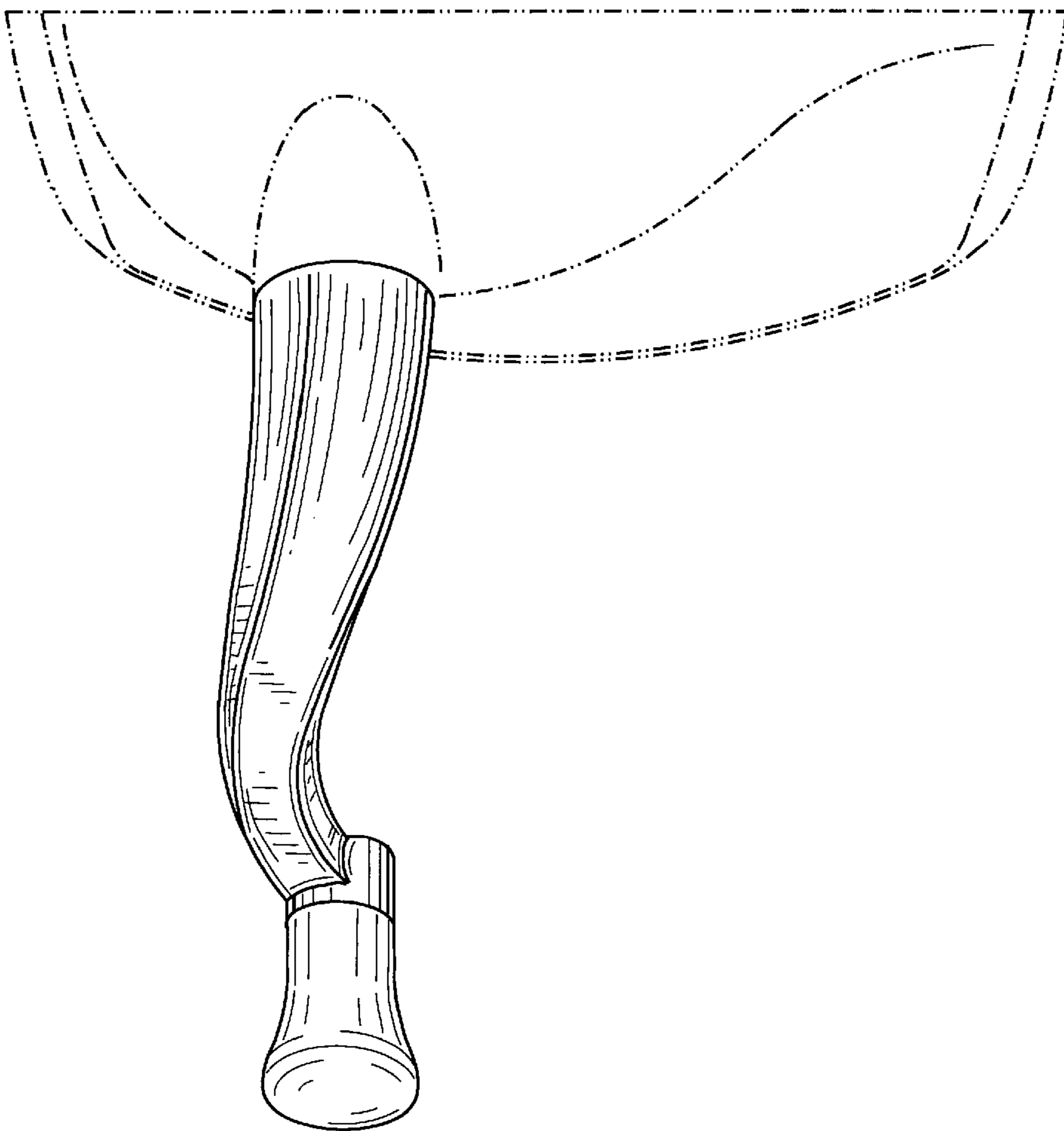

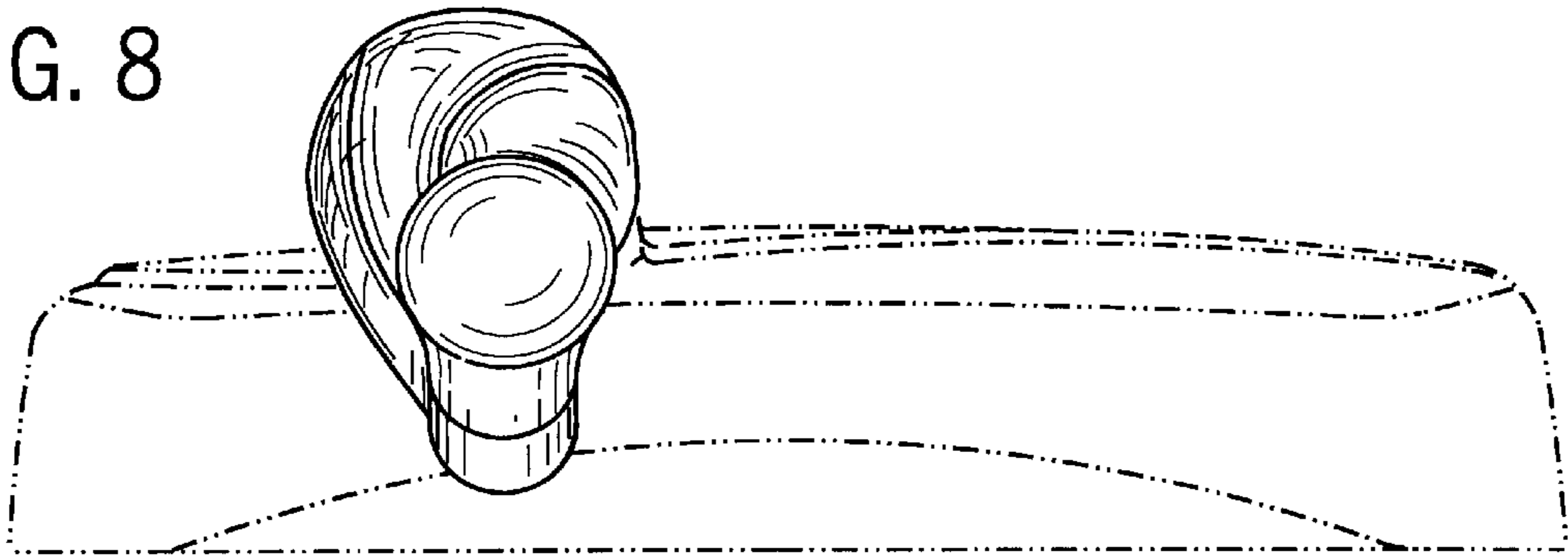

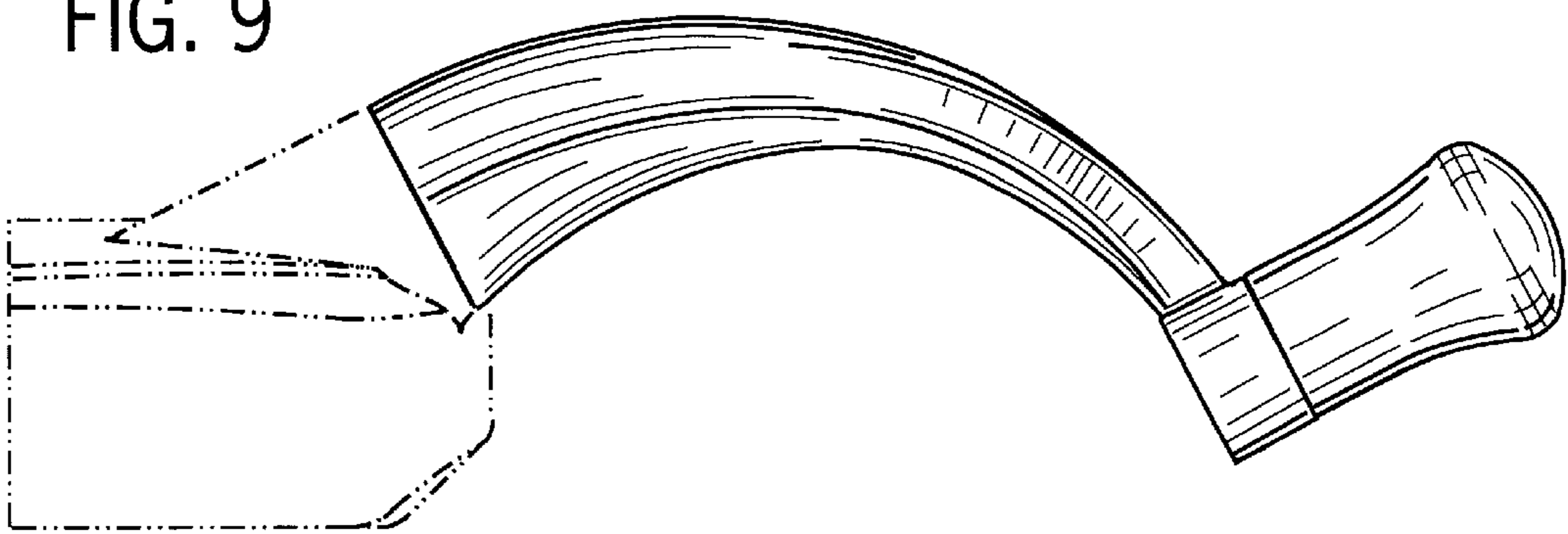

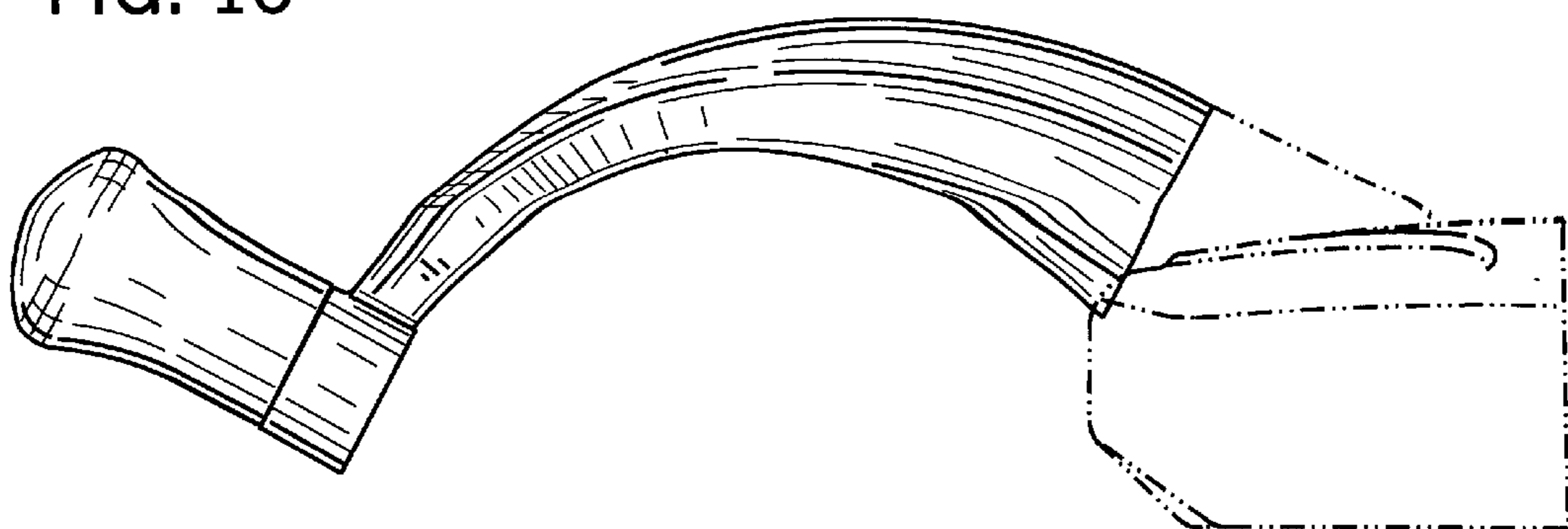

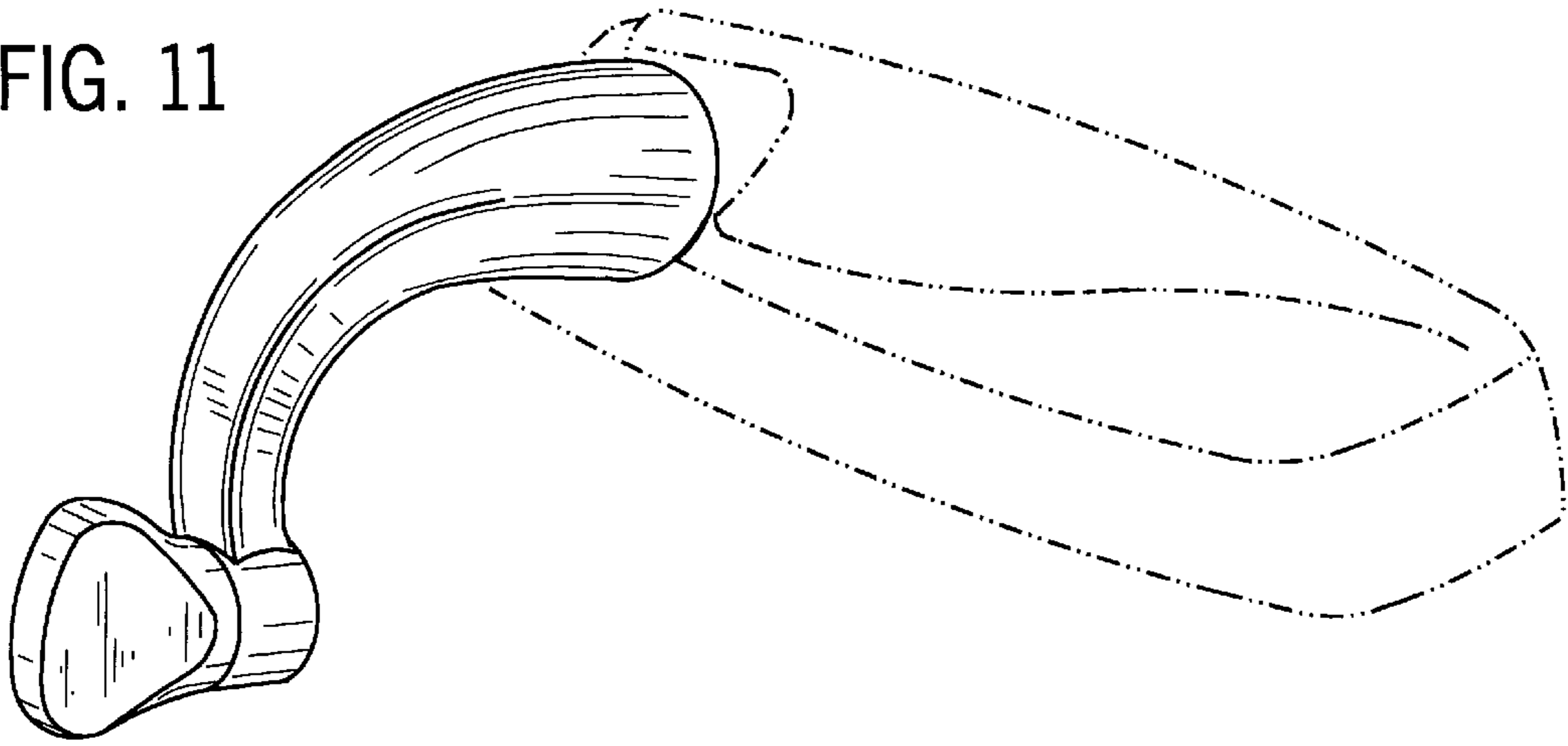

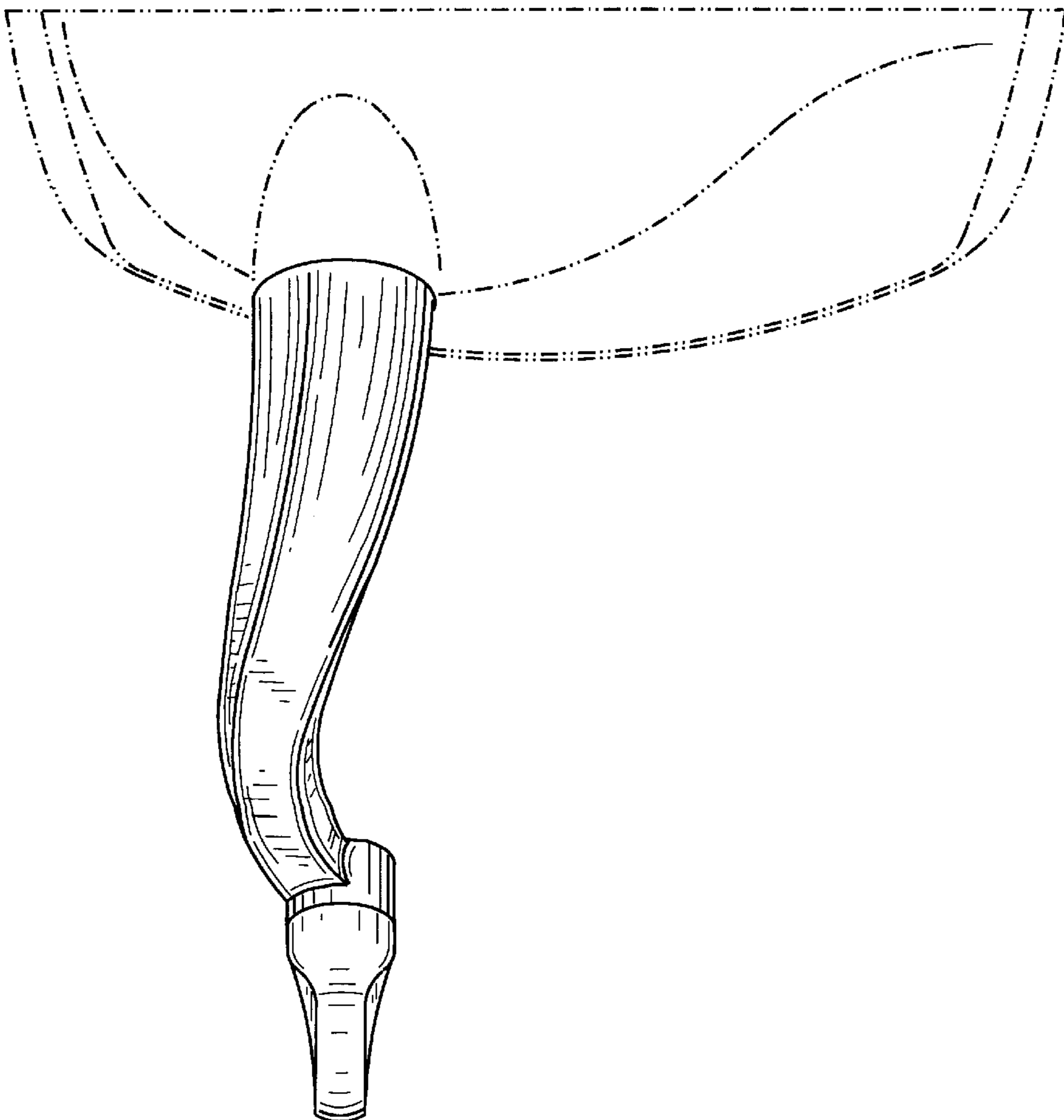

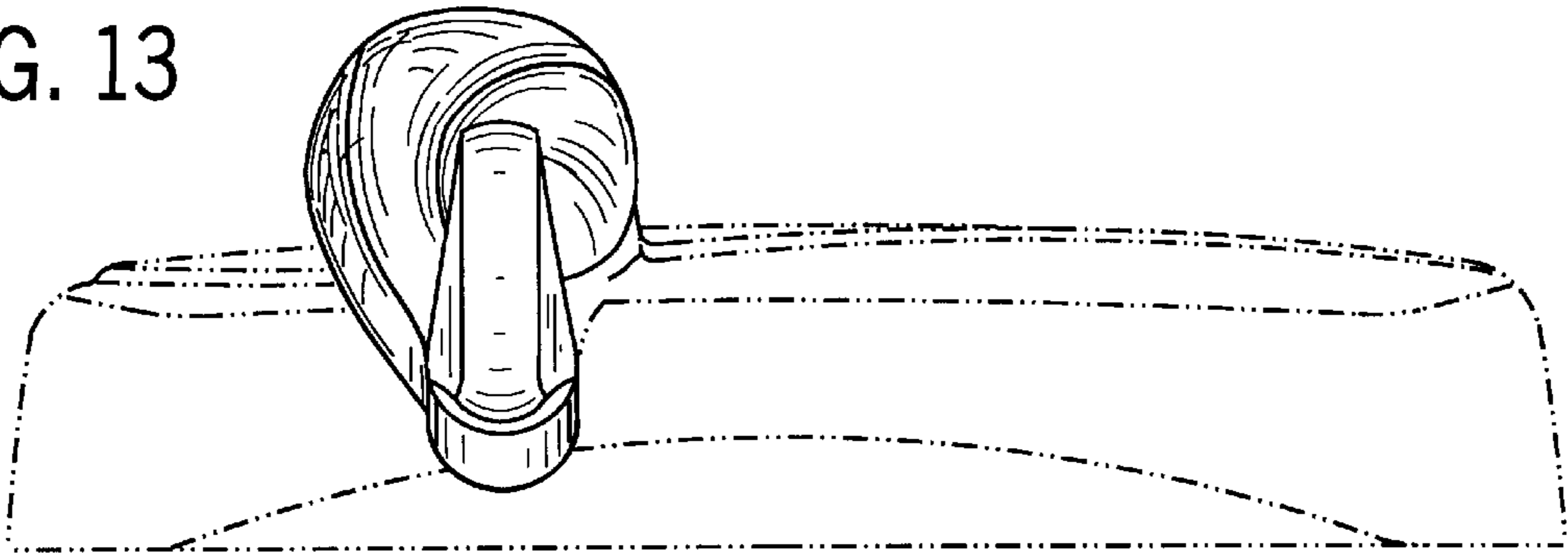

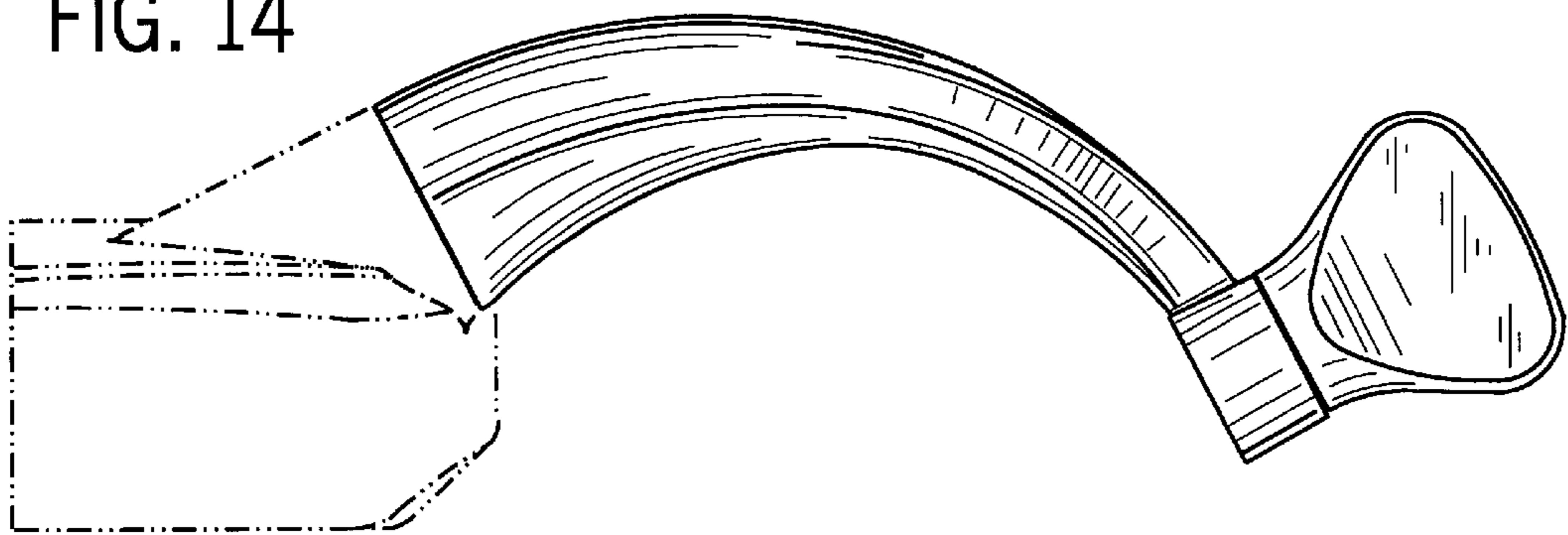

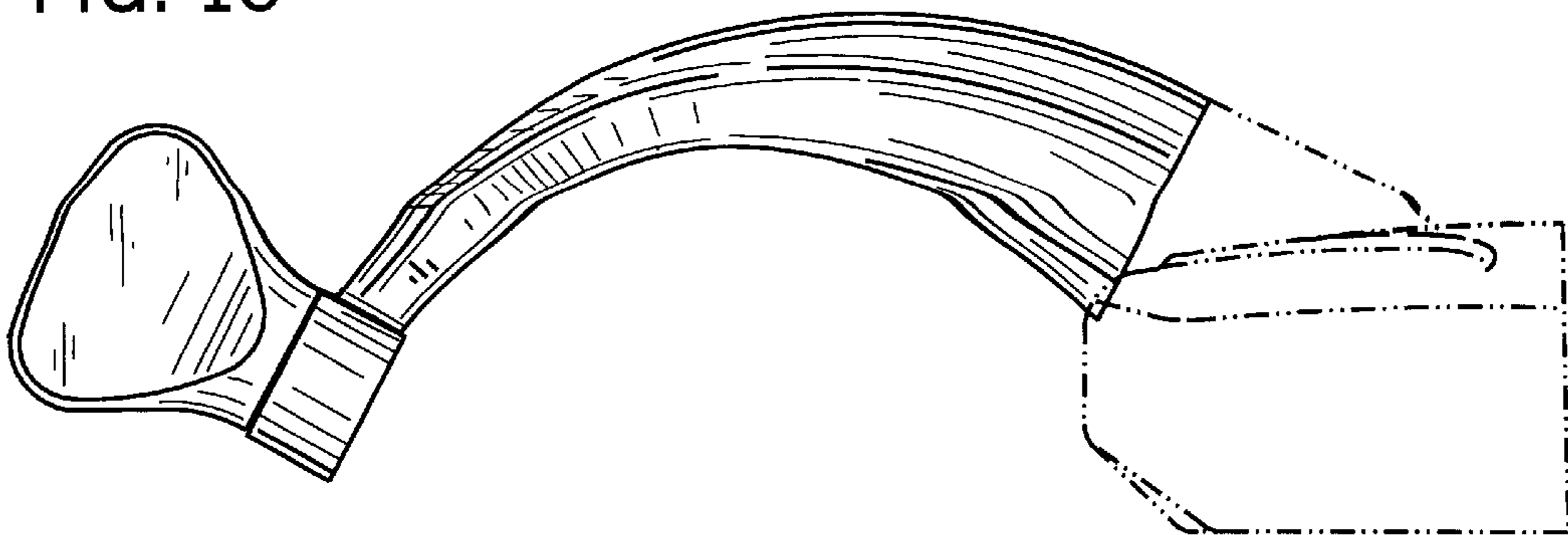

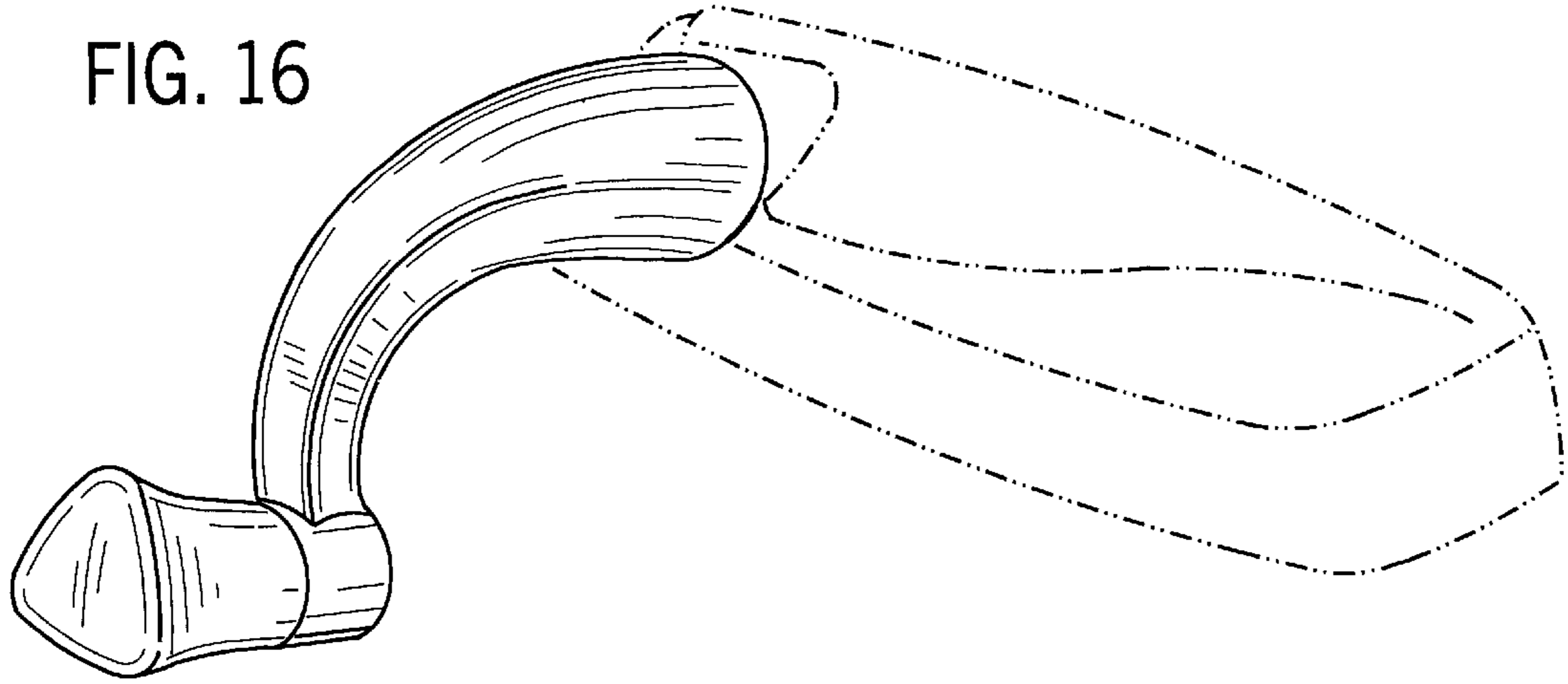

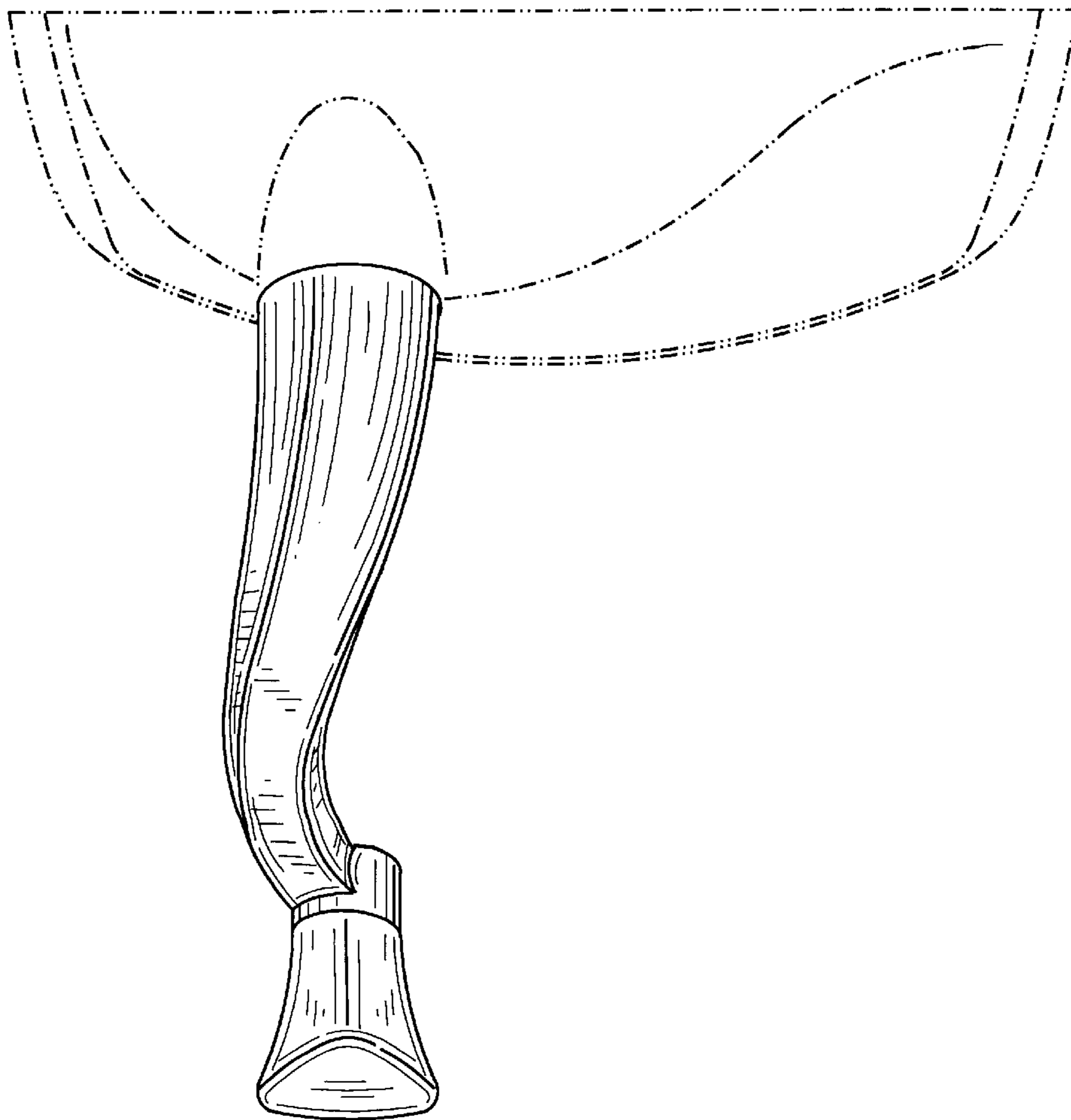

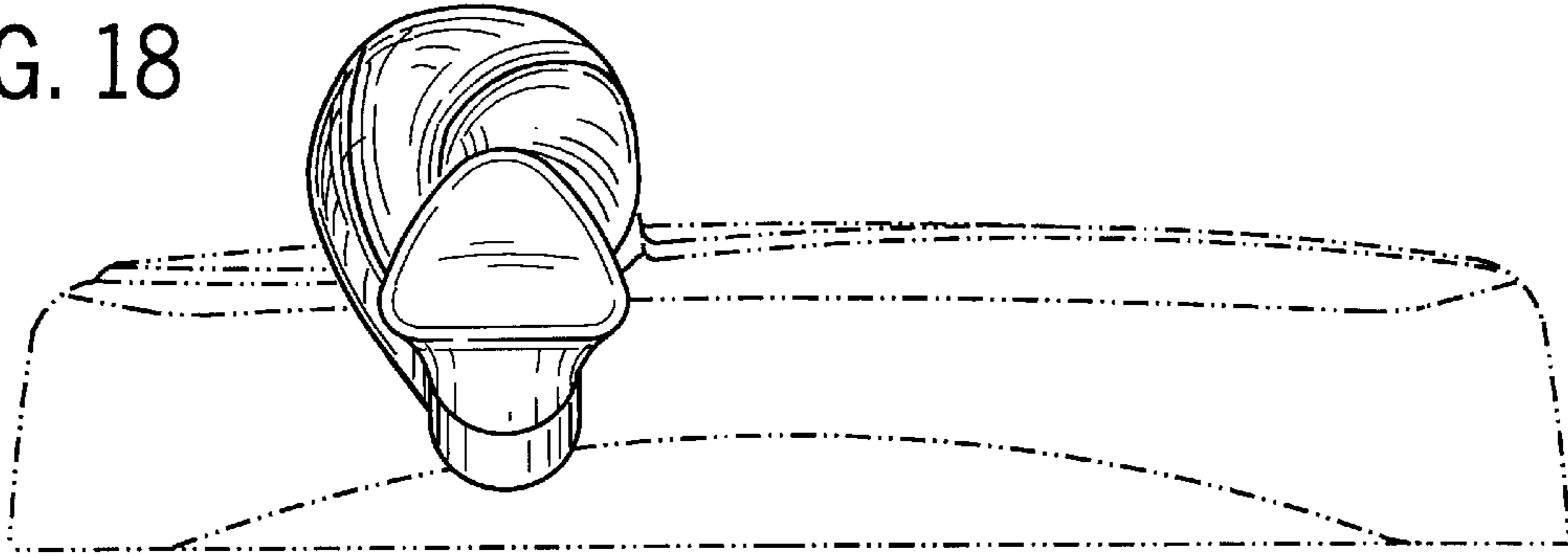

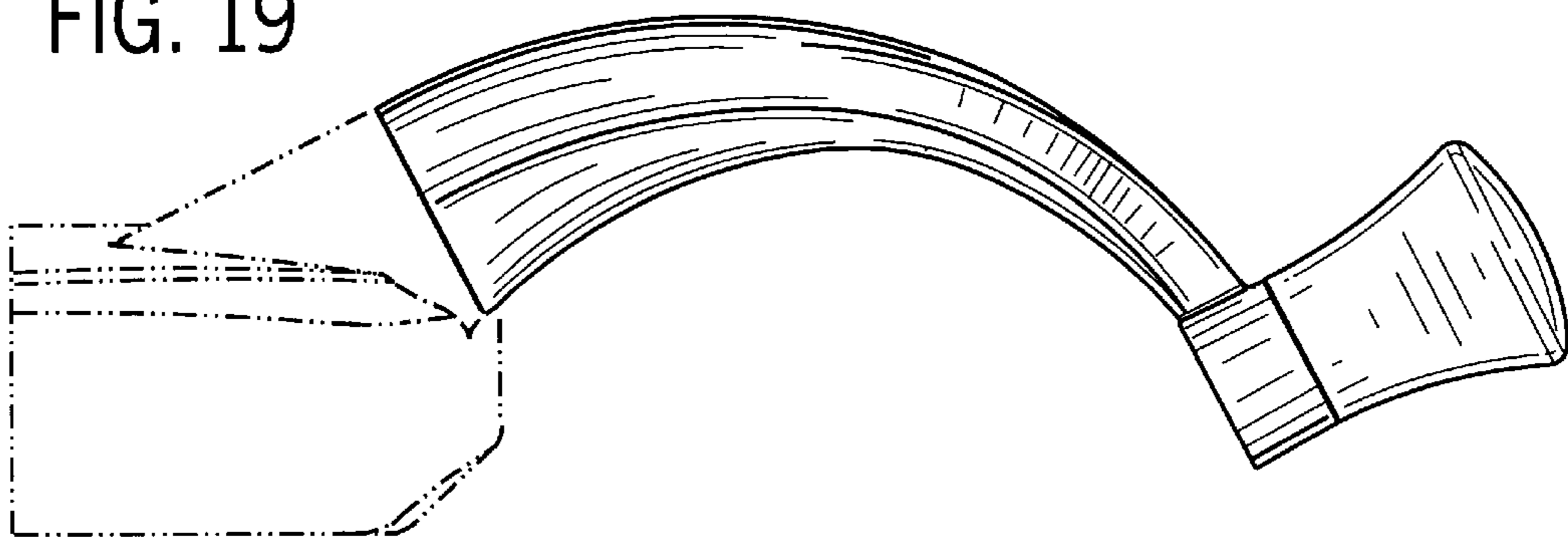
