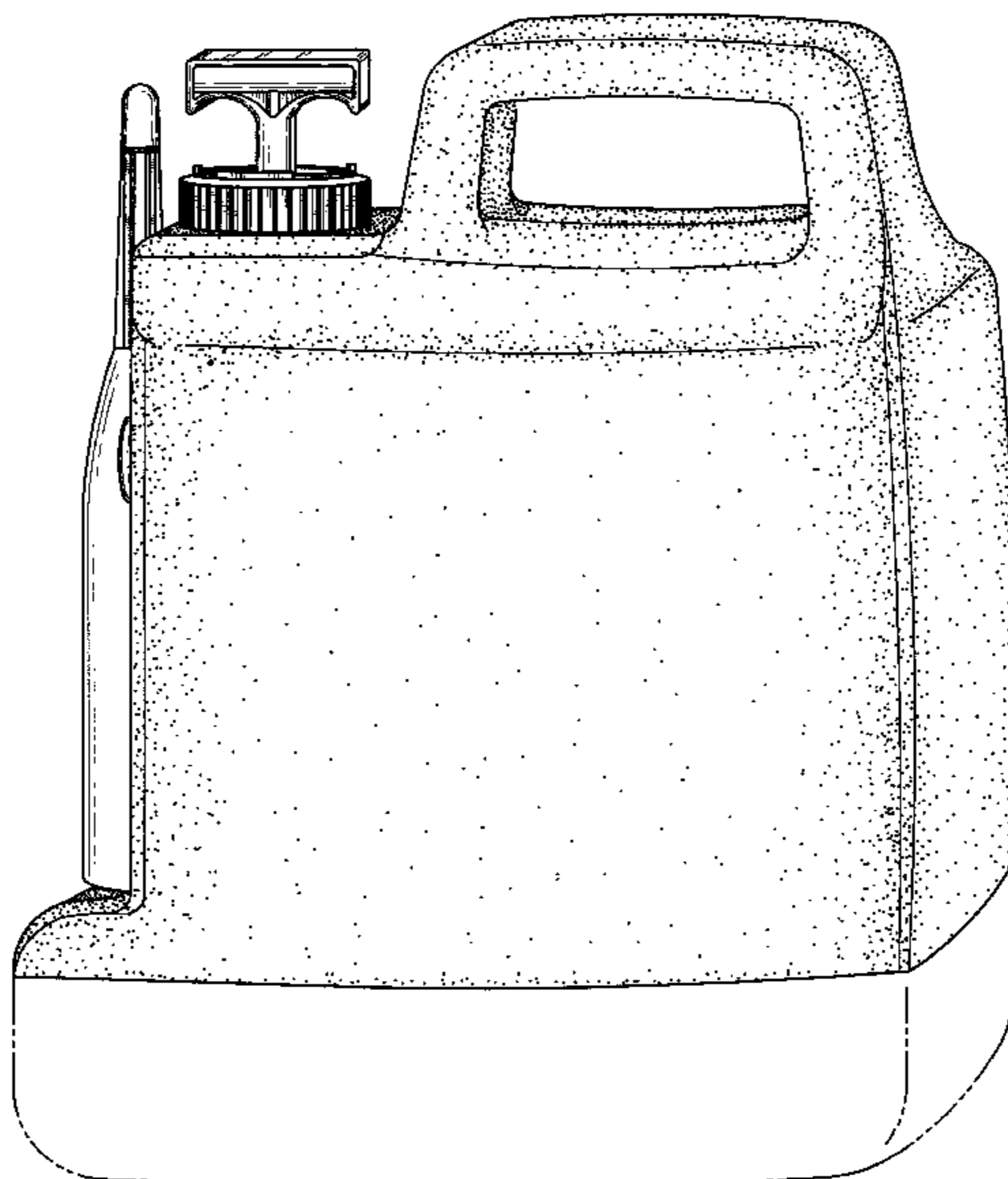
[57] **CLAIM**

The ornamental design for a bottle, pump and sprayer assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the bottle, pump and sprayer assembly illustrating my new design.  
FIG. 2 is a front elevational view of the assembly of FIG. 1.  
FIG. 3 is a top plan view of the assembly of FIG. 1.  
FIG. 4 is a left elevational view of the assembly of FIG. 1.  
FIG. 5 is a right elevational view of the assembly of FIG. 1; and,  
FIG. 6 is a rear elevational view of the assembly of FIG. 1.  
The bottom of the bottle, pump and sprayer assembly form no part of the claimed design. The lower portion of the bottle is shown in broken lines for illustrative purposes only and forms no part of the claimed design.

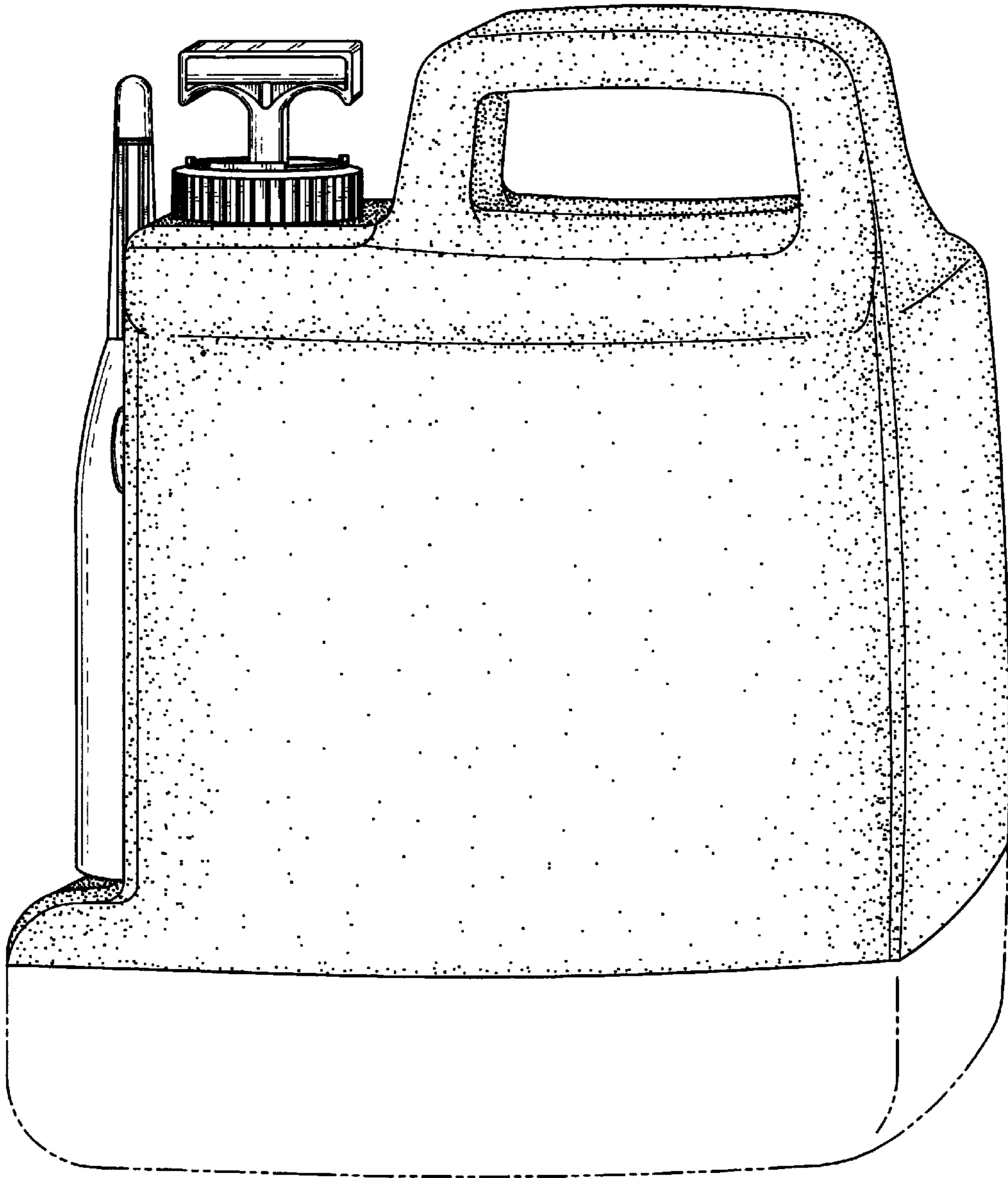

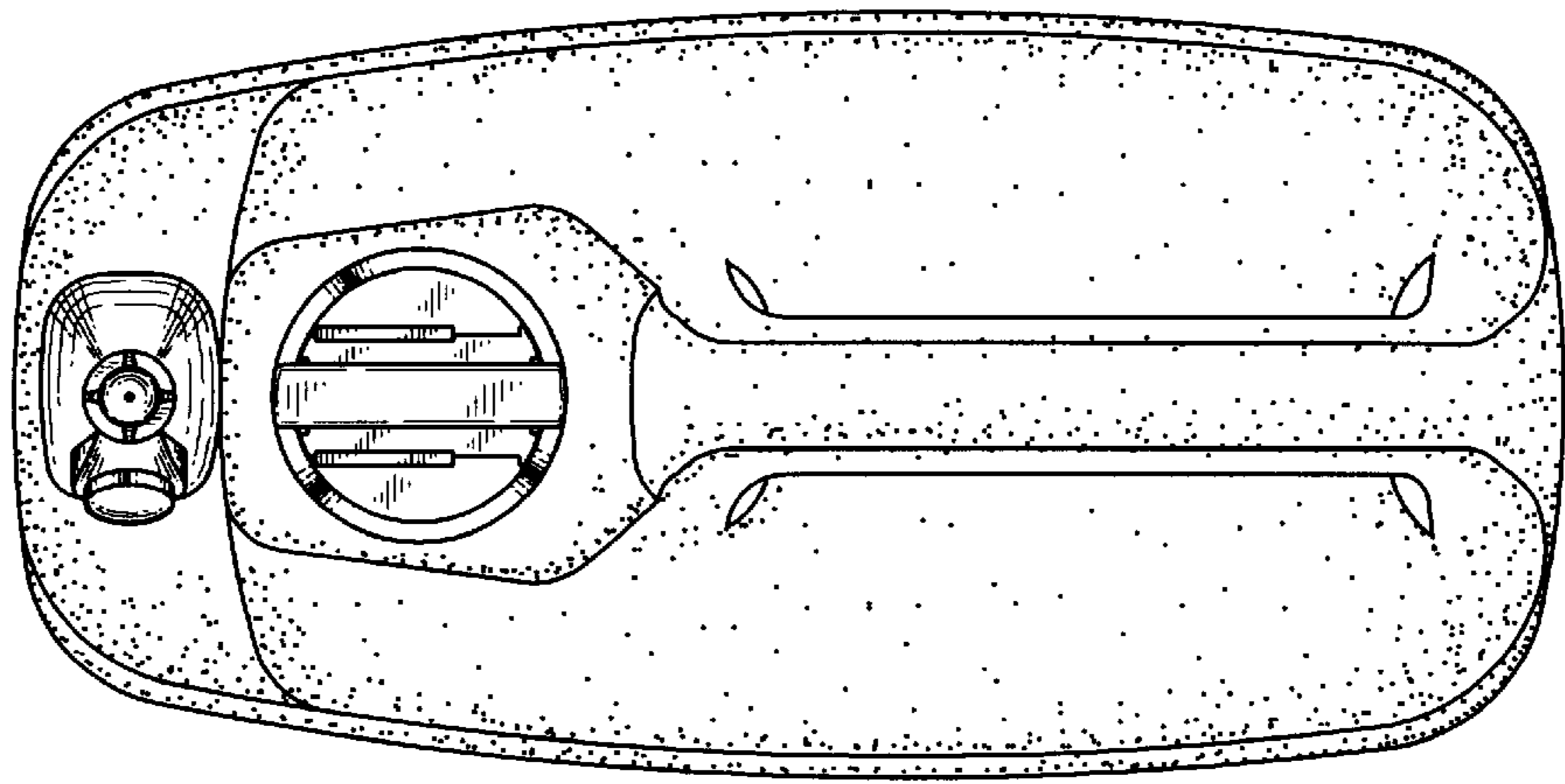

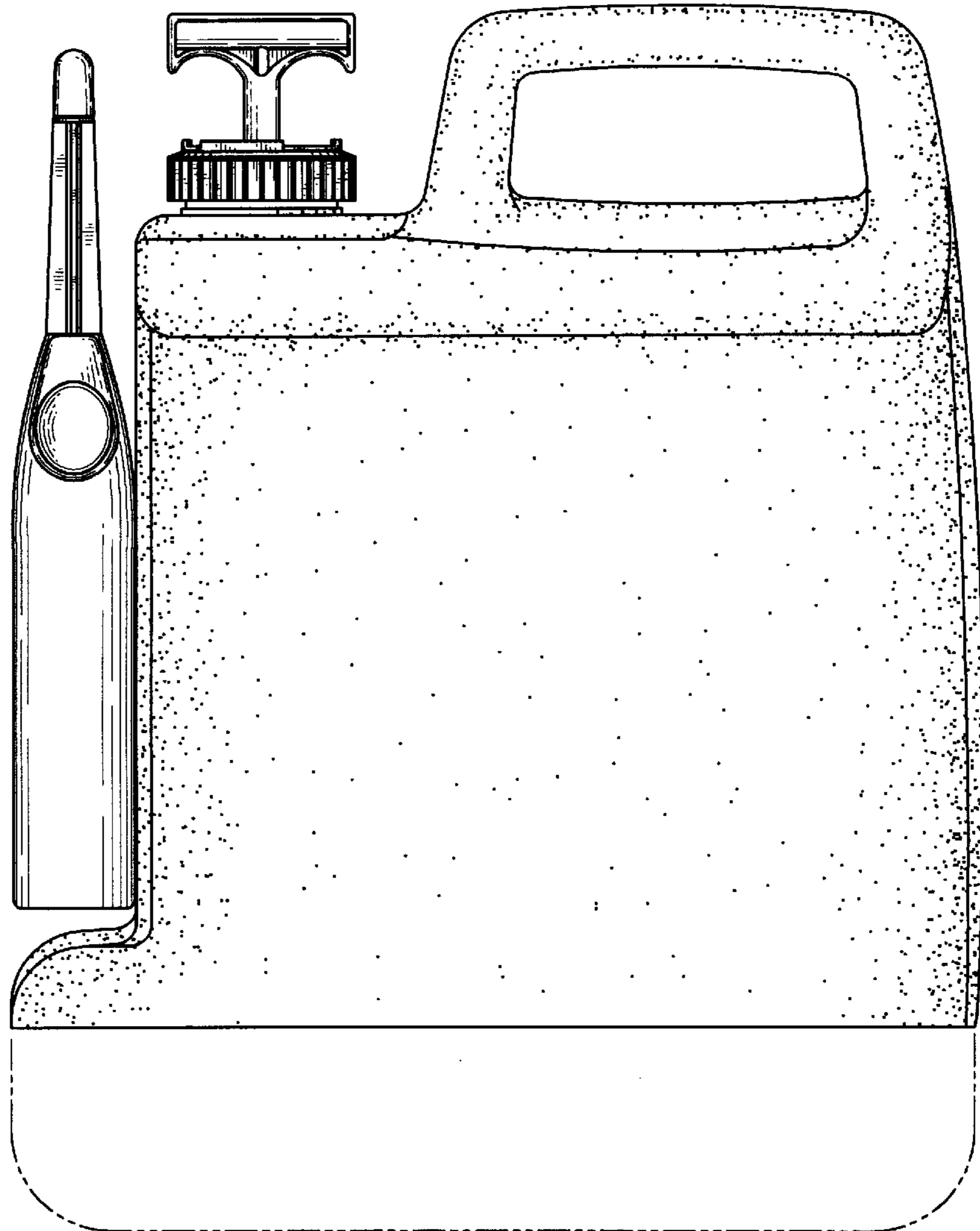

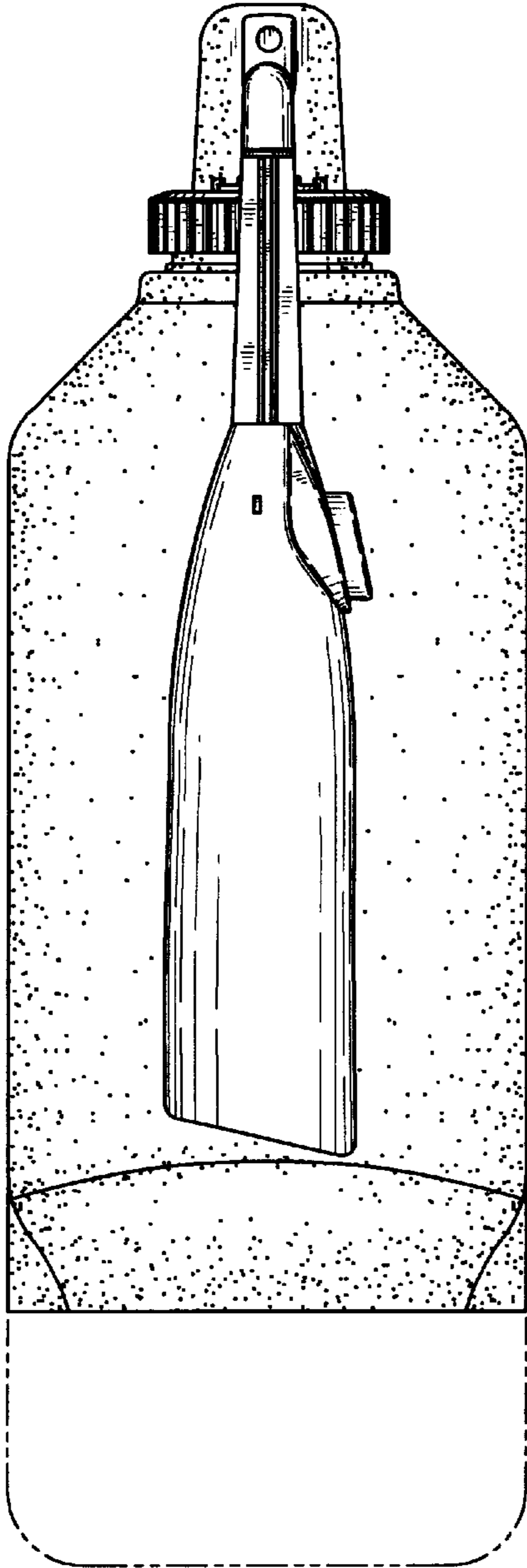

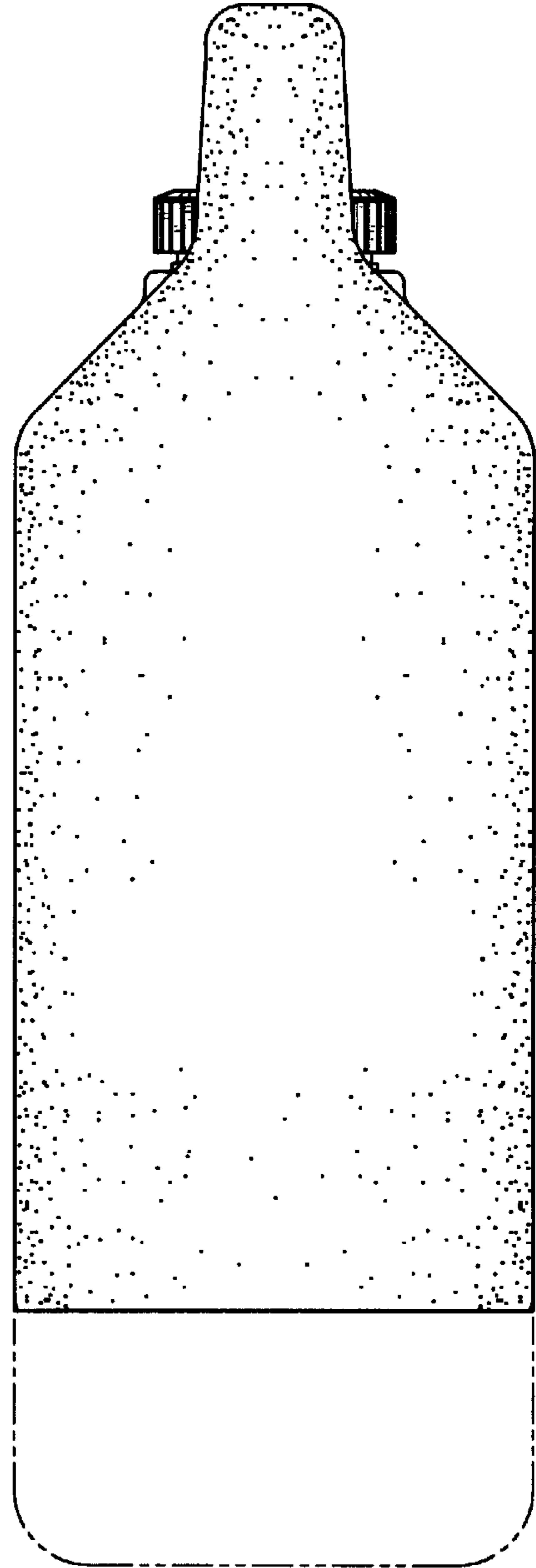
