[57] **CLAIM**

The ornamental design for a protective hand guard, as shown and described.

DESCRIPTION

FIG. 1 is a front and left side perspective view of a protective hand guard showing my new design.
FIG. 2 is a front, right and bottom perspective view thereof.
FIG. 3 is a front elevational view thereof.
FIG. 4 is a rear elevational view thereof.
FIG. 5 is a right side elevational view thereof.
FIG. 6 is a bottom plan view thereof.
FIG. 7 is a left elevational view thereof; and,
FIG. 8 is a top plan view thereof.

The fragmentary cris-cross pattern shown in the drawing is understood to represent fabric and is repeated uniformly throughout the areas shown.

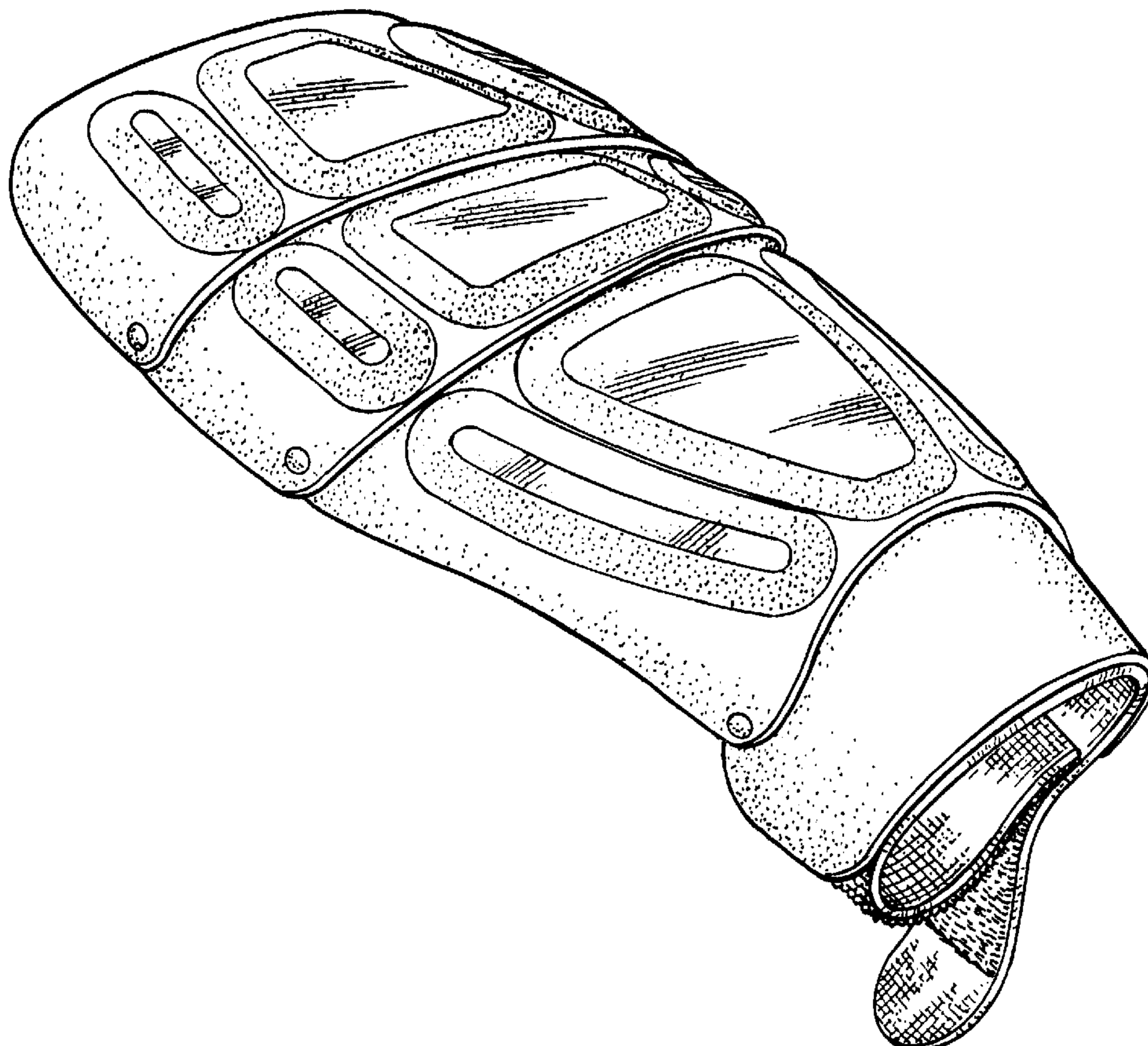

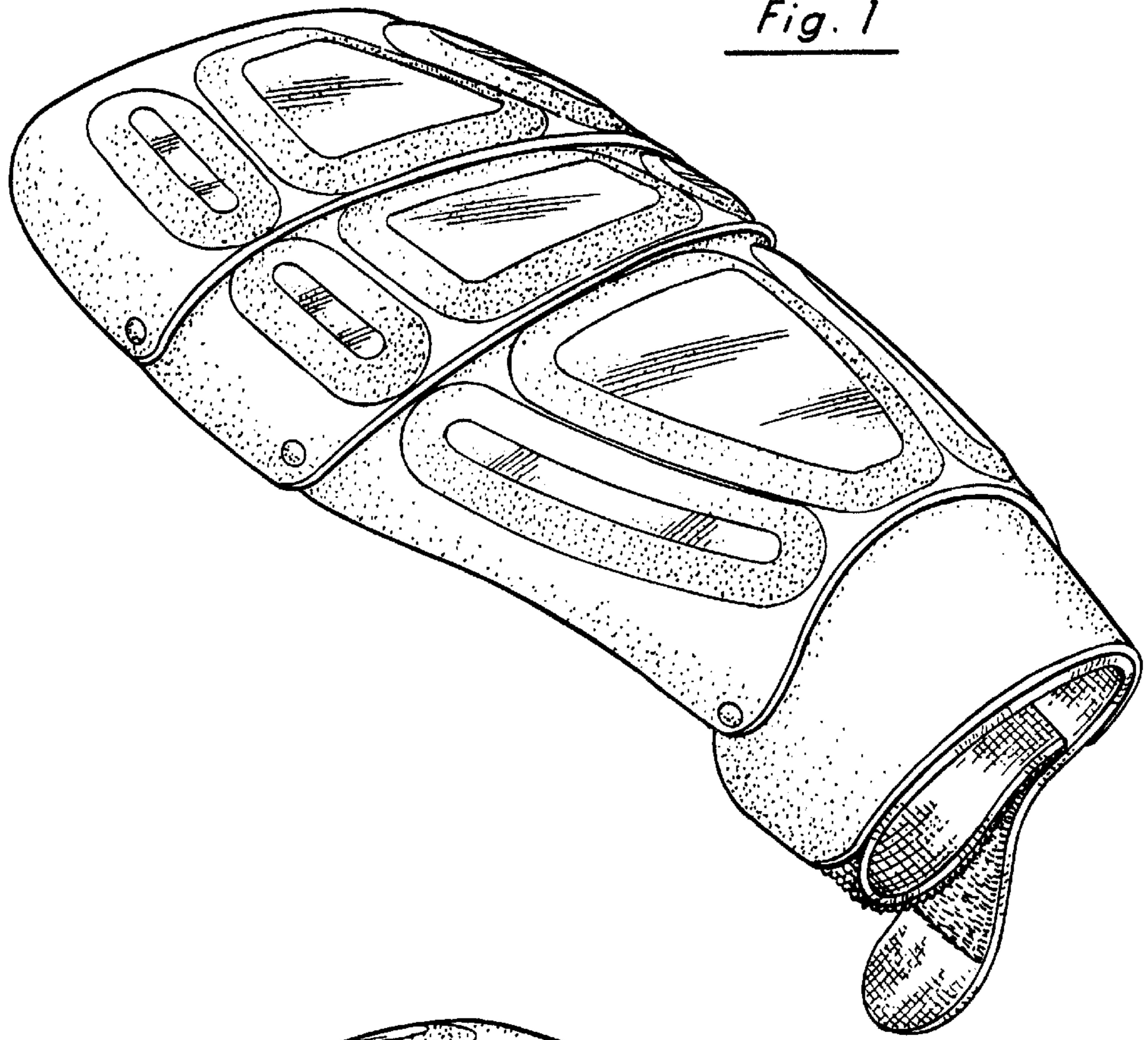

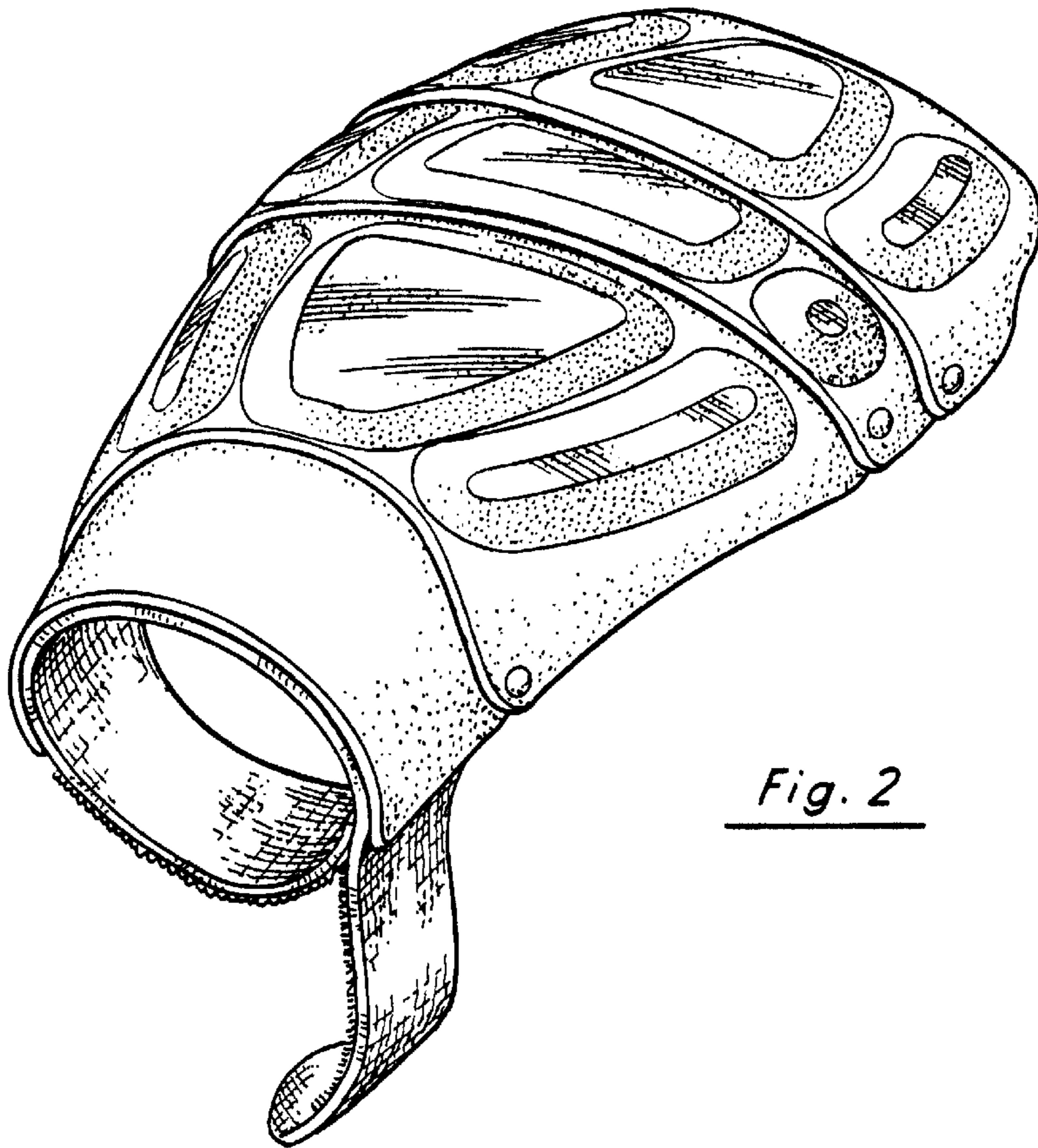

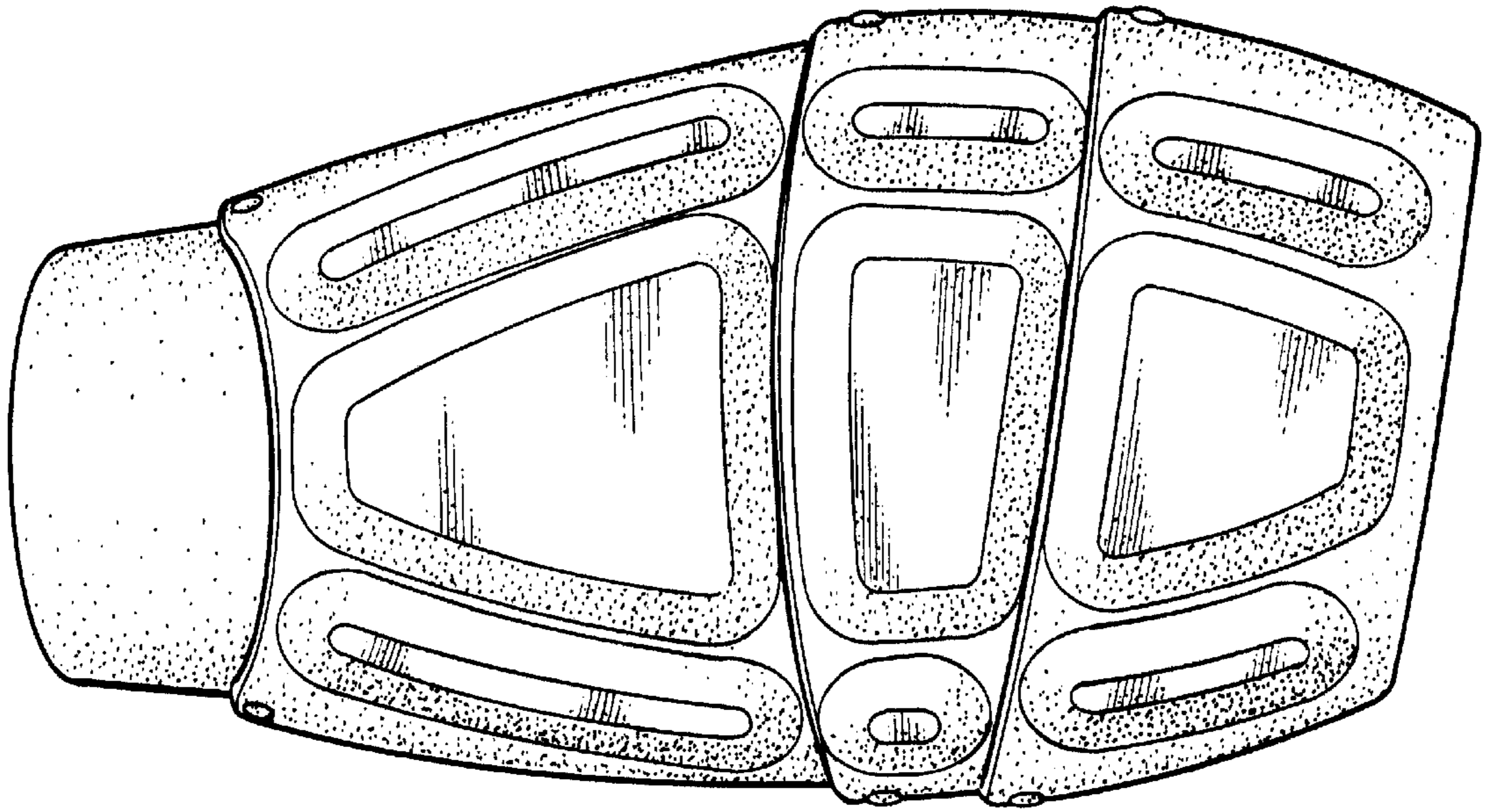
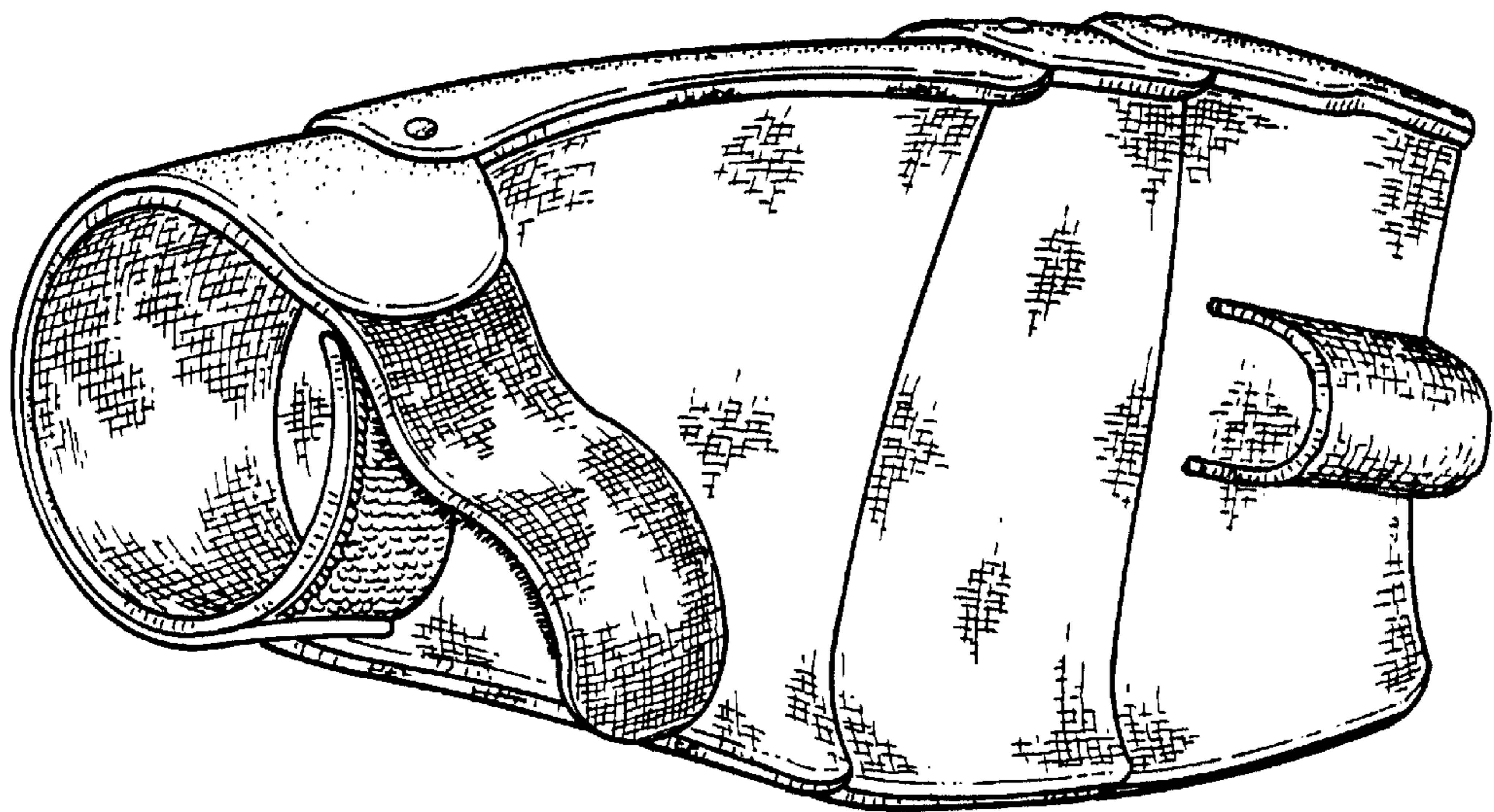

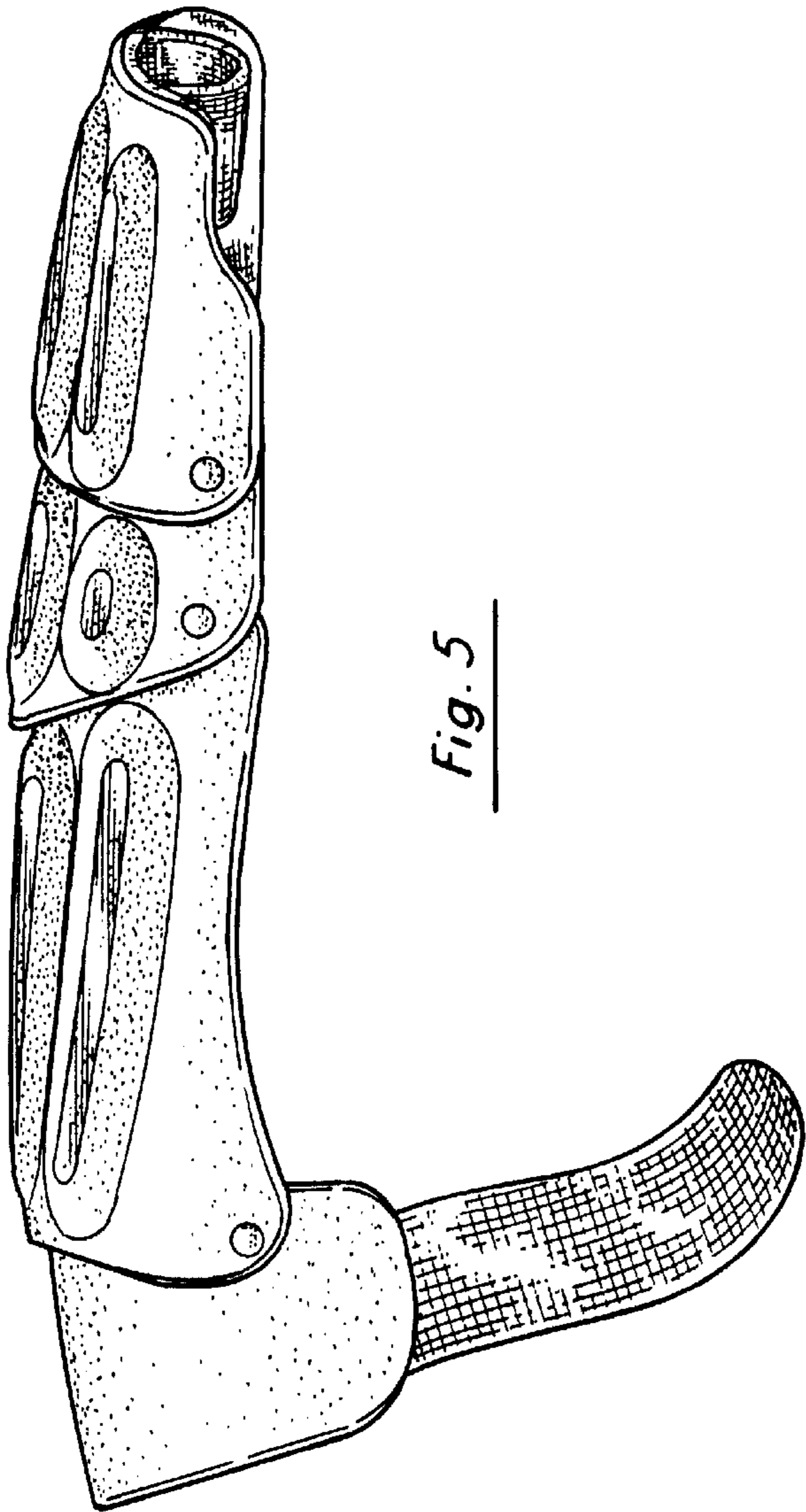

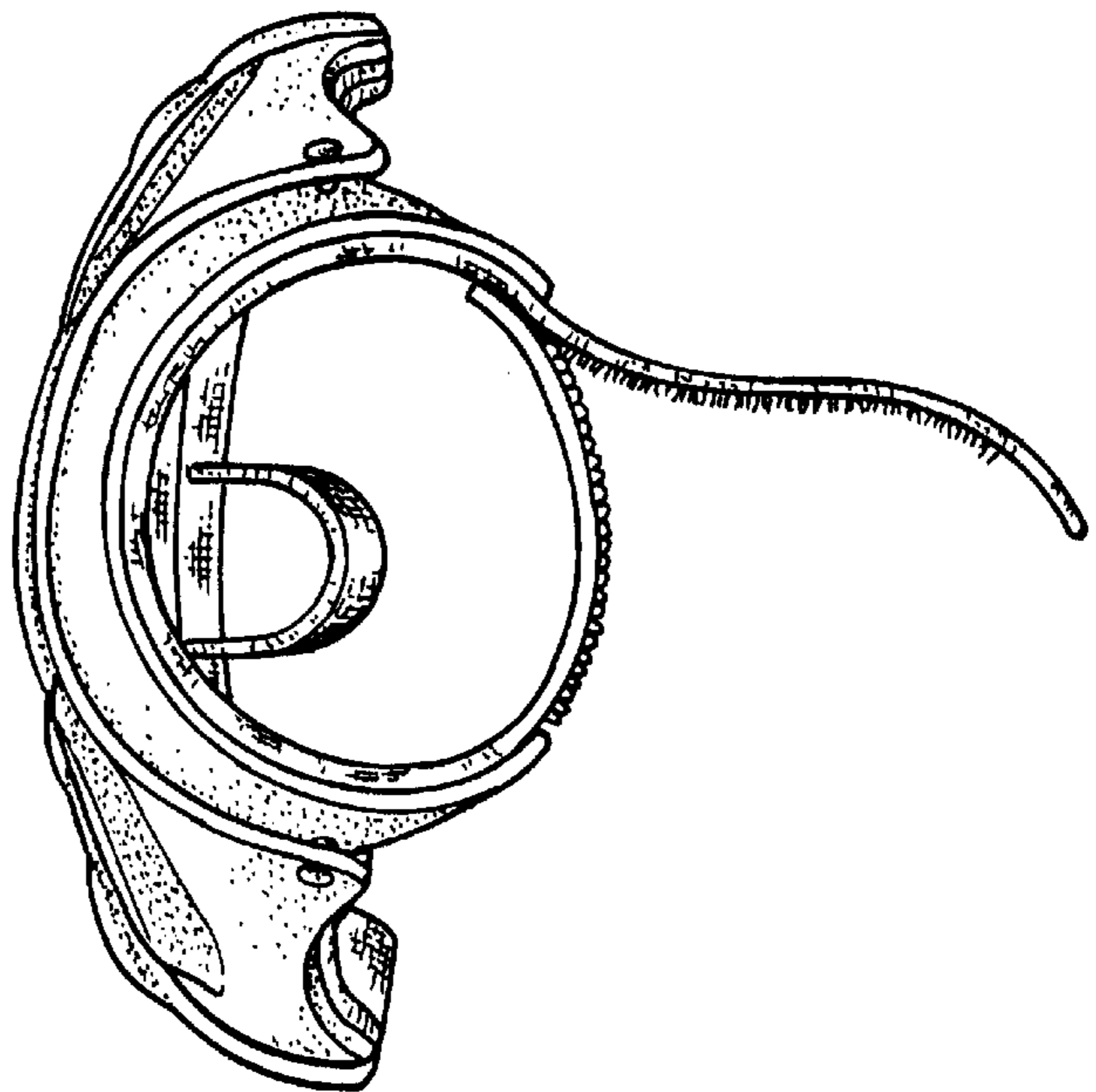

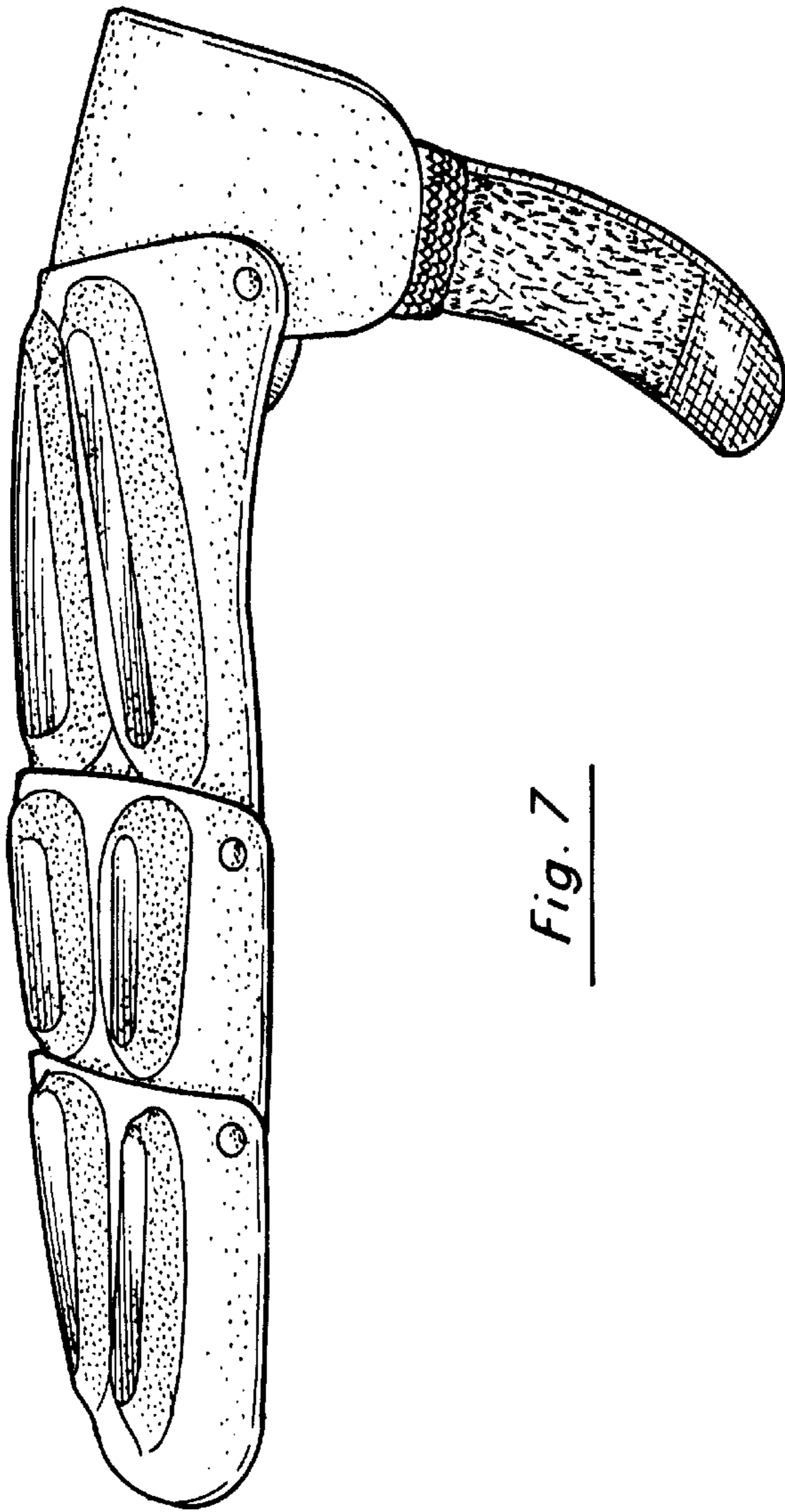

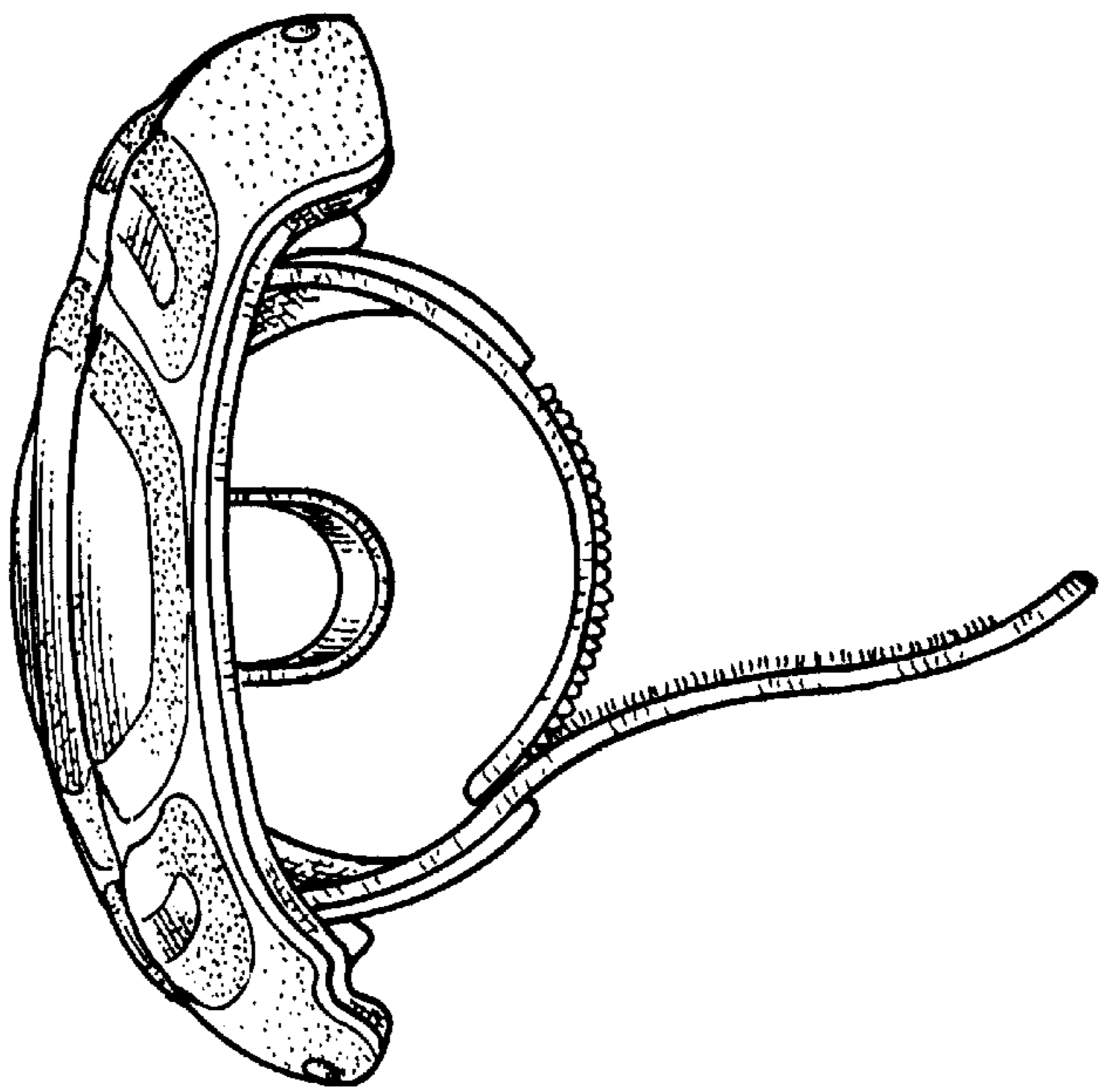
