#### [57] CLAIM

The ornamental design for a pet toy with the face of an ape, as shown and described.

#### DESCRIPTION

FIG. 1 is a front elevational view of a pet toy with the face of an ape showing our new design.

FIG. 2 is a right side elevational view thereof;

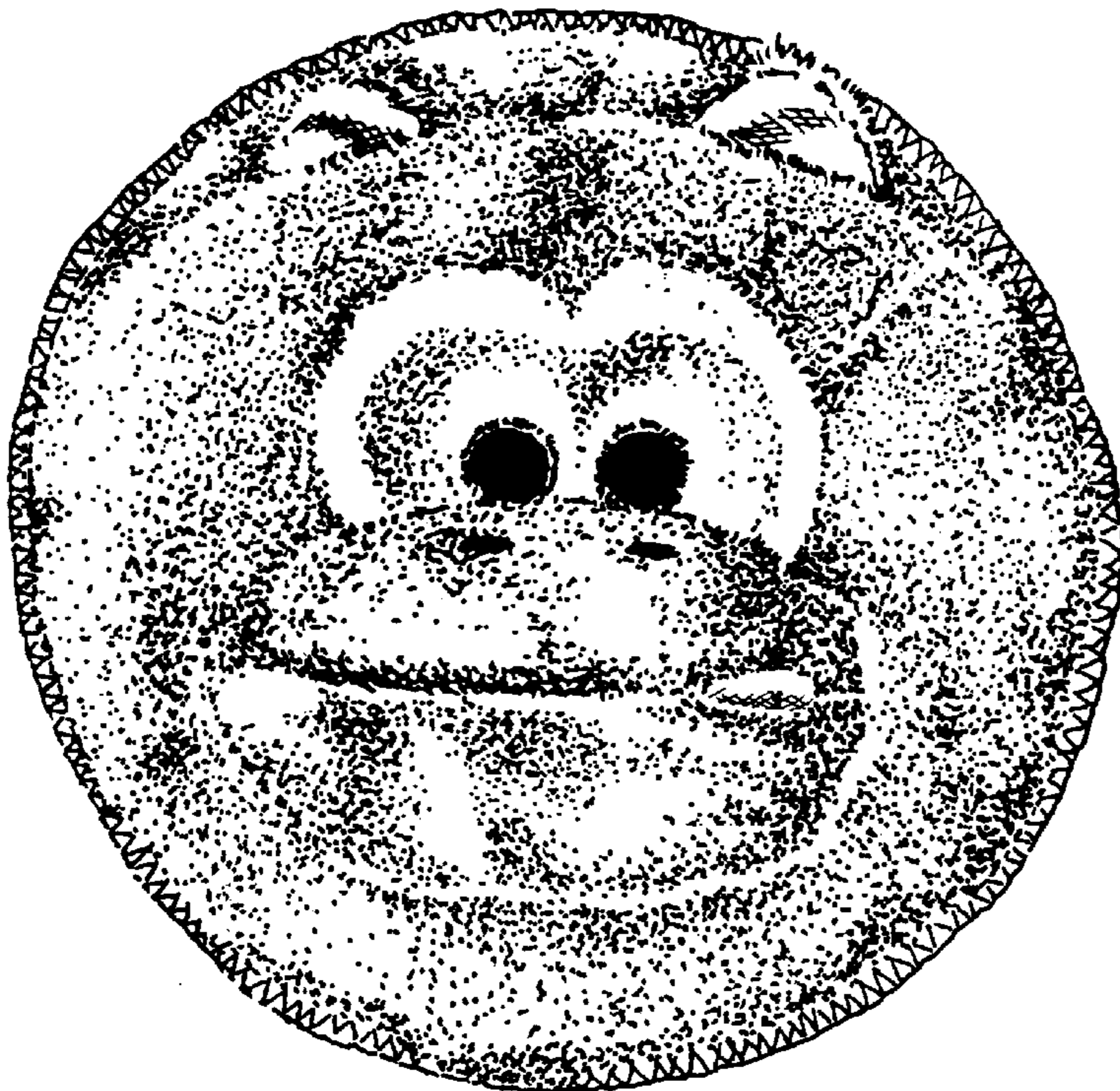

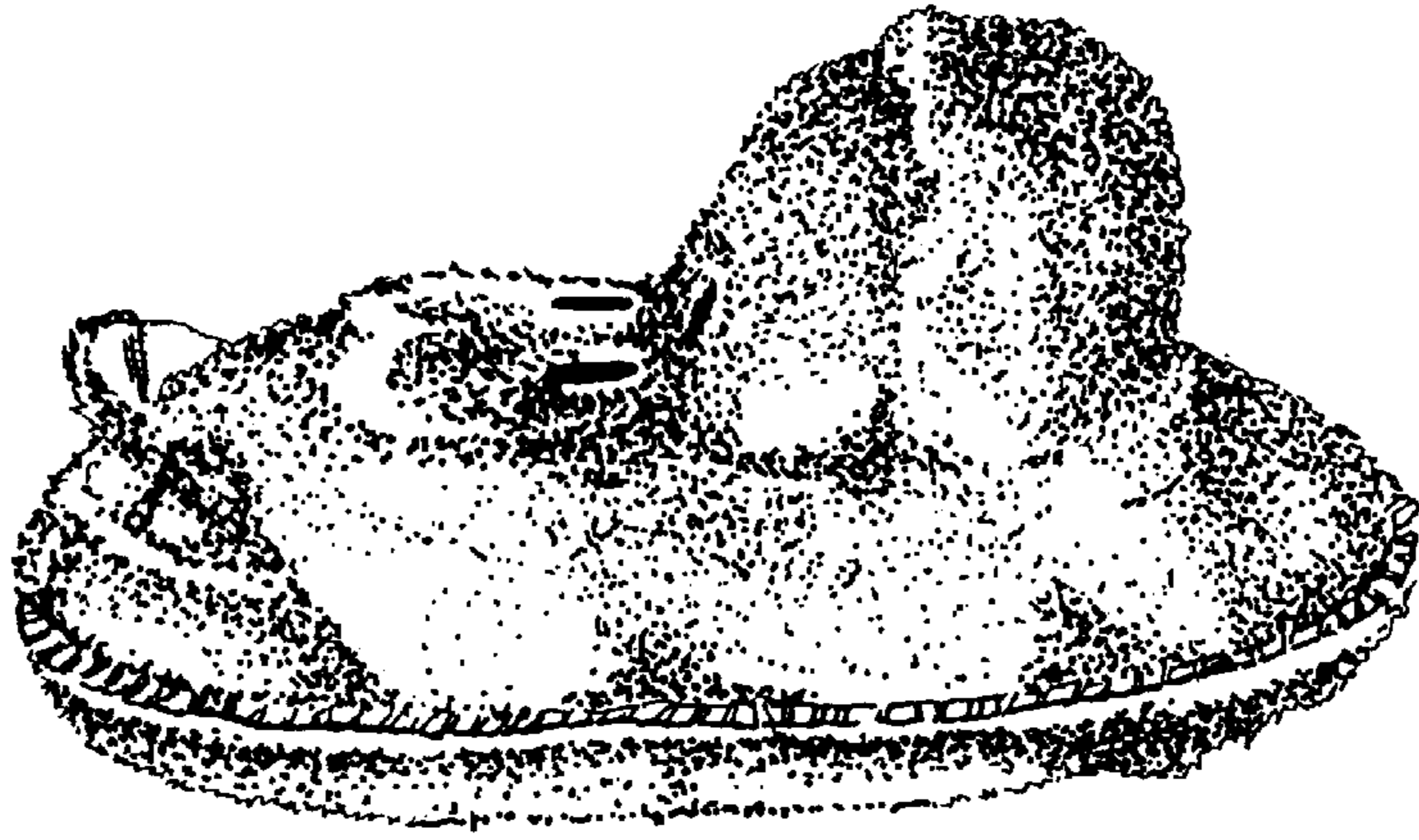
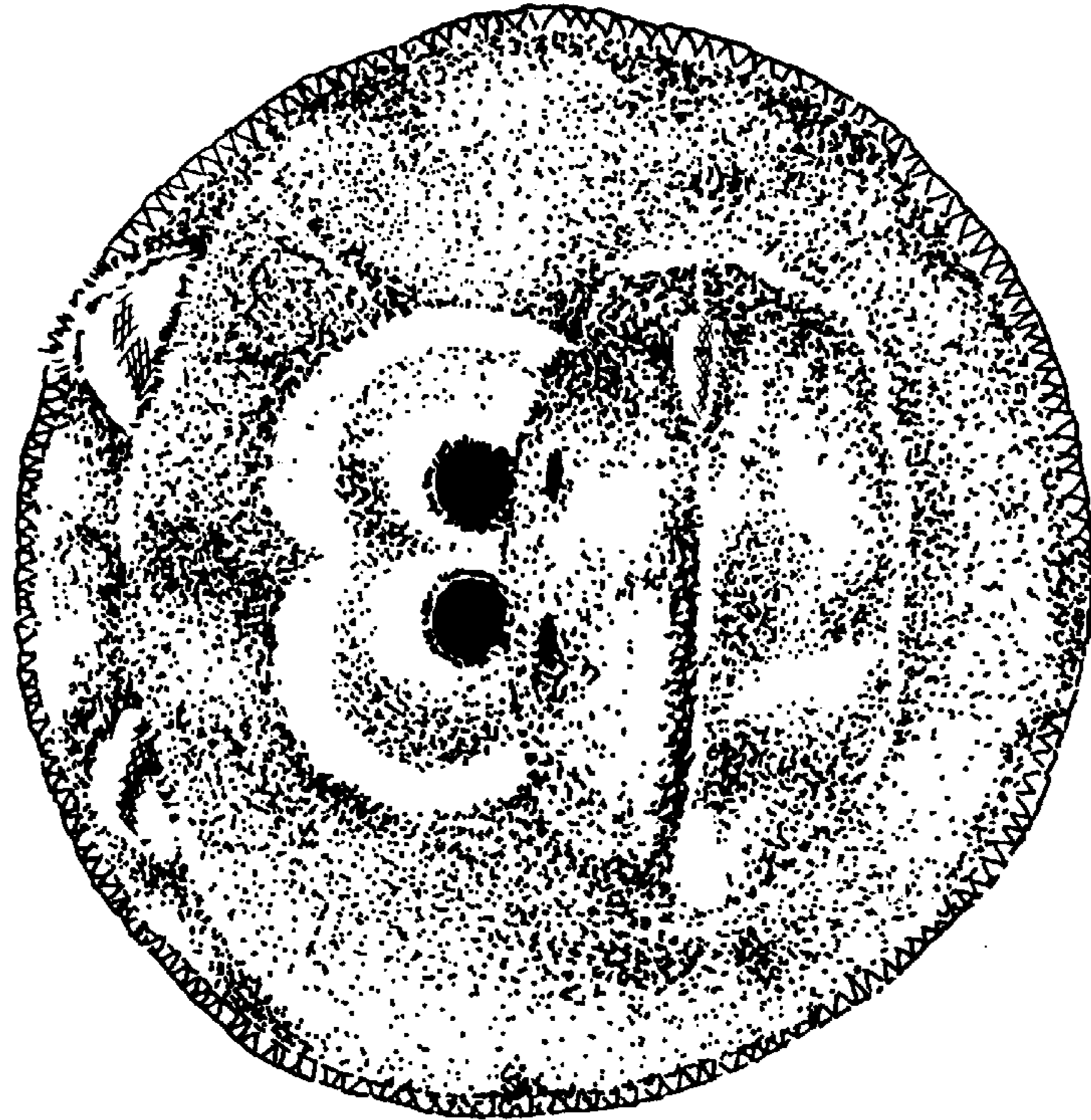

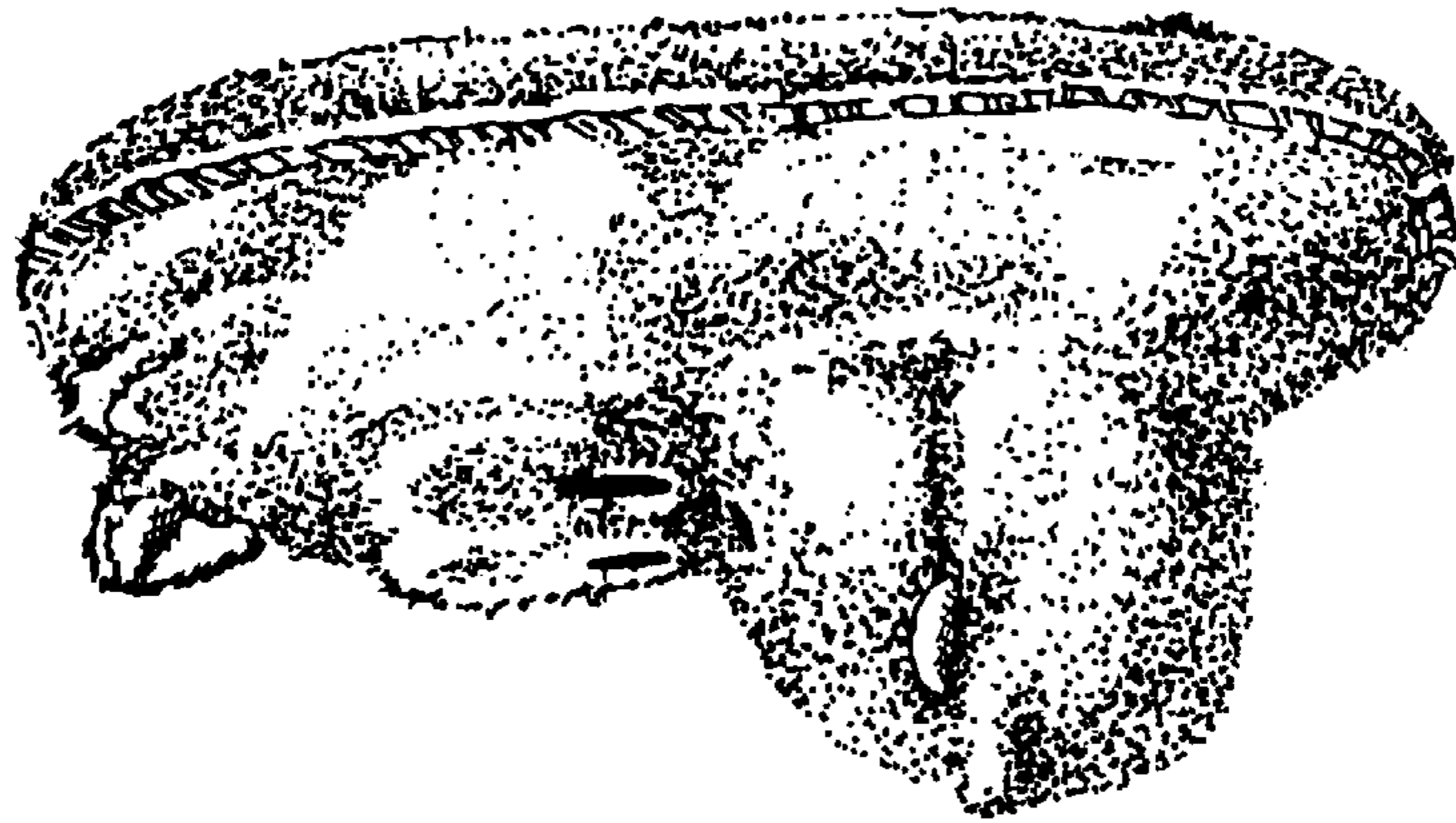

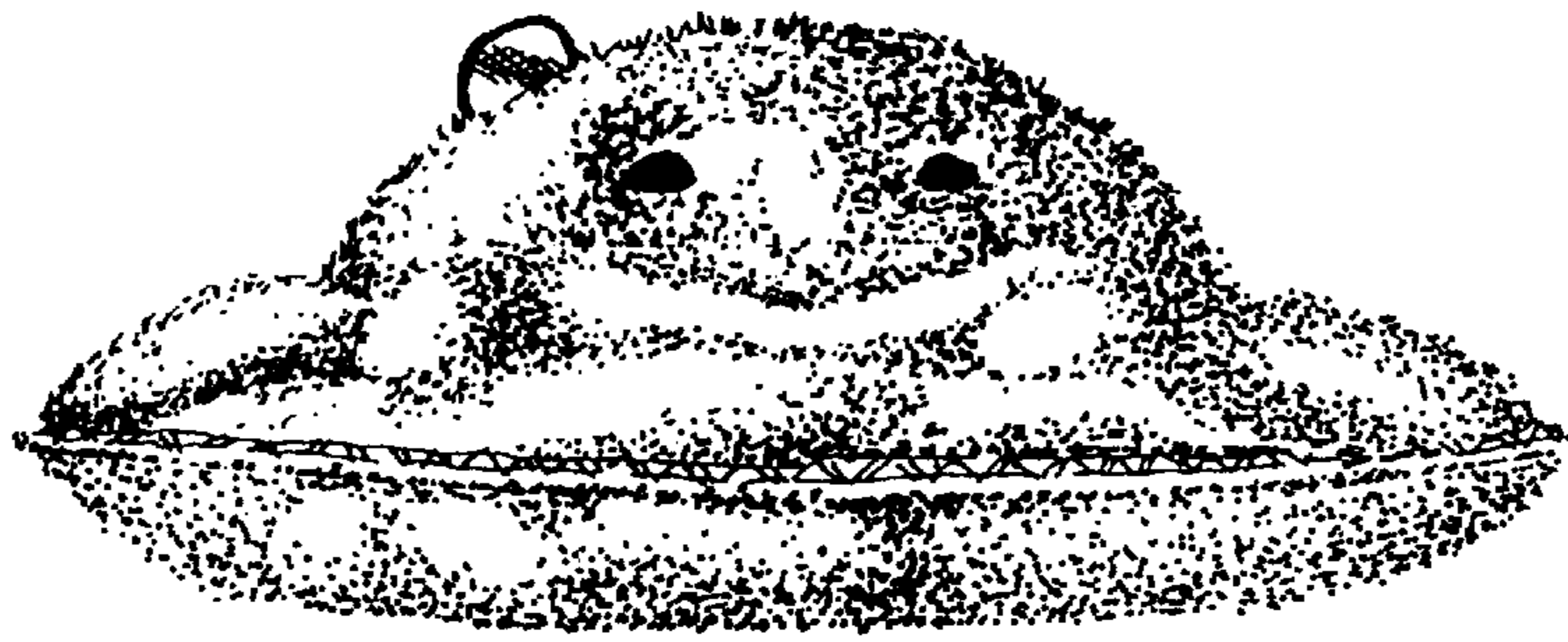

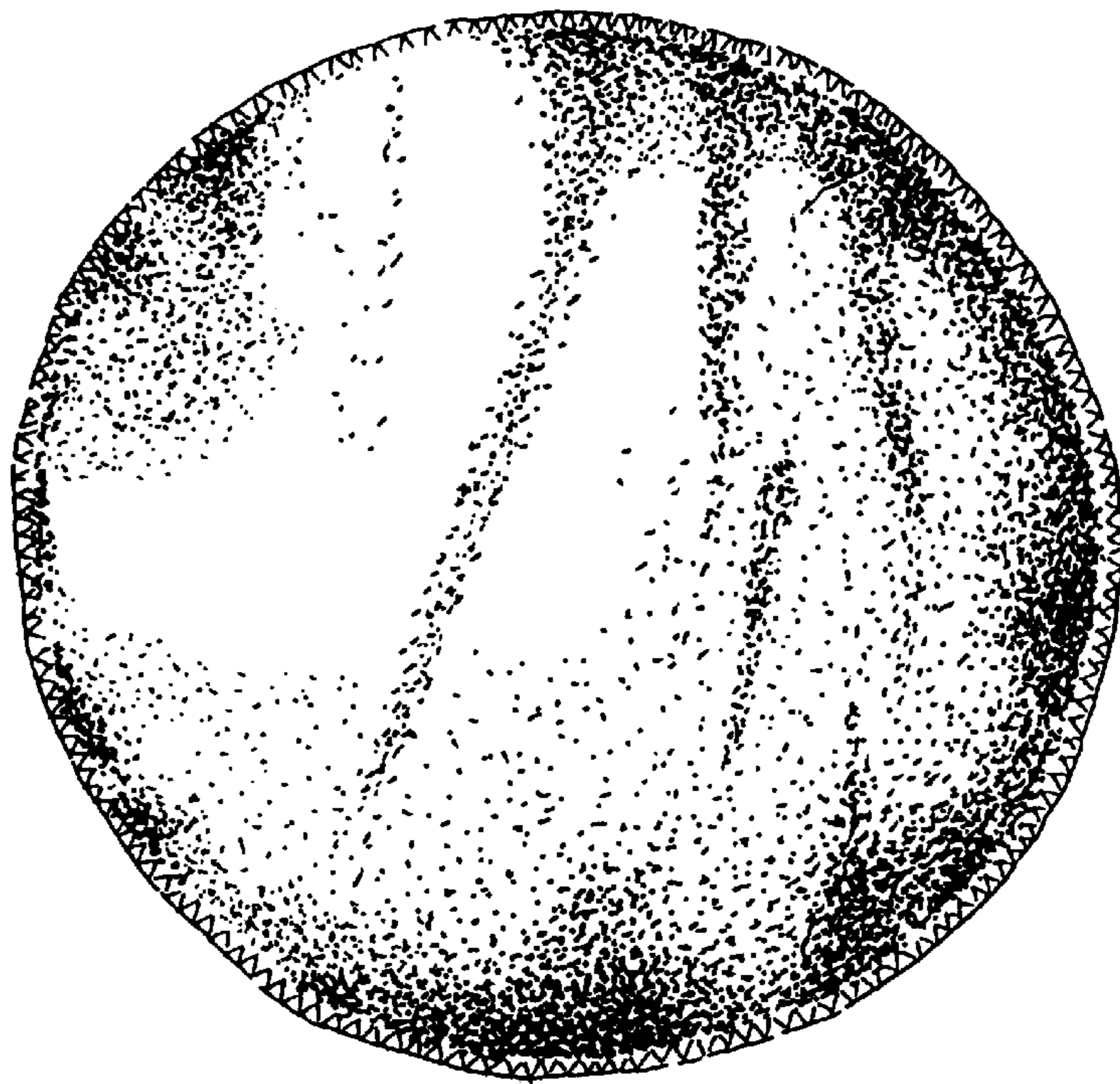

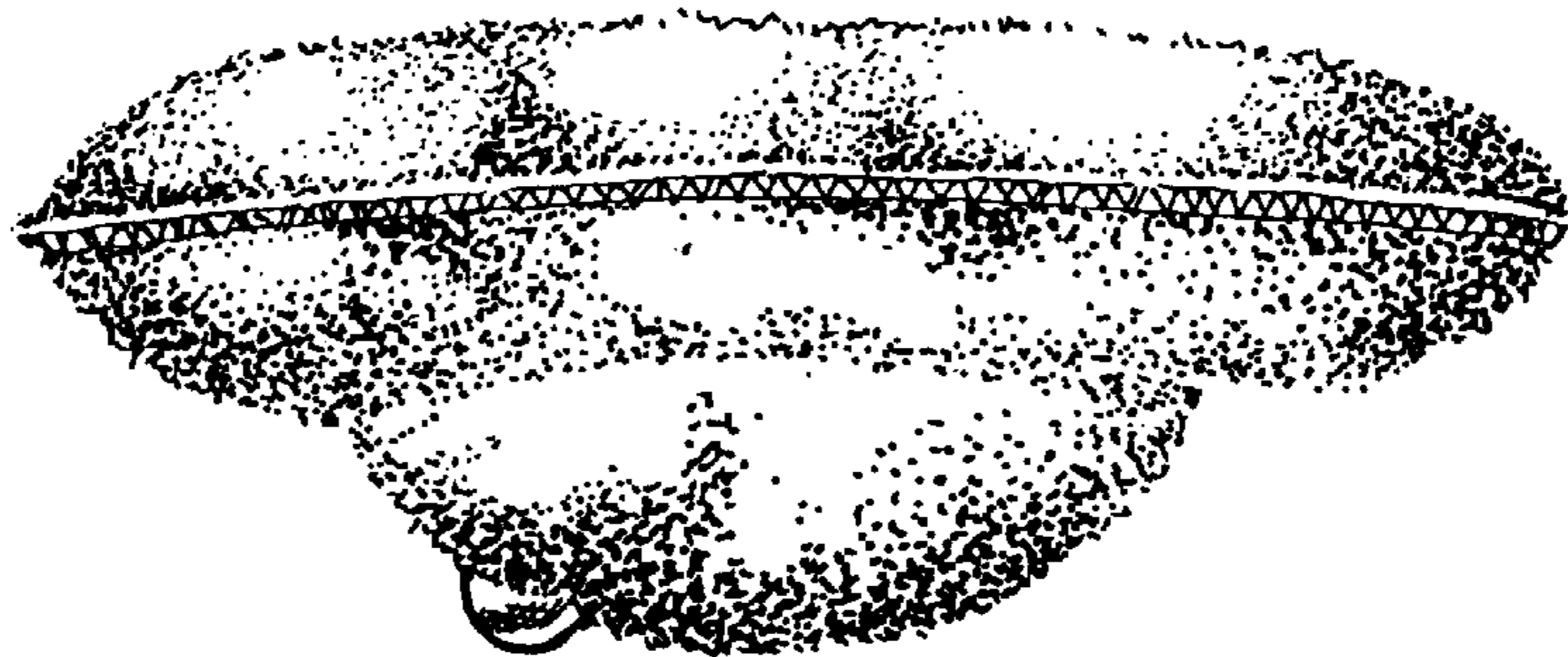
