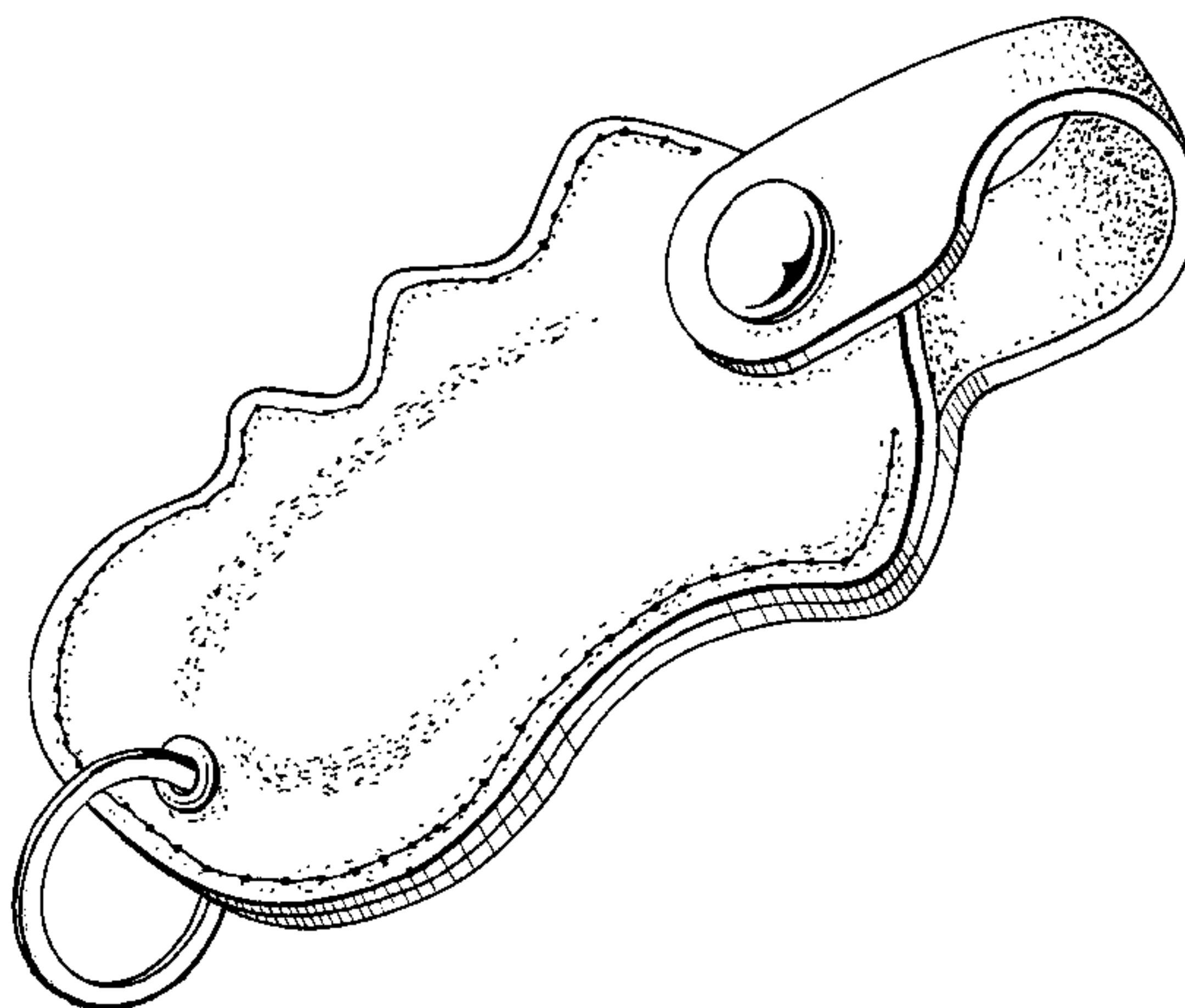
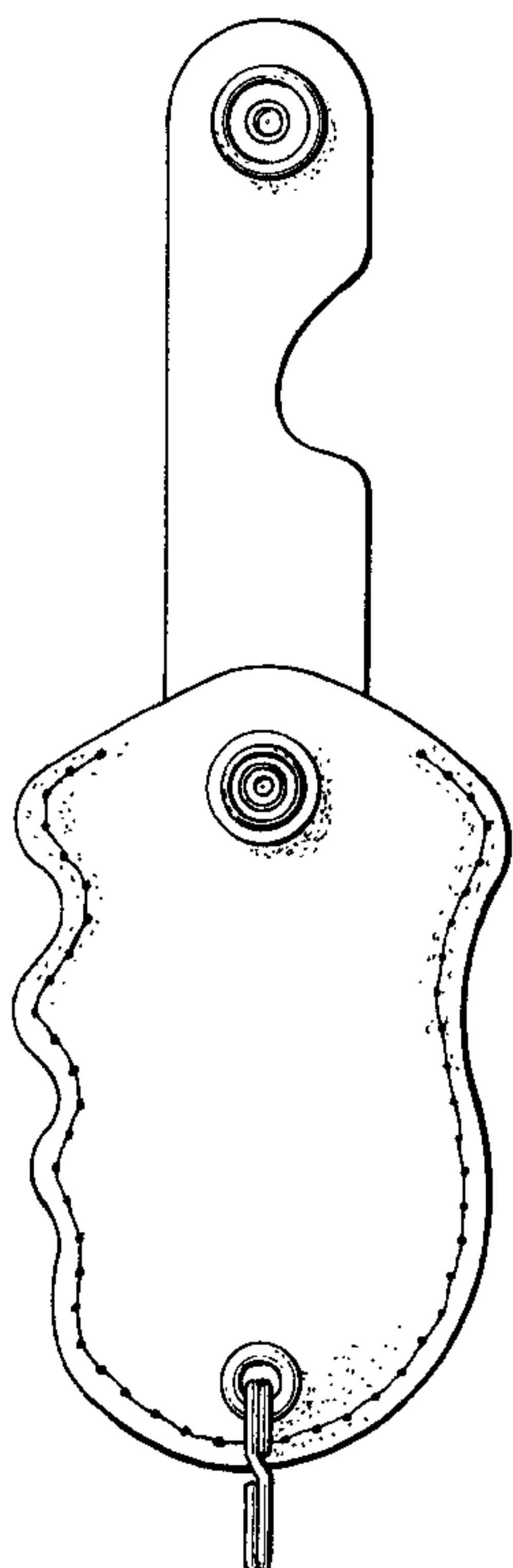
[57] **CLAIM**

The ornamental design for a case for hand held aerosol dispenser, as shown.

DESCRIPTION

FIG. 1 is a front view of the case that comprises the invention and showing the dispenser retaining strap open; FIG. 2 is a side view of the case as viewed from the left of FIG. 1; FIG. 3 is a side view of the case as viewed from the right of FIG. 1; FIG. 4 is a top view of the case as viewed from the top of FIG. 1; FIG. 5 is back view of the case showing the case from the view opposite to that of FIG. 1; FIG. 6 is a bottom view of the case as viewed from the bottom of FIG. 1; and, FIG. 7 is a perspective view of the case with the dispenser retaining strap shown closed.

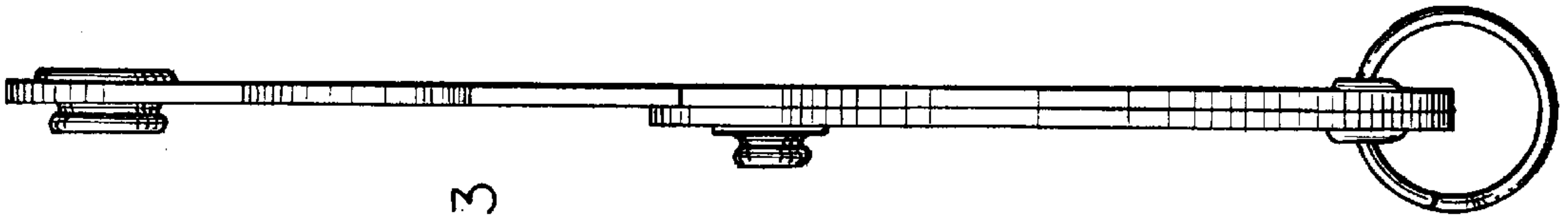

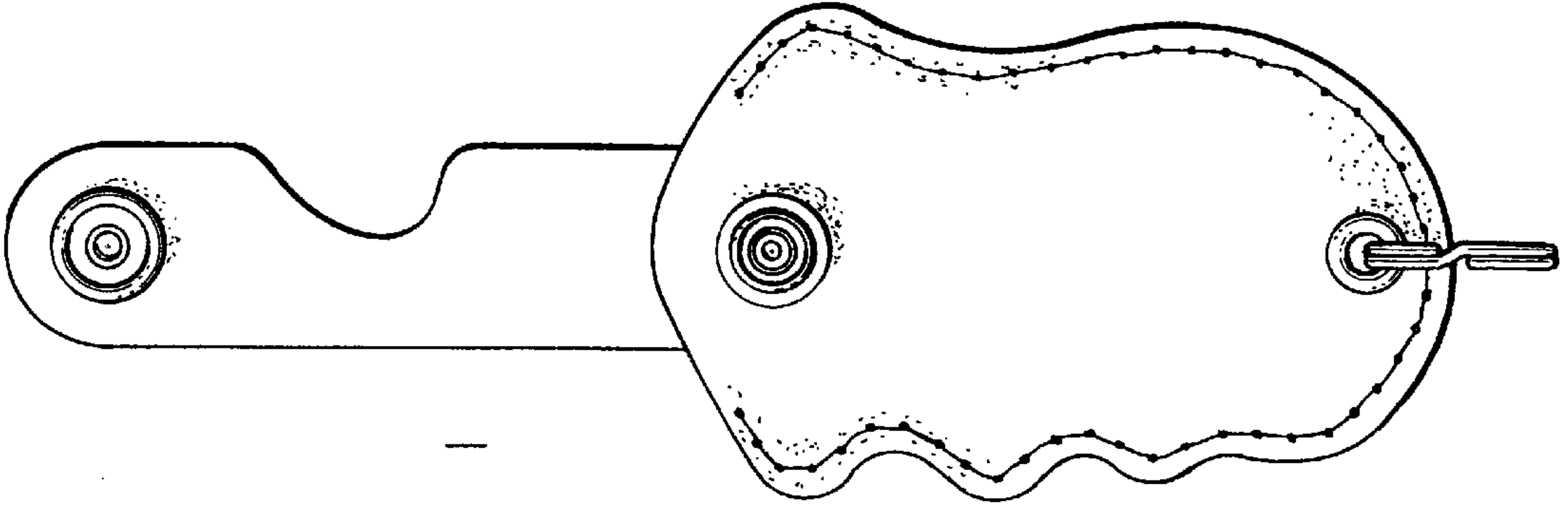

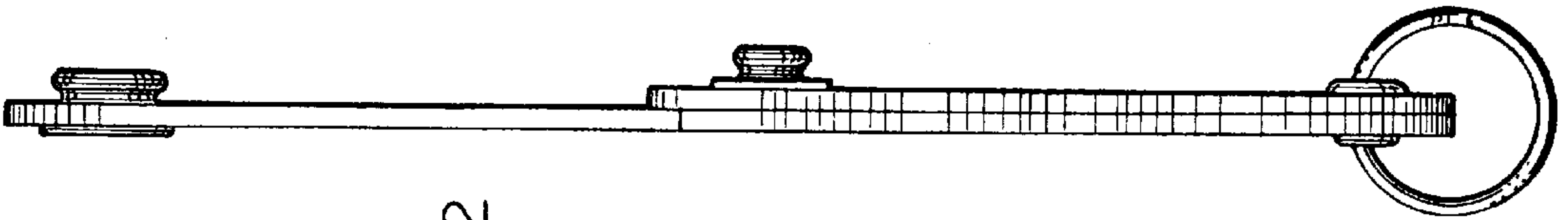

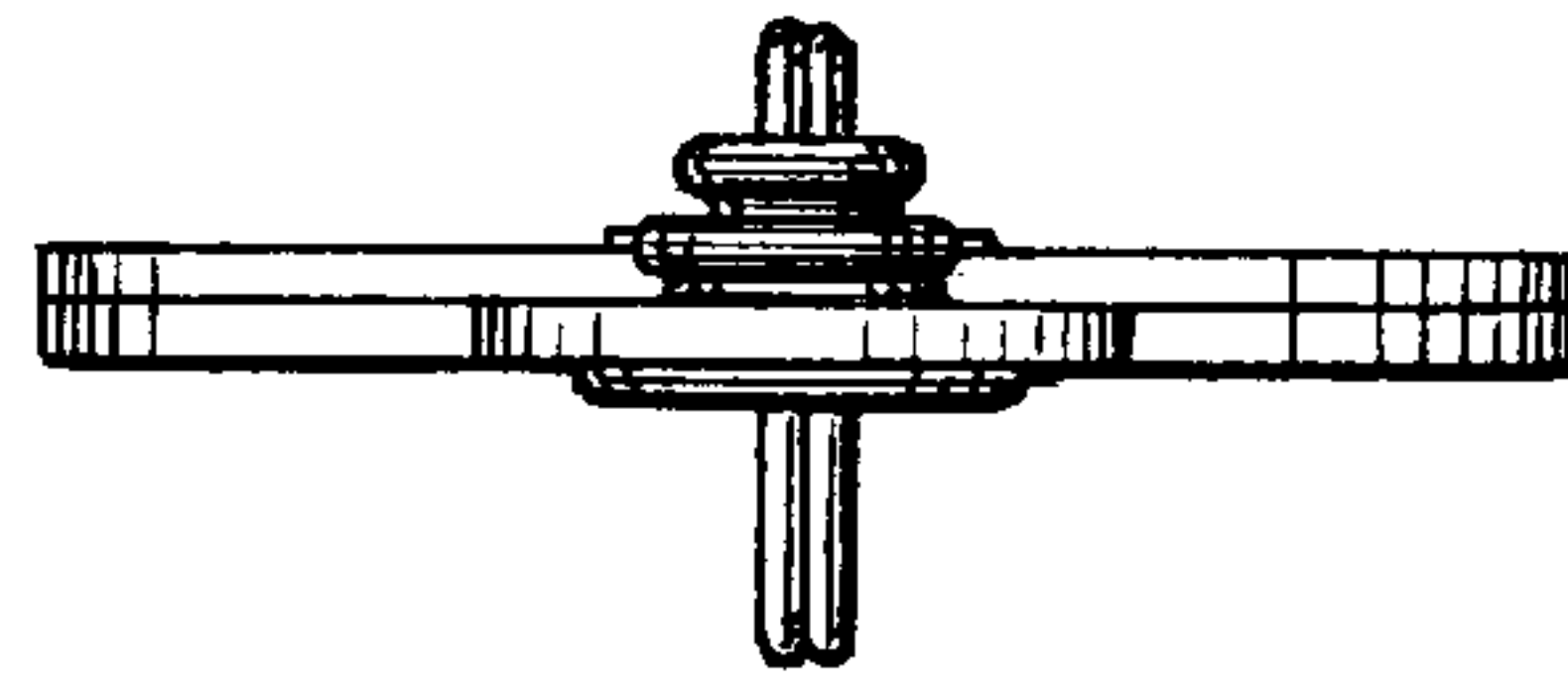

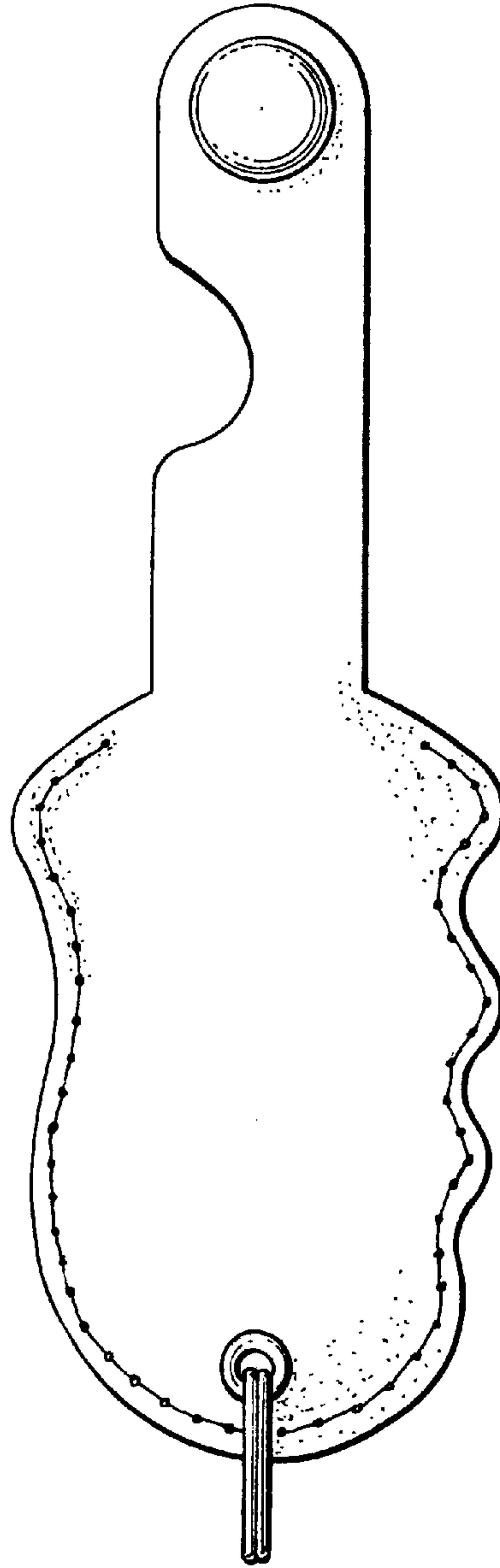
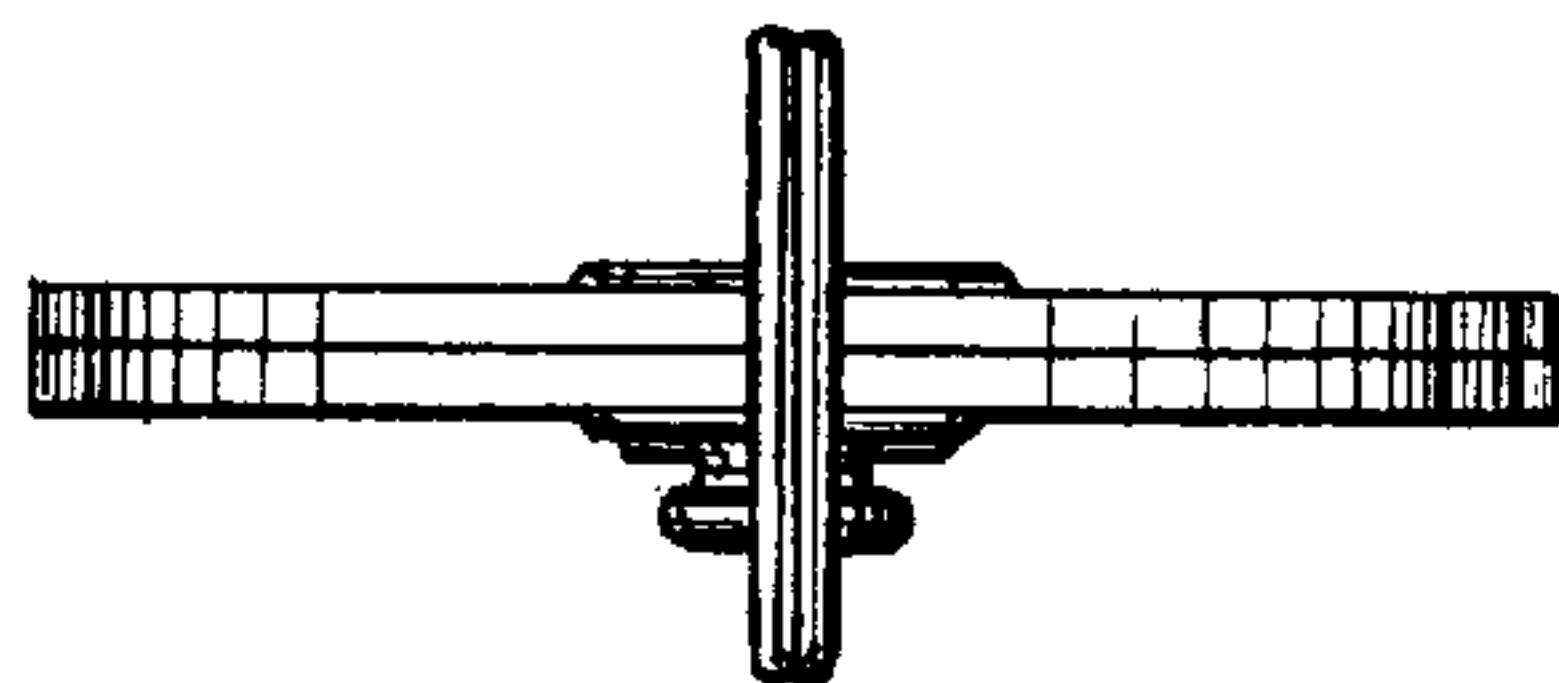

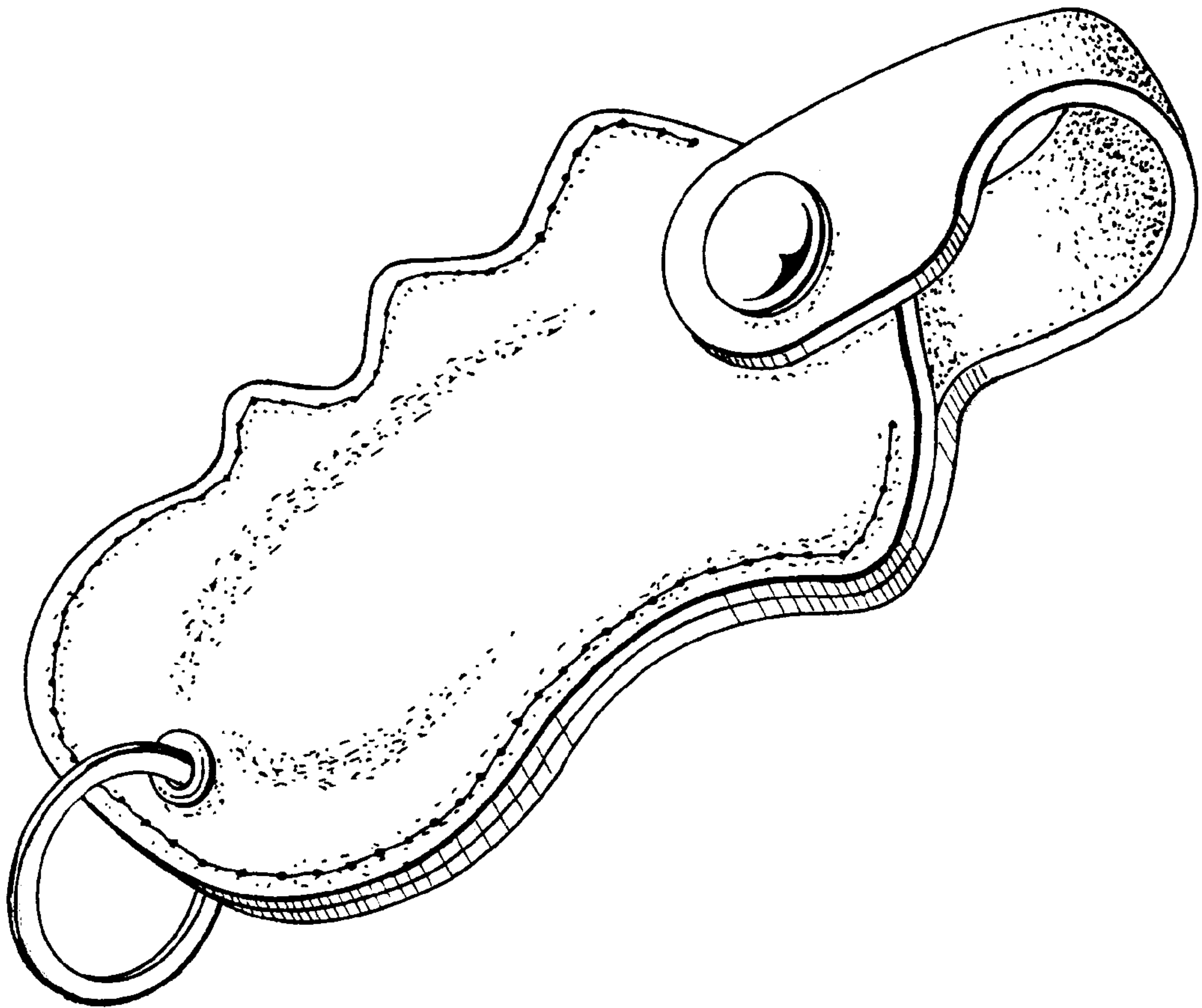
