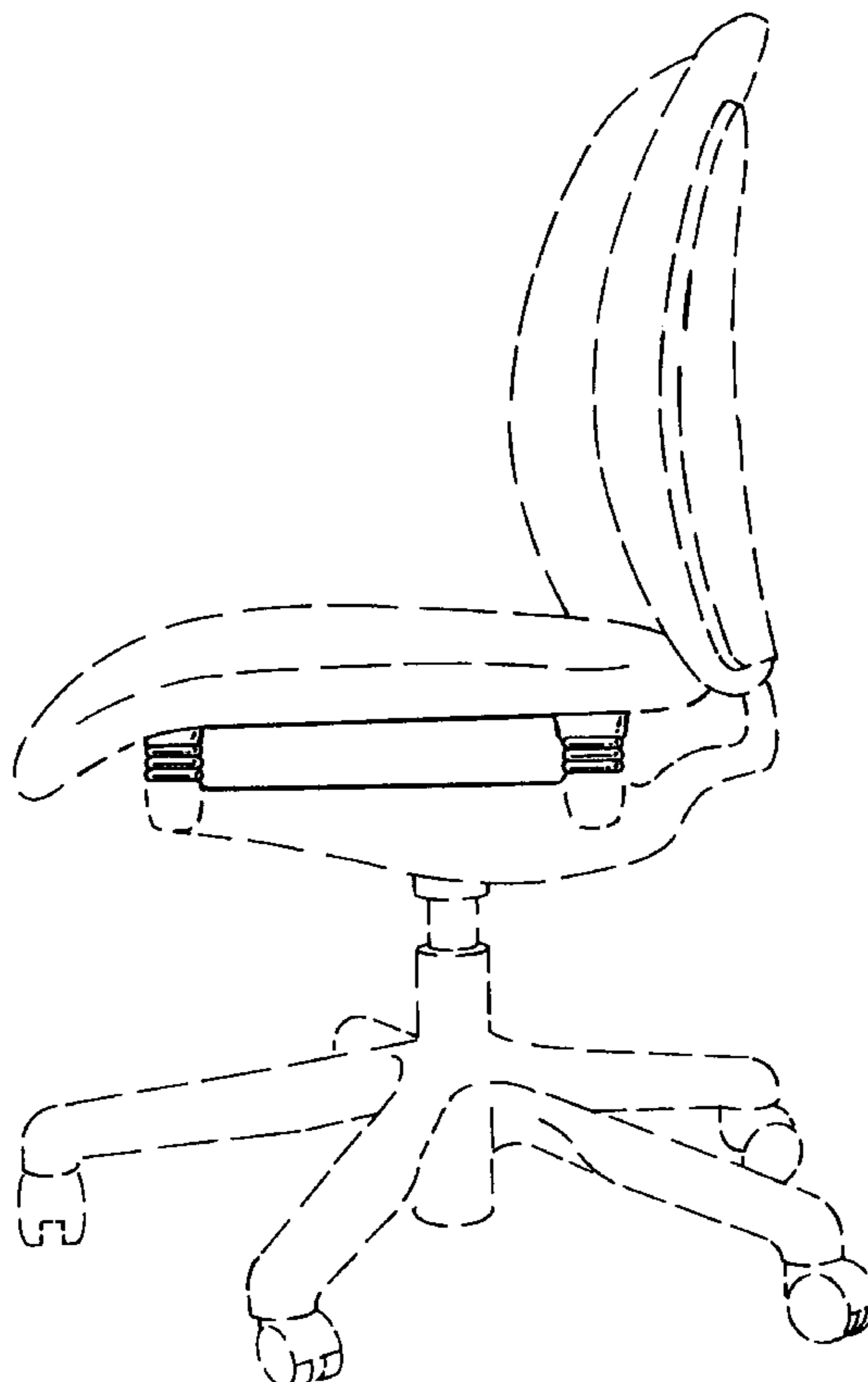
[57] **CLAIM**

The ornamental design for a seat support for a chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a side perspective view of the seat support.  
FIG. 2 is a side elevational view of the seat support of FIG. 1. The other side of the seat support is a mirror image of this view.  
FIG. 3 is a front elevational view of the seat support of FIG. 1; and,  
FIG. 4 is a rear elevational view of the seat support of FIG. 1.  
The broken line showings throughout the figures are for illustrative purposes only and form no part of the claimed design.

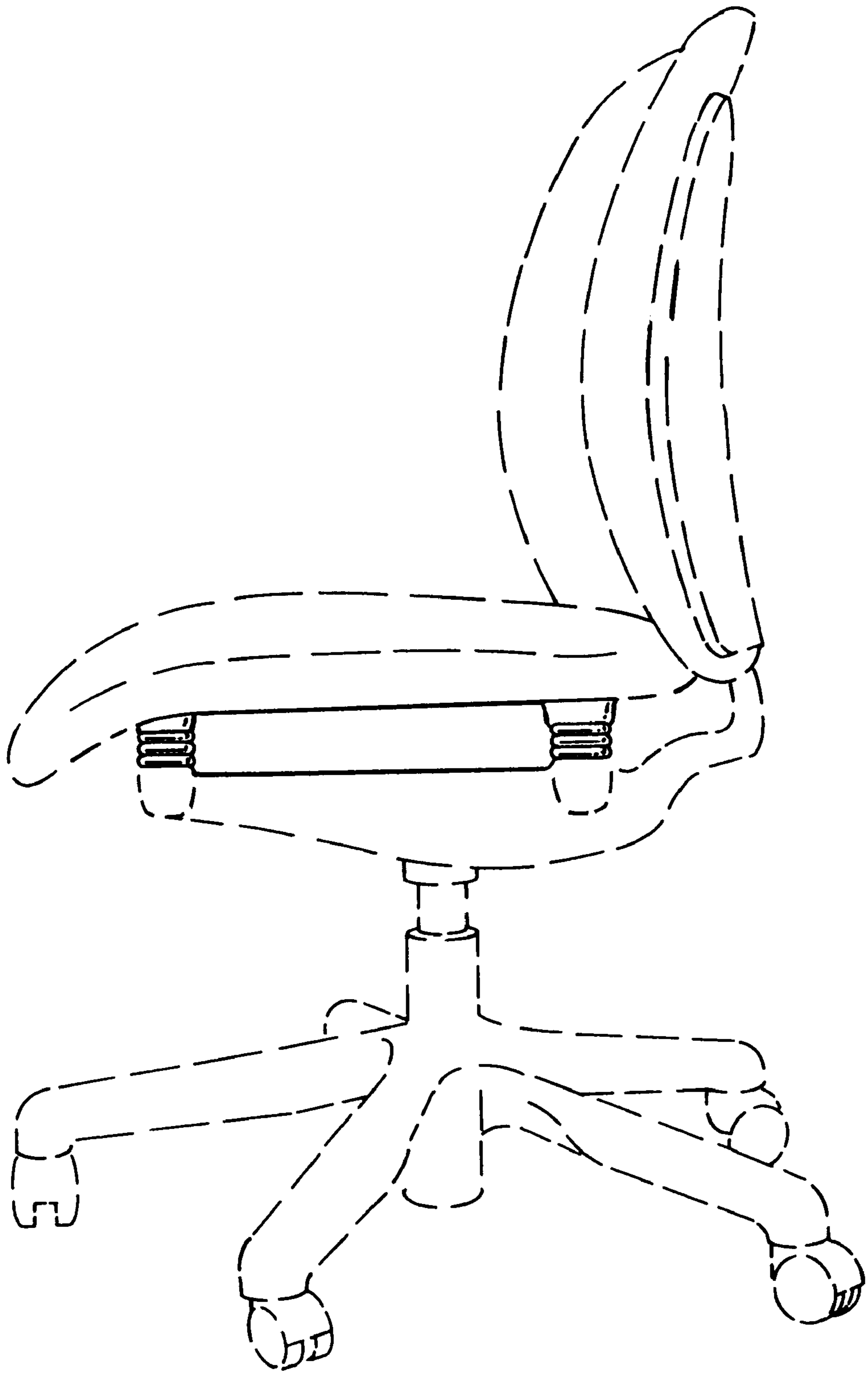

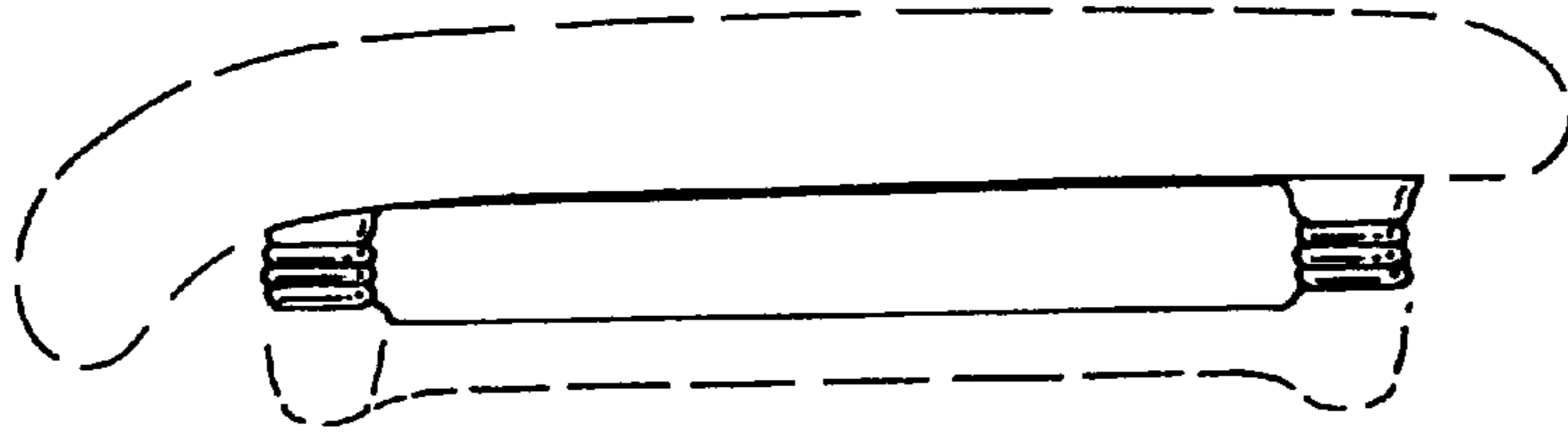

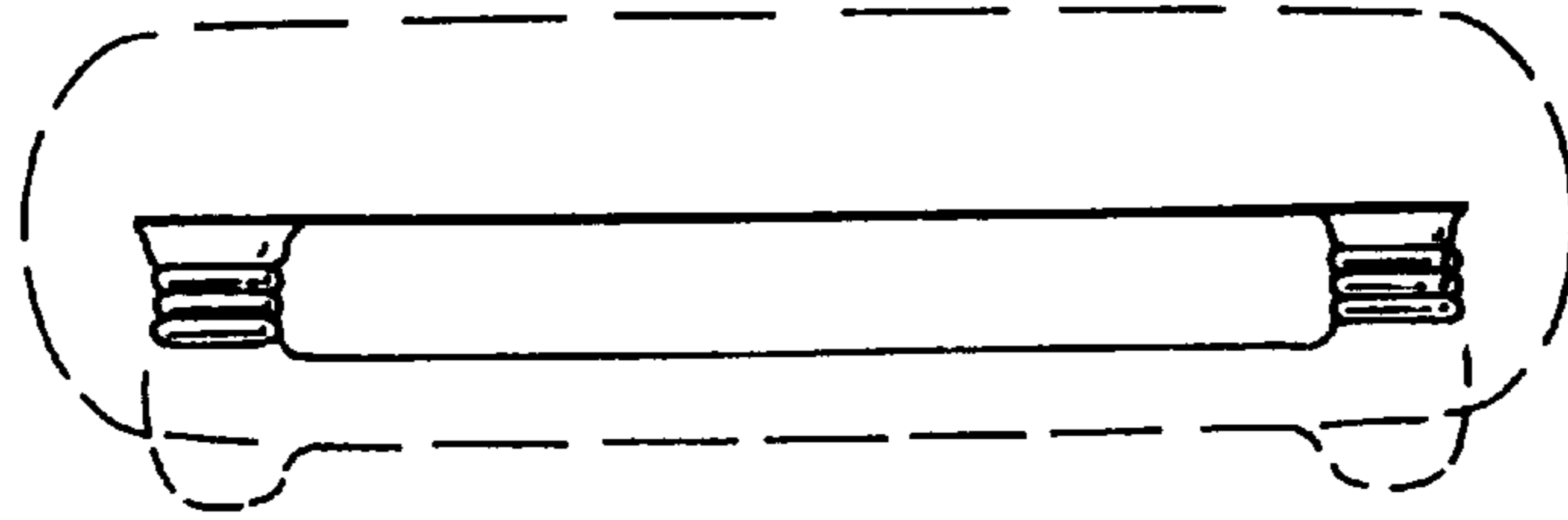

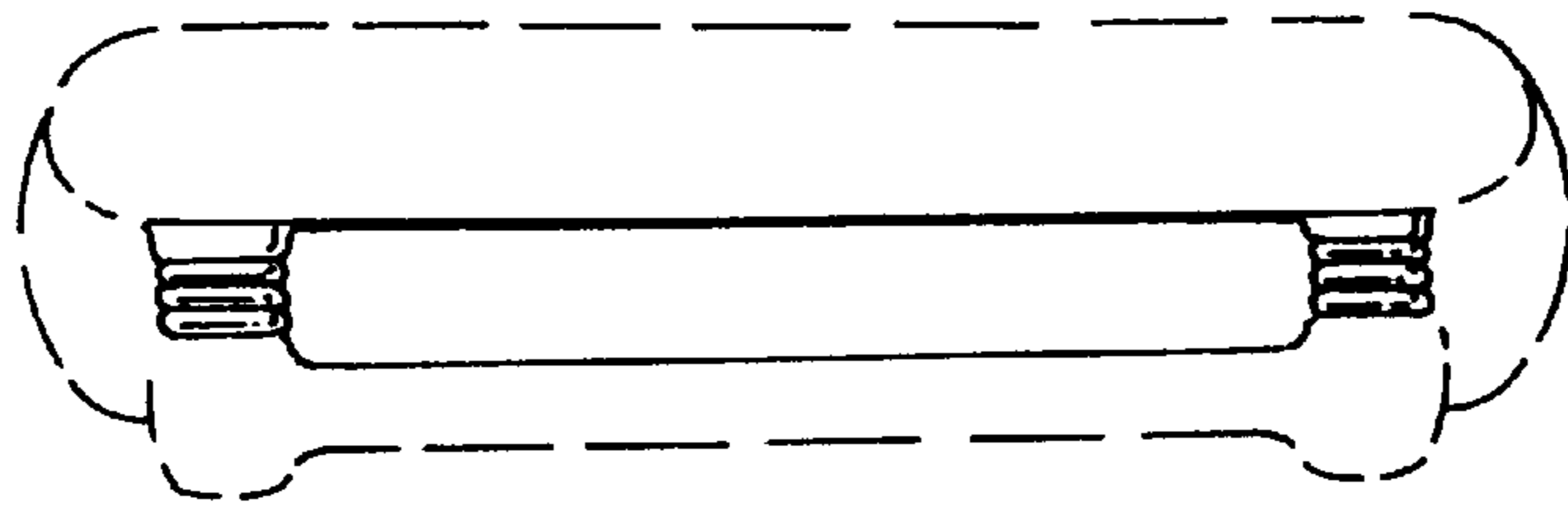
