DESCRIPTION

FIG. 1 is a front elevational view of a folding knife showing my new design;

FIG. 8 is a bottom plan view with the folding knife blade in a closed position;

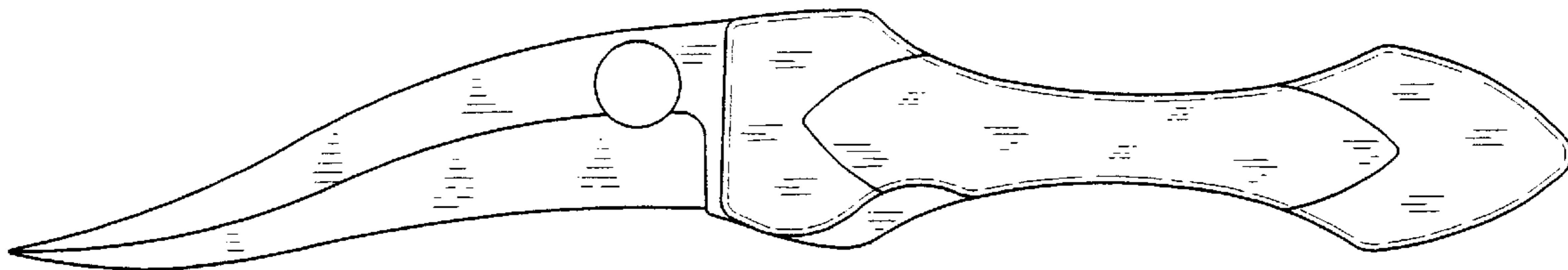
FIG. 9 is a rear elevational view with the folding knife blade in a closed position;

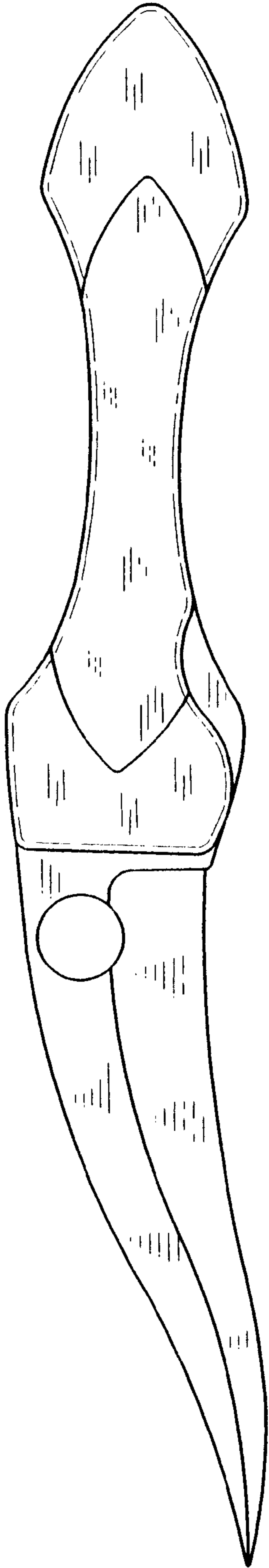

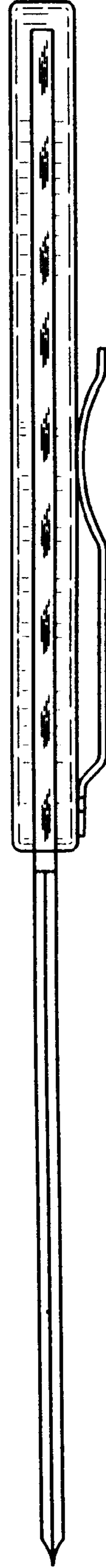

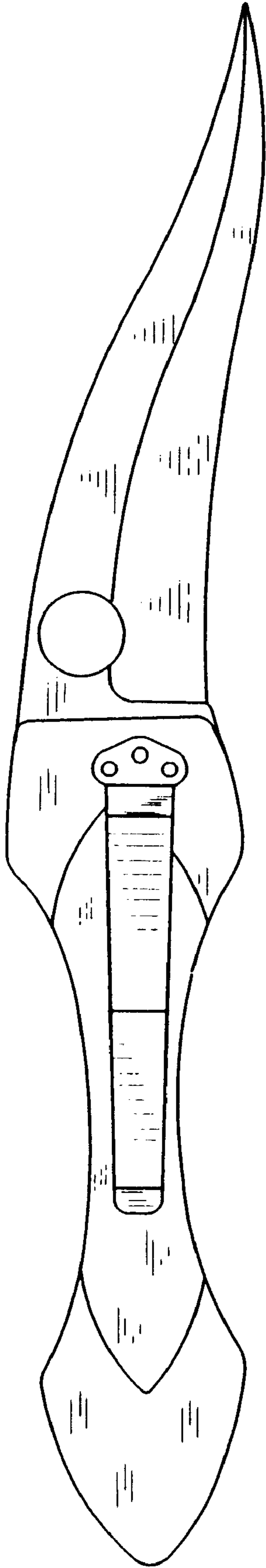

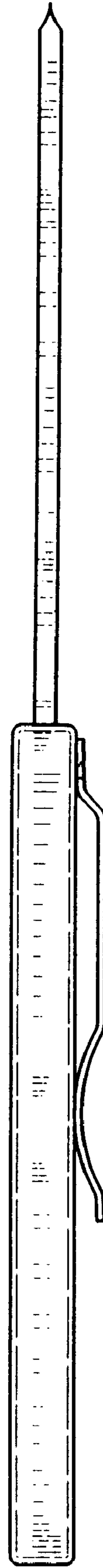

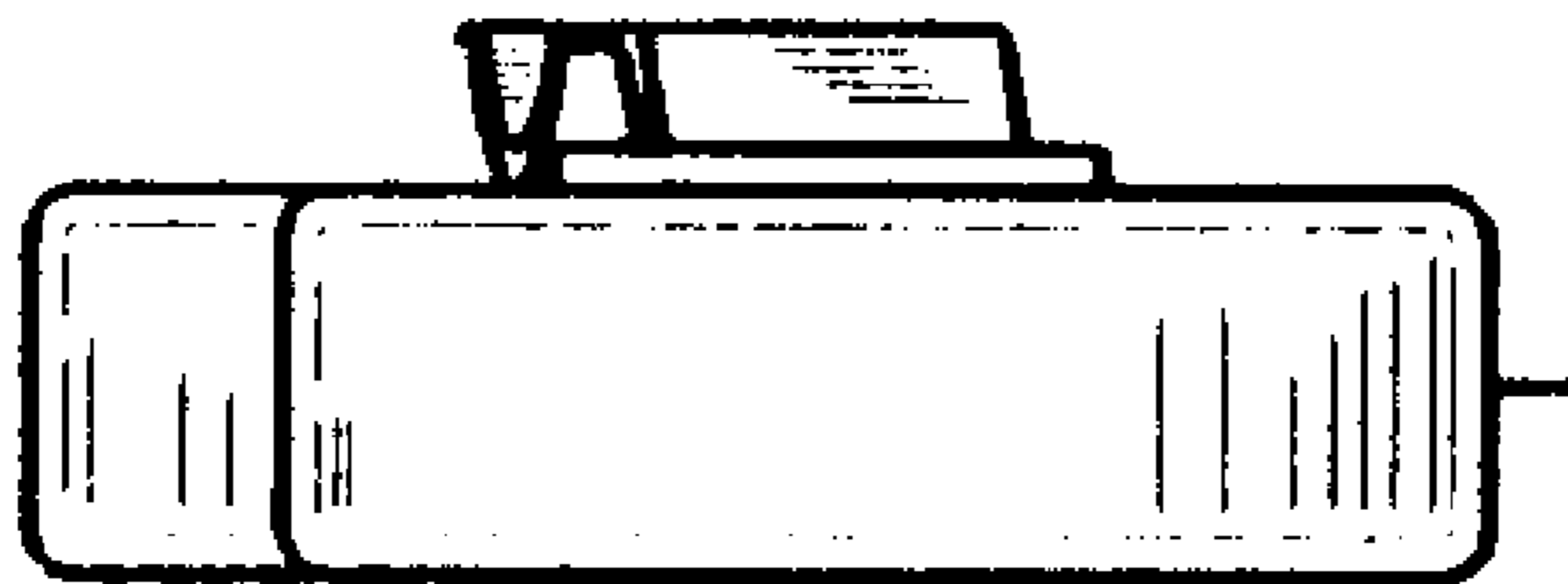

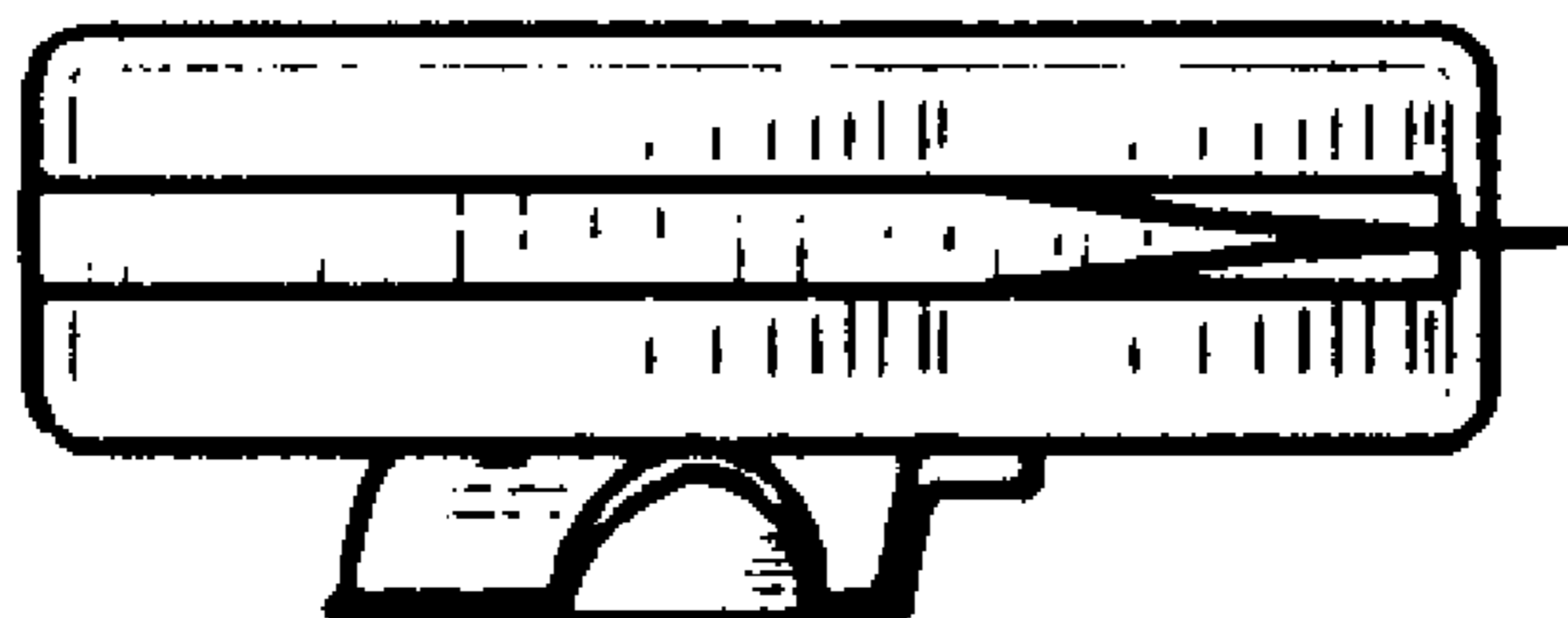

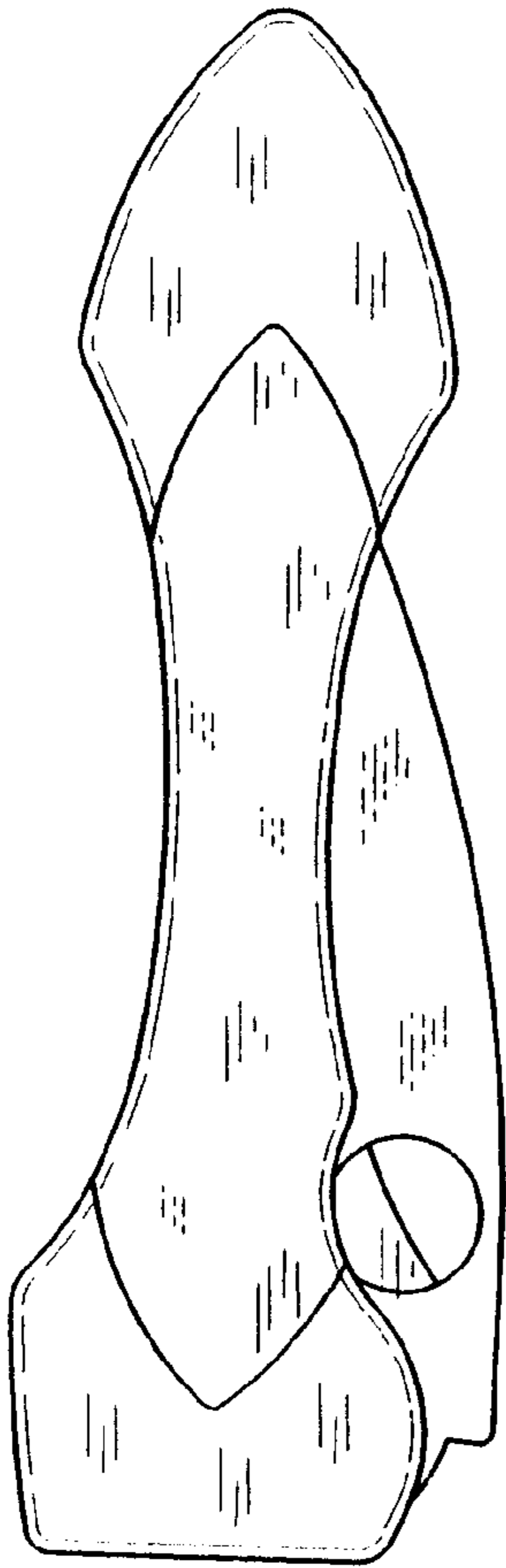

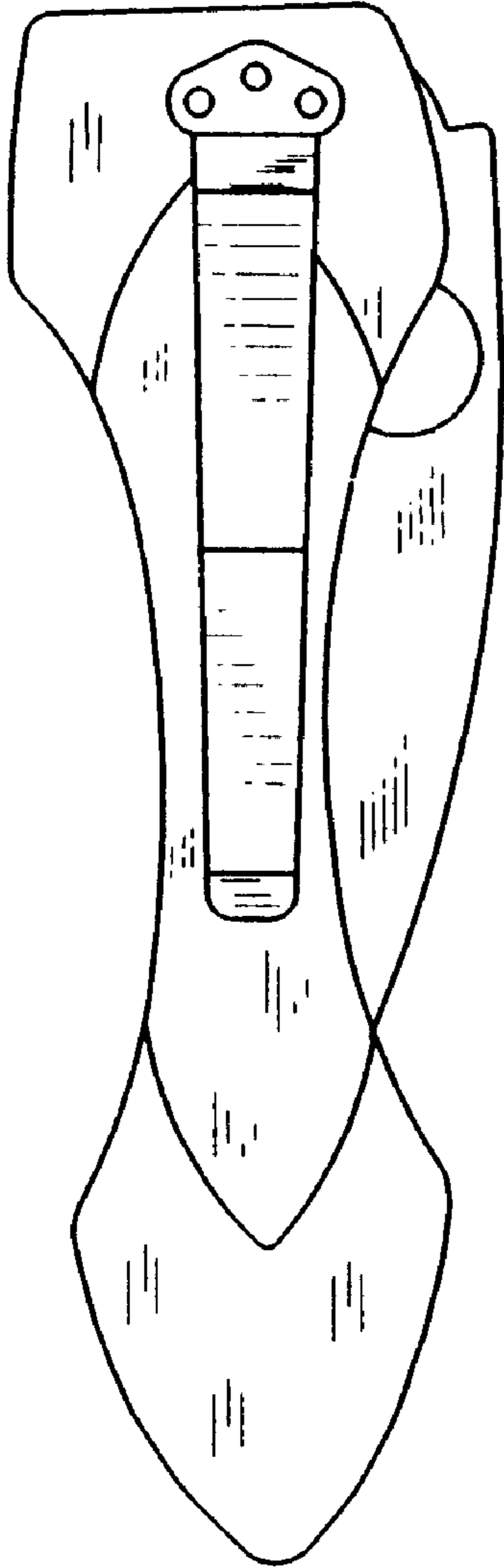

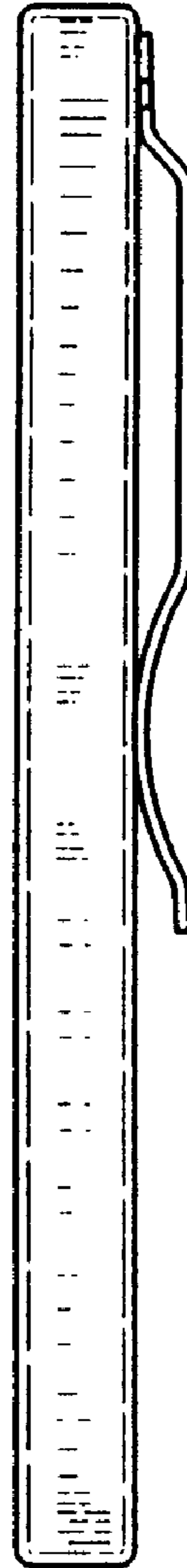

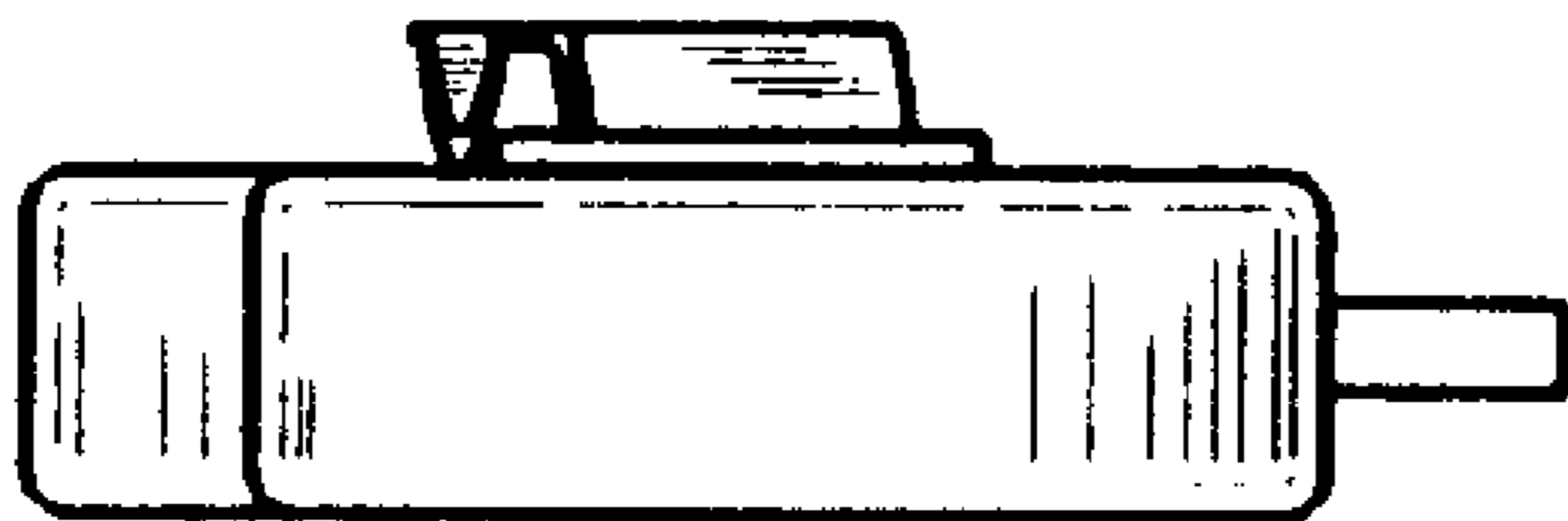

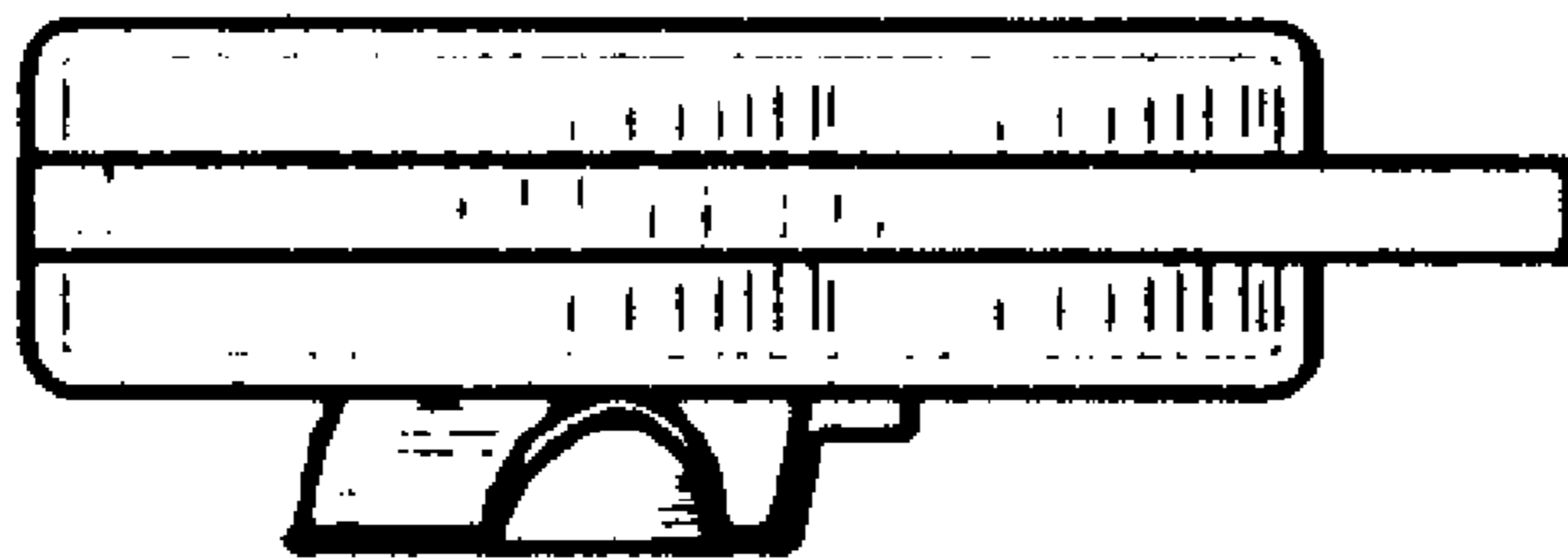
